

To all whom it may concern:

Be it known that I, ISIDOR J. LEVY, a citizen of the United States, and a resident of the city, county, and State of New York, have made a new and useful Improvement in Bags, of which the following is a specification.

The object of my invention is to provide an article of this class which will readily receive and hold small change in a definite part of the bag so that this change may be either deposited in the bag without opening it, or collected without the trouble incident to depositing or collecting it from the bottom of the bag as has heretofore been customary. This object is accomplished by my invention as will appear below.

For a more particular description of my invention reference is to be had to the accompanying drawings forming a part hereof in which,

Figure 1 is a side elevation of a bag provided with my improvements. Fig. 2 is a sectional view taken on the line 2—2 of Fig. 1, looking in the direction of the arrows. Fig. 3 is a sectional view taken on the line 3—3 of Fig. 4, looking in the direction of the arrows. Fig. 4 is an enlarged view of the lower left hand corner of Fig. 1.

Throughout the various views of the drawings, similar reference characters designate similar parts.

The bag 1 has the usual frame 2 and a body 2^a formed in the conventional manner so that a more detailed description is unnecessary.

The outer wall of the bag is provided with a pocket 3 extending to the bottom 3^a of the bag. The bag is preferably provided with exterior and interior reinforcing strips 4 and 5, respectively, which are held in place by

rivets 6 or any other suitable means. The wall of the bag and the reinforcing strips 4 and 5 are provided with coin-receiving slots 7, 8 and 9, respectively, to receive coins of 45 various sizes. The inner side of the reinforce 5 is preferably provided with a flap or cover 10 which protects the pocket 3 and prevents the coins in the bag from coming through any of the slots 7, 8 or 9.

From the foregoing, it is obvious that my improved bag will greatly increase the facility with which coins can be either inserted or removed from the bag, and do away with the usual annoyance of opening the bag to 55 deposit small change and a rummaging in the contents of the bag for it.

Any form of receptacle can be substituted for the pocket 3.

Having thus described my invention, what 60 I claim is:

A bag for carrying coins and other articles, the coins being kept separate from the other articles, said bag having openings in its side wall of various sizes; reinforcing strips pro- 65 vided with openings of various sizes registering with the openings in the side of the bag, said reinforcing strips being fastened opposite to each other, one inside and one outside of the side of the bag; a yielding flap sup- 70 ported on the inner reinforcing strip to prevent coins inserted through the side of the bag from shaking out; and a pocket secured on the inside of the wall of the bag and extending some distance on each side of the 75 inner reinforcing strip, substantially as described.
