


NECKTIE ATTACHMENT.

. To all whom it may concern:

Be it known that I, WILLIAM A. BAUER, a citizen of the United States, and a resident of Philadelphia, in the county of Philadel-5 phia and State of Pennsylvania, have invented a new and useful Improvement in Necktie Attachments, of which the following is a full,

clear, and exact description.

The purpose of the invention is to provide 10 a very simple attachment to a four-in-hand or other tie, scarf, or necktie, and an accompanying device whereby to conveniently and expeditiously shift the tie when used in connection with a turn-down collar, to bring the 15 knot at the proper position relatively to the front of the shirt.

The invention consists in the novel construction and combination of the several parts as will be hereinafter fully set forth and

20 pointed out in the claims.

Reference is to be had to the accompanytion, in which similar characters of reference indicate corresponding parts in both the fig-25 ures.

Figure 1 is a view of the rear portion of a collar and shirt to which it is applied, a portion of the collar being broken away to illustrate the central back portion of a necktie 30 and the improved attachment applied thereto; and Fig. 2 is an enlarged vertical section through the tie and attachment, and the de-

vice employed for shifting the tie.

A represents a turn-down collar which is 35 secured in the customary manner to a shirt A', and B represents the rear central portion of the neck band of a tie, a four-in-hand, for example, or a bow tie, or the equivalents thereof. At the inner or outer face of the 40 said band B, at the rear central portion thereof, a strip or a plate 10 is located, which may be made of celluloid, metal, or of any suitable or approved material, and this plate or strip 10 is so secured to the band of the tie as 45 to form a pocket 11, a loop or an eyelet, or other receptacle or purchase section for the reception of an implement C that is independent of the tie and is to be used to shift the tie when so desired. When a celluloid or 50 metal plate, or a strip of fabric is employed to produce the said purchase section or pocket, it is secured to the band of the tie by means of stitching 13 or its equivalent, which stitching extends along the top and 55 bottom of the strip employed, and along one end, leaving the other end open, and in order

that the aforesaid implement C may be readily introduced into the said pocket or purchase section of the tie, a recess 12 is made at its open end, as is clearly shown in Fig. 1.

The implement C above referred to, consists of a head section 15 that is adapted to enter the pocket or purchase section 10 attached to the band of the tie, and a handle 14 that is at an angle to the said head or body 65 section of the implement, which handle is preferably given a curvature so that it will extend in direction of one shoulder of the wearer, and thus permit the said implement to be readily operated. The implement C is 70 entirely independent of the tie and the purchase section or pocket applied thereto, and the said implement C may be made of metal, celluloid, wood, or any suitable material having sufficient stability for the purpose in- 75 tended.

In operation, when the necktie has been ing drawings forming a part of this specifica- | suitably tied, and the knot is to be shifted so as to occupy a central position relatively to the front of the bosom of the shirt A', the 80 head or body portion 15 of the implement C is introduced into the pocket or purchase section 10 of the tie, and the handle is grasped by the operator and the tie is then shifted until the knot has assumed its proper posi- 85 tion relatively to the front of the shirt.

> I desire it to be understood that, instead of the head 15 constituting an integral portion of the handle 14, a clamp or clip of any approved construction may be substituted.

Having thus described my invention, I claim as new and desire to secure by Letters Patent,—

1. A necktie provided with a purchase section at its rear, and an implement adapted to 95 enter the said purchase section for the pur-

pose of shifting the tie.

2. A necktie provided with a purchase section at its rear and an implement adapted to enter the said purchase section for the pur- 100 pose of shifting the tie, which implement consists of a head section that enters the purchase section of the tie, and a handle section that is at an angle to the head section.

3. The combination with the band of a 105 necktie having a pocket formed at its rear portion at a point about centrally between its ends, of an implement adapted to shift the said tie when in position on a collar, which implement consists of a head or body section 110 that is adapted to enter the said pocket, and a handle at an angle to the said head or body

section, that extends downwardly therefrom

when applied to the said tie.

4. The combination with the necktie band of a necktie, of a pocket or loop formed at its 5 rear outer portion at or about its center, which pocket is open at one end and at said open end is provided with a recess in its free edge, of an implement for shifting the said tie, which implement consists of a head or 10 body section adapted to enter the said pocket | Wм. or loop, and a handle which is curved downwardly from the said body section and is at an angle thereto, as described.
