

## JAR AND COVER HOLDER.

To all whom it may concern:/

Be it known that I, Isaac N. Davis, a citizen of the United States, residing at Wyalusing, in the county of Bradford and State of Pennsylvania, have invented a new and useful Improvement in Jar and Cover Holders, of which the following is a specification.

This invention relates to jar and cover holders and more particularly to holders for holding pickle jars and the like, the object being to provide a holder which is very simple and cheap in construction and one which is very effective in use.

Another object of my invention is to provide the holder with a hinged arm carrying a cover which is adapted to fit over the jar.

Another object of my invention is to provide means for supporting the cover when swung up from over the jar.

With these and other objects in view, the invention consists in the novel features of construction, combination and arrangement of parts hereinafter fully described and pointed out in the claims.

In the drawing forming a part of this specification:—Figure 1 is a perspective view of my improved holder showing a jar arranged thereon. Fig. 2 is a detail sectional view of Fig. 1. Fig. 3 is a detail sectional view of a modification.

In the drawing A indicates a circular base provided with an outwardly projecting portion A' which is preferably formed of wood but may be formed of any suitable material.

35 Arranged on the base A are spring-clips B on which the glass jar C is adapted to rest and be securely held in place by the spring clips engaging the side of the jar.

Secured on the portion A' of the base is a 40 standard D having a plate E secured on its upper end provided with vertical spaced

apertured ears E' in which is secured a pin on which is pivotally mounted the apertured end of a curved arm F. The free end of the arm F is also apertured to which is pivotally connected the apertured ears G' of a plate G which is secured on the top of a cover H by screws, which is adapted to fit over the jar and close the same. A lug F' is formed on the arm F so that the lid can be readily lifted 50 when desired. A shoulder F² is formed on the arm F adapted to engage the plate E when the arm is swung upwardly and hold the arm up into a vertical position so that the pickle or other article in the jar can be readily 55 removed from the jar.

In the modification shown in Fig. 3 the base I is formed of metal having a recess formed therein adapted to receive the jar for holding it in place.

Having thus fully described my invention, what I claim as new and desire to secure by Letters Patent is:—

A jar and cover holder comprising a circular base provided with an outwardly projecting portion, spring clips arranged on said base for supporting and holding a jar a standard secured on the outwardly projecting portion of the base, a plate secured on the upper end of said standard provided with vertical 70 spaced apertured ears, a pin secured in said ears, a curved arm mounted on said pin, a cover provided with spaced apertured ears pivotally connected to the free end of said arm, and a shoulder formed on said arm 75 adapted to engage the plate carried by the standard so as to hold the arm up in a vertical position.
