

HOLDER FOR CARDS, TICKETS, PAPERS, &c.

To all whom it may concern:

Be it known that I, Abbot Augustus Low, a citizen of the United States, residing at Horseshoe, St. Lawrence county, and 5 State of New York, have invented certain new and useful Improvements in Holders for Cards, Tickets, Papers, &c., of which the following is a specification.

My invention relates to devices for holding cards, tickets, papers and like articles which it is desired to carry upon the person or bind together temporarily or otherwise, and is designed to afford a plate of simple structure adapted for use in conjunction with one or more elastic bands by which the cards, tickets, papers or the like may be bound temporarily in such manner as to be conveniently accessible for use.

The invention consists in a plate of the 20 specific construction herein shown and described in combination with one or more elastic bands.

In the accompanying drawings, Figure 1, is an elevation of my holder plate; Fig. 2, a similar view showing the use of elastic bands in conjunction therewith, Fig. 3, an end edge view; Fig. 4, a side edge view; Fig. 5, a section upon plane of line 5—5, Fig. 1.

The plate 1 is made of metal of sufficient thickness to insure rigidity. It is elongated and rectangular in general configuration, and is preferably formed with a central longitudinal opening 2, to facilitate the handling and manipulation of cards, tickets or like articles placed upon the plate.

Each edge 3, of the plate 1 is formed with a series of undulatory notches, the notches in each series coinciding with those in the opposed outer edge of the plate. These

of an elastic retaining band or bands either transversely or longitudinally with relation to, and upon the plate, prevent accidental displacement of said band or bands. They also admit of the application of such elastic 45 retaining band or bands at practically any and all parts of the plate, as may be found most expedient under the varying conditions of actual use.

5, represents T-shaped slots which may 50 be provided for the purpose of receiving and inclosing the bights of the band if desired, but this feature forms no part of my invention.

Both sides of the plate may be utilized 55 as a backing or holder for cards, papers, &c., and the holder is designed especially for use as a pocket device, although applicable to various other uses temporarily and permanent in character.

What I claim as my invention and desire

to secure by Letters Patent is:

A card holder of the character described, comprising a single rigid elongated plate provided with a central elongated opening 65 and having a series of undulatory notches extending around its outer edge and provided with T-shaped apertures approximating its longitudinal center and also its transverse center, said T-shaped aperture 70 extending inwardly from one of the notches and adapted to receive a rubber band as and for the purpose described.
