

## CLOTHING-CASE.

To all whom it may concern:

Be it known that I, John A. Cunningham, a citizen of the United States, residing at Caruthersville, in the county of Pemiscot and State of Missouri, have invented new and useful Improvements in Clothing-Cases, of which the following is a specification.

This invention is an improved case or article of furniture for storing and exhibiting 10 clothing and the like articles and for use in stores or which may be also used for household purposes, the object of the invention being to provide in combination with a case having flooring and cross bars under the 15 flooring, the said flooring having openings at the ends of the case and the said case being further provided on the inner sides of its end with casings extending above the flooring and provided with openings in their 20 upper sides, a carrying rack in the case pivotally mounted at its lower side on the said bars and having its sides extending through and movable in the openings in the flooring and the said casings, the ends of the said 25 openings forming stops to limit the angular movement of the said carrying rack and the said rack being thereby adapted by a single lateral movement to instantly expose to view all of the clothing or other articles car-30 ried thereon, as hereinafter described and claimed.

In the accompanying drawings:—Figure 1 is a vertical longitudinal sectional view of a case or cabinet constructed in accordance with this invention. Fig. 2 is a transverse sectional view of the same, a portion of one of the casings in the case or cabinet being shown as broken away and in section.

In accordance with this invention, the case
or cabinet 1 which may be of the construction here shown or of any other suitable
construction and which may be of any suitable size is provided in its front side with a
door or doors 2 slidable in grooves 3 near
the upper and lower sides of the case.
Within the case is a rack or frame which is
made up of four pieces of pipe 12 connected
together by elbows 13, the said rack or
frame being quadrangular in form. The
lower side of the rack or frame bears in re-

cesses 14 in the upper sides of the bars 15 which are under the flooring 16 of the case or cabinet, said recesses and the engagement thereof by the said lower side of said rack or frame constituting a hinge connection be- 55 tween the rack or frame and the bottom of the case or cabinet. The sides of the said rack or frame extend up through openings in the bottom of the flooring and the lower portions of the said sides are concealed by 60 casings 17 in the ends of the case or cabinet which casings are provided in their upper sides with openings 18 through which the sides of the rack or frame extend, the ends of said openings constituting the stops 65 which respectively limit the inward and outward movement of the rack or frame. By thus providing the case with a pivotally mounted rack or carrying frame, all of the clothes or other articles carried by such rack 70 or frame may be instantly exposed to view by a single and comparatively short movement of said rack or frame as will be understood.

It will be also understood that a case or 75 other article of furniture embodying the improvements herein described may be constructed at comparatively small cost.

What is claimed is:—

A case of the class described having flooring and cross bars under the flooring, said flooring having openings at the ends of the case, and said case being further provided on the inner sides of its ends with casings extending above the flooring and provided with openings in their upper sides, and a carrying rack in the casing, pivotally mounted at its lower side on the said bars and having its sides extending through and movable in the openings in the floor and the 90 said casings, the ends of the said openings forming stops to limit the angular movement of the said carrying rack.
