

## COMBINATION BODY-GARMENT.

To all whom it may concern:

Be it known that I, CHARLES H. OSBORN, a citizen of the United States, residing at Hastings, county of Barry, State of Michi-5 gan, have invented certain new and useful Improvements in Combination Body-Garments, of which the following is a specification.

This improvement relates to an improved

10 combination body garment.

The main object of this invention is to provide a combination bust support, shoulder and arm-scye pad, and bust form or pad which is simple in construction and adapted 15 to support as well as to fill out the bust, and one which is readily adjusted.

Further objects, and objects relating to structural details, will definitely appear from the detailed description to follow.

I accomplish the objects of my invention by the devices and means described in the following specification.

The invention is clearly defined and

pointed out in the claims.

A structure embodying the features of my invention is clearly illustrated in the accompanying drawing, forming a part of this

specification, in which,

Figure 1 is a perspective view of my im-30 proved combination form, bust support and pad in position on a figure. Fig. 2 is a rear perspective view thereof. Fig. 3 is a front perspective thereof with a portion broken away to show the construction. Fig. 4 is an 35 enlarged section, taken on a line corresponding to line 4—4 of Fig. 3.

In the drawing, similar numerals of reference refer to similar parts throughout the

several views.

Referring to the drawing, my improved garment comprises a front portion; and a back, the parts 2 of the back being preferably adapted to overlap in closing, as clearly appears from Fig. 2. The front and back 45 are integral, or in one piece, and are pro-

vided with shoulder straps 3.

The means for securing the garment preferably consist of a waist tape 4, which may be brought around and tied in front, as 50 clearly appears in Fig. 1, thus enabling the drawing up of the garment to secure the desired fit for the waist portion thereof. As a further securing means I preferably provide a button 5 with a loop 6. It is ob-55 vious that other means for securing the garment might be provided.

The upper or bust portion 7 of the front 1 is convexed and provided with a pad, which is preferably formed by providing an inner pad casing wall 8, which extends 60 across the bust portion and is secured along its lower edge by a row of stitching 9 and along the front of the arm-holes by stitching 10, up on the shoulder strap and down on the side of the shoulder strap by stitch- 65 ing, as 11, the casing being left open at 12 so that the desired amount of filling material 13 can be placed therein, or adjusted to the shoulder strap portions and under the arm portions of the casing. The filling ma- 70 terial is preferably left loose so that this adjustment can be readily accomplished by the wearer, thus not only securing the desired fullness of the pad, but arranging it as may be desired to fit the form of the 75 particular wearer. The opening for the casing is preferably closed by the tape 14.

My improved bust support and form is designed by me for use in connection with or without a corset, especially a short corset 80 or waist, and I have shown the same as applied over a corset, as 15, a loop 16 being provided at the front for securing the garment to the corset, thus preventing its drawing up at the front. The front of the gar- 85 ment is preferably provided with stiffening blades 17, which extend upwardly from a central point at the lower edge of the corset onto the pad portion of the front, thereby preventing the wrinkling of the front and 90 forming a more effective support for the

wearer.

By this simple means, I secure a combination shoulder and arms-cye pad, bust support and form which is very effective, as it 95 not only effectively supports the body, but also forms an effective pad which may be readily adjusted to meet the requirements of the particular wearer, the pad extending onto the shoulders and in front of and under 100 the arms which obviates the necessity of further pads.

Having thus described my invention, what I claim as new and desire to secure

by Letters Patent is: 1. A combination body garment and pad comprising front, back and shoulder portions, said garment being open at the back, the parts of the back being adapted to overlap, said front portion being convexed 110 at the upper or bust portion thereof, an inner pad casing wall extending across said

front from a point under the arm openings and upwardly under the shoulder strap portions, said inner casing wall being secured to said front by stitching along its lower edge, the ends and shoulder strap portions to form a pad casing in the upper part of said front portion, a filling for said pad casing, vertically and diagonally arranged stiffening strips for the said front portion extending upwardly from a central point of the lower edge thereof upon the said pad casing, means for securing the garment at the back of the wearer comprising a waist belt or tape, and a corset engaging means on the lower edge of the

garment at the front thereof.

2. A combination body garment and pad comprising front, back and shoulder strap portions, said garment being open at the back, said front portion being convexed at the upper or bust portion thereof, an inner pad casing wall extending across said front from a point under the arm openings and upwardly under the shoulder strap portions, said inner casing wall being secured to said front by stitching leving to said front by stitching leving to said front by stitching leving the said front by stitching leving secured

to said front by stitching along its edge, the ends and shoulder strap portions to form a pad casing in the upper part of said front portion, a filling for said pad casing, vertically and diagonally arranged stiffening strips for the said front portion extending upwardly from a central point of the lower edge thereof upon the said pad casing, and means for securing the garment at the back of the wearer.

A combination body garment and pad comprising front, back and shoulder strap portions, said garment being open at the back, said front portion being convexed at the upper or bust portion thereof, an inner pad casing wall extending across said front from a point under the arm openings and upwardly under the shoulder strap portions, said inner casing wall being secured to said front by stitching along its lower edge, the ends and shoulder strap portions to form a pad casing in the upper part of said front

portion, a filling material for said pad casing, and means for securing the garment at the back of the wearer comprising a waist belt or tape, and a corset engaging means on the lower edge of the garment at the front thereof.

4. A combination body garment and pad casing wall extending across said front portion being convexed at the upper or bust portion thereof, an inner pad casing wall extending across said front

from a point under the arm openings and upwardly under the shoulder strap portions,

said inner casing wall being secured to said front by stitching along its lower edge, the ends and shoulder strap portions to form a pad casing in the upper part of said front 65 portion, a filling for said pad casing, and means for securing the garment at the back of the wearer.

5. A combination body garment and pad comprising front, back and shoulder strap 70 portions, said garment being open at the back, said front portion being convexed at the upper or bust portion thereof, an inner pad casing wall extending across said front from a point under the arm openings and 75 upwardly under the shoulder strap portions, said inner casing wall being secured to said front by stitching along its lower edge, the ends and shoulder strap portions to form a pad casing open at the top in the upper part 80 of said front portion, a filling of loose material of said pad casing, vertically and diagonally arranged stiffening strips for the said front portion extending upwardly from a central point of the lower edge thereof 85 upon the said pad casing, and means for securing the garment at the back of the wearer.

6. A combination body garment and pad comprising front, back and shoulder strap 90 portions, said garment being open at the back, the parts of the back being adapted to overlap, said front portion being convexed at the upper or bust portion thereof, a pad for the convexed portion of said front, vertically and diagonally arranged stiffening strips for the said front portion extending upwardly from a central point of the lower edge thereof upon the said pad casing, means for securing the garment at the back of the 100 wearer comprising a waist belt or tape, and a corset engaging means on the lower edge of the garment at the front thereof.

7. A combination body garment and pad comprising front, back and shoulder strap 105 portions, said garment being open at the back, said front portion being convexed at the upper or bust portion thereof, a pad for the convexed portion of said front, a filling for said pad casing, and vertically and diagnoally arranged stiffening strips for the said front portion extending upwardly from a central point of the lower edge thereof upon the said pad casing.
