



COMBINED TOBACCO CARTRIDGE AND STEM.

To all whom it may concern:

Be it known that I, Benjamin Ziegler, a citizen of the United States of America, residing at East Liverpool, in the county of Columbiana and State of Ohio, have invented certain new and useful Improvements in a Combined Tobacco Cartridge and Stem, of which the following is a specification, reference being had therein to the accompanying drawing.

This invention relates to tobacco products, and the primary object of the invention is to provide a novel pipe having the bowl there-of formed of tobacco, the pipe being smoked in the ordinary manner while the bowl is consumed similar to a cigar or cigarette.

Another object of the invention is to provide a novel tobacco holder for supporting a large quantity of tobacco, whereby the

With the above and other objects in view which will more readily appear as the invention is better understood the same consists in the novel construction, combination and arrangement of parts to be presently de-

scribed and then specifically claimed.

Referring to the drawings:—Figure 1 is a side elevation of the tobacco product, Fig. 2 is a similar view partly broken away and partly in section, and Fig. 3 is a horizontal sectional view of a portion of the tobacco

To put my invention into practice, I provide a pipe stem 1 with a small wooden heel 2 having a socket 3 formed therein communicating with the bore 4^a of the stem 1. Extending into the socket 3 of the heel 2 is a filler 4 and surrounding said filler and the heel 2 is a tobacco wrapper 5 adapted to hold the filler in engagement with the

The tobacco products supported by the heel 2 can be made similar to an ordinary cigar or stogie, the filler 4 being of an inferior tobacco relative to the tobacco wrapper 5, both products being consumed with the exception of the lower end of the wrapper 5, when the tobacco is ignited and the pipe smoked.

It will be observed from the foregoing description that I have devised a novel to-bacco holder, and since the filler can be made of various sizes, the pipes can be constructed with various quantities of tobacco according to the price at which the same is to be disposed of.

The pipe in shape is adapted to resemble an ordinary corn cob pipe having the greater portion of the bowl thereof made of tobacco, resembling somewhat a cigar having the stem stuck into the lower end of the same for creating a draft through the tobacco.

Having now described my invention what I claim as new, is:—

1. The combination with a pipe stem, a 65 heel carried by said stem and having a socket formed therein communicating with the bore of said stem, of a tobacco filler extending into the socket of said heel, and a tobacco wrapper surrounding said filler and 70 said heel for holding said filler in engagement with said heel.

2. The combination with a stem, a heel carried by said stem, of a tobacco filler extending into said heel, and a tobacco wrapper surrounding said filler and engaging said heel for holding said filler in engagement with said heel.

3. The combination with a stem having a smoke passage, and a heel connected to said stem and communicating with said smoke passage, of a tobacco filler mounted upon the heel, and a tobacco wrapper inclosing the filler and the heel and attached to the heel for connecting the filler thereto.

4. A tobacco product comprising a tobacco filler, a hollow heel connected with the lower end of said filler and having a smoke outlet to establish a draft through said filler, and a tobacco wrapper inclosing the filler and the heel and attached to the heel for connecting the filler thereto.
