

COMBINED LEDGER AND FILE.

To all whom it may concern:

Be it known that I, Lucien A. Blochman, a citizen of the United States, residing at San Diego, in the county of San Diego and State of California, have invented a certain new and useful Combined Ledger and File, of which the following is a specification, reference being had therein to the accompanying drawing.

My invention relates to an improved file; and has for its object to provide a file which may be used for a ledger and file combined, or a special account and file, or for a ledger and special account and file thus making a file which may include all the business pertaining to one person or to any certain class of business.

The invention consists of certain novel features in construction and arrangements and combinations of parts, as more fully described and set forth hereinafter.

Referring to the accompanying drawing which illustrates my invention for the purpose of explanation, the figure is a perspective view of my file.

The file shown here is composed of a heavy sheet of paper folded centrally forming two extending portions 5 and 6, portion 5 is notched centrally at 5^a and 5^a, and in these notches a rubber band 5^b is inserted; between said band 5^b and portion 5, any loose papers are filed, also between portions 5

and 6 when folded together loose papers may be filed, while on the outside of both portions ledger and cash account blanks are 35 printed.

It will thus be readily seen that with the above described file and ledger combined any individual account will be easily kept by debits and credits, or said cash accounts, etc. 40 together with a file for a variety of loose papers relating thereto or the accounts of any certain class of business may be thus systematized thus providing a quick and ready reference to accounts and to all papers 45 pertaining thereto, thus facilitating the system of accounts and files.

Having thus described my invention what I claim is:—

A file envelop comprising a flexible body 50 sheet folded centrally to form a compartment, one side of said compartment being centrally notched and provided with a rubber band inserted in said notches and a ledger blank printed on the outside thereof 55 to be used for ledger or other accounts, all substantially as set forth.
