

CLOTHING-BAG.

To all whom it may concern:

Be it known that I, André F. Bornor, a citizen of the United States, residing in the city and county of Philadelphia, State of Pennsylvania, have invented a new and useful Clothing-Bag, of which the following is a specification.

My invention consists of a bag adapted as a wrapper for clothing or garments, so as to protect the same from dust, dirt, rain and exterior contact, the bag having an open side, whereby access to its interior may be had, and having its top adapted to be carried by or sustained on a hanger, from which the clothing or garment may be suspended, while within the bag.

For the purpose of explaining the invention, the accompanying drawing illustrates a satisfactory reduction of the same to practice, but the important instrumentalities thereof may be varied, and so it is to be understood that the invention is not limited to the specific arrangement and organization

shown and described.

Figure 1 represents a perspective view of a clothing bag embodying my invention. Fig. 2 represents a transverse section thereof, on line x-x, Fig. 1.

Similar letters of reference indicate corre-

30 sponding parts in the figures.

Referring to the drawing:—A designates a bag which is formed of a piece of fabric folded on one side, as at B, producing a body with separated walls C, C, the opposite side being open, as at D, where the walls are provided with fastenings preferably of the form of snaps E, F, which when disconnected permit the bag to be opened to admit an article of clothing or a garment between the same.

The exterior surface of the bag is of water-proof material, so as to protect the garment from rain or moisture, while the garment is furthermore kept in clean condition without liability of dust and dirt reach-

ing the same.

The top of the bag is closed, excepting at the center, where the passage G exists, the same permitting the protrusion of the hook II of the clothes hanger J, on which latter the garment is suspended within the bag,

said hanger abutting against the inner wall of the top of the bag, so that the latter may be carried by said hook, and also if desired placed in a closet or elsewhere, while the 55 garment remains in the bag.

The end portions of the open side of the bag are folded on themselves, forming a double-thickness of material as at K, so as to reinforce said portions, affording in-60 creased strength for the attachment of the fastenings E, F, and avoiding the presentation of cut or raw edges of the material of the bag at said open side.

Having thus described my invention, what 65 I claim as new and desire to secure by Let-

ters Patent, is:—

1. A clothes bag of the character stated, consisting of a body composed of a folded piece of material, the sides of the body op- 70 posite to the fold being open, fastenings for the open side, the top of the bag being permanently closed and having a passage therein for a member of a clothes hanger, the body portion of which is adapted to rest 75 against the interior of said top.

2. A clothing bag of the character stated consisting of a body having a temporarily closed side and a permanently closed top, which is adapted to have a clothes hanger 80 abut against its interior thereof, and the carrying member of said hanger adapted to pass through said top, whereby the bag may

be sustained by said hanger.

3. A clothing bag of the character stated 85 consisting of a body having an open side, fastenings for the walls of said side at the edge thereof, an open bottom, and a closed top, the latter being adapted for the passage therethrough of a member of a clothes 90 hanger, which is adapted to sustain the bag.

4. A clothes bag of the character stated consisting of an open bottomed body composed of a folded piece of material, the side of the body opposite to the fold being open 95 and the top permanently closed, the bottom being open, the end portions of the open side having reinforcing members thereon, and fastenings for said side connected with said members at the edge opposite said fold.

5. A clothes bag of the character stated consisting of a body composed of a folded

piece of material, the side of the body opposite to the fold being open, the end portions of the open side having reinforcing members thereon, and fastenings for said side connected with said members, the top of the

bag being closed and having a passage there-in for a member of a clothes hanger adapted

to be placed in the body and rested against the interior of said top.
