

FAINT-BRUSH HOLDER.

To all whom it may concern:

Be it known that I, CHARLES H. JOREY, a citizen of the United States, residing at Seymour, in the county of New Haven and 5 State of Connecticut, have invented a new and useful Improvement in Paint-Brush Holders; and I do hereby declare the following, when taken in connection with the accompanying drawings and the numerals of .10 reference marked thereon, to be a full, clear, and exact description of the same, and which said drawings constitute part of this specification, and represent, in—

Figure 1 is a top or plan view of a pail with 15 a brush holder constructed in accordance with my invention resting thereon. Fig. 2 a sectional view on the line a-b of Fig. 1.

This invention relates to an improvement in paint brush holders, that is a device 20 adapted to set upon a paint pail and so as to hold the brushes suspended at such a point that the bristles will be submerged in the paint so that they will not dry, and so that they will not become bent as is the case when 25 the brushes rest upon the bottom of a pail.

The object of the invention is a simple construction of a device for this purpose formed from wire which may be readily applied to any paint pail; and the invention 30 consists in the construction hereinafter described and particularly recited in the claim.

In carrying out my invention I form the holder from a single piece of wire. This wire is folded together at the center and 35 bent downward to form a leg 2 and the ends

of the wires are bent downward to form legs 3, 4. Between the legs the wires are bent back and forth to form fingers 5 to 11, more or less in number, between which the handles of paint brushes may be passed as 40 shown in Fig. 2 of the drawings. Preferably and as herein shown the wires adjacent to each leg are bent upward so that the fingers are raised in a plane above the ends of the wires and so that when the device rests 45 upon the top of the pail the fingers will stand above the top of the pail, and so that if the pail be nearly full the brushes are not necessarily submerged above their heads.

It will be seen that these brushes may be 50 suspended at any desired point so that the bristles will be submerged, and will not become bent by resting upon the bottom of a pail.

I claim:—

A paint-brush holder formed from wire and comprising a central portion consisting of a plurality of horizontally arranged fingers formed by looping the wire, and radial extensions from the center, and two ends 60 forming legs to support the device on the top of a pail.
