

To all whom it may concern:

Be it known that I, Adelaide Smith, a citizen of the United States, residing at St. Marys, Province of Ontario, Dominion of Canada, have invented new and useful Improvements in Wrinkle-Masks, of which the following is a specification.

My invention relates to certain new and useful improvements in wrinkle masks and consists in the novel combination and arrangement of parts as will be hereinafter more particularly described and pointed out in the claim.

In the drawing:—Figure 1 is a perspective view of my complete invention as applied to the face of a person. Fig. 2 is a side elevation of the same removed from the face, and Fig. 3 is a fragmentary vertical

sectional view through the mask.

The object of my invention is to provide a comparatively simple and practical wrinkle mask constructed of suitable pliable material preferably of rubber, which is adapted to envelop or cover the face or portion thereof to be treated and further for providing suitable means forming a part of the same for embracing the hair or head portion of the user, whereby the wrinkles or other deformities of the face may be easily and readily removed as will appear from the following detail description.

Referring to the drawing 1 represents an elastic or flexible continuous band which is adapted to encircle or embrace the face of the person as clearly shown in Fig. 1 of the drawing, and formed with or attached to said band is thin rubber or other flexible material 2 which is also adapted to closely or snugly embrace the face or other portion thereof to be treated or operated upon, which forms a mask embracing the face, the opening 3 formed in said mask exposing to view the prominent features of the face as clearly shown in Fig. 1. The thin rubber or other flexible material 2 of the mask thus formed is preferably provided with openings

or perforations 4 through which air is admitted to the face or that portion thereof to be treated, and attached to the elastic or flexible band 1 in any suitable or mechanical 50 manner is a hood of suitable textile material 5 which is adapted to embrace or envelop the head of the user in a manner as clearly shown in said Fig. 1 for holding the said mask in its proper position on the head in 55 respect to the face thereof, the said mask being further and more securely held in position by tie strings 6.

It will be noted by the foregoing description and particularly to the drawing that 60 the elastic or flexible band 1 practically surrounds the face of the user with its flexible and pliable extension or mask 2 covering that portion of the face to be treated and by its application thus described all facial 65 blemishes or defects are entirely removed by

its proper use and application.

My invention dispenses with the usual work in massaging, employed for removing the wrinkles or blemishes from the face, and 70 can be used at any time more particularly, however, at nights while the patient is sleeping.

Having thus described my invention what I claim is:—

A wrinkle mask comprising a substantially circular and non-adhesive perforated rubber plate having an elongated central opening for the prominent features of the face, an elastic band located on the outer 80 face and at the outer periphery of said plate, and a hood of knitted material to house the hair, having one end secured between the band and plate and extending substantially half way around the band and plate, and its 85 opposite end provided with a running string.
