(57) **ABSTRACT**

A method for software code integration from media files includes comparing portions of development code in an integrated development environment to a plurality of classified portions of a plurality of media files. The method also includes identifying a first classified portion of a first media file from the plurality of media files for integration into the development code, where the first classified portion includes a first snippet of code associated with a first function. Responsive to receiving a user confirmation, the method also includes extracting the first snippet of code associated with the first function. The method also includes integrating the first snippet of code associated with the first function into the development code in the integrated development environment.

SOFTWARE CODE INTEGRATION FROM A MEDIA FILE

BACKGROUND

This disclosure relates generally to software code integration, and in particular to integrating software code sourced from a media file in an integrated development environment.

An integrated development environment (IDE) is software utilized for creating applications that combing common developer tools into a single graphical user interface (GUI) with which a user interacts. A typical IDE includes a source code editor for assisting the user with code creation, a local build automation for automating repeatable tasks as part of creating a local build of software, and a debugger for 15 testing other programs that can visually display in a GUI the location of a bug in the code. An IDE also allows for the user to utilize code snippets from various locations by importing the code snippets from the various locations into the code being created by the user.

from a media file into development code in an integrated development environment. As a user modifies code in the integrated development environment, the code integration module can receive a user selection or provide a selection of one or more portions of a media file (e.g., image or video) that include snippets of code for integration into the development code. The code integration module can perform video analysis on the media file to identify textual content relating to code and identify code based on the textual content. The code integration module can classify portions 10 of the media file based on code functionality and store the classified portions of the media file in a media library accessible through the integrated development environment. The code integration module can analyze the development code and identify classified portions of a media file for integration into the development code based on required functionality. Code integration module presents the identified classified portions of the media file to the user for selection and confirmation of inclusion into the development 20 code. Alternatively, code integration module receives a user selection for a classified portion of a media file for integration into the development and learns user preferences for future identification of classified portions. The code integration module extracts one or more code snippets from each of the classified portions of the media file and displays any compilation errors during the integration process between the extracted one or more code snippets and the development code. By integrating the extracted one or more code snippets, the code integration module creates a single process flow for the development code that includes the desired functionality. The code integration module can continuously learn with each code snippet integration into the development code to identify user coding patterns and preferences when integrating the classified portions of media files in the development code. SUMMARY

Embodiments in accordance with the present invention disclose a method, computer program product and computer system for software code integration from media files, the method, computer program product and computer system can compare portions of development code in an integrated development environment to a plurality of classified portions of a plurality of media files. The method, computer program product and computer system can identify a first classified portion of a first media file from the plurality of media files for integration into the development code, wherein the first classified portion includes a first snippet of code associated with a first function. The method, computer program product and computer system can, responsive to receiving a user confirmation, extract the first snippet of code associated with the first function. The method, computer program product and computer system can integrate the first snippet of code associated with the first function into the development code in the integrated development envi-⁴⁰ ronment.

BRIEF DESCRIPTION OF THE SEVERAL VIEWS OF THE DRAWINGS

FIG. 1 is a functional block diagram illustrating a distributed data processing environment, in accordance with an embodiment of the present invention.

FIG. 2 is a flowchart depicting of a code integration module for integrating software code sourced from media ⁵⁰ files, in accordance with an embodiment of the present invention.

FIG. 3 illustrates an example of a code integration module operating in an integrated development environment, in accordance with an embodiment of the present invention.

FIG. 4 is a block diagram of components of a computer system, such as the server computer of FIG. 1, in accordance with an embodiment of the present invention.
FIG. 5 depicts a cloud computing environment, in accordance with an embodiment of the present invention.
FIG. 6 depicts abstraction model layers, in accordance with an embodiment of the present invention.

can also provide a recommendation to the user on how to capture a media file to accelerate and increase an accuracy of a code extraction process for a classified portion of a media file for integration into the development code.

FIG. 1 is a functional block diagram illustrating a distributed data processing environment, generally designated 100, in accordance with one embodiment of the present invention. The term "distributed" as used herein describes a computer system that includes multiple, physically distinct devices that operate together as a single computer system. FIG. 1 provides only an illustration of one implementation and does not imply any limitations with regard to the environments in which different embodiments may be implemented. Many modifications to the depicted environments of the scope of the invention as recited by the claims.

Distributed data processing environment includes server computer 102 and client device 104, interconnected over network 106. Server computer 102 can be a standalone computing device, a management server, a web server, a mobile computing device, or any other electronic device or computing system capable of receiving, sending, and processing data. In other embodiments, server computer 102 can represent a server computing system utilizing multiple computers as a server system, such as in a cloud computing environment. In another embodiment, server computer 102 can be a laptop computer, a tablet computer, a netbook computer, a personal computer (PC), a desktop computer, a smart phone, or any programmable electronic device capable of communicating with client device 104 and other computing devices (not shown) within the distributed data

DETAILED DESCRIPTION

Embodiments of the present invention include a code integration module for integrating software code sourced

processing environment via network 106. In another embodiment, server computer 102 represents a computing system utilizing clustered computers and components (e.g., database server computers, application server computers, etc.) that act as a single pool of seamless resources when 5 accessed within the distributed data processing environment. Server computer 102 includes integrated development environment **108** with code integration module **110** and database 112. Server computer 102 may include internal and external hardware components, as depicted and described in further 10 detail with respect to FIG. 4.

Client device 104 can be a laptop computer, a tablet computer, a smart phone, smart watch, a smart speaker, or any programmable electronic device capable of communicating with various components and devices within the 15 distributed data processing environment, via network 106. Client device 104 may be a wearable computer. Wearable computers are miniature electronic devices that may be worn by the bearer under, with, or on top of clothing, as well as in or connected to glasses, hats, or other accessories. Wear- 20 able computers are especially useful for applications that require more complex computational support than merely hardware coded logics. In general, client device 104 represents one or more programmable electronic devices or combination of programmable electronic devices capable of 25 executing machine readable program instructions and communicating with other computing devices (not shown) within the distributed data processing environment via a network, such as network 106. In one embodiment, client device 104 represents one or more devices associated with 30 a user. Client device 104 includes an instance of user interface 114 displaying content and interacting with integrated development environment 108 with code integration module **110**.

In the event code integration module **110** does not receive a user confirmation for integrating the identified classified portion of the media file, code integration module 110 receives a user selection for a classified portion of the media file for integration into the development code and extracts the code from the classified portion of the media file. In the event code integration module 110 receives a user confirmation for integrating the identified classified portion of the media file, code integration module 110 extracts the code from the classified portion of the media file. Subsequent to extracting the code, code integration module 110 integrates the extracted code from the classified portion of the media file into the development code. Database 112 is a repository for data used by code integration module 110. In the depicted embodiment, database 112 resides on server computer 102. In another embodiment, database 112 may reside on client device 104 or elsewhere within the distributed data processing environment provided code integration module 110 has access to database 112. A database is an organized collection of data. Database 112 can be implemented with any type of storage device capable of storing data and media files that can be accessed and utilized by code integration module 110, such as a database server, a hard disk drive, or a flash memory. Database 112 stores the data and the media files used by code integration module 110, such as, images with code snippets and videos with code snippets. User interface 114 enables a user to make requests of or issue commands to client device 104 and receive information and instructions in response. In one embodiment, a user of client device 104 accesses user interface 114 via voice commands in natural language. In one embodiment, user interface 114 may be a graphical user interface (GUI) or a Network 106 can be, for example, a telecommunications 35 web user interface (WUI) and can display text, documents, web browser windows, user options, application interfaces, and instructions for operation, and include the information (such as graphic, text, and sound) that a program presents to a user and the control sequences the user employs to control the program. In another embodiment, user interface 114 may also be mobile application software. In an example, mobile application software, or an "app," is a computer program designed to run on smart phones, tablet computers and other mobile devices. User interface **114** enables a user of client device **104** to interact with integrated development environment 108 and code integration module 110. FIG. 2 is a flowchart depicting of a code integration module for integrating software code sourced from media files, in accordance with an embodiment of the present invention. Code integration module 110 receives a media file for code generation (202). The media file represents an image with at least one code snippet or a video with at least one code snippet, where a code snippet includes one or more lines of code. In one embodiment, code integration module 110 receives a media file for code generation from a user of an integrated development environment (IDE), where the user uploads an image (e.g., screenshot) or a video (e.g., tutorial video) with the code snippets. Code integration module **110** also allows for the user of the IDE to provide a link to a web-based media content platform that is hosting the media file, where code integration module 110 accesses the media file through the provided link to the web-based media content platform to obtain the media file. With every media file that code integration module 110 receives, code integration module 110 retains the media file in a database for utilization in a media file library in the IDE.

network, a local area network (LAN), a wide area network (WAN), such as the Internet, or a combination of the three, and can include wired, wireless, or fiber optic connections. Network **106** can include one or more wired and/or wireless networks capable of receiving and transmitting data, voice, 40 and/or video signals, including multimedia signals that include voice, data, and video information. In general, network 106 can be any combination of connections and protocols that will support communications between server computer 102 and client device 104, and other computing 45 devices (not shown) within the distributed data processing environment.

Integrated development environment **108** is software utilized by a user of client device 104 for creating applications that combing common developer tools into a single graphi- 50 cal user interface (GUI) with which a user interacts through user interface 114. Integrated development environment 108 includes code integration module 110 for integrating software code sourced from a media file into development code. Code integration module 110 receives a media file for code 55 generation from database 112 or a web-based media content provider. Code integration module 110 identifies textual content relating to code in the media file and identifies code in the media file based on the textual content. Code integration module 110 classifies portions of the media files 60 based on code functionality and stores the classified portions of the media file in a media library associated with integrated development environment 108. Code integration module 110 compares portions of development code that a user is interacting with to the classified portions of the media file 65 and identifies a classified portion of the media file for integration into the development code.

Code integration module 110 identifies textual content relating to code (204). Code integration module 110 performs video analysis on the media file to identify textual content relating to code. The textual content can include but is not limited to closed captioning, a title for the media file, 5 a file name for the media file, an associated description for the media file, text displayed in single frame of a video file, text displayed in an image file, and metadata associated with the media file. Closed captioning represents displayable text in the media file that provides additional or interpretive 1 information. For example, if a media file is a tutorial video of a professor teaching coding techniques, the closed captioning can include audible words spoken by the professor during the tutorial video. An associated description includes a brief overview for the media file. For example, if a media 15 file is the tutorial video of the professor teaching coding techniques, the description can include a summary of the coding techniques and a link to a portion of the tutorial video associated with a specific technique being taught. Text displayed in a single frame or a video file or an image file, 20 includes text identifiable by the code integration module 110 through the video analysis. For example, if a media file is a tutorial video of a professor teaching coding techniques where the professor transitions between a camera classroom view and screen sharing view with a coding program, code 25 integration module 110 can identify text on a display board in the camera classroom view and text in the screen sharing view with the coding program. In one embodiment, code integration module 110 identifies textual content relating generally to code, where the textual content is not specific to 30 the development code that the user is modifying in the IDE. In another embodiment, code integration module **110** identifies textual content relating to code specific to one or more function in the development code that the user is modifying in the IDE. Code integration module **110** identifies code in the media file based on the contextual content (206). Code integration module 110 utilizes the contextual content to identify snippets of code present in the media file and associates the identified snippets of code with one or more functions. In 40 one example, a video file includes a professor teaching an online class how to perform function A, while going through a step-by-step process for creating a snippet of code associated with function A. The step-by-step process for creating the snippet of code associated with function A is presented 45 by the professor as part of a screen share for a software coding program. Based on the previously identified contextual content, code integration module 110 identifies the code relates to function A and code integration module 110 performs text detection and recognition on the video to 50 identify the code snippet being presented by the professor in the step-by-step process. In another example, an image file includes a screenshot of a snippet of code in a software coding program. Based on the previously identified contextual content, code integration module **110** identifies the code 55 relates to function B based on a file name for the media file. Code integration module 110 performs text detection and recognition on the image with the screenshot to identify the code snippet associated with function B. Code integration module 110 classifies portions of the 60 media file based on code functionality (208). Code integration module **110** classifies portions of the media file based on code functionality for the previously identified code in the media file. In one example, a video file includes a professor teaching an online class how to perform functions A, B, and 65 C, while going through a step-by-step process for creating a snippet of code associated with each function A, B, and C.

Code integration module **110** identifies code in the video file based on the contextual content and associates a first snippet of code in a first portion of the video with function A, a second snippet of code in a second portion of the video with function B, and a third snippet of code in a third portion of the video with function C. Code integration module 110 classifies the portions of the video files based on code functionality (i.e., function A, function B, and function C) for future utilization in development code that a user is modifying in an IDE. In another example, an image file includes a screenshot of a snippet of code in a software coding program, where code integration module 110 identifies code relating to function D in the screenshot. Code integration module 110 classified the image file with the snippet of code based on functionality (i.e., function D) for future utilization in development code that user is modifying in an IDE. Code integration module **110** stores the classified portions of the media file in a media library in the IDE (210). Code integration module 110 stores the classifieds portions of the media file in the media library in the IDE, where the media library is searchable by code integration module 110 and a user of the IDE modifying development code. Code integration module **110** compares portions of development code to the classified portions of the media file (212). As the user modifies development code in the IDE, code integration module 110 compares portions of the development code to the classified portions of the media files available in the media library in the IDE. Code integration module 110 analyzes the development code being modified for one or more required functions and compares the one or more required functions to the various code functions of the classified portions of the media files. Code integration module 110 identifies a classified por-35 tion of a media file for integration into the development code (214). Based on the comparison between the one or more required functions in the development code and the various code functions of the classified portions of the media files, code integration module 110 identifies a classified portion of a media file for integration into the development code. The classified portion of the media file for integration into the development code includes one or more code snippets for one or more functions for integration into the development code being modified by the user in the IDE. In one embodiment, code integration module 110 displays an overlay in the IDE with the media file and highlights the classified portion of the media that includes a code snippet for integration into the development code. In another embodiment, code integration module 110 highlights the media file in the media library section of the IDE, where code integration module 110 also highlights a portion of the media with the identified portion with a code snippet for integration into the development code. Code integration module 110 can provide a recommendation to the user with the identified classified portion of the media file and a summary of the media file with the code snippet associated with the identified classified

portion.

Code integration module **110** determines whether a user confirmation was received (decision **216**). As discussed above, code integration module **110** can highlight the media file in the media library section of the IDE, where code integration module **110** also highlights a portion of the media with the identified portion with a code snippet for integration into the development code. Code integration module **110** can display a notification where a user inputs a confirmation for integrating the identified classified portion of the media. In the event code integration module **110**

determines a user confirmation was not received by the user rejecting the classified portion ("no" branch, decision **216**), code integration module **110** receives a user selection for a classified portion of a media file for integration into the development code (**218**). In the event code integration 5 module **110** determines a user confirmation was received ("yes" branch, decision **216**), code integration module **110** extracts code from the classified portion of the media file (**220**).

Code integration module **110** receives a user selection for 10 a classified portion of a media file for integration into the development code (**218**). If the user previously rejected integrating the identified classified portion of the media file,

the corrective action and subsequently performs the corrective action for a future integration of extracted code from a classified portion of a media file relating to a similar function. Code integration module **110** continuously learns how the extracted code is integrated into the development code and can provide the user with recommendations for future integrations between the extracted code and the development code.

FIG. 3 illustrates an example of a code integration module operating in an integrated development environment, in accordance with an embodiment of the present invention. In this embodiment, integrated development environment is a software utilized by a user of a client device for creating applications that combing common developer tools into a single graphical user interface (GUI) with which a user interacts through user interface 302. User interface 302 includes media library 304 provided by code integration module 110 for storing classified portions of media files based on code functionality, where code integration module 110 previously identified code in the media files based on textual content located in media library 304. Media file 306 and 308 each represent a video file, where each media file **306** and **308** includes classified portions with code snippets for integration into development code being modified by the user. For media file 308, first classified portion 310 includes a first code snippet associated with a first function and second classified portion 312 includes a second code snippet associated with a second function. As the user modifies the development code in the integrated development environment, code integration module 110 compares portions of the development code, such as development code portion 314 and 316, and identifies a classified portion of a media file in media library 304 for integration into the development code based on development code portion 314 and 316. In this embodiment, code integration module 110 identifies second classified portion 312 of media file **308** as including a second code snippet with a second function for integration into the development code. In response to receiving a user confirmation to integrate the second code snippet with the second function into the development code, code integration module 110 extracts code **318** (i.e., the second code snippet) from second classified portion 312 of media file 308 and integrates code 318 into the development code in the integrated development environment. FIG. 4 depicts computer system 400, where server computer 102 is an example of a computer system 400 that includes code integration module **110**. The computer system includes processors 404, cache 416, memory 406, persistent storage 408, communications unit 410, input/output (I/O) interface(s) **412** and communications fabric **402**. Communications fabric 402 provides communications between cache 416, memory 406, persistent storage 408, communications unit **410**, and input/output (I/O) interface(s) **412**. Communications fabric 402 can be implemented with any architecture designed for passing data and/or control information between processors (such as microprocessors, communications and network processors, etc.), system memory, peripheral devices, and any other hardware components within a system. For example, communications fabric 402 can be implemented with one or more buses or a crossbar switch. Memory 406 and persistent storage 408 are computer readable storage media. In this embodiment, memory 406 includes random access memory (RAM). In general, memory 406 can include any suitable volatile or non-volatile computer readable storage media. Cache 416 is a fast

code integration module **110** allows for the user to search the media library based on a described code functionality and 15 select another classified portion of a media file for integration into the development code. The media library allows for the user to perform a search based on a desired functionality of a code and select an appropriate classified portion of the media file for integration into the development code. Based 20 on the user selection of another classified portion and the previous rejection of the classified portion, code integration module **110** learns for a future identification of code snippets from a classified portion of a media file for integration into the development code. For example, a user previously 25 rejected integrating code snippet A for a first identified classified portion of a media file relating to function B. Subsequently, code integration module **110** receives a user selection for integrating code snippet B for a second identified classified portion of a media file relating to function B, 30 where code snippet B is a different method of performing function B compare to code snippet A. Code integration module **110** learns this distinction for a future identification of code snippets from a classified portion of a media file for integration into the development code, where code integra- 35

tion module **110** identifies code snippet B rather than code snippet A to perform function B.

Code integration module 110 extracts code from the classified portion of the media file (220). For an instance where the media file is an image file, code integration 40 module **110** extracts text (i.e., letters, numbers, and symbols) from the classified portion of the media file and based on the extracted text, generates the code for integration into the development code to perform a desired function. For an instance where the media file is a video file, code integration 45 module **110** extracts text (i.e., letters, numbers, and symbols) from multiple frames of the classified portion of the media file. Code integration module 110 compiles the extracted text from the multiple frames of the classified portions and generates the code for integration into the development 50 code. During the compiling of the extracted text from the multiple frames, code integration module 110 can identify additions and deletion that occur between the multiple frames of the classified portion of the video file. Code integration module **110** generates a final code for integration 55 into the development code to perform a desired function. Code integration module 110 integrates the extracted code from the classified portion of the media file into the development code (222). Code integration module 110 integrates the extracted code from the classified portion of the media 60 via the IDE into the development code, where the user can simultaneously view code integration module 110 compiling the final code. If a compilation error occurs during the integration between the extracted code and the development code, code integration module 110 generates an error noti- 65 fication, where a user can take a corrective action to resolve the compilation error. Code integration module 110 learns

What is claimed is:

1. A method comprising:

identifying textual content relating to code associated with a plurality of media files that includes a first media file, wherein a portion of the textual content includes an associated description with a summary of coding techniques presented in the first media file;

comparing portions of development code in an integrated development environment to a plurality of classified portions presented in the plurality of media files;
identifying a first classified portion presented in the first media file from the plurality of media files for integration into the development code based on the portion of

the textual content, wherein the first classified portion includes a first snippet of code associated with a first function;

responsive to receiving a user confirmation, extracting, from the first media file, the first snippet of code associated with the first function; and integrating the first snippet of code associated with the first function into the development code in the integrated development environment.

2. The method of claim 1, further comprising:
identifying the first snippet of code presented in the first media file based on the portion of textual content;
classifying the first snippet of code based on at least the first function, wherein the first snippet of code is associated with the first classified portion of the first media file from the plurality of classified portions of the plurality of media files; and

storing the first classified portion of the first media file in a media library in the integrated development environment.

3. The method of claim 2, wherein the textual content is selected from a group consisting of: closed captioning, a title for the first media file, a file name for the first media atoll text displayed in single frame of a video in the first media file, text displayed in an image in the first media file, and metadata associated with the first media file.
4. The method of claim 1, further comprising: identifying a second classified portion of the first media file from the plurality of media files for the integration into the development code, wherein the second classified portion includes a second snippet of code associated with a second function;

responsive to receiving a user rejecting the second classified portion, receiving a user selection with a third classified portion of a second media file from the plurality of media files for the integration into the development code, wherein the third classified portion 5includes a third snippet of code associated with the second function;

- extracting the third snippet of code associated with the second function; and
- integrating the third snippet of code associated with the second function into the development code in the integrated development environment.
- 5. The method of claim 1, further comprising:

9. The computer program product of claim 8, the stored program instructions further comprising:

- program instructions to identify the first snippet of code presented in the first media file based on the portion of the textual content;
- program instructions to classify the first snippet of code based on at least the first function, wherein the first snippet of code is associated with the first classified portion of the first media file from the plurality of classified portions of the plurality of media files; and program instructions to store the first classified portion of the first media file in a media library in the integrated development environment.

responsive to identifying a compilation error, generating an error notification with the compilation error between the first code snippet and the development code.

6. The method of claim 1, wherein extracting the first snippet of code associated with the first function further comprises:

extracting text from an image of the first classified portion of the first media file, wherein the text includes a plurality of letters, numbers, and symbols; and generating, based on the text, the first snippet of code for the integration into the development code to perform 25 the first function.

7. The method of claim 1, wherein extracting the first snippet of code associated with the first function further comprises:

- extracting text from a plurality of frames in a video of the 30 first classified portion of the first media file, wherein the text includes a plurality of letters, numbers, and symbols;
- identifying a first text addition and a first text deletion that occur between the plurality of framed in the video; and 35

10. The computer program product of claim 9, wherein 15 the textual content is selected from a group consisting of: closed captioning, a title for the first media file, a file name for the first media file, text displayed in single frame of a video in the first media file, text displayed in an image in the first media file, and metadata associated with the first media 20 file.

11. The computer program product of claim 8, the stored program instructions further comprising:

program instructions to identify a second classified portion of the first media file from the plurality of media files for the integration into the development code, wherein the second classified portion includes a second snippet of code associated with a second function;

program instructions to, responsive to receiving a user rejecting the second classified portion, receive a user selection with a third classified portion of a second media file from the plurality of media files for the integration into the development code, wherein the third classified portion includes a third snippet of code associated with the second function;

program instructions to extract the third snippet of code associated with the second function; and program instructions to integrate the third snippet of code associated with the second function into the development code in the integrated development environment. **12**. The computer program product of claim **8**, the stored program instructions further comprising: program instructions to, responsive to identifying a compilation error, generate an error notification with the compilation error between the first code snippet and the development code. 13. The computer program product of claim 8, wherein extracting the first snippet of code associated with the first function, the stored program instructions further comprises: program instructions to extract text from an image of the first classified portion of the first media file, wherein the text includes a plurality of letters, numbers, and symbols; and

generating, based on the text with the first text addition and the first text deletion, the first snippet of code for the integration into the development code to perform the first function.

8. A computer program product comprising one or more 40 computer readable storage media and program instructions collectively stored on the one or more computer readable storage media, the stored program instructions executable by one or more computer processors, the stored program instructions comprising: 45

program instructions to identify textual content relating to code associated with a plurality of media files that includes a first media file, wherein a portion of the textual content includes an associated description with a summary of coding techniques presented in the first 50 media file;

program instructions to compare portions of development code in an integrated development environment to a plurality of classified portions presented in a plurality of media files; 55

program instructions to identify a first classified portion presented in the first media file from the plurality of media files for integration into the development code based on the portion of the textual content, wherein the first classified portion includes a first snippet of code 60 associated with a first function; program instructions to, responsive to receiving a user confirmation, extract, from the first media file, the first snippet of code associated with the first function; and program instructions to integrate the first snippet of code 65 associated with the first function into the development code in the integrated development environment.

program instructions to generate, based on the text, the first snippet of code for the integration into the development code to perform the first function.

14. The computer program product of claim 8, wherein extracting the first snippet of code associated with the first function, the stored program instructions further comprises: program instructions to extract text from a plurality of frames in a video of the first classified portion of the first media file, wherein the text includes a plurality of letters, numbers, and symbols; program instructions to identify a first text addition and a first text deletion that occur between the plurality of framed in the video; and program instructions to generate, based on the text with the first text addition and the first text deletion, the first

snippet of code for the integration into the development code to perform the first function.

15. A computer system comprising: one or more computer processors;

one or more computer readable storage media; and program instructions stored on the computer readable storage media for execution by at least one of the one or more computer processors, the program instructions comprising:

program instructions to identify textual content relating to code associated with a plurality of media files that ¹⁰ includes a first media file, wherein a portion of the textual content includes an associated description with a summary of coding techniques presented in the first media file;

17. The computer system of claim 16, wherein the textual content is selected from a group consisting of: closed captioning, a title for the first media file, a file name for the first media file, text displayed in single frame of a video in the first media file, text displayed in an image in the first media file, and metadata associated with the first media file. **18**. The computer system of claim **15**, the stored program instructions further comprising:

program instructions to identify a second classified portion of the first media file from the plurality of media files for the integration into the development code, wherein the second classified portion includes a second snippet of code associated with a second function; program instructions to, responsive to receiving a user rejecting the second classified portion, receive a user selection with a third classified portion of a second media file from the plurality of media files for the integration into the development code, wherein the third classified portion includes a third snippet of code associated with the second function; program instructions to extract the third snippet of code associated with the second function; and program instructions to integrate the third snippet of code associated with the second function into the development code in the integrated development environment. **19**. The computer system of claim **15**, the stored program instructions further comprising: program instructions to, responsive to identifying a compilation error, generate an error notification with the compilation error between the first code snippet and the development code. **20**. The computer system of claim **15**, wherein extracting the first snippet of code associated with the first function, the stored program instructions further comprises:

- program instructions to compare portions of development ¹⁵ code in an integrated development environment to a plurality of classified portions presented in a plurality of media files;
- program instructions to identify a first classified portion presented in the first media file from the plurality of ²⁰ media files for integration into the development code based on the portion of the textual content, wherein the first classified portion includes a first snippet of code associated with a first function;
- program instructions to, responsive to receiving a user ²⁵ confirmation, extract, from the first media file, the first snippet of code associated with the first function; and program instructions to integrate the first snippet of code associated with the first function into the development 30 code in the integrated development environment.

16. The computer system of claim 15, the stored program instructions further comprising:

program instructions to identify the first snippet of code presented in the first media file based on the portion of the textual content;

program instructions to classify the first snippet of code based on at least the first function, wherein the first snippet of code is associated with the first classified portion of the first media file from the plurality of classified portions of the plurality of media files; and 40 program instructions to store the first classified portion of the first media file in a media library in the integrated development environment.

- program instructions to extract text from an image of the first classified portion of the first media file, wherein the text includes a plurality of letters, numbers, and symbols; and
- program instructions to generate, based on the text, the first snippet of code for the integration into the development code to perform the first function.
