(57) **ABSTRACT**

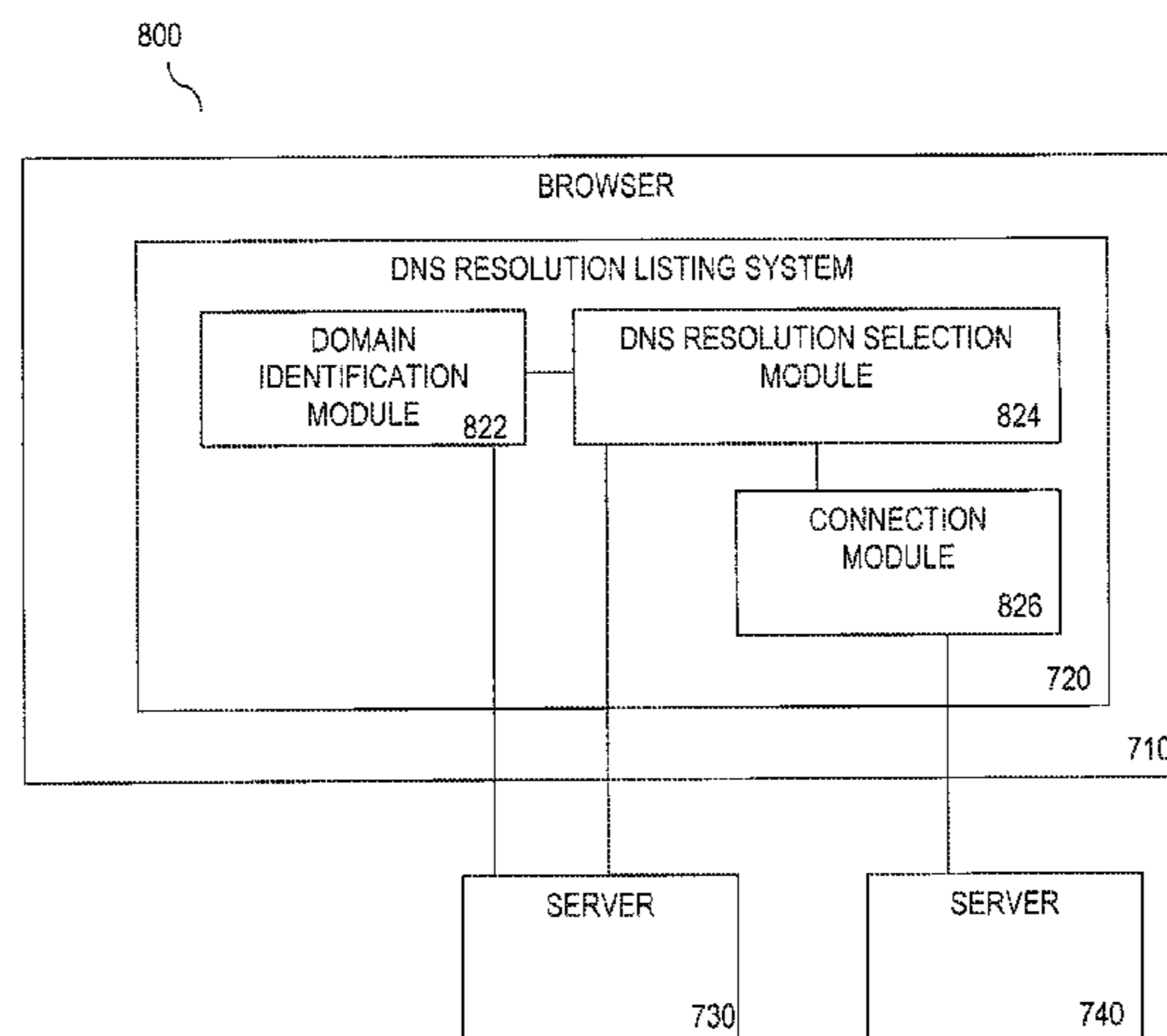

Methods and systems for using and providing trustworthy DNS resolutions are provided. A method for using trustworthy DNS resolutions may include obtaining a DNS resolution listing for a domain name and validating the listing's plausibility using a plausible range list. The method may also include selecting a DNS resolution from the DNS resolution listing based on a requested host associated with the domain name. The method may further include initiating a connection to the host using the selected DNS resolution. A method for providing trustworthy DNS resolutions may include obtaining a plurality of potential DNS resolutions for a domain name. The method may also include generating a DNS resolution listing for a domain name and providing the DNS resolution listing. A system may include a DNS resolution selection module and a connection module. Another system may include a DNS resolution inquiry module and a DNS resolution listing provision module.

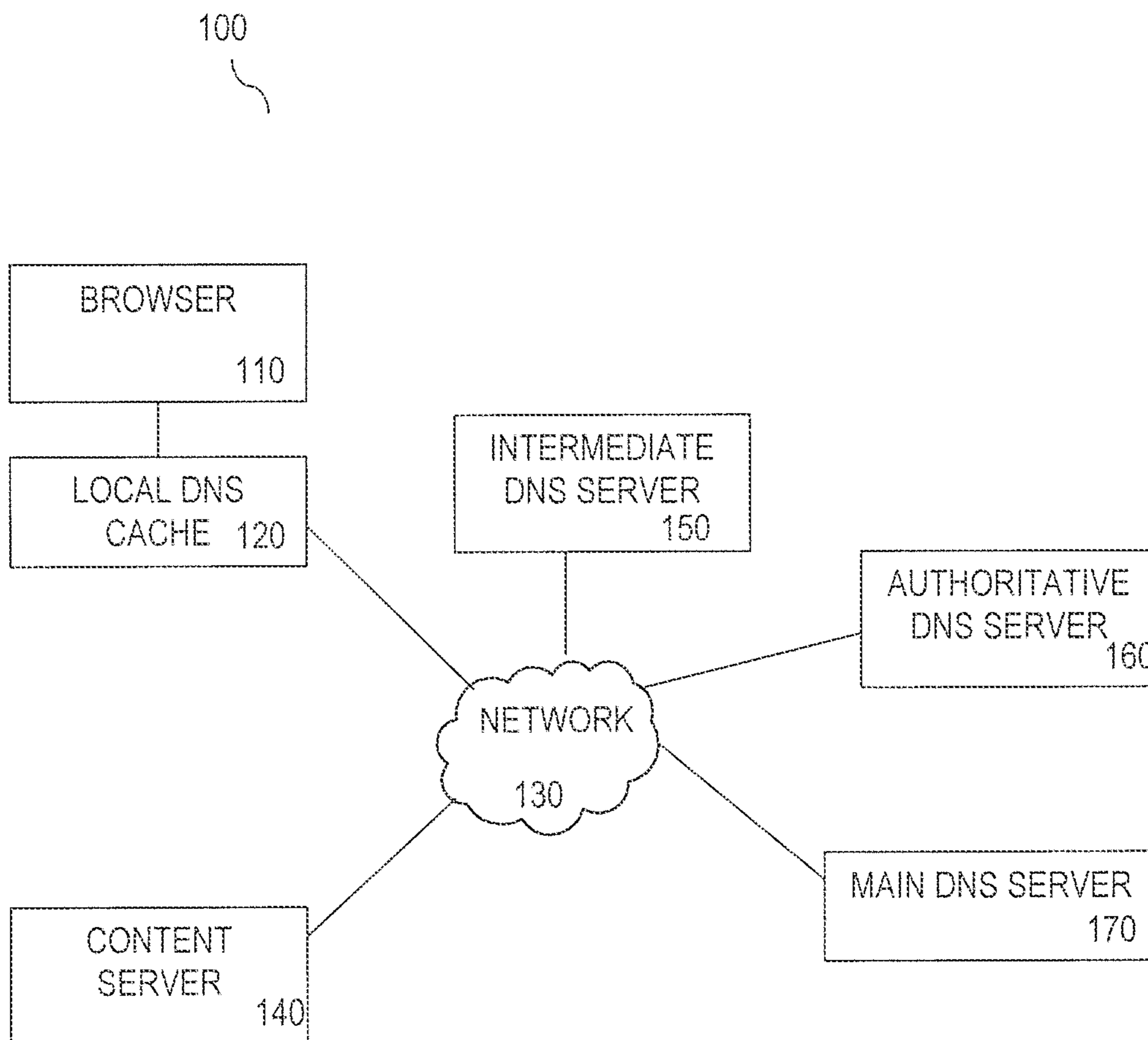

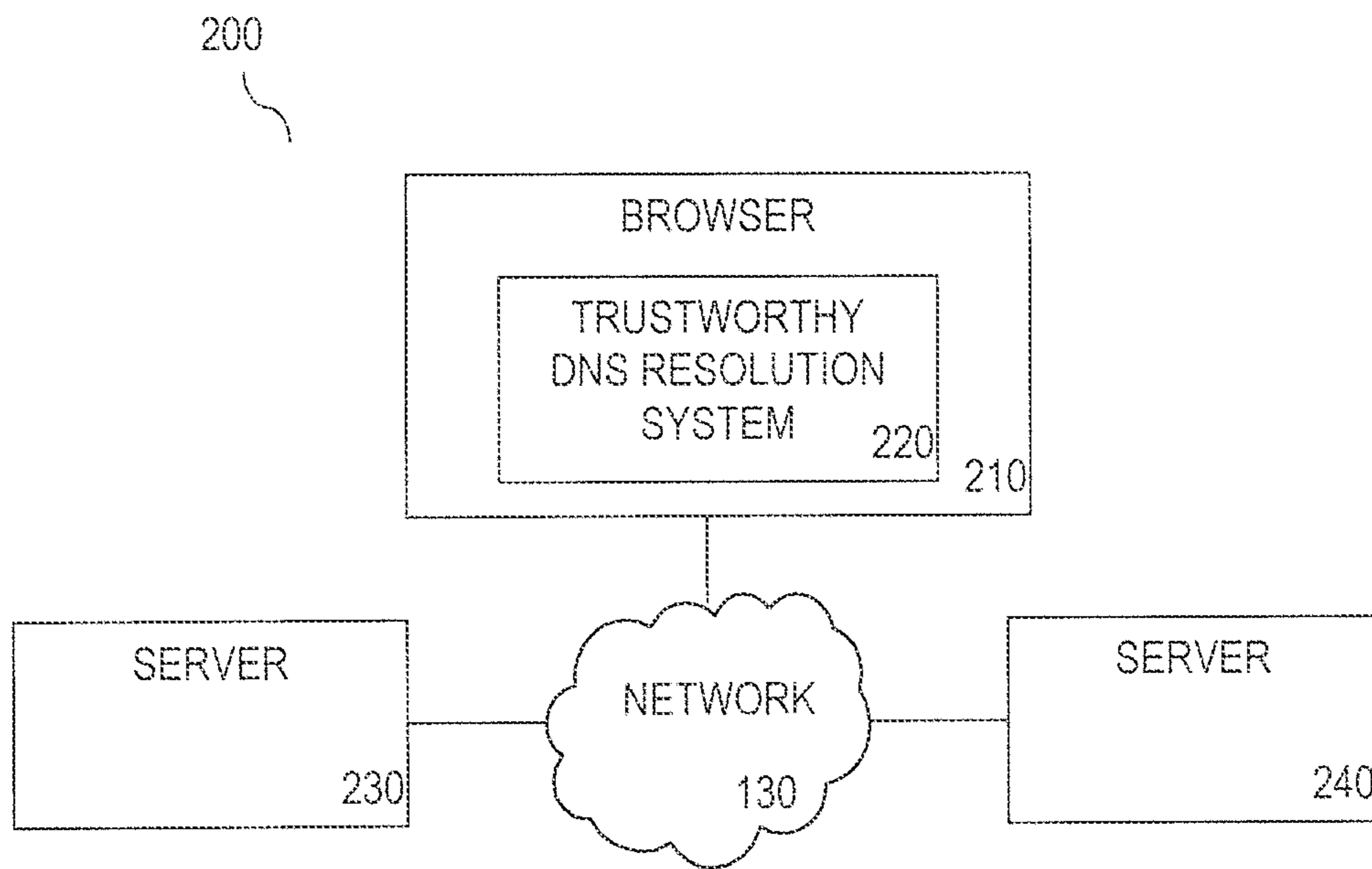

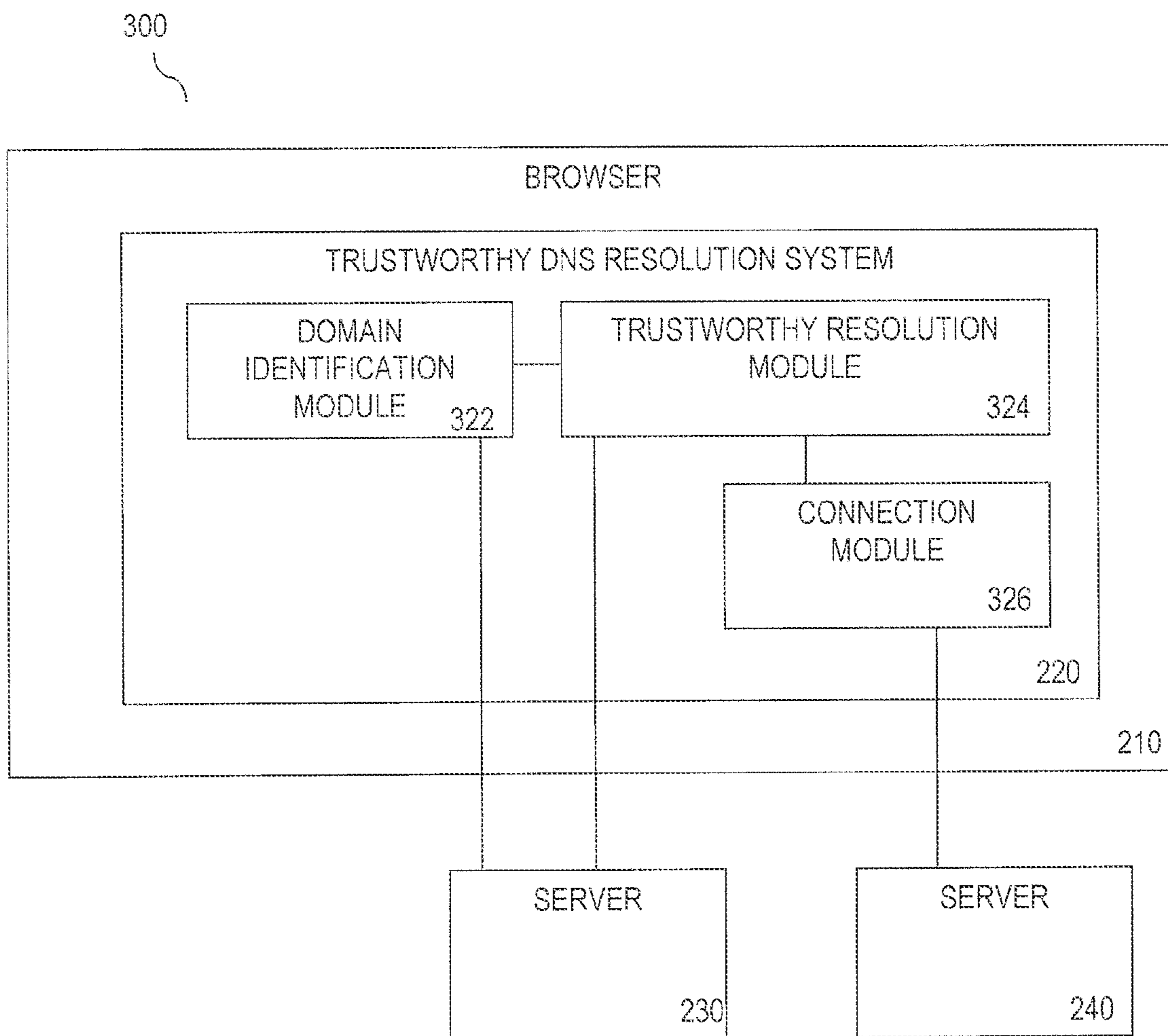

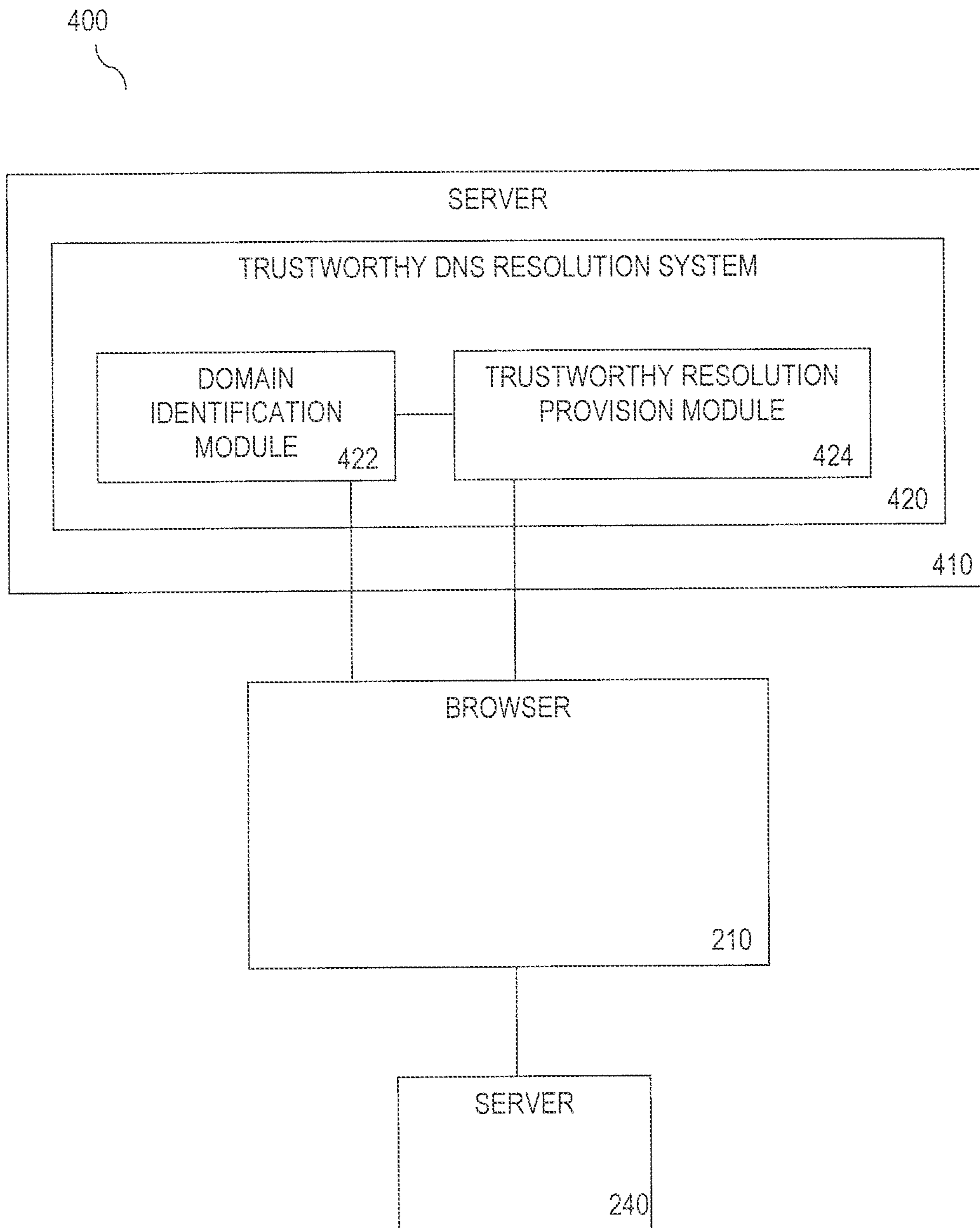

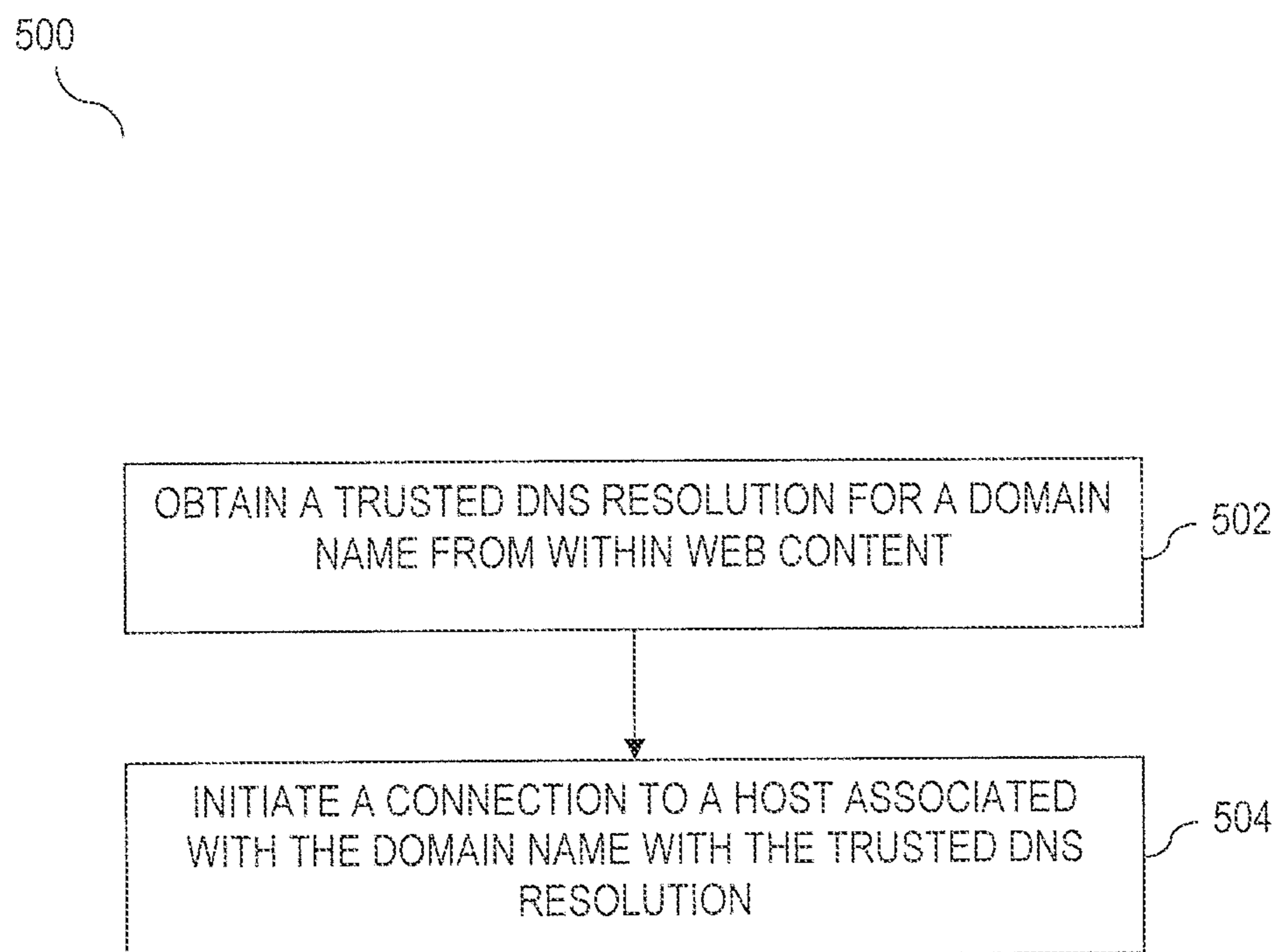

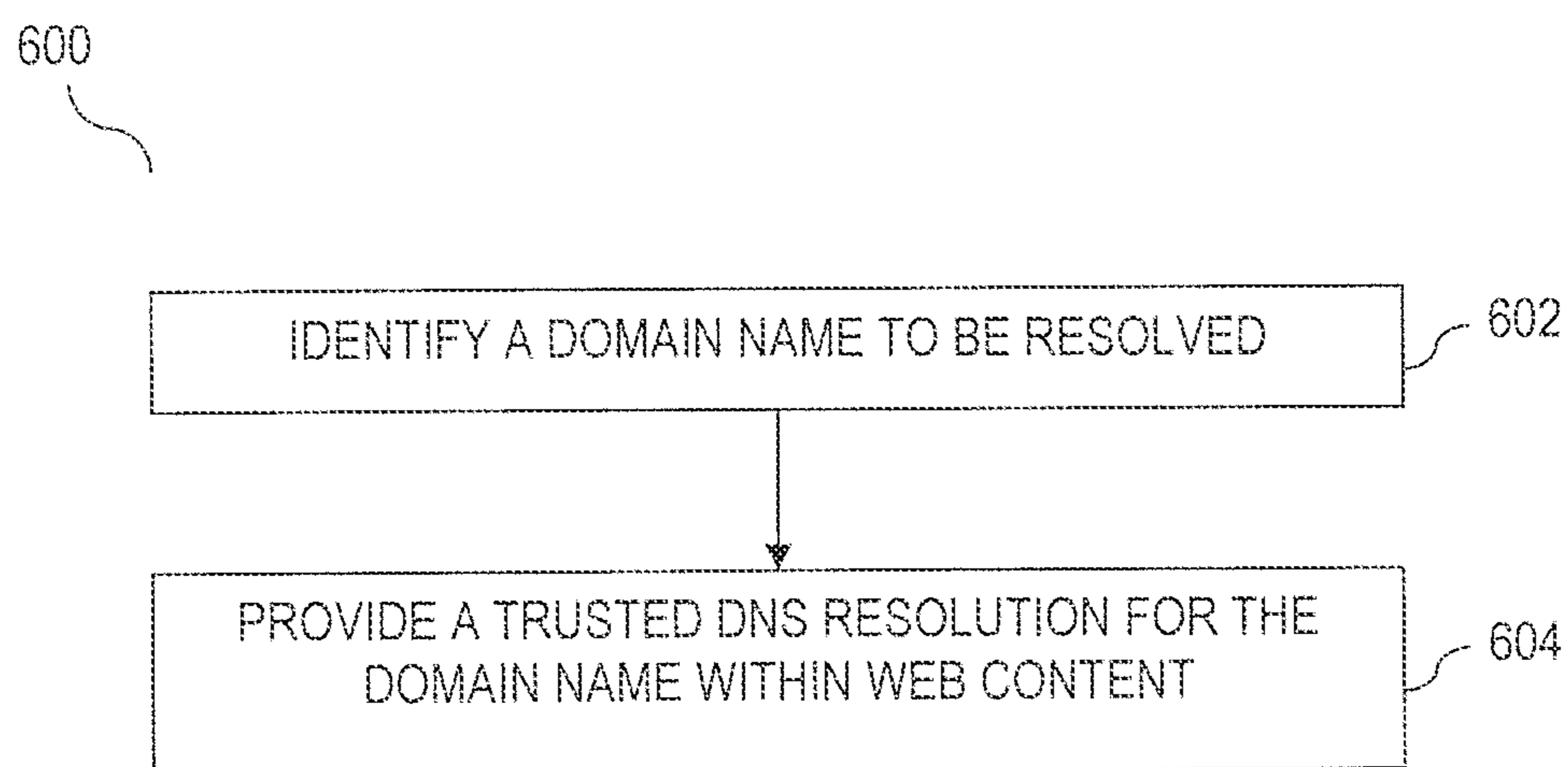

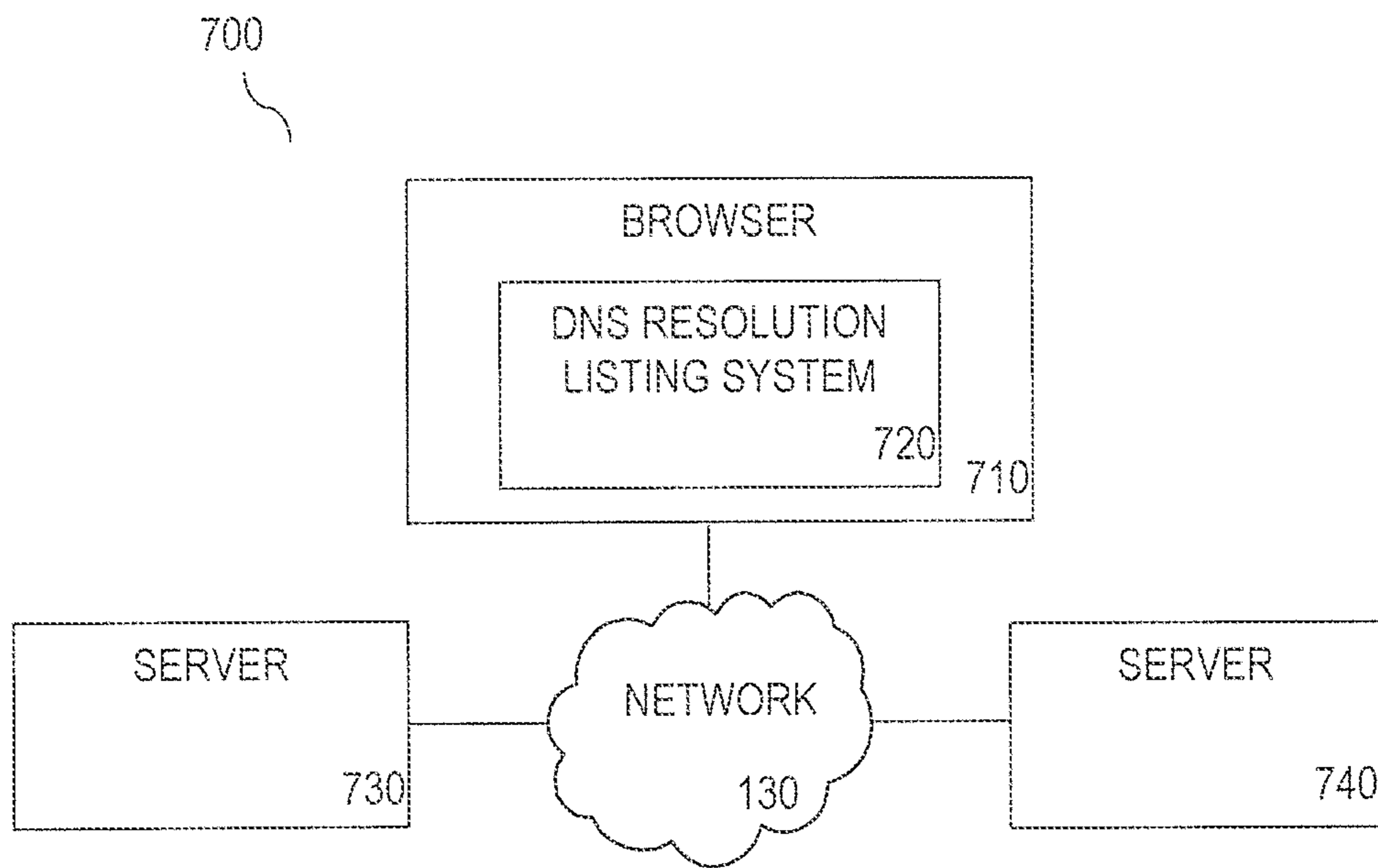

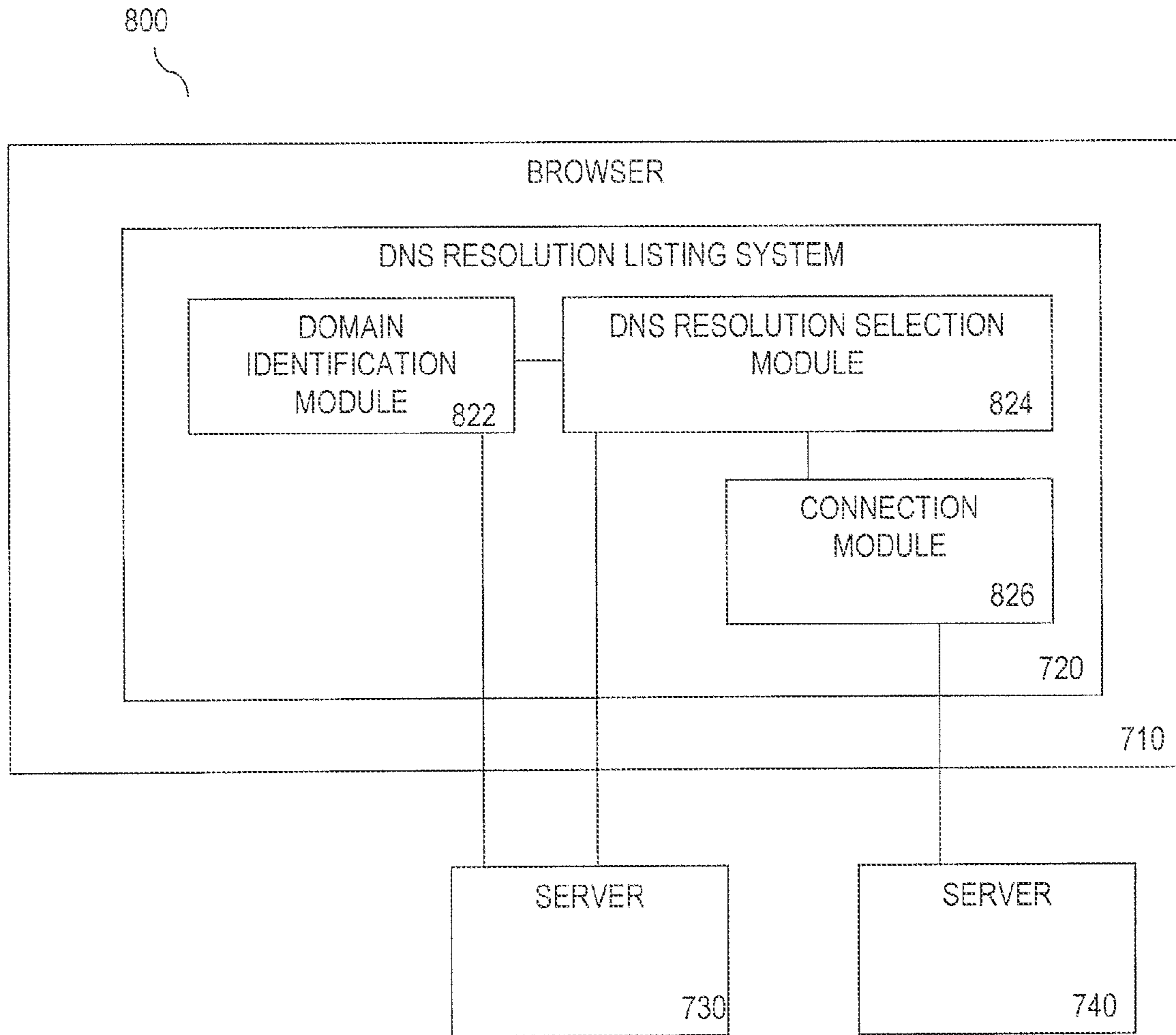

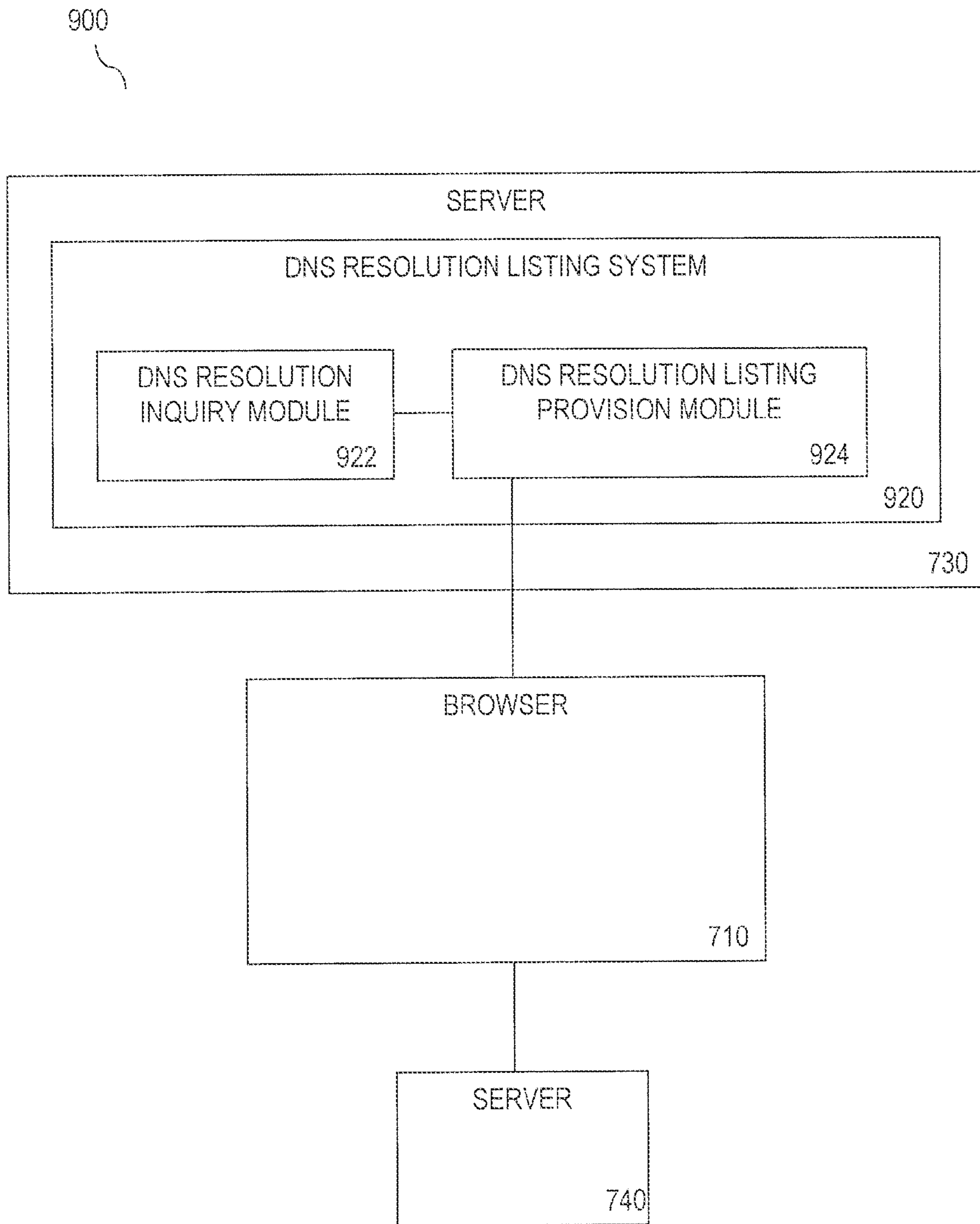

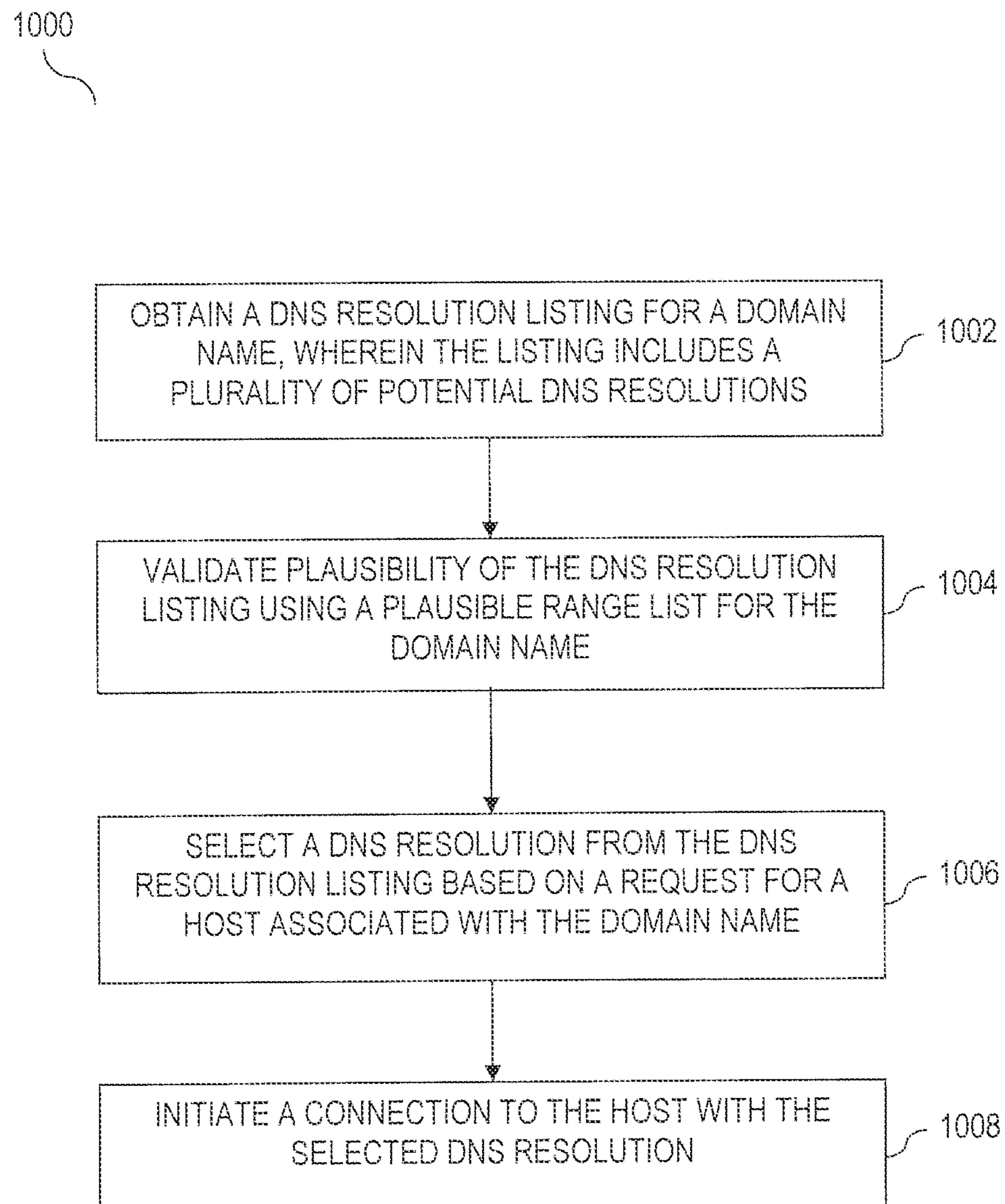

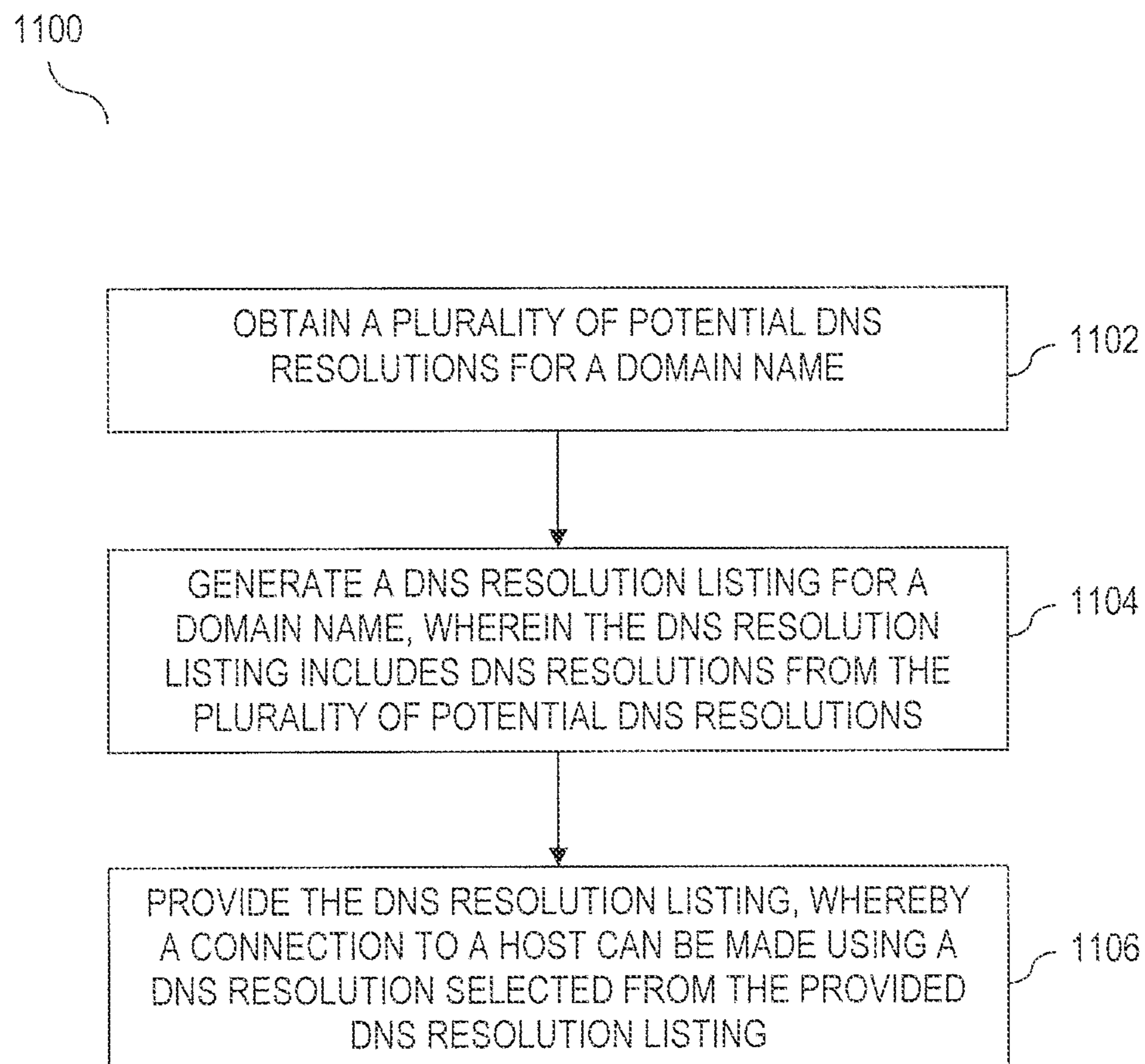

CONTENT PROVIDED DNS RESOLUTION VALIDATION AND USE

CROSS REFERENCE TO RELATED APPLICATIONS

This application is a continuation of U.S. patent application Ser. No. 14/478,936, filed Sep. 5, 2014, now allowed, which is a continuation of U.S. patent application Ser. No. 13/149,406, filed May 31, 2011, now U.S. Pat. No. 8,832,283, which is a continuation-in-part of U.S. patent application Ser. No. 12/883,393, filed Sep. 16, 2010, entitled "Trustworthy Provisioning of DNS Resolutions Within Web Content," all of which are incorporated by reference herein in their entirety.

BACKGROUND

1. Technical Field

Embodiments relate to applications and the World Wide Web.

2. Background Art

Web browsers may use a number of protocols and standards to obtain or manage content flow. Most browsers primarily use hypertext transfer protocol (HTTP) to fetch content and web pages. Web pages are located using a uniform resource locator (URL), which identifies where the web page may be found. Web pages may be retrieved using the Internet Protocol (IP) address of the computer holding the web page content. In order to be more memorable and human friendly, an IP address or hierarchy may be represented by a hostname (such as www.google.com). A hostname is a domain name that has one or more associated IP addresses. Hostnames and other information associated with domain names may be resolved or translated to IP addresses using the Domain Name System (DNS). This DNS resolution system is sometimes referred to as the "phone book" for the Internet.

DNS resolution requires either looking in a local computer cache for a DNS resolution or querying a set of DNS servers over the network. DNS utilizes authoritative DNS resolvers to help map domain names to IP addresses. Multiple DNS resolvers may be used in order to avoid having all the information in a single, central DNS server.

DNS resolution may add extra latency, which can cause users some discomfort. FIG. 1 illustrates an exemplary system **100** that performs DNS resolution. When network traffic is required to connect to a content server **140** from browser **110**, User Datagram Protocol (UDP) packets are sent to a DNS resolver, and eventually a UDP response is provided. If a DNS resolution is not selected from a local cache, such as DNS cache **110**, DNS resolution is requested from internet intermediate DNS server **150**, authoritative DNS server **160** or main DNS server **170** over network **130**. There is a latency time required to request DNS resolution from a DNS server. For example, the latency cost for an HTTP page load is at least a) a DNS resolution; and b) a round trip to establish a TCP/IP connection. The latency cost for an HTTPS (secure HTTP) connection is a) a DNS resolution; b) a round trip to establish a TCP/IP connection; and c) a round trip to perform an SSL handshake and establish a shared key.

BRIEF SUMMARY

The embodiments described below include systems and methods for using trustworthy domain name system (DNS)

resolutions. According to an embodiment, a method for using trustworthy DNS resolutions may include obtaining a DNS resolution listing for a domain name. The listing may include a plurality of potential DNS resolutions. The listing may be a bulk listing. The plausibility of the potential DNS resolutions may be validated using a plausible range list for the domain name. DNS resolutions that are validated as plausible are considered trustworthy DNS resolutions. Trustworthy DNS resolutions may be relied upon as being true DNS resolutions for a domain name. For instance, trusted DNS resolutions for SSL enabled web sites may be relied upon for initiating secure SSL connections. The method may also include selecting a DNS resolution from the DNS resolution listing based on a requested host associated with the domain name. The method may further include initiating a connection to the host using the selected DNS resolution. According to a further embodiment, the DNS resolution list is obtained without requesting DNS resolution for the domain name subsequent to identifying the domain name.

According to another embodiment, a method for providing trustworthy DNS resolutions may include obtaining a plurality of potential DNS resolutions for a domain name. The method may also include generating a DNS resolution listing for a domain name. The DNS resolution listing may include DNS resolutions from the plurality of potential DNS resolutions. The method may further include providing the DNS resolution listing. A connection to a host can be made using a DNS resolution selected from the provided DNS resolution listing.

According to an embodiment, a system for using trustworthy DNS resolutions may include a DNS resolution selection module configured to obtain a DNS resolution listing for a domain name. The listing may include a plurality of potential DNS resolutions. The DNS resolution selection module may also be configured to validate plausibility of the DNS resolution listing using a plausible range list for the domain name. The DNS resolution selection module may further be configured to select a DNS resolution from the DNS resolution listing based on a request for a host associated with the domain name. The system may also include a connection module configured to connect to a host with the selected DNS resolution.

According to another embodiment, a system for providing trustworthy DNS resolutions may include a DNS resolution inquiry module configured to obtain a plurality of potential DNS resolutions for a domain name. The system may also include a DNS resolution listing provision module configured to generate a DNS resolution listing for a domain name, wherein the DNS resolution listing includes DNS resolutions from the plurality of potential DNS resolutions. The DNS resolution listing provision module may also be configured to provide the DNS resolution listing. A connection to a host can be made using a DNS resolution selected from the provided DNS resolution listing.

Further embodiments, features, and advantages, as well as the structure and operation of the various embodiments are described in detail below with reference to accompanying drawings.

BRIEF DESCRIPTION OF THE FIGURES

Embodiments are described with reference to the accompanying drawings. In the drawings, like reference numbers may indicate identical or functionally similar elements. The drawing in which an element first appears is generally indicated by the left-most digit in the corresponding reference number.

FIG. 1 is a diagram showing an existing system for DNS resolution.

FIG. 2 is a diagram of a system for using trustworthy DNS resolutions, according to an embodiment.

FIG. 3 is a diagram of a system for using trustworthy DNS resolutions, according to an embodiment.

FIG. 4 is a diagram of a system for providing trustworthy DNS resolutions, according to an embodiment.

FIG. 5 is a flowchart illustrating a method for using trustworthy DNS resolutions, according to an embodiment.

FIG. 6 is a flowchart illustrating a method for providing trustworthy DNS resolutions, according to an embodiment.

FIG. 7 is a diagram of a system for using trustworthy DNS resolutions, according to an embodiment.

FIG. 8 is a diagram of a system for using trustworthy DNS resolutions, according to an embodiment.

FIG. 9 is a diagram of a system for providing trustworthy DNS resolutions, according to an embodiment.

FIG. 10 is a flowchart illustrating a method for using trustworthy DNS resolutions, according to an embodiment.

FIG. 11 is a flowchart illustrating a method for providing trustworthy DNS resolutions, according to an embodiment.

DETAILED DESCRIPTION

Embodiments described herein refer to illustrations for particular applications. It should be understood that the invention is not limited to the embodiments. Those skilled in the art with access to the teachings provided herein will recognize additional modifications, applications, and embodiments within the scope thereof and additional fields in which the embodiments would be of significant utility.

When a content provider provides a uniform resource locator (URL) that points to additional sites, a browser typically has to request a DNS resolution on the embedded host name prior to obtaining the content from the additional sites or subresources. To reduce latency, a content provider may provide a DNS resolution, or DNS to IP address translation, along with the host name. For security reasons, a browser cannot typically trust such a proposed resolution from a content provider. For instance, client use of a misstated or malicious resolution, beyond for example a handshake, could allow a client application to violate security policy and provide cookies for a misresolved domain to a server at the misstated IP address. However, if the URL is a secure HTTP (HTTPS) URL, then the DNS resolution can automatically be validated during the connection phase. As a result, embedding such translation hints in content can significantly reduce page load latency. Such a mechanism is trustworthy enough for SSL connectivity.

Latency may be reduced for content loaded from secondary domains. This may also apply to content of an HTTPS connection. The latency cost for an HTTPS connection may be as large as a) a DNS resolution; b) a round trip to establish a TCP/IP connection; and c) a round trip to perform an SSL handshake and establish a shared key. Embodiments described below may reduce the latency cost of an HTTPS connection to not more than: b) a round trip to establish a TCP/IP connection; and c) a round trip to perform an SSL handshake. Since the cost of a DNS resolution typically exceeds that of a round trip on a TCP/IP connection, subresource fetching from SSL enabled sites may be faster than HTTP connection fetching.

FIG. 2 shows exemplary system 200 for using trustworthy DNS resolutions, according to an embodiment. System 200 shows browser 210 and trustworthy DNS resolution system 220, which may be used to connect to server 230 or server

240 over one or more networks 130. Browser 210 and trustworthy DNS resolution system 220 may be coupled directly or indirectly. According to an embodiment, browser 210 may include any device, application or module that enables a user or computer to navigate and/or retrieve data from another data source, typically over a network. Browser 210 may include any conventional web browser such as those that are widely available. Browser 210 may also be a multi-threading browser. According to a further embodiment, browser 210 may also be configured to use any number of protocols, including protocols such as HTTP, FTP, and underlying protocols such as TCP/IP or UDP. Network(s) 130 may be any type of data network or combination of data networks including, but not limited to, a local area network (LAN), a medium area network, or a wide area network such as the Internet. Browser 210 may also be configured to support or interact with any number of world wide web protocols, applications or services.

Browser 210 and/or resolver information system 220 may exist within or be executed by hardware in a computing device. For example, browser 210 and/or trustworthy DNS resolution system 220 may be software, firmware, or hardware or any combination thereof in a computing device. A computing device can be any type of computing device having one or more processors. For example, a computing device can be a workstation, mobile device (e.g., a mobile phone, personal digital assistant, or laptop), computer, game console, set-top box, kiosk, embedded system or other device having at least one processor and memory. A computing device may include a communication port or I/O device for communicating over wired or wireless communication link(s). Browser 210 and trustworthy DNS resolution system 220 may be located on the same or different computing devices.

According to an embodiment, browser 210 may be configured to connect to another server, such as server 230 or server 240. The connection may be a secure sockets layer (SSL) connection. Browser 210 may use a trusted DNS resolution received from trustworthy DNS resolution system 220 to connect to a domain name.

FIG. 3 illustrates an exemplary system 300 for using trustworthy DNS resolutions, according to an embodiment. System 300 includes browser 210 and trustworthy DNS resolution system 220 that may connect to server 230 and/or server 240. Trustworthy DNS resolution system 220 may include domain identification module 322, trustworthy resolution module 324 and connection module 326. These components may be coupled together directly or indirectly.

According to an embodiment, domain identification module 322 may be configured to identify a domain name to be resolved. Domain identification module 322 may automatically identify proposed resolutions based on scanning or parsing of content. For example, a hypertext markup language (HTML) renderer may scan content and extract suggested DNS resolutions. In some cases, domain names to be resolved may be determined from a web page or search results. In other cases, domain names to be resolved may be received from another component or data source.

Trustworthy resolution module 324 may be configured to obtain and use DNS resolution information, according to an embodiment. DNS resolutions may be obtained without requesting DNS resolution from an operating system DNS cache, local DNS resolver, or a global DNS resolver for the domain name subsequent to identifying the domain name. In other words, a DNS resolution may have already been performed at some time earlier than when the domain name to be resolved is identified. In other cases, a DNS resolution

may have been generated. An existing DNS resolution is obtained upon identification of the domain name to be resolved rather than requesting resolution after the domain name is identified. Trustworthy resolution module **324** may also be configured to determine whether a DNS resolution is trusted. Trustworthy resolution module **324** may automatically validate the trusted DNS resolution during a secure sockets layer (SSL) connection phase.

Trustworthy resolution module **324** may obtain DNS resolutions from web content, according to an embodiment. DNS resolutions may be obtained from or provided within a web page, such as a search page or a web page containing links. Resolutions may be contained in HTML, such as within an HTML tag field such as `<link rel=resolution host=other.domain.com ips=1.2.3.4,9.8.7.6>`. In this example, trustworthy resolution module **324** may parse or otherwise scan the HTML, and deduce that the host "other.domain.com" may have a DNS resolution of either "1.2.3.4" or "9.8.7.6". DNS resolutions may also be obtained from or provided within header content, such as within an HTTP header. For example, a header X-DNSRESOLUTIONS might contain one or more hostnames, and one or more DNS resolutions for each of those host names.

In other cases, DNS resolutions may be obtained from or provided from within HTML, such as an HTML tag field. DNS resolutions may also be provided by a scripting language, such as by calls made to global functions. For example, a call from JavaScript® code to a global function with code, such as `SuggestResolution("other.domain.com", "1.2.3.4")`, may provide a plausible DNS resolution. Embedded DNS resolutions may be obtained from or provided by a secure sockets layer (SSL) web link. In some embodiments, the embedded DNS resolutions provided may be for the domain that served the content. Resolutions may be used to re-connect to the server that provided the (presumably alternate) resolution for the domain that served the content. For example, the reconnection may be done using the embedded resolution even if the connection is not SSL based.

Trustworthy resolution module **324** may also obtain an embedded DNS resolution that is closer to a desired domain than a current DNS resolution or IP address for the domain name. For example, a server, such as server **230** may include a "better" IP address for use in future connection back to server **230**, the original serving domain. "Better" may mean a server IP address that is closer to a user location, a user's internet provider, a user domain, a browser domain or a server domain. "Closer" may include geographically closer, topologically closer, closer in terms of round-trip-time, closer in terms of improved bandwidth or reliability connectivity, etc. A better or more desirable IP address can provide more responsive or lower latency responses to a user, based on network connectivity. For example, server **230** may serve the same content as server **240**, but server **230** is closer and would lead to less latency. Even though a resolution for the domain name is currently an IP address to server **240**, a better resolution would point to the IP address of server **230** for the domain name.

Connection module **326** may be configured to establish a connection to another host or server with an obtained or provided DNS resolution, according to an embodiment. An SSL connection may also be established. If a trusted DNS resolution is provided, connections to sub-resource servers for a domain name may be initiated. In some embodiments, a user application, such as browser **210**, may rely on content-provided DNS resolutions to initiate connections to

a host. In some cases, such embedded resolutions may be used only to initiate SSL connection, such as HTTPS content acquisitions. For example, connections to hosts via HTTP connection may ignore resolutions provided in content.

FIG. 4 illustrates an exemplary system **400** for providing trustworthy DNS resolutions, according to an embodiment. System **400** may include browser **210**, coupled to server **410** and server **240**. Server **410** may include trustworthy DNS resolution system **420**, which may include domain identification module **422** and trustworthy resolution provision module **424**. These components may be coupled together directly or indirectly. Domain identification module **422** may perform at least the functions of domain identification module **322**.

Trustworthy resolution provision module **424** may be configured to provide trusted DNS resolutions in web content, as explained above. Trustworthy provision module **424** may obtain DNS resolutions from other data sources or the DNS resolution may be requested prior to identification of a domain name to be resolved. According to an embodiment, web servers, such as HTTP or HTTPS servers, may augment content by including one or more DNS resolutions with the content served as a page. Web search results that included SSL links may be augmented to provide possible IP addresses for given hosts.

In some embodiments extracted resolutions may be stored for possible future use, such as in DNS resolution records. Resolutions may be searched for when the need for a resolution has manifested itself. For example, a DNS resolution may be needed when a connection to a host is required, such as when a user clicks on a web link, or when a sub-resource of a page, such as an image, needs to be fetched. Expiration times may also be included with embedded DNS resolutions.

FIG. 5 illustrates an exemplary method **500** for using trustworthy DNS resolutions, according to an embodiment. In step **502**, a trusted DNS resolution may be obtained for a domain name from within web content. This step may be performed by trustworthy DNS resolution system **220**. In some cases, the domain to be resolved may be identified or provided to trustworthy DNS resolution system **220**.

In step **504**, a connection to a host associated with the domain name may be initiated with the trusted DNS resolution. This step may be assisted by trustworthy DNS resolution system **220** or connection module **326**.

FIG. 6 illustrates an exemplary method **600** for providing trustworthy DNS resolutions, according to an embodiment. In step **602**, a domain name to be resolved is identified. Domain identification may be performed by domain identification module **422**.

In step **604**, a trusted DNS resolution may be provided within web content. This step may be performed by trustworthy resolution provision module **424**. A receiving component may then use the trusted DNS resolution to initiate a connection to a host associated with the domain name. The trusted DNS resolution may also be used in a SSL connection or for subresources requiring an SSL connection.

FIG. 7 illustrates an exemplary system **700** for providing a DNS resolution listing system, according to an embodiment. System **700** shows browser **710** and DNS resolution listing system **720**, which may be used to connect to server **730** or server **740** over one or more networks **130**. Browser **710** and DNS resolution listing system **720** may be coupled directly or indirectly. According to an embodiment, browser **710** may be similar to browser **210** above. Browser **710** may

include any conventional web browser such as those that are widely available. Browser **710** may also be a multi-process browser.

Browser **710** and/or DNS resolution listing system **720** may exist within or be executed by hardware in a computing device. For example, browser **710** and/or DNS resolution listing system **720** may be software, firmware, or hardware or any combination thereof in a computing device. Browser **710** and DNS resolution listing system **720** may be located on the same or different computing devices.

According to an embodiment, browser **710** may be configured to connect to another server, such as server **730** or server **740**. The connection may be a secure sockets layer (SSL) connection. Browser **710** may obtain a DNS resolution listing for a domain name. The listing may include at least two or more potential DNS resolutions. The potential DNS resolutions may be trusted DNS resolutions.

In an embodiment, browser **710** may receive a DNS resolution listing. Listings may include a bulk listing of potential or plausible IP resolutions, blocks of IP addresses, IP address subnet information or one or more ranges of IP addresses. Listings may be received from a service for a given domain name. For example, if a domain owns, controls or uses all IP addresses in the block 172.24.*,*, then files containing data, such as in an XML encoding, may indicate that all web pages of domain or associated with the domain may plausibly be directed to an any IP address starting with 172.24. An IP address in the range may be selected such as 172.24.1.1 or 172.24.102.5. In an exemplary embodiment, a DNS resolution listing, such as a bulk listing of plausible IP resolutions, may be derived from an application, such as browser **710**, recording previous DNS resolutions. These DNS resolutions may have been received from web page header content, from web page content, from a bulk DNS listing service provider, etc.

FIG. **8** illustrates an exemplary system **800** for using a DNS resolution listing, according to an embodiment. System **800** includes browser **710** and DNS resolution listing system **720** that may connect to server **730** and/or server **740**. DNS resolution listing system **720** may include domain identification module **822**, DNS resolution selection module **824** and connection module **826**. These components may be coupled together directly or indirectly.

According to an embodiment, domain identification module **822** may be configured to identify a domain name to be resolved. This domain name may be based on a user hostname request. Domain identification module **822** may automatically identify proposed domain names based on scanning or parsing of content. For example, a hypertext markup language (HTML) renderer may scan content and extract suggested domain names for DNS resolution. In some cases, domain names to be resolved may be determined from a web page or search results.

DNS resolution selection module **824** may be configured to obtain and use a DNS resolution listing, according to an embodiment. DNS resolution listings may be obtained from another server. In some cases, a DNS resolution listing may be collected or received from another component or data source such as a bulk listing service provider. DNS resolutions may be obtained without requesting DNS resolution from an operating system DNS cache, local DNS resolver, or a global DNS resolver for the domain name subsequent to identifying the domain name. In other words, a DNS resolution may have already been performed at some time earlier than when the domain name to be resolved is identified. In other cases, a DNS resolution listing may have been generated. An existing DNS resolution listing is used upon

identification of the domain name to be resolved rather than requesting resolution after the domain name is identified.

DNS selection module **824** may validate plausibility of the DNS resolution listing using a plausible range list for the domain name. This plausible range list may include one or more hostnames with corresponding DNS resolution range restrictions. Plausible range lists may be obtained from trusted sources prior to obtaining a DNS resolution listing. Plausible range lists may be obtained or formatted similar to DNS resolution listings, as described below. For example, a plausible range list may be a bulk listing of IP addresses or IP address ranges for corresponding domain names. Plausible range lists may also be constructed based on an analysis of past DNS resolutions and validating.

DNS selection module **824** may select a DNS resolution from or based upon the DNS resolution listing. The selection may also be based upon the validation of DNS resolutions. In a further embodiment, other factors such as proximity to the server, age of the listing, history of use of the DNS resolution, reliability of the resolution and availability of IP addresses in a DNS resolution listing may be considered when selecting a DNS resolution or IP address from the DNS resolution listing associated with a domain name. DNS resolution selection module **824** may also be configured to determine whether a DNS resolution is trusted. DNS resolution selection module **824** may also automatically validate the trusted DNS resolution during a secure sockets layer (SSL) connection phase.

In an embodiment, content providers, including the provider described in FIG. **9**, may supply proposed DNS resolution listings for related items along with content. For example, a web content provider may include metadata suggesting that a given domain may efficiently be resolved to a specific range or list of IP addresses. In an exemplary embodiment, a proposed resolution listing may be included in a header, such as an HTTP header, or it may be provided by directly augmenting content, such as the HTML content. For example, a header such as X-DNSRESOLUTION=(www.google.com, 172.24.0.7, 172.24.0.9, 172.24.0.10, 172.24.0.14), X-DNSRESOLUTION=(www.google.com, 172.24.0.7-172.24.0.200) or X-DNSRESOLUTION=(www.google.com, 172.24.*,*) may be provided to propose a DNS resolution of www.google.com to the specified IP address. Similarly, in an exemplary embodiment, in HTML content, a link such as may be augmented to to propose a resolution of www.google.com. Therefore, in an embodiment, selection module **824** may obtain a DNS resolution listing for a domain name from within header or web page content. Other variations and combinations of HTML augmentation are foreseeable beyond this particular example.

In an embodiment, content providers may supply proposed DNS resolution listings for the domain used to acquire the content. In another exemplary embodiment, content from www.google.com may include a proposed DNS resolution listing for www.google.com. In some embodiments, such proposed DNS resolutions may be added to an accumulated list of plausible addresses. In still other embodiments, these proposed DNS resolutions may include a time-to-live (TTL) value. The TTL is an expiration time, after which the list should not be relied upon.

In an embodiment, selection module **826** may use content-provided resolutions to connect to domain addresses. For example, connection module **826** may connect to a domain using a DNS resolution selected by selection module **824**. In some embodiments, resolutions that are plausible by

virtue of being implied by a bulk listing of plausible addresses may be selected. In some cases, resolutions that are plausible by inclusion in an accumulated list of plausible addresses may be selected. In other cases, resolutions that are plausible by inclusion in an accumulated list of plausible addresses may be selected. An attempted connection to a content-suggested, and plausible resolution, may be performed in parallel with an independent DNS resolution of the indicated host name. If an attempted connection to a content-suggested resolution does not succeed, an application may wait for a current DNS resolution, and retry a connection to that resolution, before considering the host unreachable. In other embodiments, a DNS resolution from the DNS resolution listing that is closer to the server domain than a current DNS resolution for the domain name may be deemed more plausible or highly plausible.

In some cases, DNS resolutions may only be plausible if they are derived from authoritative DNS servers. Selection module **824** may also only consider DNS resolutions plausible if they are received from servers from known points-of-presence. In a further embodiment, DNS resolutions may only be deemed “trusted” if they are derived from known or trusted servers. In another embodiment, DNS resolutions may only be deemed “trusted” if they are derived from authoritative DNS servers. In some cases, certain resolutions in a DNS listing may be marked depending on attributes such as origination, age or trustworthiness.

In some embodiments, selection module **824** may give preference to a content-provided address, over a DNS resolver provided address. For example, if content from www.google.com proposed an IP address of 172.24.0.7, while a previous DNS resolution provided a resolution of 172.24.0.8, the application may give preference to the IP address 172.24.0.7. In other embodiments, a preference may be given to applicable DNS resolutions over content provided resolutions. In another embodiment, a preference may be given to applicable DNS resolutions resolved from multiple points-of-presence. According to a further embodiment, selection module **824** may use an IP address not explicitly provided in a range but predicted upon other information or past use.

In an embodiment, selection module **824** may accumulate a list of plausible resolutions. In an exemplary embodiment, after a resolution of a name to an IP address has been made by an application, it may record the IP address as a plausible address, with an expiration value that is longer than the TTL value provided with the resolution. For example, a website having a TTL value of 5 minutes or less, may be recorded as being plausible for a day or week. In another embodiment, DNS resolution selection module **824**, may accumulate and retain a generic list of plausible resolutions for a specific domain name. Selection module **824** may also accumulate a bulk DNS resolution listing of the most frequently visited websites by a user. In another exemplarily embodiment, selection module **824** may automatically accumulate a bulk DNS resolution listing for a list of generic or frequently visited (e.g. popular) Internet websites.

In an embodiment, DNS resolution selection module **824** may rely upon a bulk listing service provider to provide a bulk listing of plausible DNS resolutions for a given domain name. The bulk listing service provider may also provide a bulk listing of plausible DNS resolutions for a plurality of domain names. Furthermore, the bulk listing service provider may provide one or more blocks of DNS addresses corresponding to one or more domain names. The bulk listing service provider may routinely provide updates for such listings. For example, routine updates may be provided

to system **720** at regular time intervals, such as weekly, daily, hourly, etc. In some embodiments, a bulk listing service provider may provide updates resolved from a previously provided listing. For example, the bulk listing service provider may determine what version is possessed by the browser **710**, and send only the changes needed to create a new version of the listing. In an embodiment the resolutions contained in the bulk listing may contain a TTL value. In another embodiment, individual resolutions (or items) in a listing may have individual TTL values.

Connection module **826** may be configured to establish a connection to another host or server with an obtained or provided DNS resolution, according to an embodiment. An SSL connection may also be established. If a trusted DNS resolution is provided, connections to sub-resource servers for a domain name may be initiated. In some embodiments, system **720** may rely on a bulk listing of plausible IP resolutions for a given domain name provided by DNS resolution selection module to initiate connections to a host. In some cases, such bulk listings of plausible IP resolutions may be used only to initiate SSL connection, such as HTTPS content acquisitions. For example, connections to hosts via HTTP connection may ignore resolutions provided in content. In an exemplary embodiment SSL connections are initiated with DNS resolutions that are deemed “trusted.”

FIG. **9** illustrates an exemplary system **900** for providing a DNS resolution listing system, according to an embodiment. System **900** may include browser **710**, coupled to server **730** and server **740**. Server **730** may include DNS resolution listing system **920**, which may include DNS resolution inquiry module **922** and DNS resolution listing provision module **924**. These components may be coupled together directly or indirectly. DNS resolution inquiry module **922** may perform at least the functions of domain identification module **822**.

DNS resolution inquiry module **922** may inquire about DNS resolution from DNS servers, such as authoritative DNS servers. DNS resolutions may be collected by inquiries about IP address ranges or blocks. Inquiry module **922** may request DNS resolution from multiple points-of-presence. Inquiry module **922** may acquire DNS resolutions as described above for the bulk listing provider. DNS resolutions may be acquired from only trusted sources so that trustworthy DNS resolutions may be provided.

DNS resolution listing provision module **924** may be configured to combine acquired DNS resolutions or DNS resolution ranges into a DNS resolution listing. Generating a listing may include creating a new listing or updating an existing listing. This listing may be also generated or compiled based on current and past information about DNS resolutions. This information may include associations between IP addresses and domain names.

DNS resolution listing provision module **924** may be configured to provide DNS resolution listings. Listings may be provided in web content, web headers, or in reference links. In some cases, DNS resolution listings may be provided in a simple data transmission. Provision module **924** may include the functionality of the bulk listing provider described above. DNS resolution listing provision module **924** may obtain DNS resolutions form other data sources or from requesting DNS resolution prior to identification of a domain name to be resolved. According to an embodiment, web servers, such as HTTP or HTTPS servers, may augment content by including one or more DNS resolutions with the content served as a page. Web search results that included SSL links may be augmented to provide possible IP addresses for given hosts. DNS resolution listing provision

module **924** may provide trusted DNS resolution listings. DNS resolutions listing provision module **924** may also provide plausible range lists.

In some embodiments extracted resolutions may be recorded by system **720** or system **920** for possible future use, such as in a DNS resolution listing. Resolutions may be searched for when the need for a resolution has manifested itself. In an exemplary embodiment, these extracted resolutions may include IP subnet addresses. For example, a DNS resolution may be needed when a connection to a host is required, such as when a user clicks on a web link, or when a sub-resource of a page, such as an image, needs to be fetched. TTL expiration values may also be included with embedded DNS resolutions. In a further embodiment, plausible IP addresses may be determined or extrapolated based on existing DNS resolution listing information.

FIG. **10** illustrates an exemplary method **1000** for using trustworthy DNS resolution listings, according to an embodiment. In step **1002**, a DNS resolution listing for a domain name is obtained. The listing may include or describe a plurality of potential DNS resolutions. This step may be performed by system **720**. In some cases, the domain to be resolved may be identified or provided to DNS resolution listing system **720**. Systems such as **920** may provide the DNS resolution listings.

In step **1004**, the plausibility of the DNS resolution listing is validated using a plausible range list for the domain name. The plausible range list may have been pre-cached or obtained at an earlier time. The plausible range list may also be built into the system or established at an earlier date. The plausible range list may be considered trustworthy. Successful validation of a DNS resolution listing may indicate that a DNS resolution listing is trustworthy and that successful connection using a DNS resolution listing is plausible. In many cases, plausible DNS resolutions may also be relied on for secure connections, such as SSL.

In step **1006**, a DNS resolution from the DNS resolution listing is selected based on a request for a host associated with the domain name. This step may be performed by DNS resolution selection module **824**. In step **1008**, the selected DNS resolution may be used to initiate a connection with the host. This step may be performed by DNS resolution selection module **824** or connection module **826**.

FIG. **11** illustrates an exemplary method **1100** for providing trustworthy DNS resolutions, according to an embodiment. In step **1102**, multiple potential DNS resolutions may be obtained for a domain name. In an exemplary embodiment, DNS resolution inquirer **922** may perform this step.

In step **1104**, a DNS resolution listing is generated for a domain name. The DNS resolution listing includes DNS resolutions from the plurality of potential DNS resolutions. This step may be performed by inquirer **922** or DNS resolution listing provision module **924**.

In step **1106**, the DNS resolution listing may be provided. A receiving client or application may then use the provided DNS resolution listing to initiate a connection to a host associated with the domain name. In an exemplary embodiment, the selected DNS resolution may be deemed a trusted DNS resolution as discussed above. This trusted DNS resolution may also be used in a SSL connection or for sub-resources requiring an SSL connection. Trusted DNS resolutions listings may have been validated using plausible range lists. Plausible range lists may also be provided.

The approaches discussed above may benefit web applications that require secure connectivity. Any time there is a need to link to SSL content, such approaches may be used.

Perceived latency may be reduced as the steps needed to establish a secure connection are fewer.

Aspects of the embodiments for exemplary systems **200-400** and **700-900**; as well as methods **500-600** and **1000-1100**; or any part(s) or function(s) thereof may be implemented using hardware, software modules, firmware, tangible computer readable or computer usable storage media having instructions stored thereon, or a combination thereof and may be implemented in one or more computer systems or other processing systems.

The embodiments have been described above with the aid of functional building blocks illustrating the implementation of specified functions and relationships thereof. The boundaries of these functional building blocks have been arbitrarily defined herein for the convenience of the description. Alternate boundaries can be defined so long as the specified functions and relationships thereof are appropriately performed.

The foregoing description of the specific embodiments will so fully reveal the general nature of the invention that others can, by applying knowledge within the skill of the art, readily modify and/or adapt for various applications such specific embodiments, without undue experimentation, without departing from the general concept of the present invention. Therefore, such adaptations and modifications are intended to be within the meaning and range of equivalents of the disclosed embodiments, based on the teaching and guidance presented herein. It is to be understood that the phraseology or terminology herein is for the purpose of description and not of limitation, such that the terminology or phraseology of the present specification is to be interpreted by the skilled artisan in light of the teachings and guidance.

The breadth and scope of the present invention should not be limited by any of the above-described exemplary embodiments, but should be defined only in accordance with the following claims and their equivalents.

What is claimed is:

1. A computer-implemented method for using Domain Name Service (DNS) resolutions, comprising:
 - obtaining, by a client device, content from a content provider;
 - analyzing, by the client device, the content from the content provider to identify a domain name of a uniform resource identifier (URI) and a translation for the domain name embedded in the content;
 - determining, by the client device, that the URI is a secure protocol URI;
 - initiating, by the client device, a secure connection to a host associated with the translation; and
 - validating, by the client device, the translation during the secure connection.
2. The method of claim 1, wherein the content is web page content, the URI is a uniform resource locator (URL), the secure protocol URI is a secure protocol URL, and the translation is a DNS resolution.
3. The method of claim 2, wherein the secure protocol URL is a secure hypertext transport protocol (HTTPS) URL.
4. The method of claim 2, wherein the secure connection is a secure socket layer (SSL) connection, and the initiating comprises initiating the SSL connection to the host associated with the DNS resolution.
5. The method of claim 2, wherein the obtaining comprises obtaining the web page content including the DNS resolution from the content provider via another secure connection.

6. The method of claim 2, wherein the analyzing comprises calling a function of scripting language in the web page content to identify the DNS resolution.

7. The method of claim 2, wherein the initiating comprises initiating the secure connection without the client device requesting a second DNS resolution for the domain name from an operating system DNS cache, a local DNS cache, or a global DNS resolver.

8. The method of claim 2, further comprising:
 requesting a second DNS resolution for the domain name in parallel with the initiating; and
 if the initiating fails, using the second DNS resolution to initiate a second connection to the host.

9. A system for using Domain Name Service (DNS) resolutions comprising:

a memory; and
 at least one processor coupled to the memory and configured to:
 obtain content from a content provider;
 analyze the content from the content provider to identify a domain name of a uniform resource identifier (URI) and a translation for the domain name embedded in the content;
 determine that the URI is a secure protocol URI;
 initiate a secure connection to a host associated with the translation; and
 validate the translation during the secure connection.

10. The system of claim 9, wherein the content is web page content, the URI is a uniform resource locator (URL), the secure protocol URI is a secure protocol URL, and the translation is a DNS resolution.

11. The system of claim 10, wherein the secure protocol URL is a secure hypertext transport protocol (HTTPS) URL.

12. The system of claim 10, wherein the secure connection is a secure socket layer (SSL) connection, the processor is configured to initiate the secure connection by initiating the SSL connection to the host associated with the DNS resolution.

13. The system of claim 10, wherein the processor is configured to obtain the web page content including the DNS resolution from the content provider via another secure connection.

14. The system of claim 10, wherein the processor is configured to analyze the web page content by calling a function of scripting language in the web page content to identify the DNS resolution.

15. The system of claim 10, wherein the processor is configured to initiate the secure connection without requesting a second DNS resolution for the domain name from an operating system DNS cache, a local DNS cache, or a global DNS resolver.

16. The system of claim 10, wherein the processor is configured to:

request a second DNS resolution for the domain name in parallel with the initiating the secure connection; and
 if the initiating the secure connection fails, use the second DNS resolution to initiate a second connection to the host.

17. A non-transitory computer-readable device having instructions stored thereon that, when executed by at least one computing device, cause the at least one computing device to perform operations for using Domain Name Service (DNS) resolutions, the operations comprising:

obtaining content from a content provider;
 analyzing the content from the content provider to identify a domain name of a uniform resource identifier (URI) and a translation for the domain name embedded in the content;
 determining that the URI is a secure protocol URI;
 initiating a secure connection to a host associated with the translation; and
 validating the translation during the secure connection.

18. The computer-readable device of claim 17, wherein the content is web page content the URI is a uniform resource locator (URL), the secure protocol URI is a secure protocol URL, and the translation is a DNS resolution.

19. The computer-readable device of claim 18, wherein the secure protocol URL is a secure hypertext transport protocol (HTTPS) URL.

20. The computer-readable device of claim 18, wherein the secure connection is a secure socket layer (SSL) connection, and the initiating comprises initiating the SSL connection to the host associated with the DNS resolution.

21. The computer-readable device of claim 18, wherein the obtaining comprises obtaining the web page content including the DNS resolution from the content provider via another secure connection.

22. The computer-readable device of claim 18, wherein the analyzing comprises calling a function of scripting language in the web page content to identify the DNS resolution.

23. The computer-readable device of claim 18, wherein the initiating comprises initiating the secure connection without requesting a second DNS resolution for the domain name from an operating system DNS cache, a local DNS cache, or a global DNS resolver.

24. The computer-readable device of claim 18, further comprising:

requesting a second DNS resolution for the domain name in parallel with the initiating; and
 if the initiating fails, using the second DNS resolution to initiate a second connection to the host.
