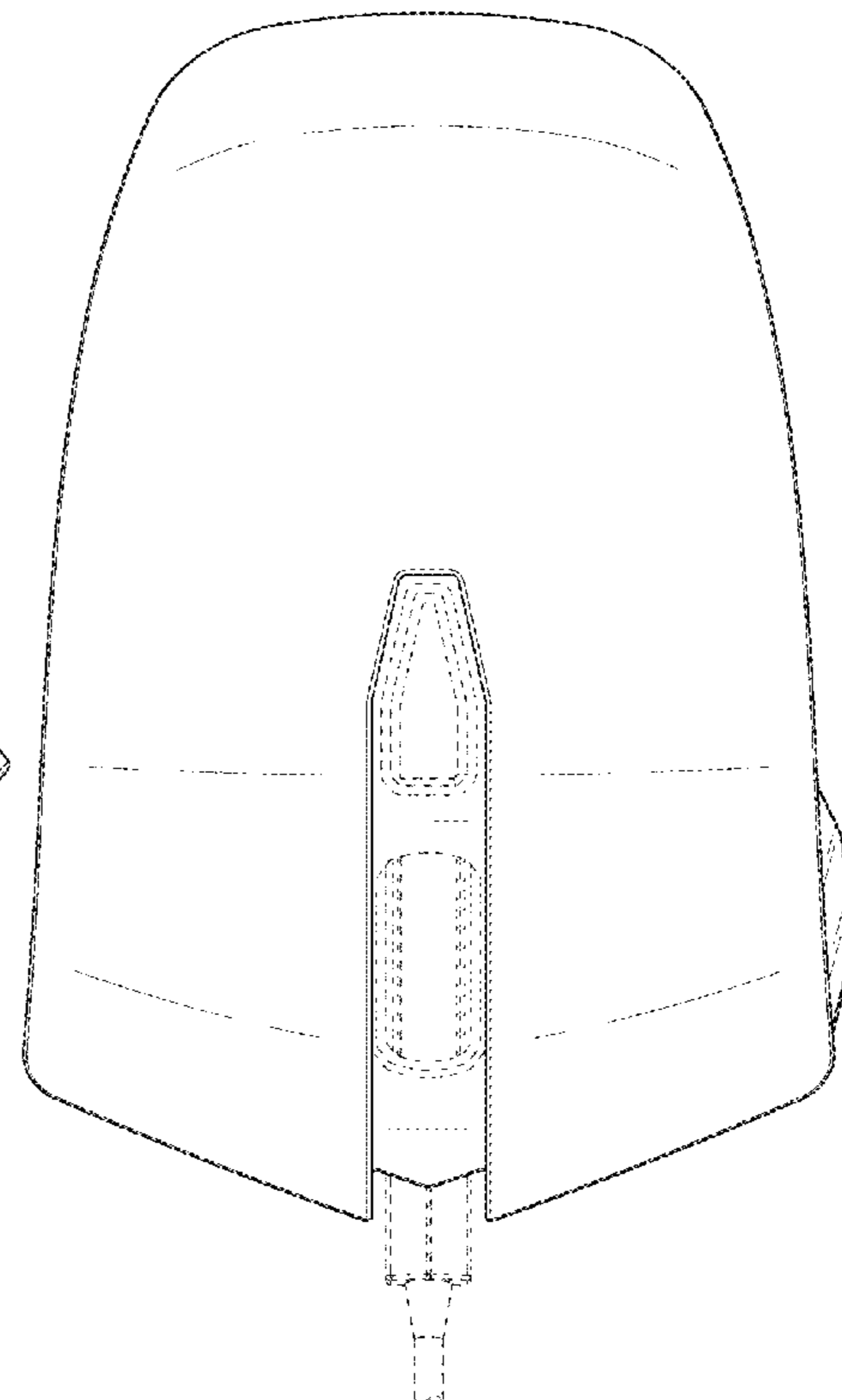
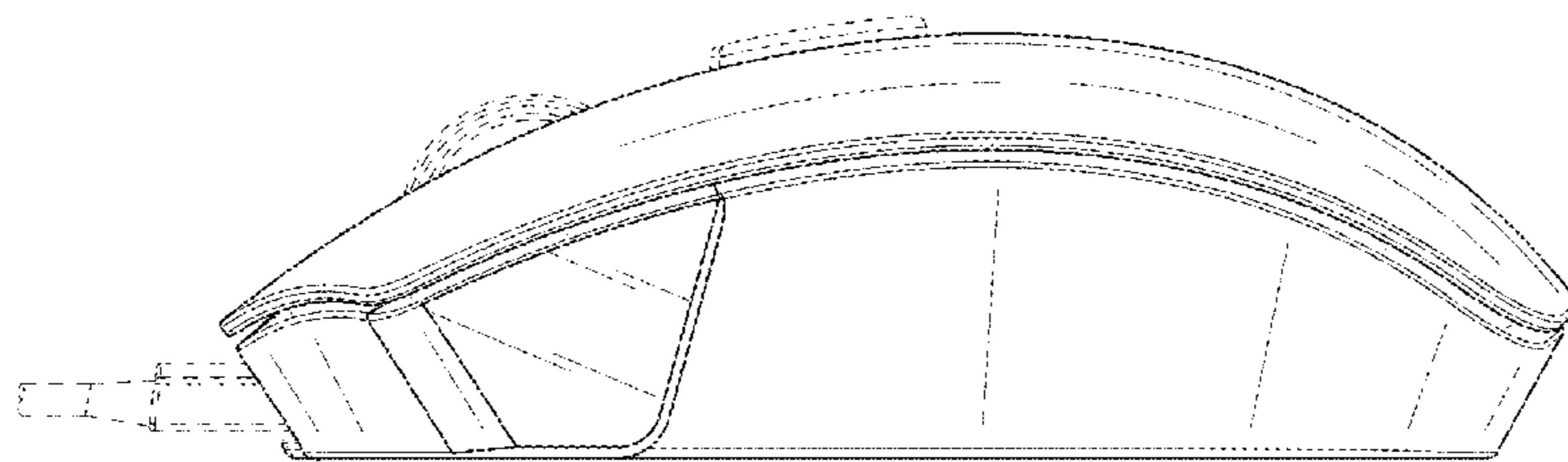
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a mouse showing our new design;
FIG. 2 is another perspective view thereof;

FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;

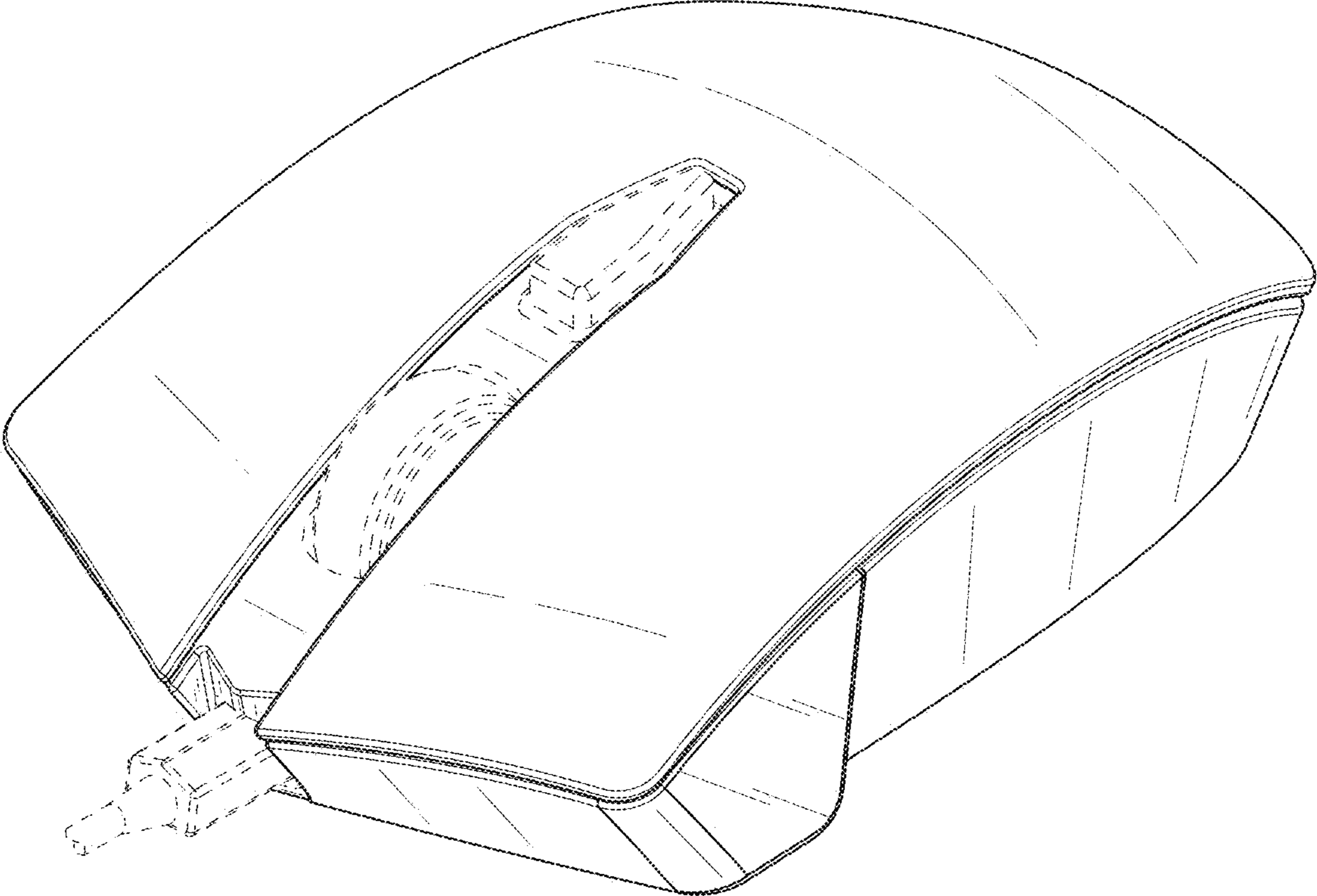

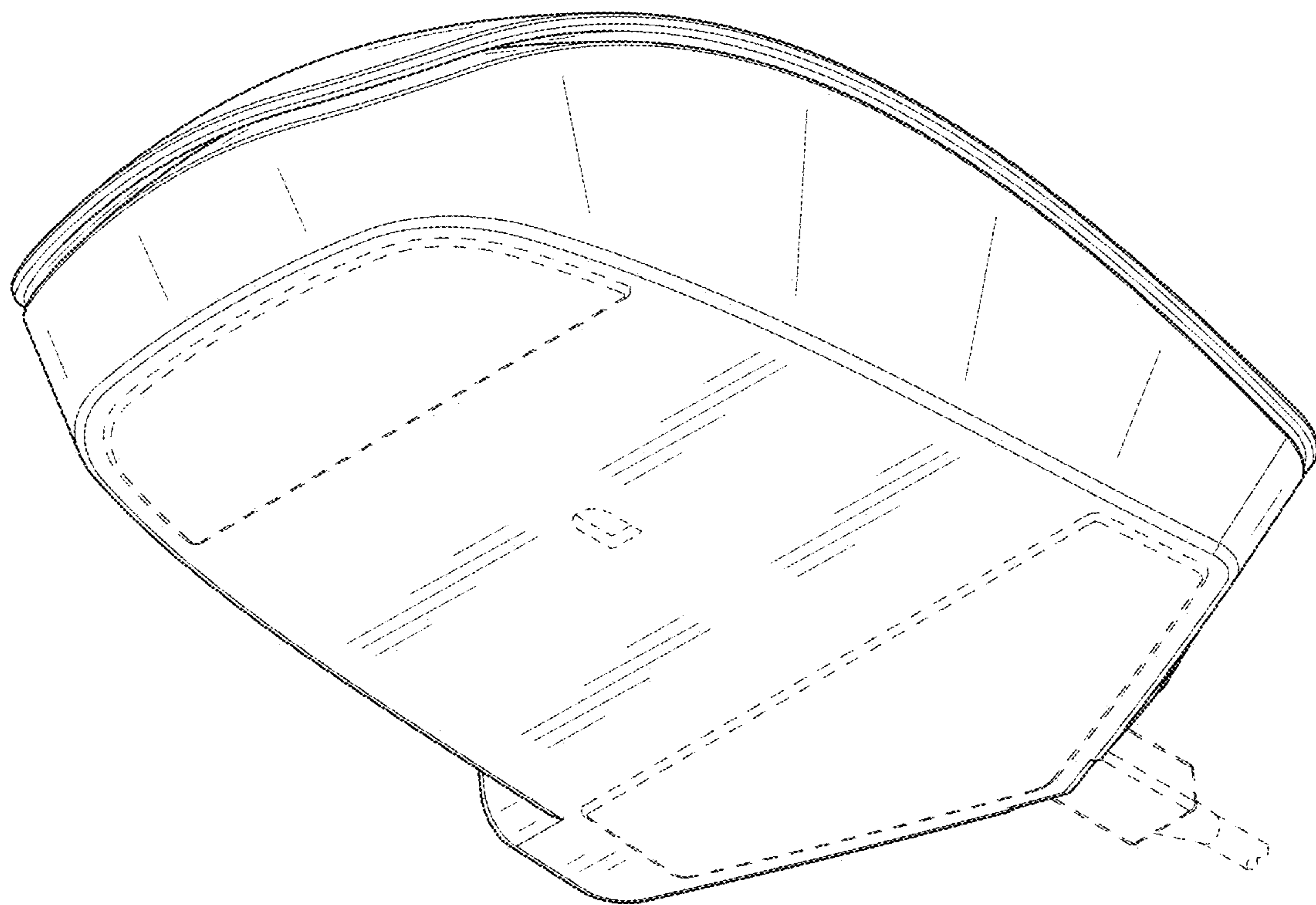

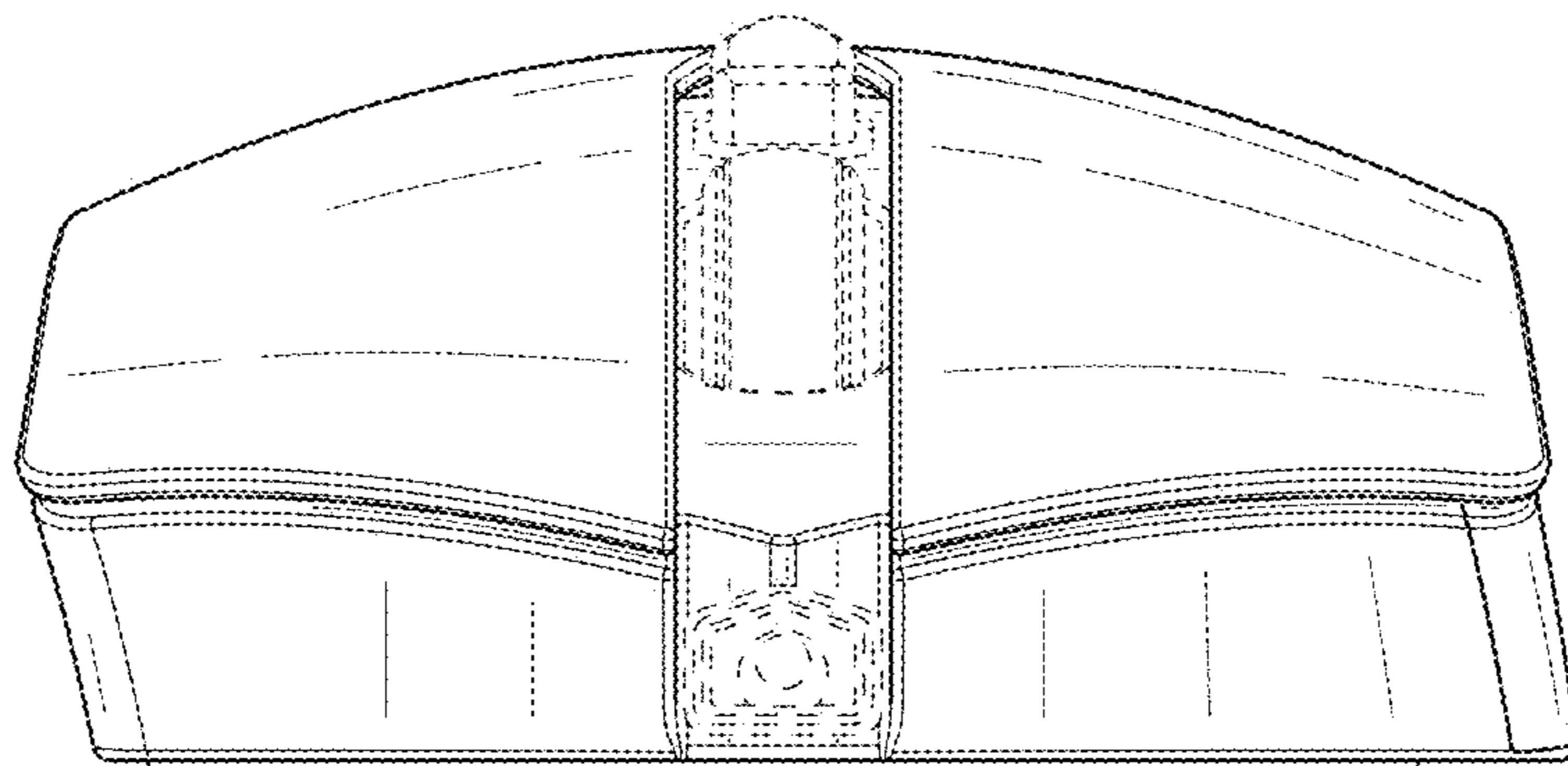

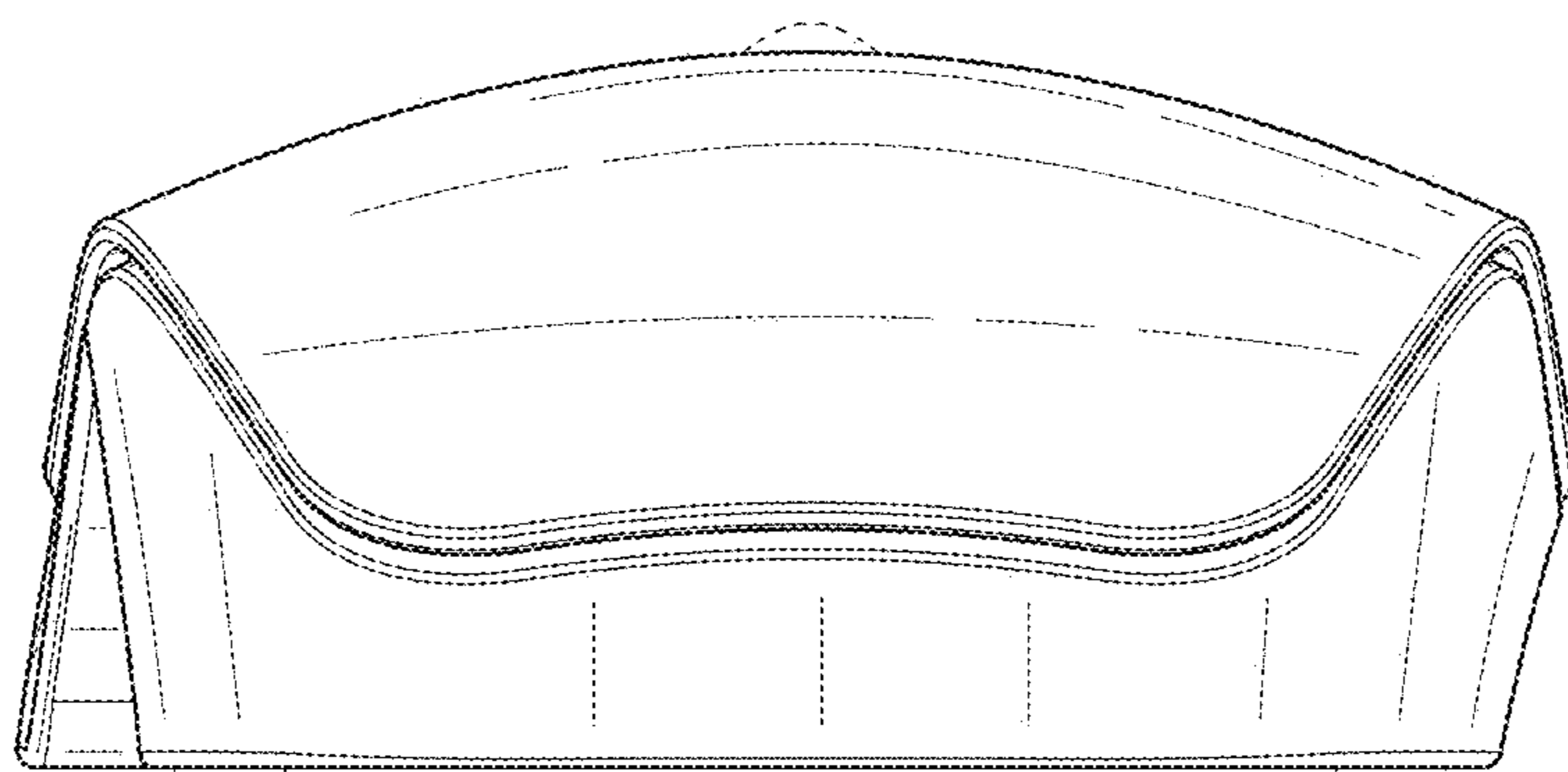

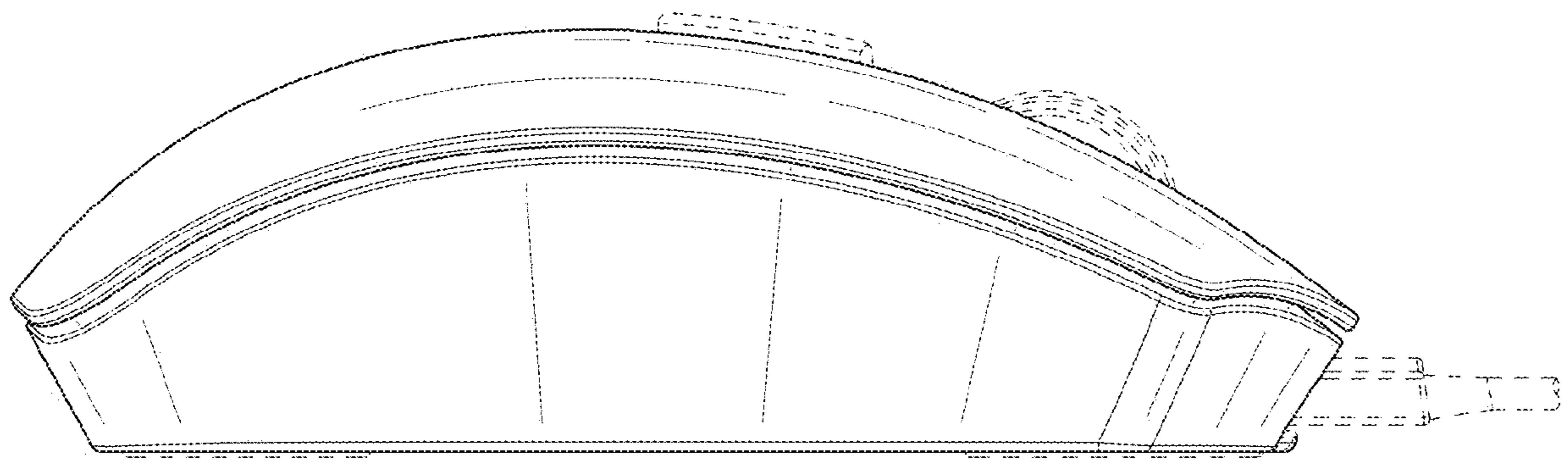

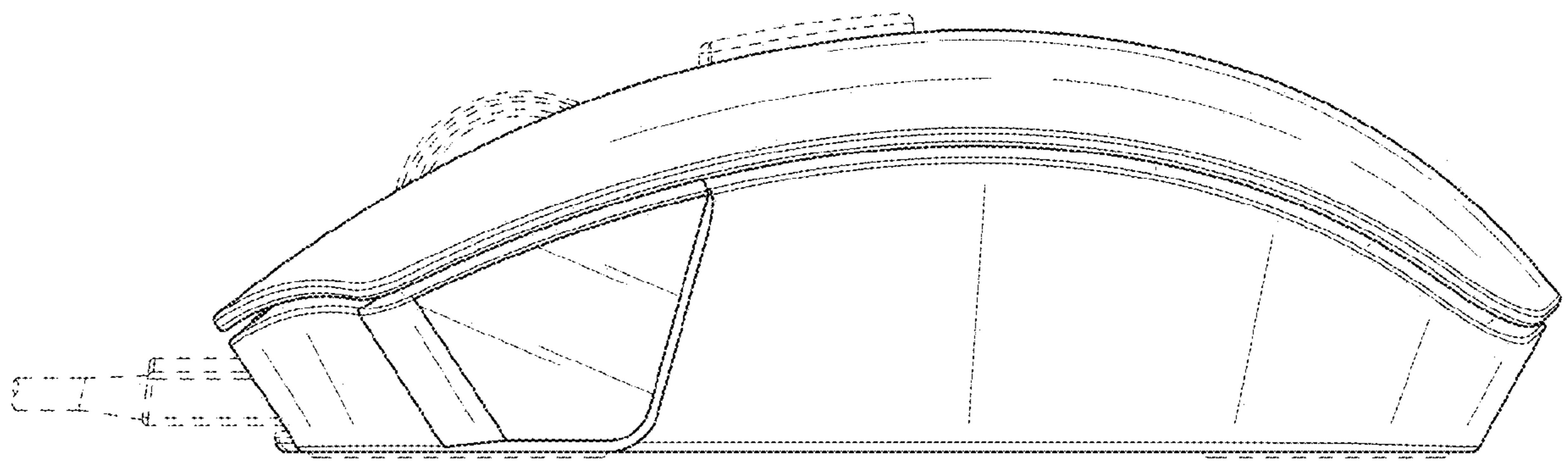

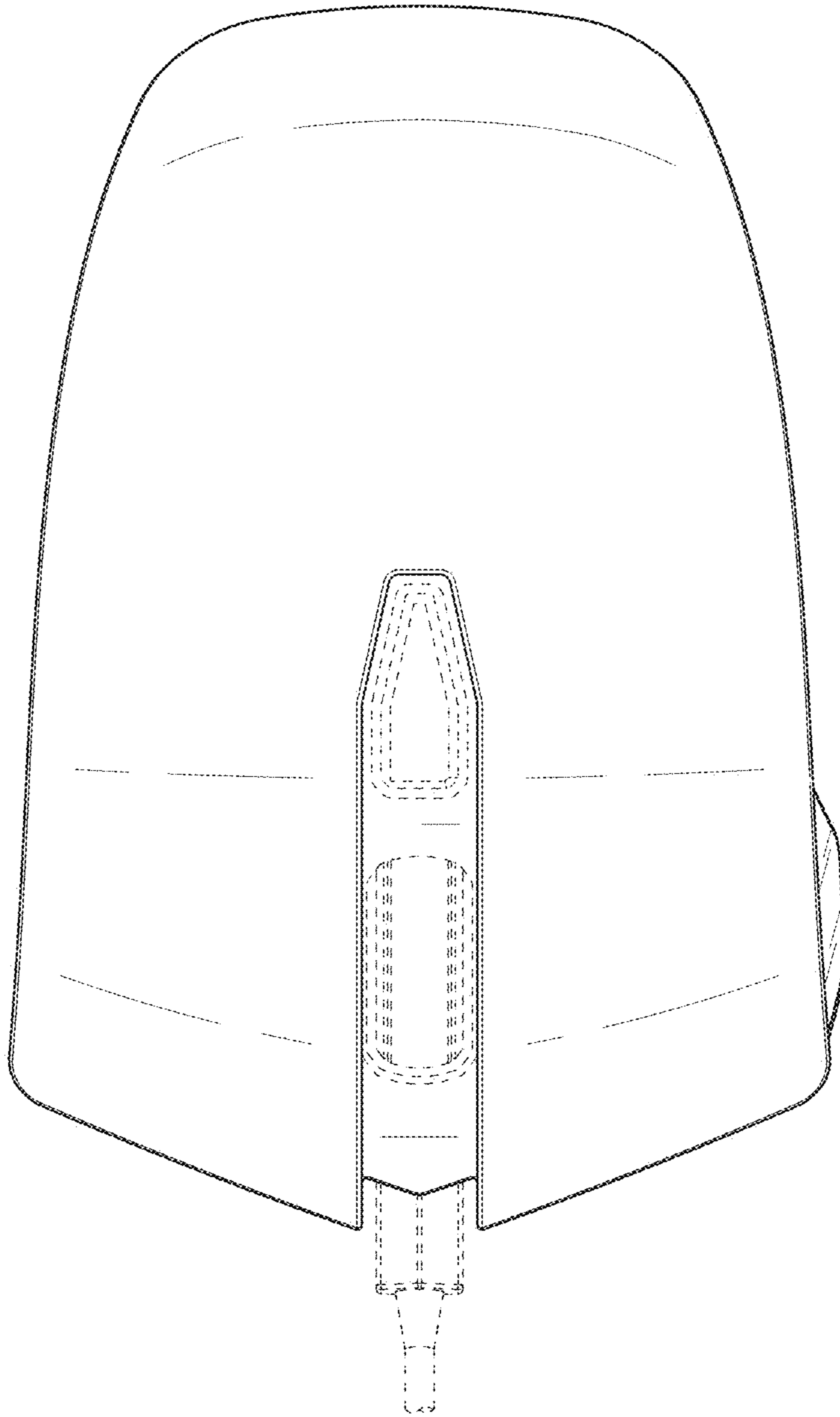

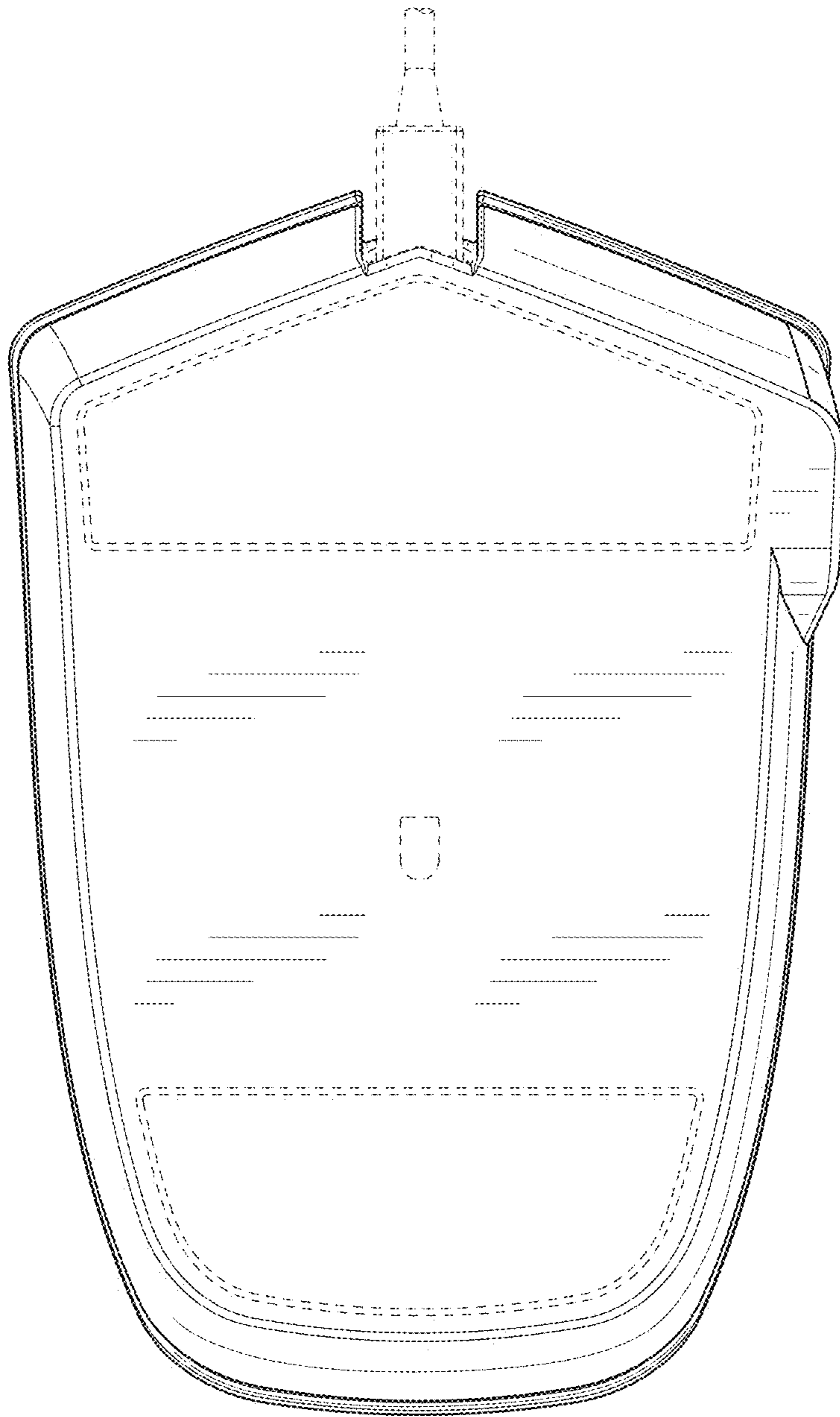
