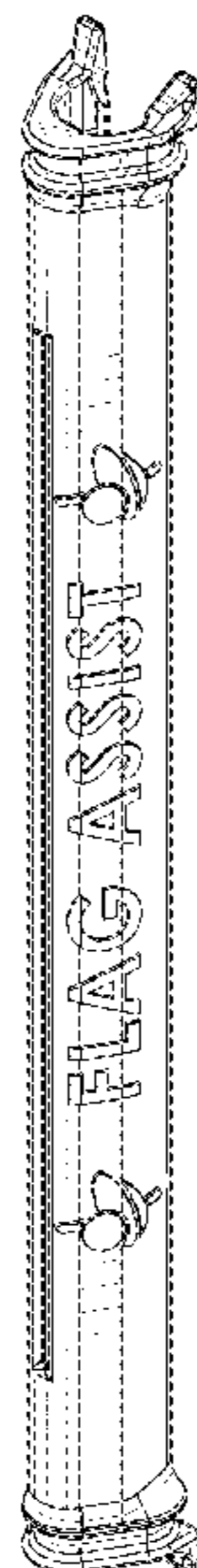
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-right perspective view of a flag holder showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left elevational view thereof;
FIG. 4 is a right elevational view thereof;
FIG. 5 is a rear plan view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

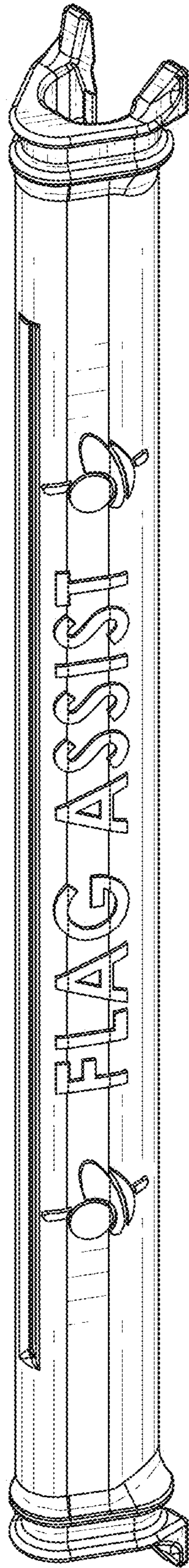

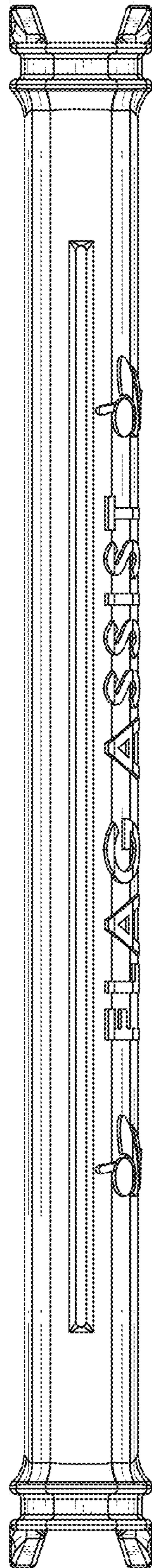

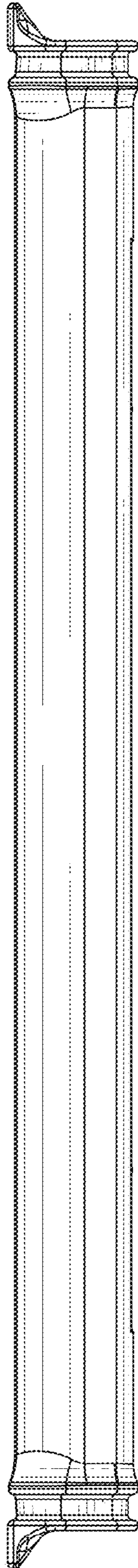

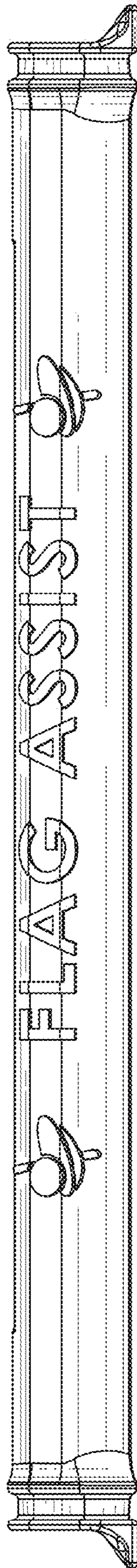

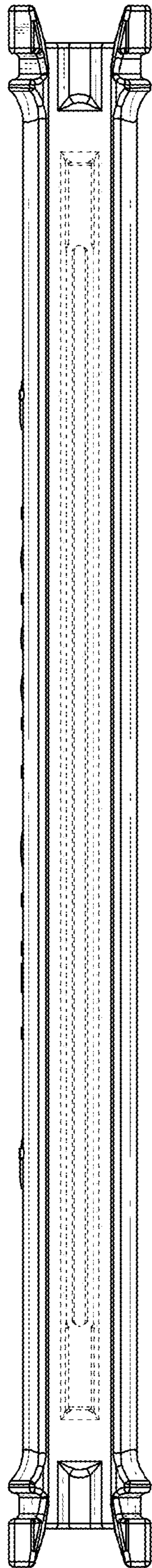

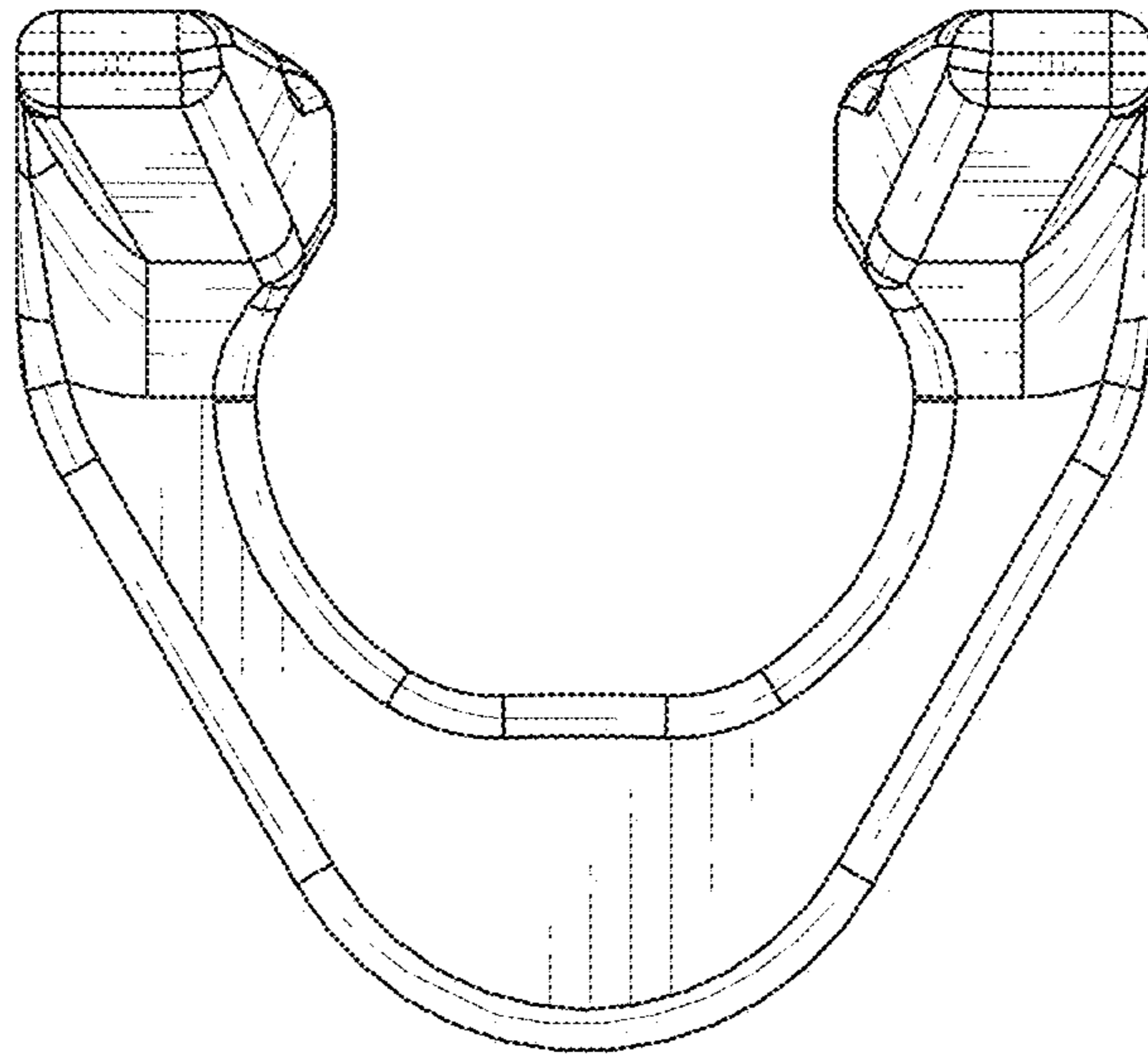

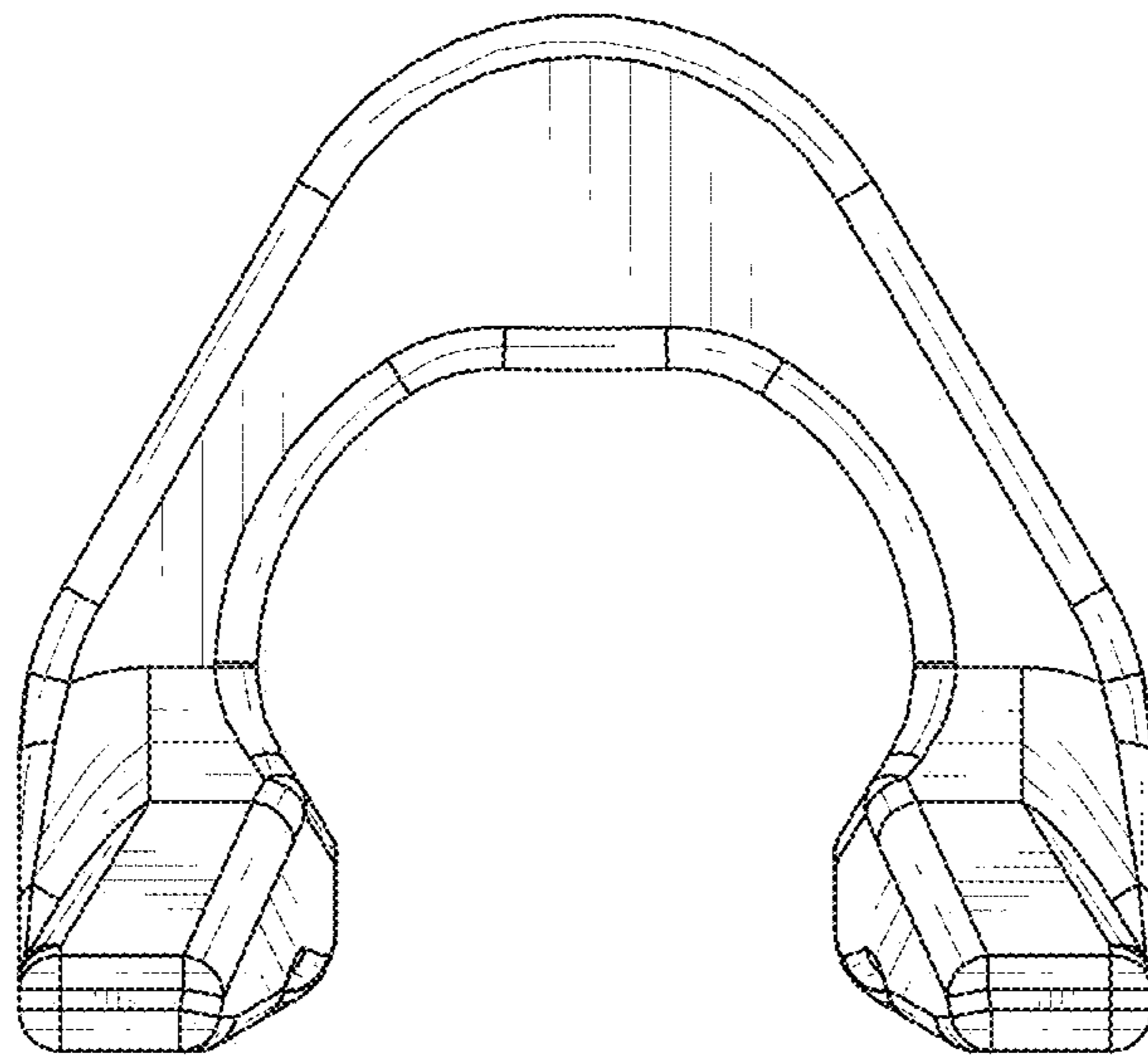
