FIG. 9 is an enlarged breakout elevational view taken on circle 3 of FIG. 3.

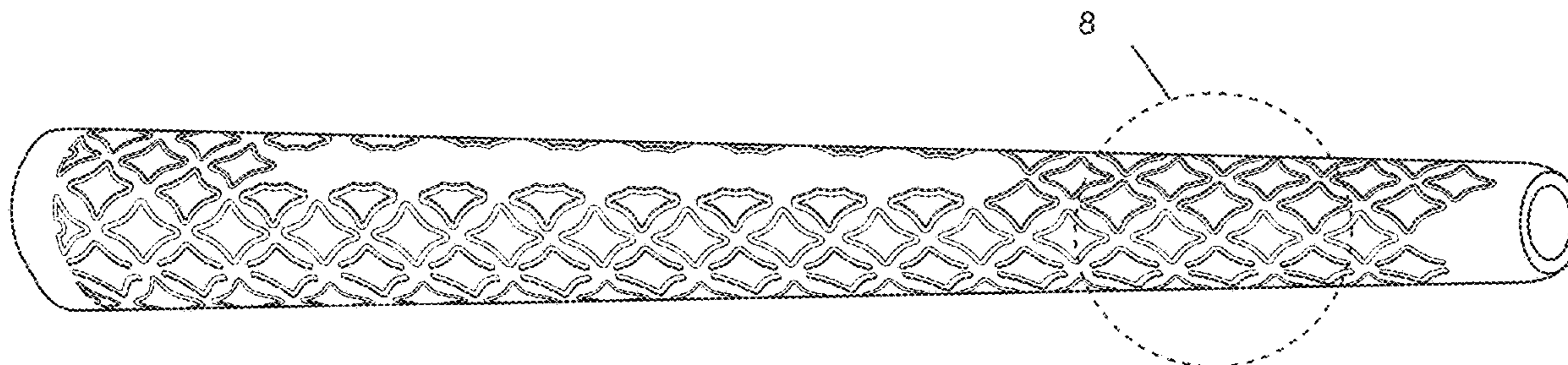

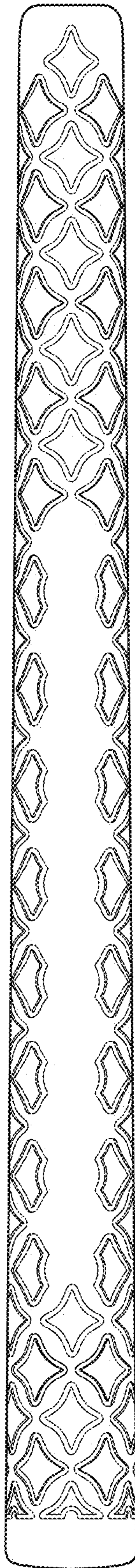

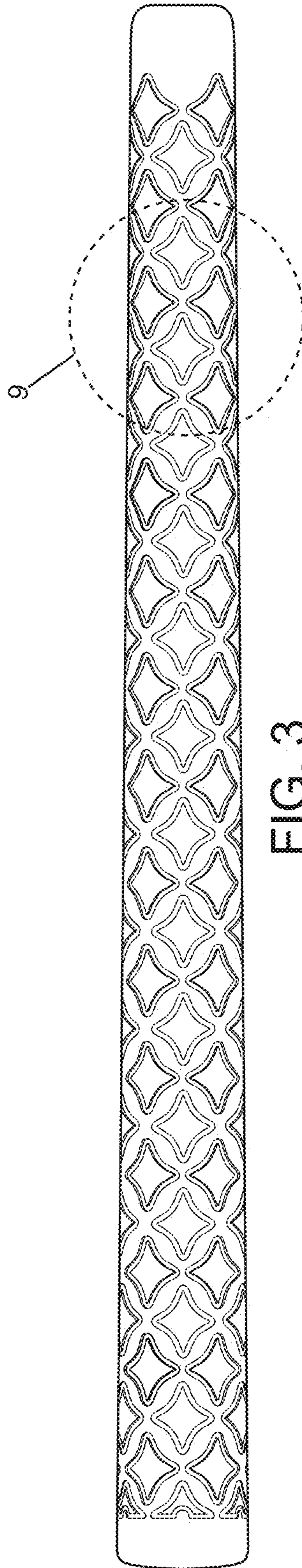

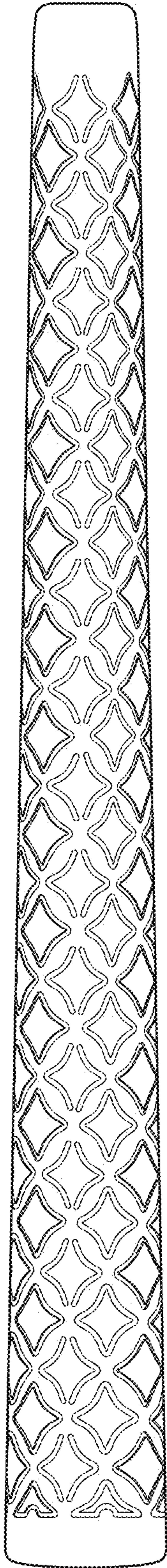

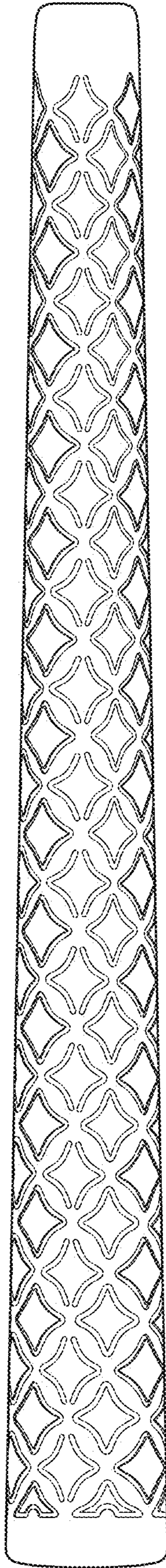

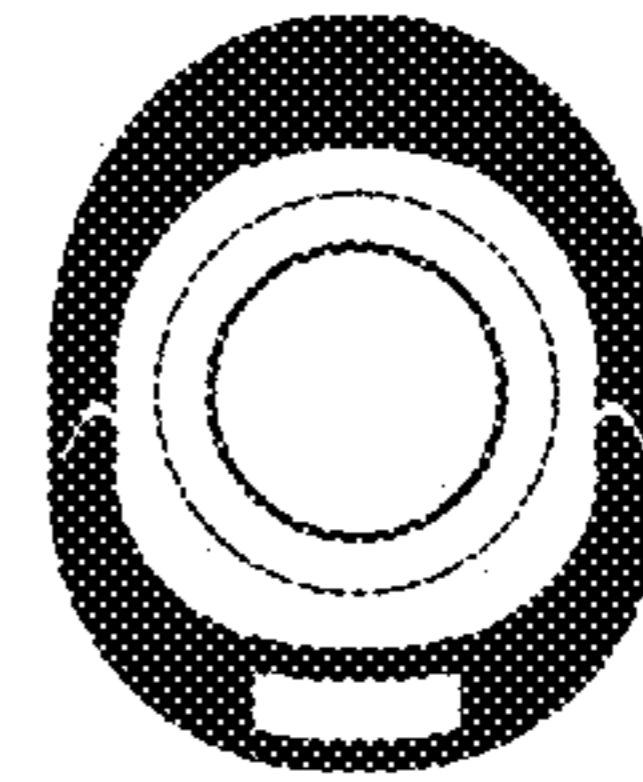

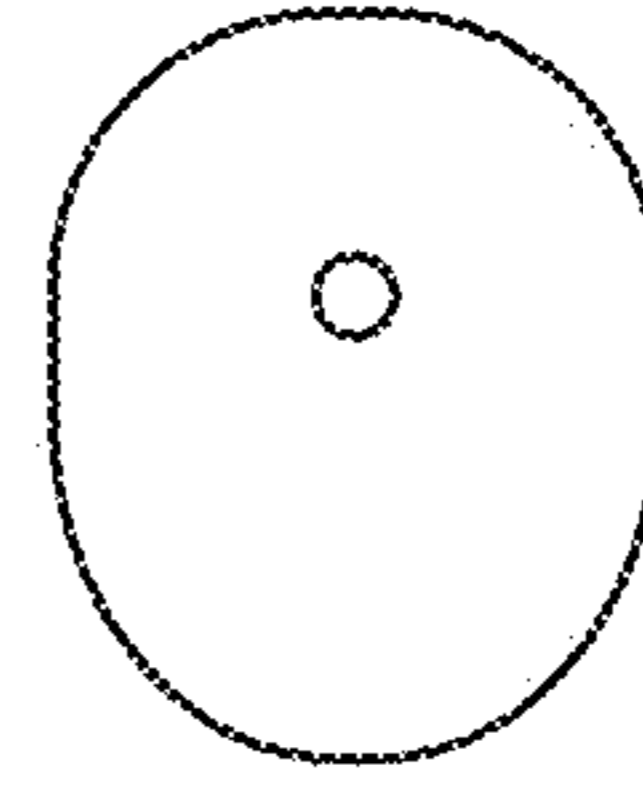

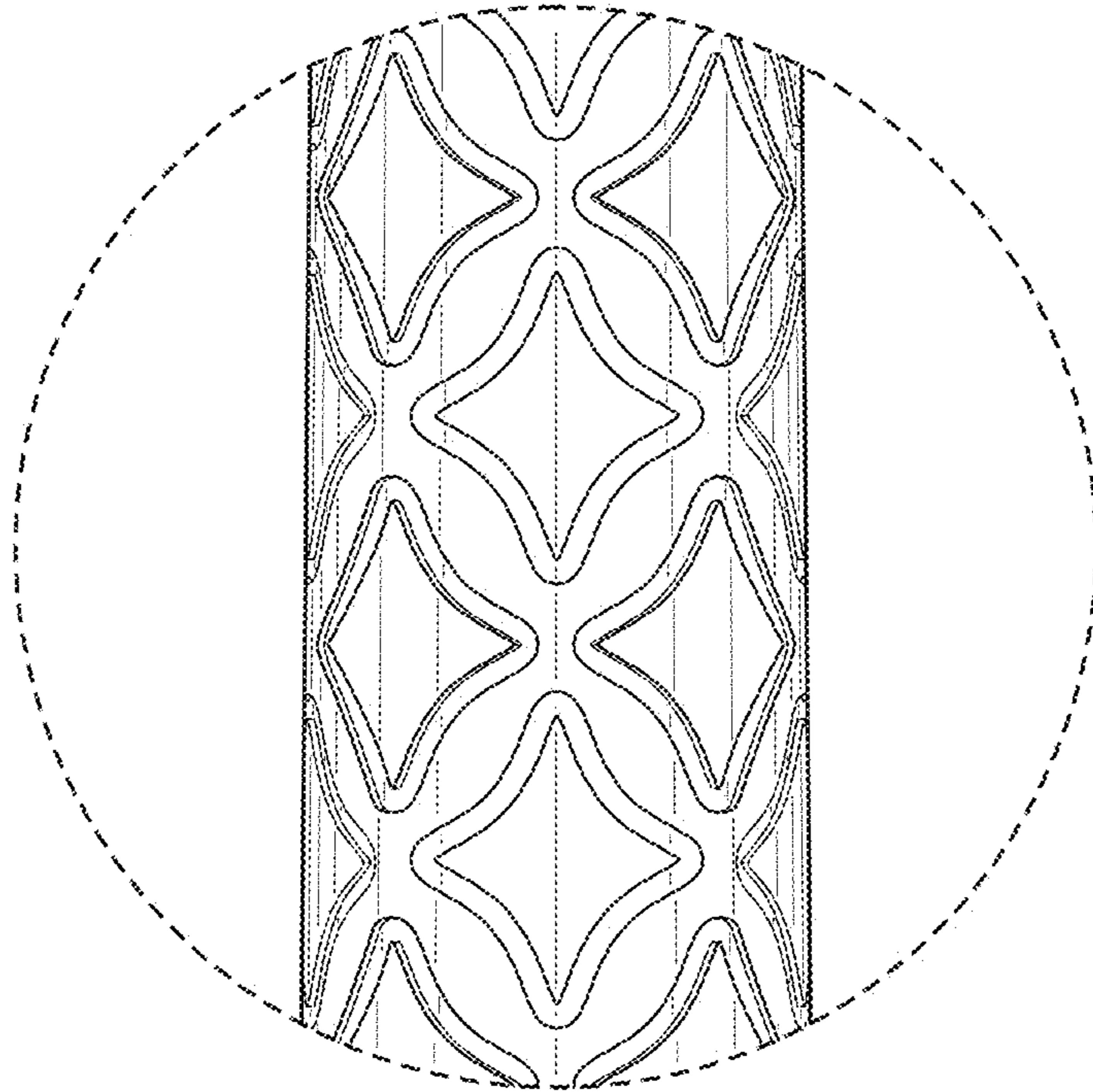

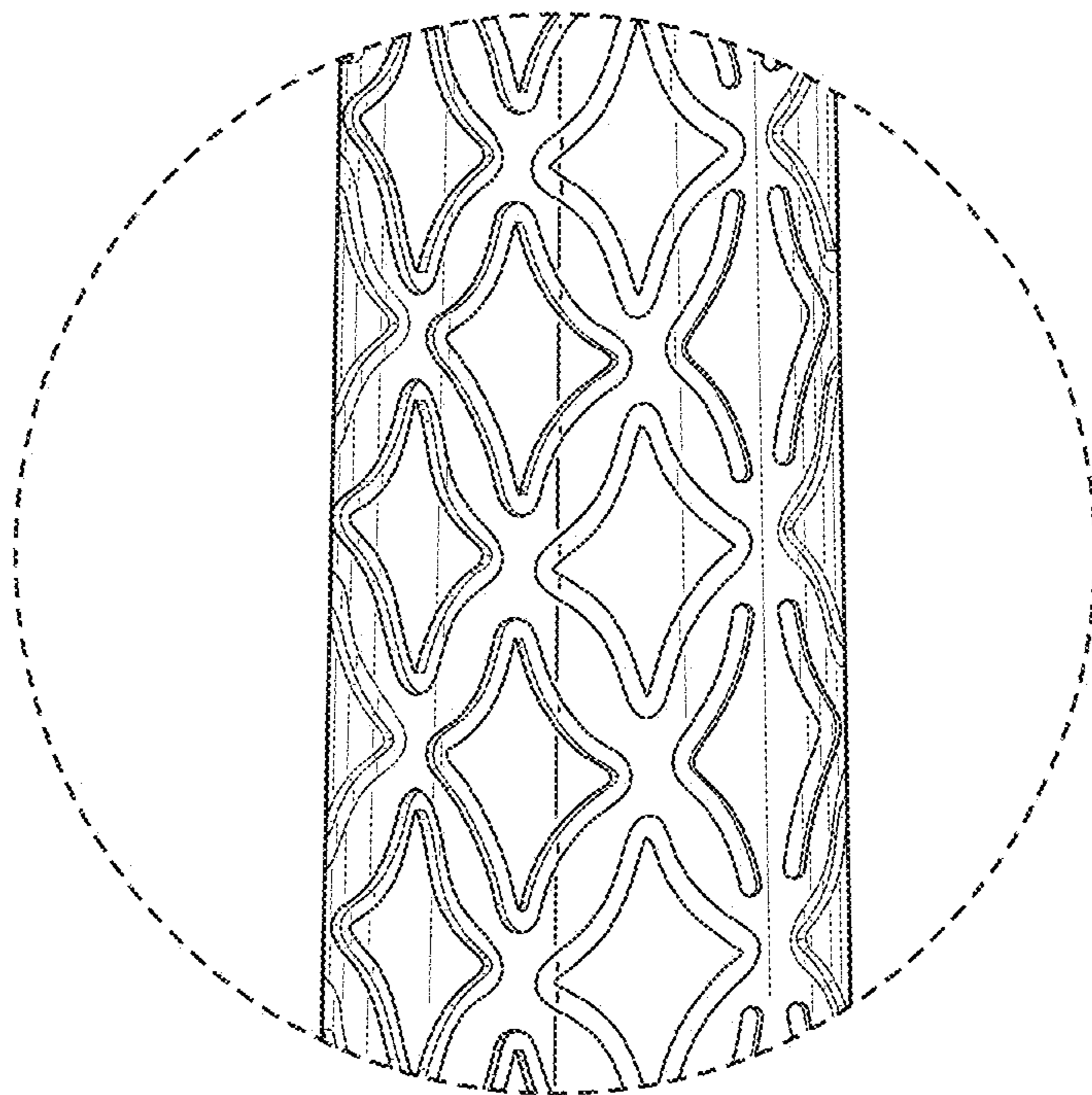
