(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

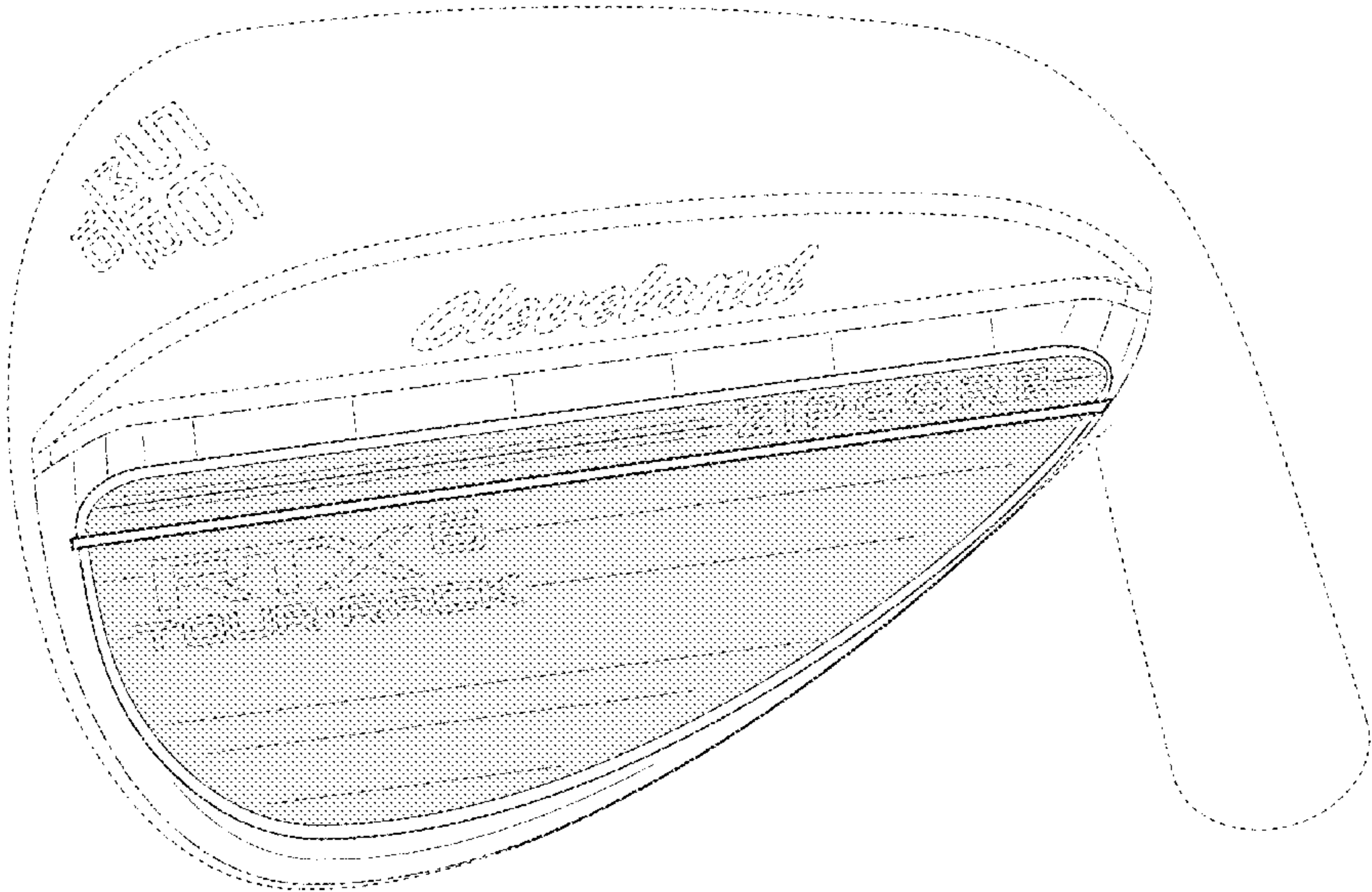
FIG. 1 is a front, toe-side, top perspective view of a golf club head, showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a toe-side elevational view thereof;
FIG. 5 is a heel-side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a rear, toe-side, bottom perspective view thereof.
The broken lines depict parts of the golf club head that form no part of the claimed design. The dot-dash chain lines depict boundaries of the claimed subject matter that form no part of the claimed design. The gray shading depicts claimed surfaces having a different surface finish than non-gray-shaded claimed surfaces.

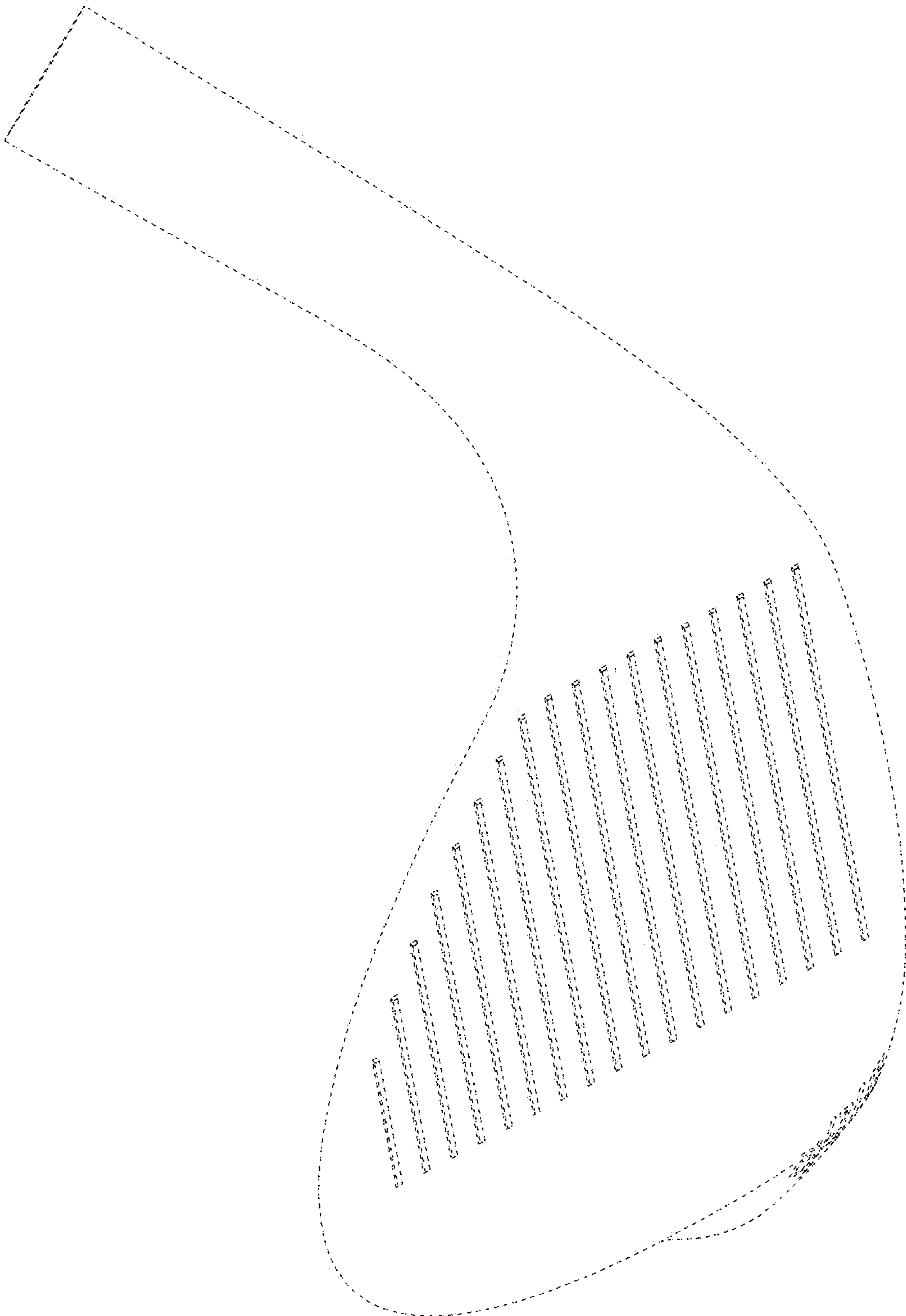

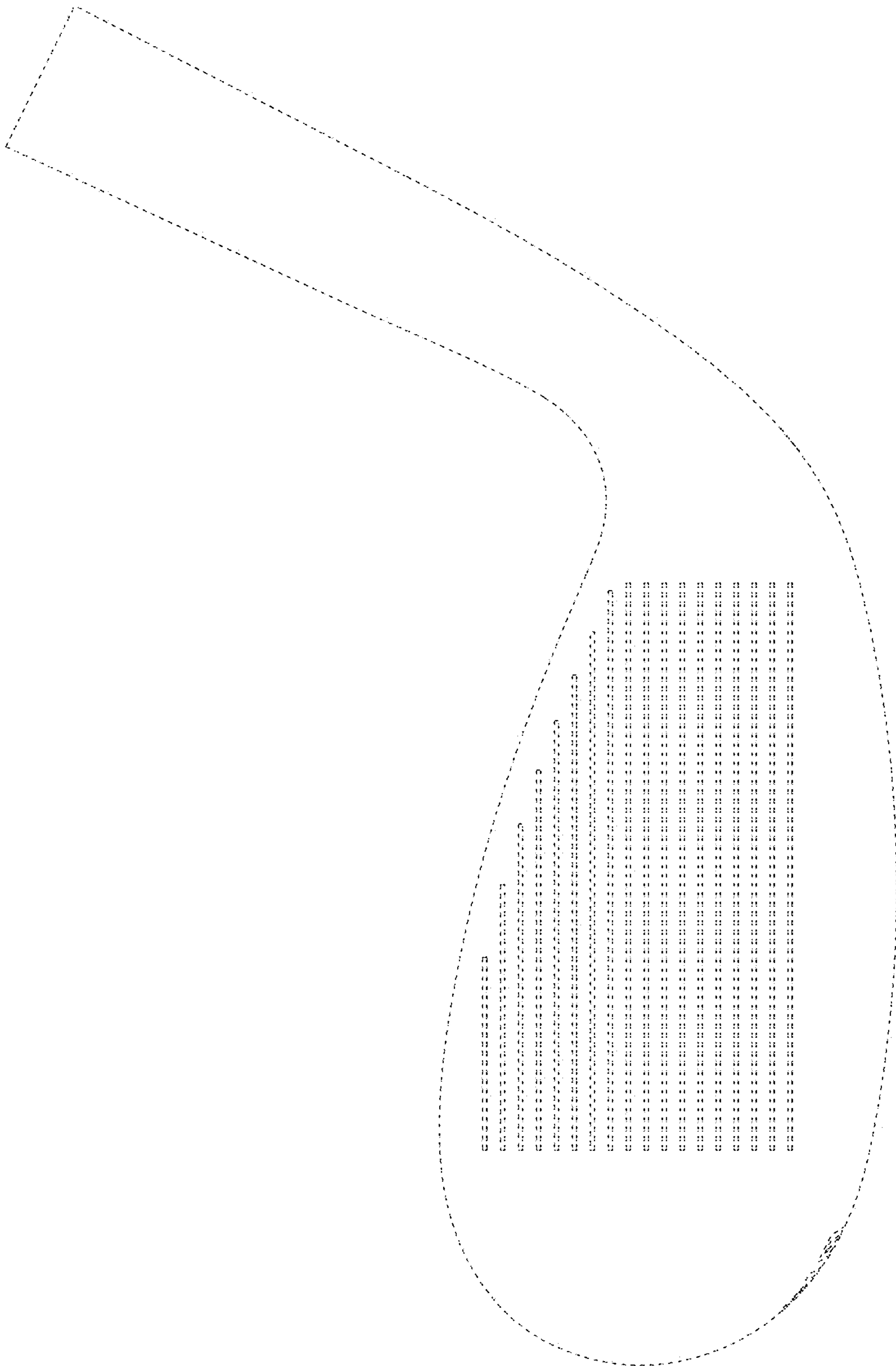

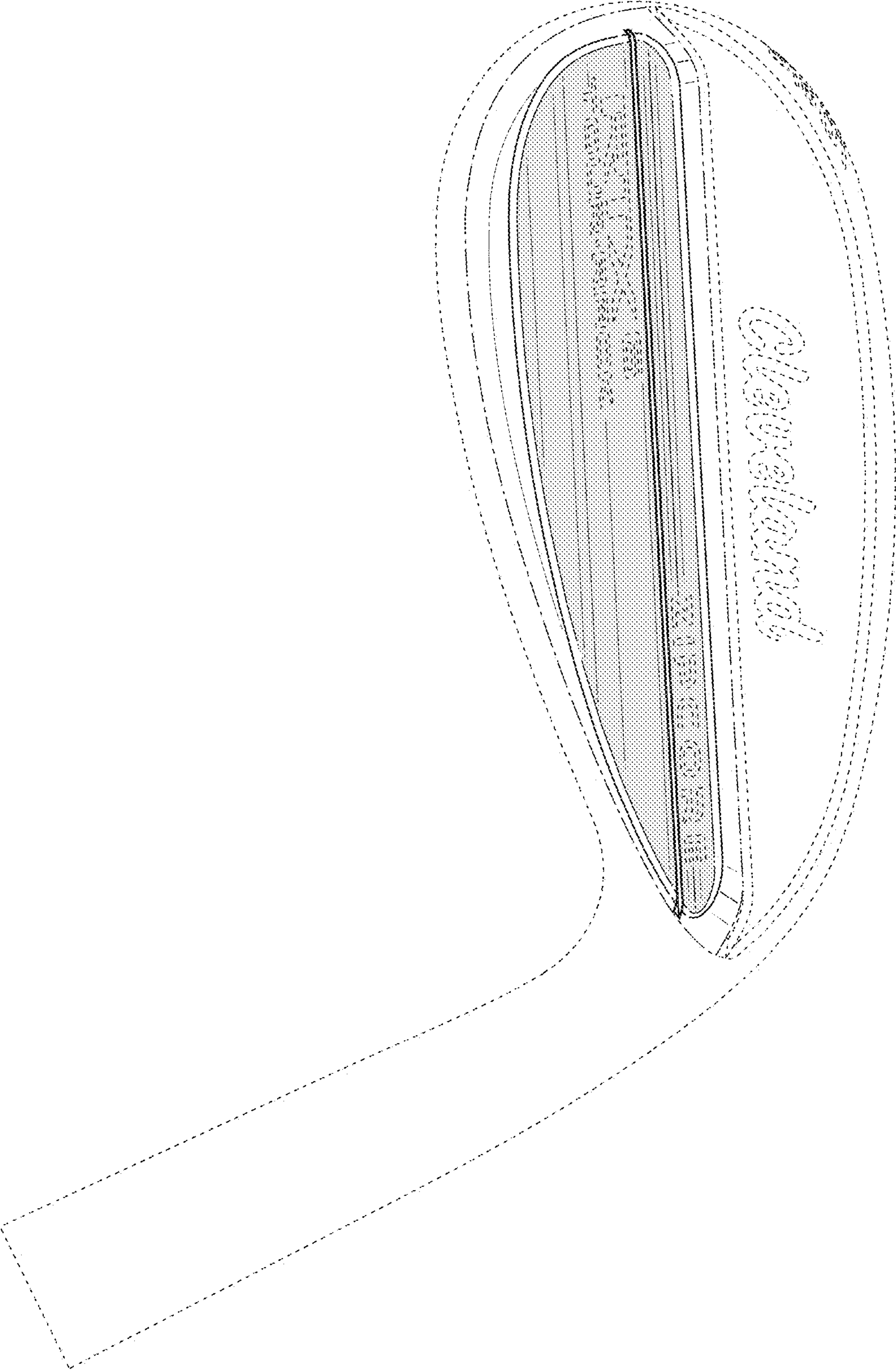

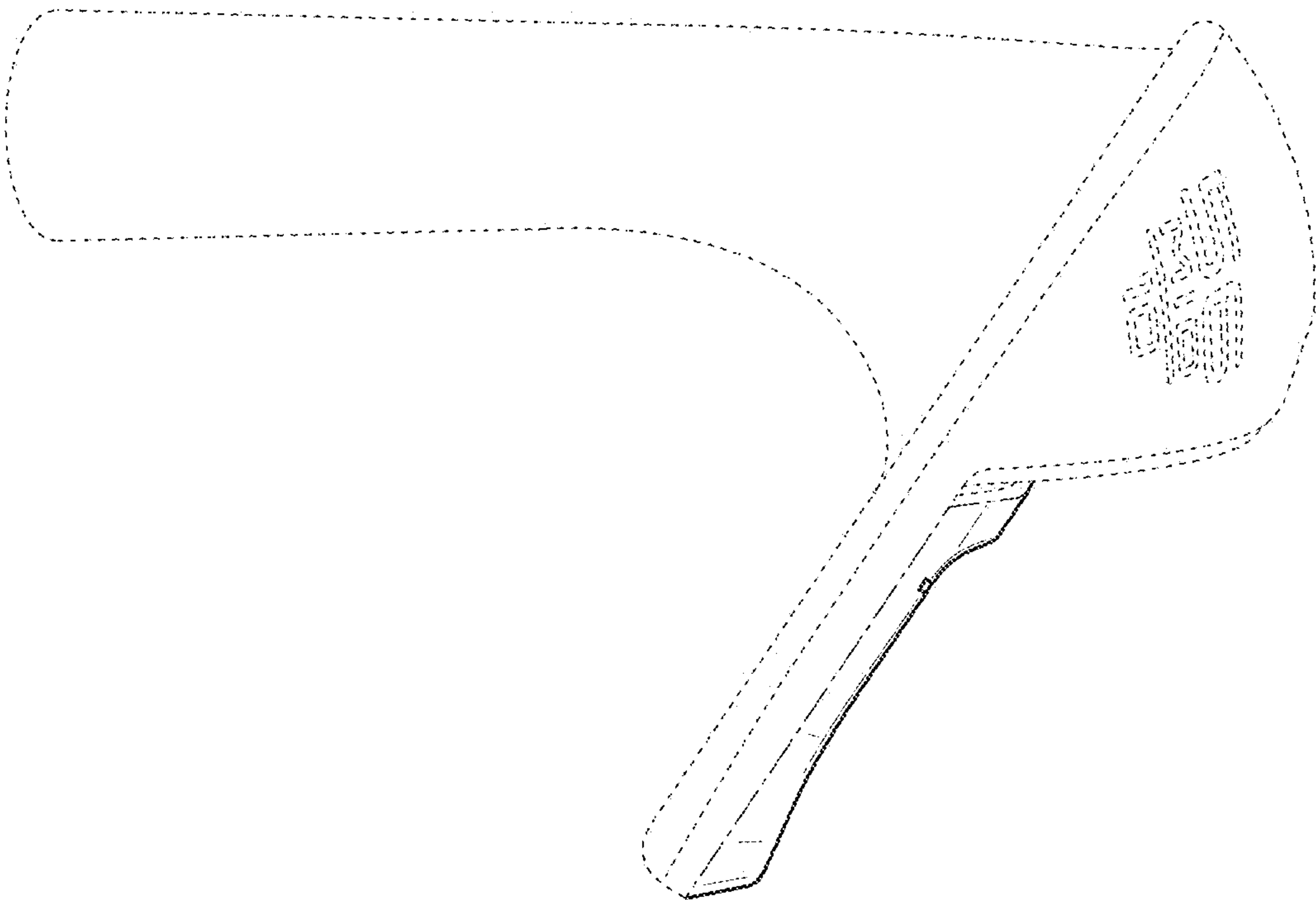

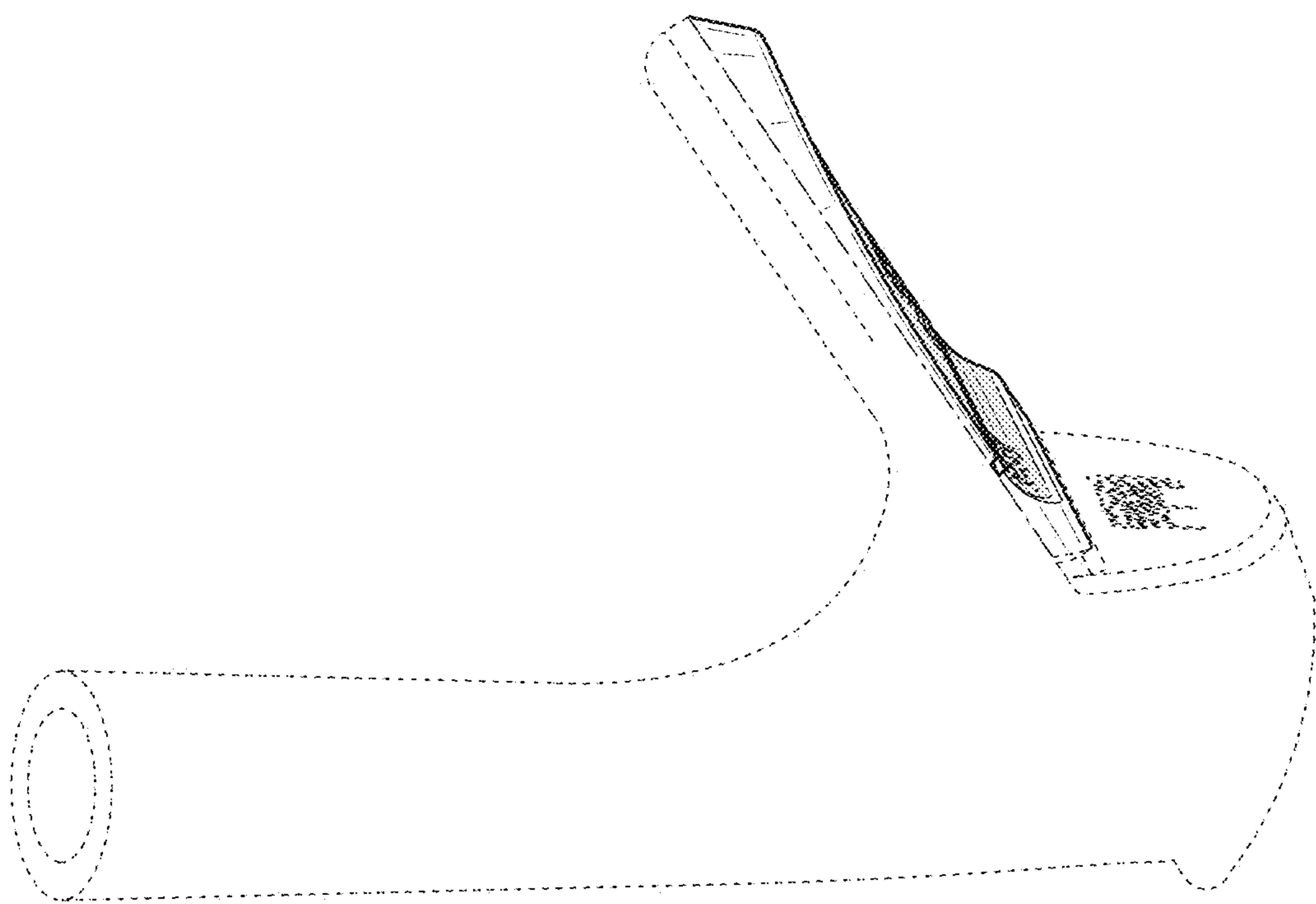

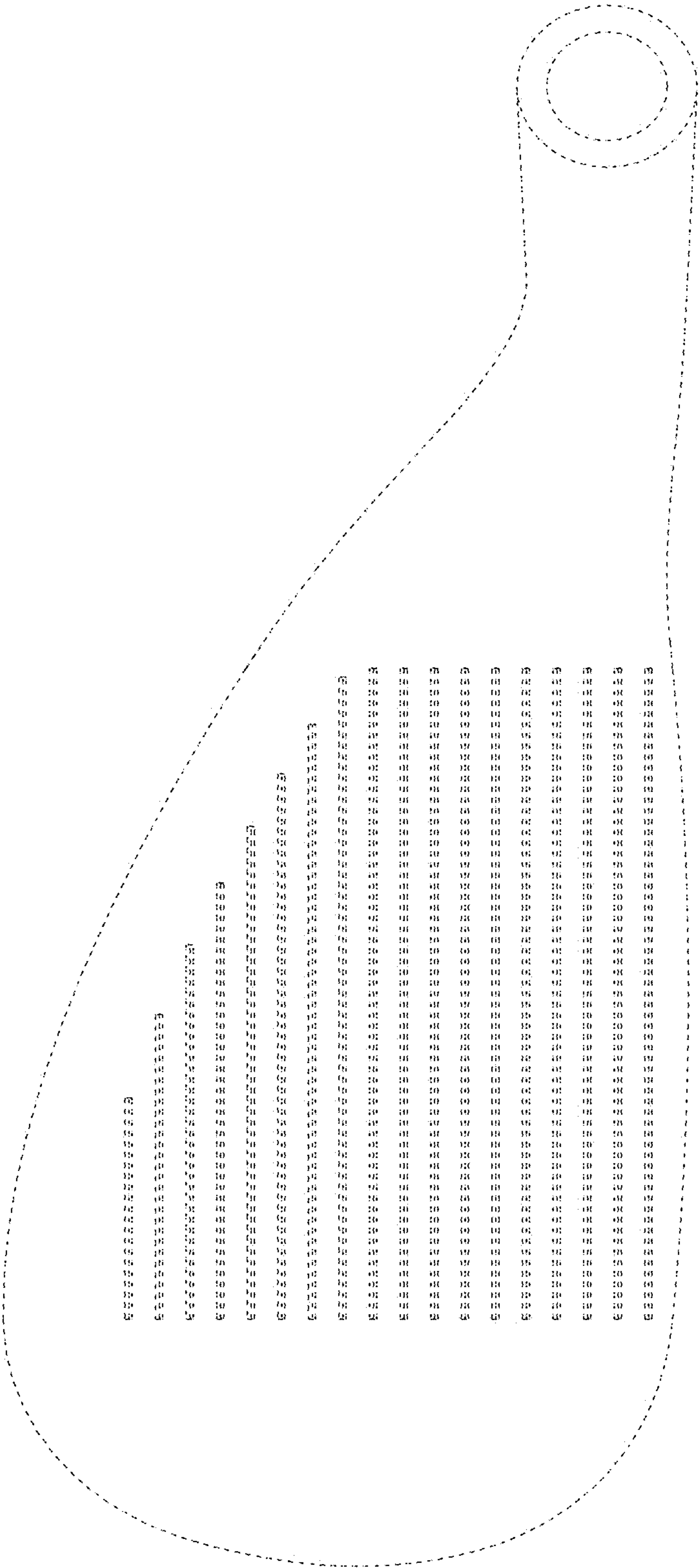

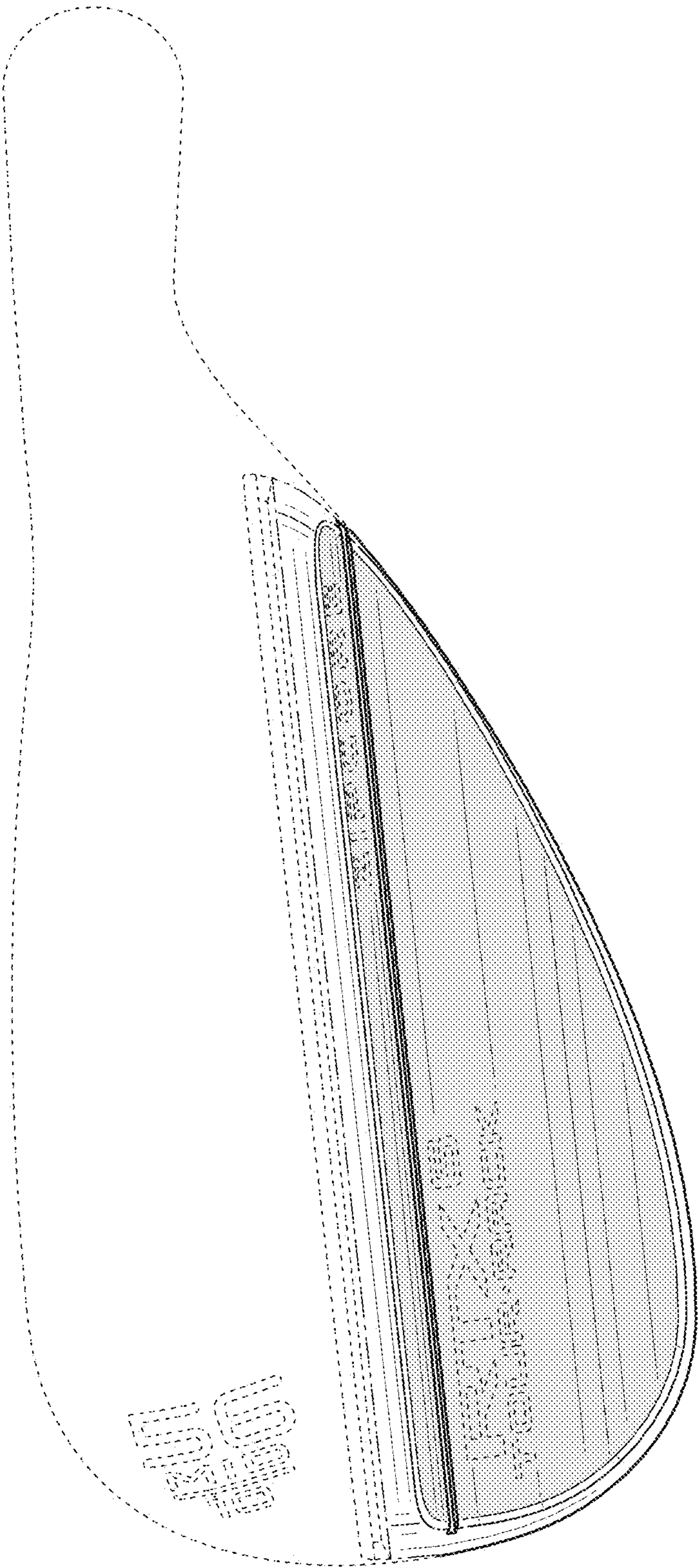

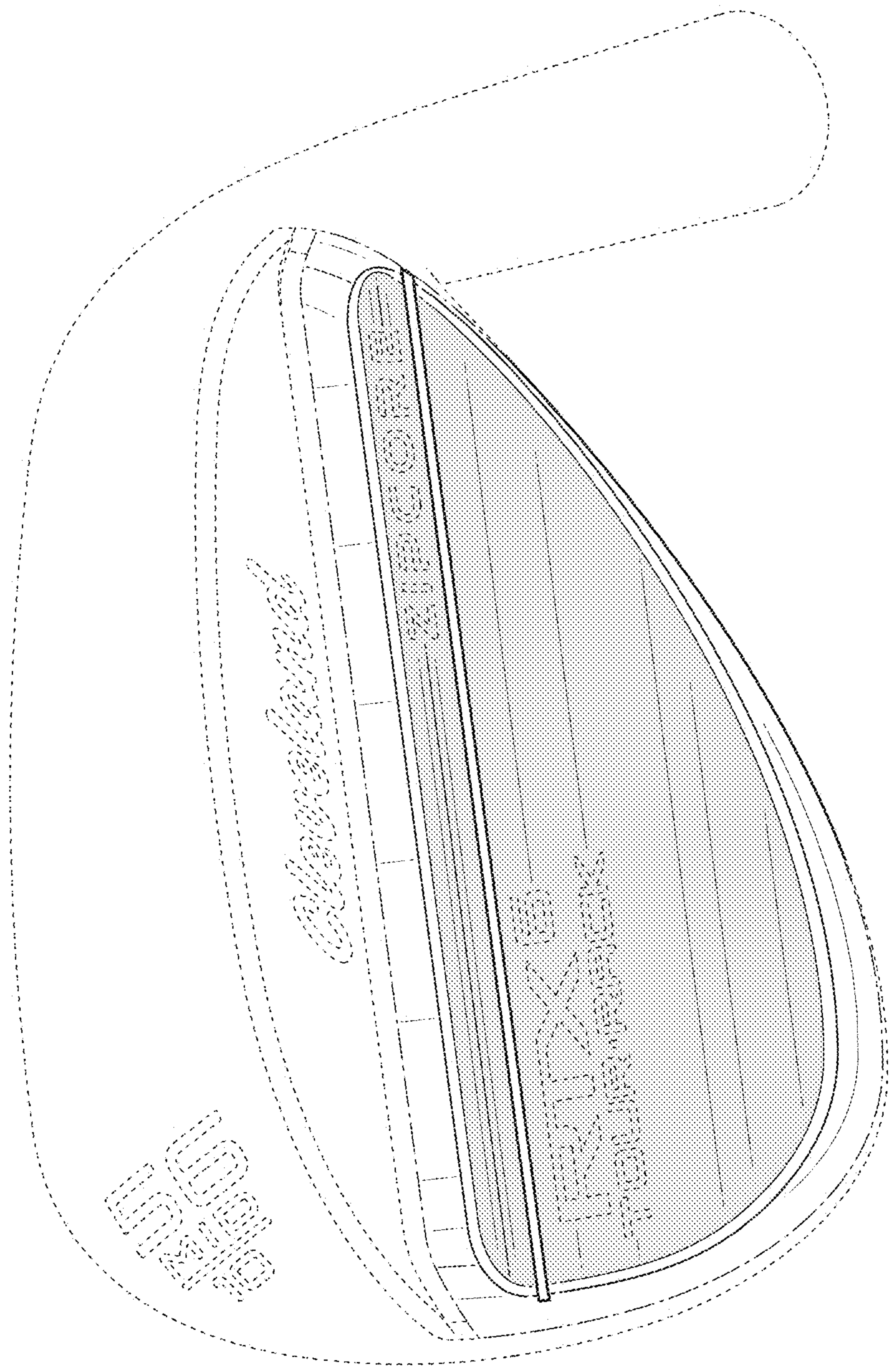
