DESCRIPTION

FIG. 1 is a left side elevational view of an anchor system showing my new design;
 FIG. 2 is a top-left perspective view thereof;

 FIG. 4 is a top plan view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a bottom plan view thereof;

 FIG. 8 is an enlarged front view thereof.

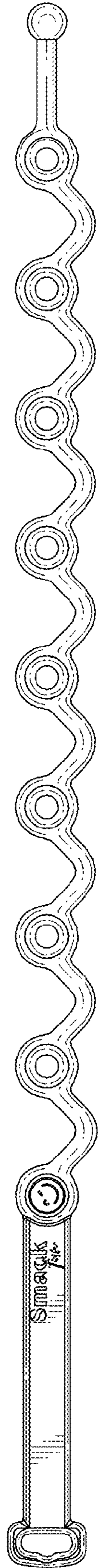

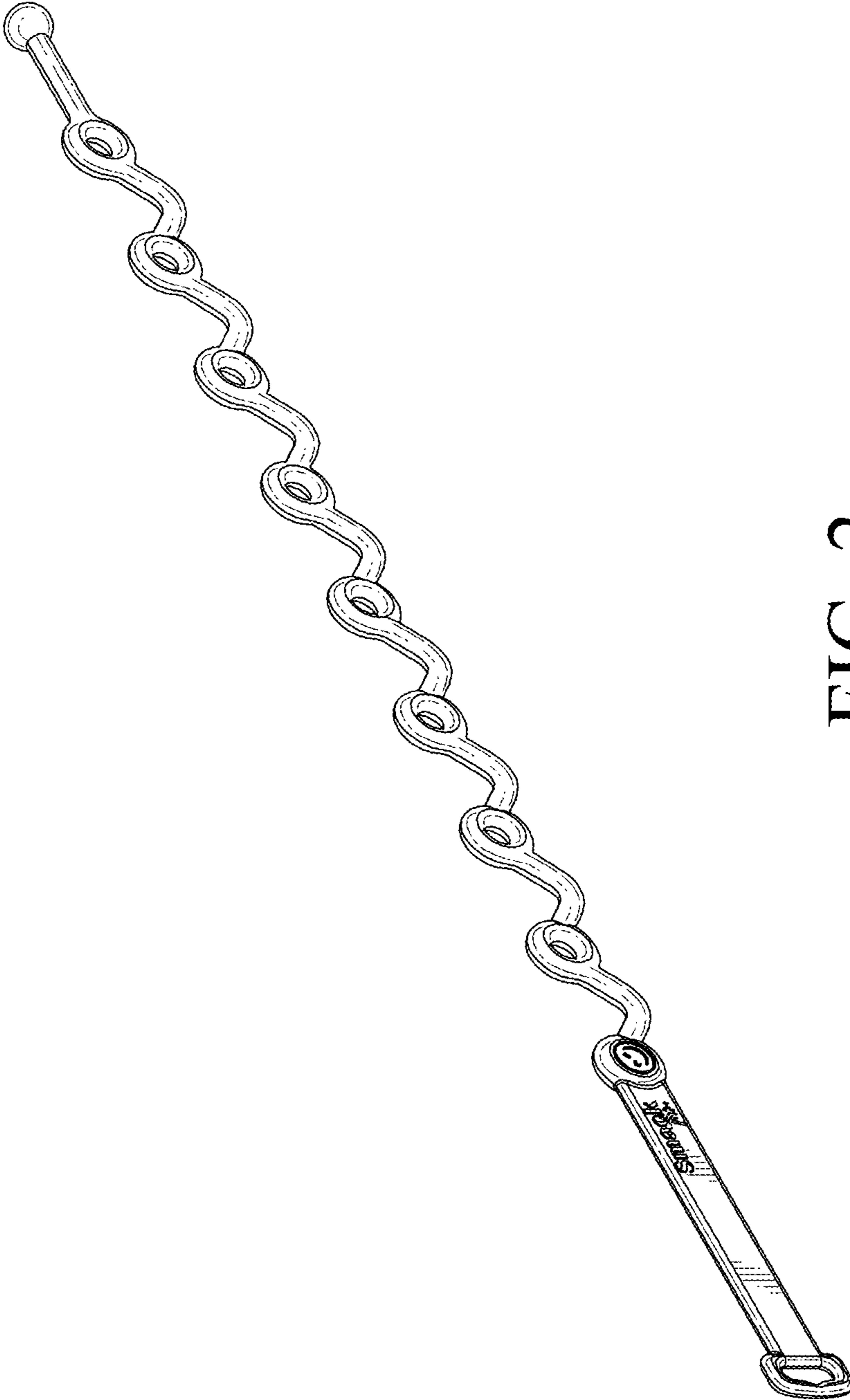

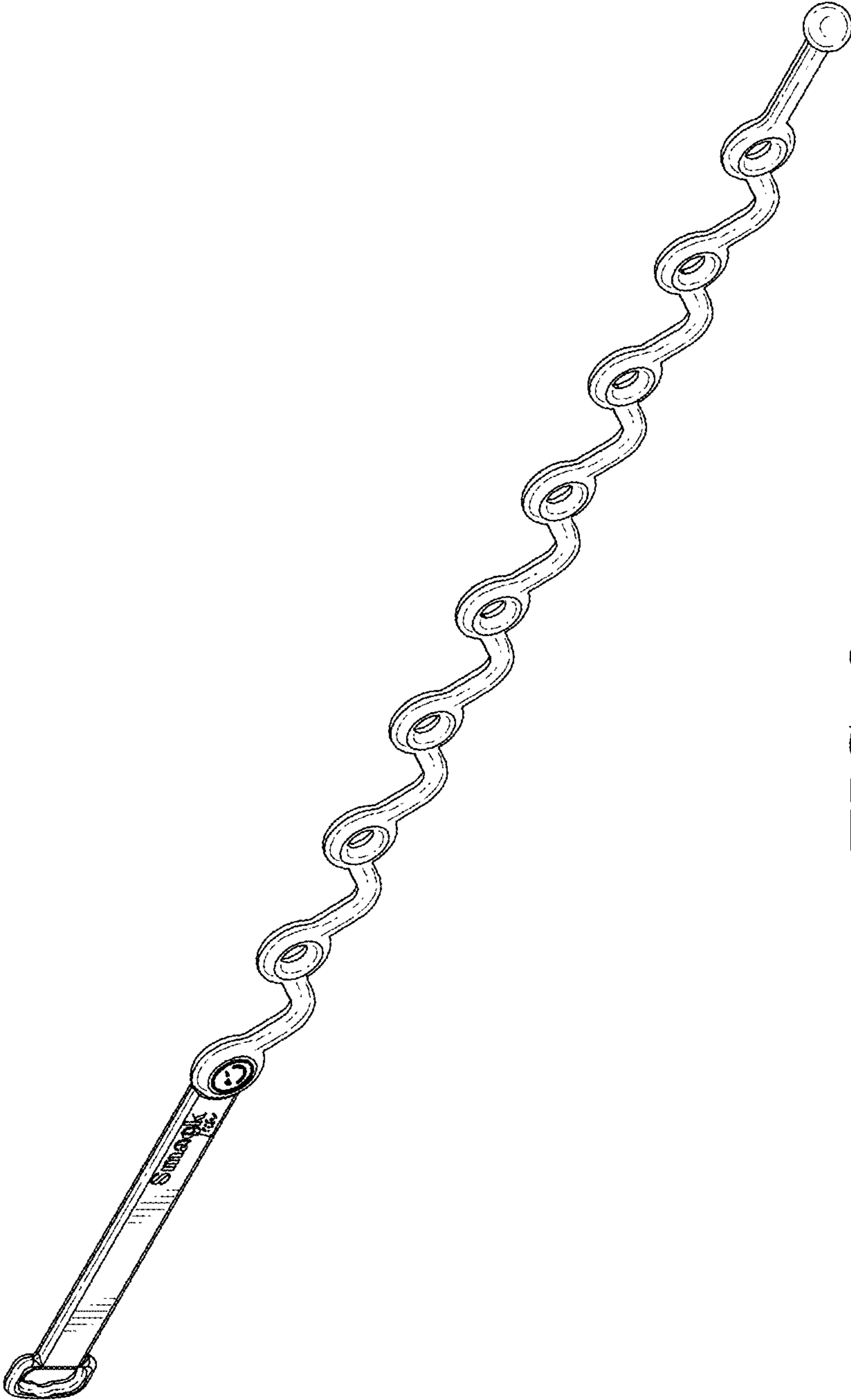

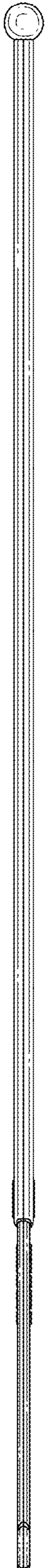

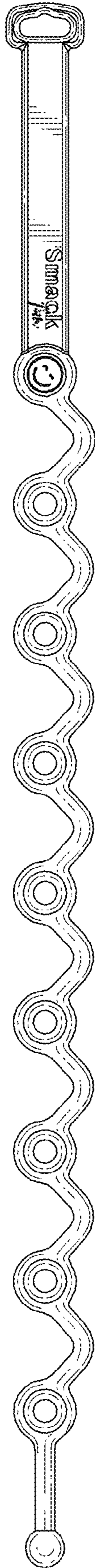

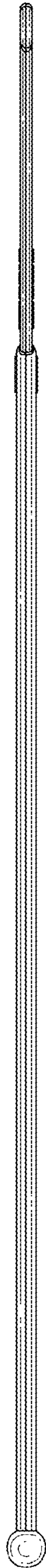

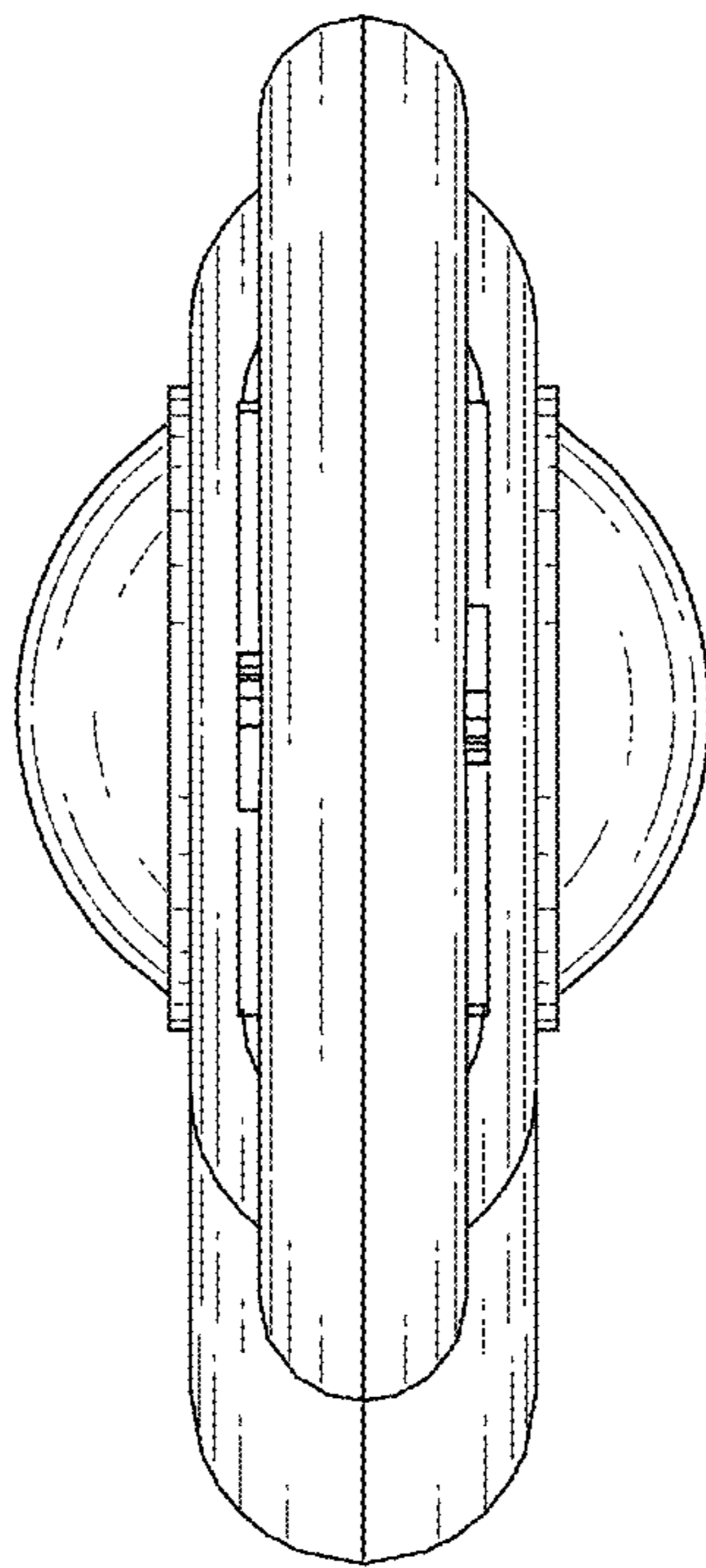

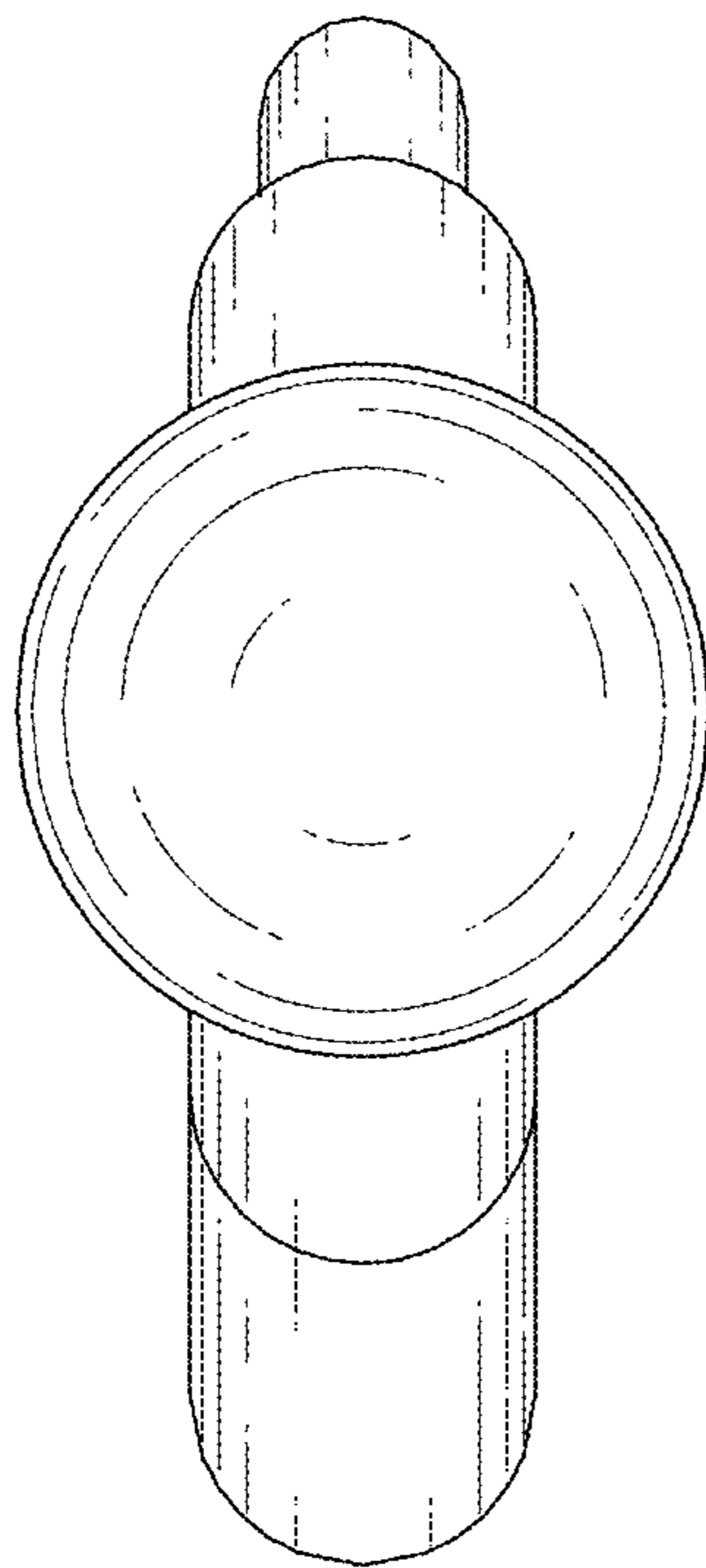
