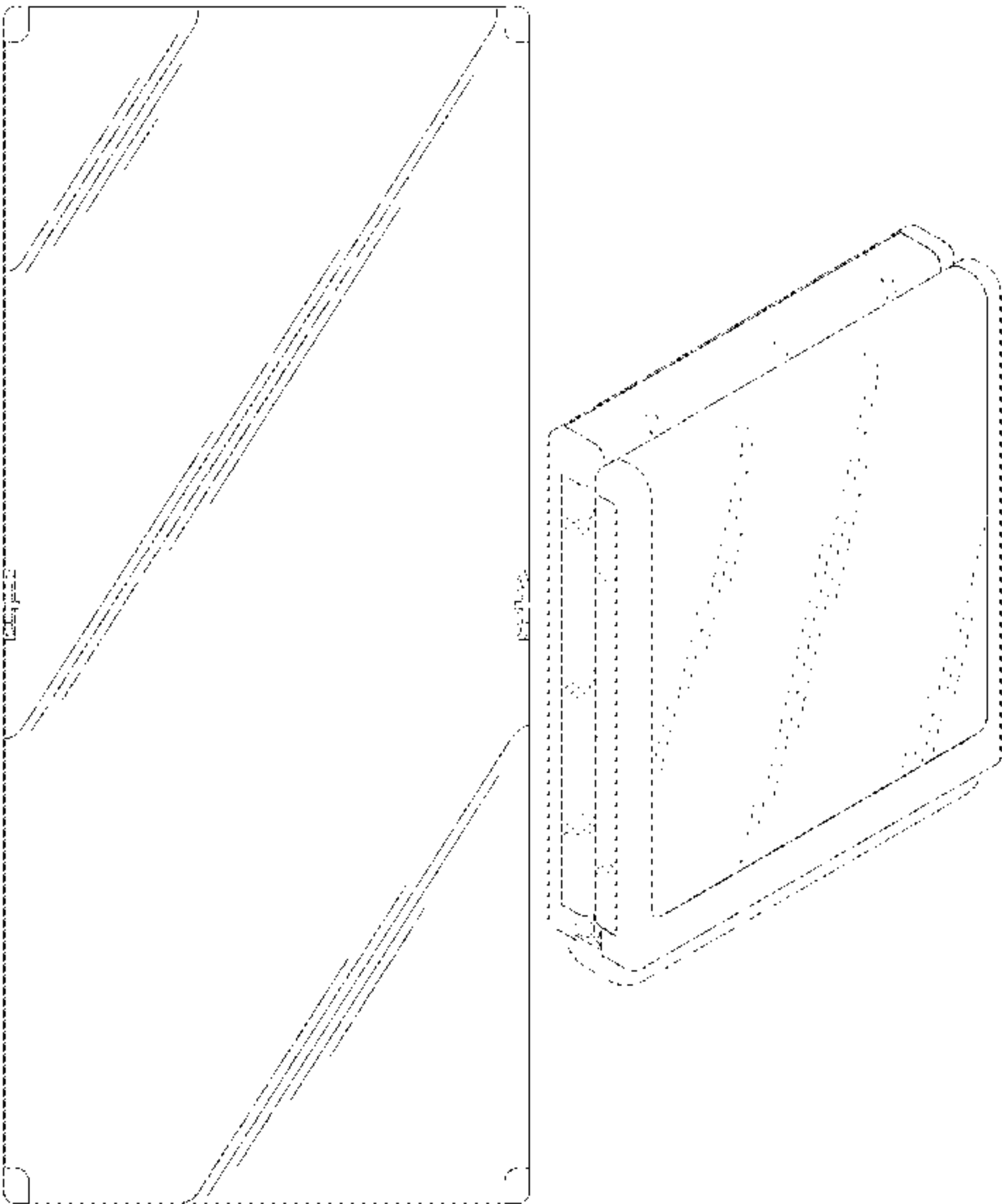
(57) **CLAIM**

The ornamental design for a display device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a display device according to the present design, shown in an unfolded state;
FIG. 2 is a front view thereof;

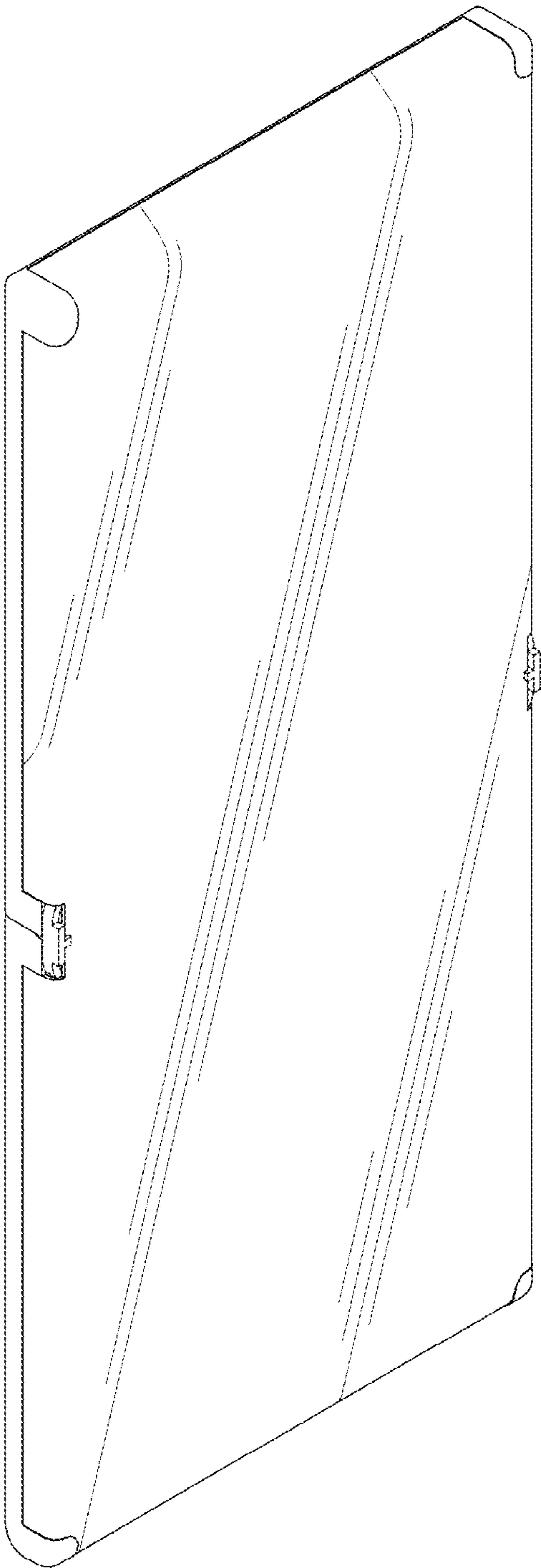

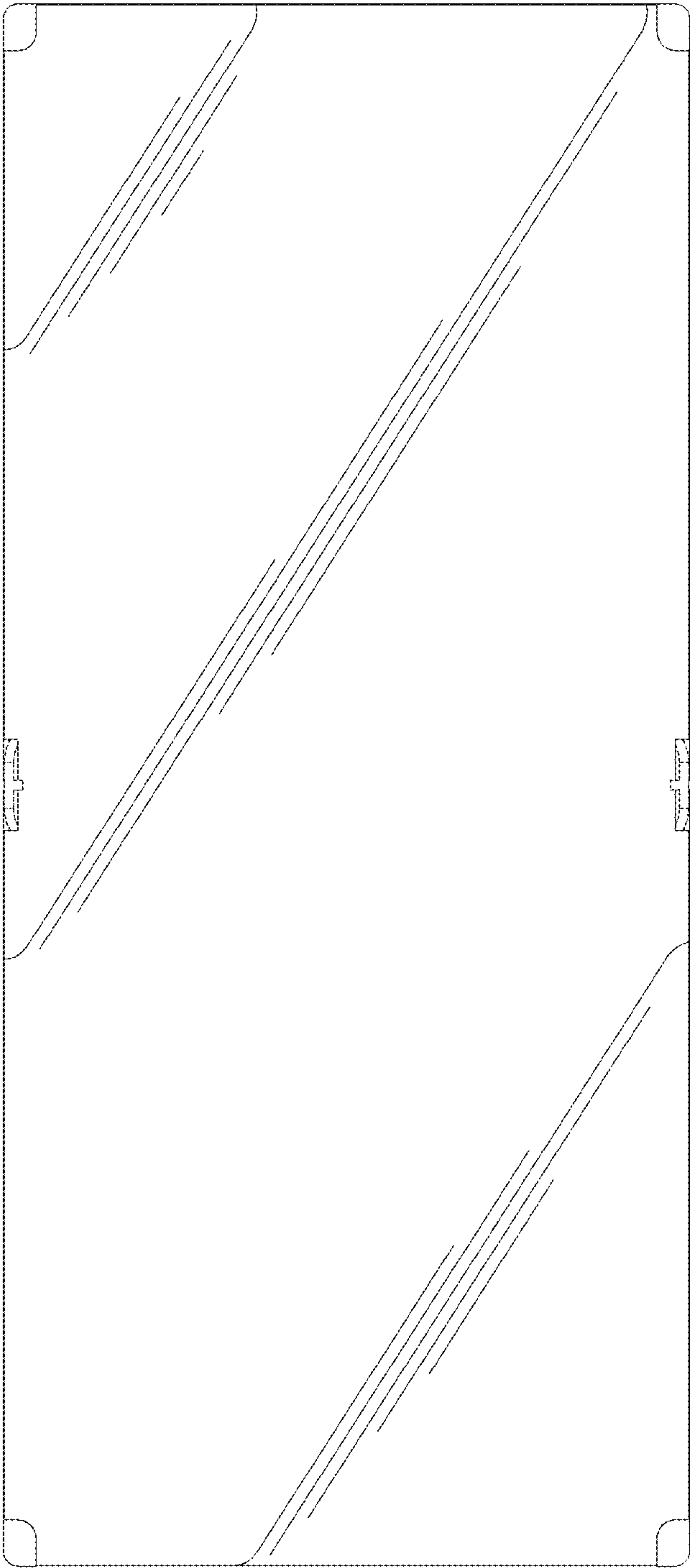

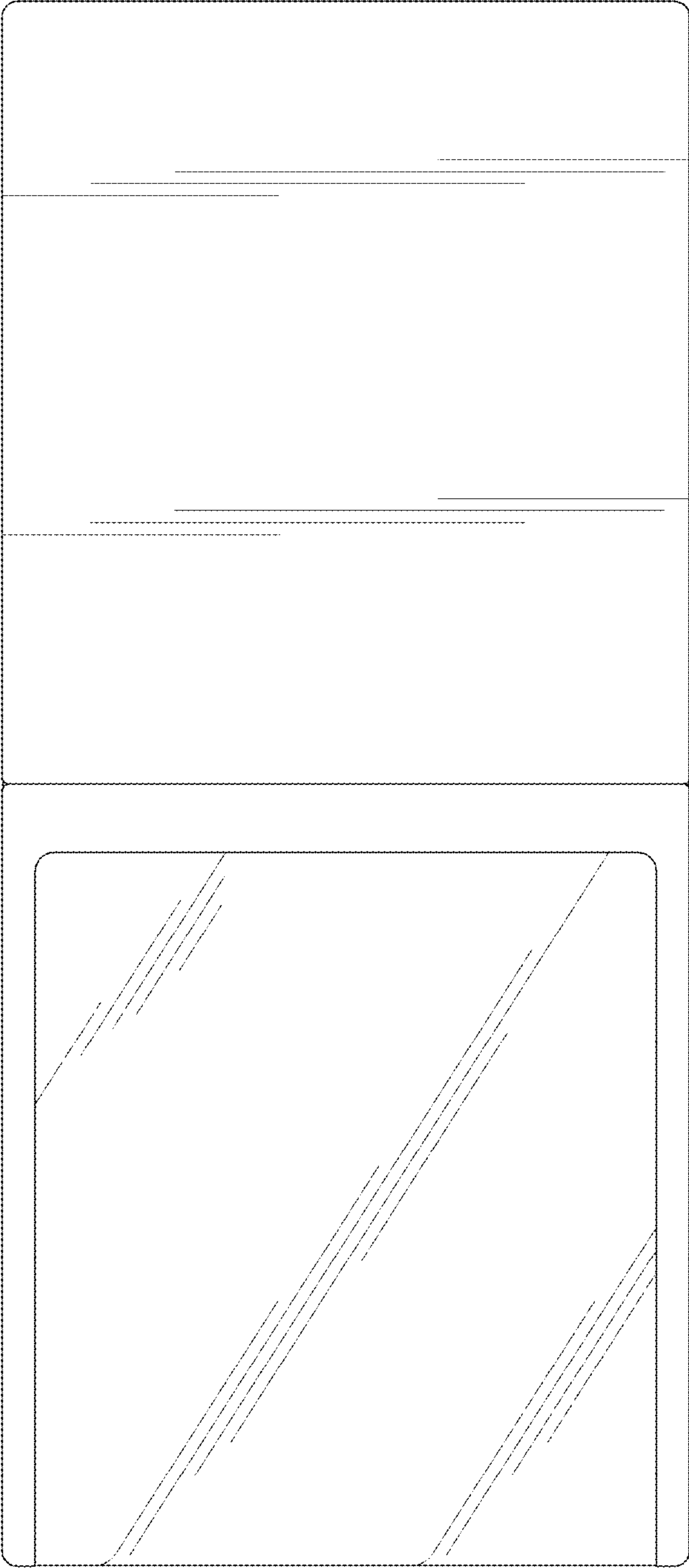

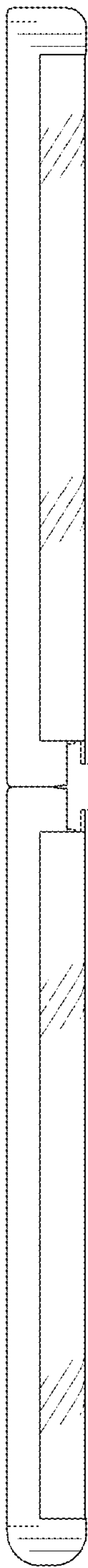

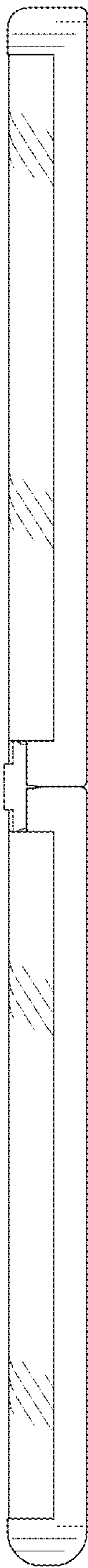

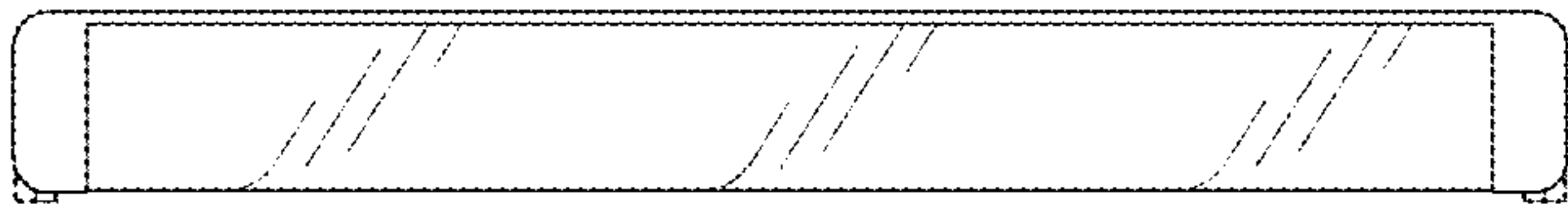

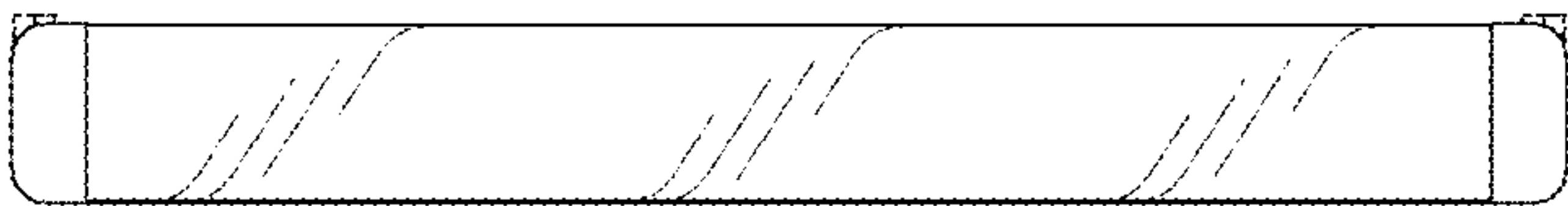

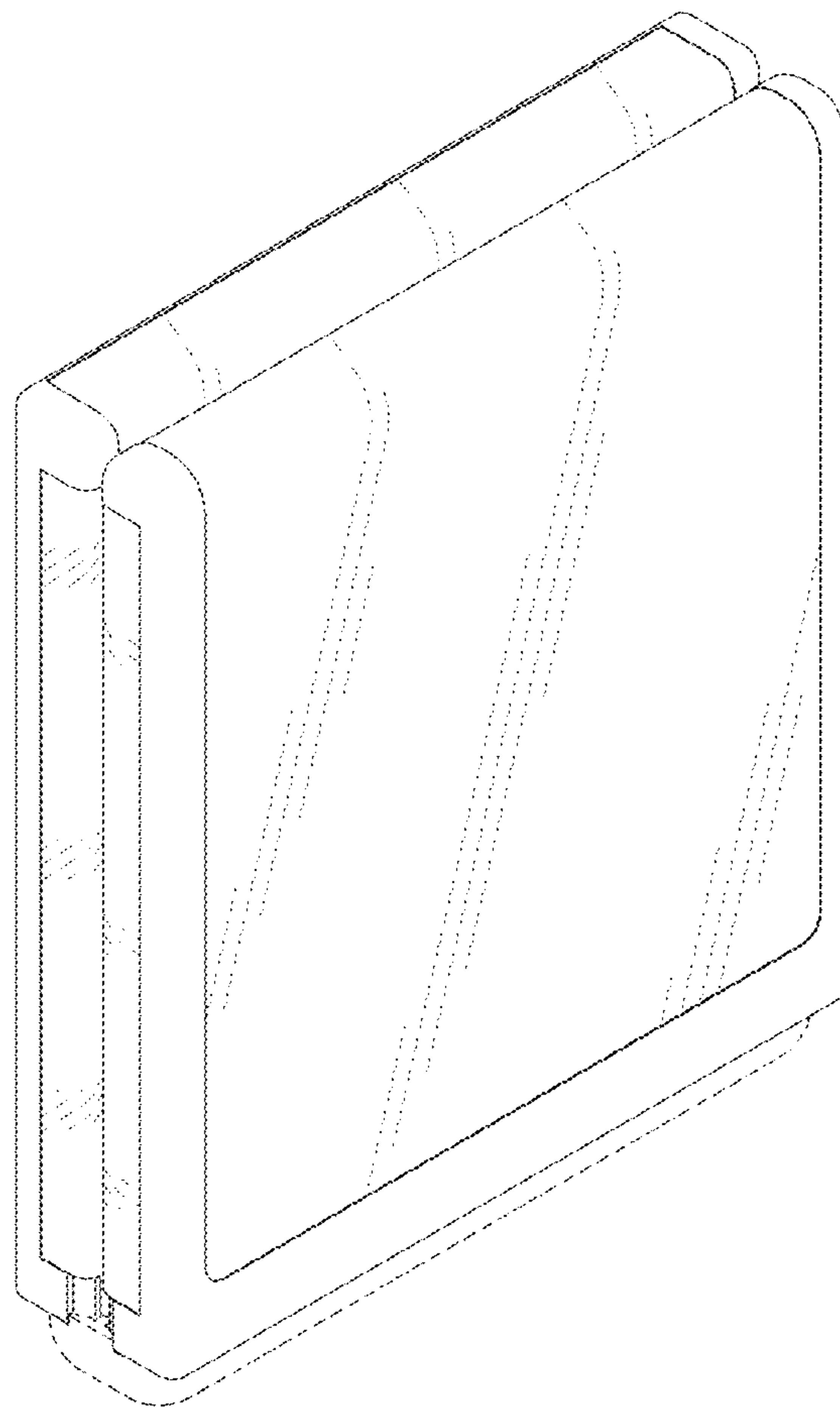

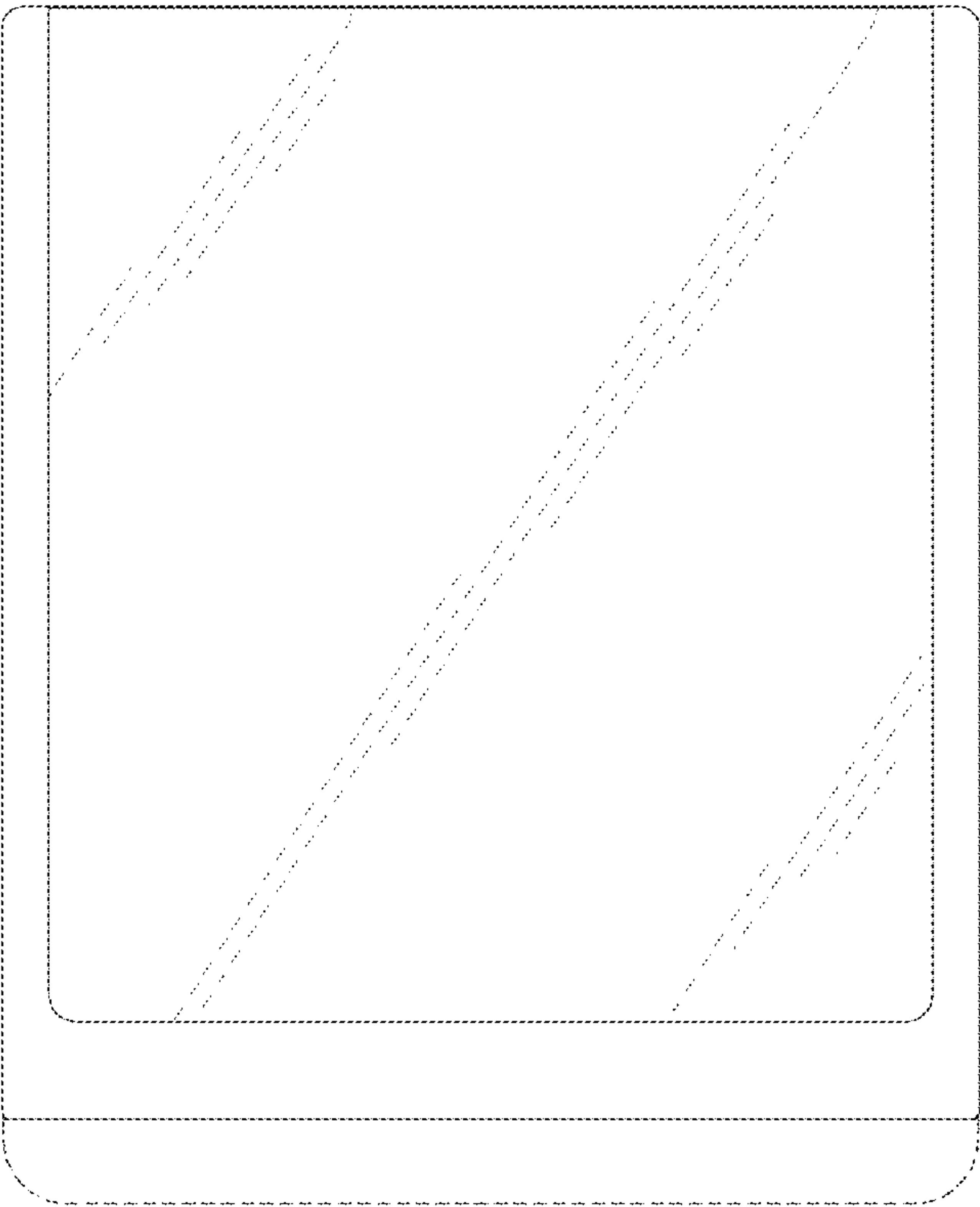

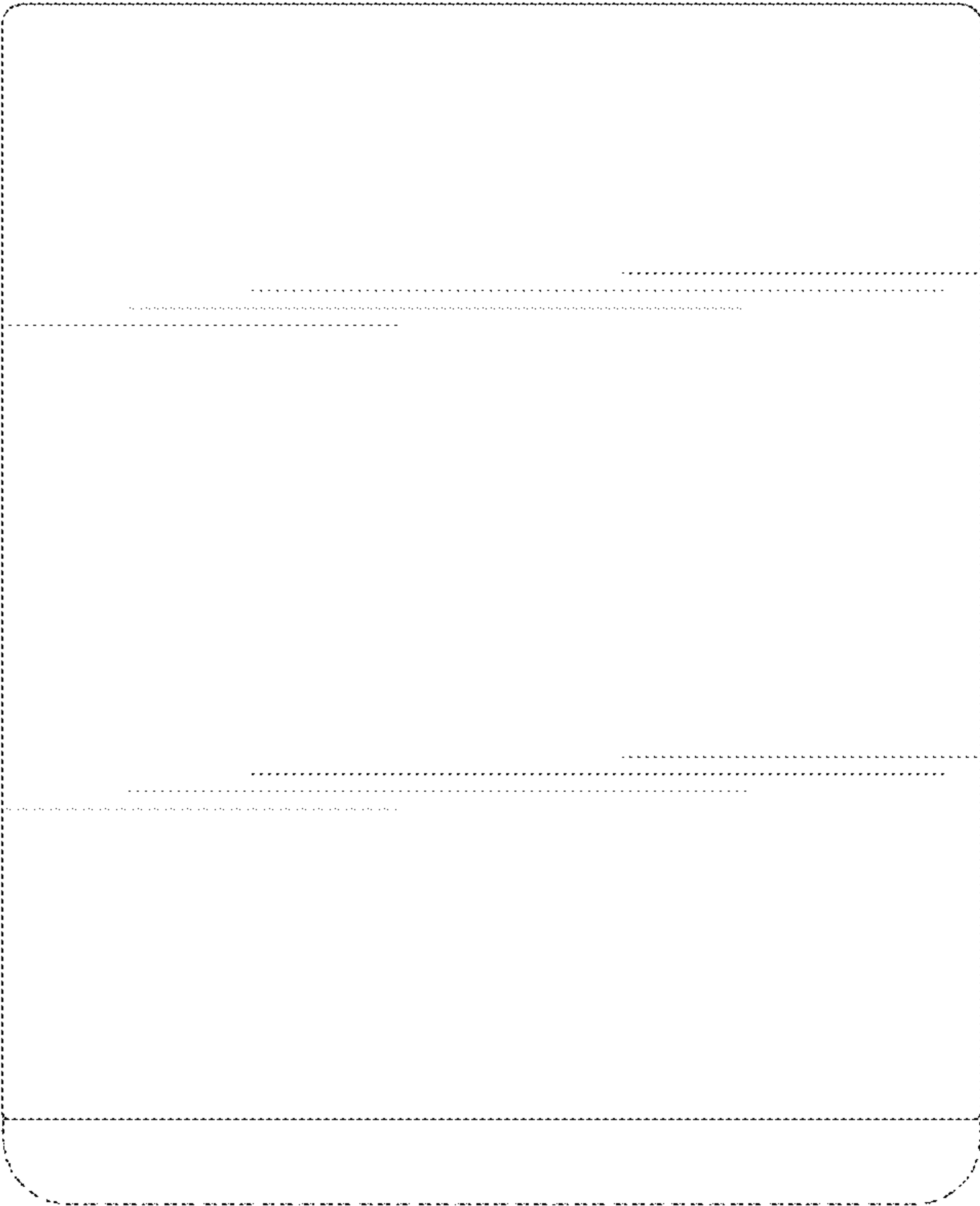

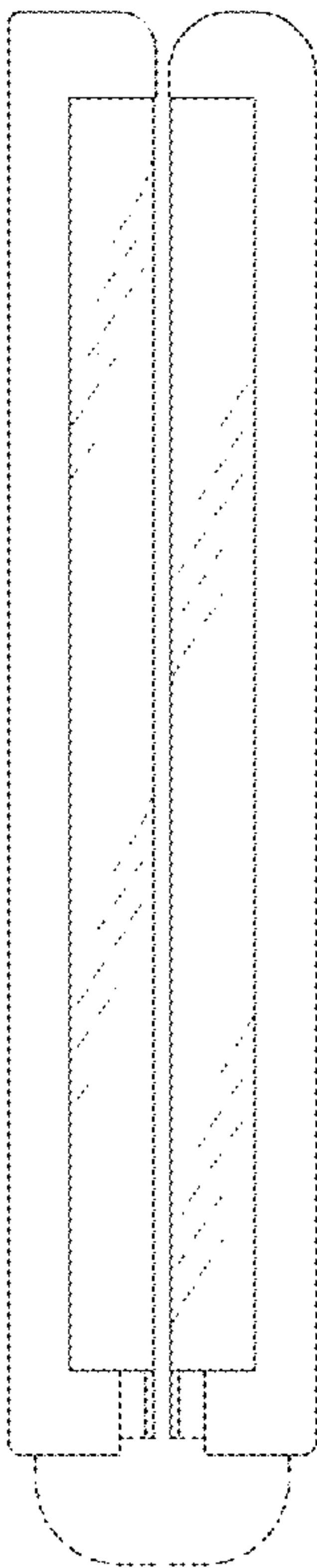

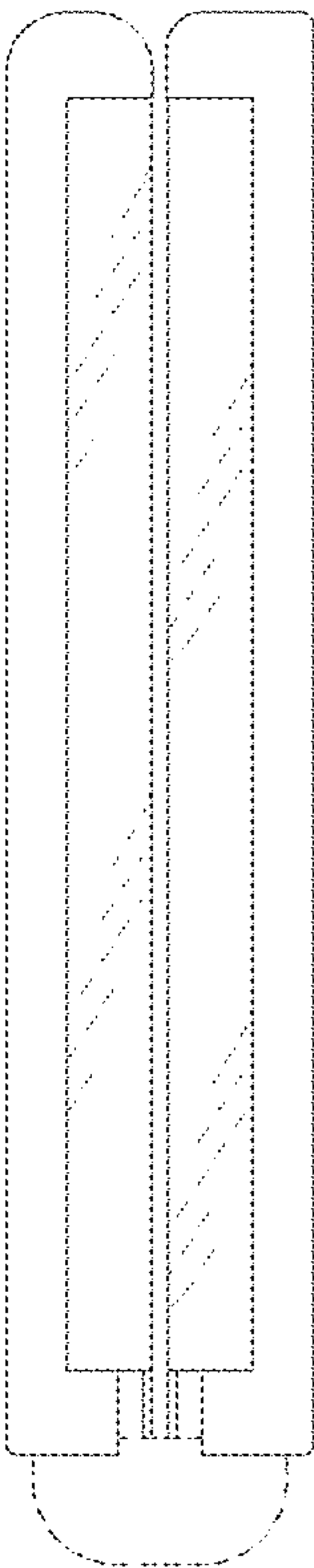

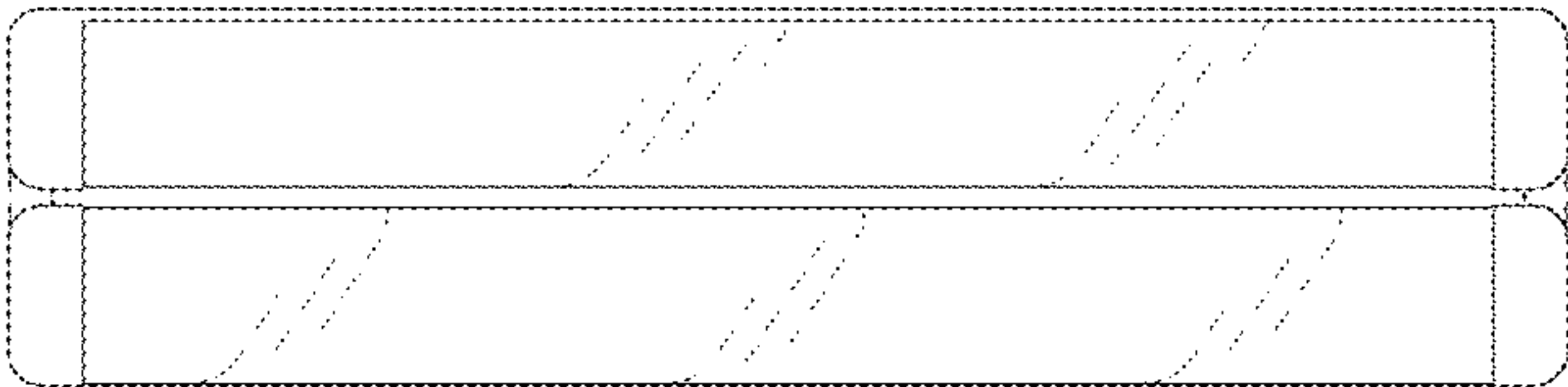
