DESCRIPTION

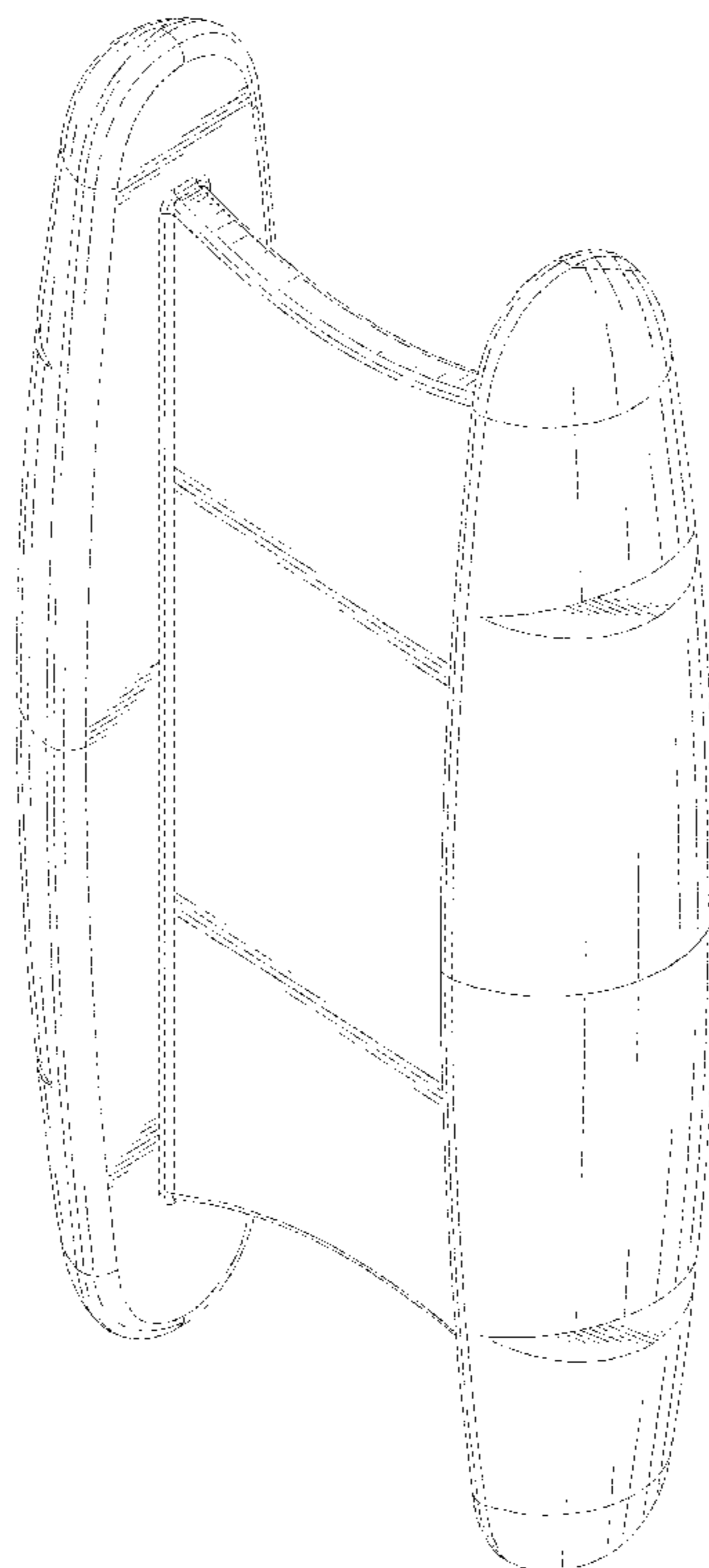
FIG. 1 is a top front perspective view of a universal cable holder showing my new design;

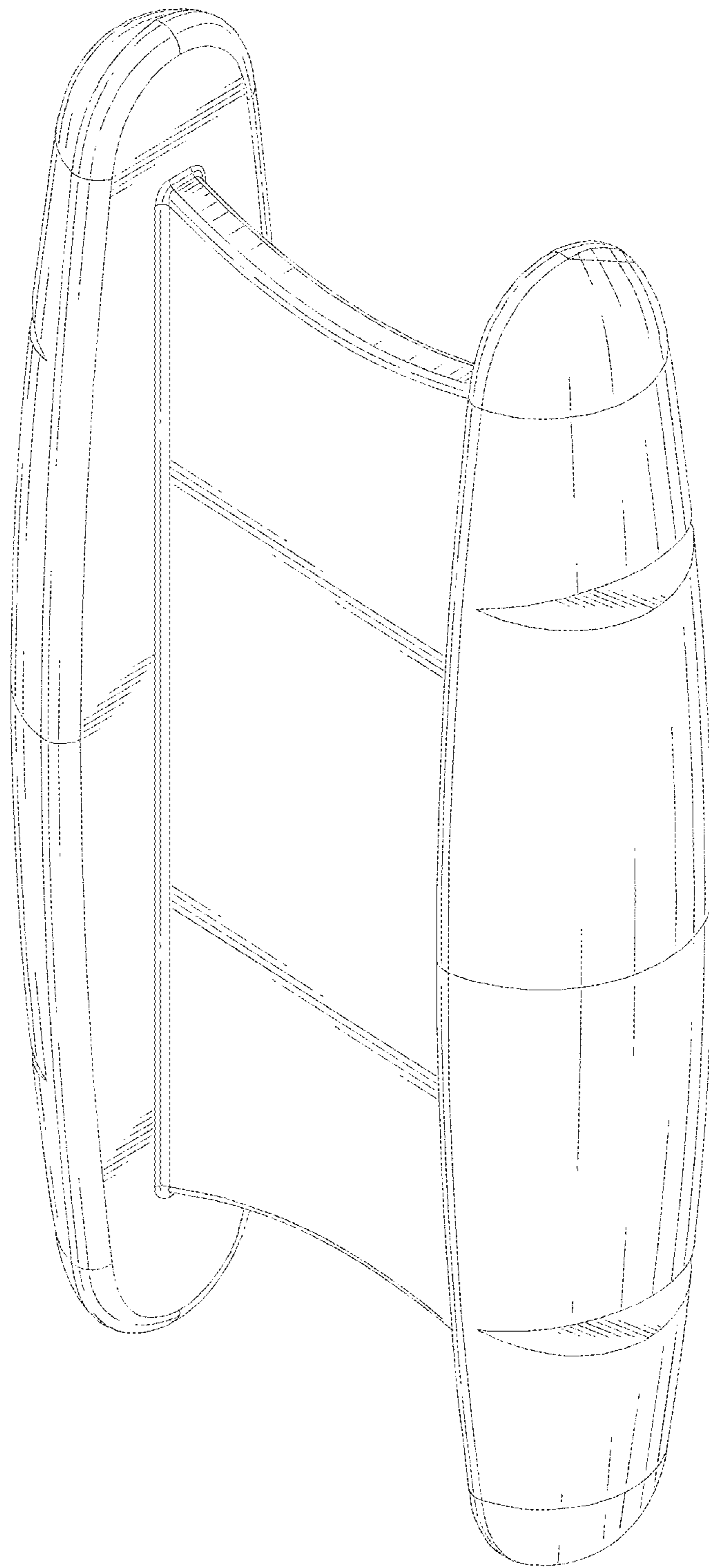

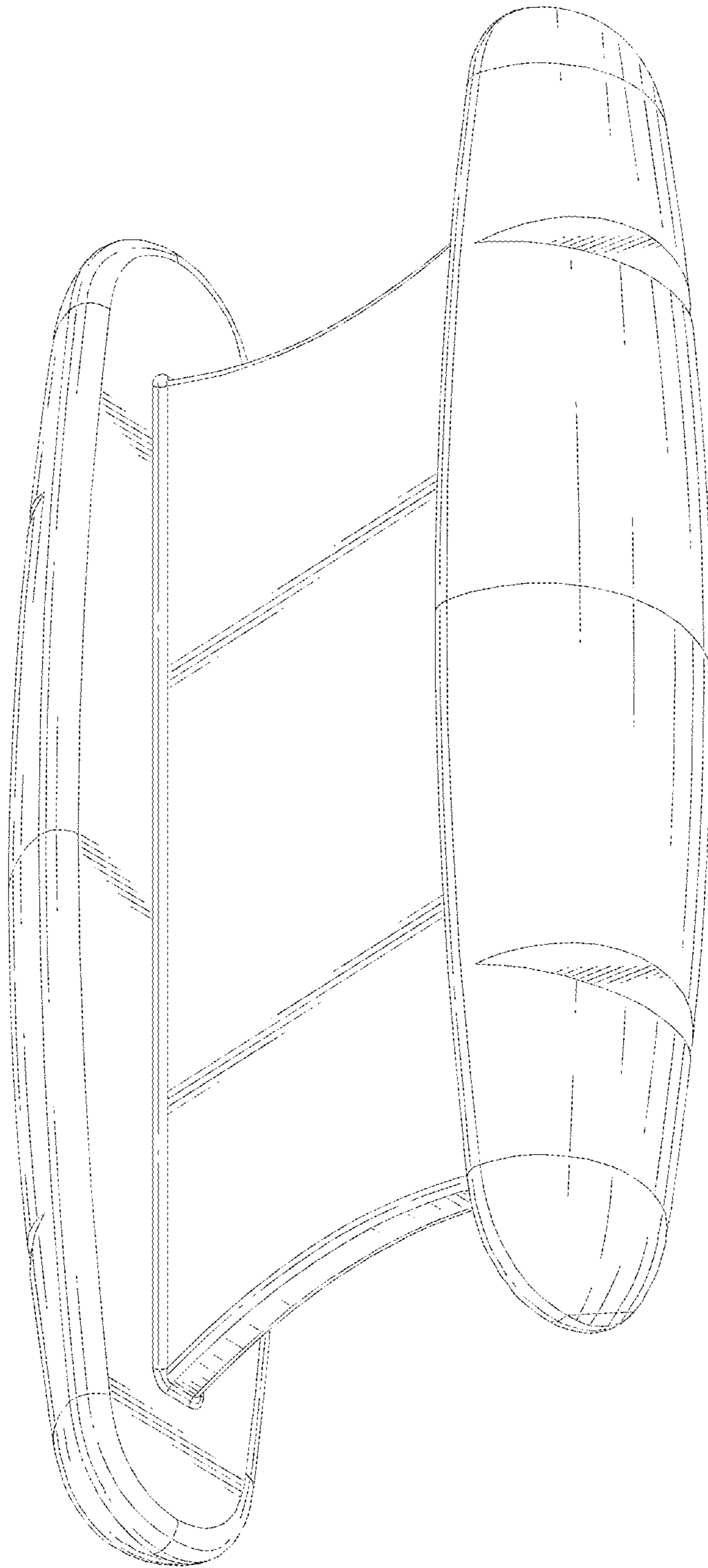

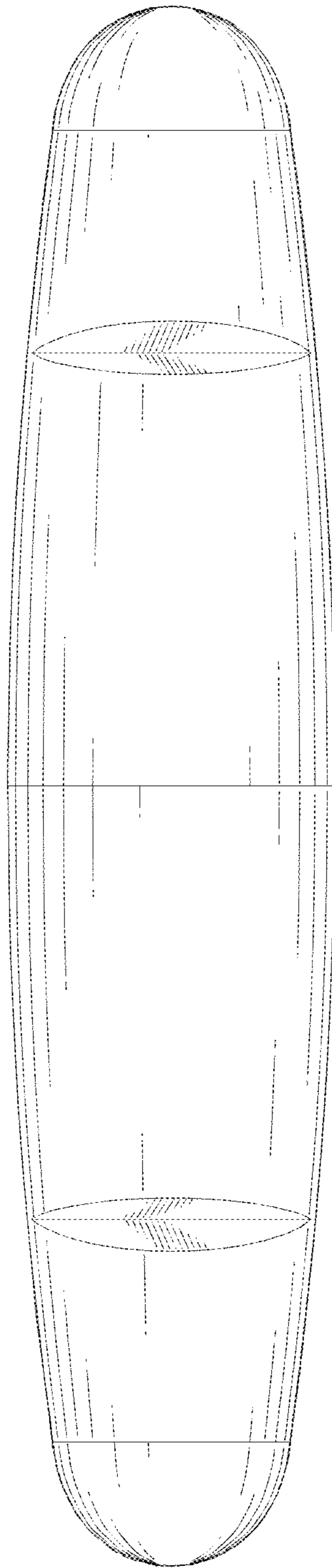

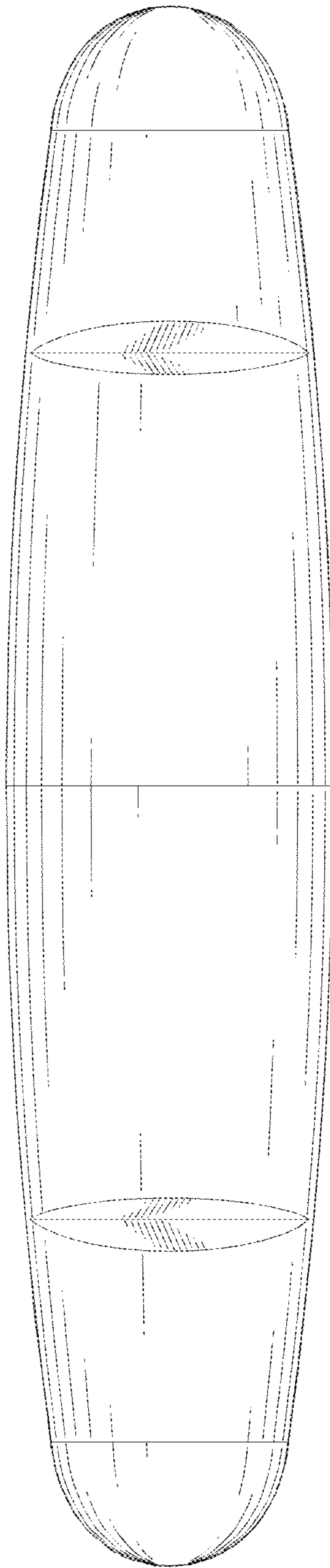

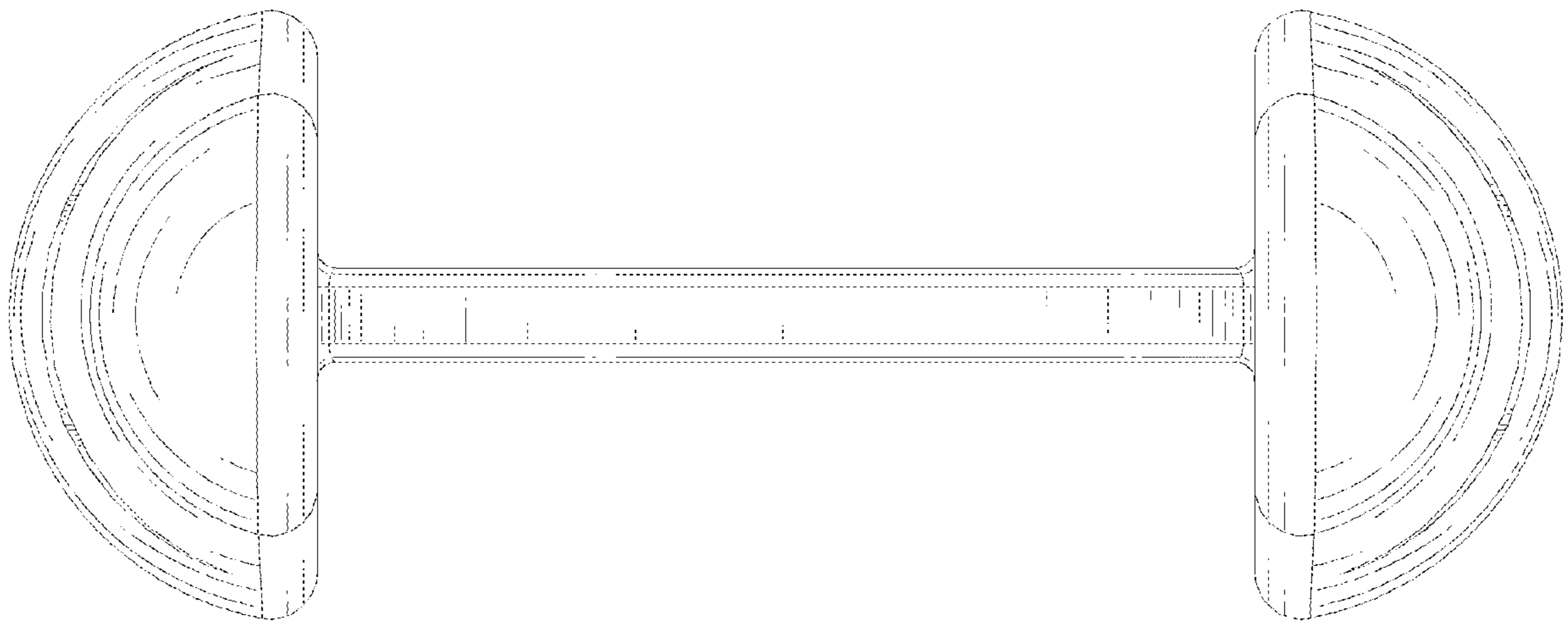

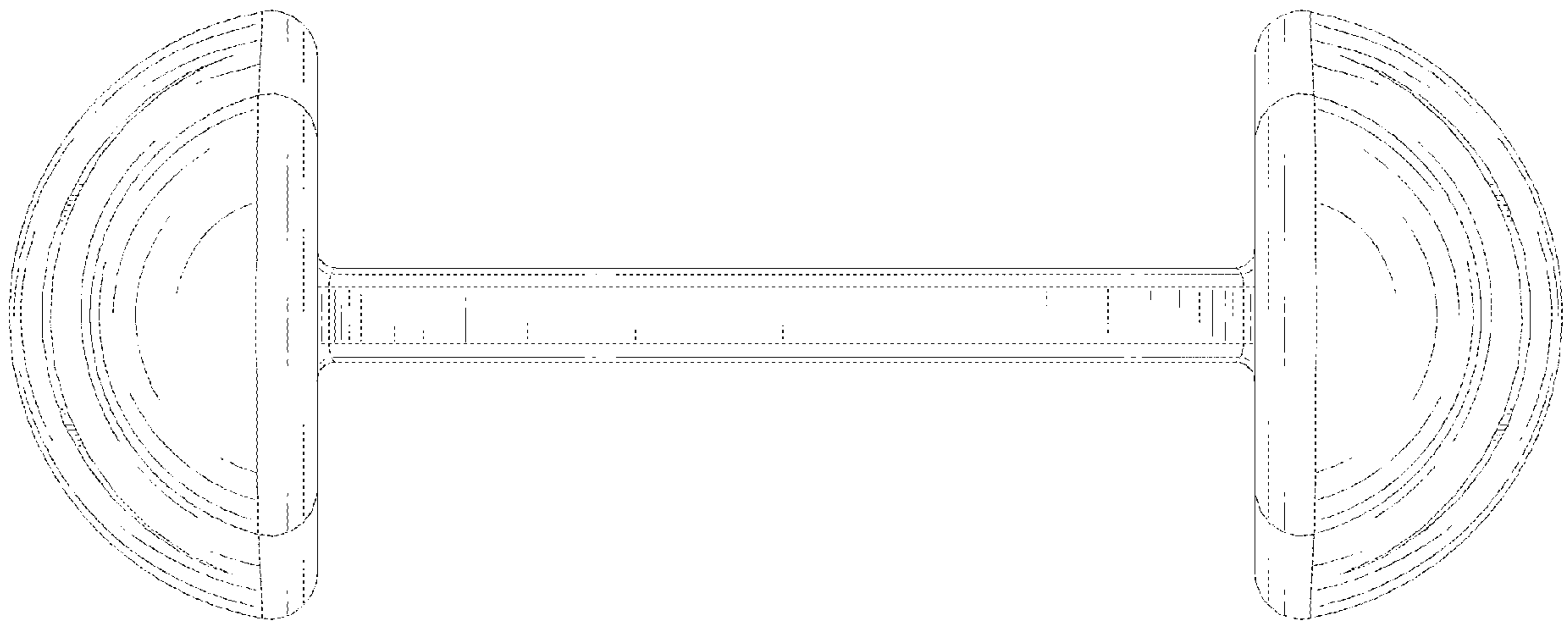

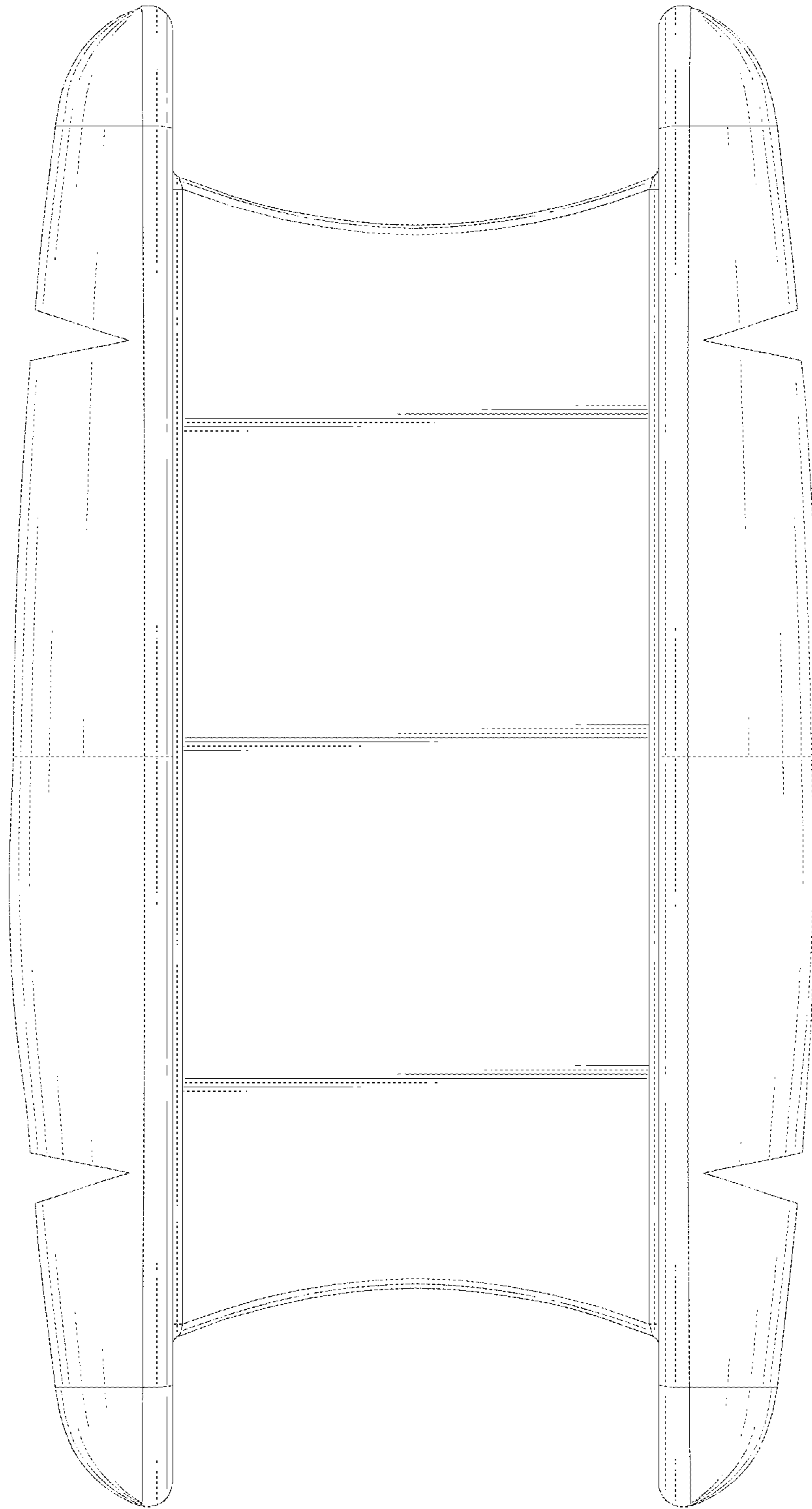

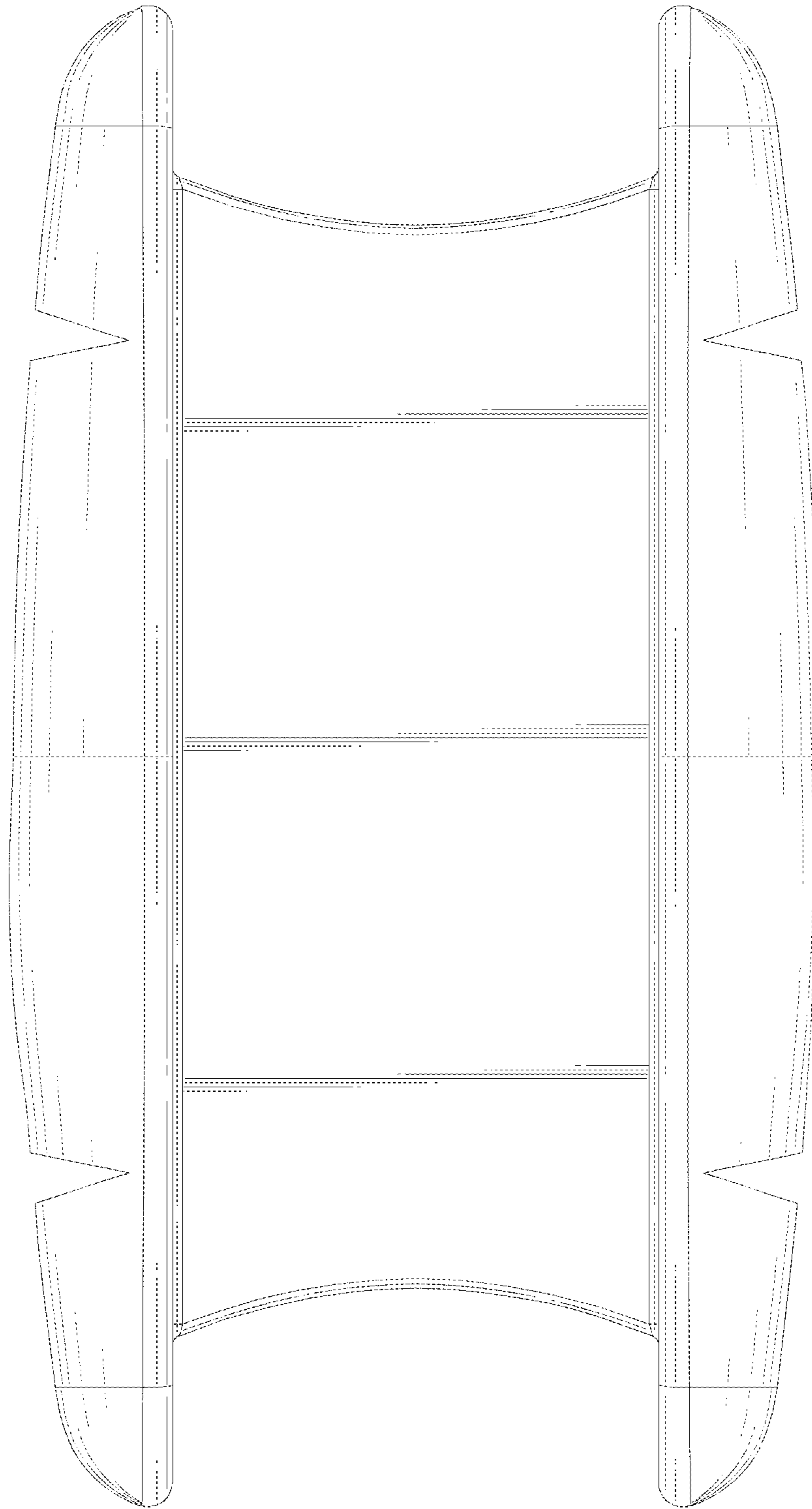
