(57) CLAIM

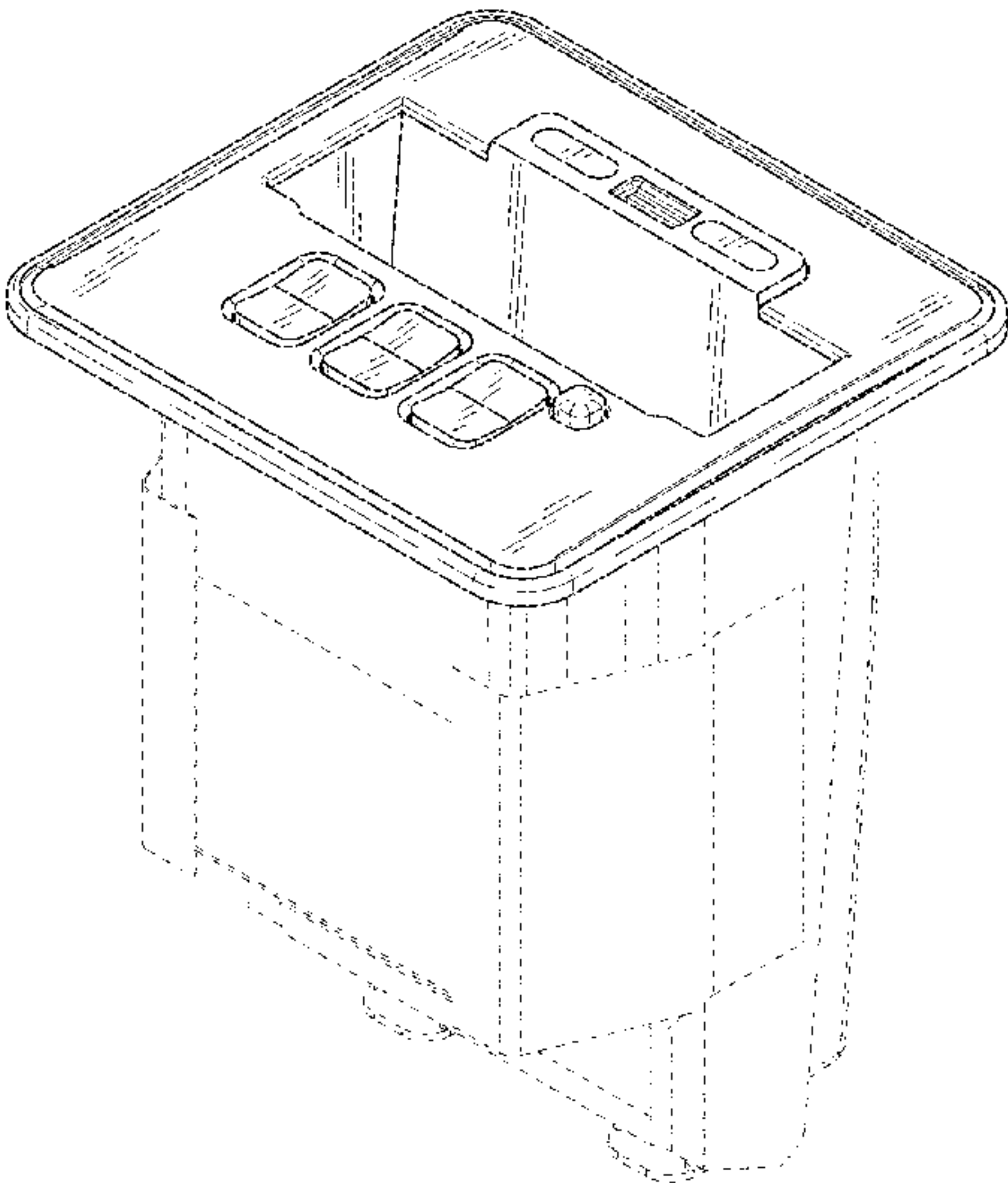
The ornamental design for a sanitizing device, as shown and described.

DESCRIPTION

FIG. 1 is a three-quarter top perspective view of a sanitizing device;
FIG. 2 is a one-half top perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is a rear elevational cross section view along axis 9 shown in FIG. 7.

The broken lines in the figures are for the purpose of illustrating portions of the sanitizing device, which form no part of the claimed design. The dash-dot broken lines in the figures define the boundary of the claimed design and form no part thereof.

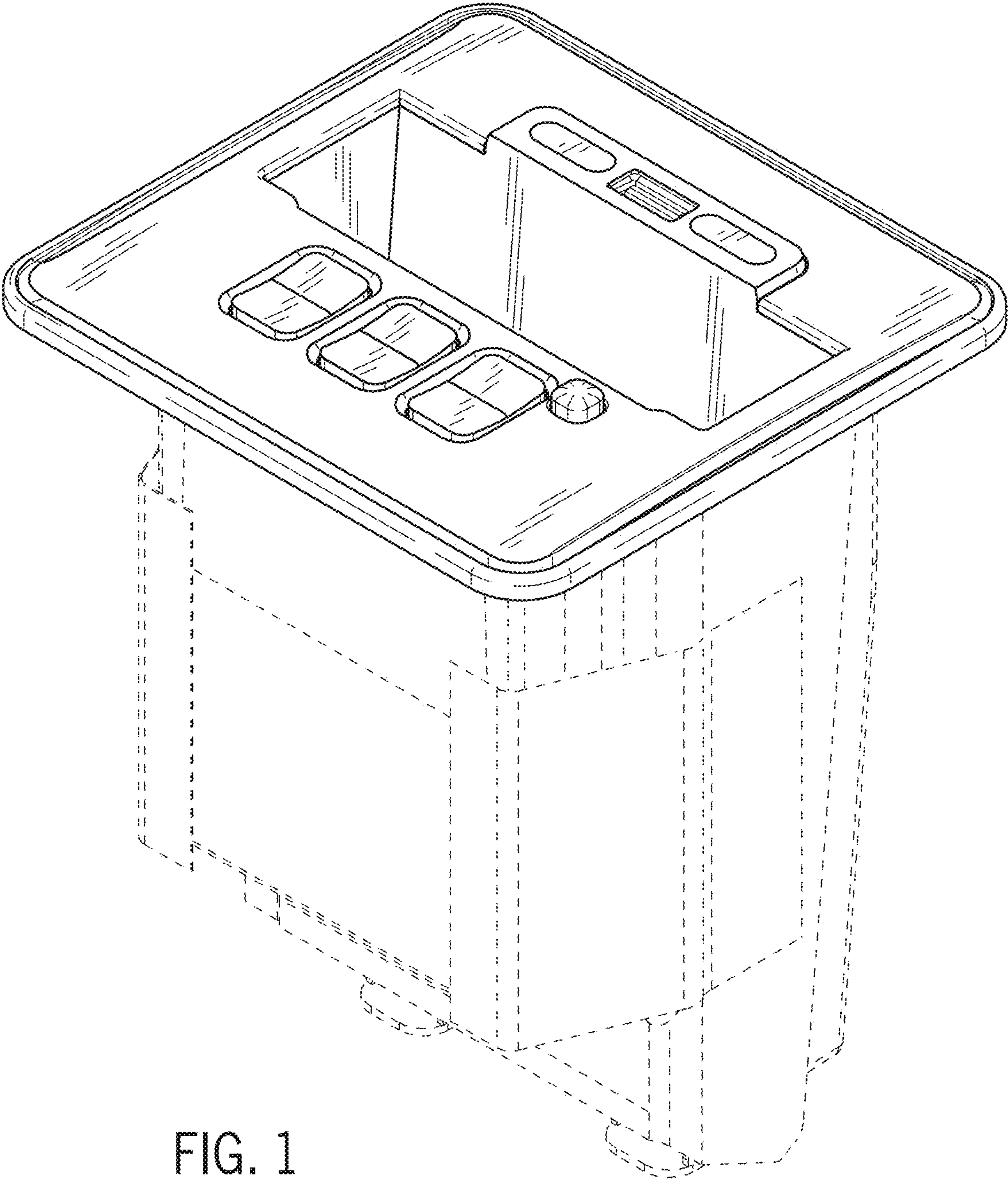

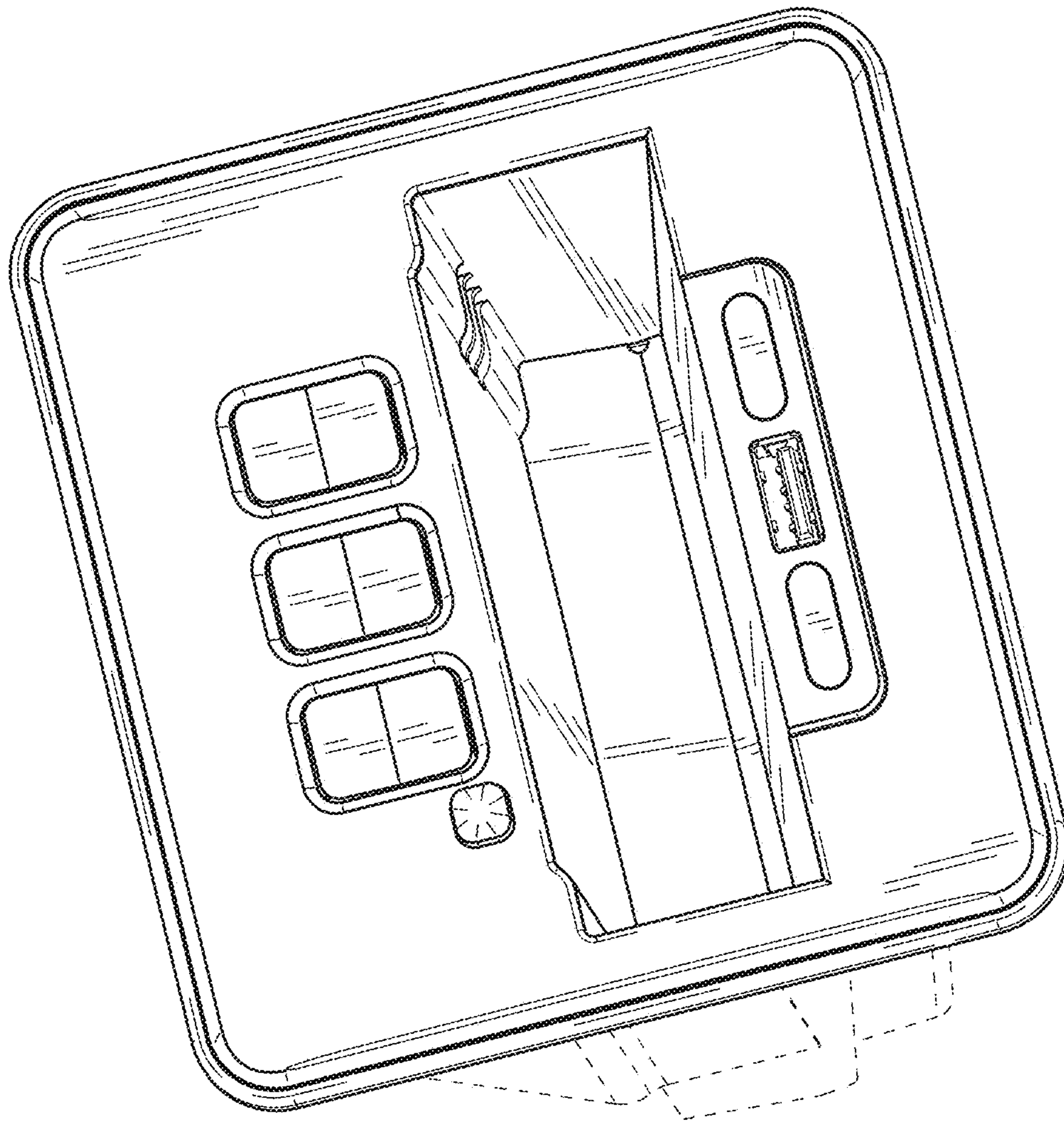

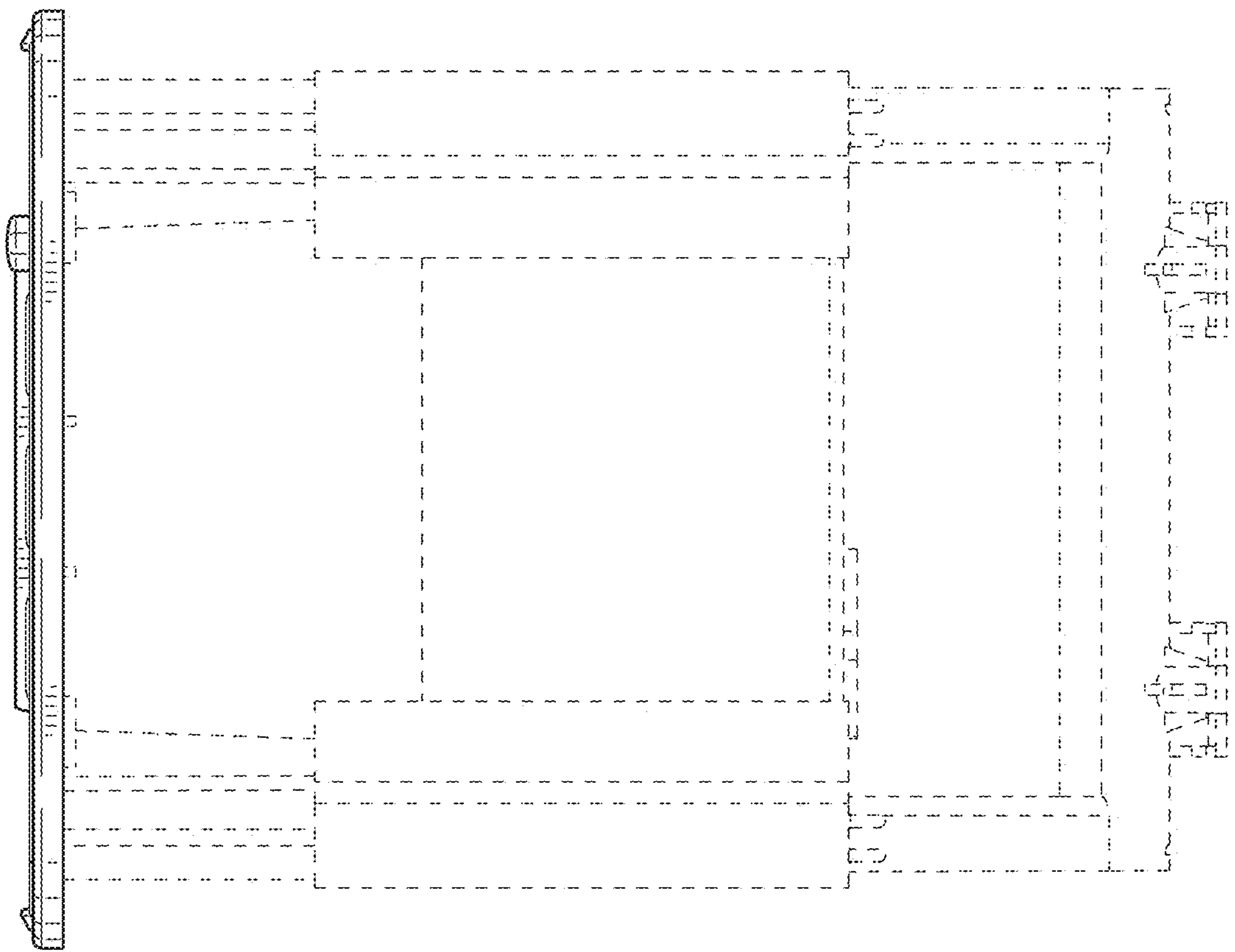

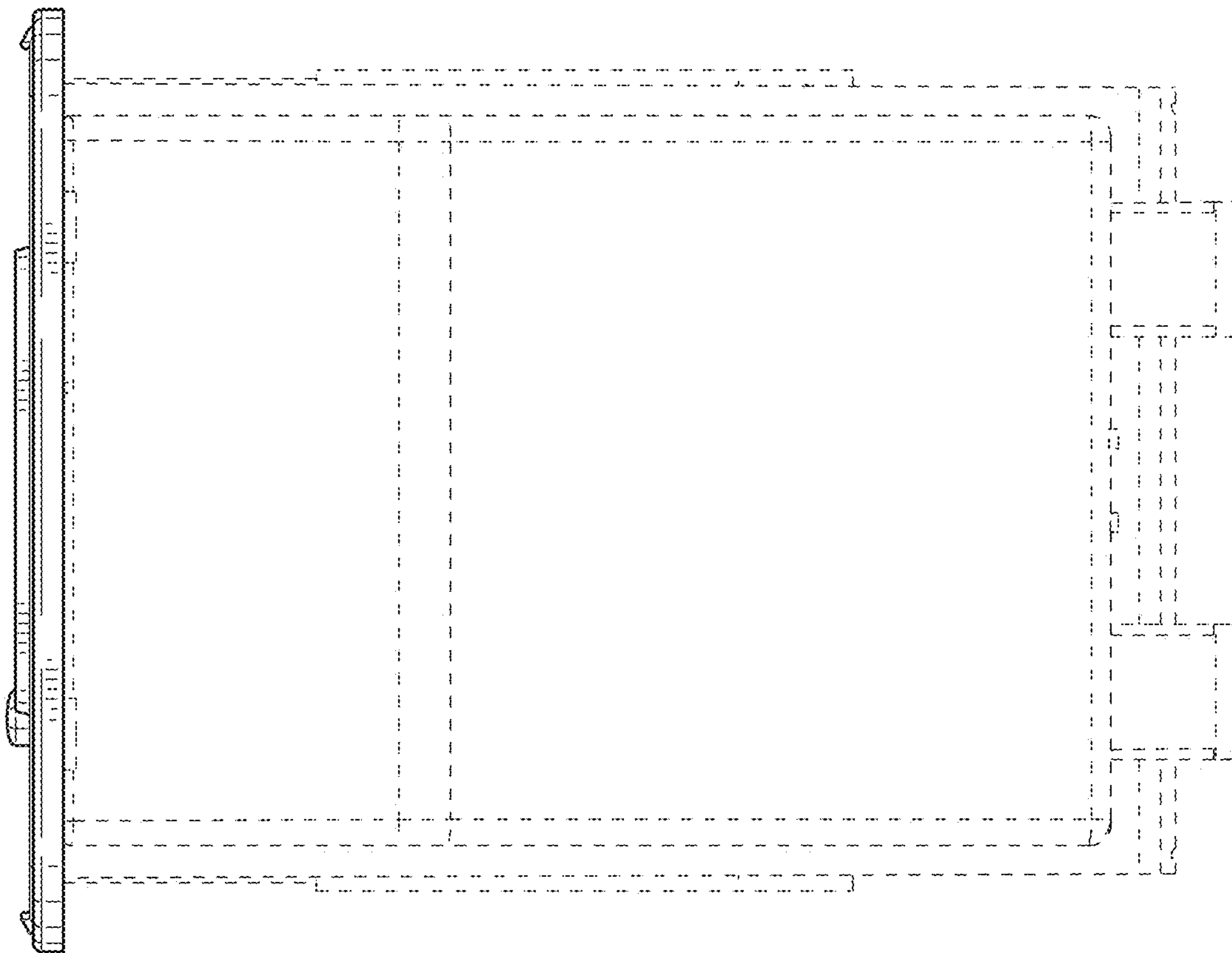

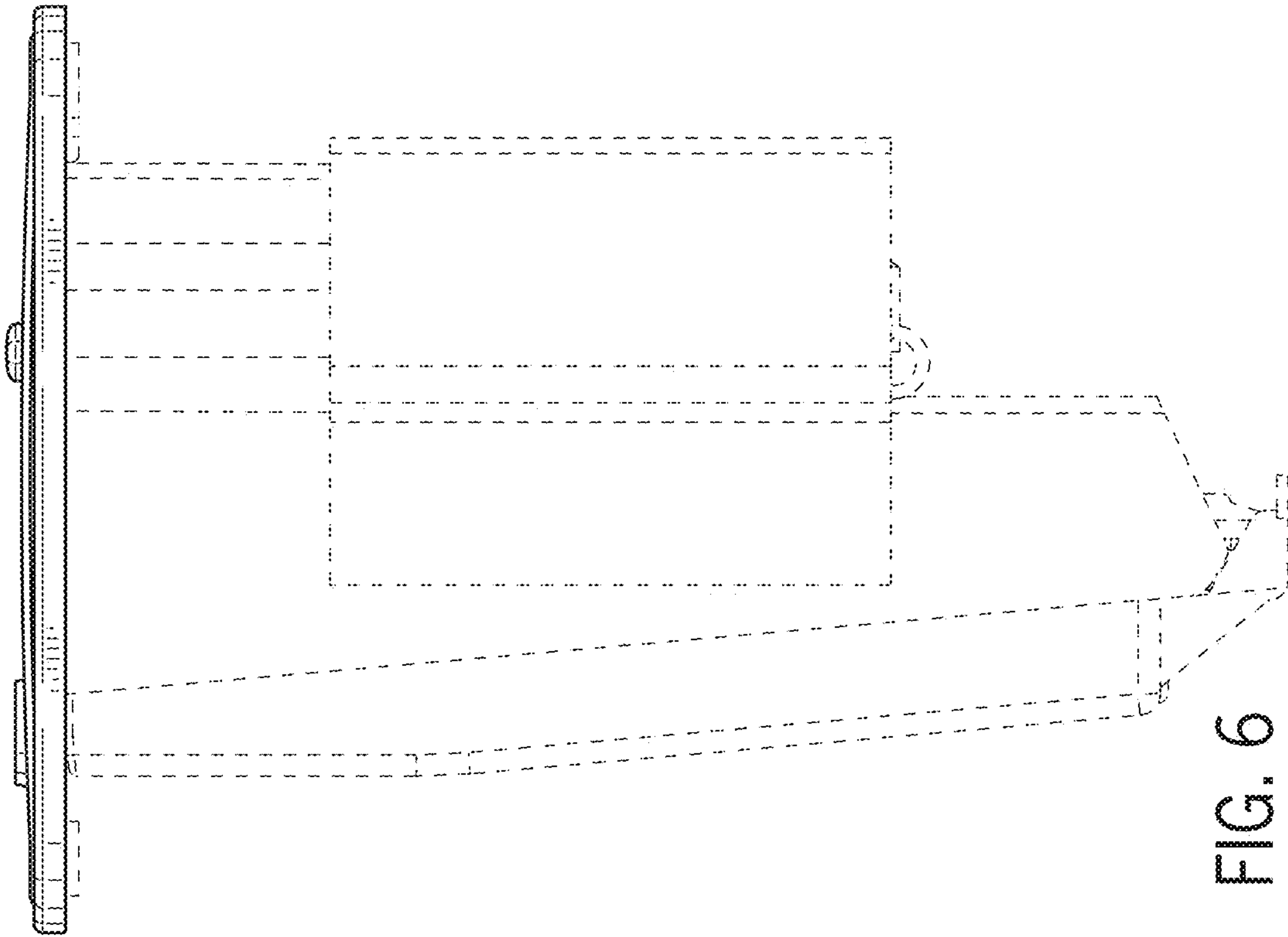

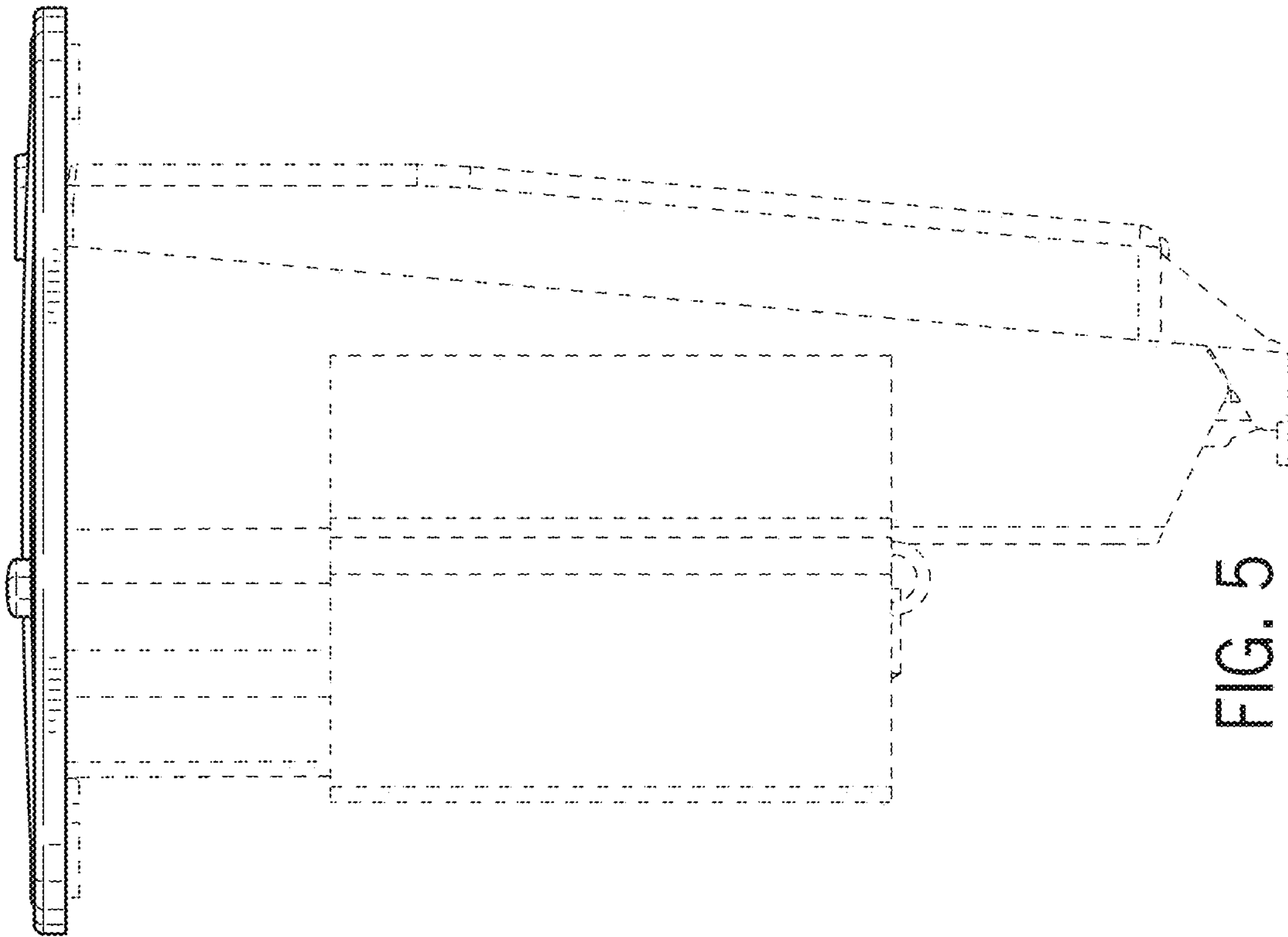

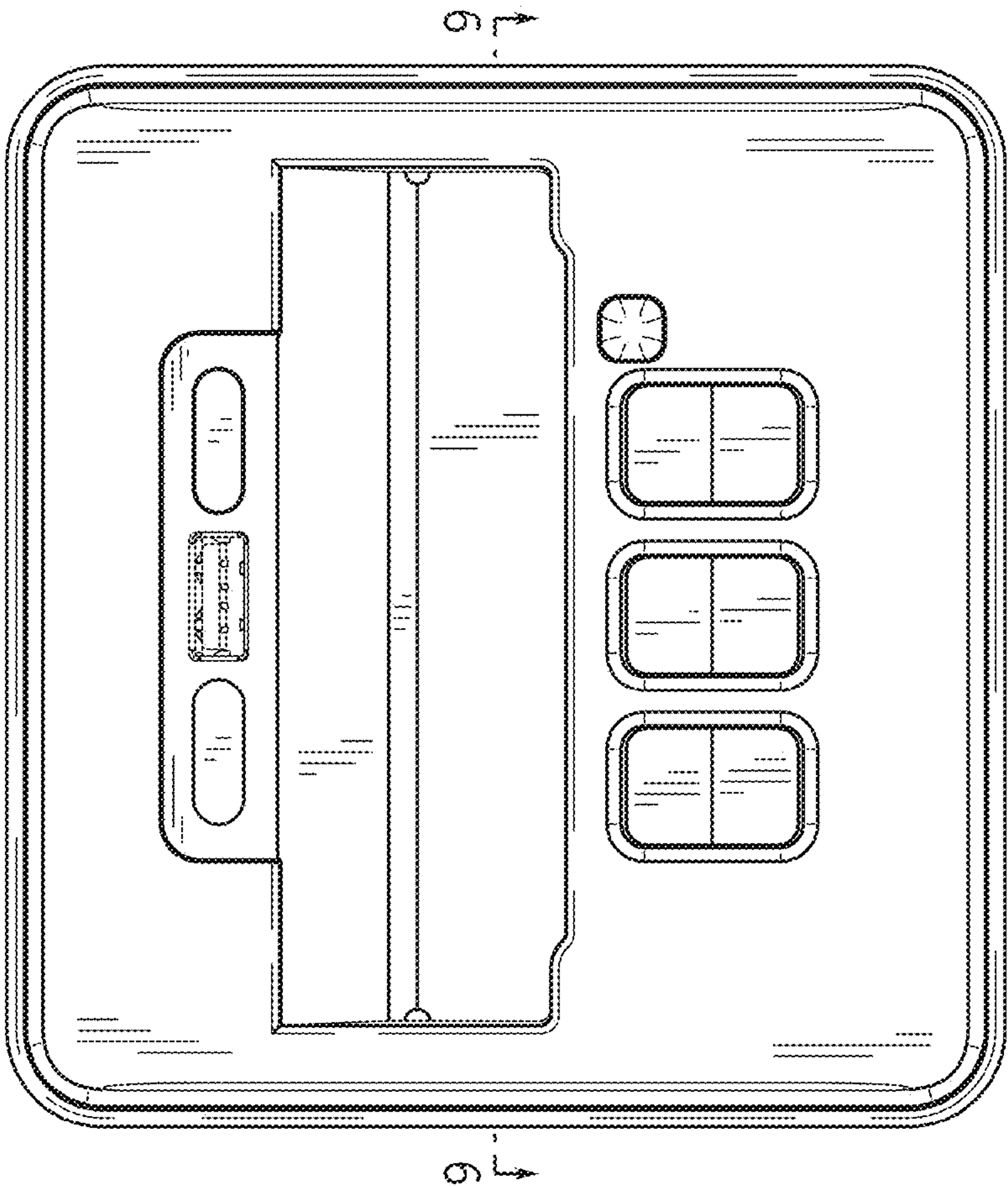

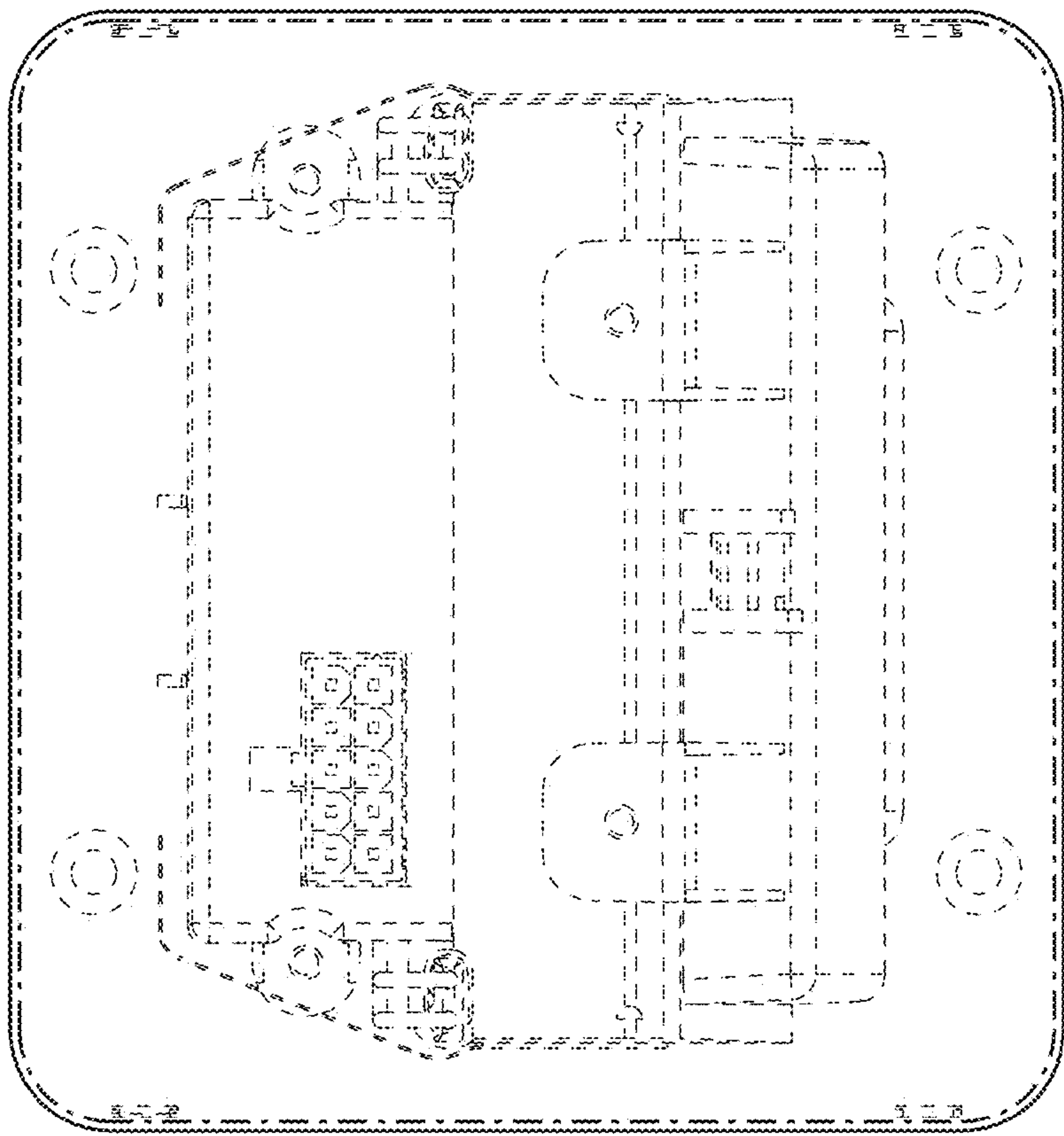

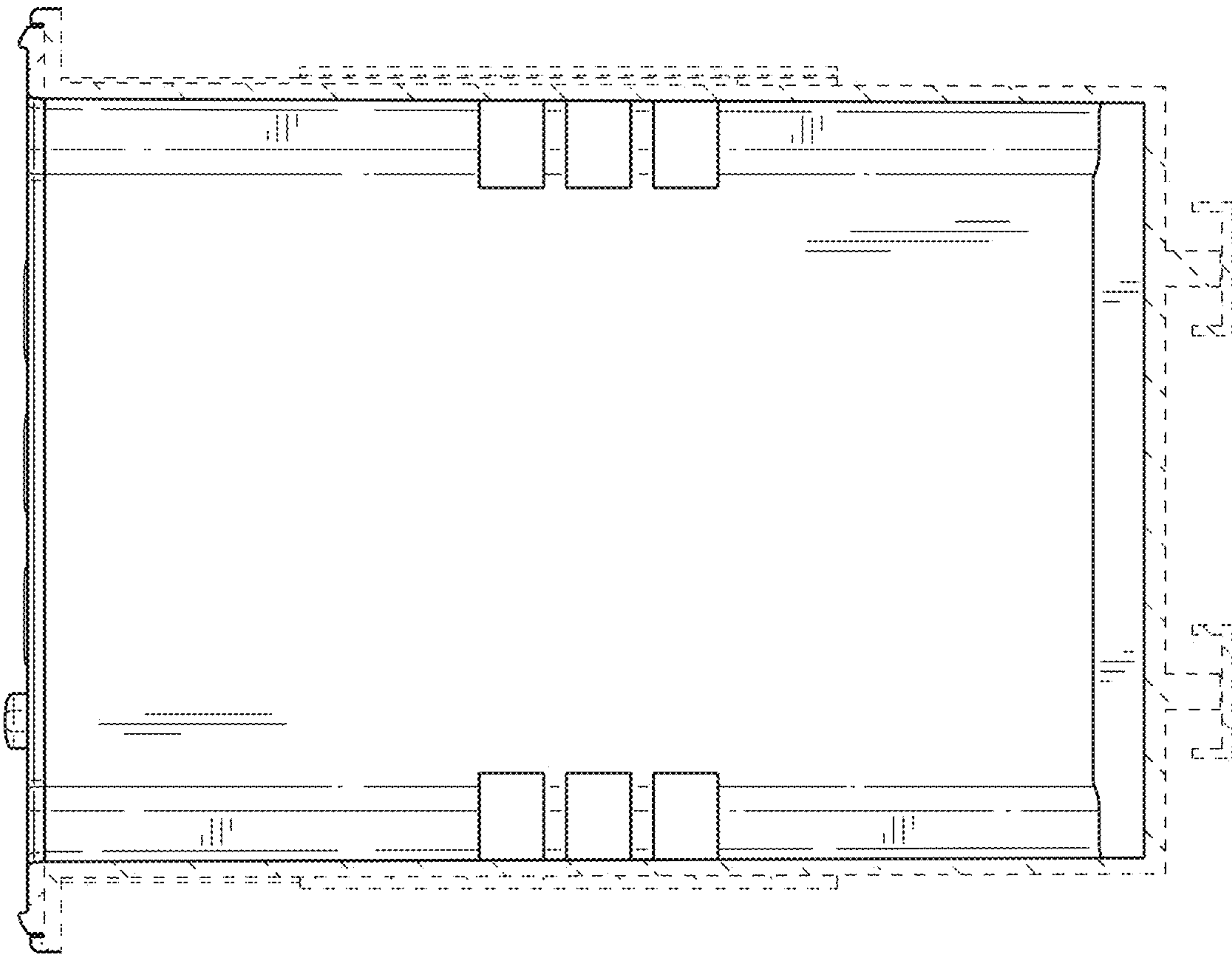
