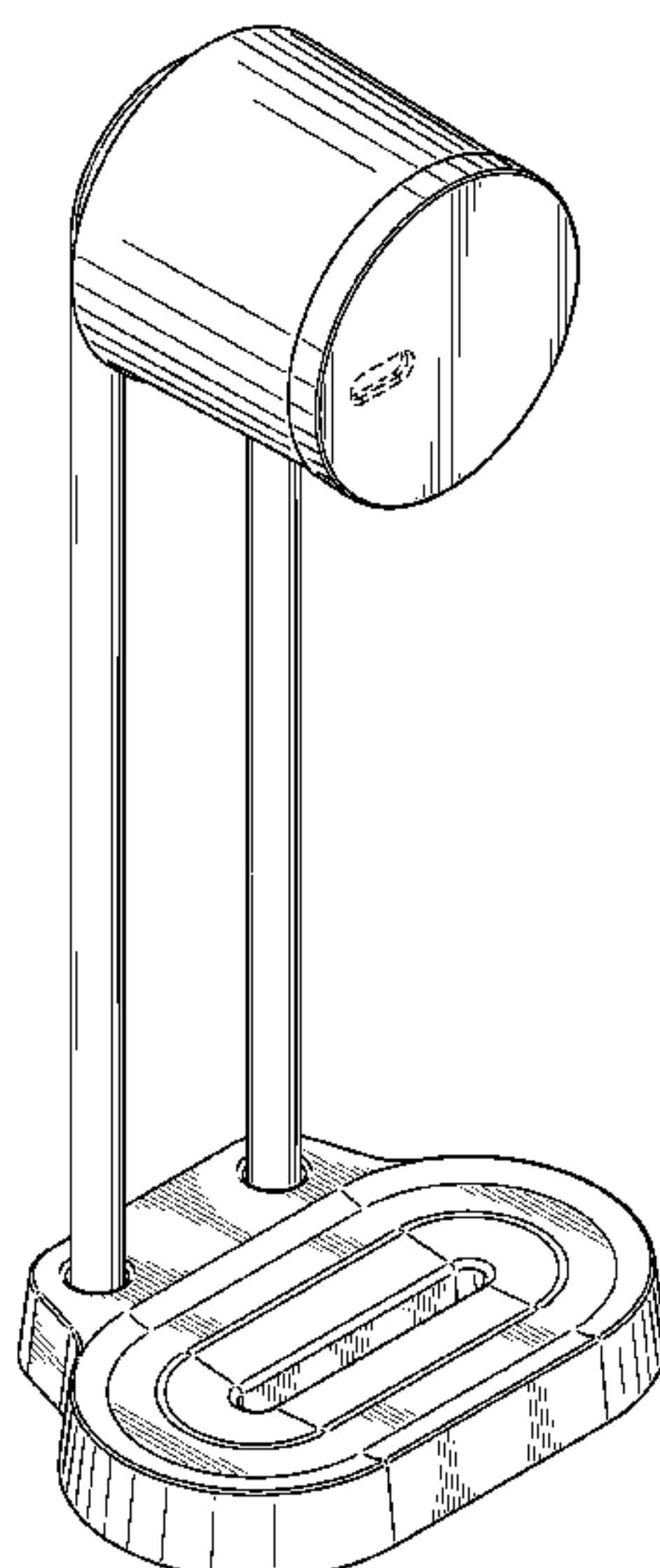
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front left top isometric view of a paper holder showing my new design;  
FIG. 2 is a rear left top isometric view thereof;

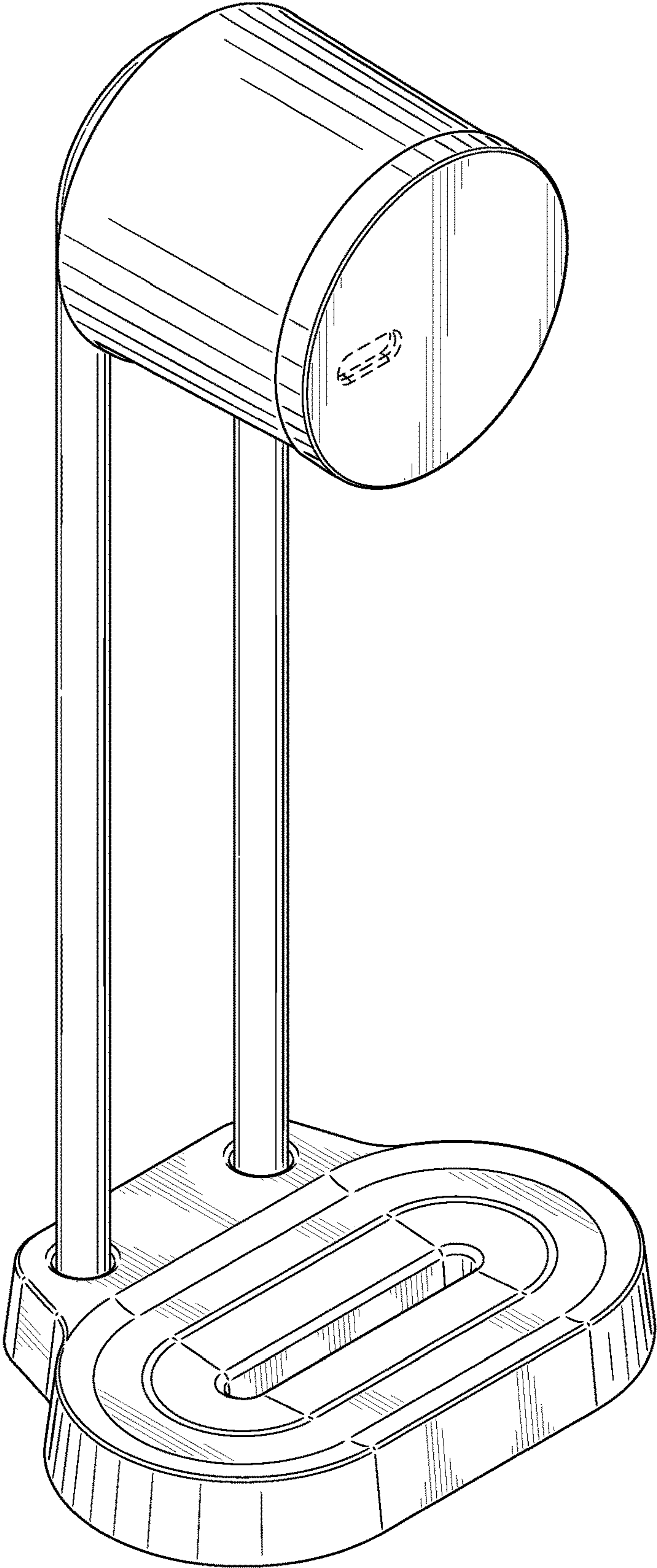

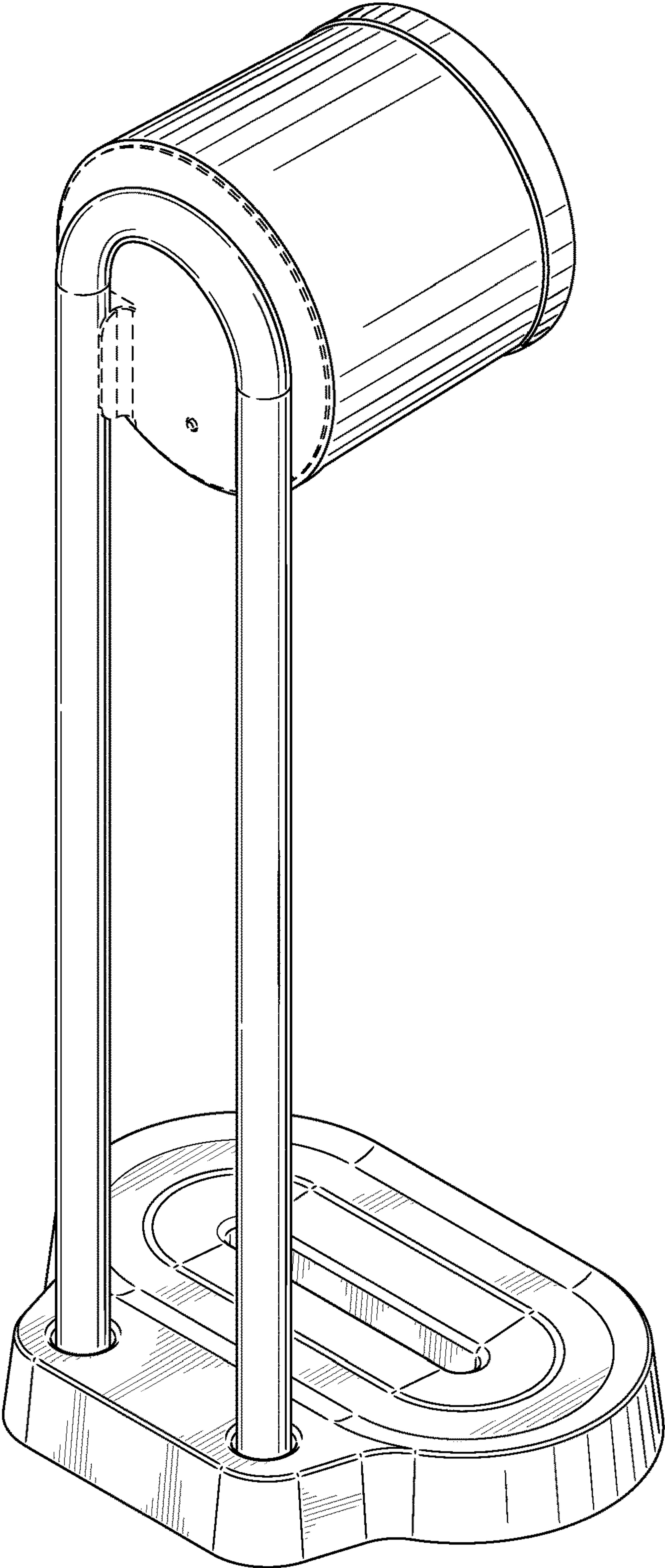

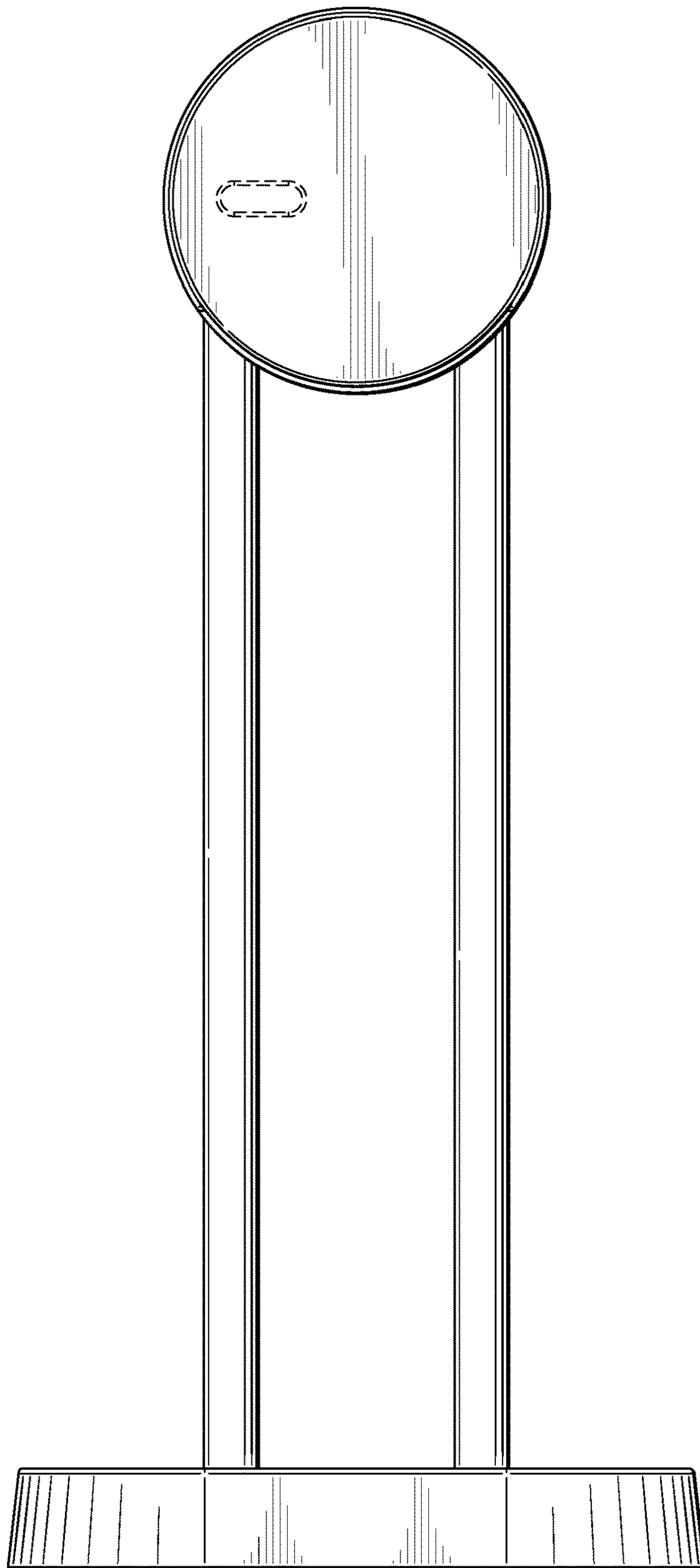

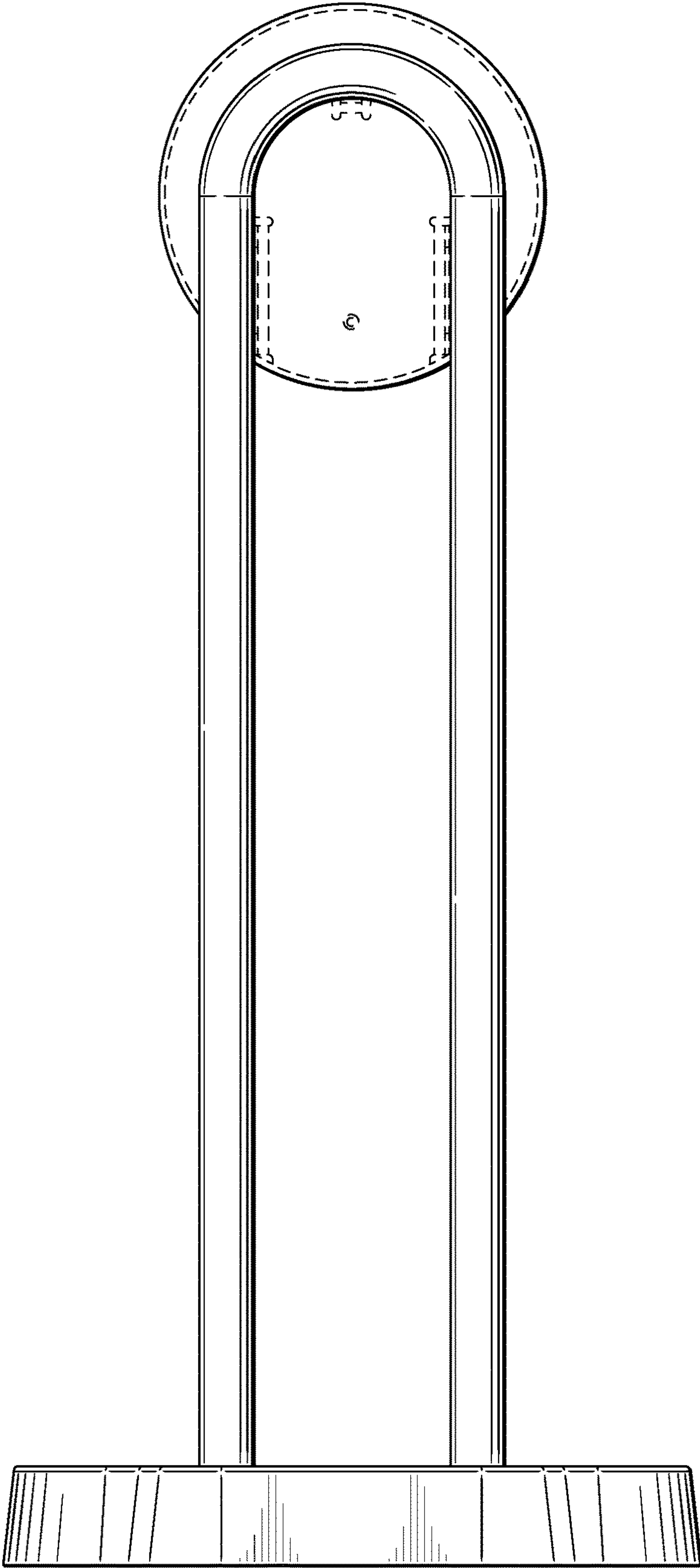

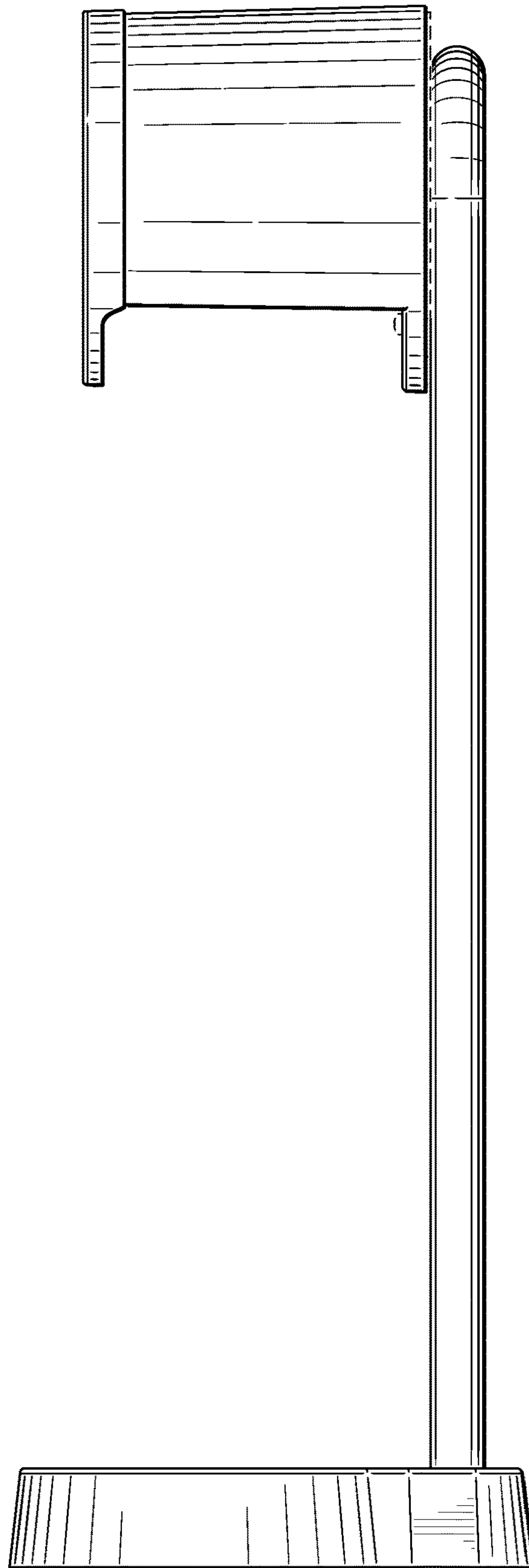

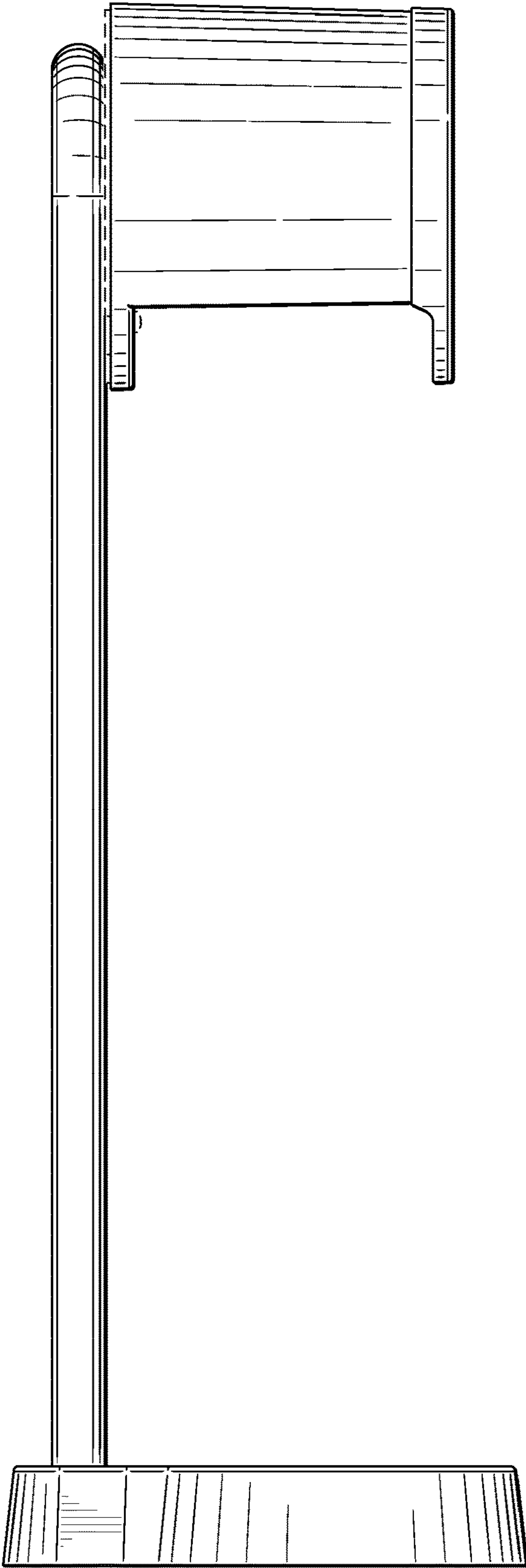

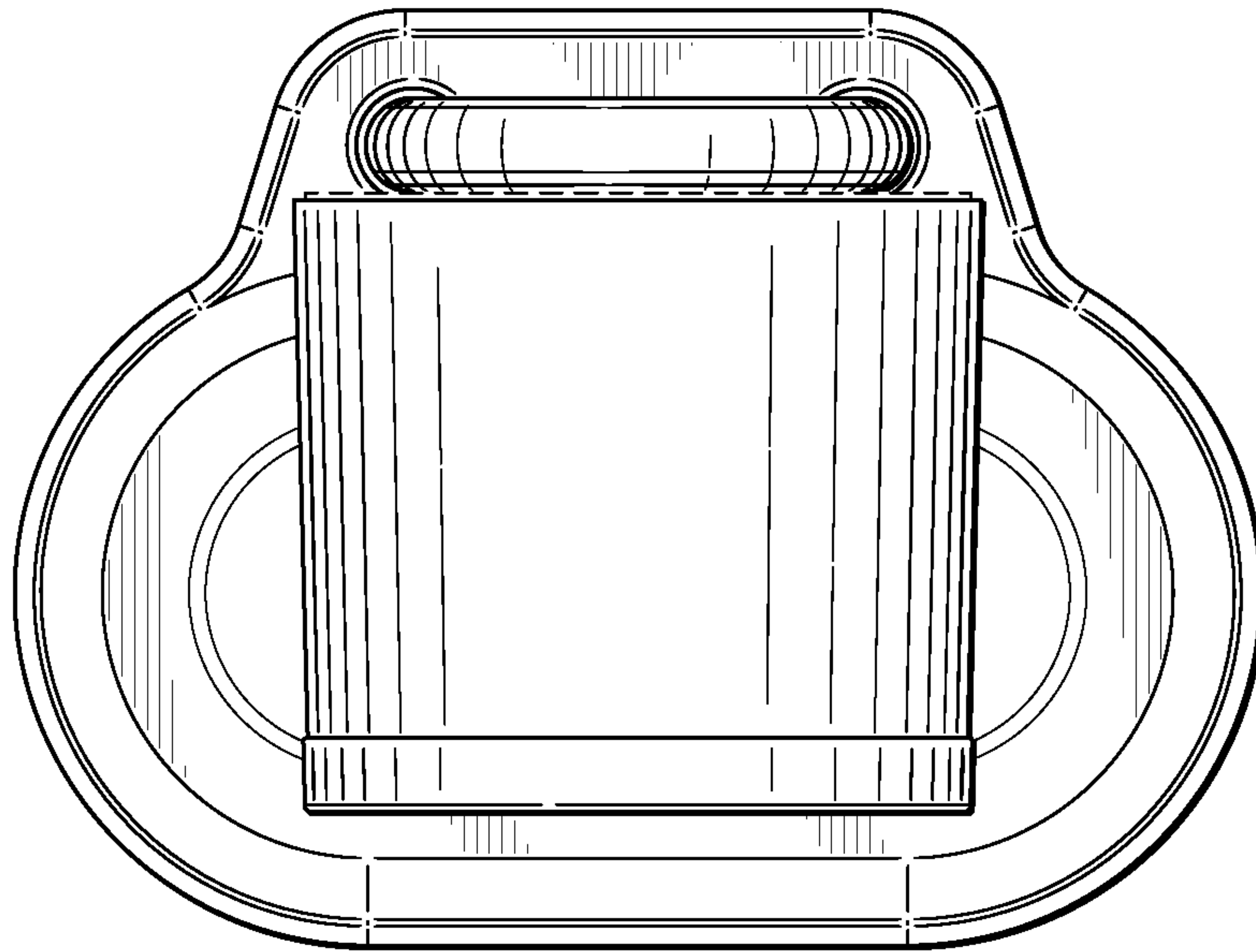

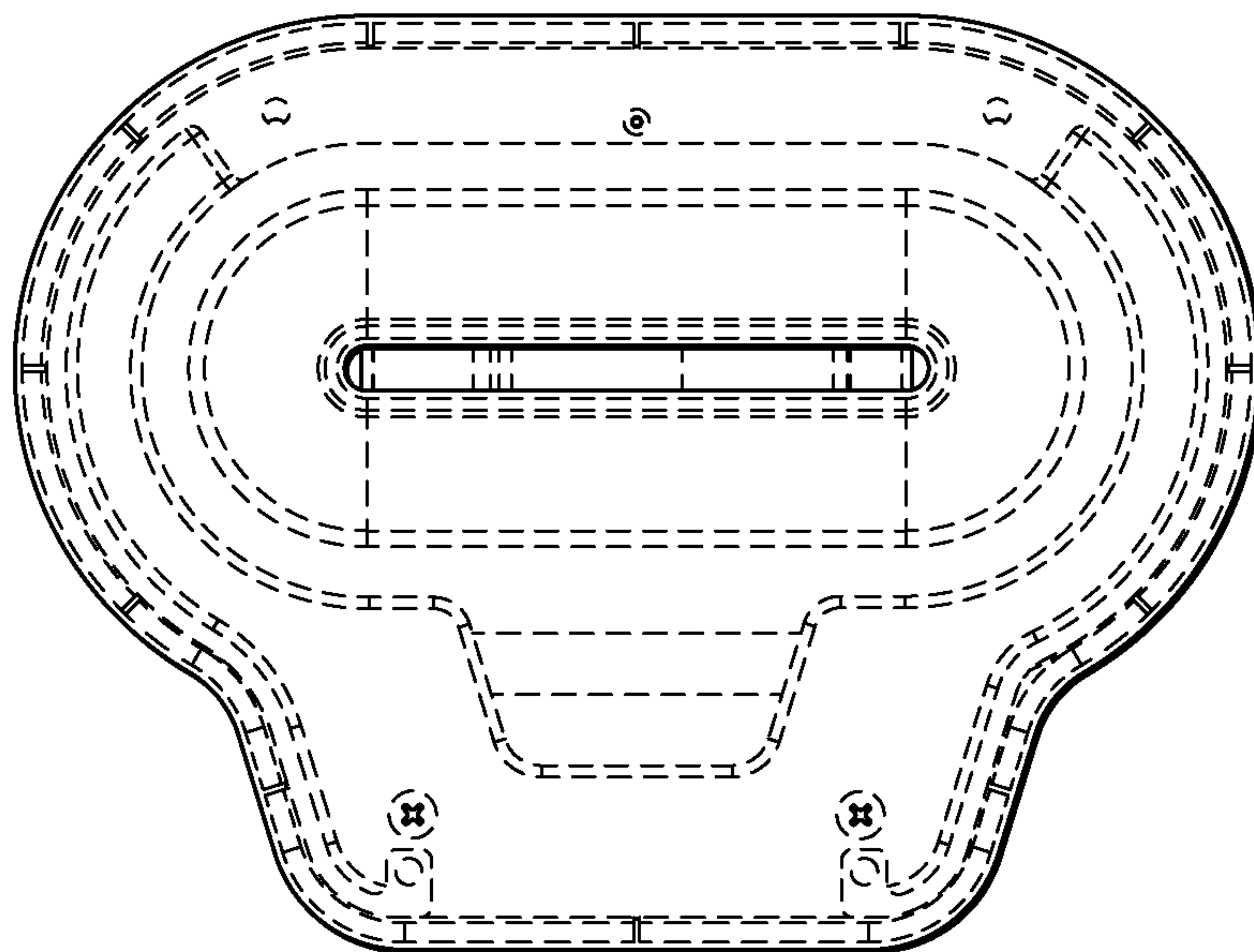
