FIG. 11 shows a left side view of the thermometer.

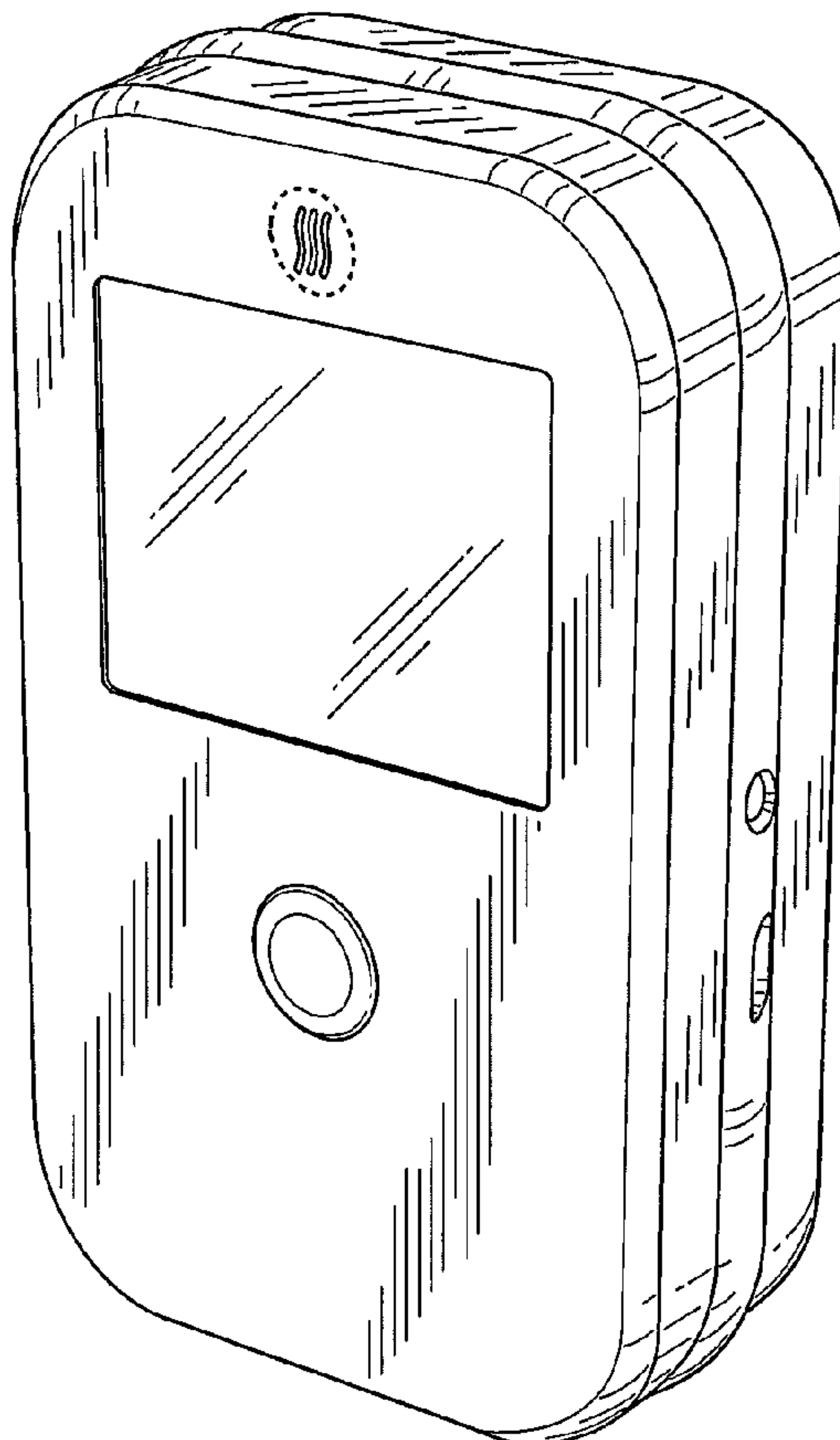
FIG. 12 shows a right side view of the thermometer.

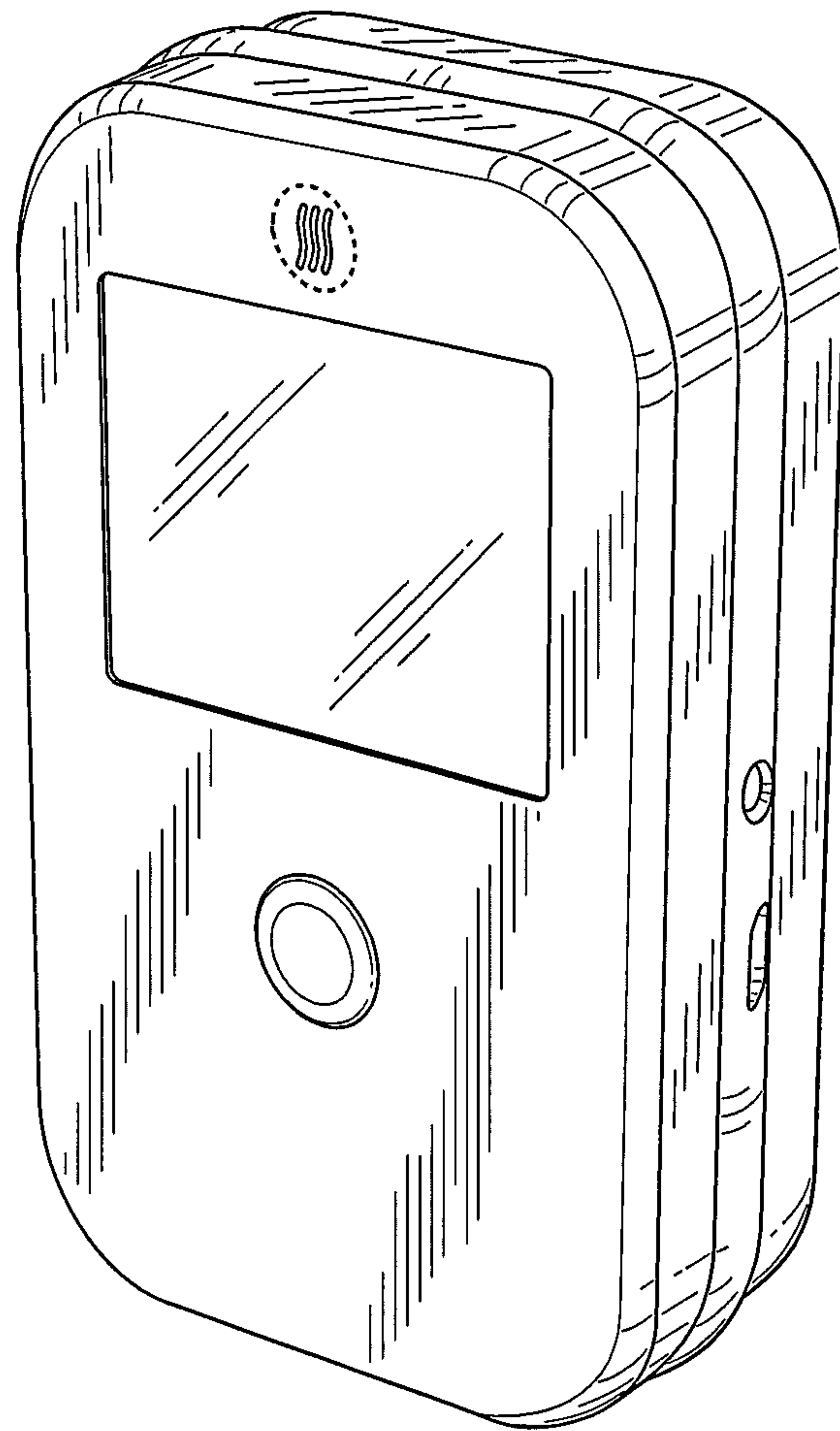

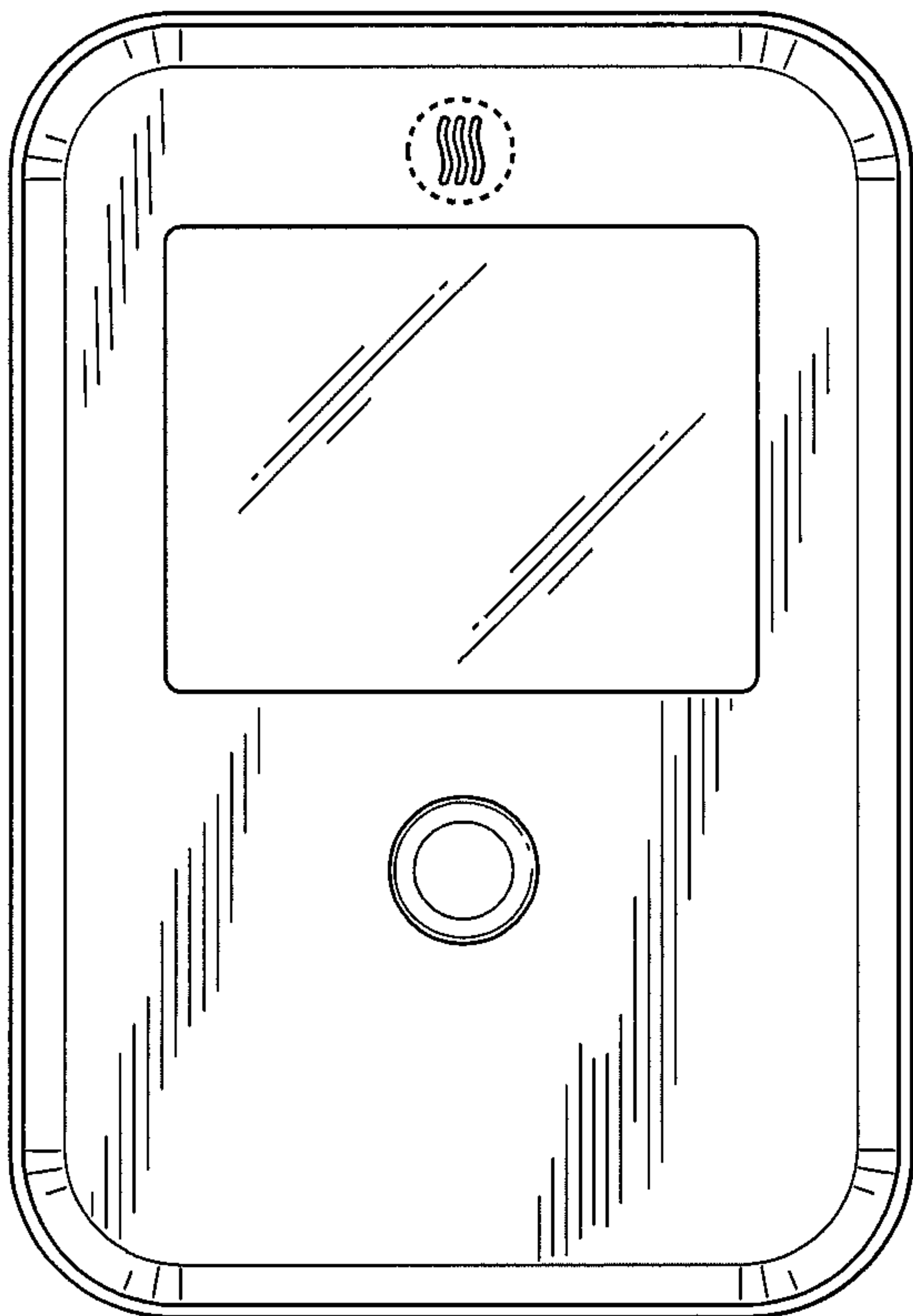

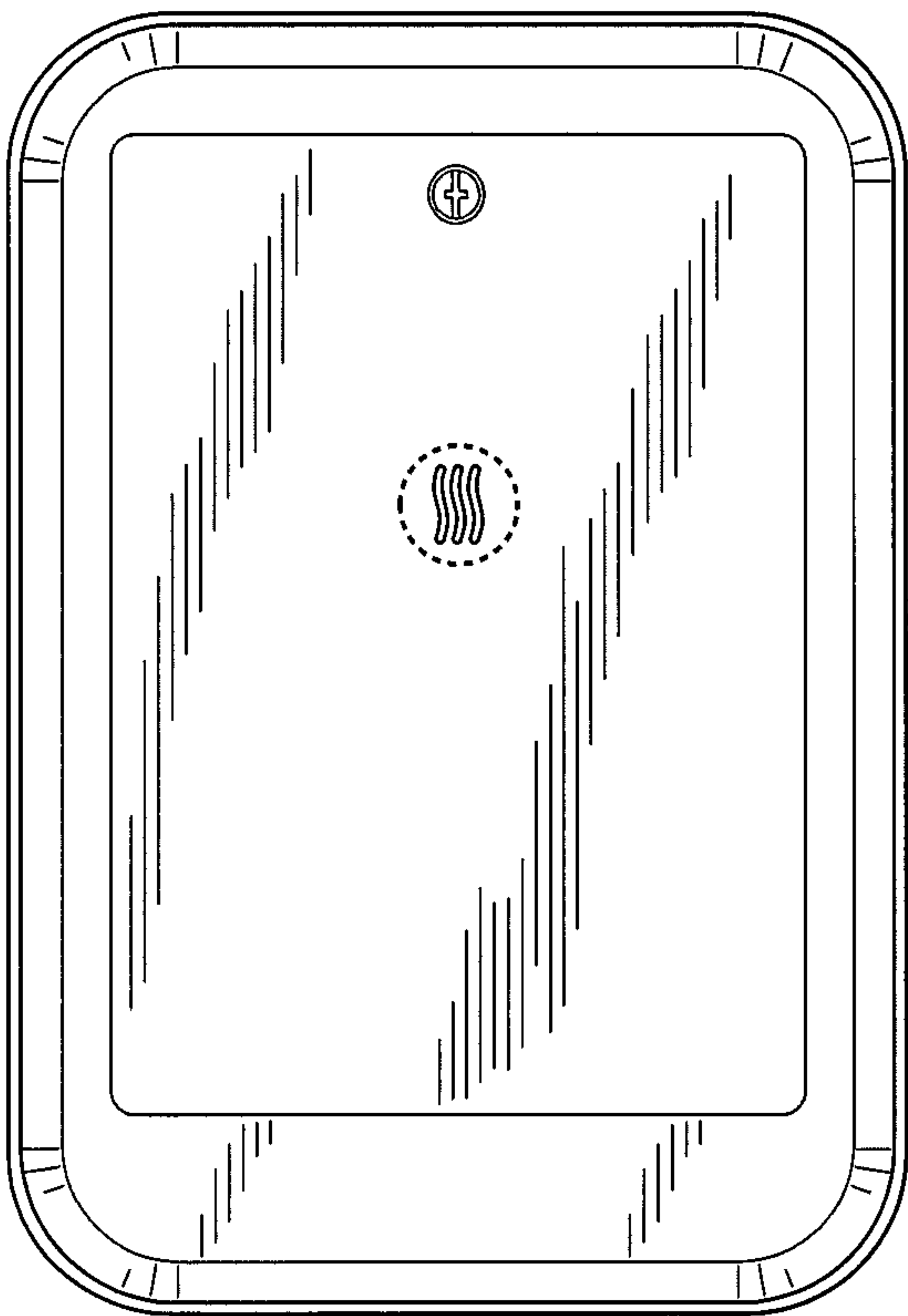

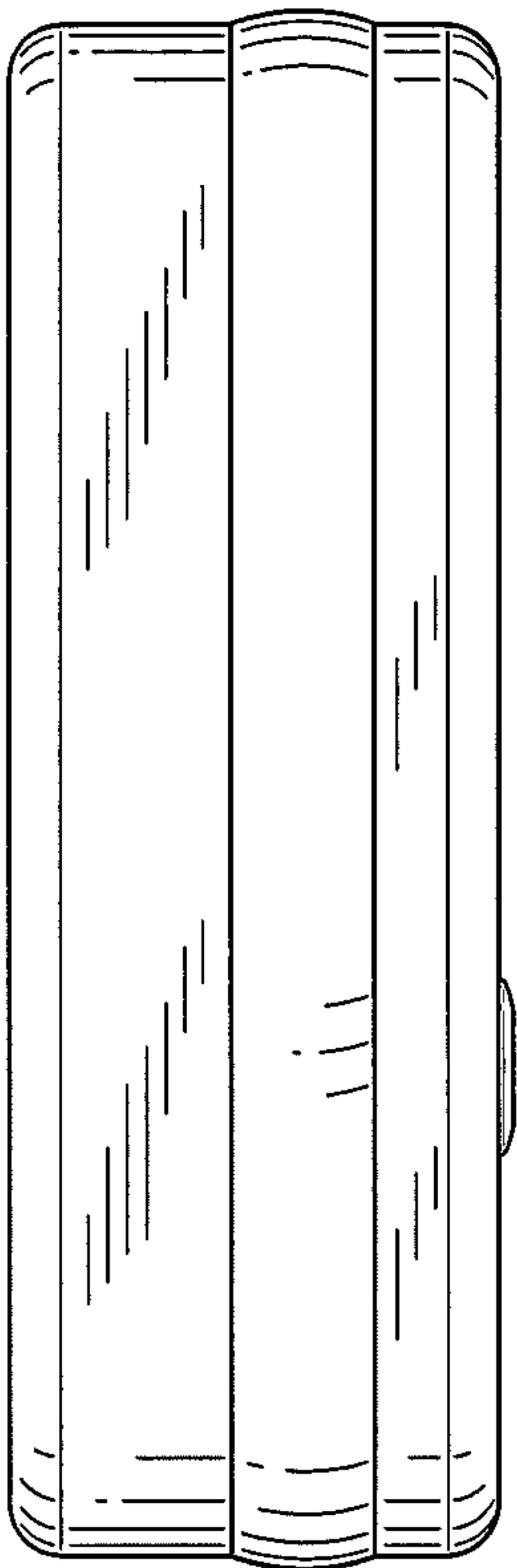

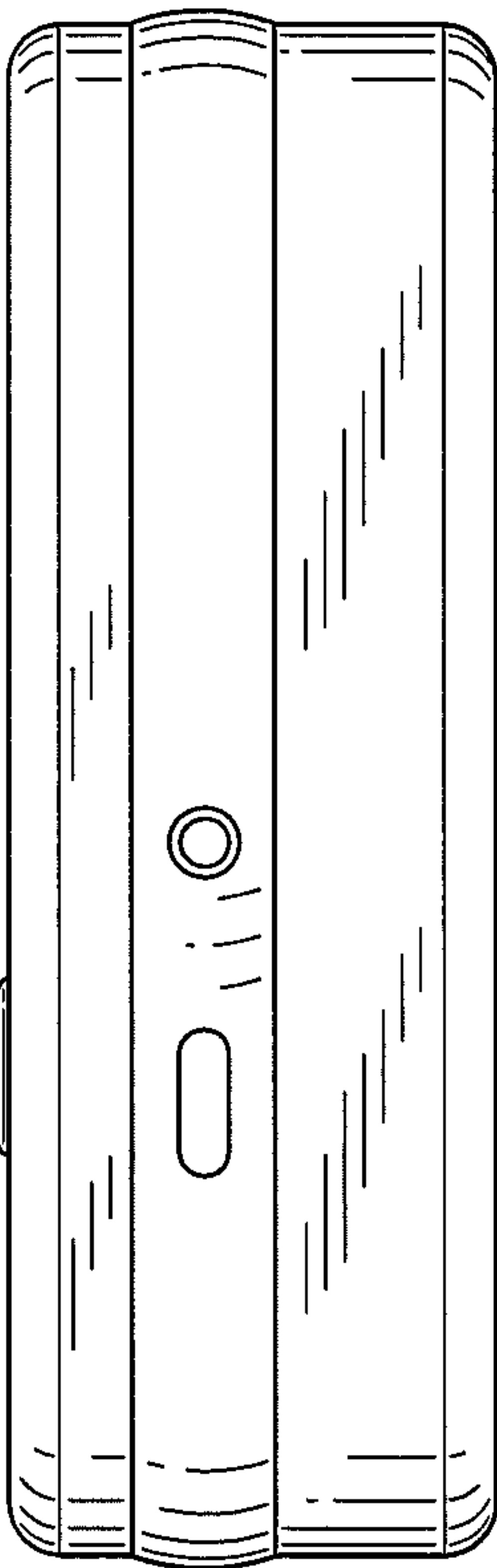

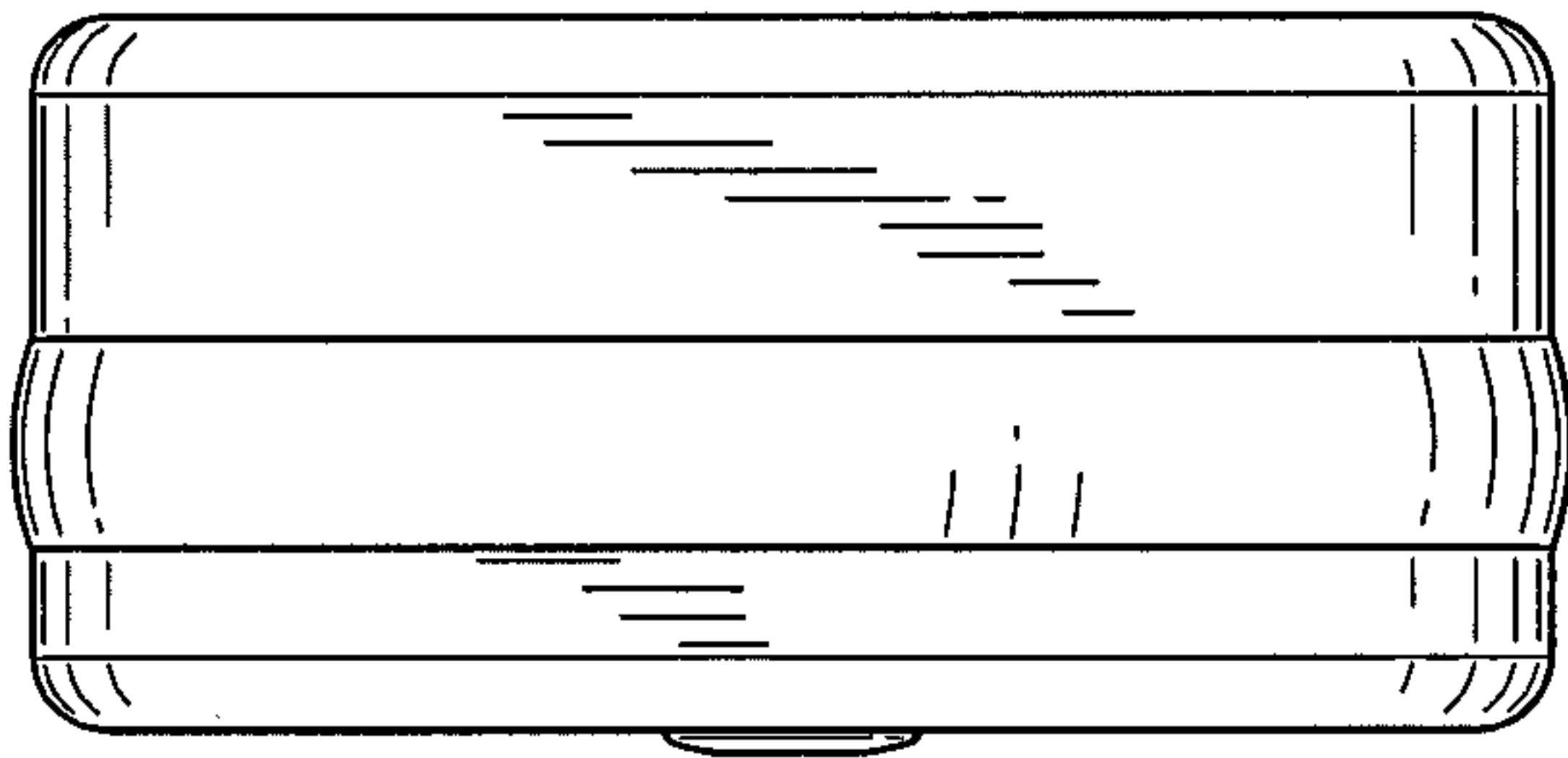

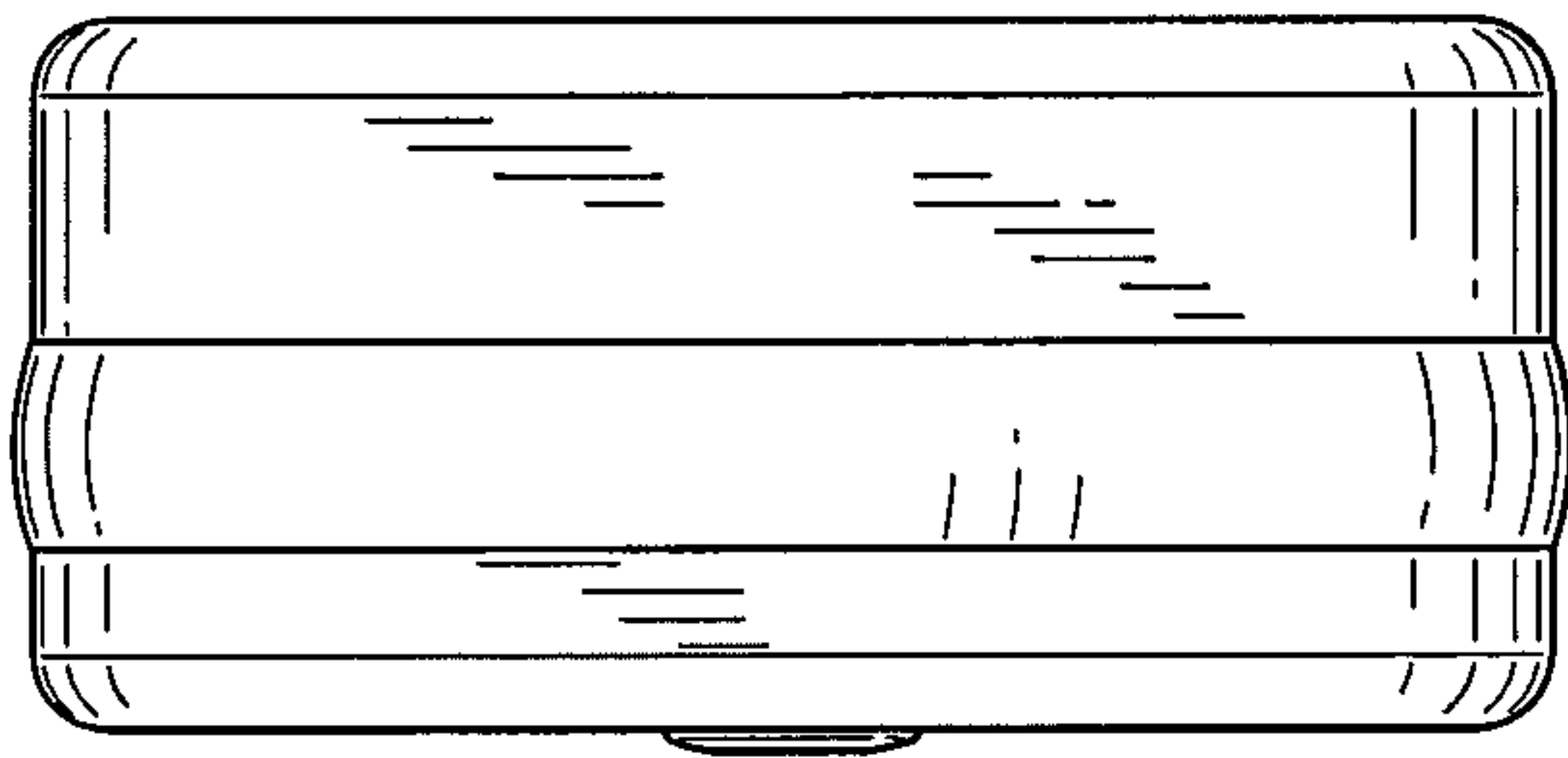

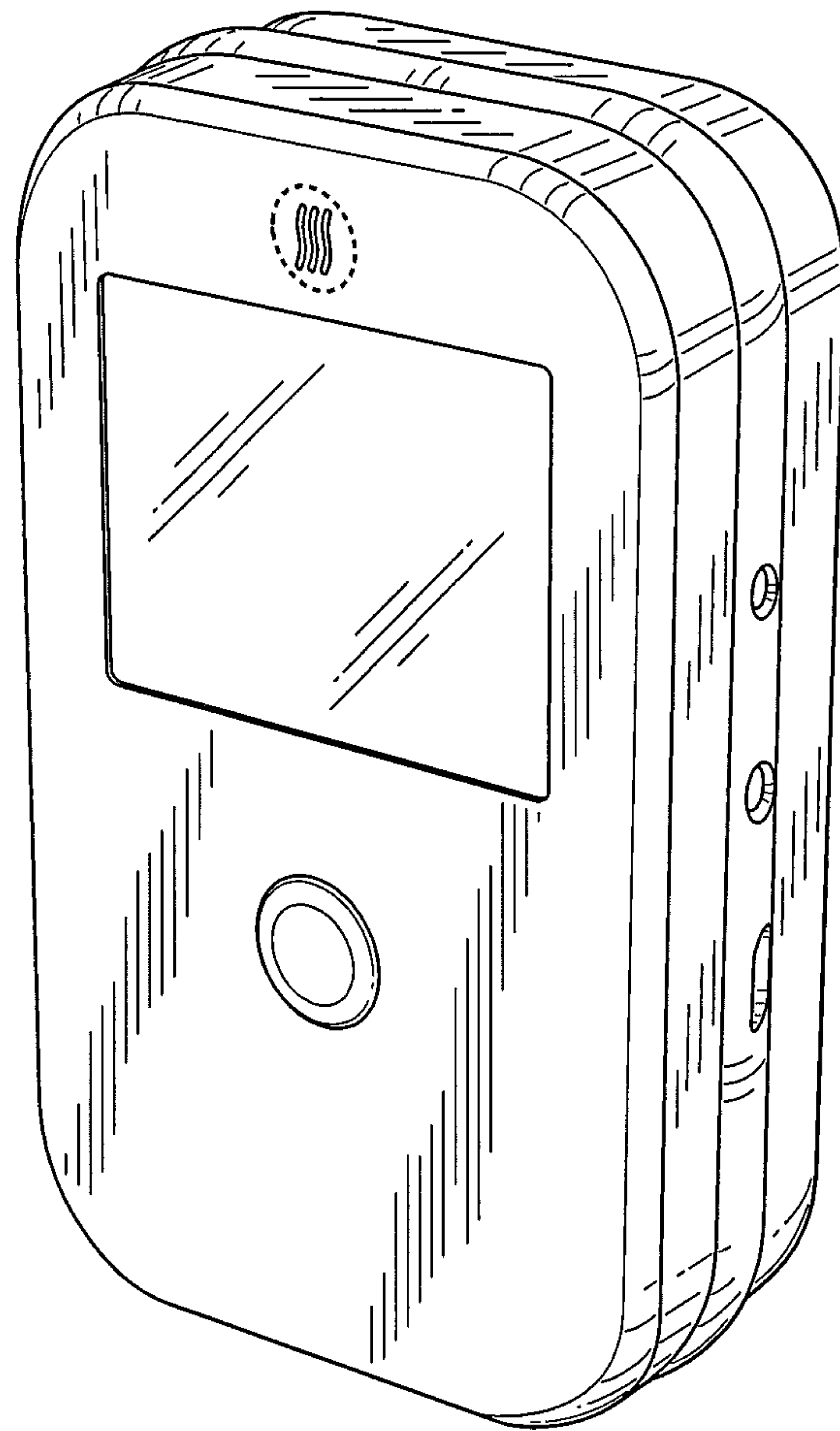

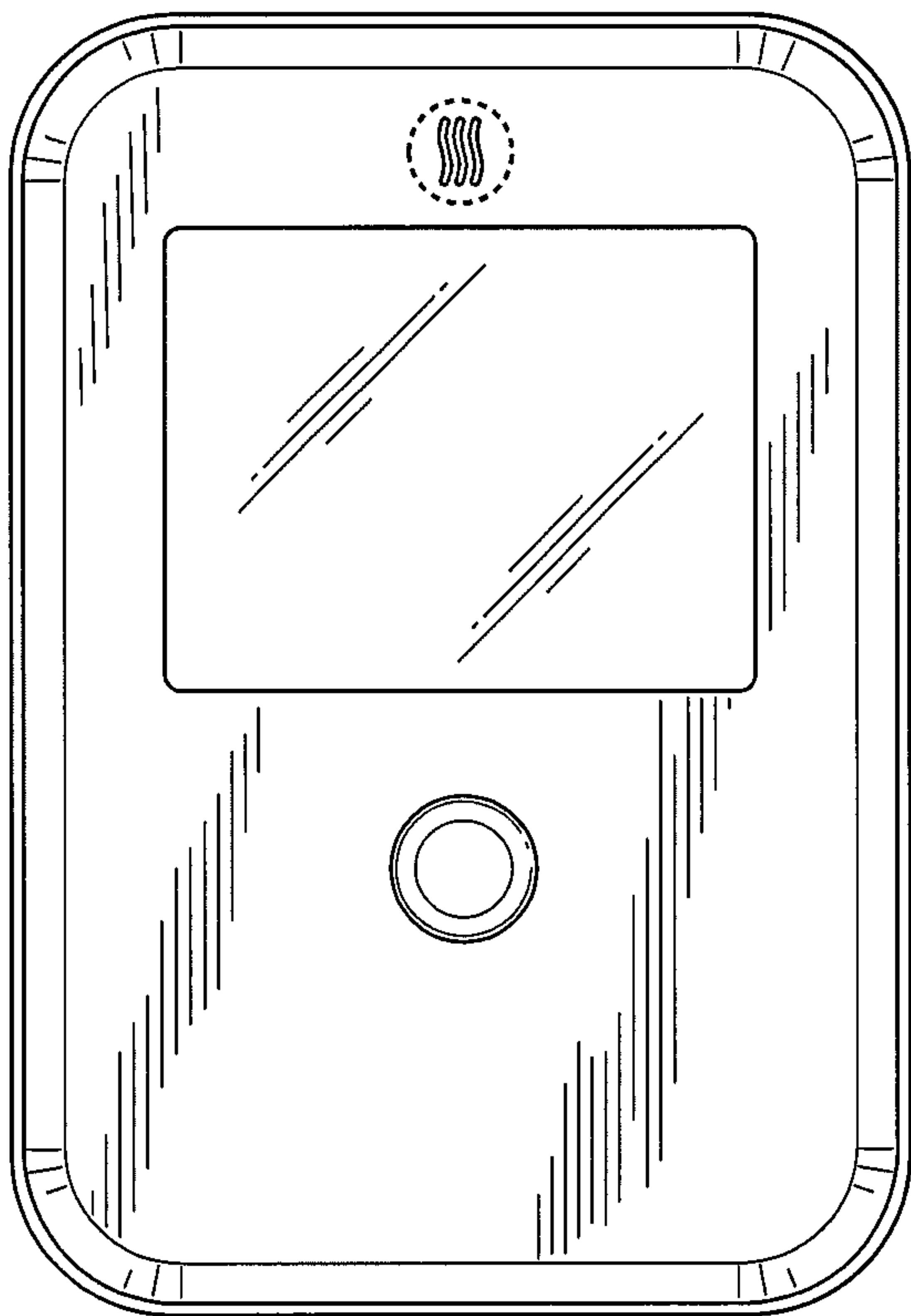

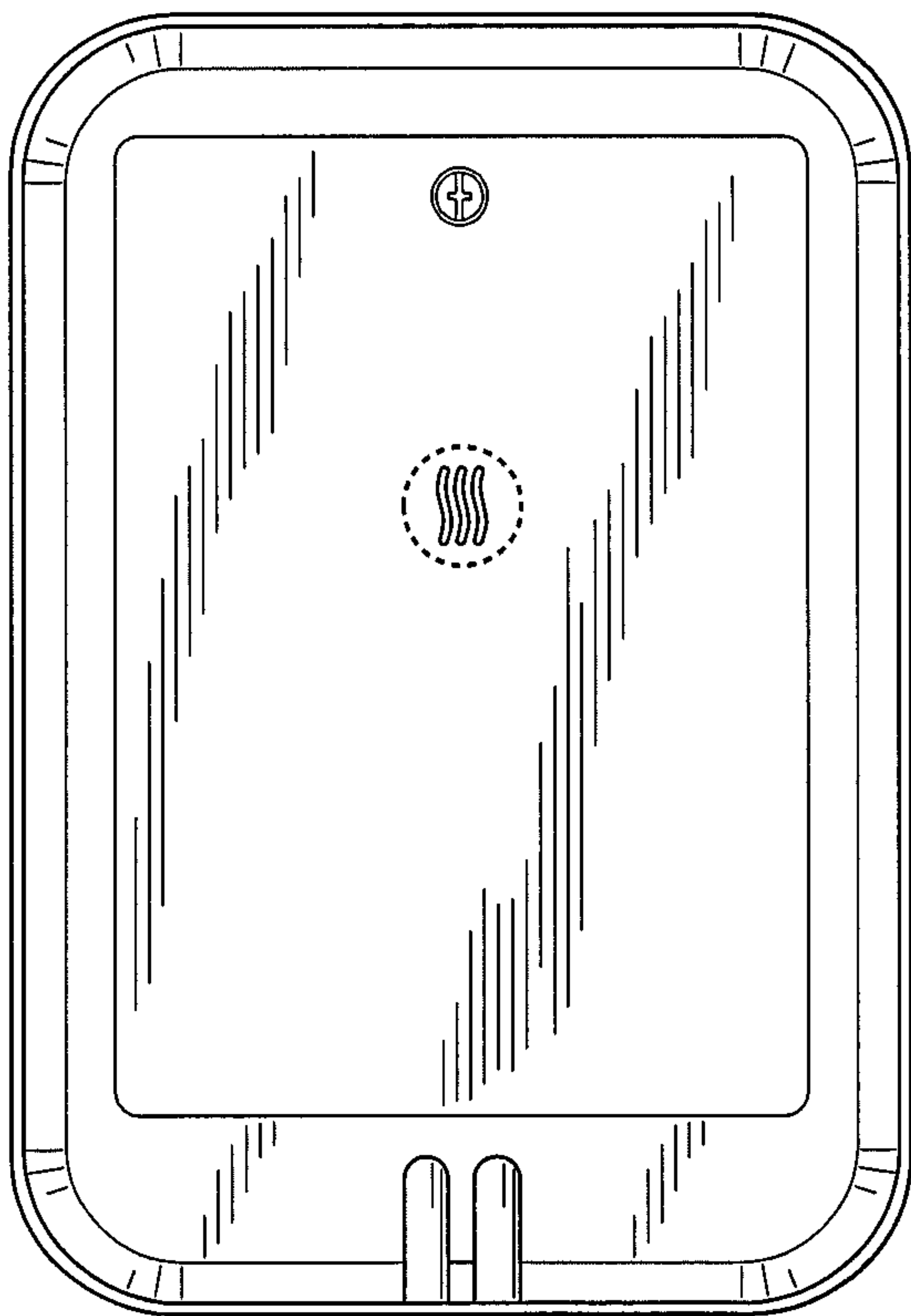

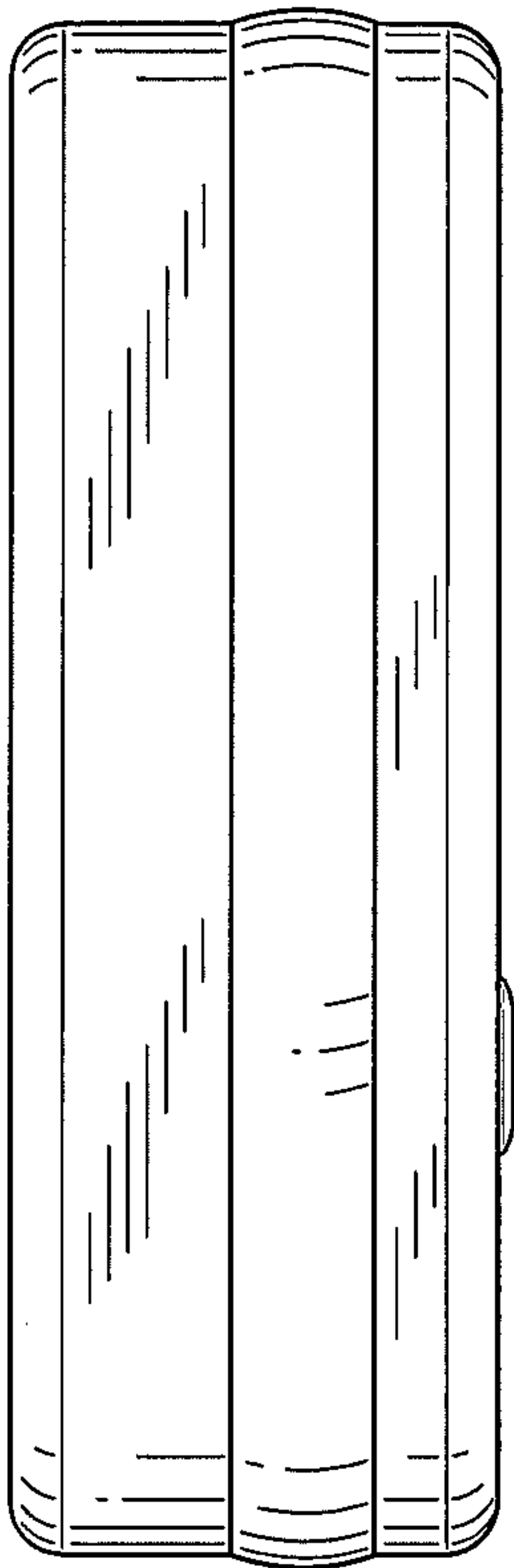

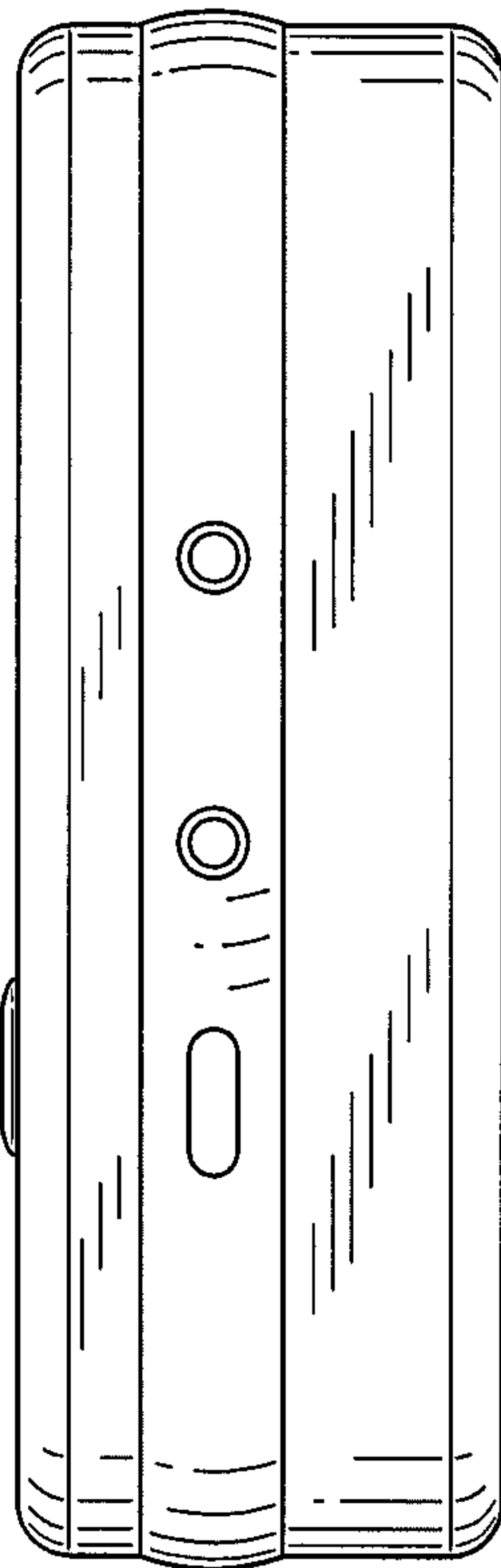

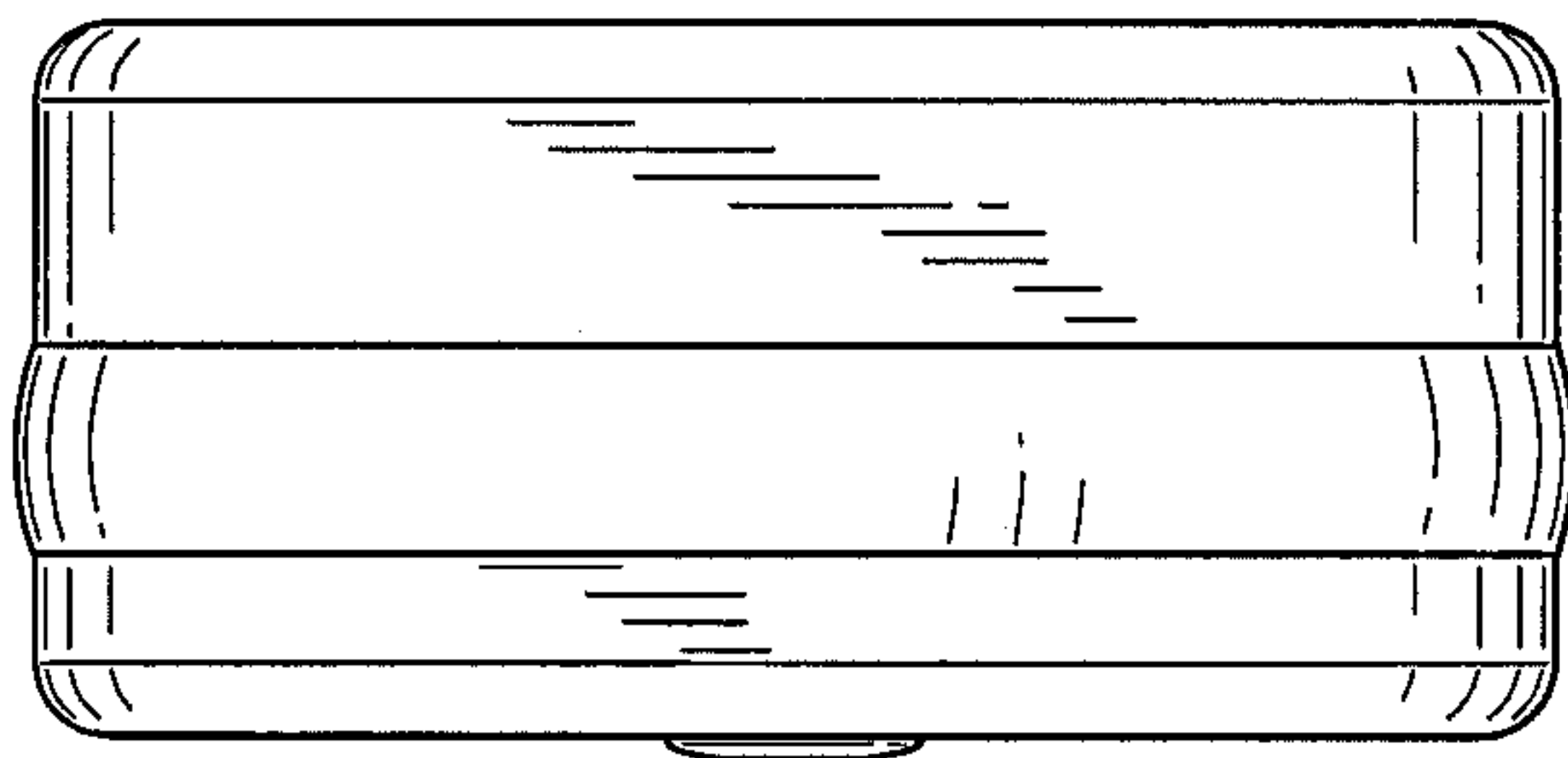

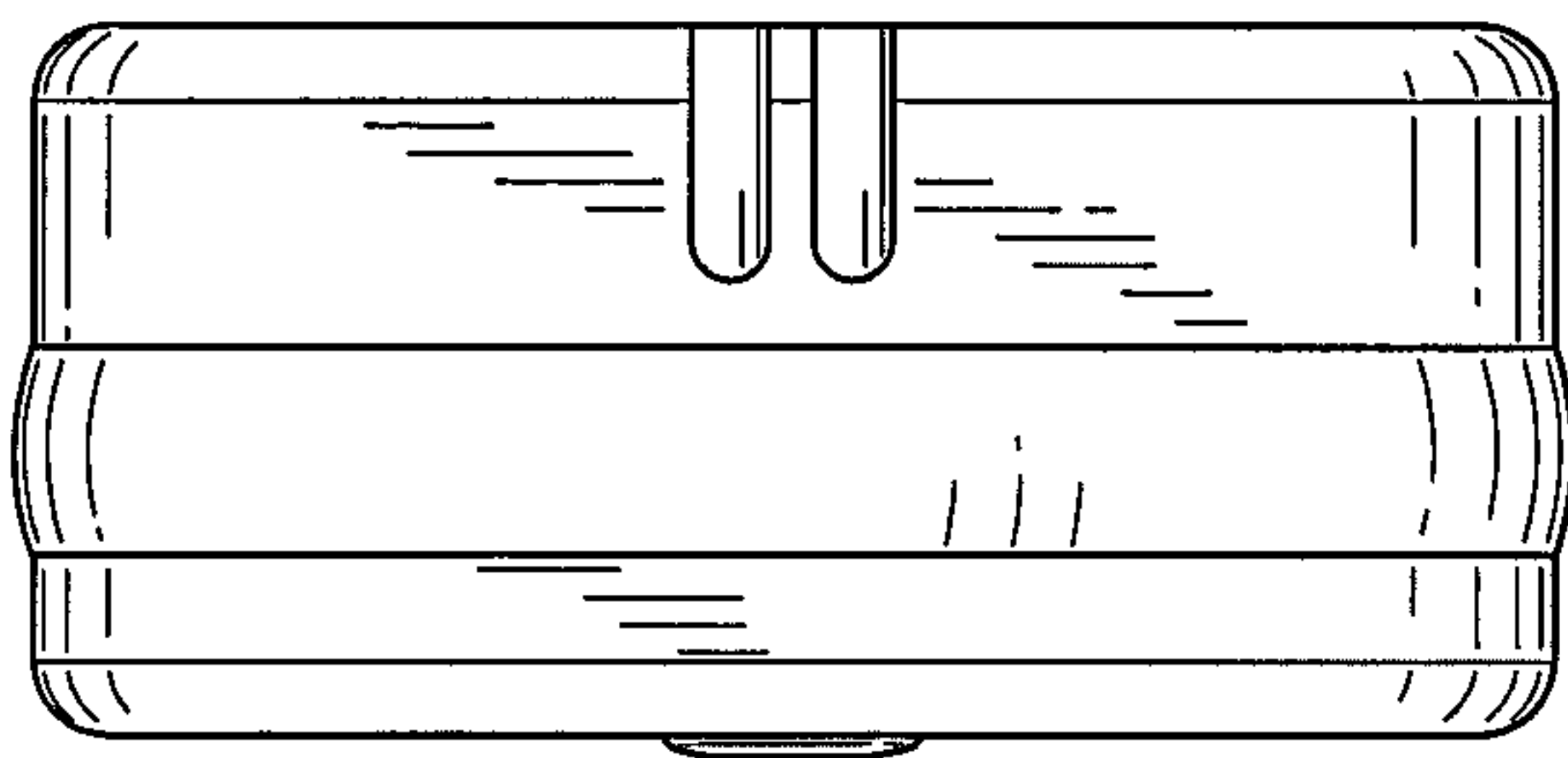
