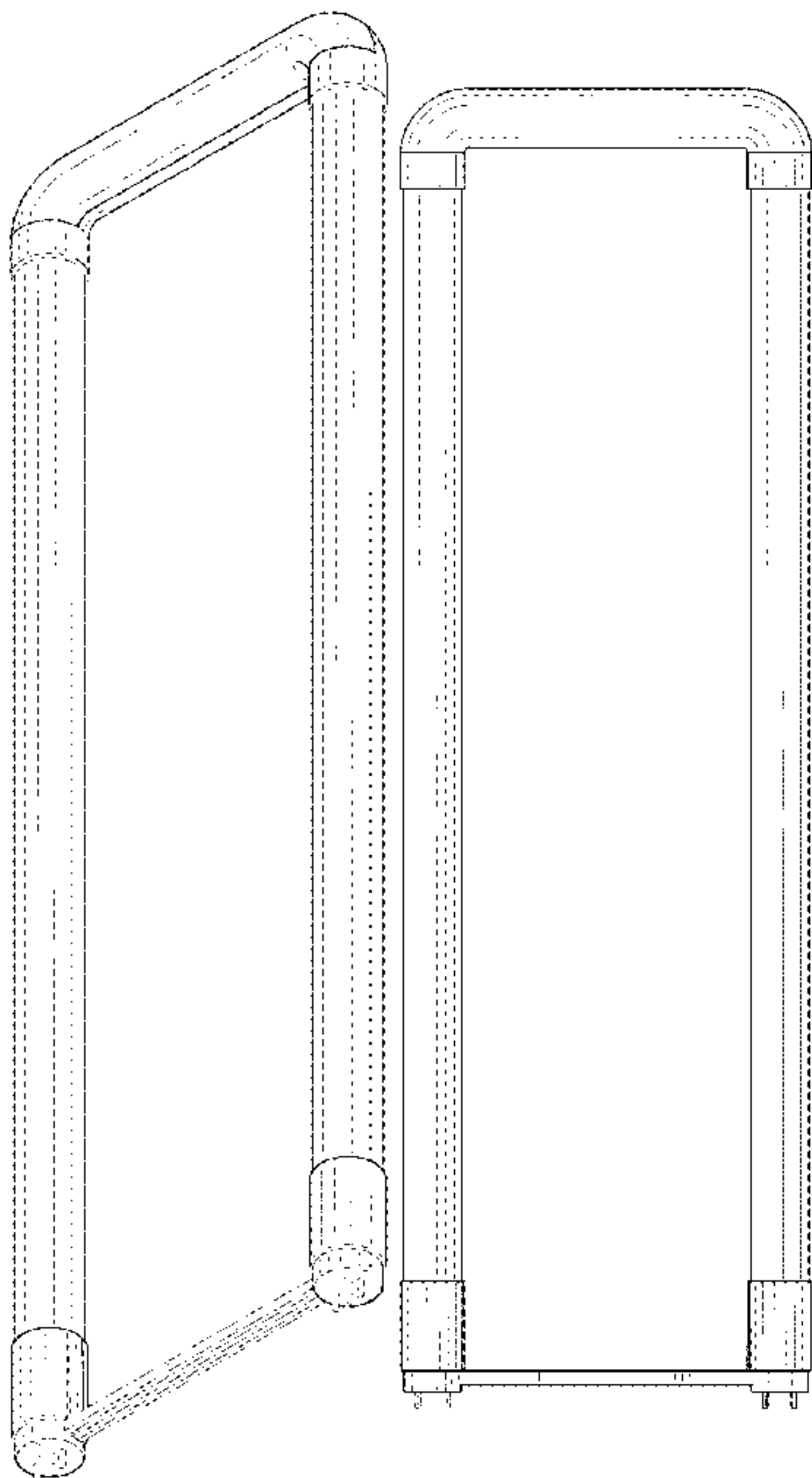
(57) CLAIM

DESCRIPTION

FIG. 1 is a bottom, front, and right side perspective view for a U-shape lamp showing our new design;

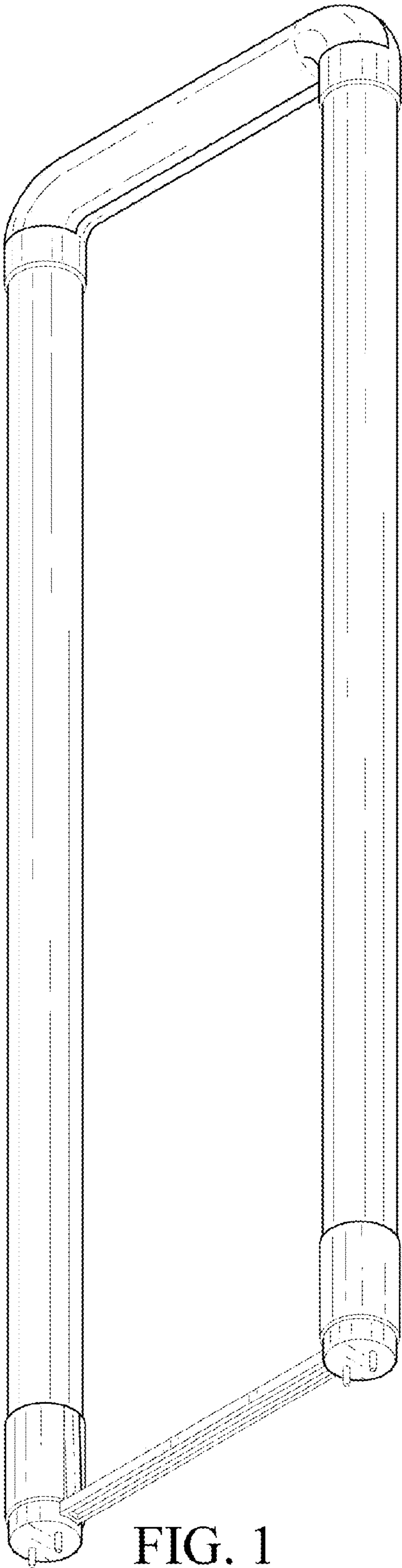

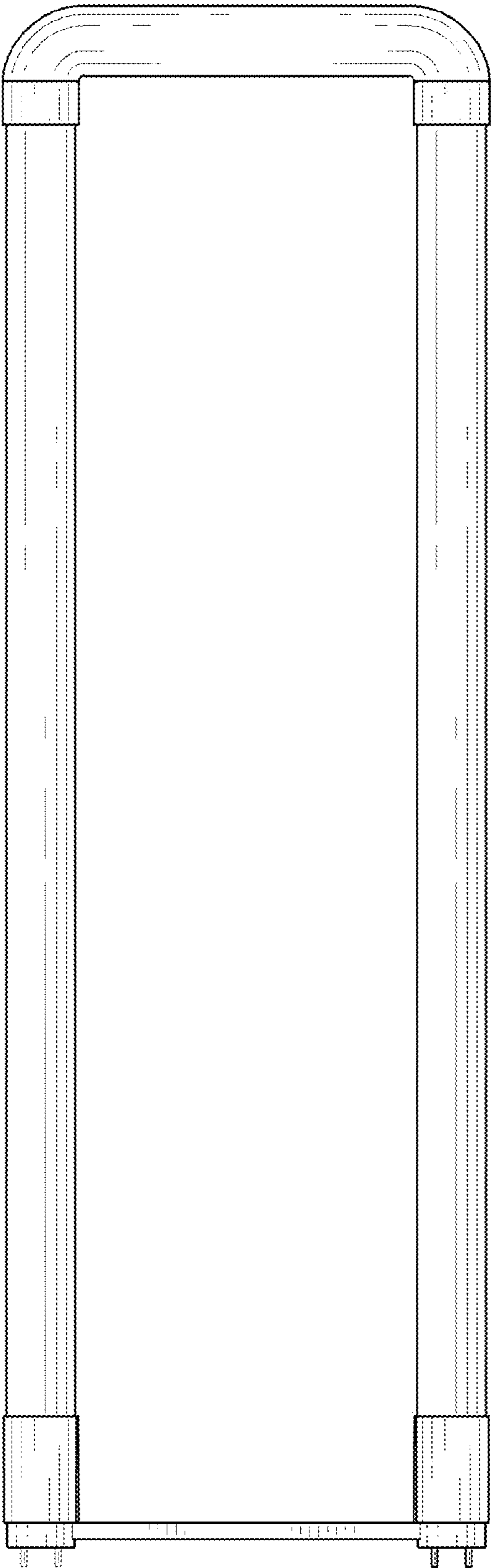

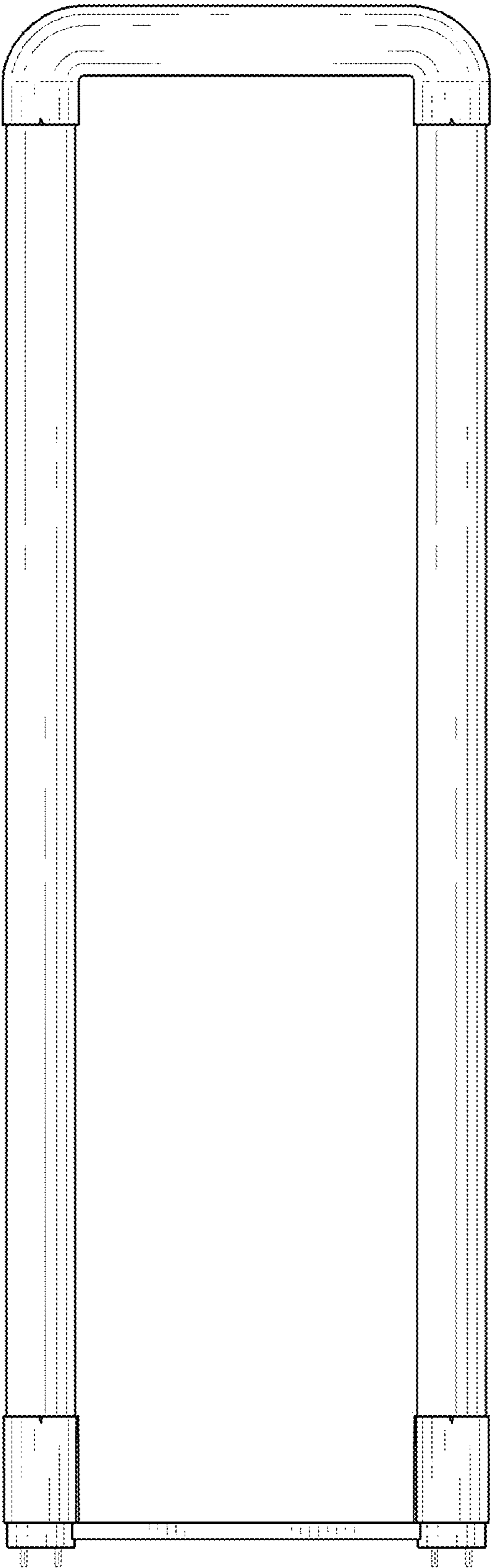

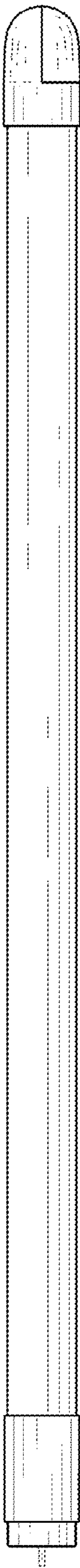

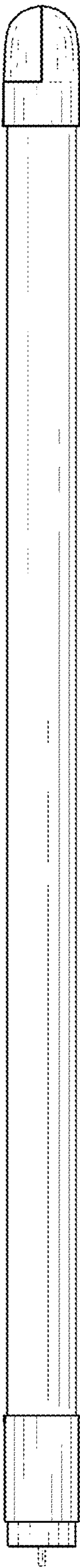

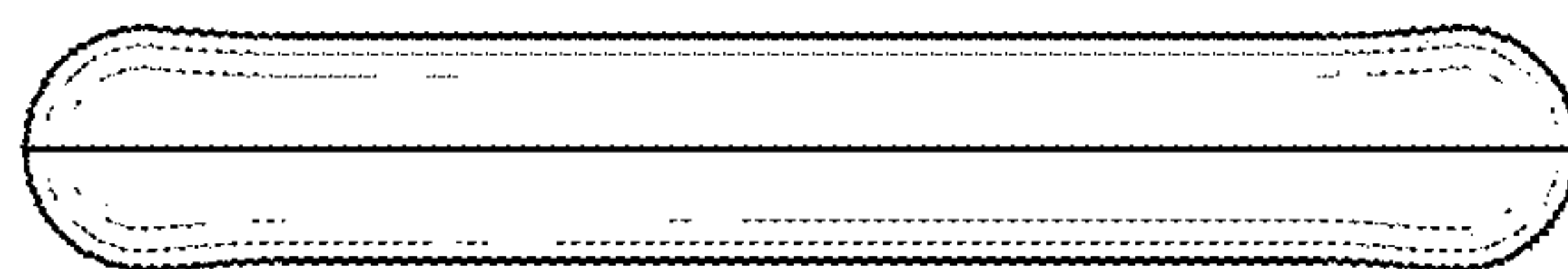

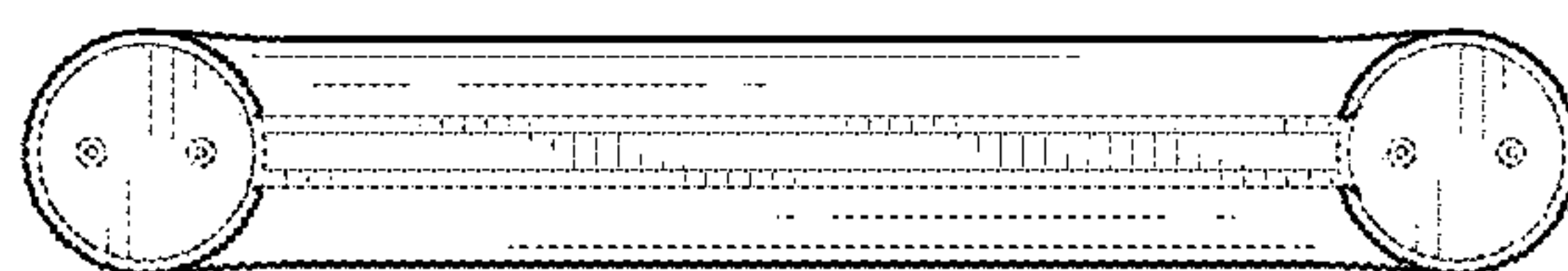
