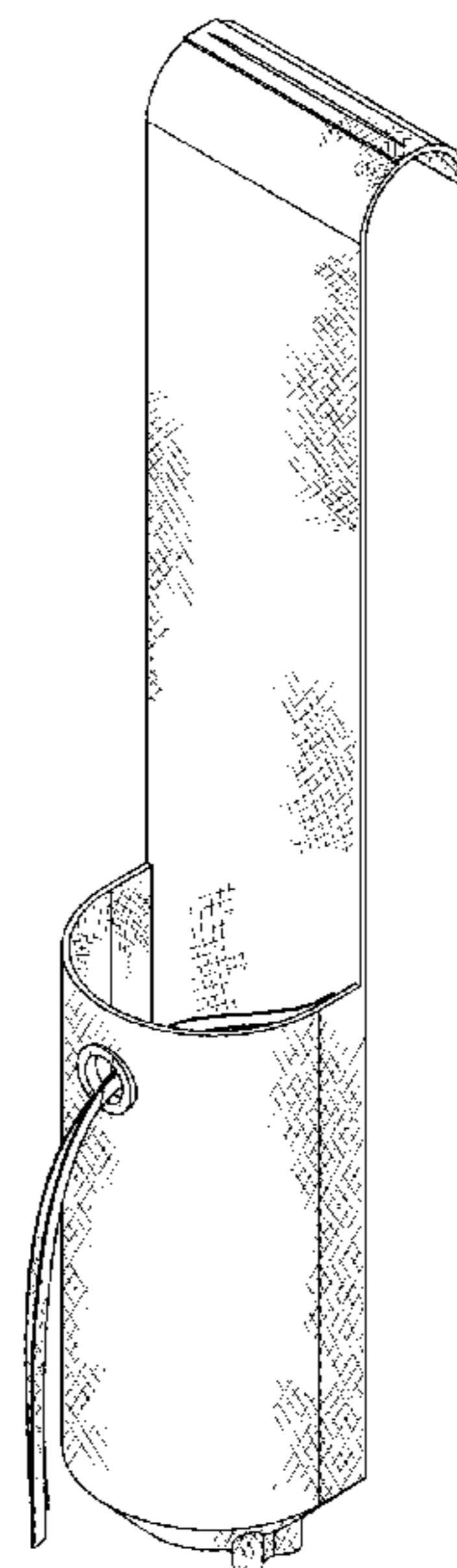
(57) **CLAIM**

The ornamental design for a boat fender hanger, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a boat fender hanger showing my new design;
FIG. 2 is a bottom-rear-right perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right elevational view thereof;
FIG. 6 is a left elevational plan view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom elevational view thereof; and,
FIG. 9 is a top-front-left perspective view thereof, wherein the boat fender hanger is attached to a boat cleat.
The broken line of a boat cleat in FIG. 9, is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

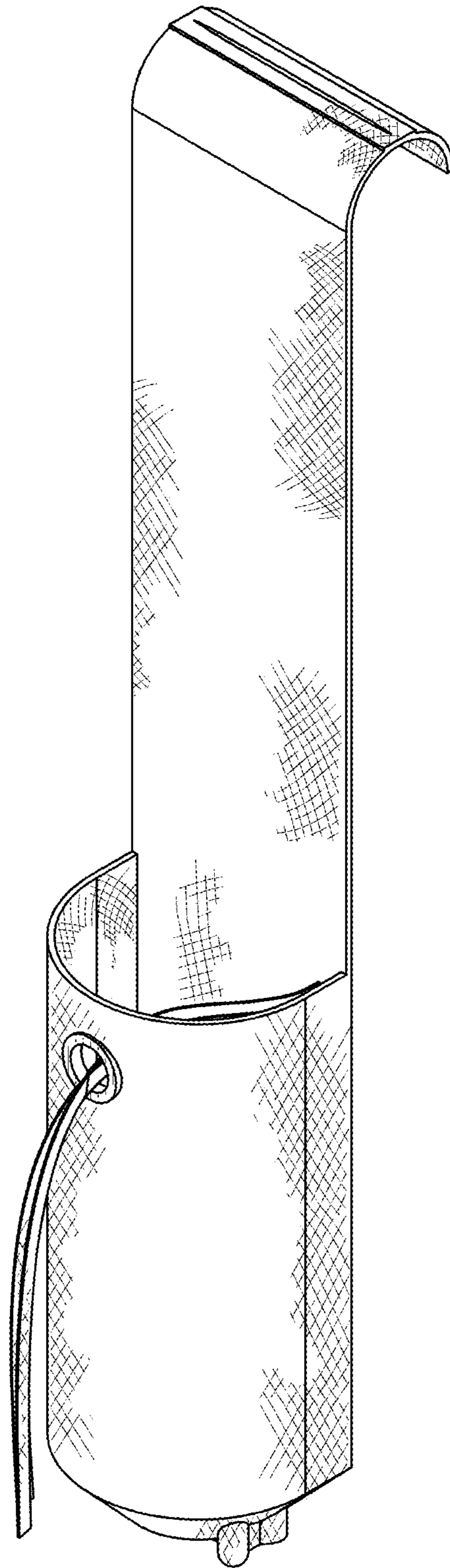

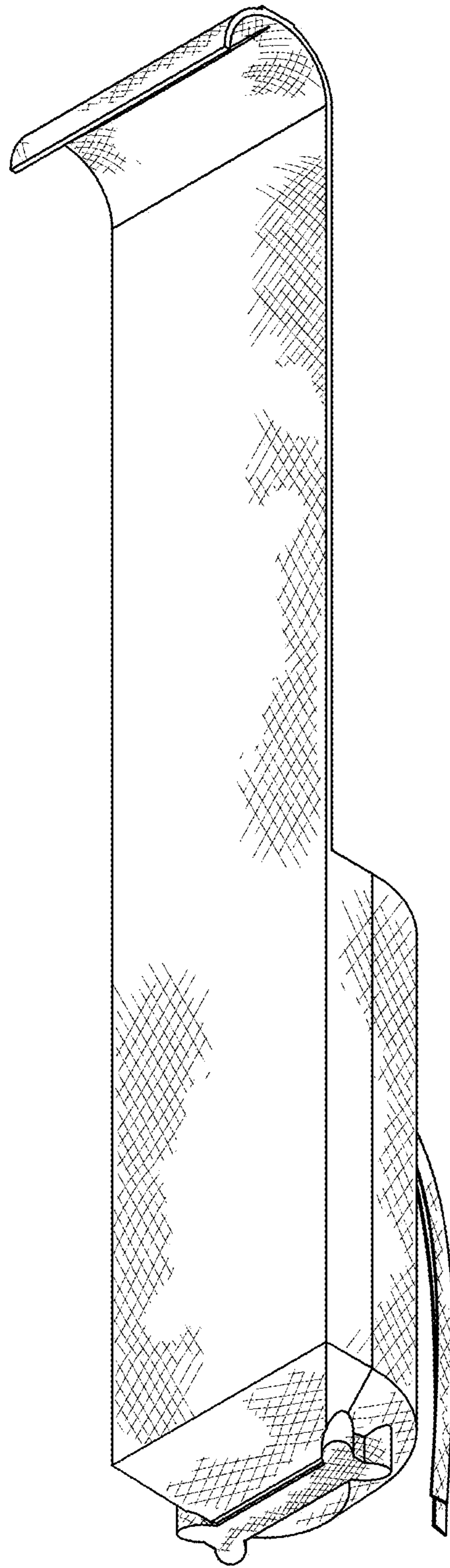

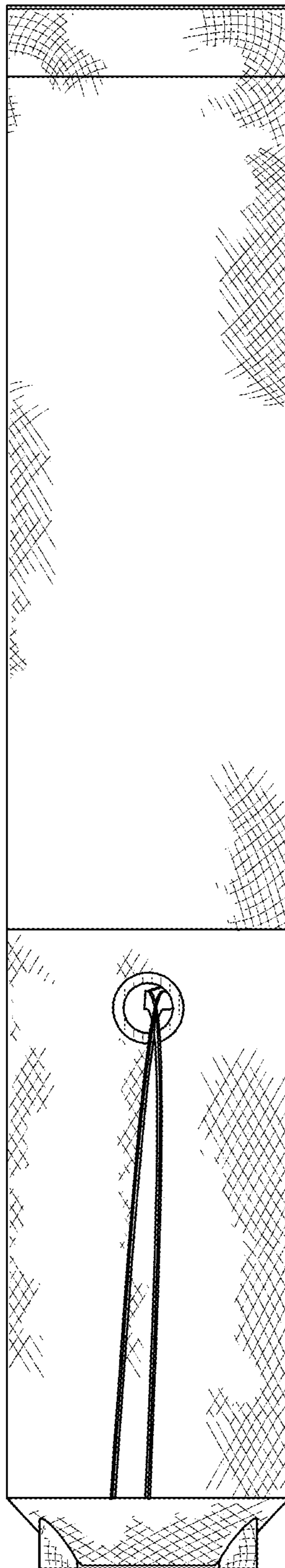

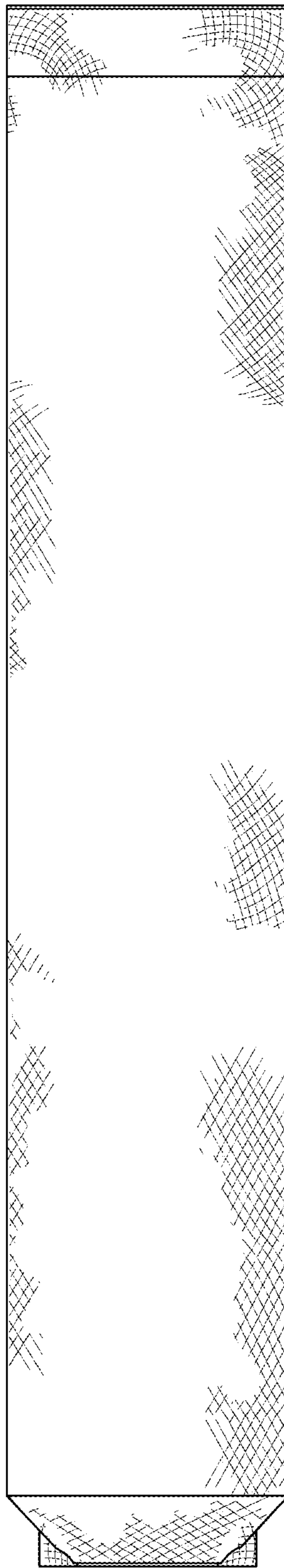

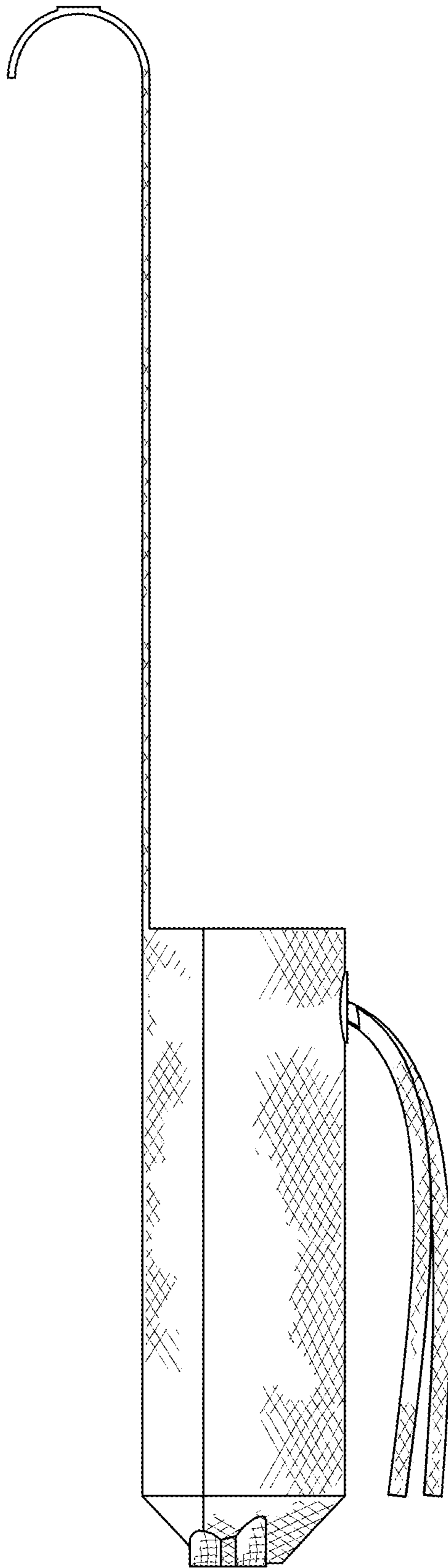

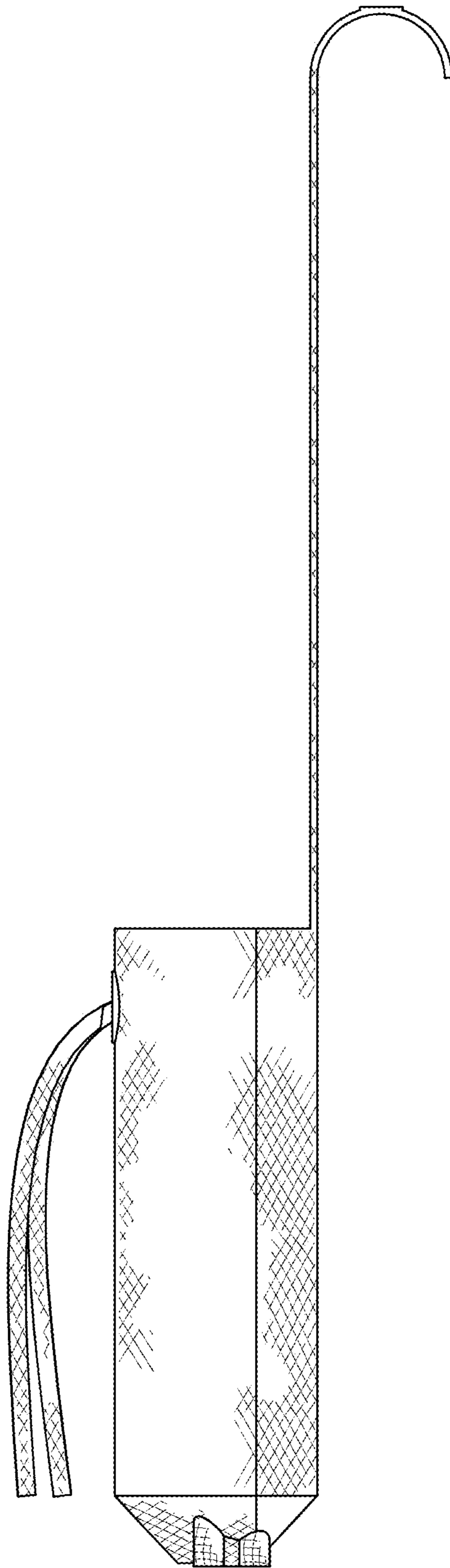

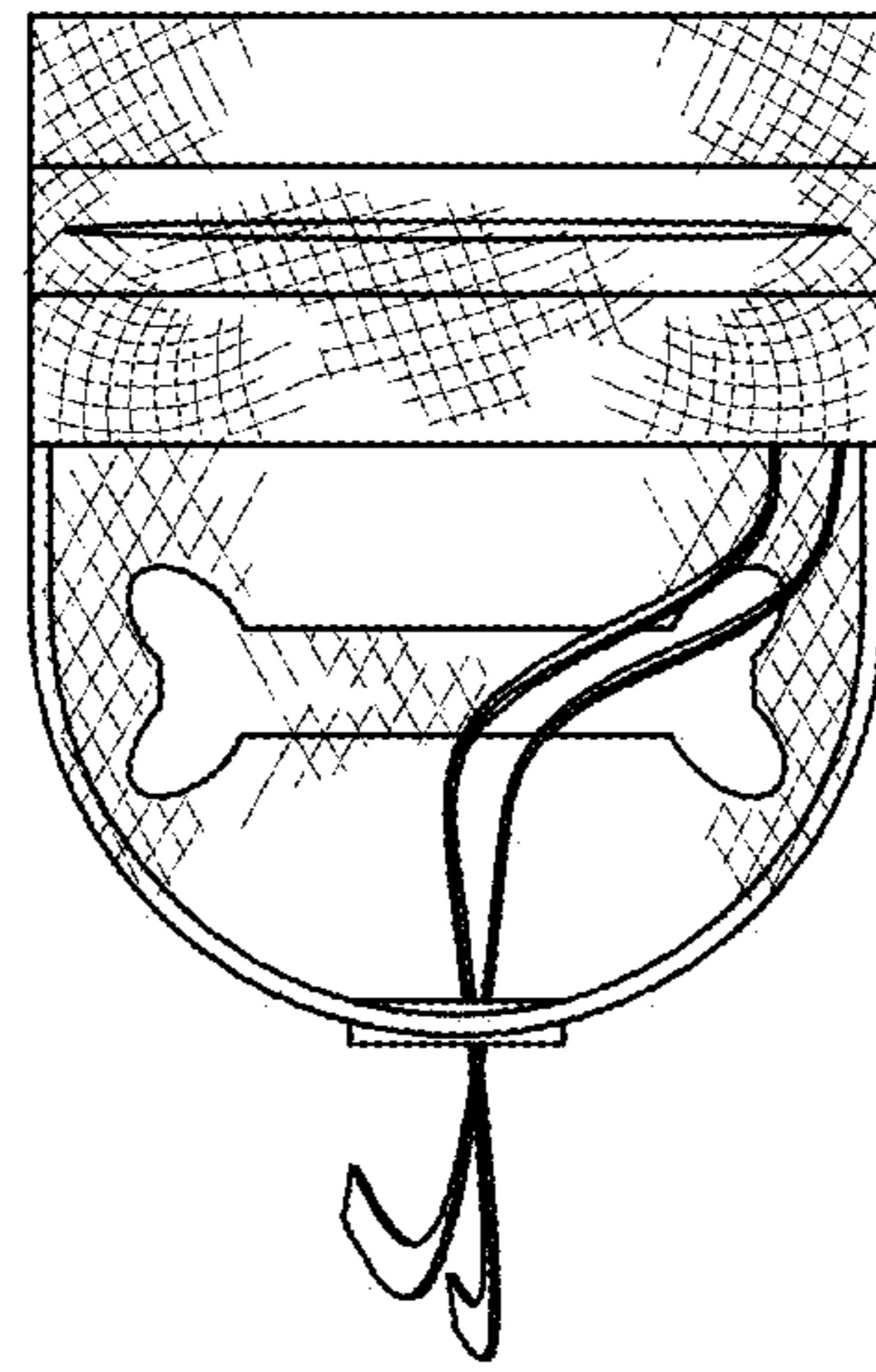

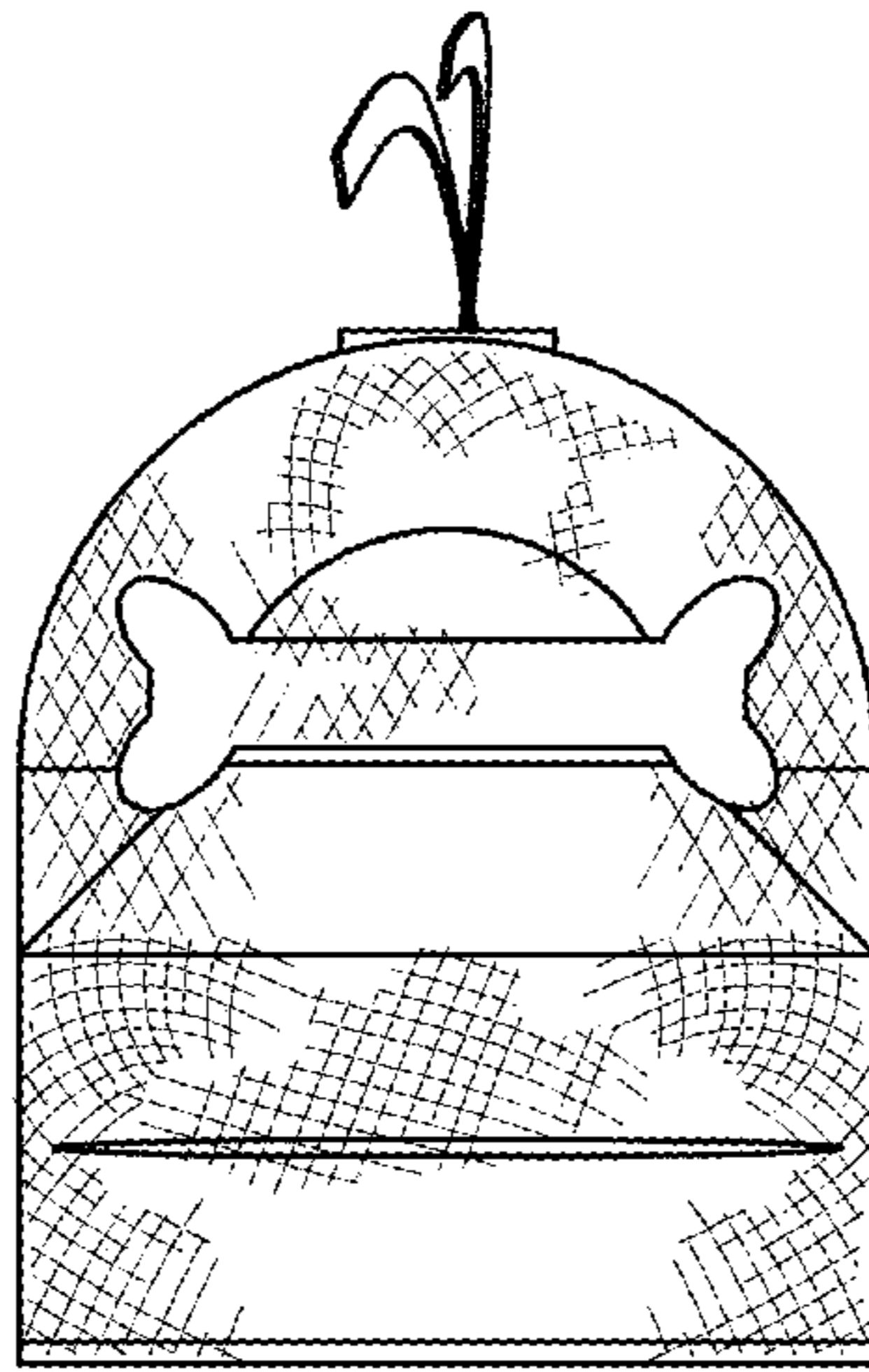

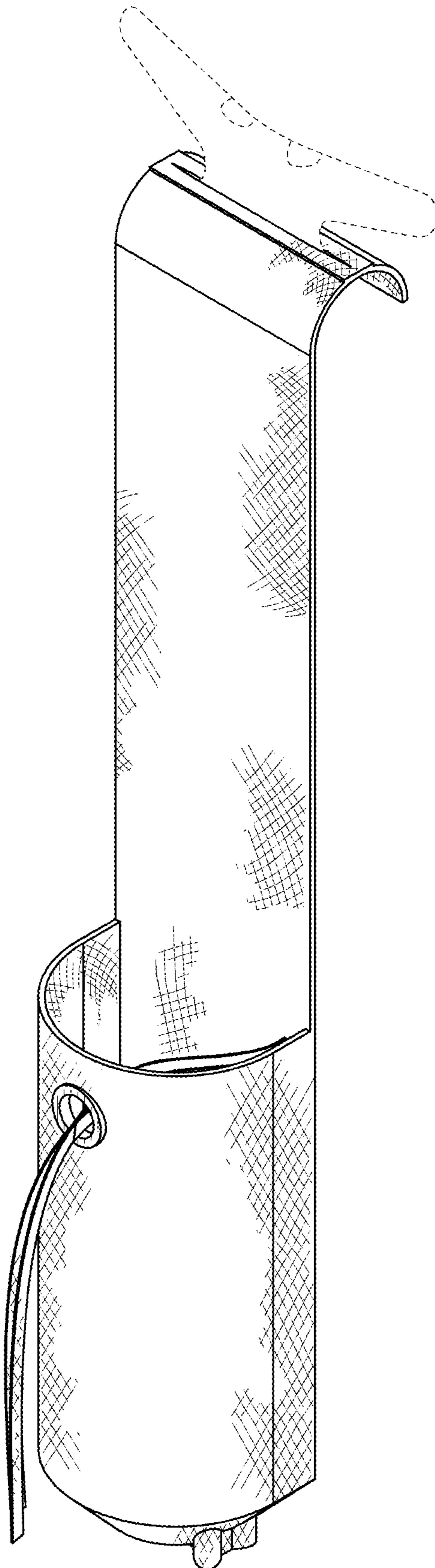
