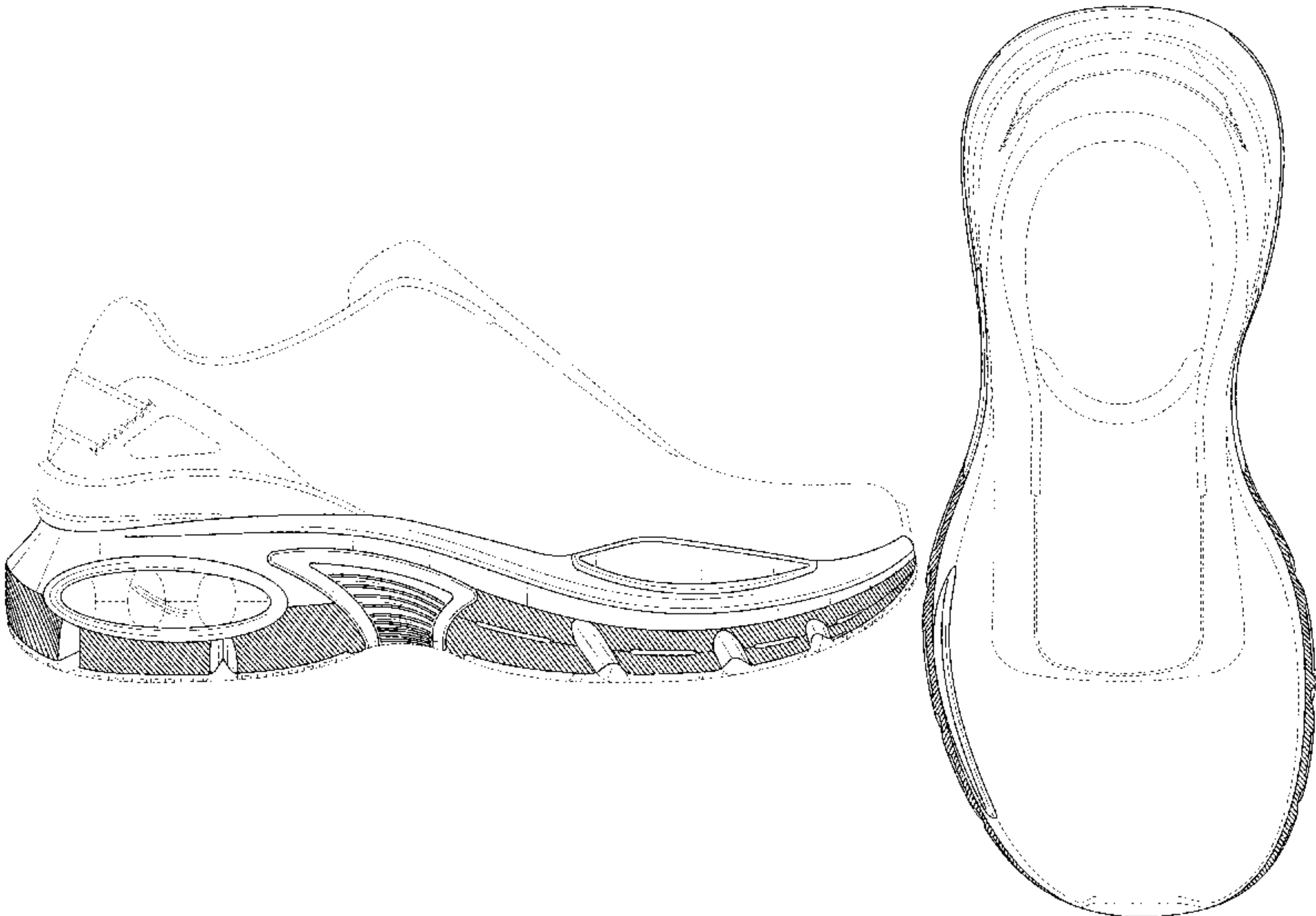
(57) CLAIM

The ornamental design for a shoe midsole periphery, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe midsole periphery in accordance with my new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. Broken lines shown in the drawings represent environmental structure of the shoe and form no part of the claimed design.

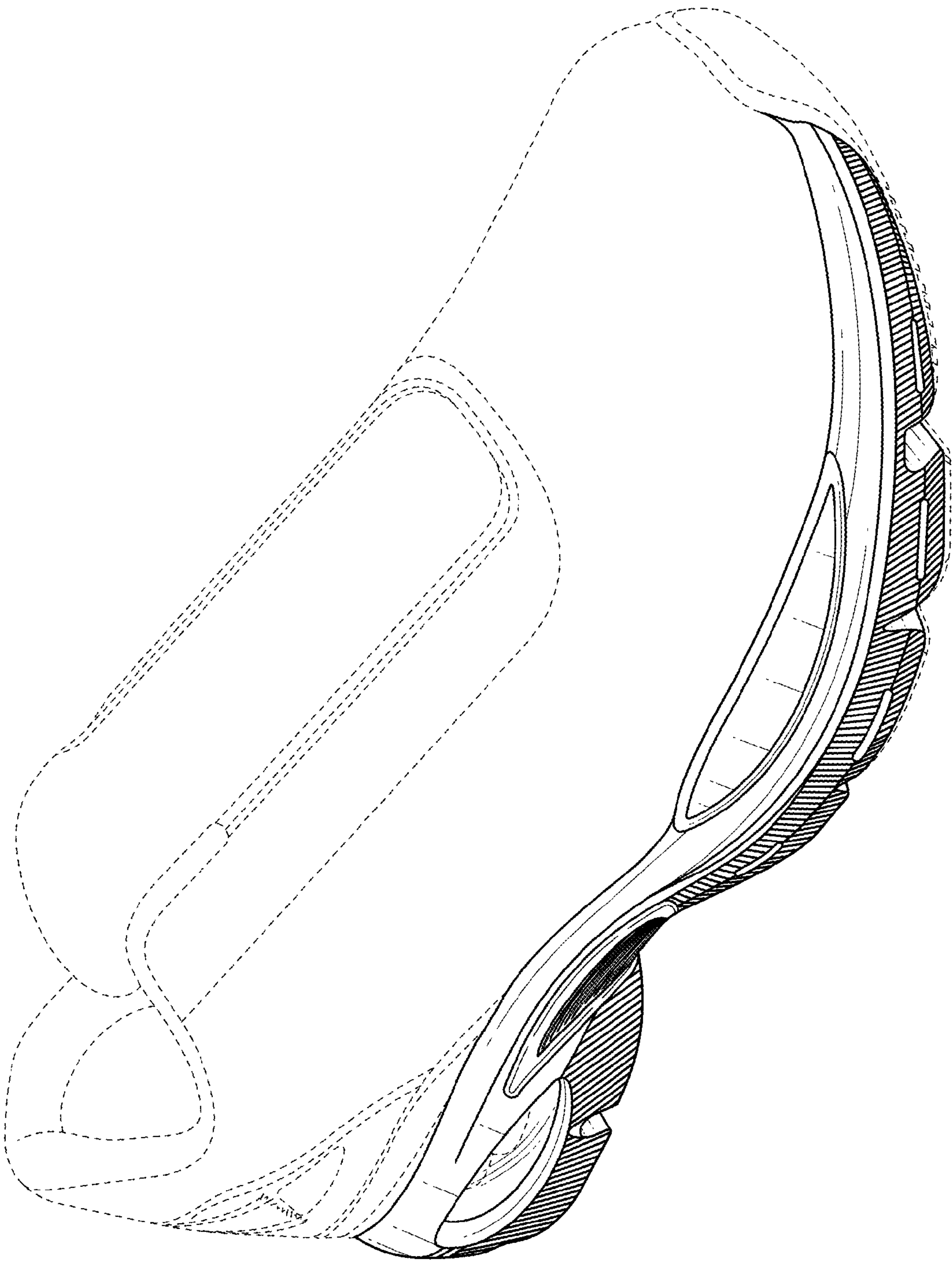

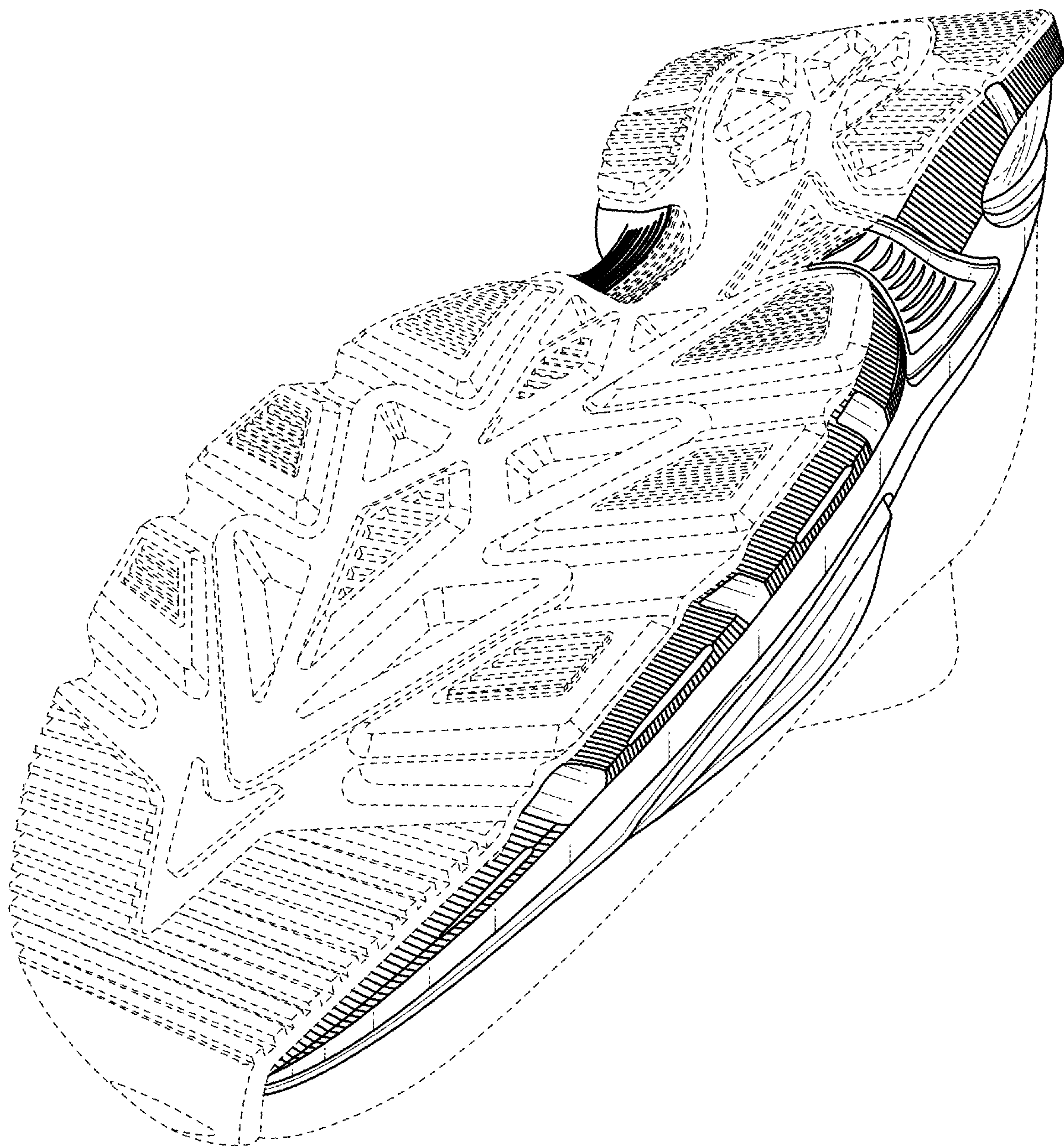

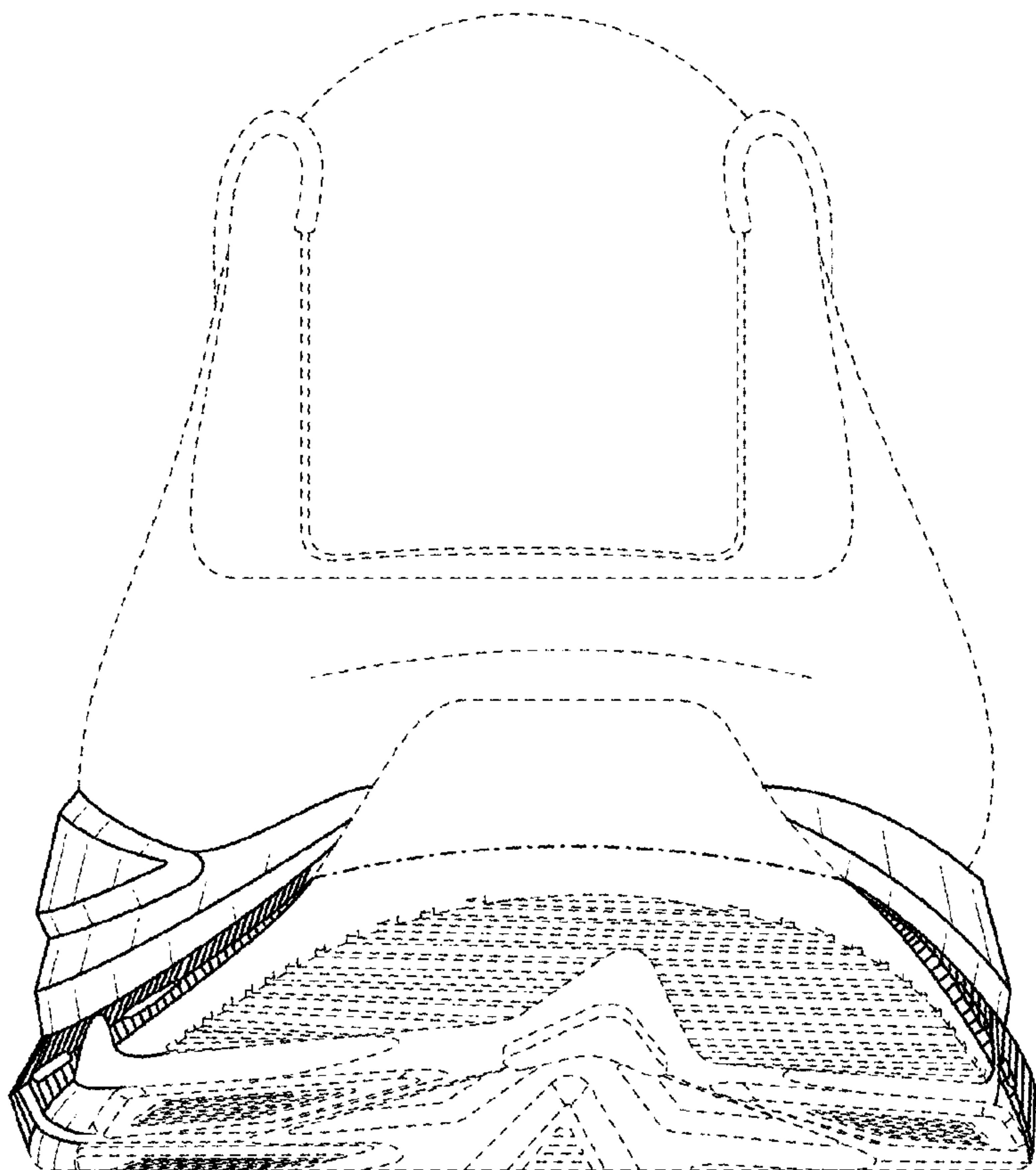

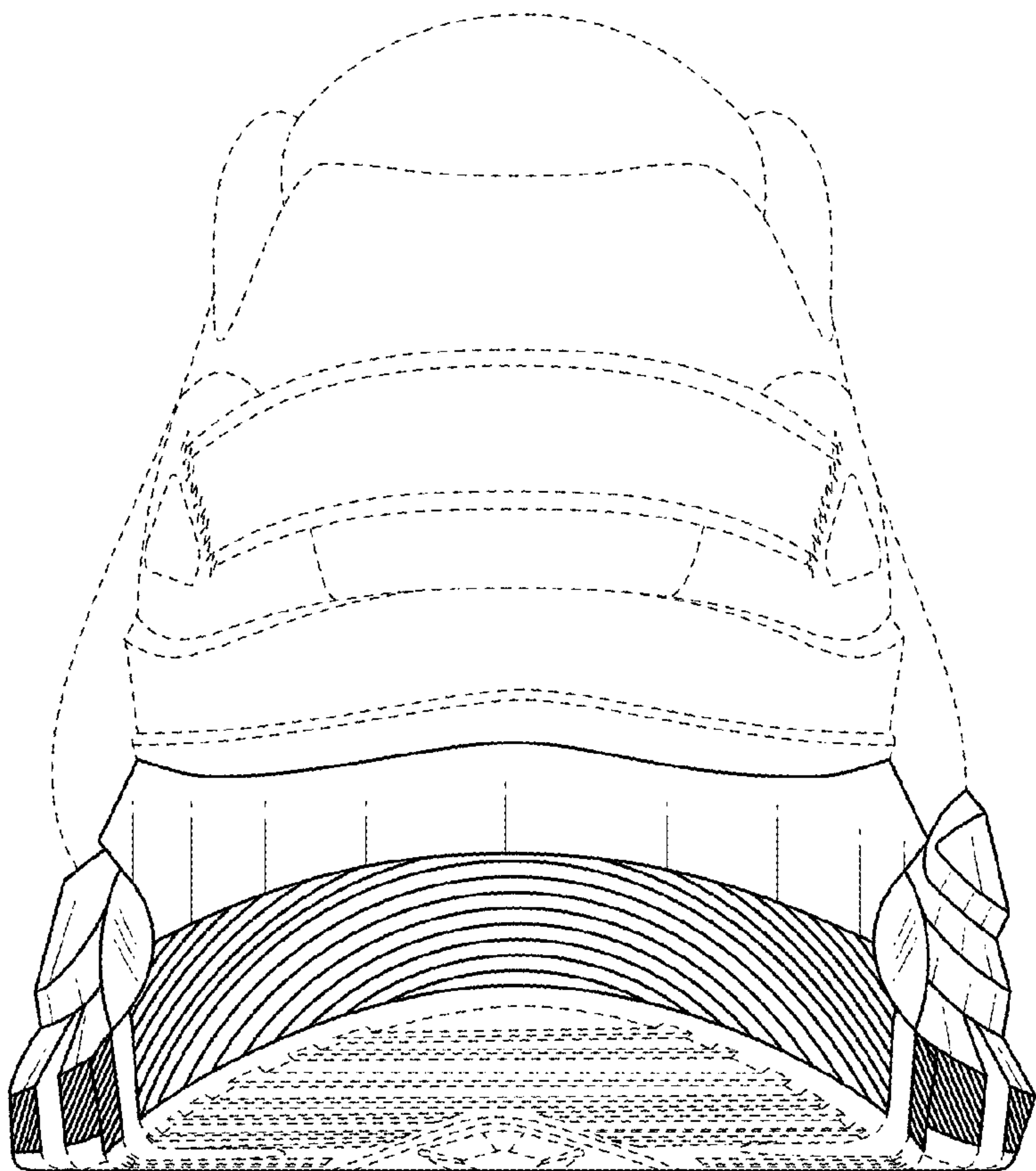

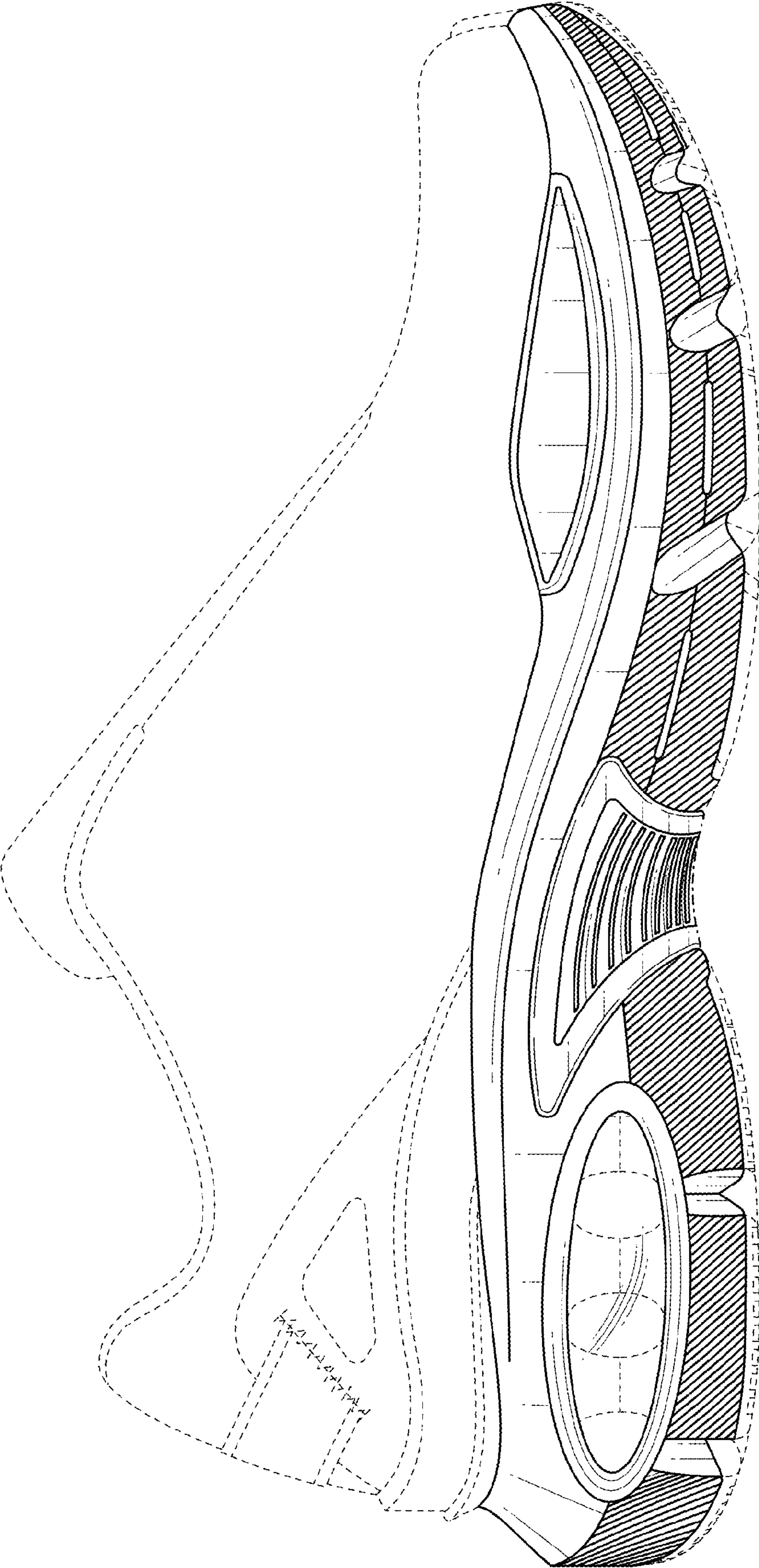

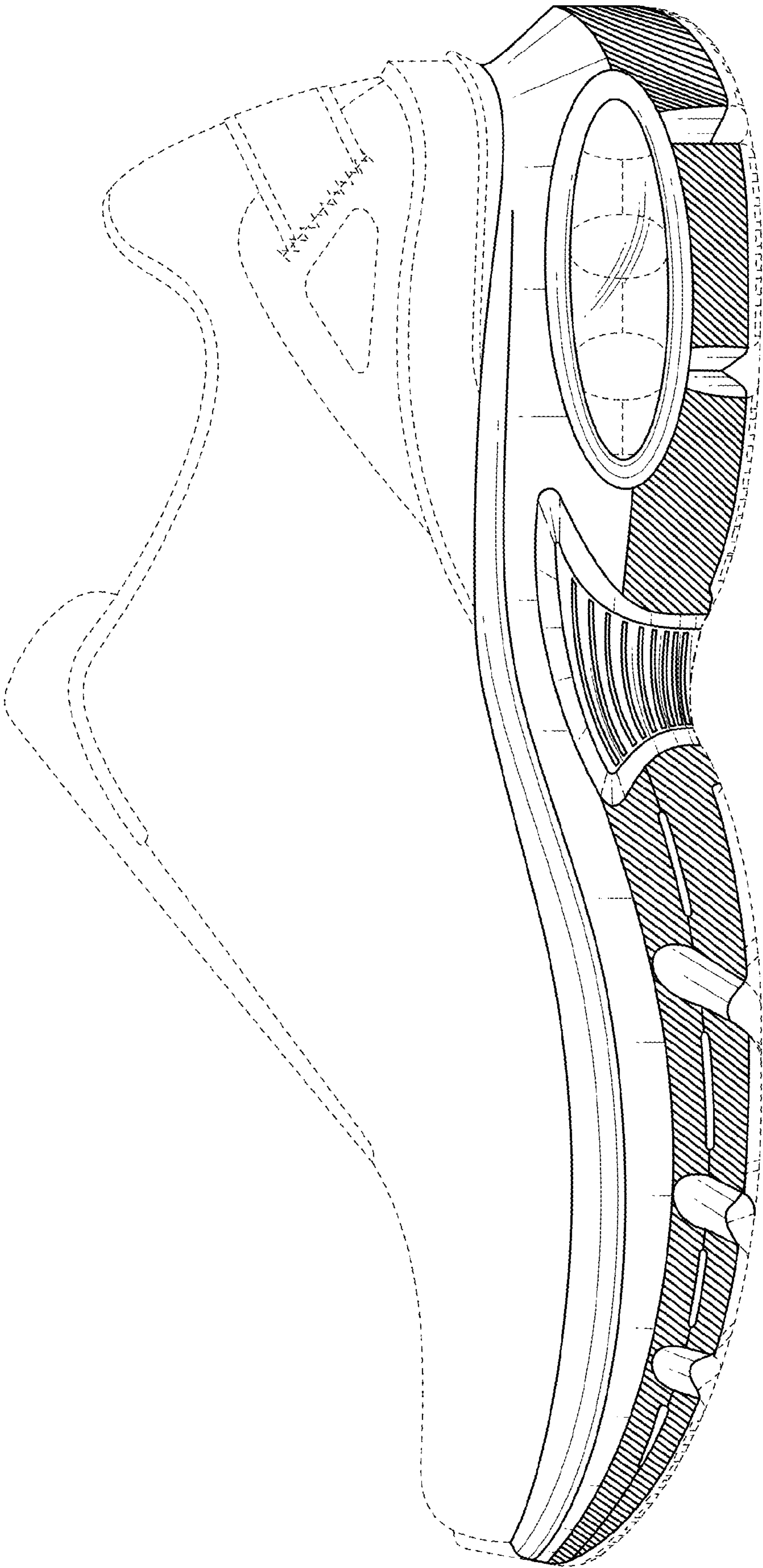

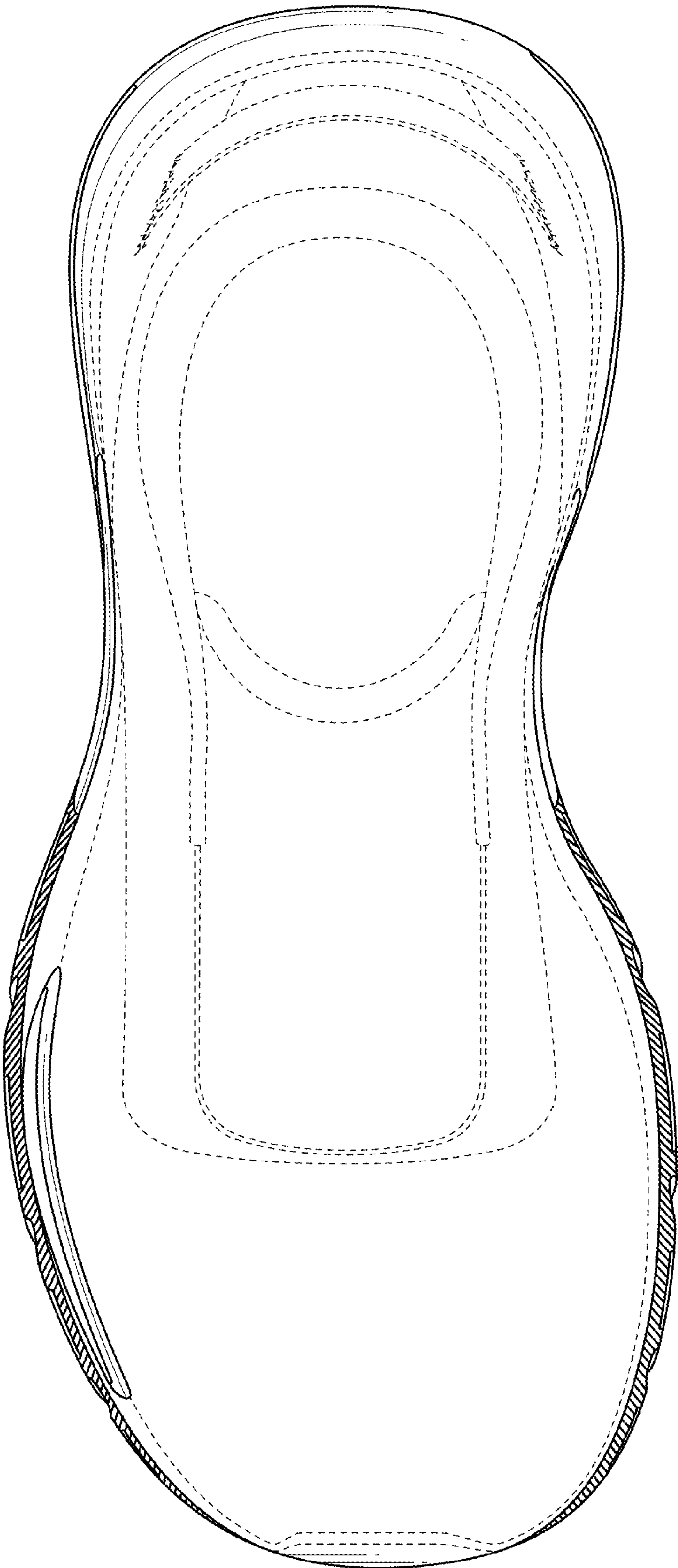

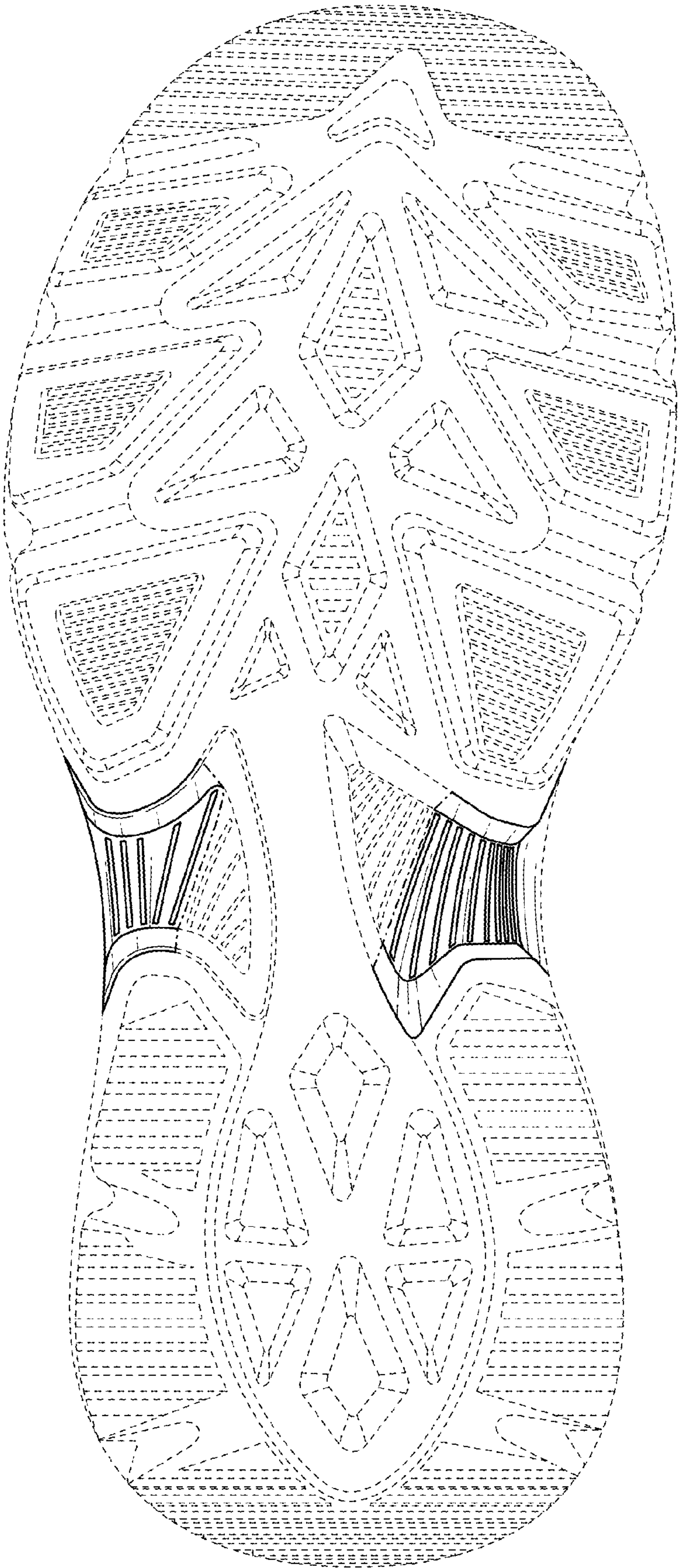
