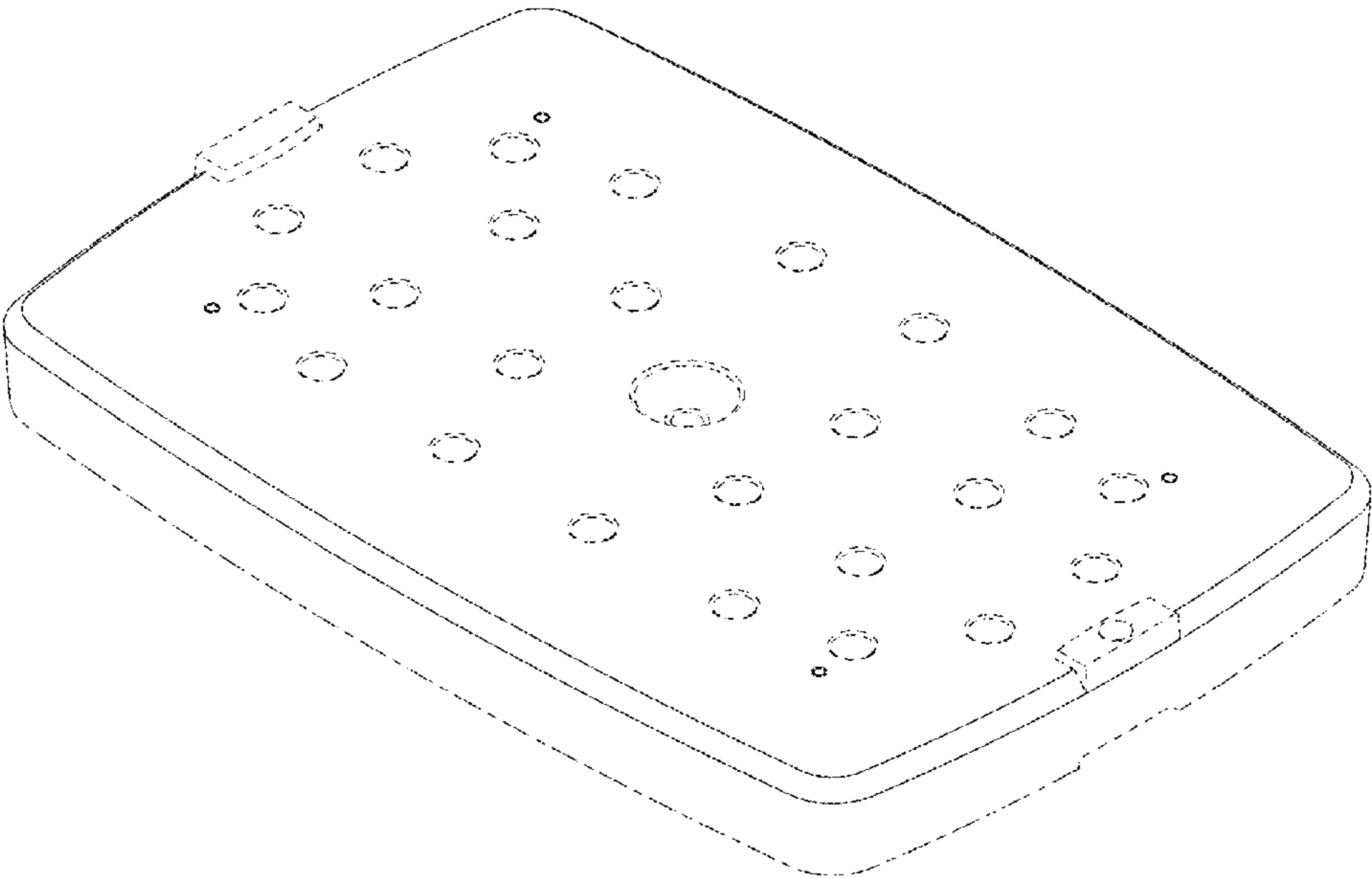
(57) CLAIM

The ornamental design of a support member for a generator, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a support member for a generator showing our new design; FIG. 2 is a top view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right side view thereof; FIG. 6 is the left side view thereof; and, FIG. 7 is a bottom view thereof. The dashed broken lines illustrate portions of the support member for a generator that form no part of the claimed design. The dot-dash broken lines define the bounds of the claimed design and form no part thereof.

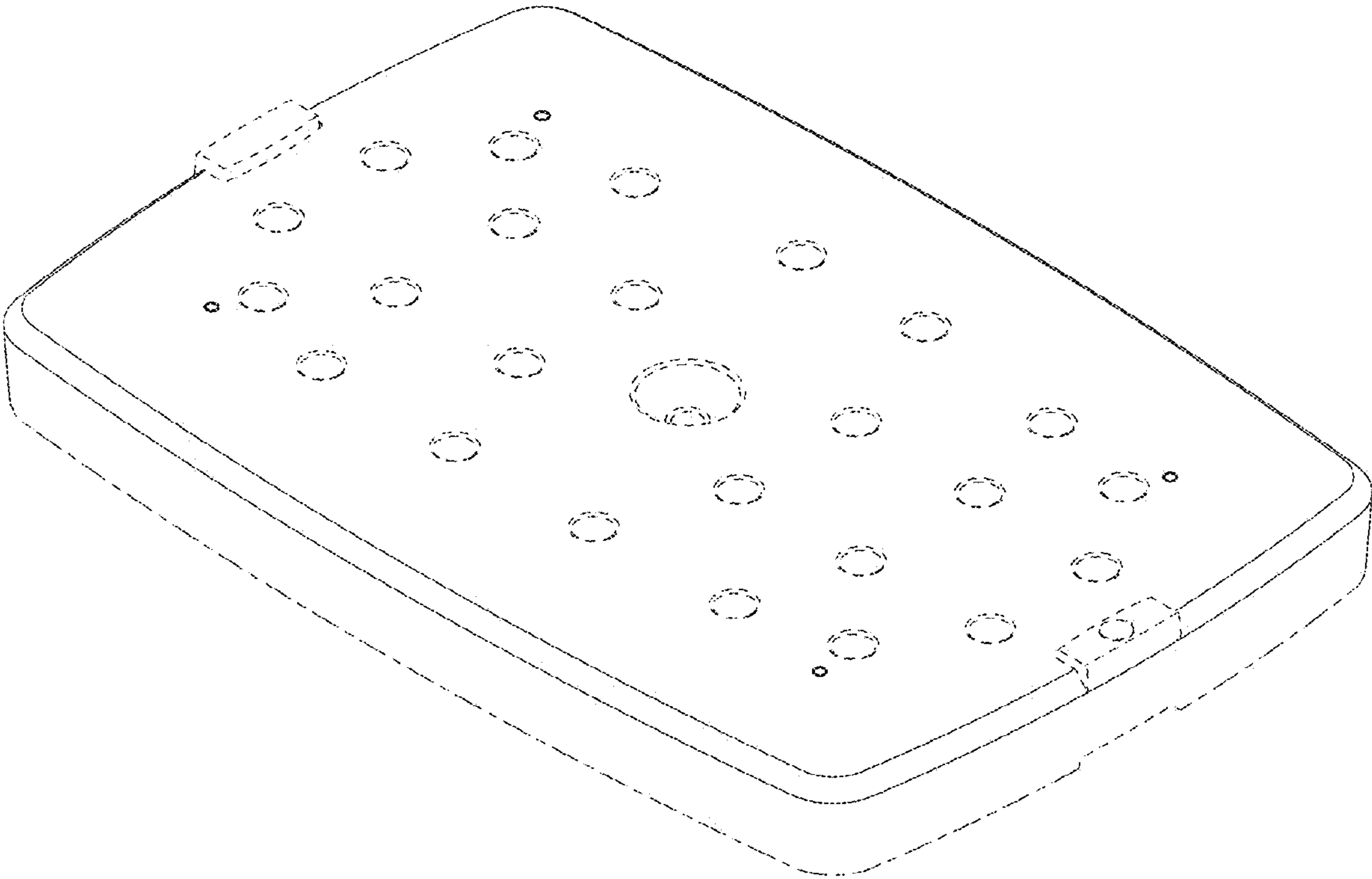

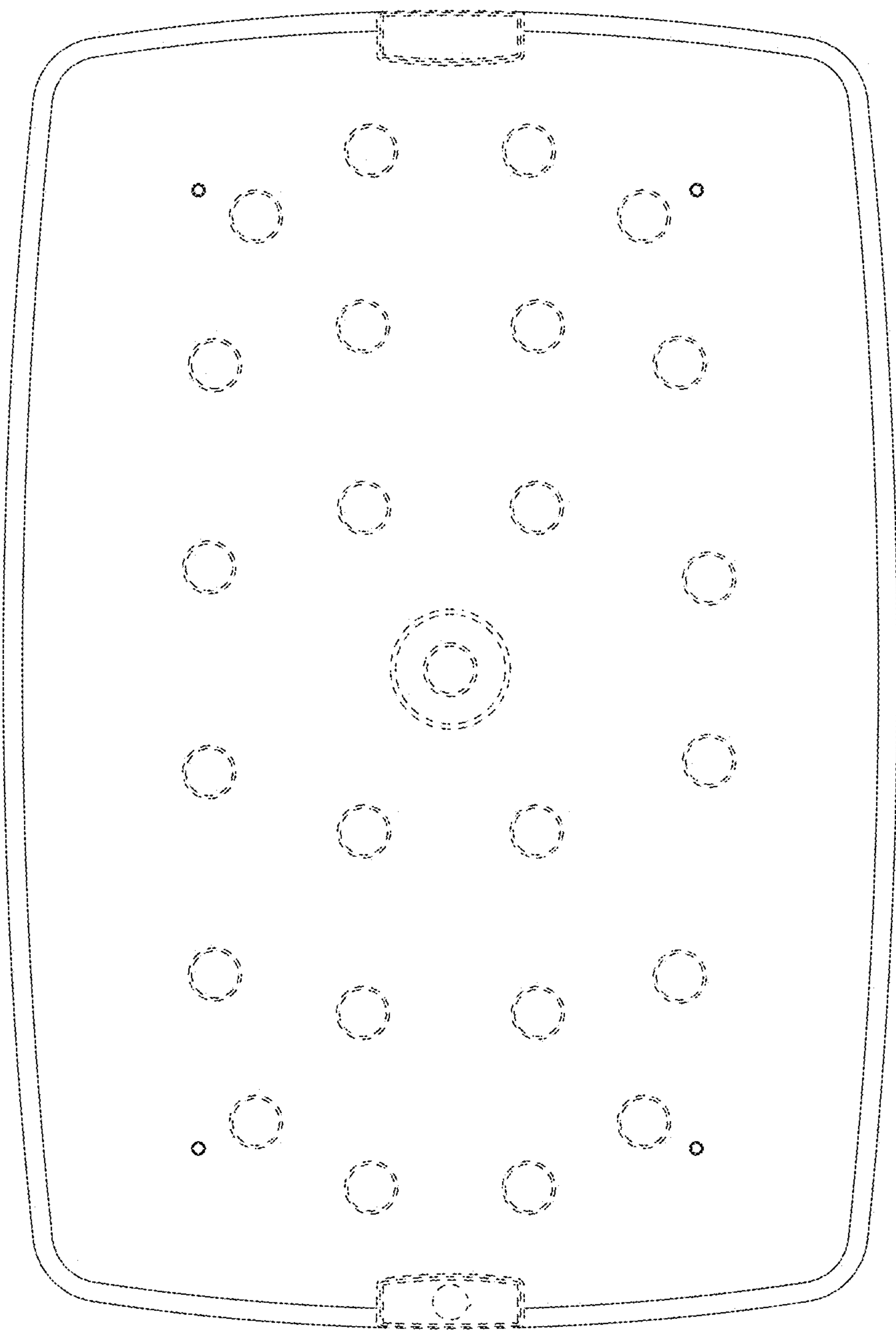

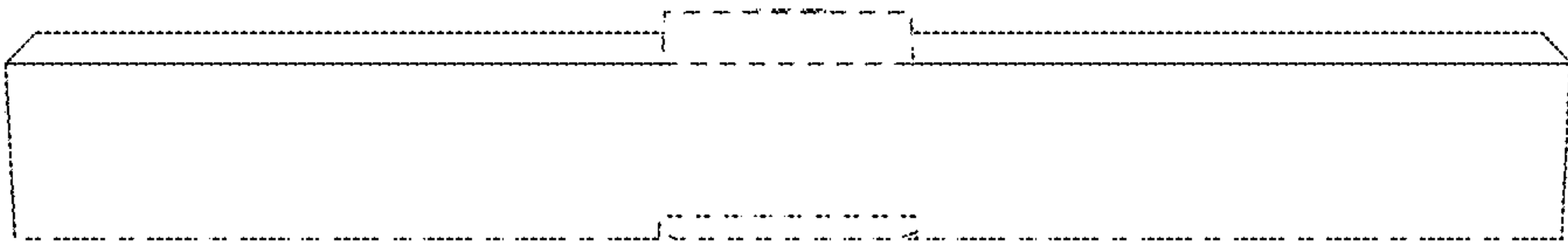

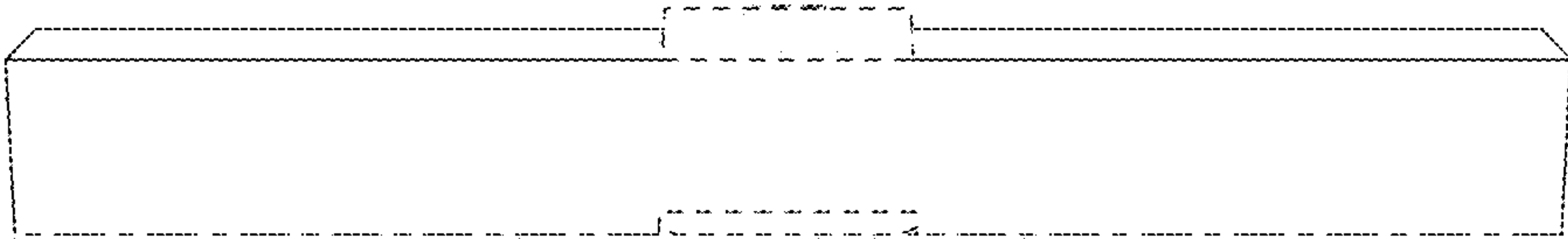

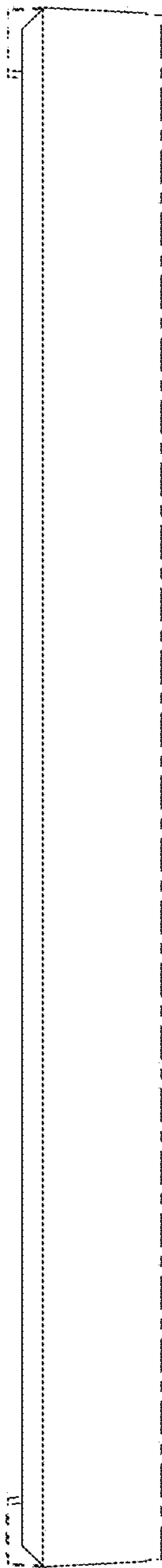

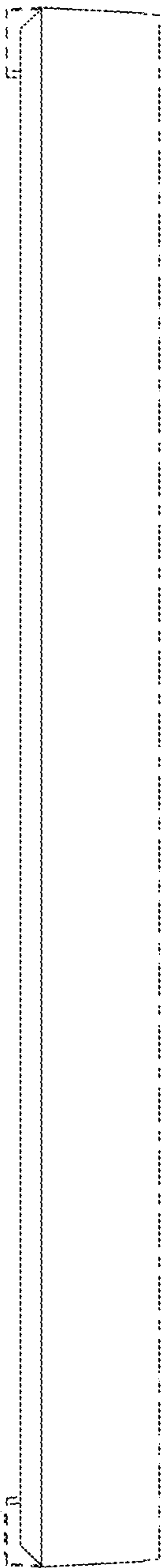

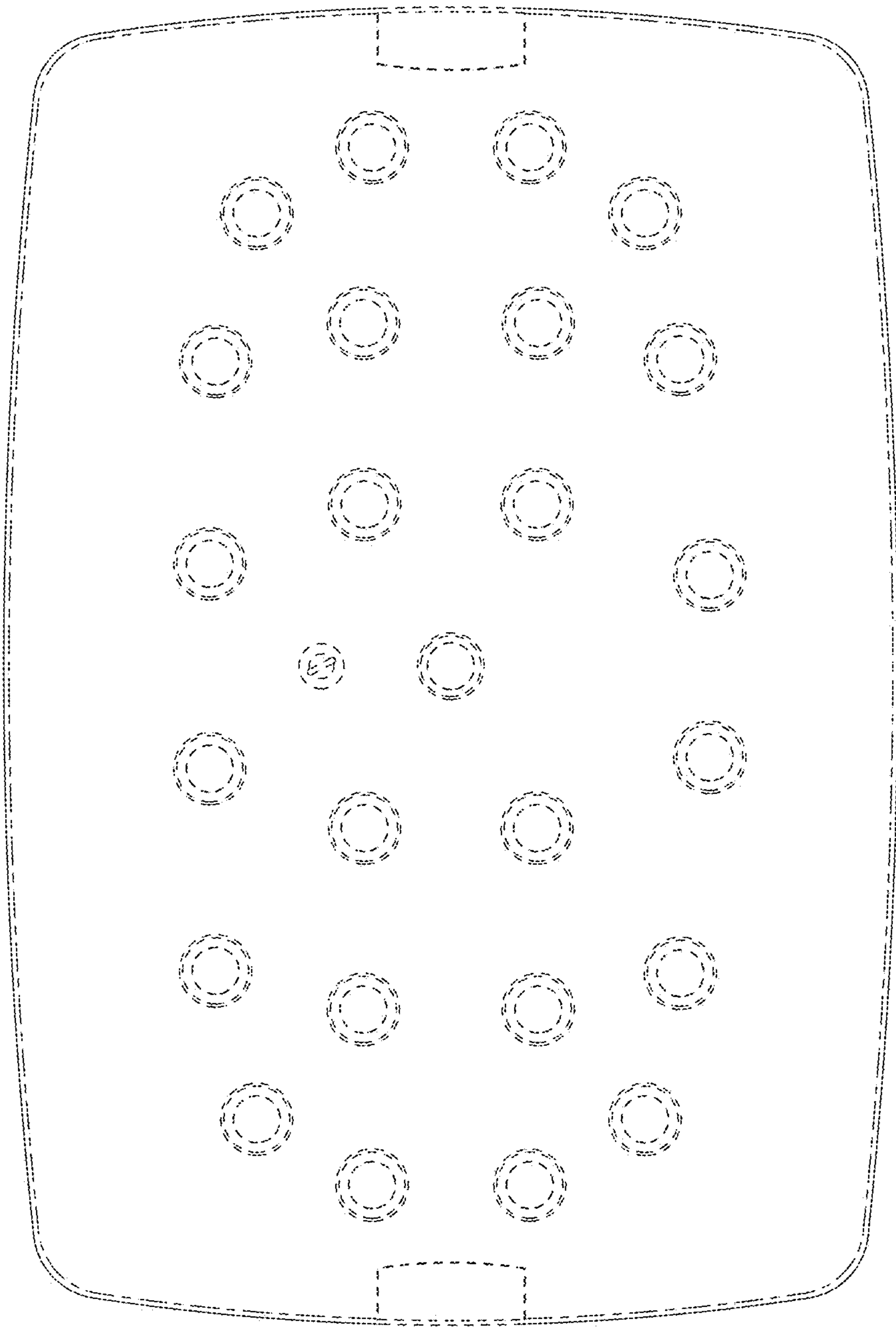
