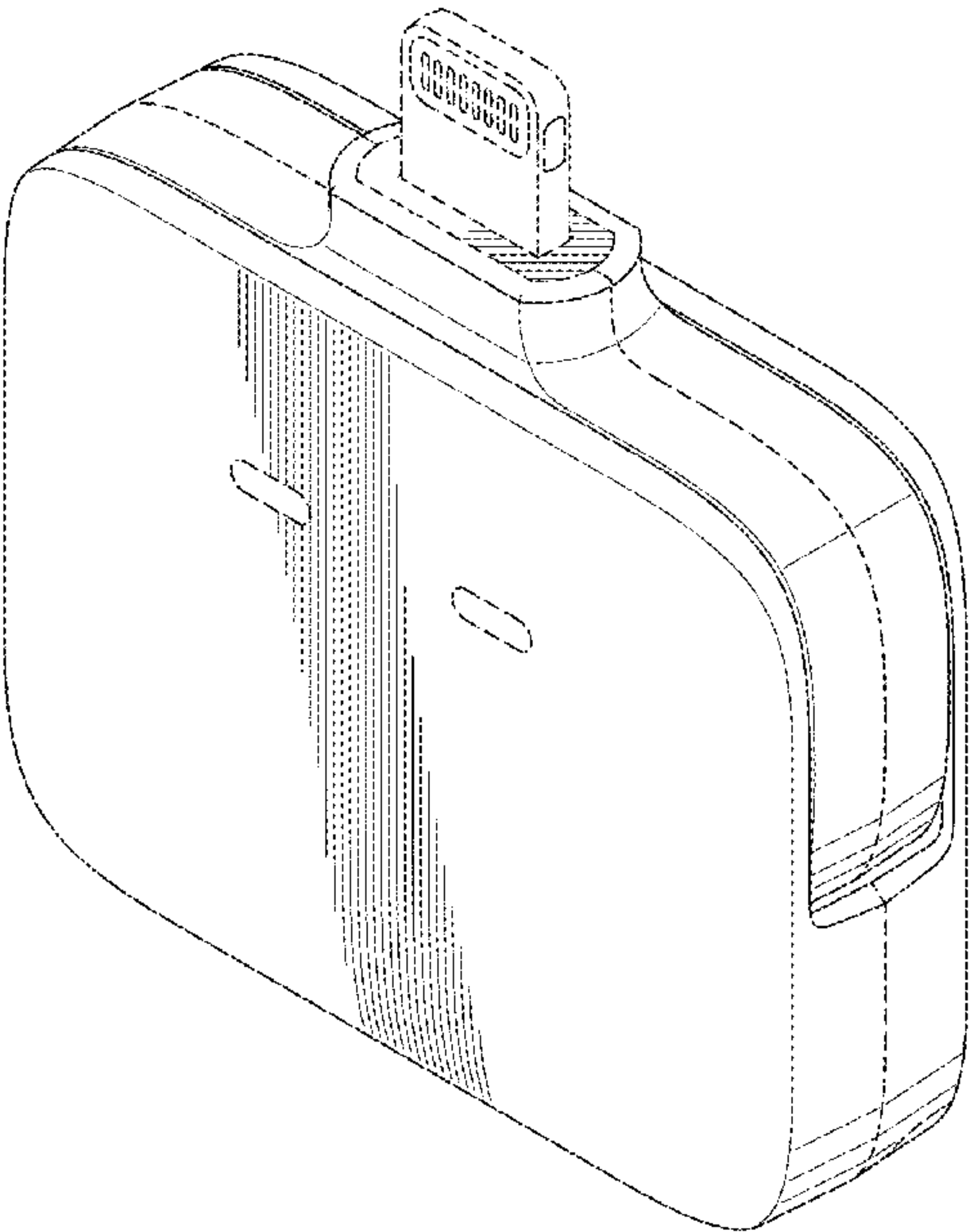
(57) CLAIM

The ornamental design for a wireless transmission receiver, as shown and described.

DESCRIPTION

FIG. 1 is a top front right side perspective view of a wireless transmission receiver according to our design;
FIG. 2 is a bottom back right side perspective view of the wireless transmission receiver;
FIG. 3 is a front side perspective view of the wireless transmission receiver;
FIG. 4 is a right side perspective view of the wireless transmission receiver;
FIG. 5 is a back side perspective view of the wireless transmission receiver;

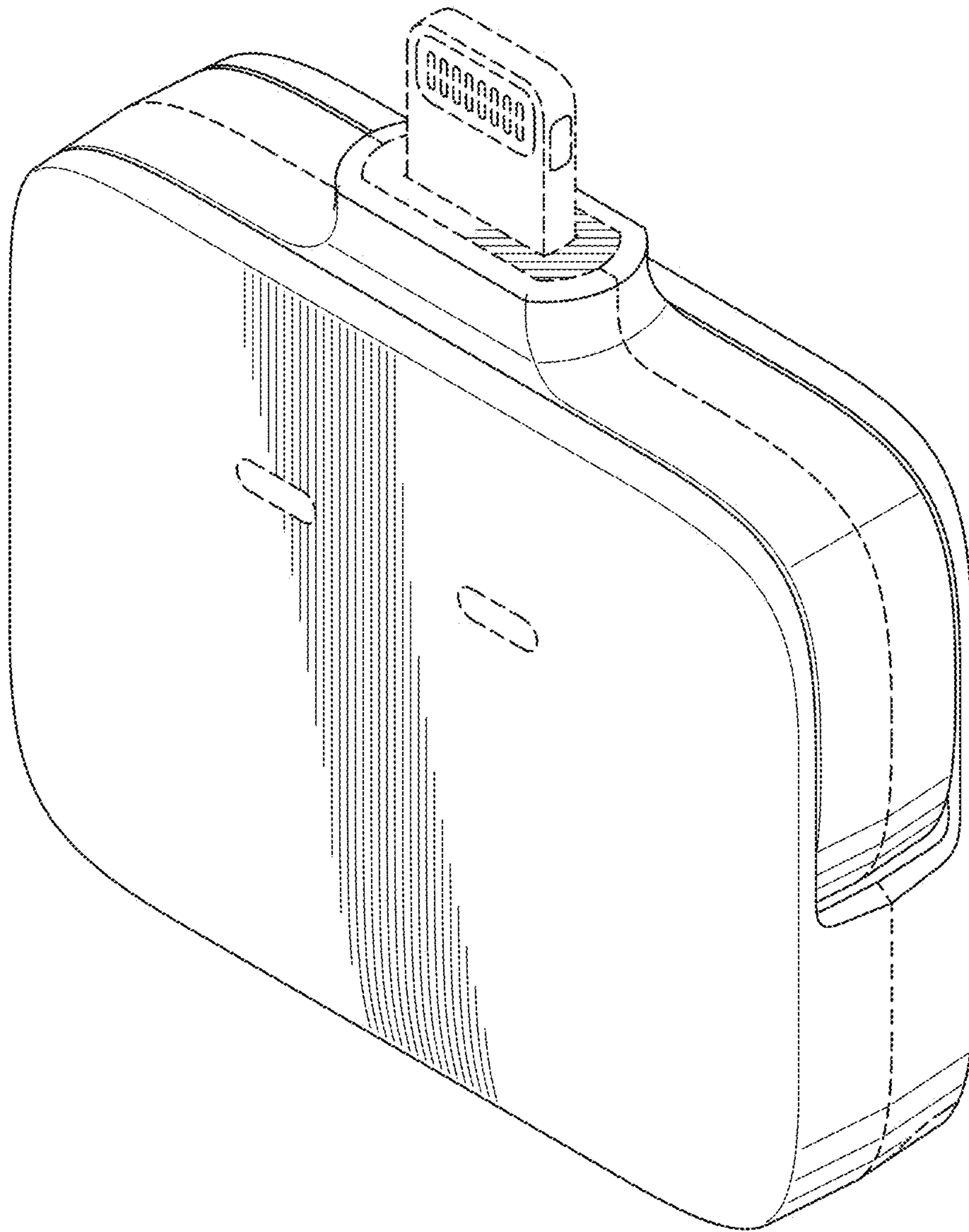

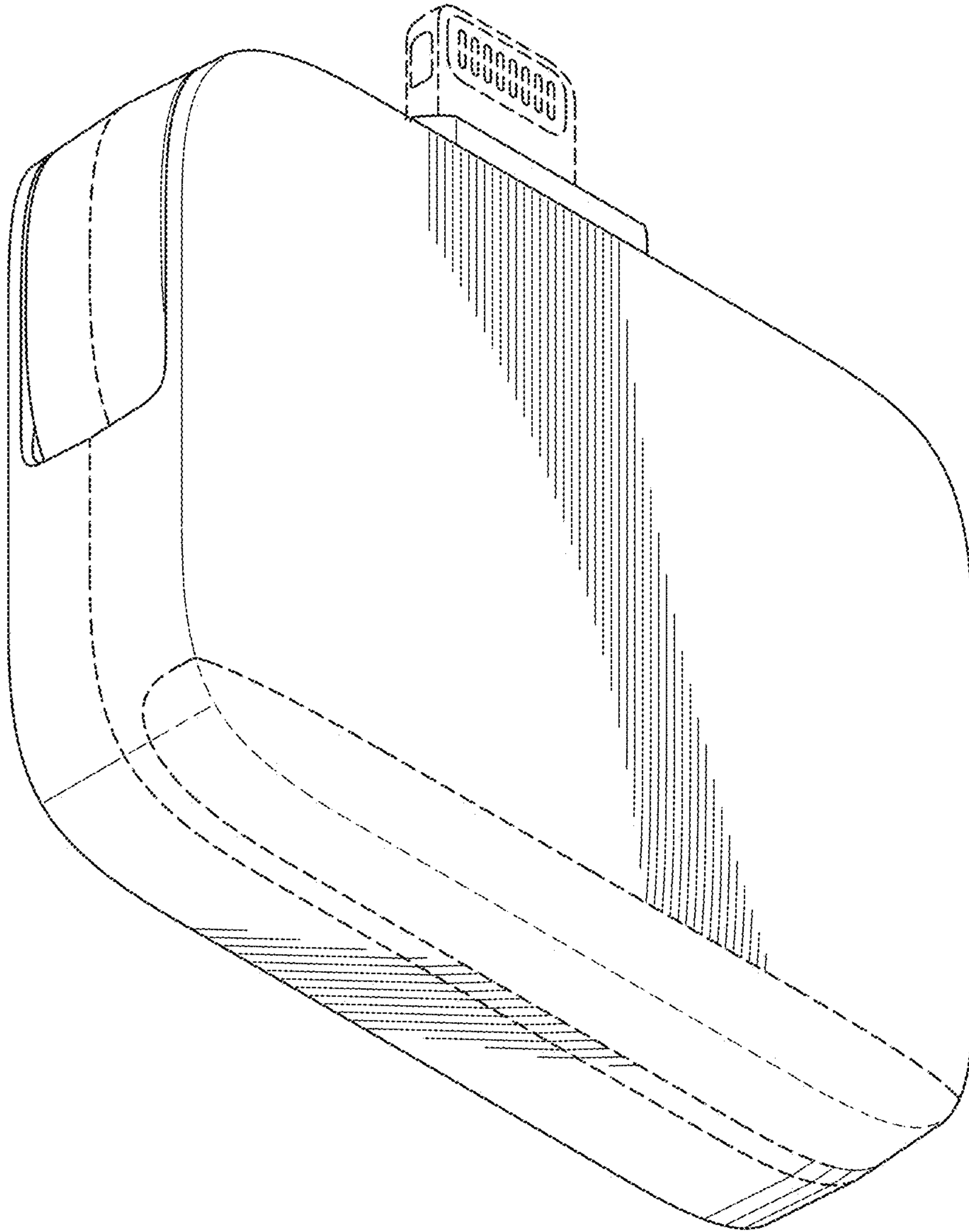

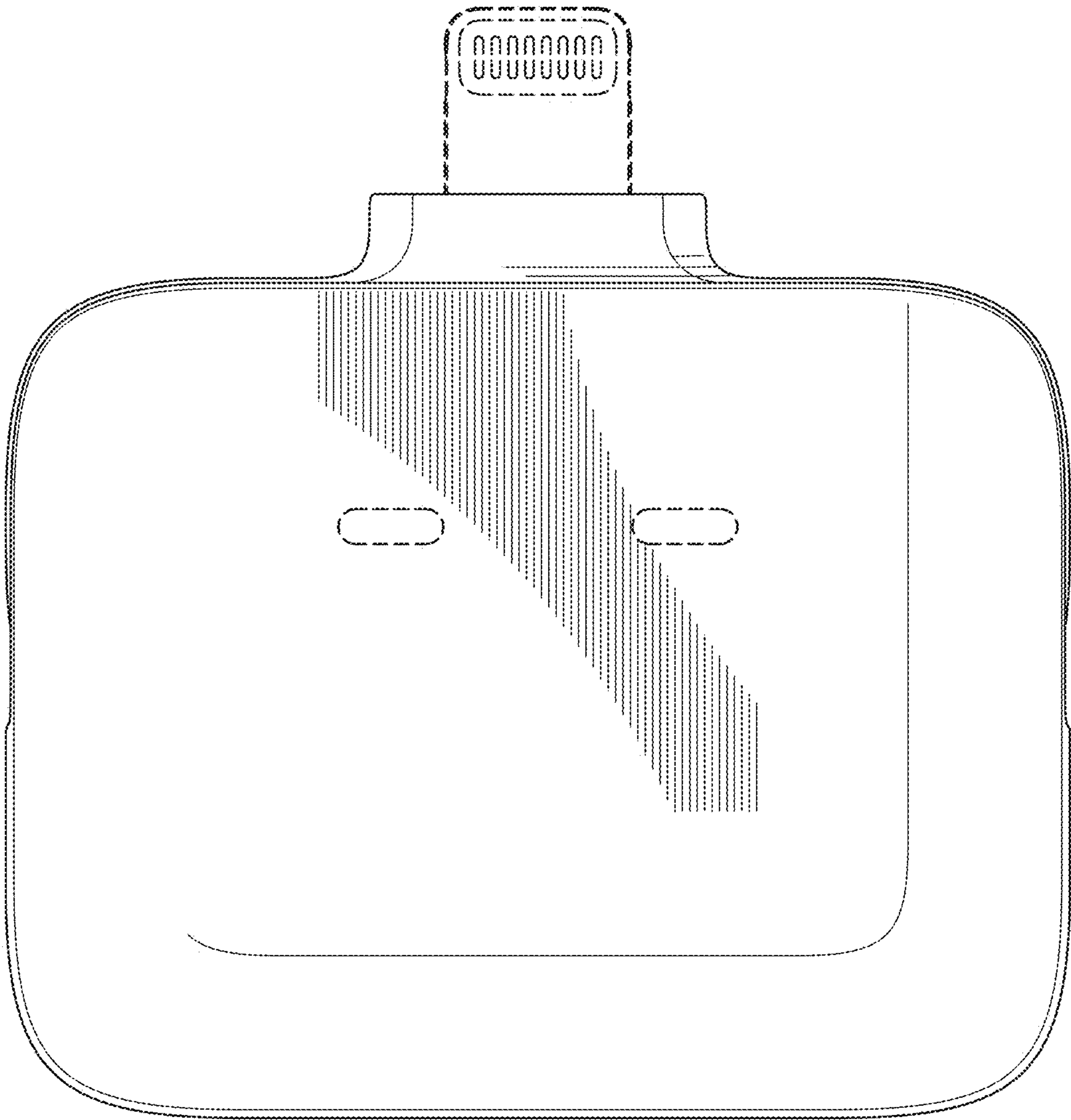

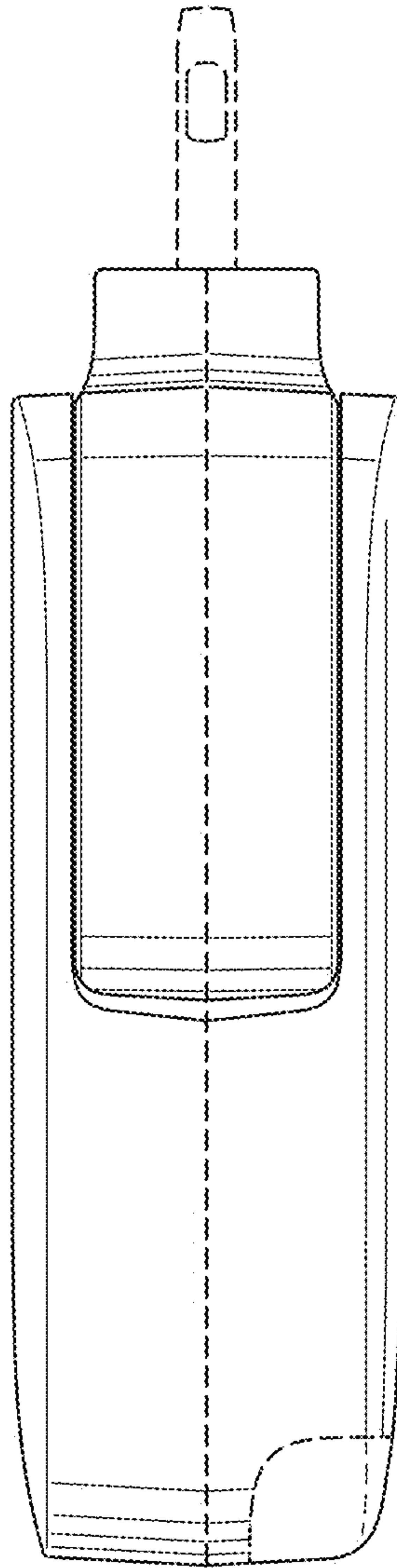

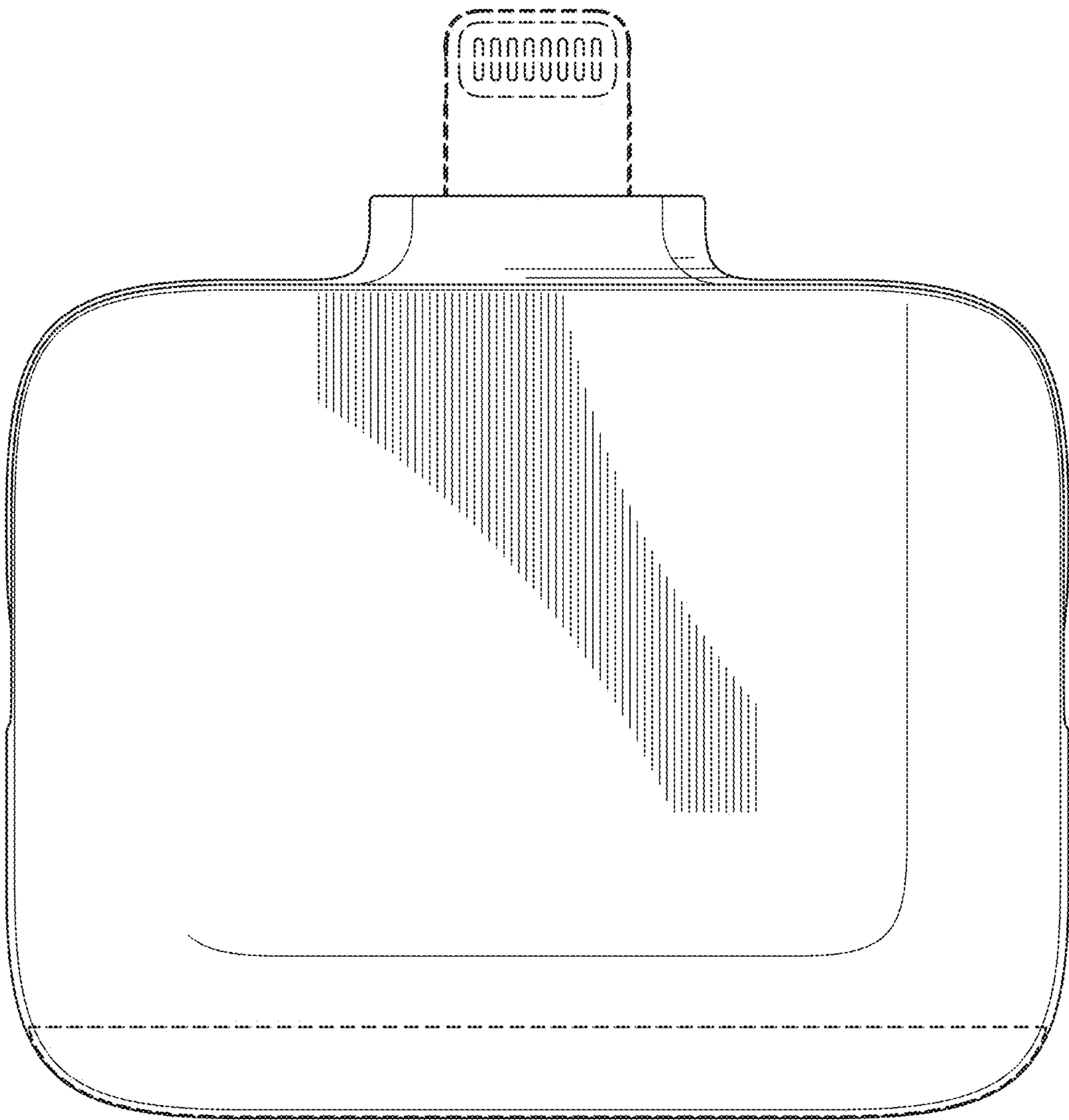

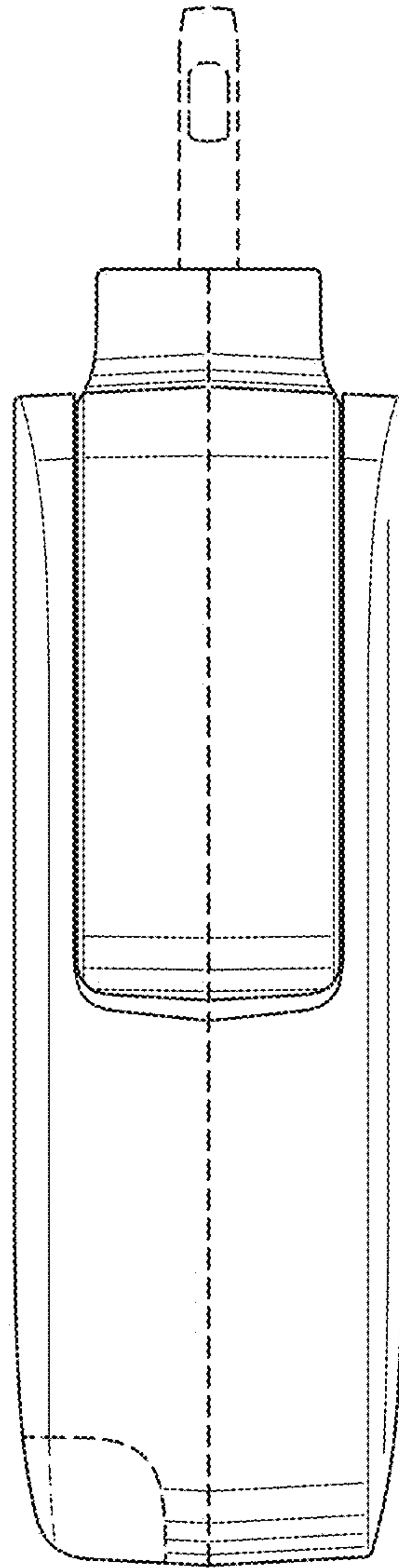

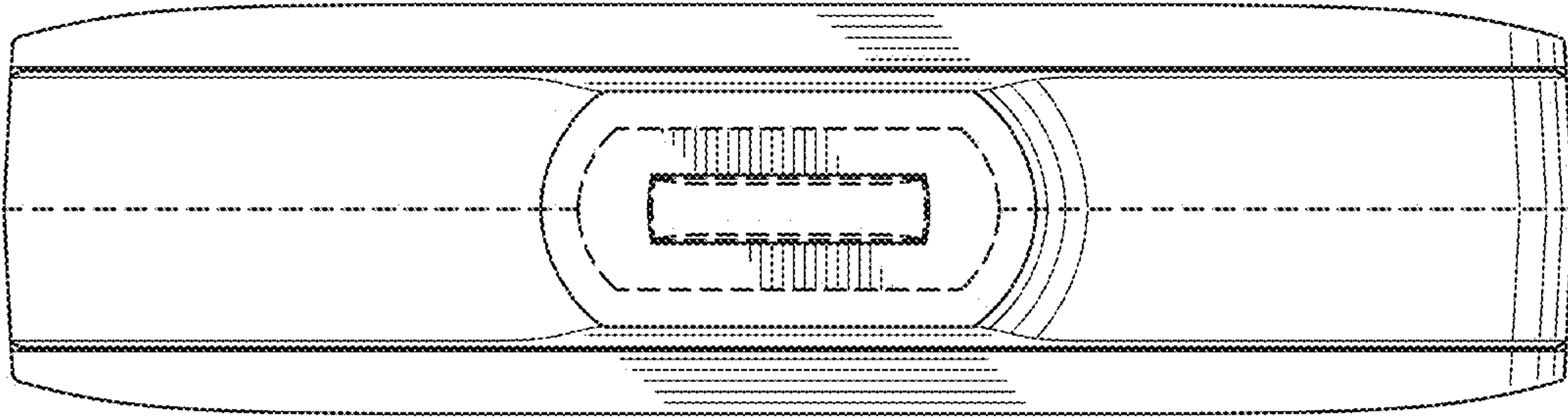

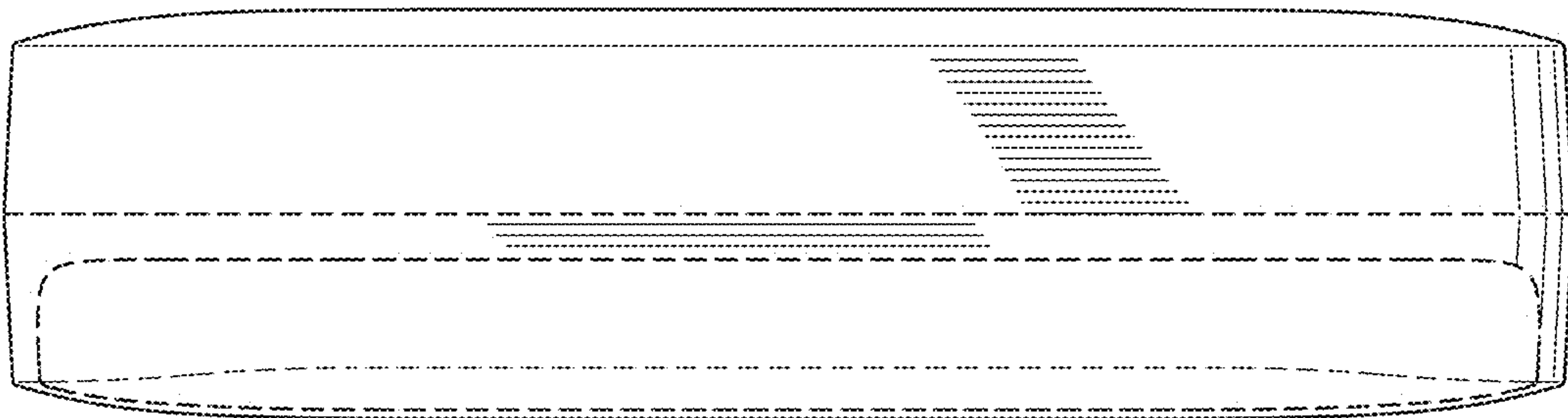
