The ornamental design for a static mixer, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a static mixer;
FIG. 2 is an end elevation view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is a cross-section view taken from line 5-5 of FIG. 3;
FIG. 6 is an enlarged detail view of portion 6 of FIG. 4; and,
FIG. 7 is a bottom perspective view of FIG. 1.

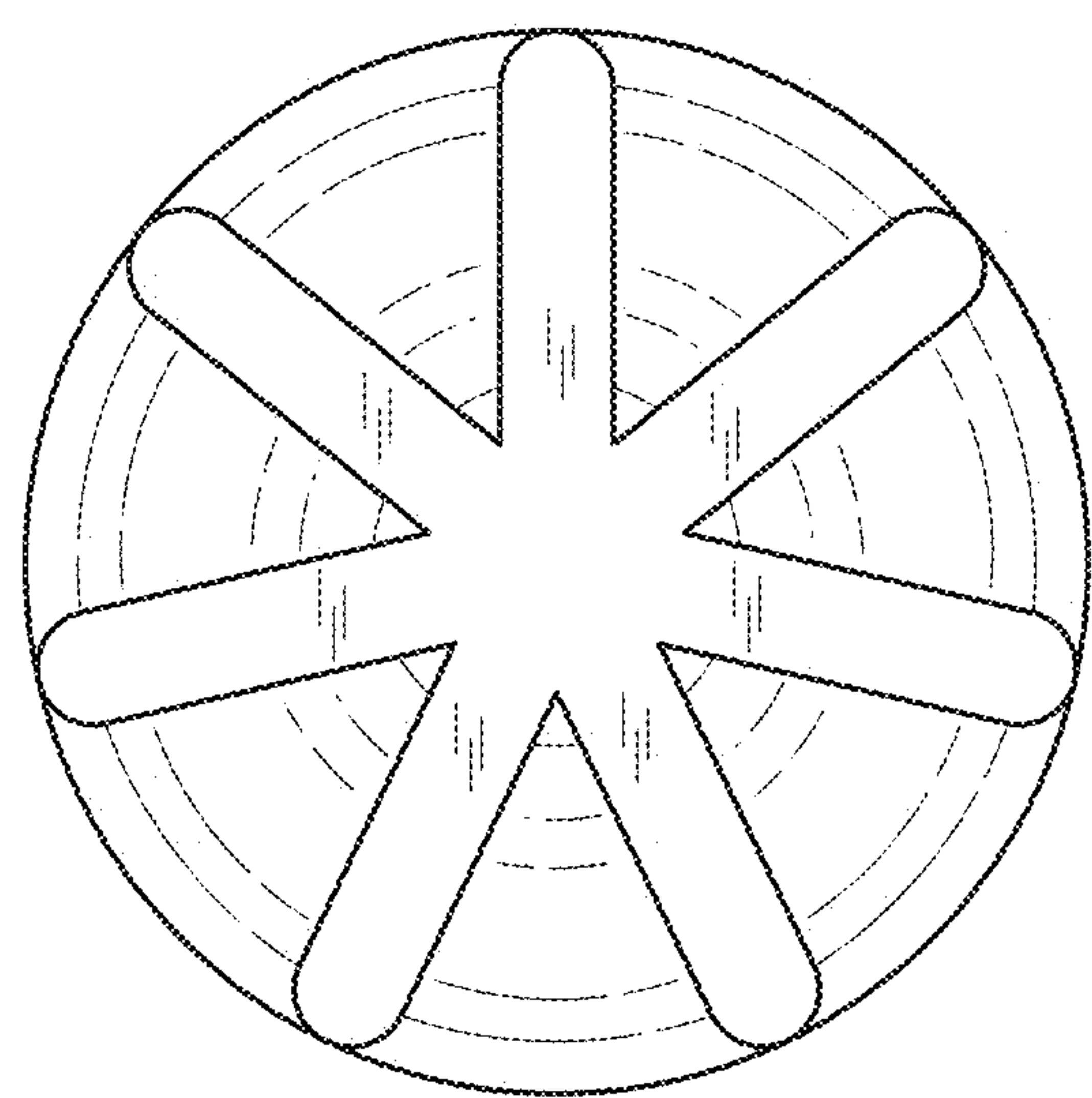

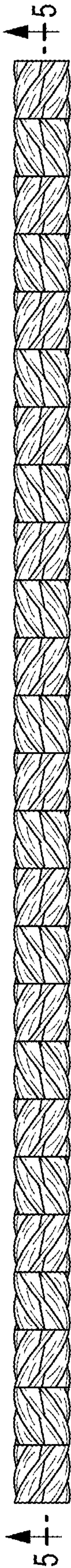

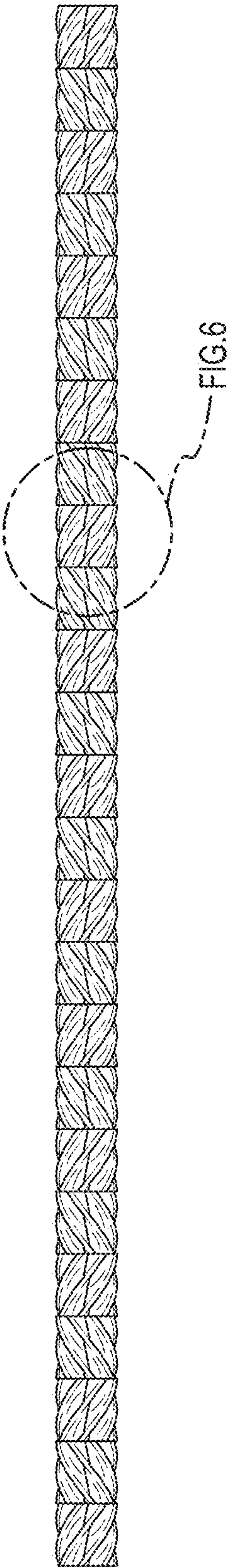

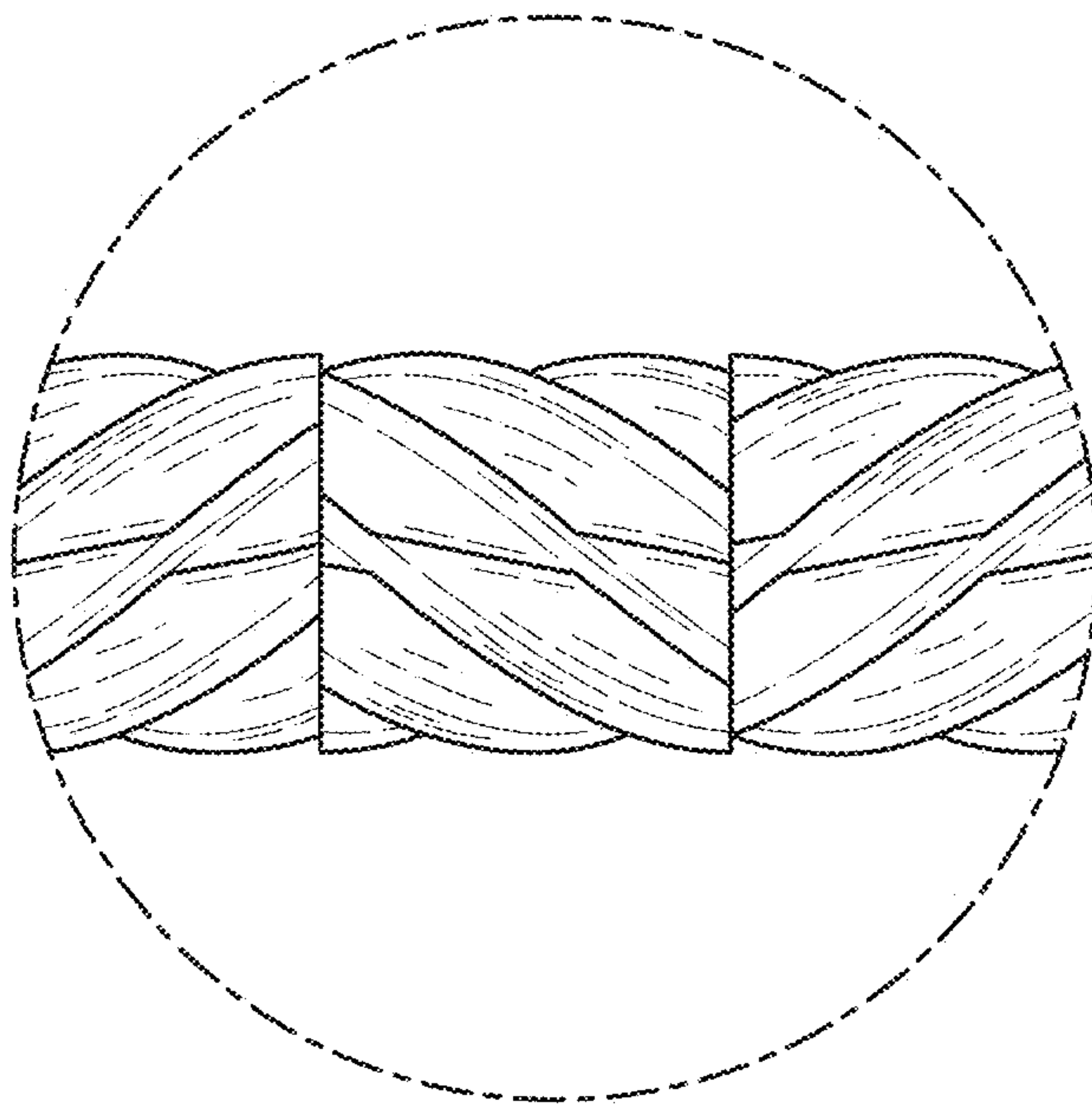

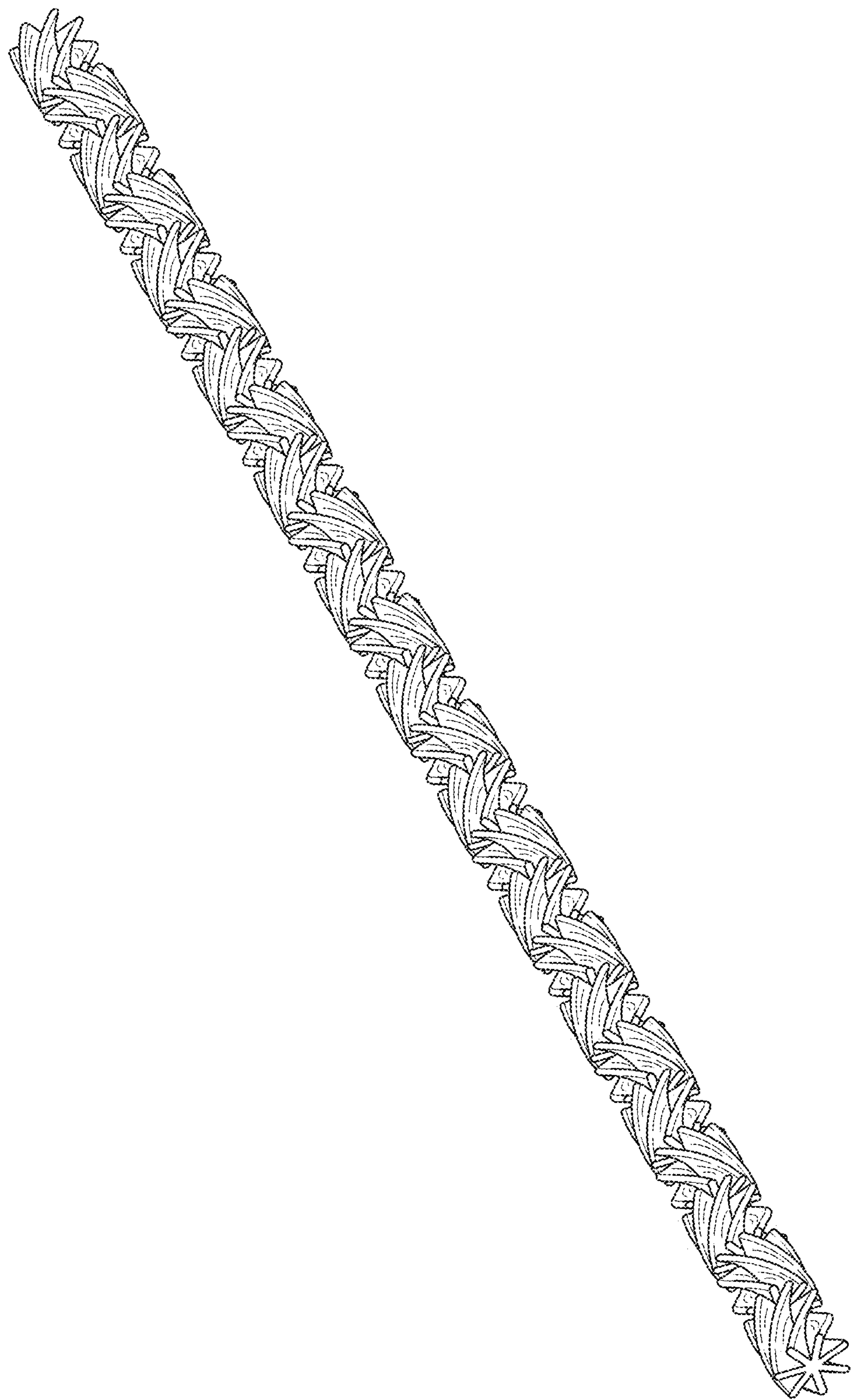
