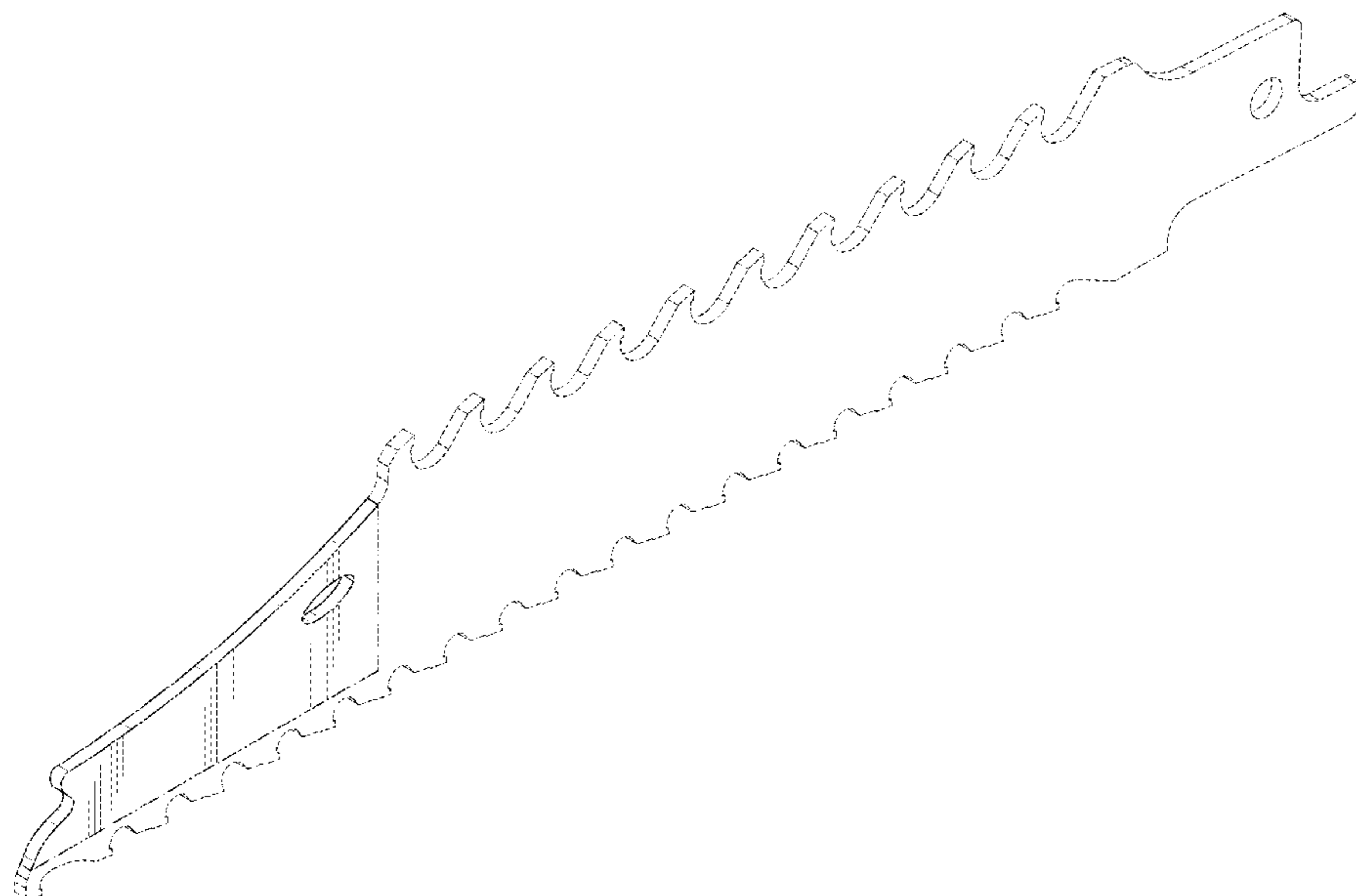
(57) **CLAIM**

The ornamental design for a saw blade, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a saw blade showing our new design.  
FIG. 2 is a left side elevational view of the saw blade of FIG. 1;  
FIG. 3 is a right side elevational view of the saw blade of FIG. 1;  
FIG. 4 is a front side elevational view of the saw blade of FIG. 1;  
FIG. 5 is a rear side elevational view of the saw blade of FIG. 1;  
FIG. 6 is a top side plan view of the saw blade of FIG. 1; and,  
FIG. 7 is a bottom side plan view of the saw blade of FIG. 1.  
The broken lines shown in the drawings illustrate portions of the saw blade that form no part of the claimed design. The dash-dot-dash lines depict boundaries of the claimed design and form no part of the claimed design.

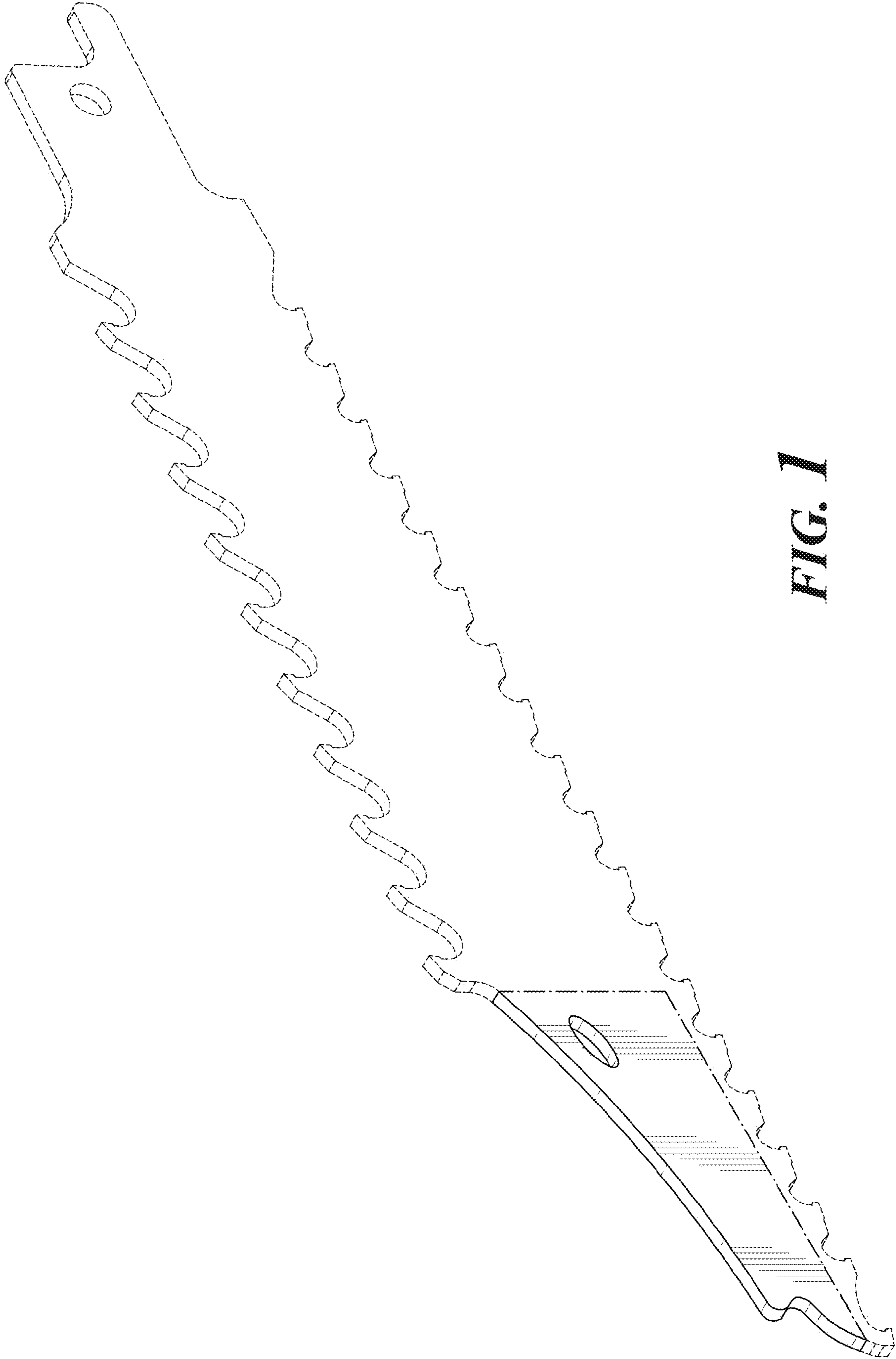

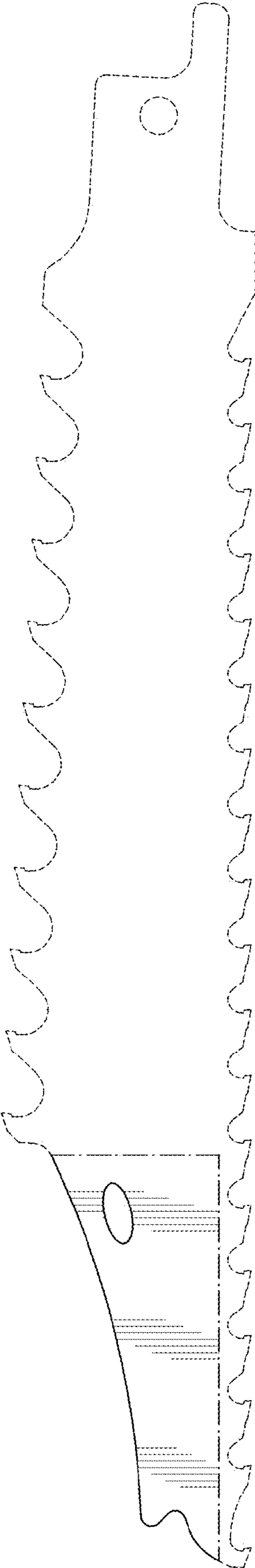

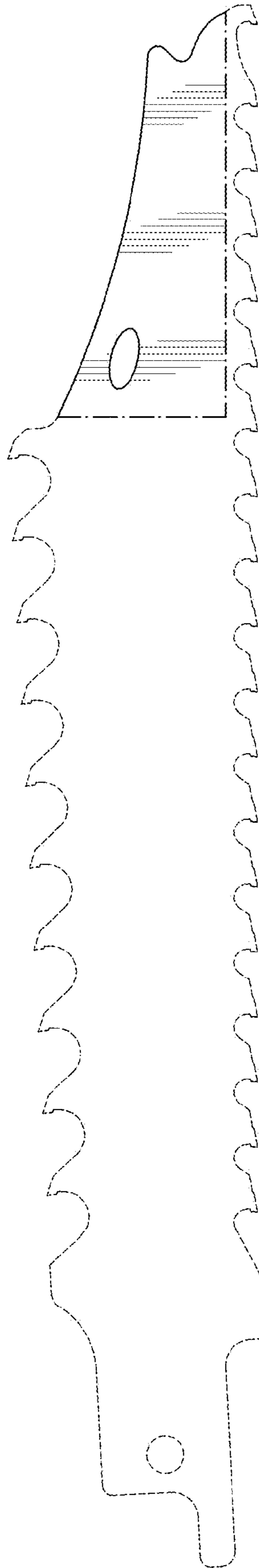

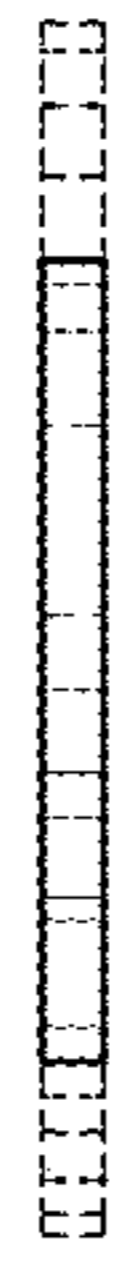

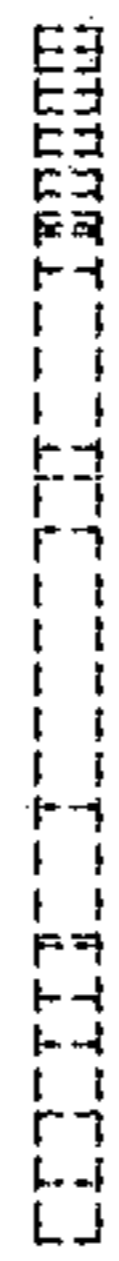

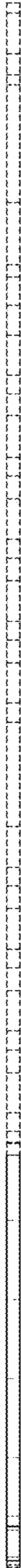

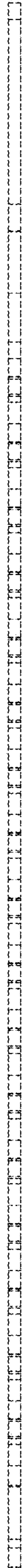
