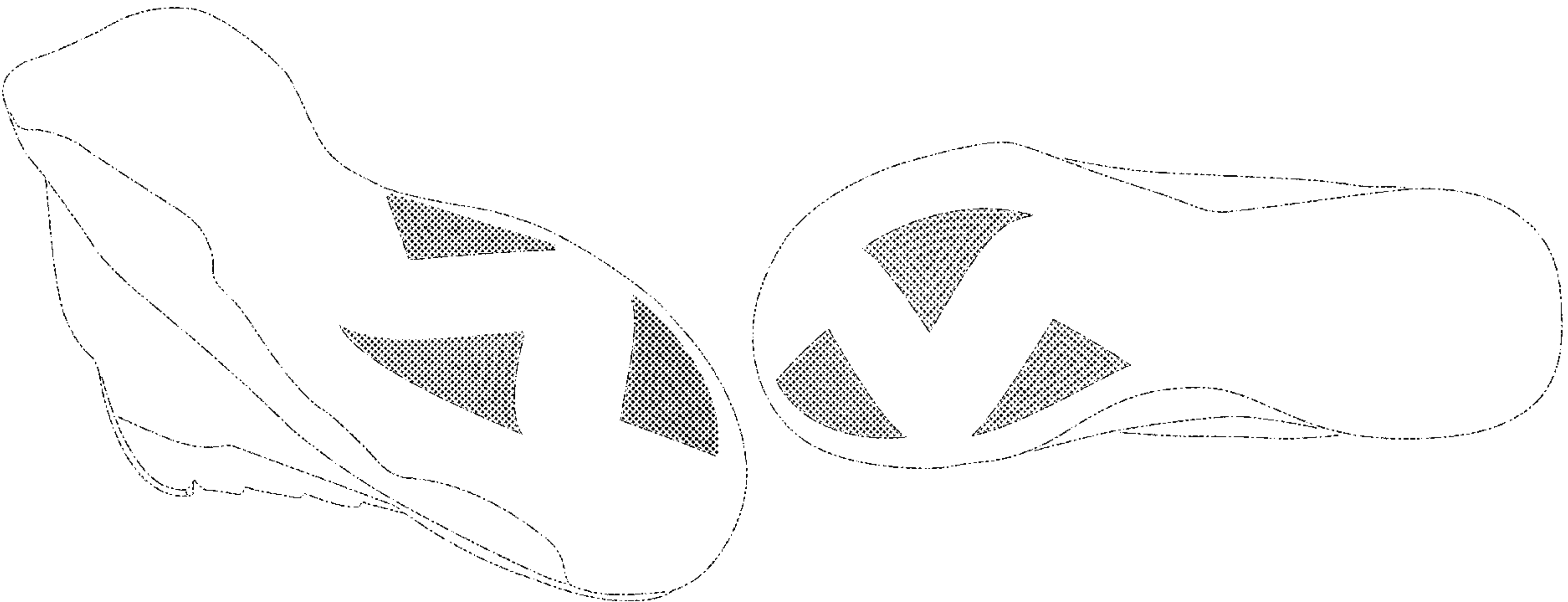
CLAIM

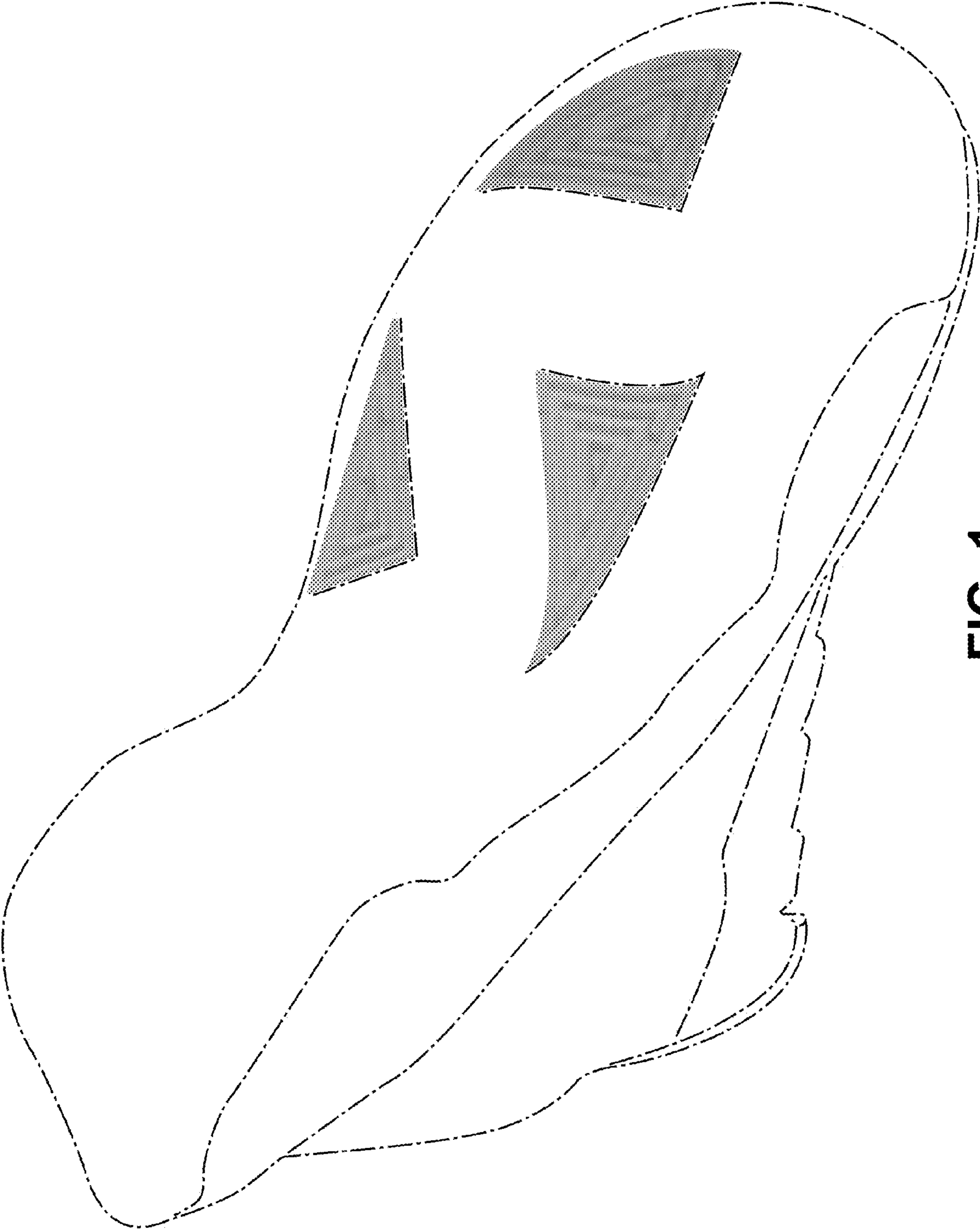

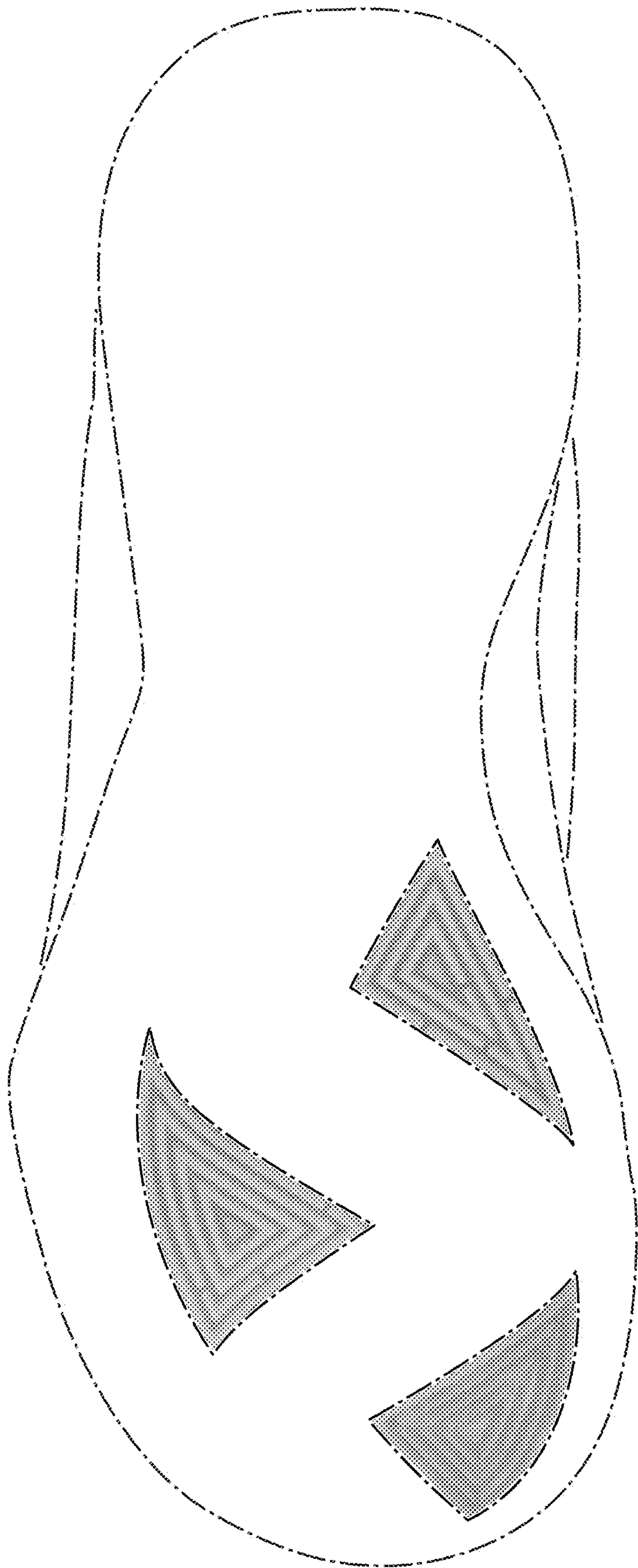

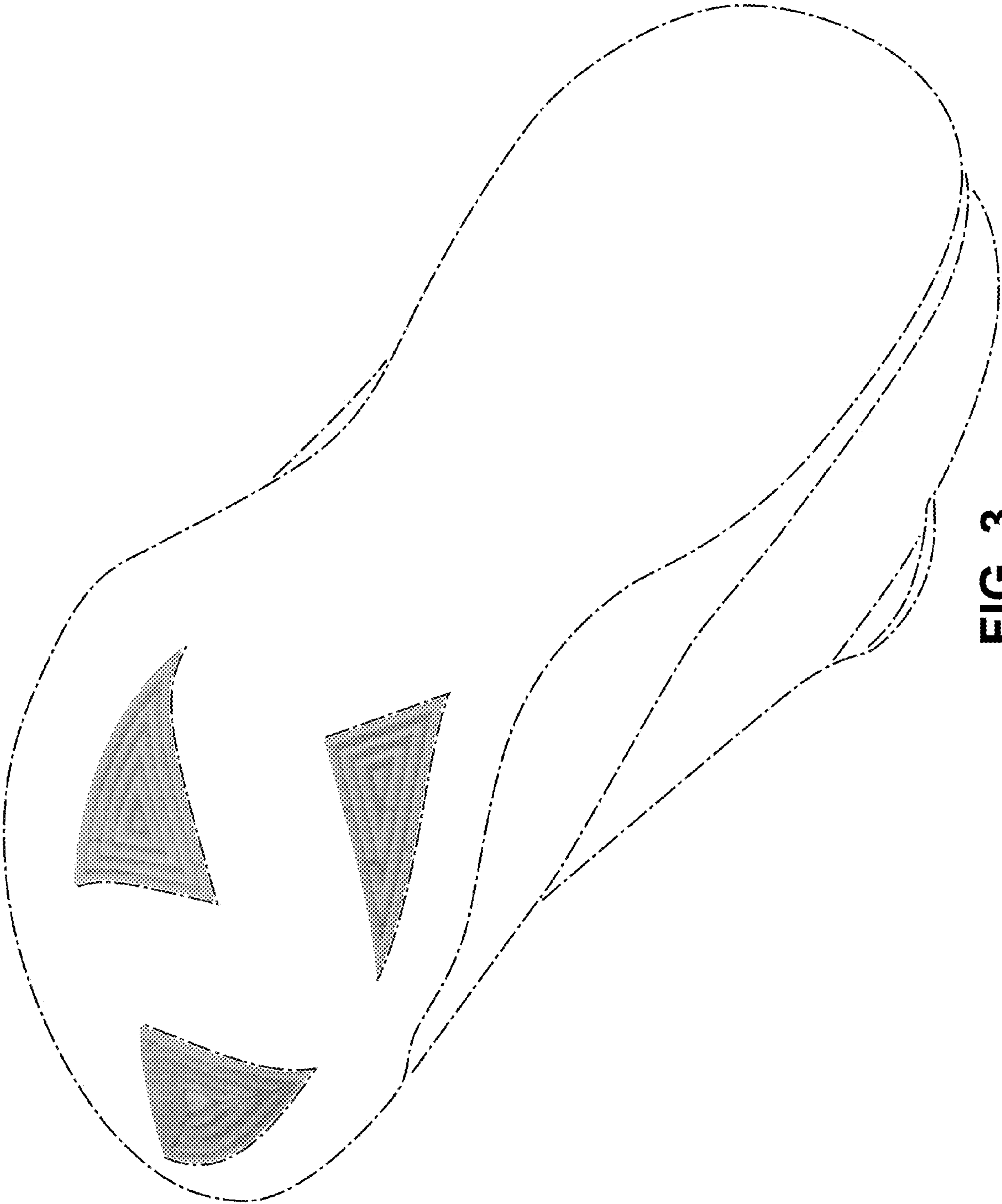
