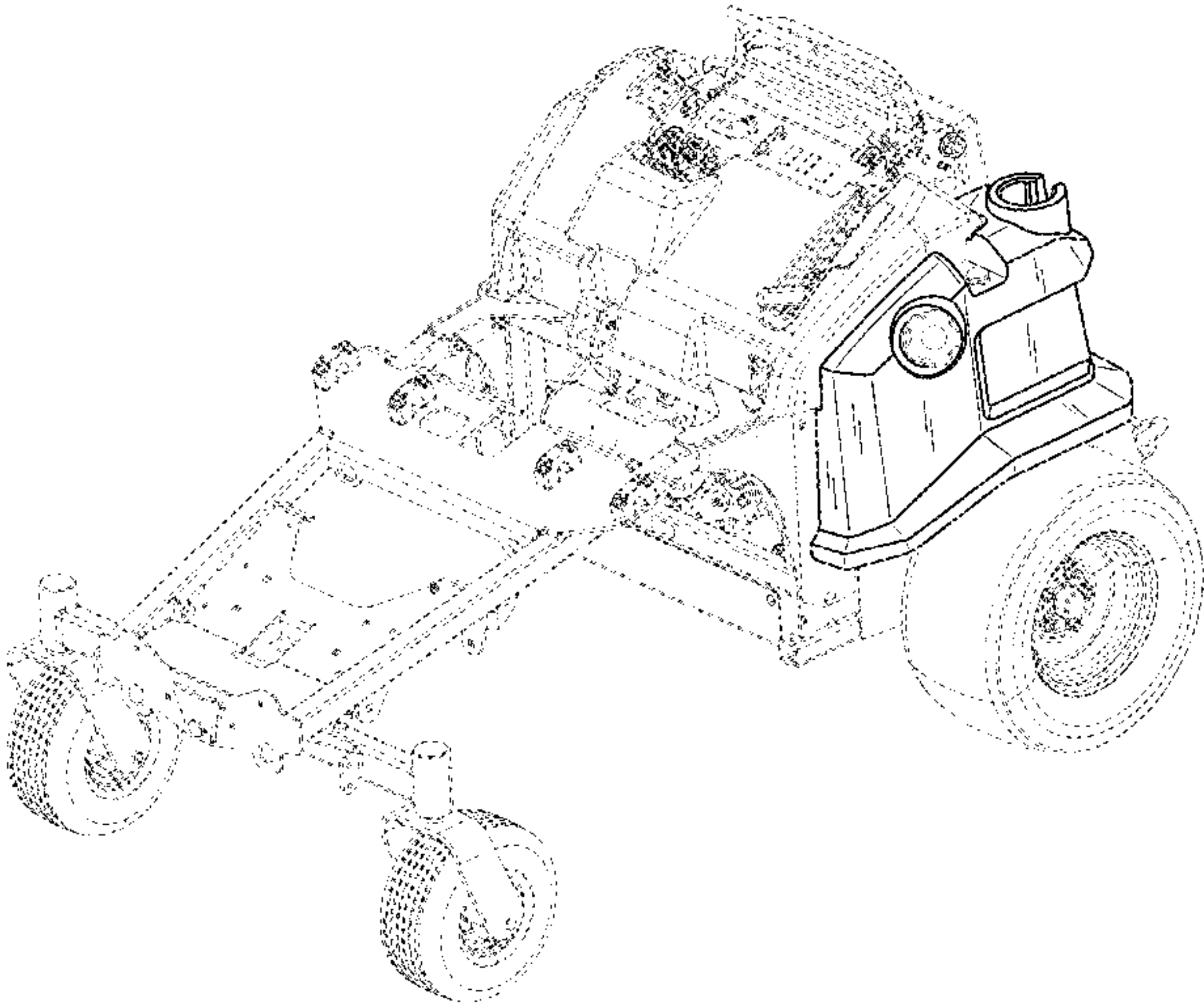
(57) CLAIM

The ornamental design for a tank for ground maintenance vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a top left front perspective view of a tank for ground maintenance vehicle in accordance with the claimed design, the tank for ground maintenance vehicle shown attached to a sports field groomer;
FIG. 2 is an isolated top left front perspective view of the design of FIG. 1;
FIG. 3 is a front elevation view of the design of FIG. 1;
FIG. 4 is a rear elevation view of the design of FIG. 1;
FIG. 5 is a left side elevation view of the design of FIG. 1;
FIG. 6 is a top plan view of the design of FIG. 1; and,
FIG. 7 is a bottom plan view of the design of FIG. 1.
The right side elevation view is omitted as it forms no part of the claimed design and/or is cumulative in view of the remaining figures.
The dash-dash broken lines in the figures represent unclaimed subject matter and form no part of the claimed design.
The dot-dash broken lines in the figures represent a boundary between claimed and unclaimed subject matter and form no part of the claimed design.
The labels used herein to describe orientation (e.g., front, rear, top, bottom, left, right) are merely for reference and are not intended to limit the scope of the design.

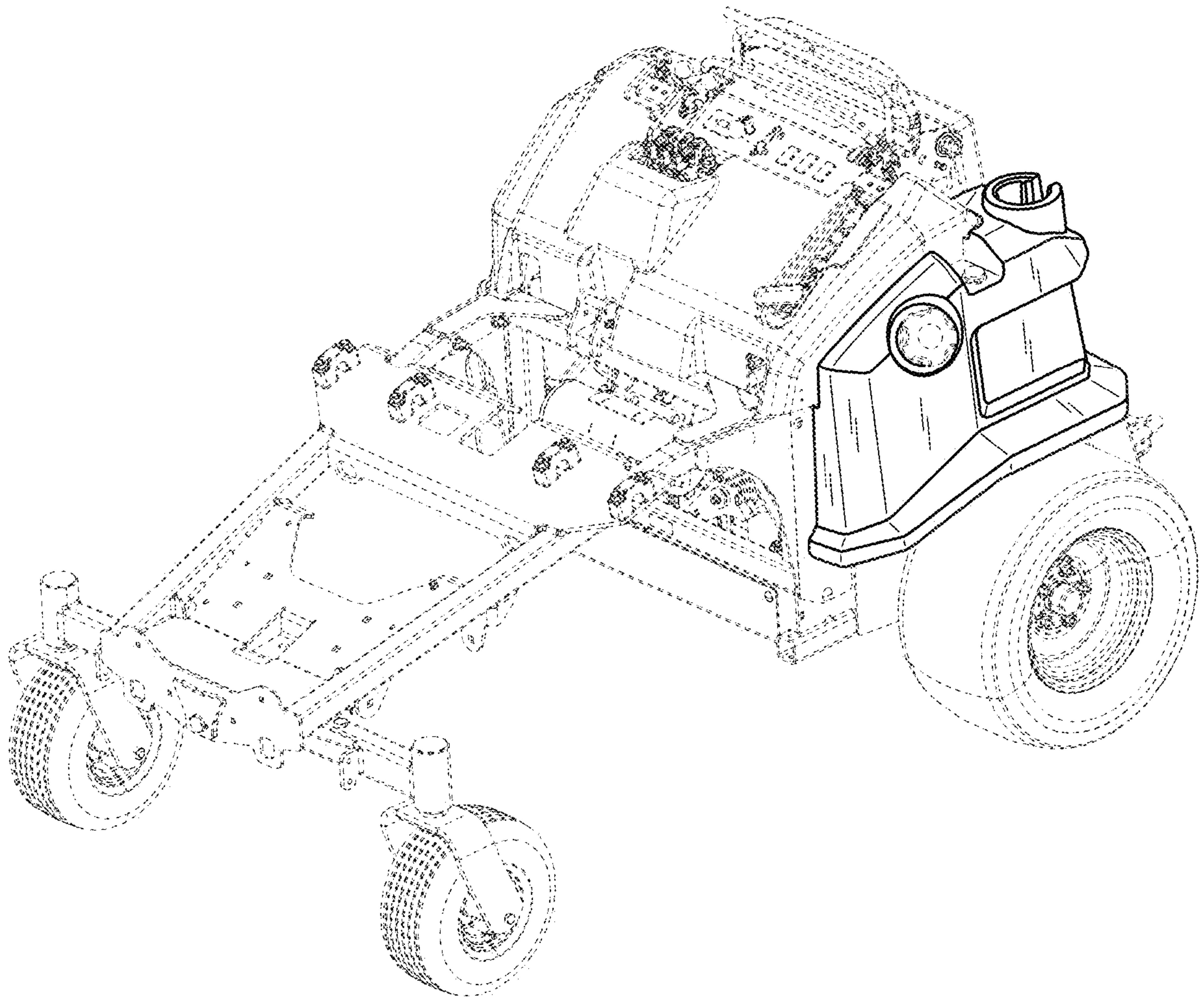

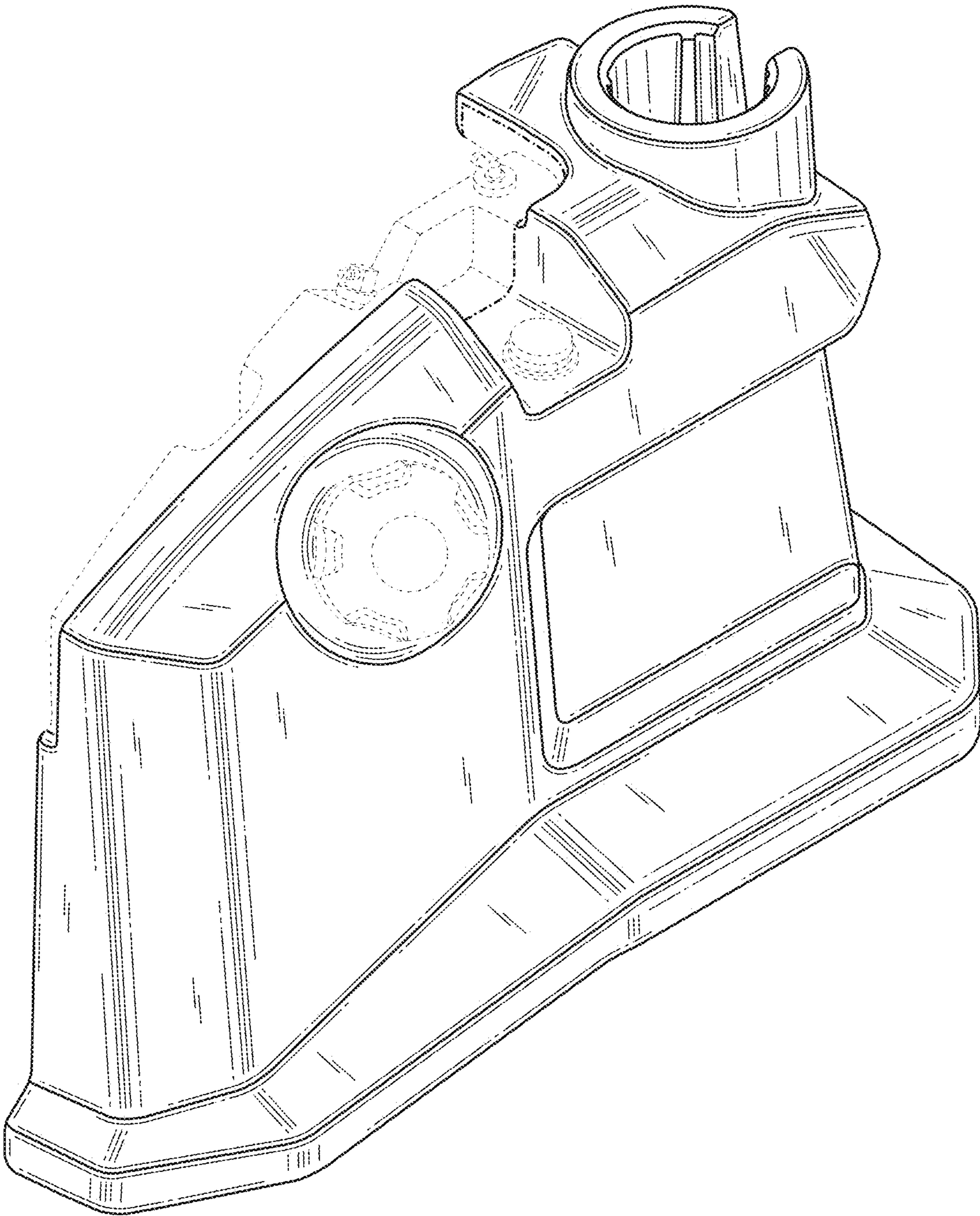

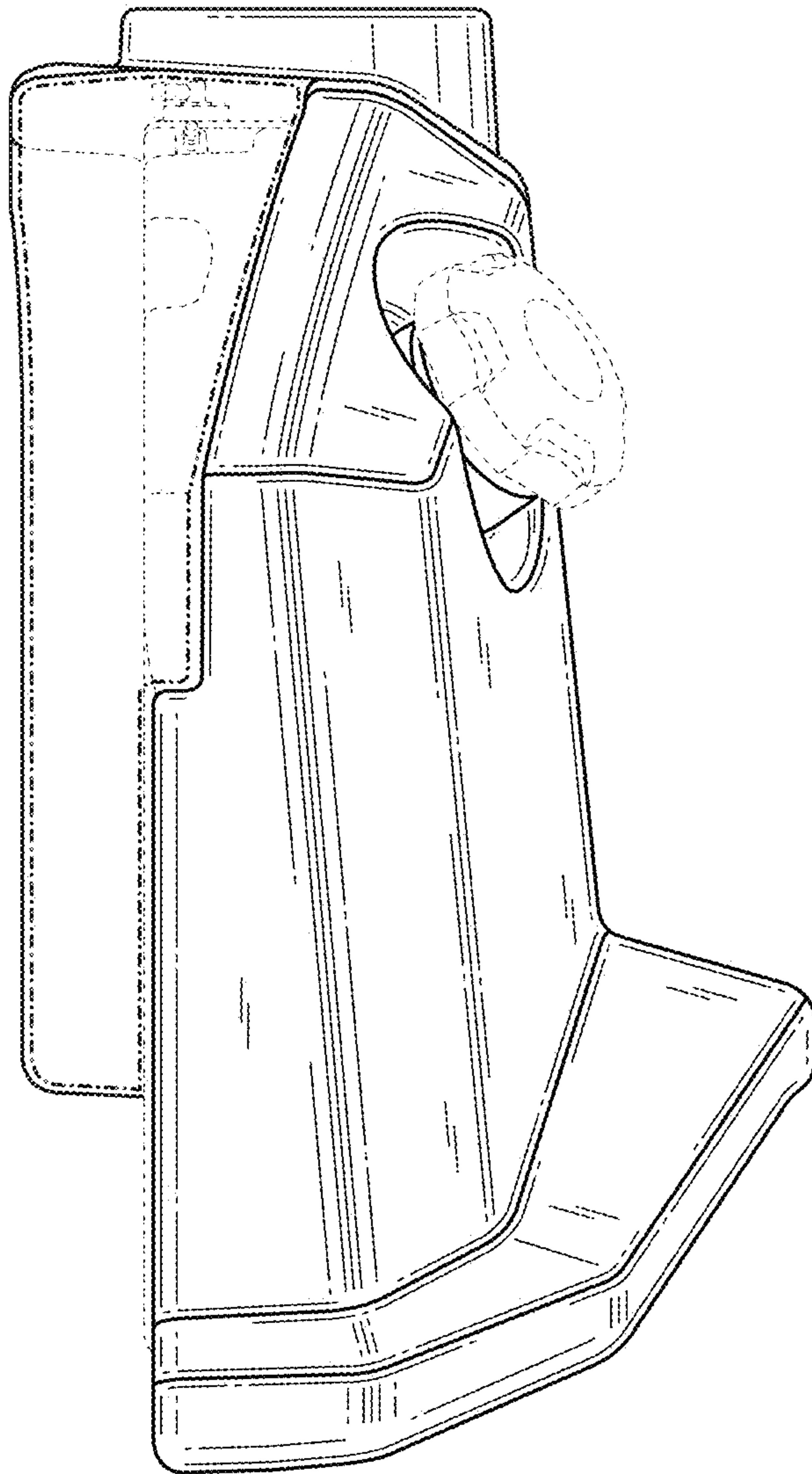

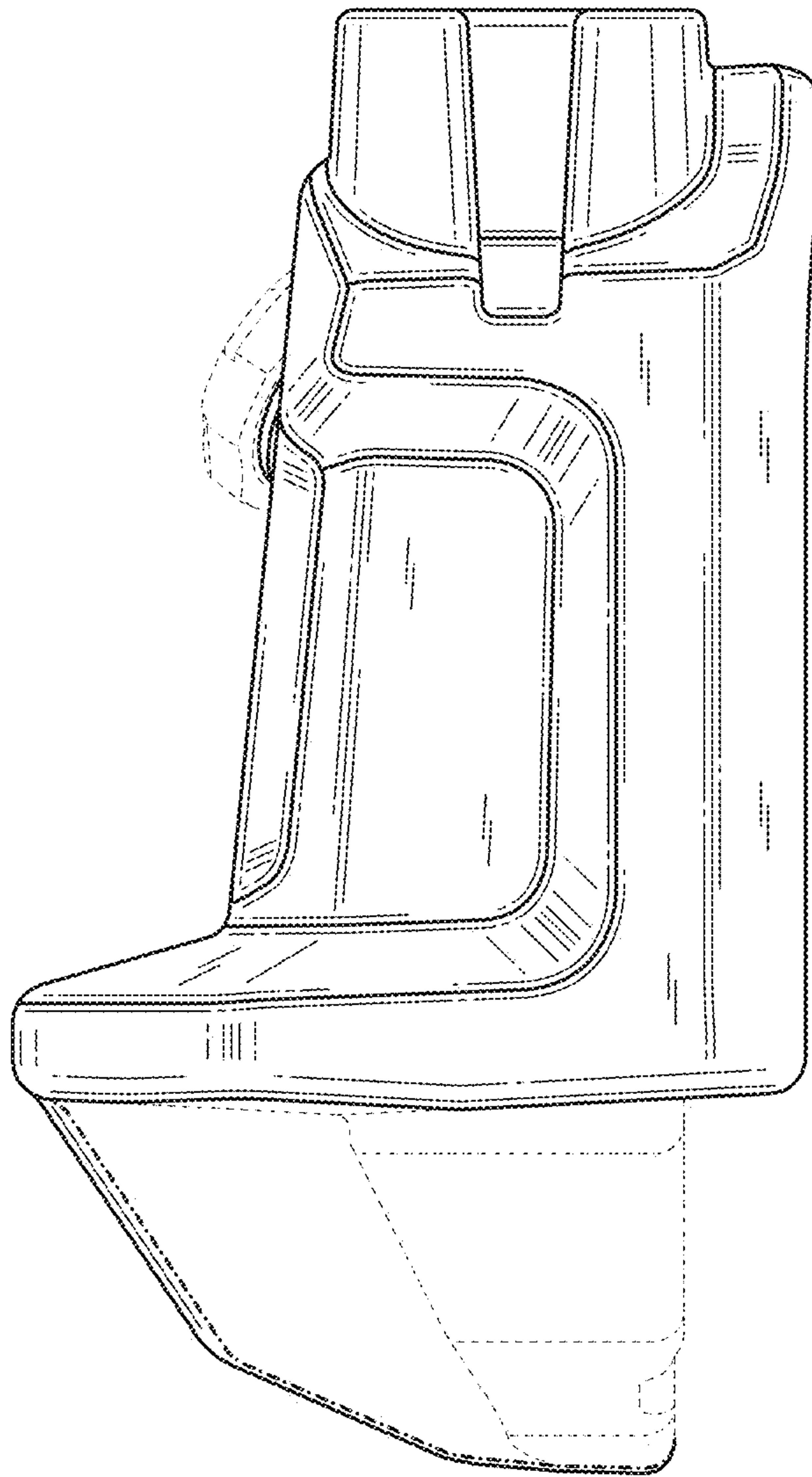

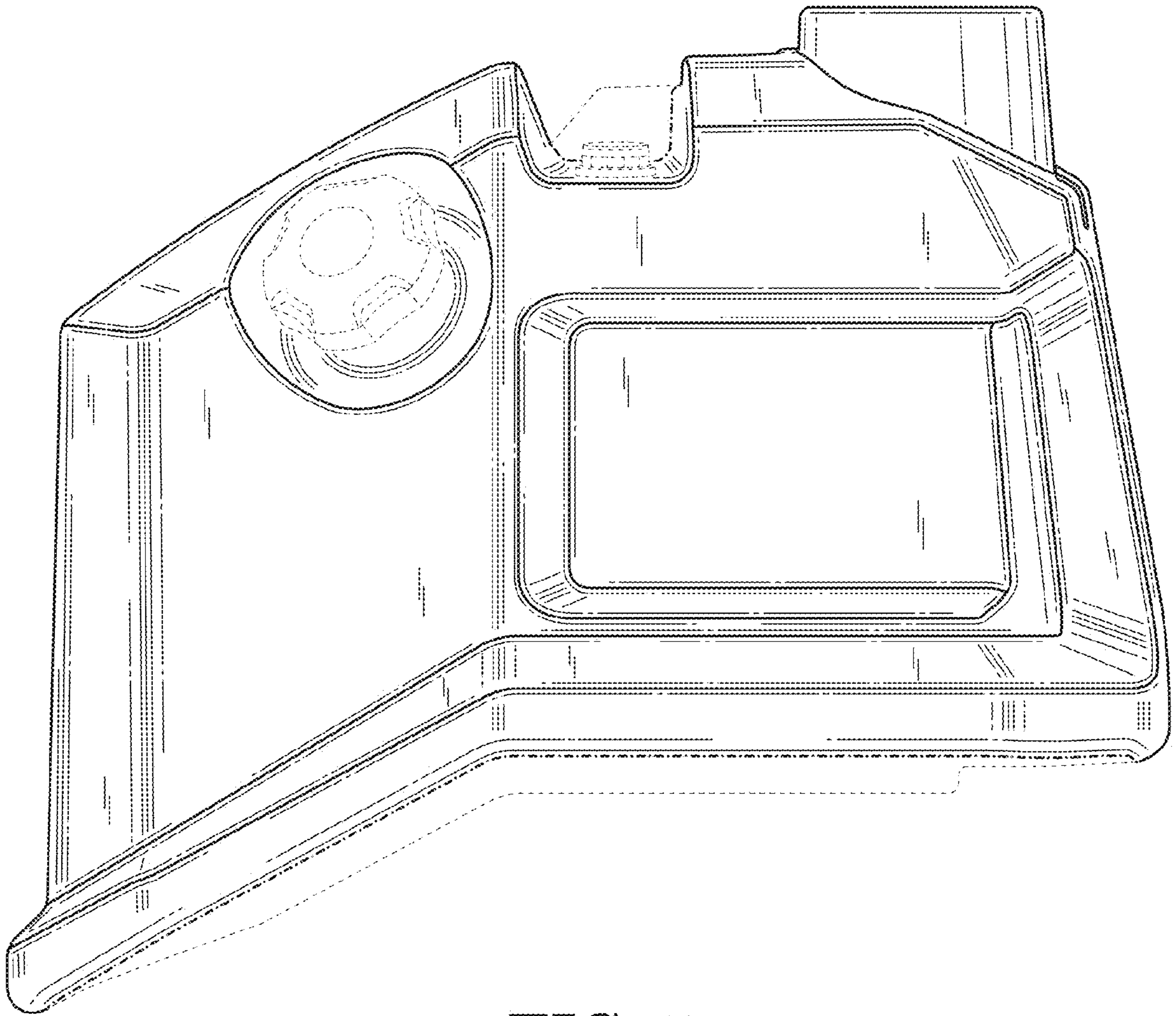

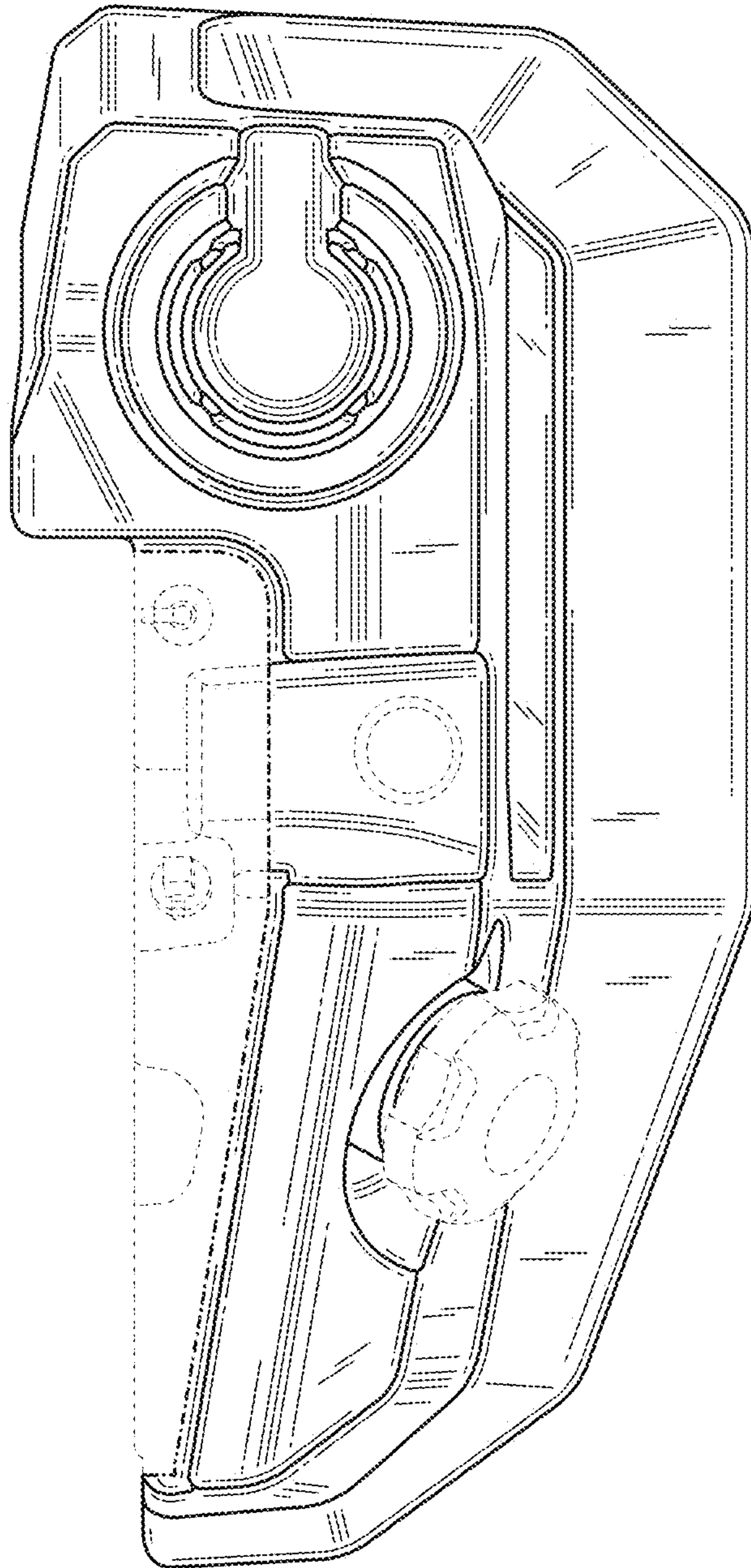

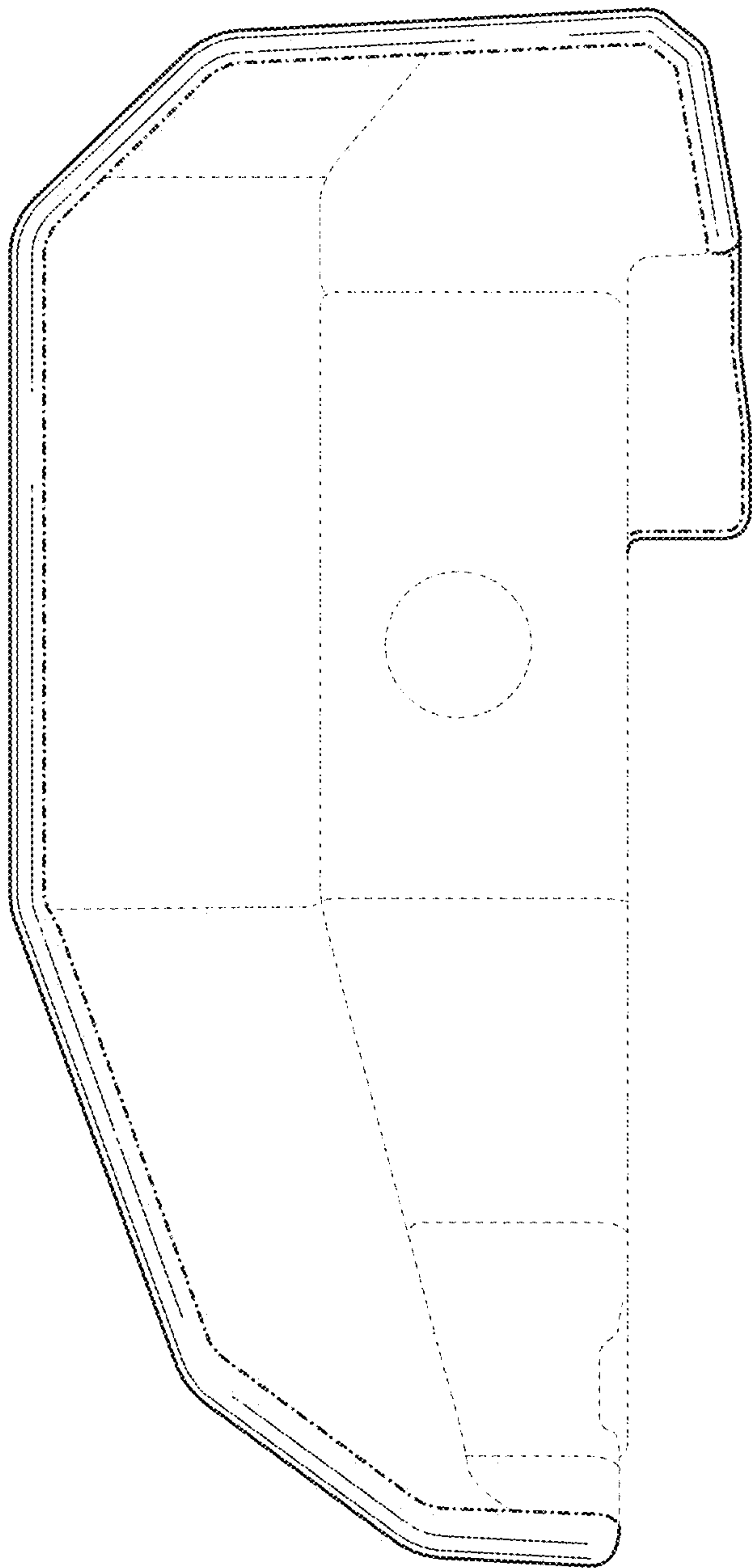
