The ornamental design for a business card, as shown and described.

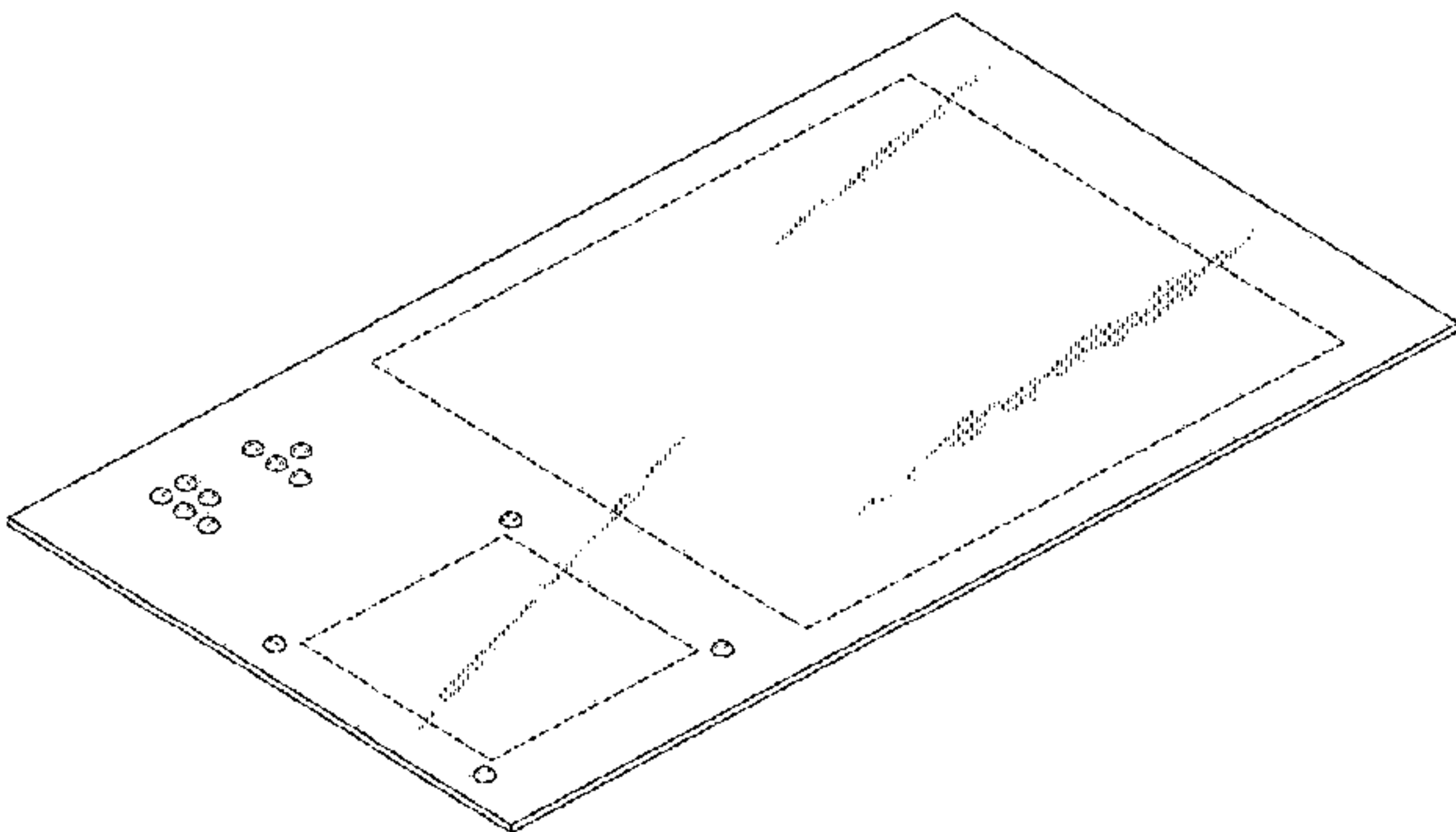
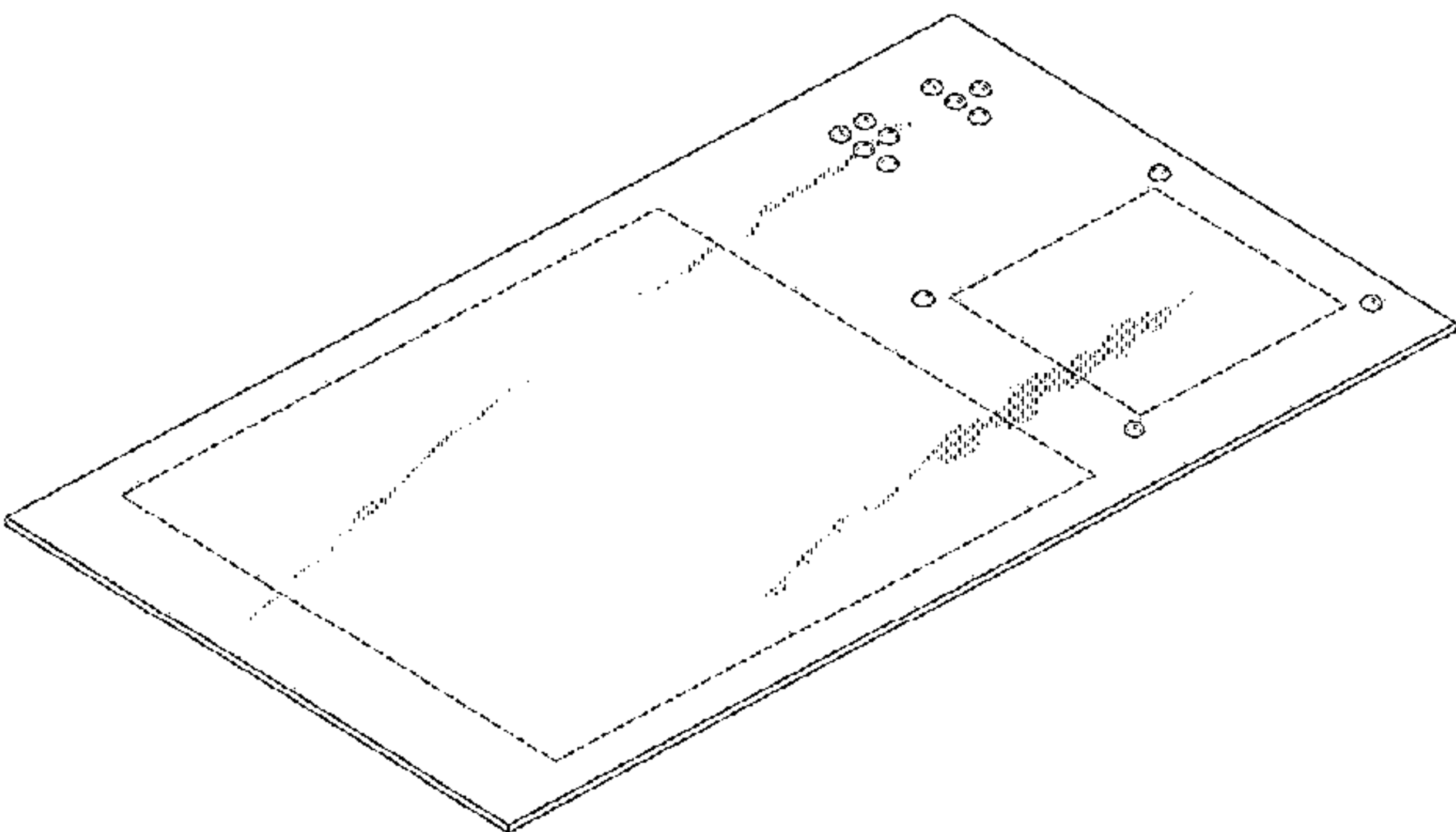
DESCRIPTION

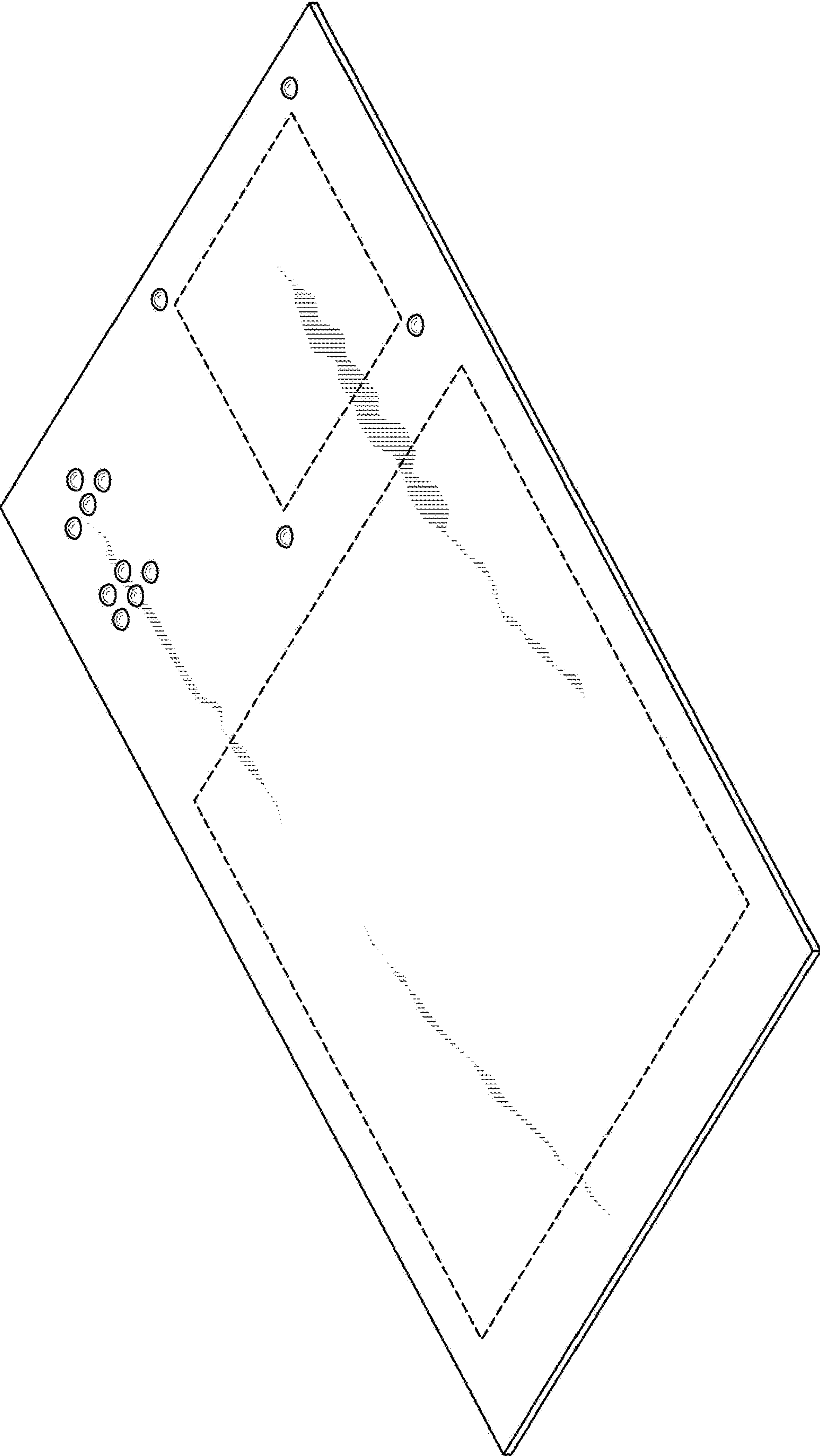

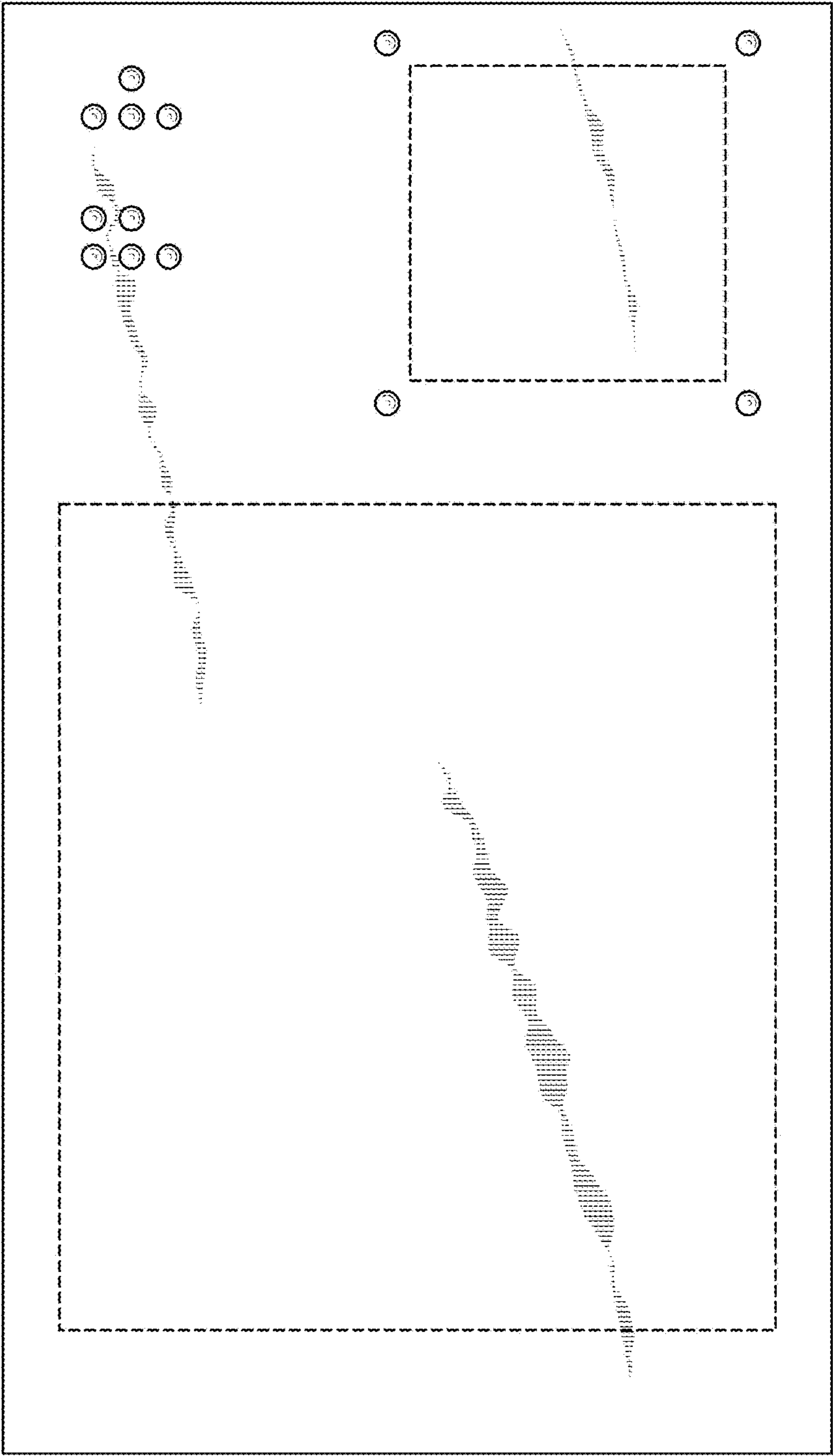

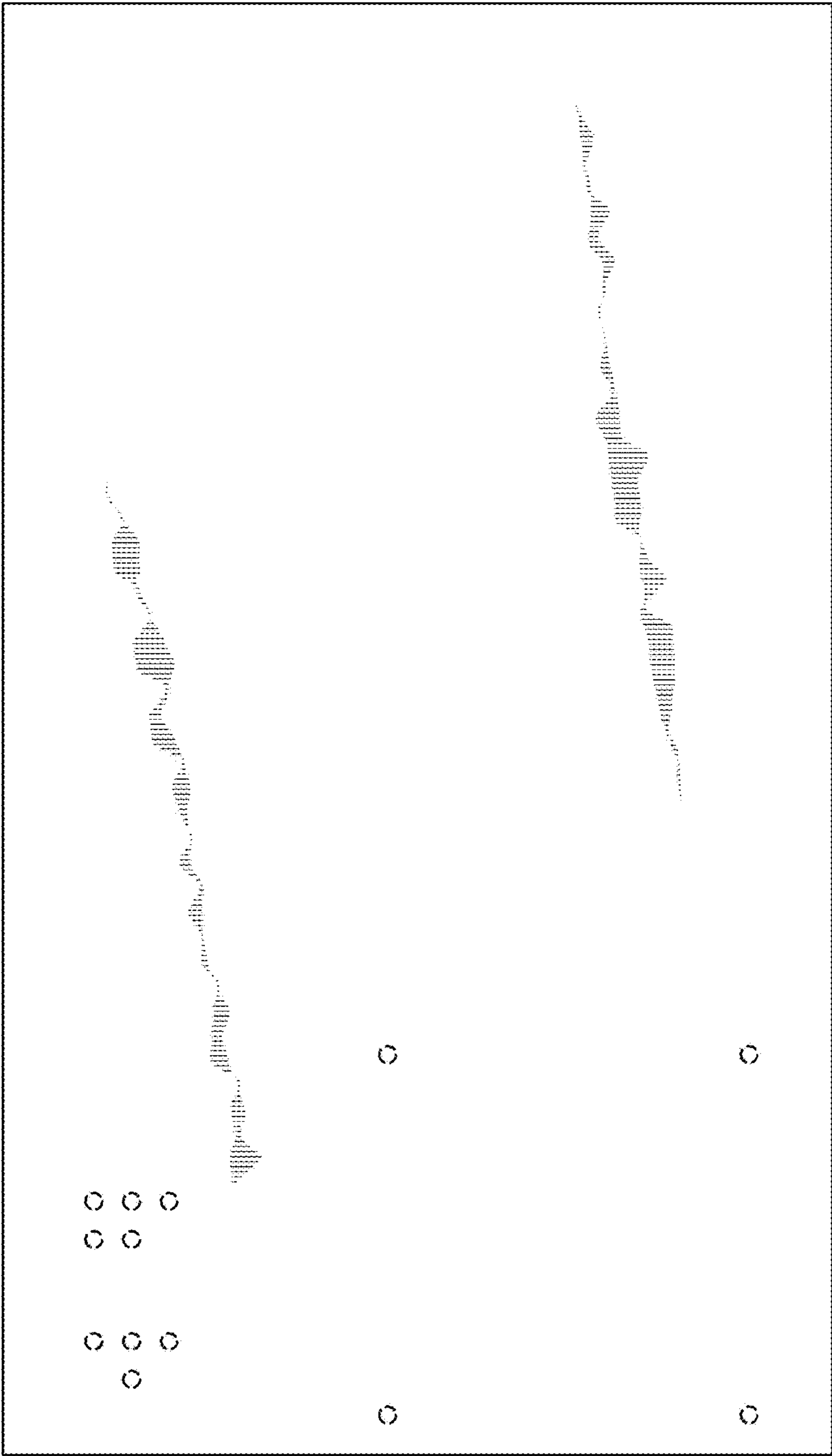

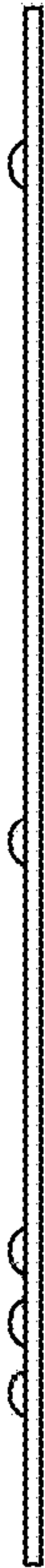

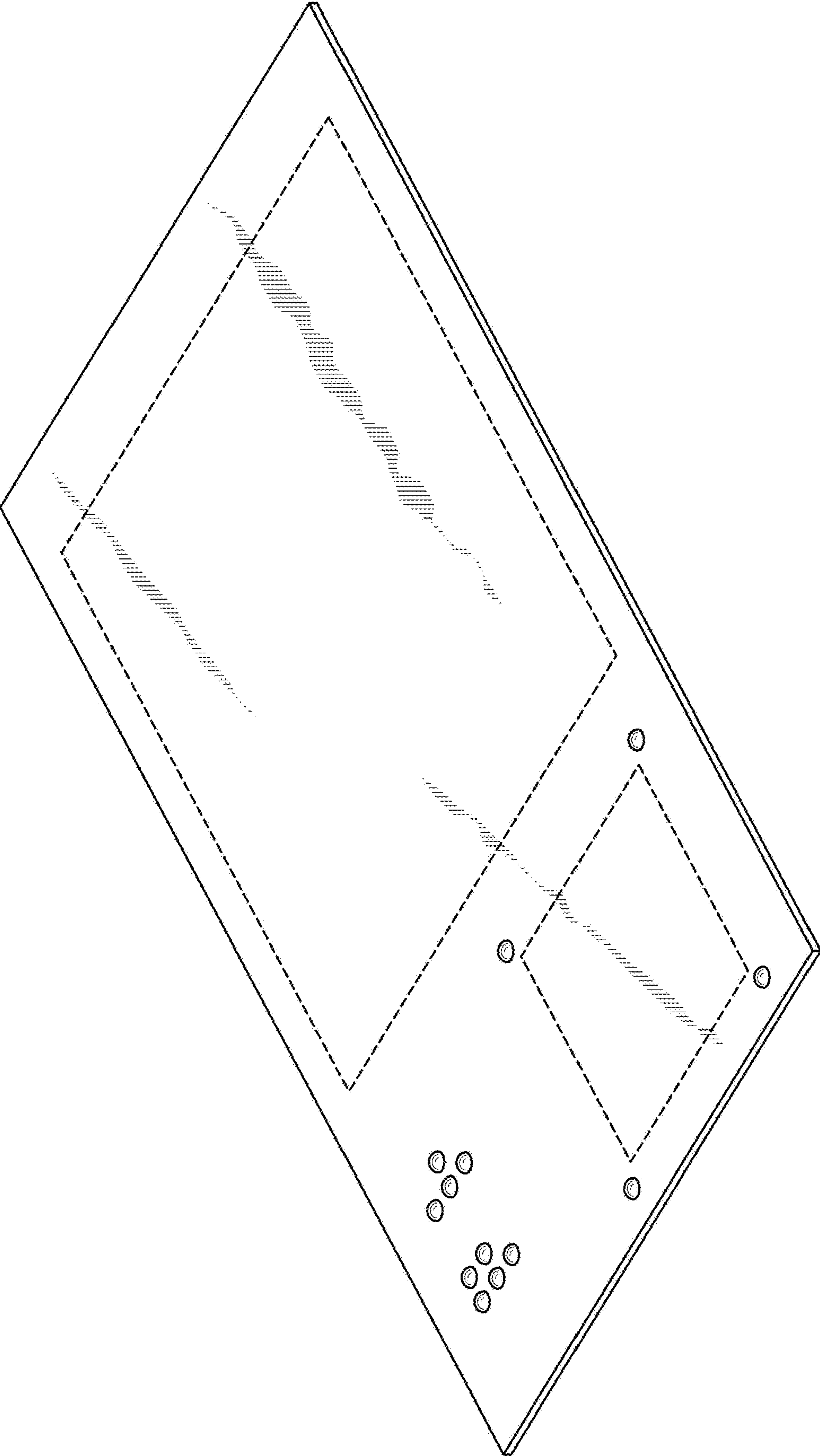

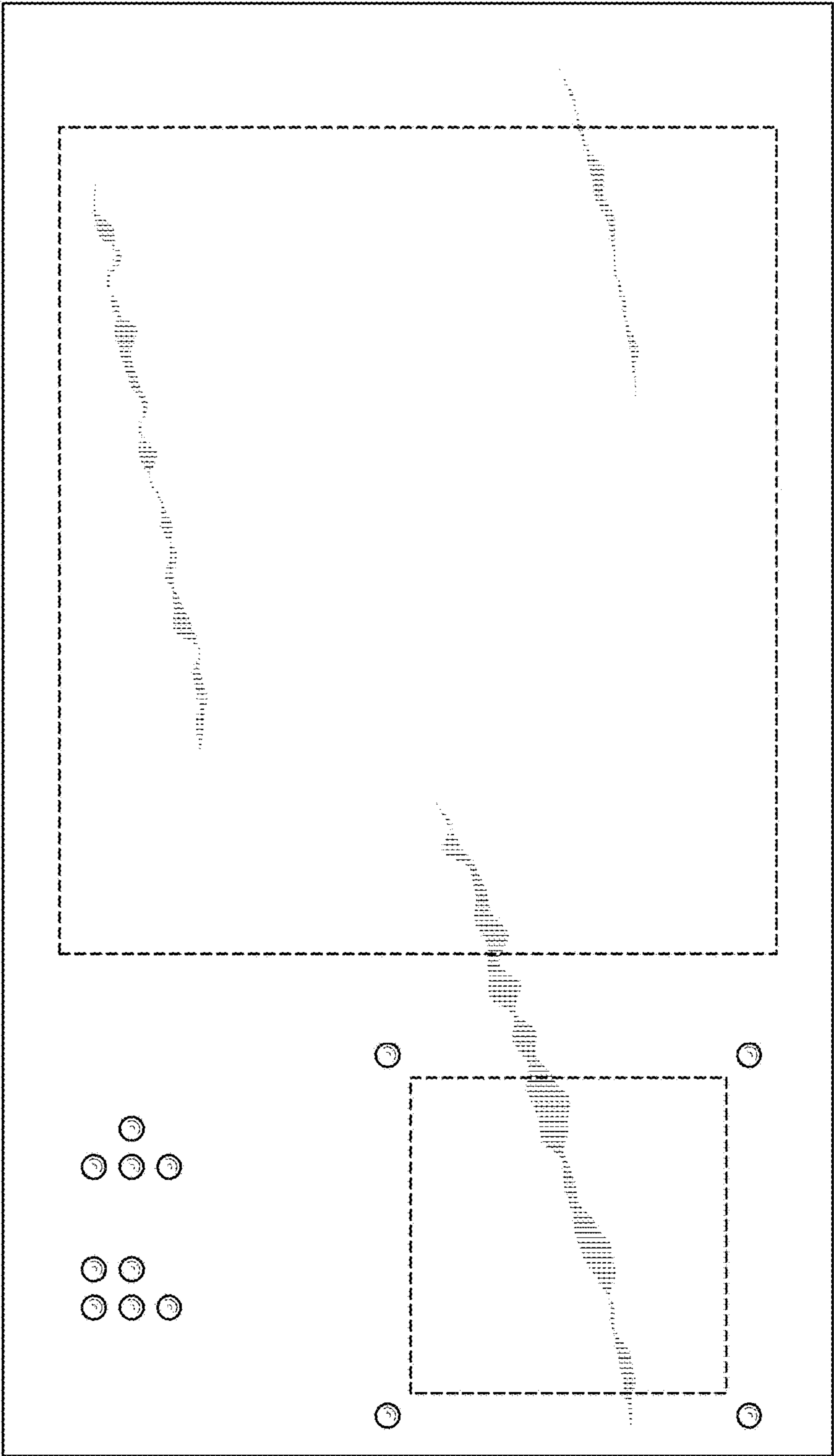

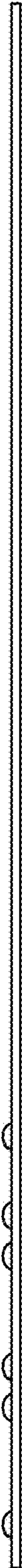

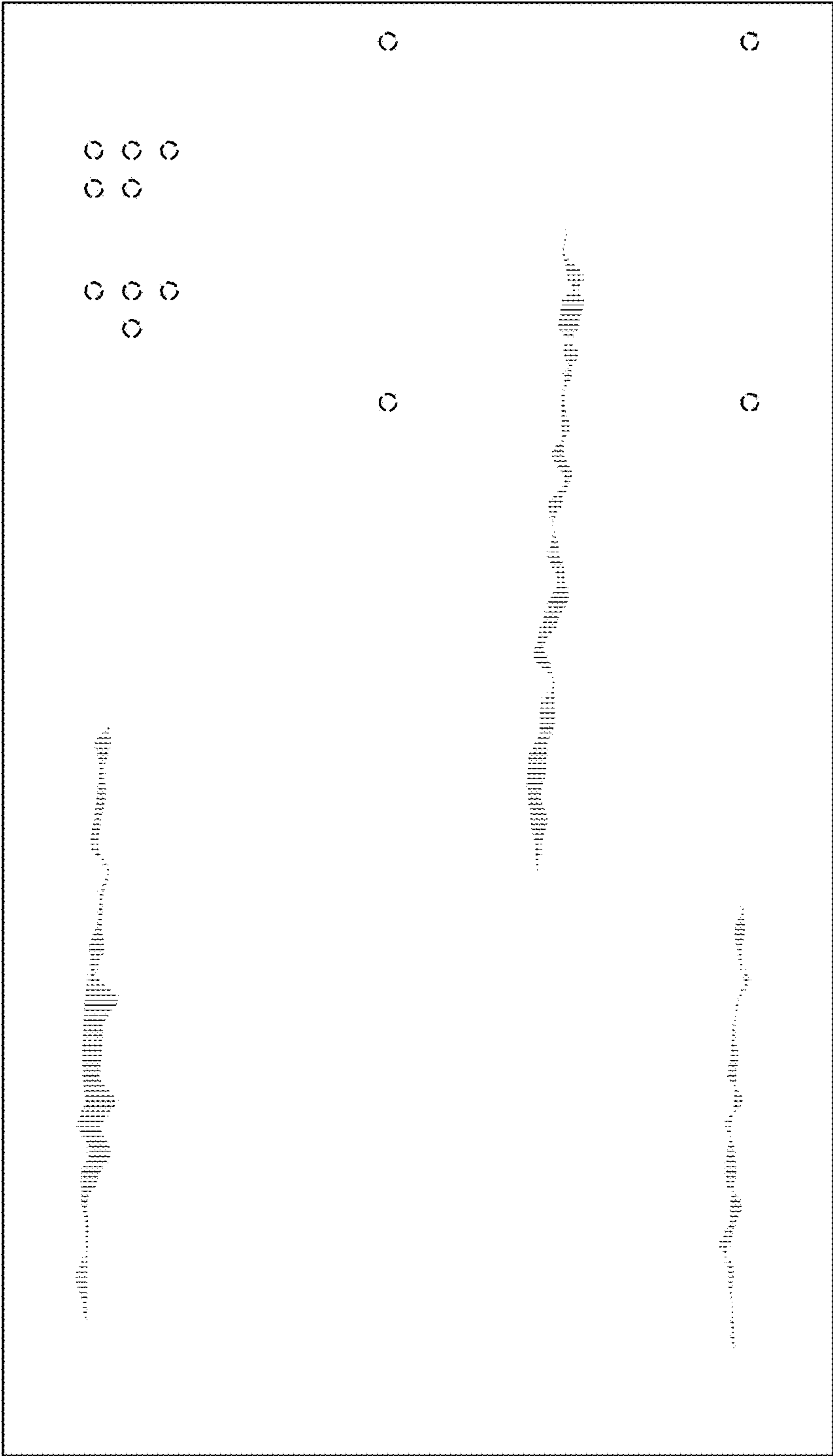

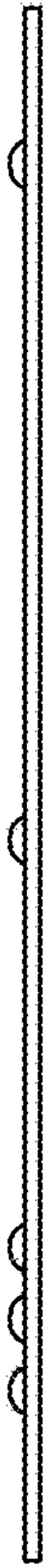

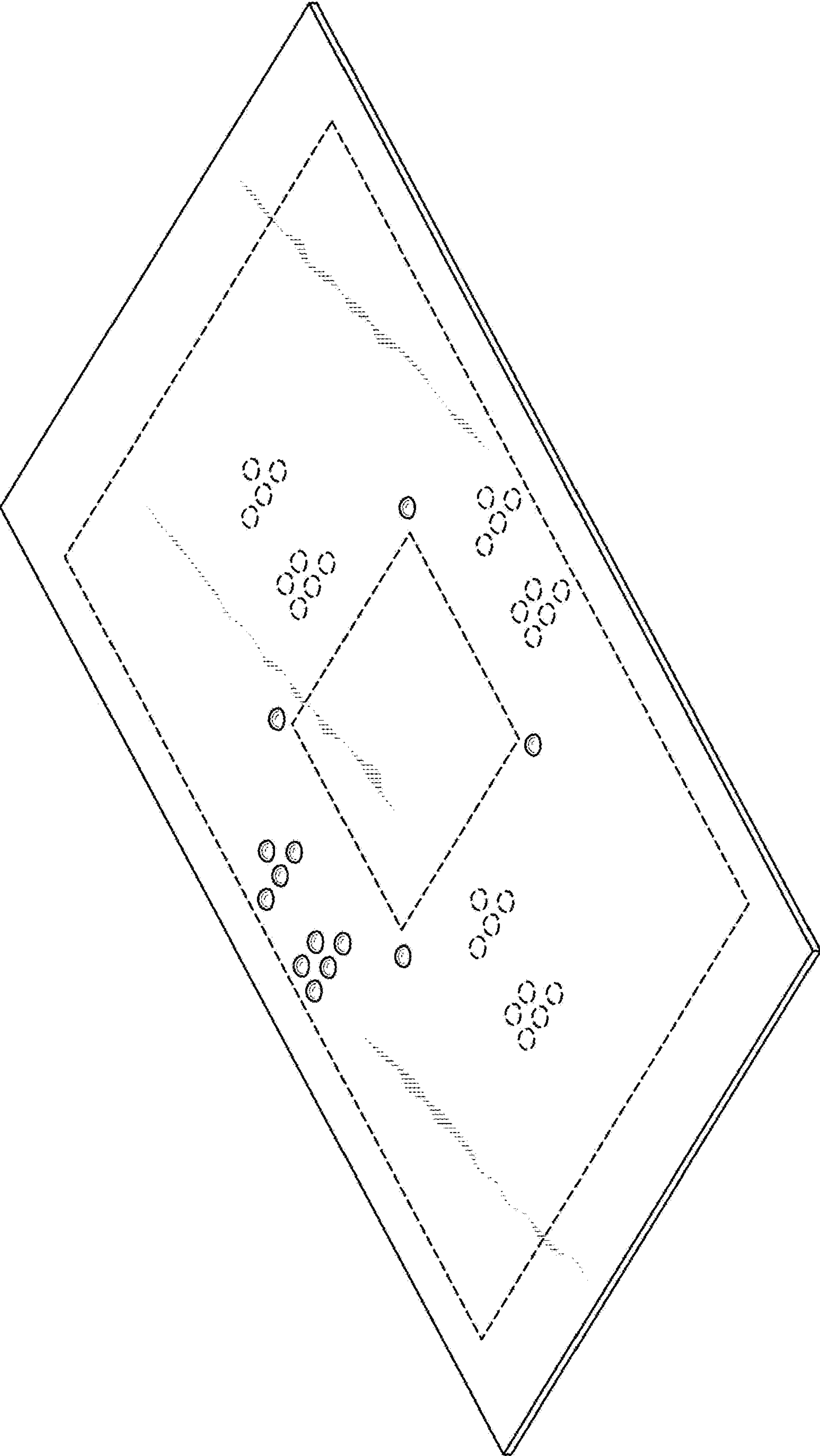

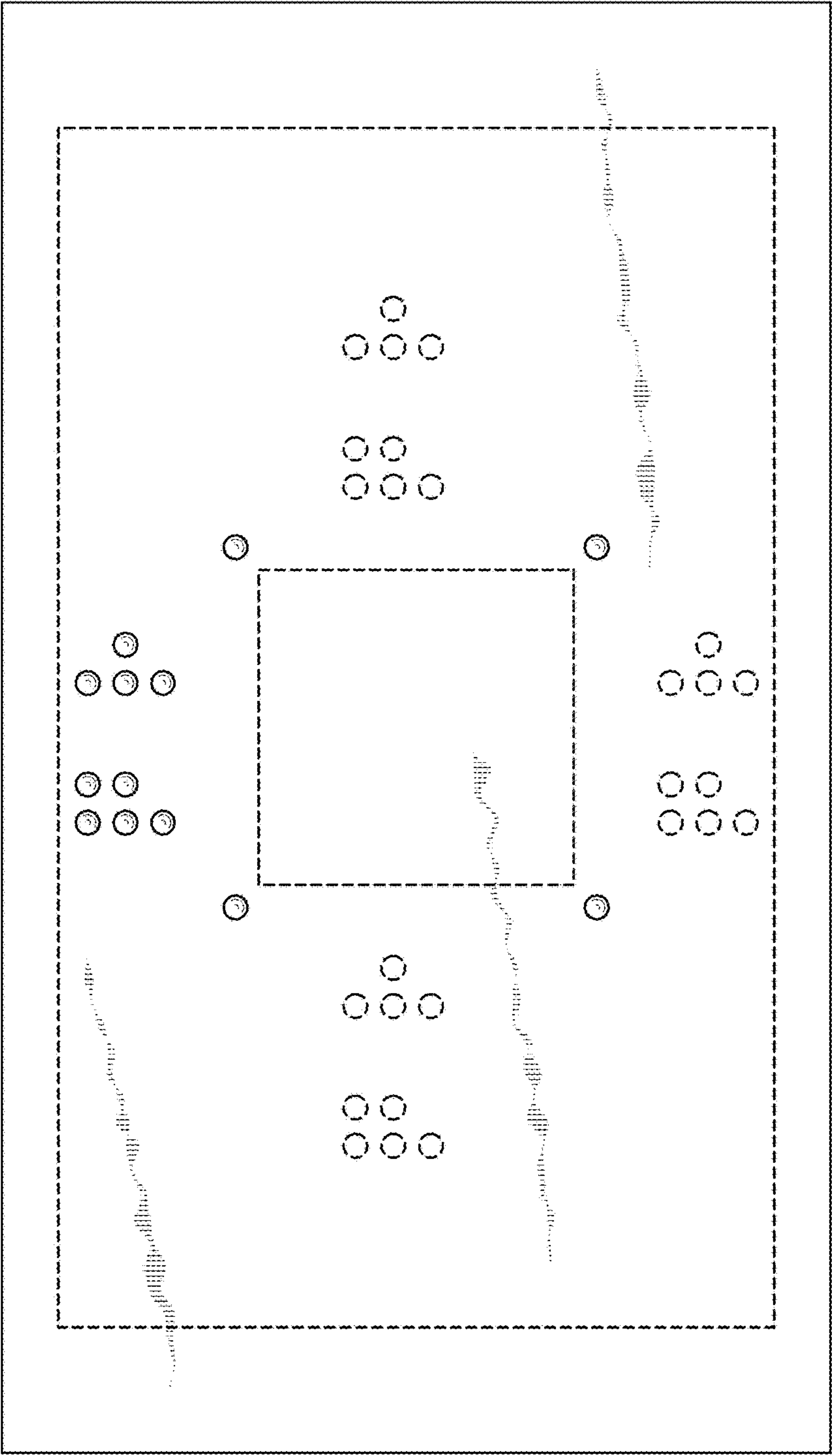

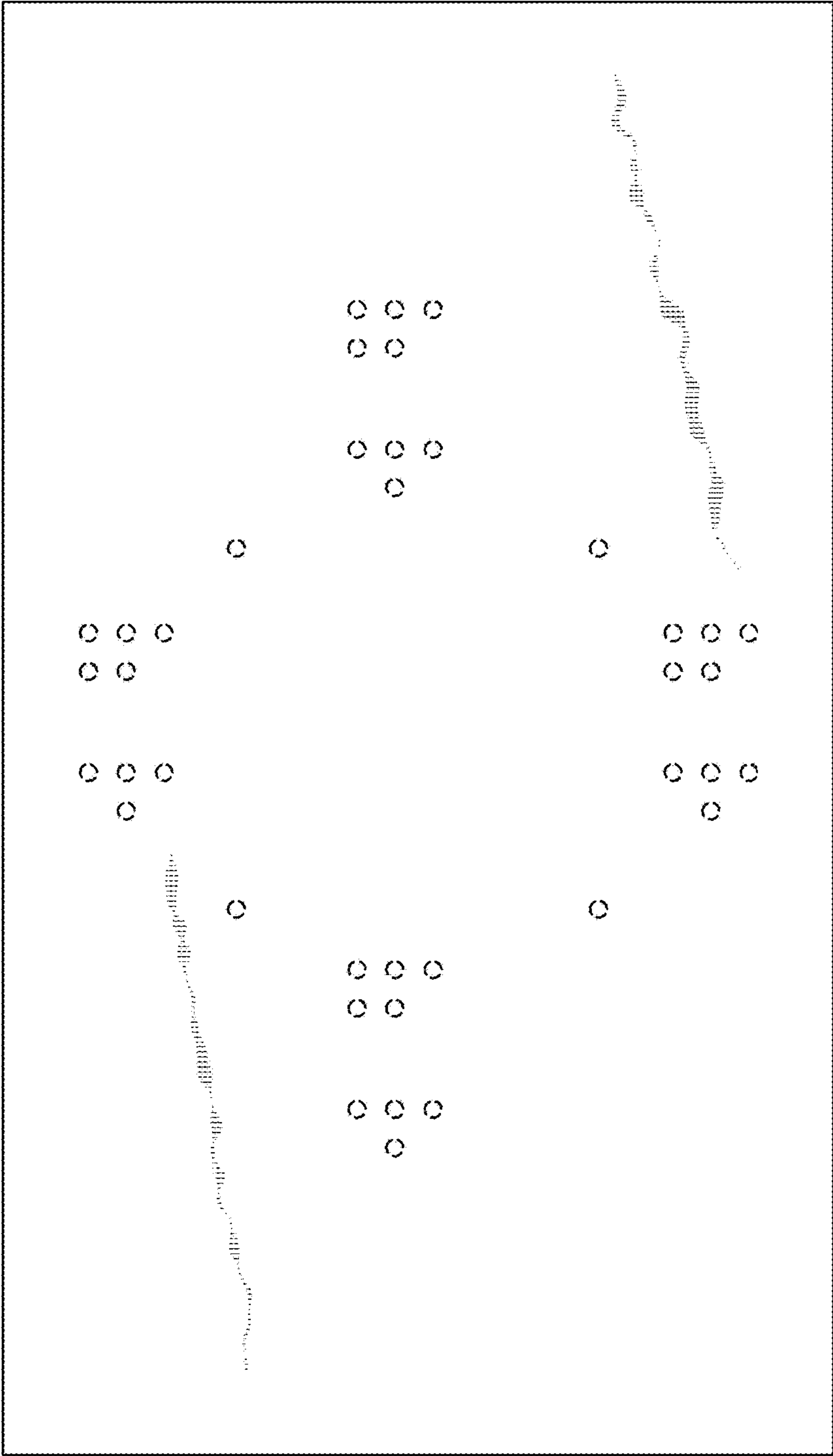

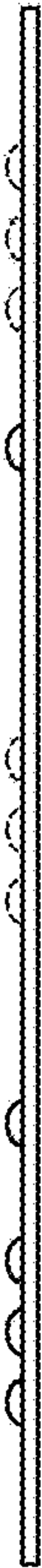
