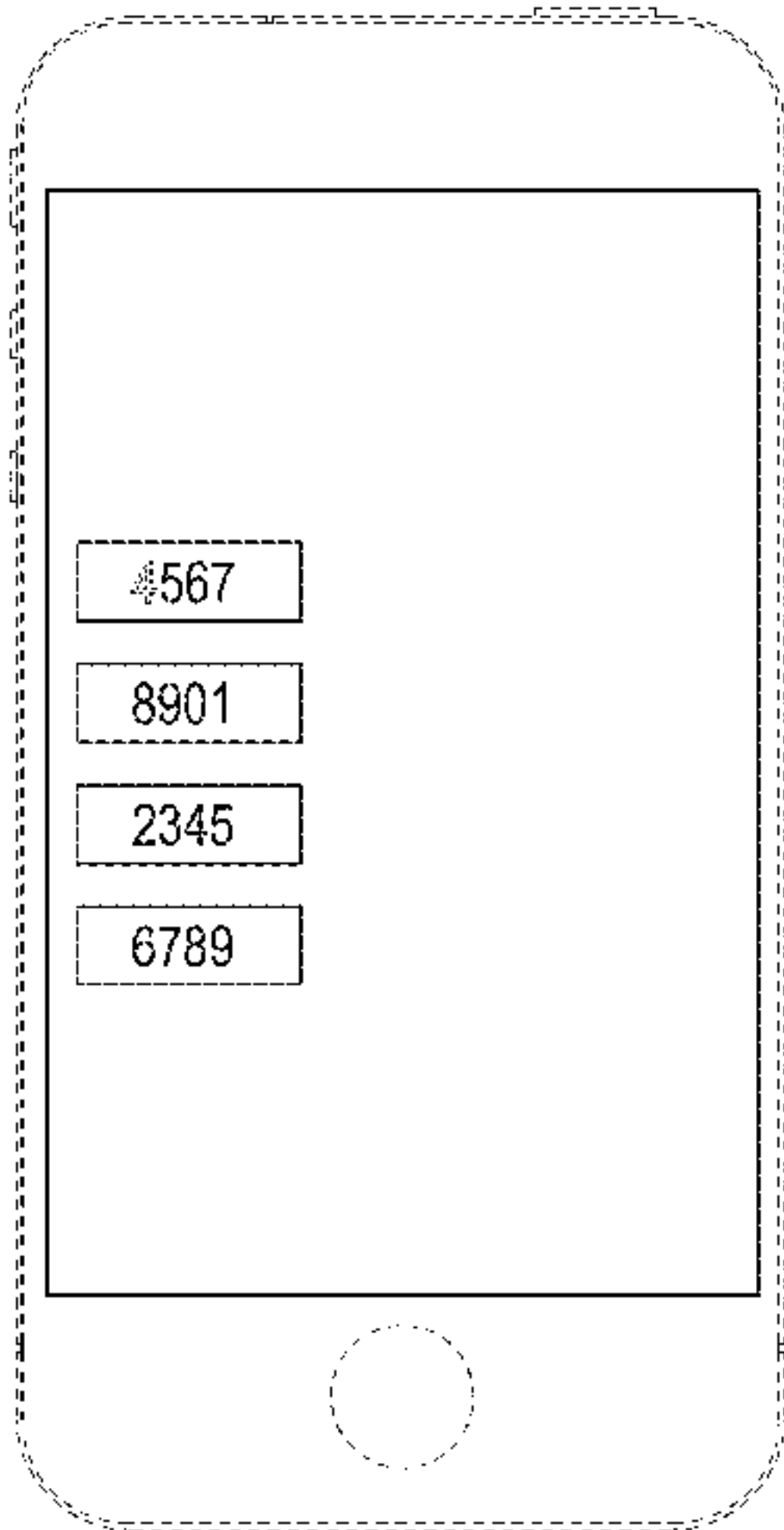

## (57) CLAIM

The ornamental design for a display with graphical user interface displaying account identifier, as shown and described.

## DESCRIPTION

The sole FIGURE is a front view of a display with graphical user interface displaying account identifier showing our new design.

The outermost broken lines show portions of the display that form no part of the claimed design. The broken line number on the display and broken line buttons on the display form no part of the claimed design.

**1 Claim, 1 Drawing Sheet**
