(57) CLAIM

I claim the ornamental design for an eyebrow razor, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an eyebrow razor showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged view of FIG. 4;
FIG. 9 is an enlarged view of FIG. 5; and,
FIG. 10 is a perspective view of the eyebrow razor in which the cover feature is provided in broken lines shown in a state of use.
The broken lines in the figures depict portions of the eyebrow razor which form no part of the claimed design.

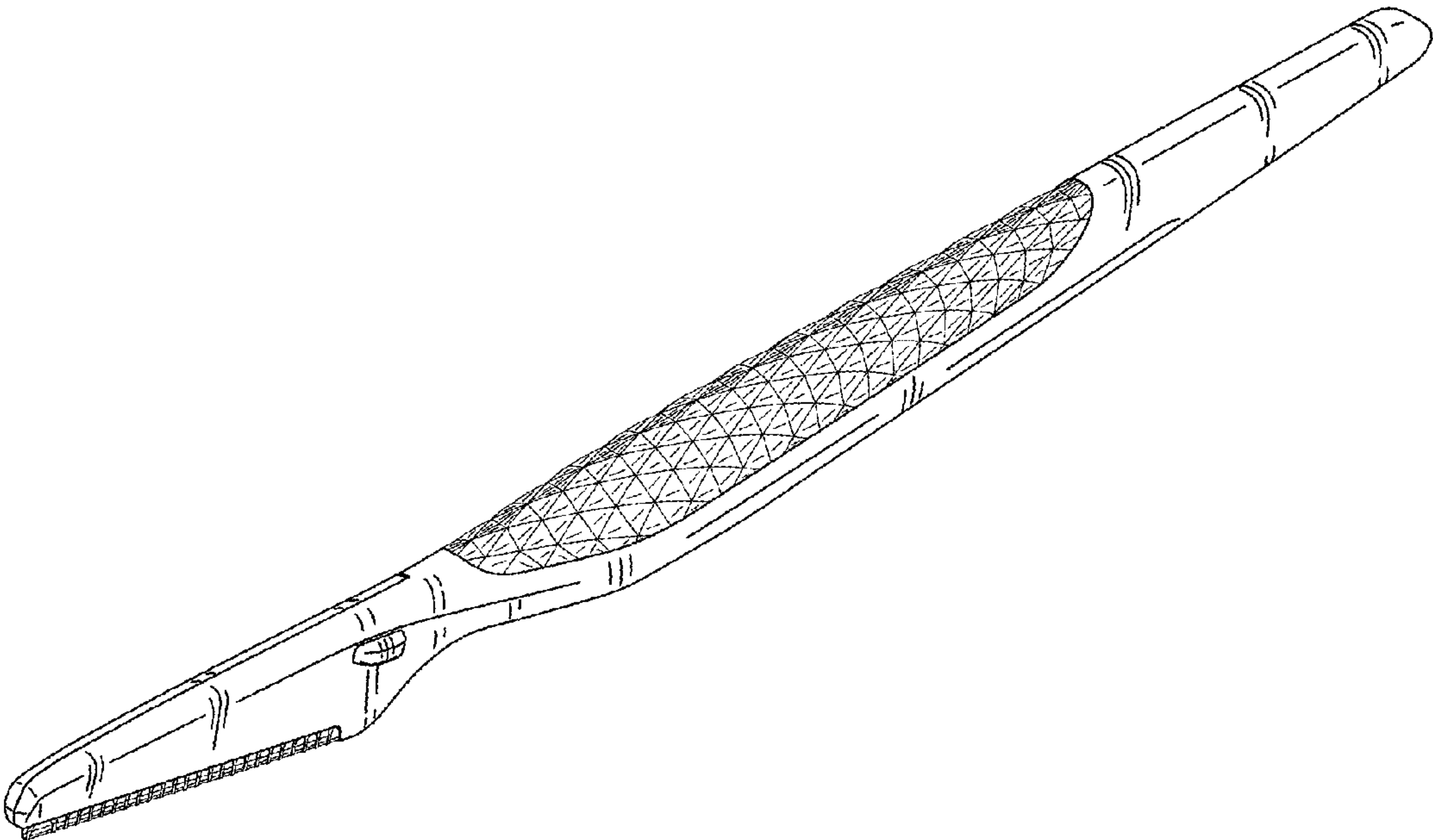

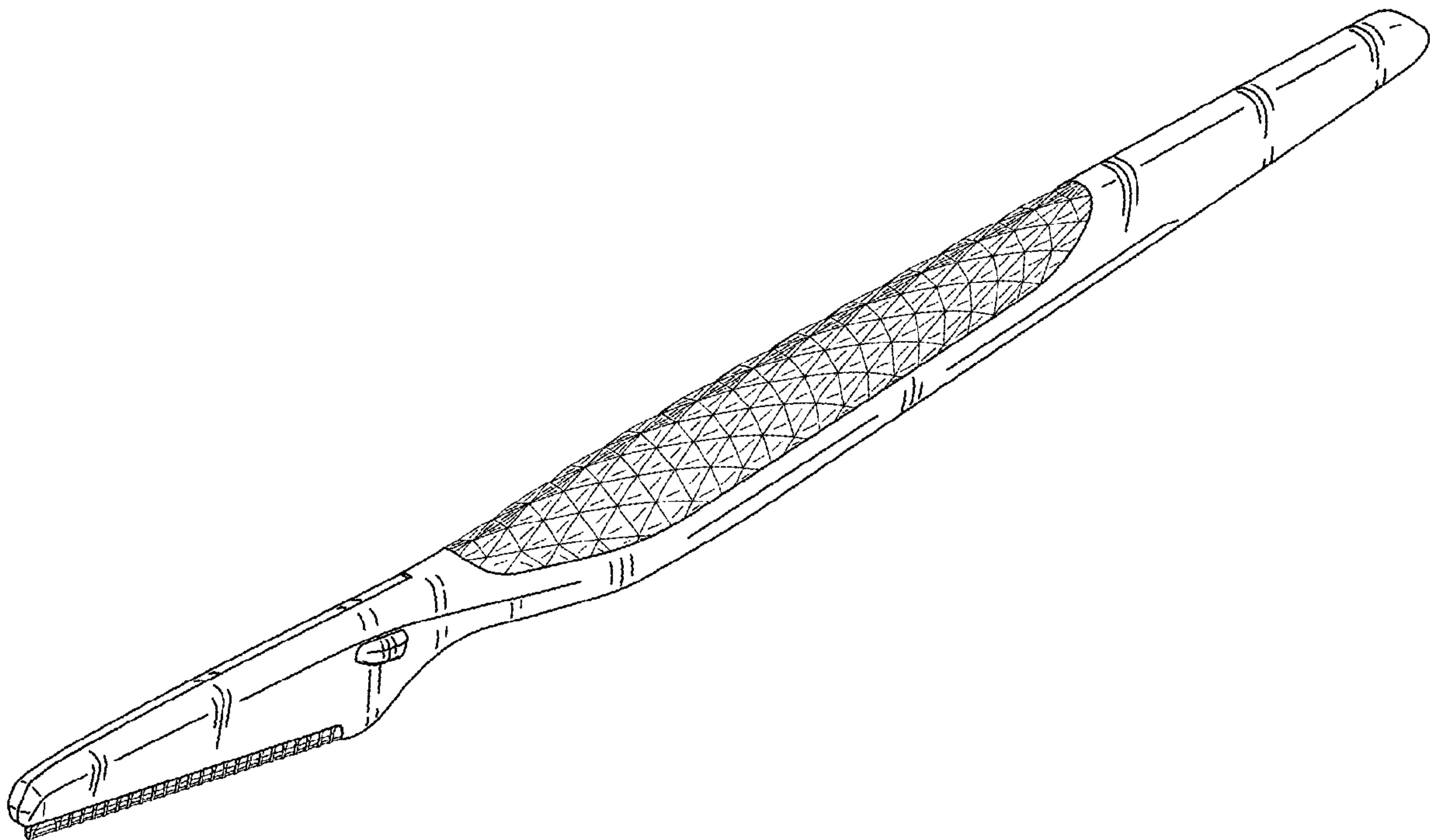

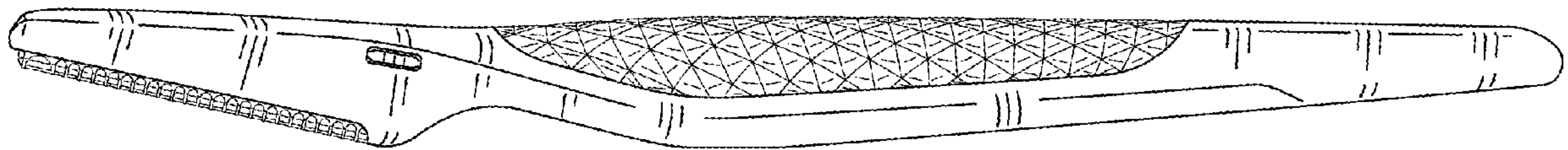

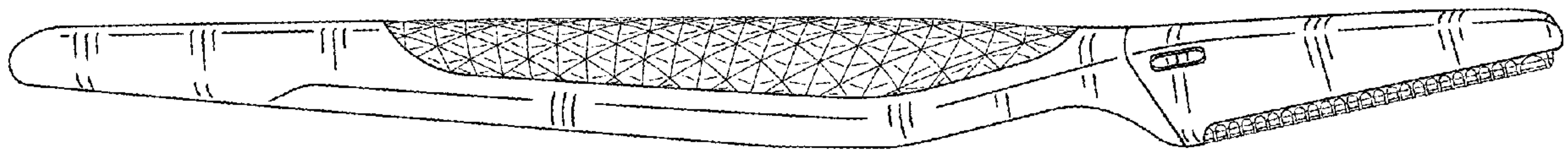

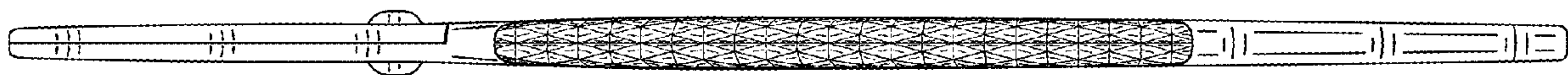

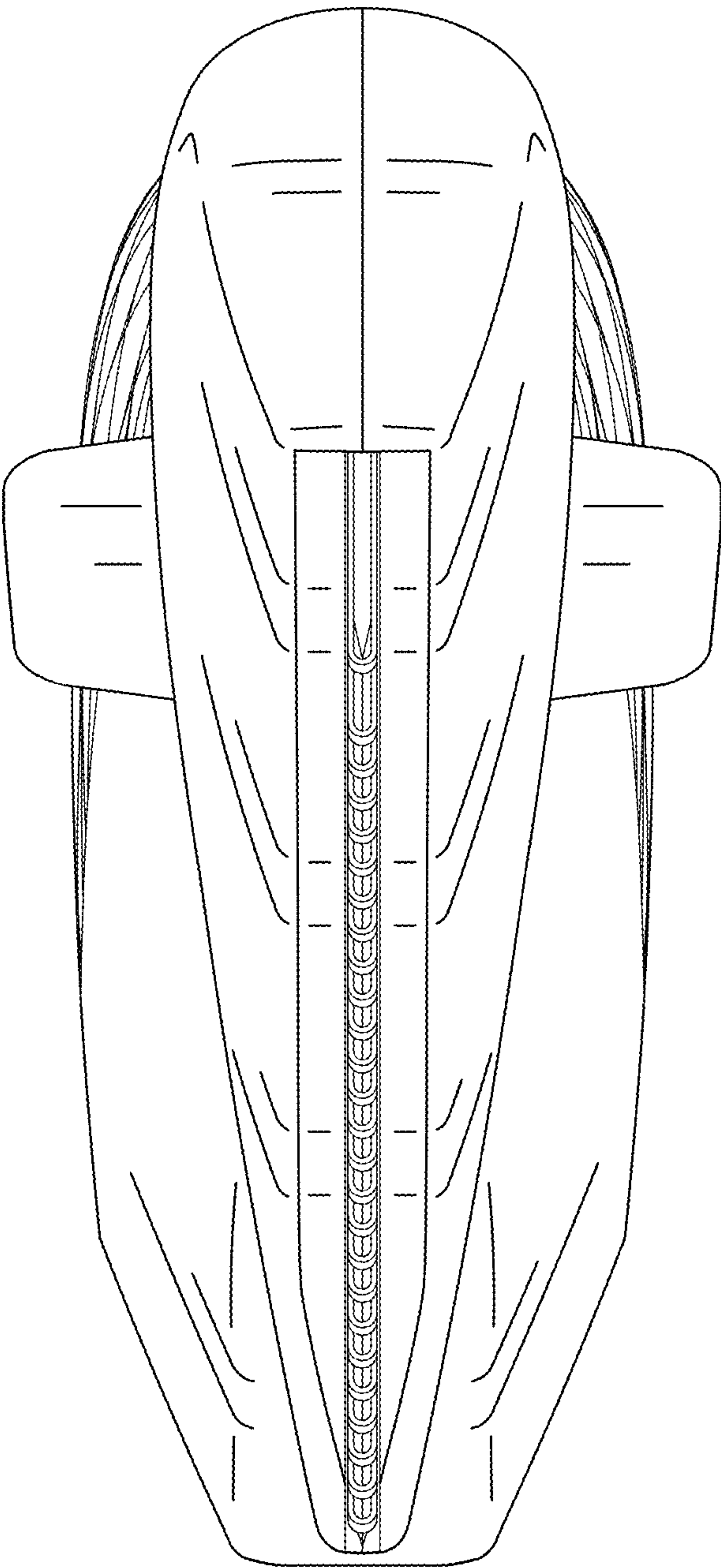

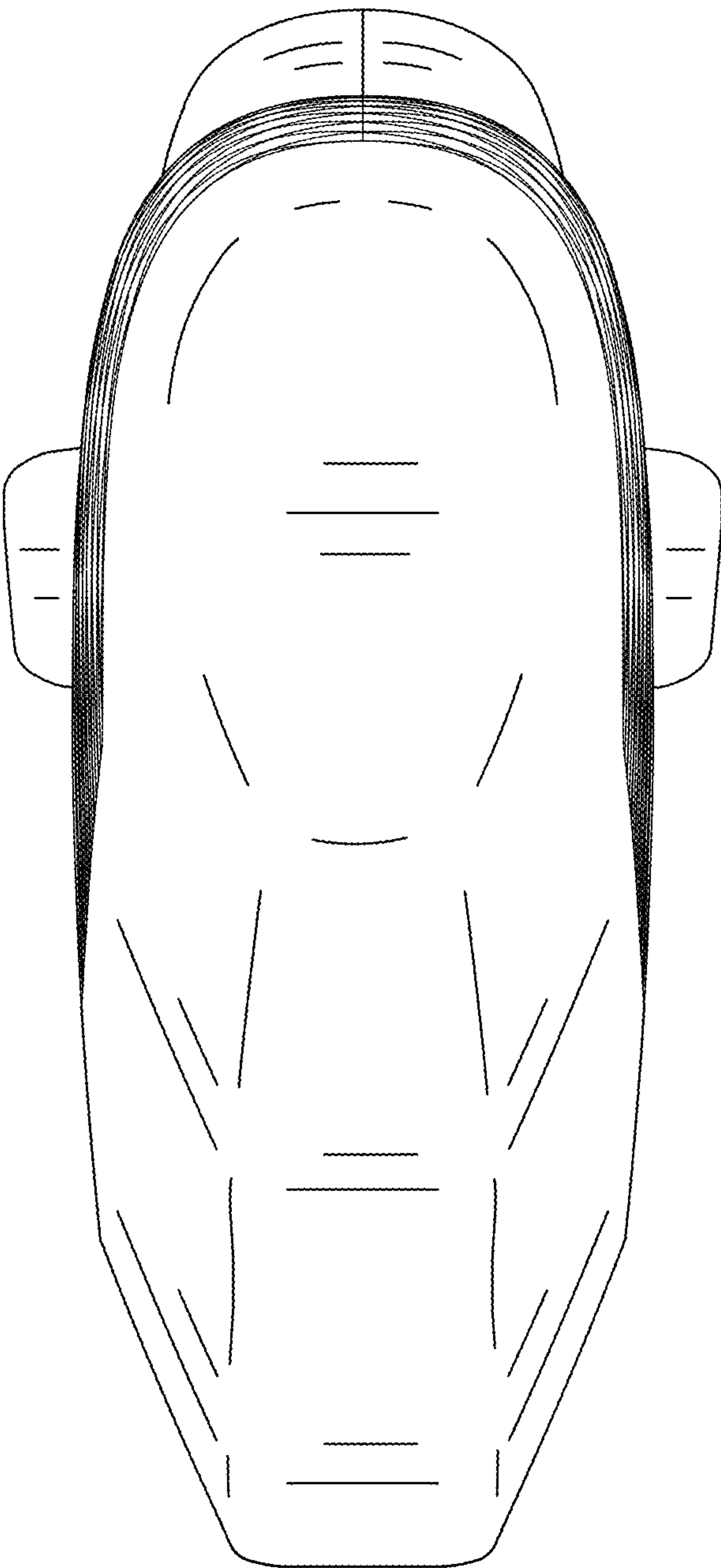
