DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a pressing tool;

FIG. 2 is a rear perspective view of the pressing tool of FIG. 1;

FIG. 5 is a rear end view of the pressing tool of FIG. 1;

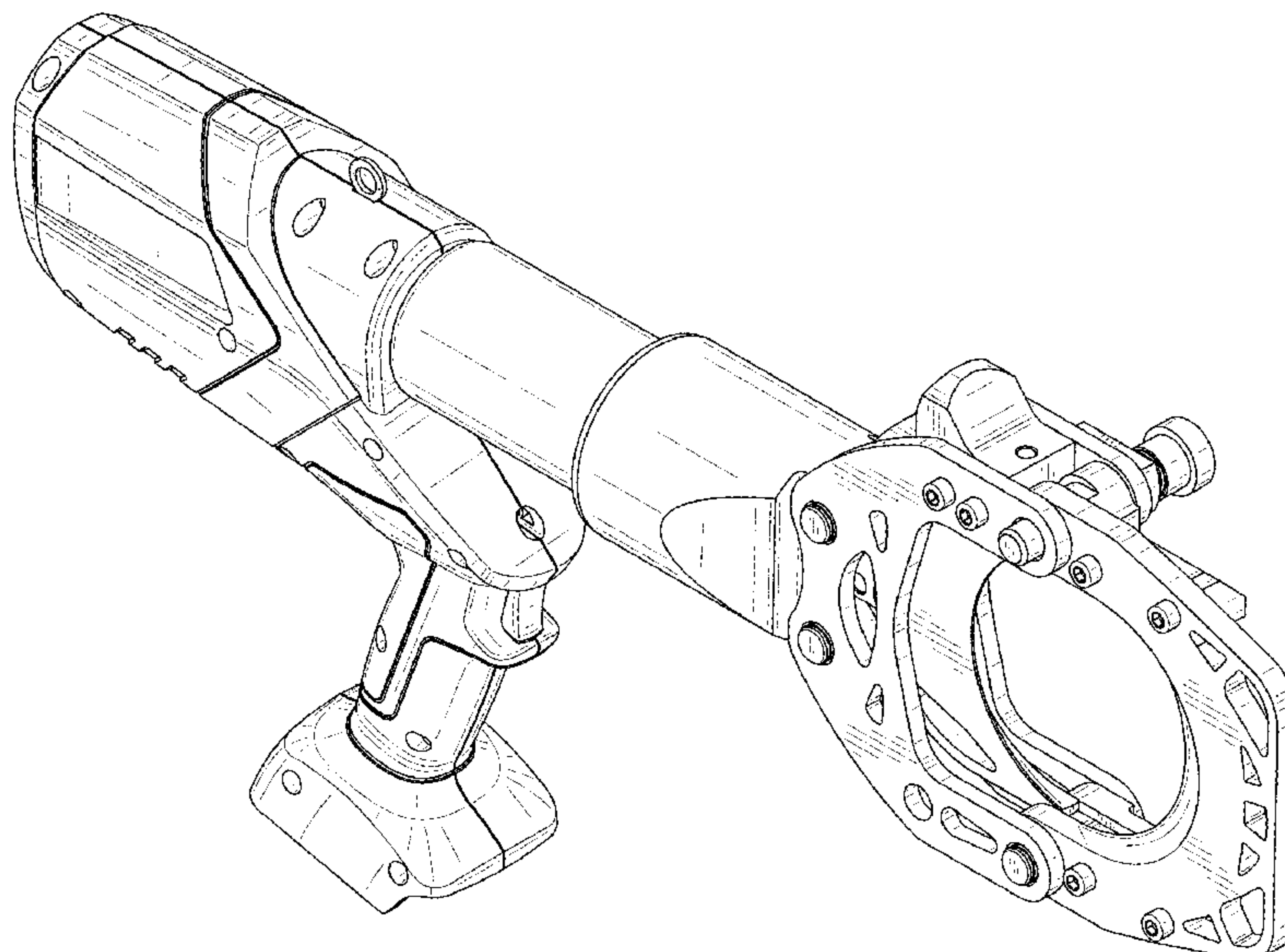
FIG. 6 is a front end view of the pressing tool of FIG. 1;

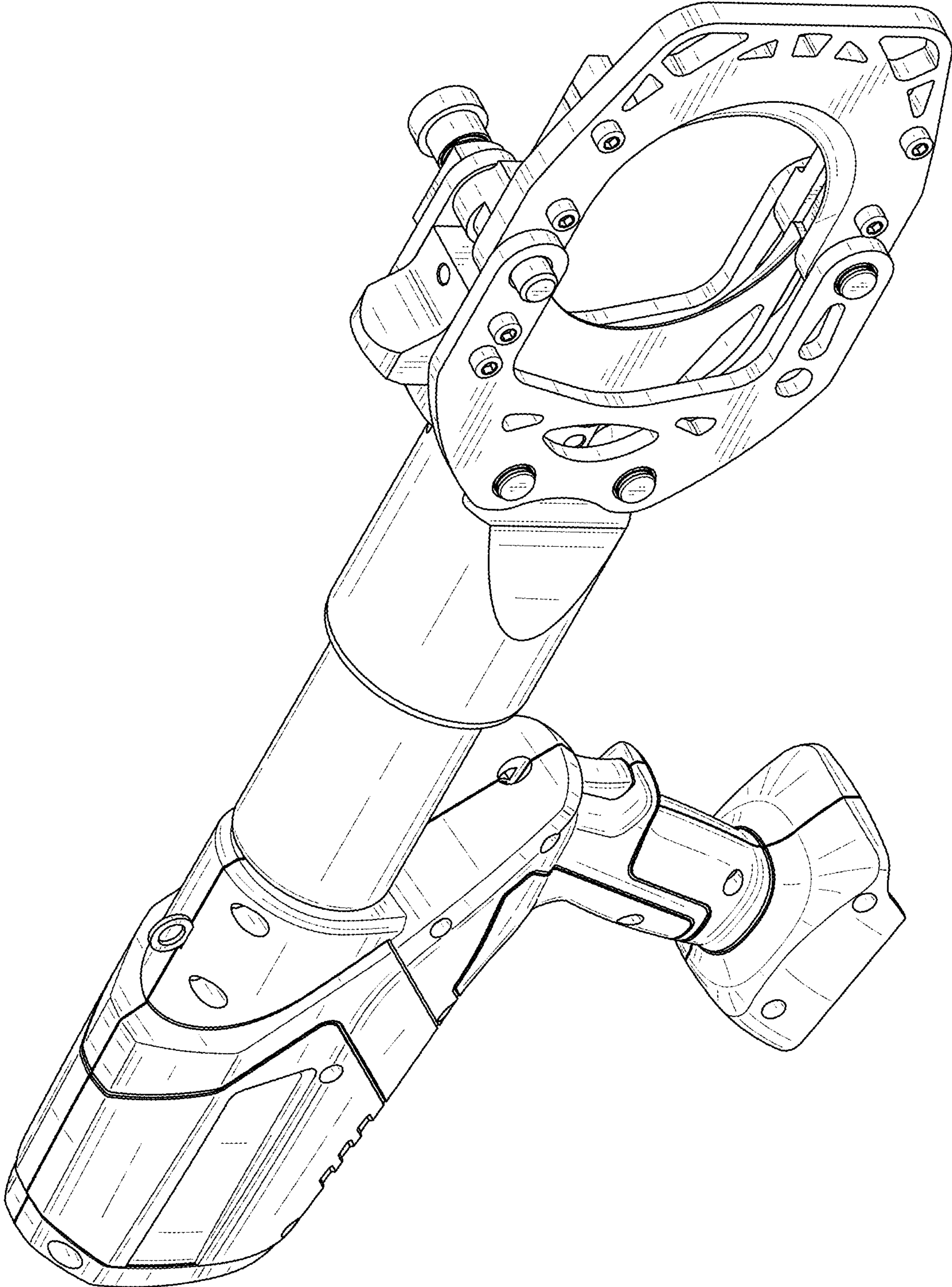

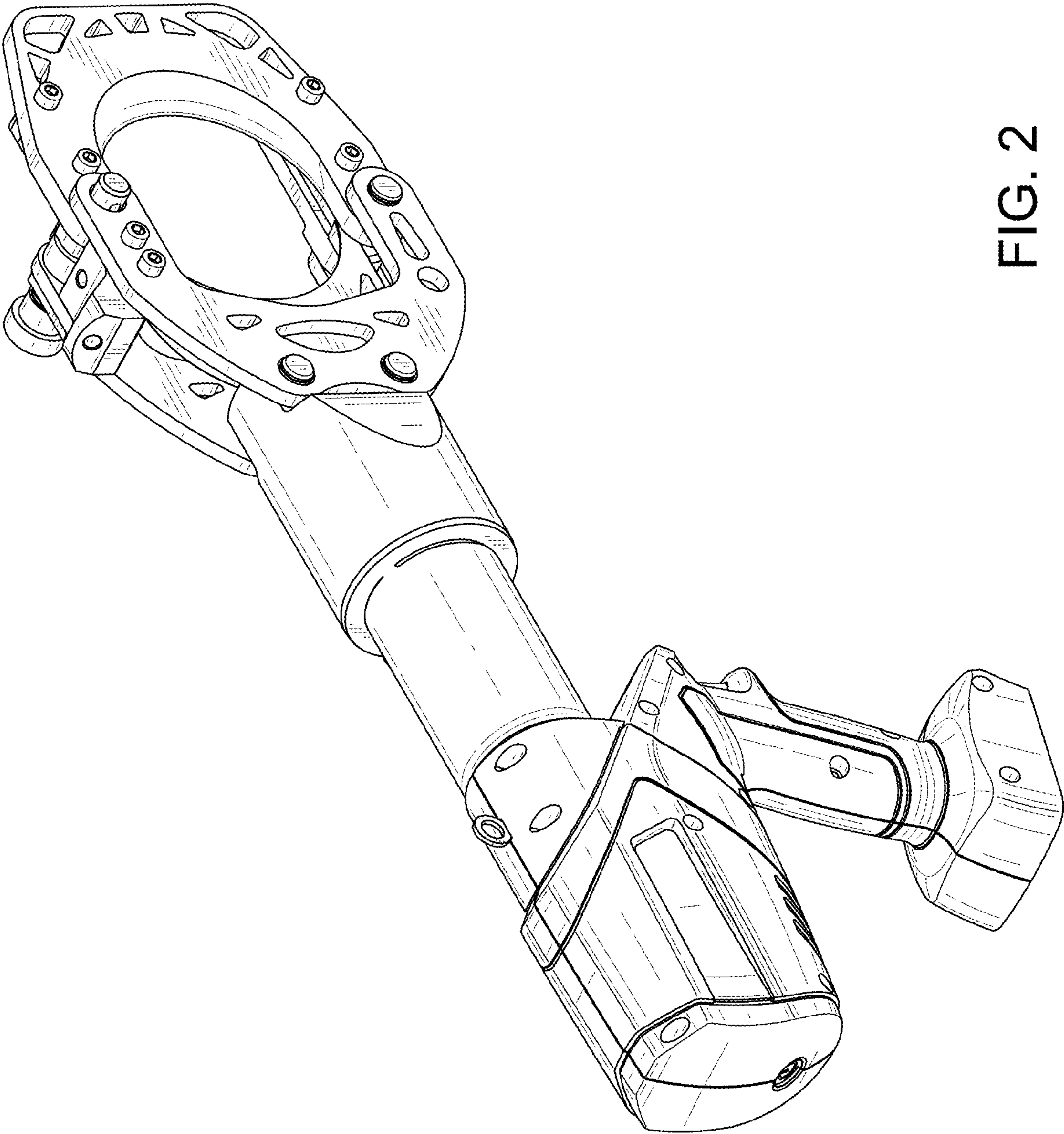

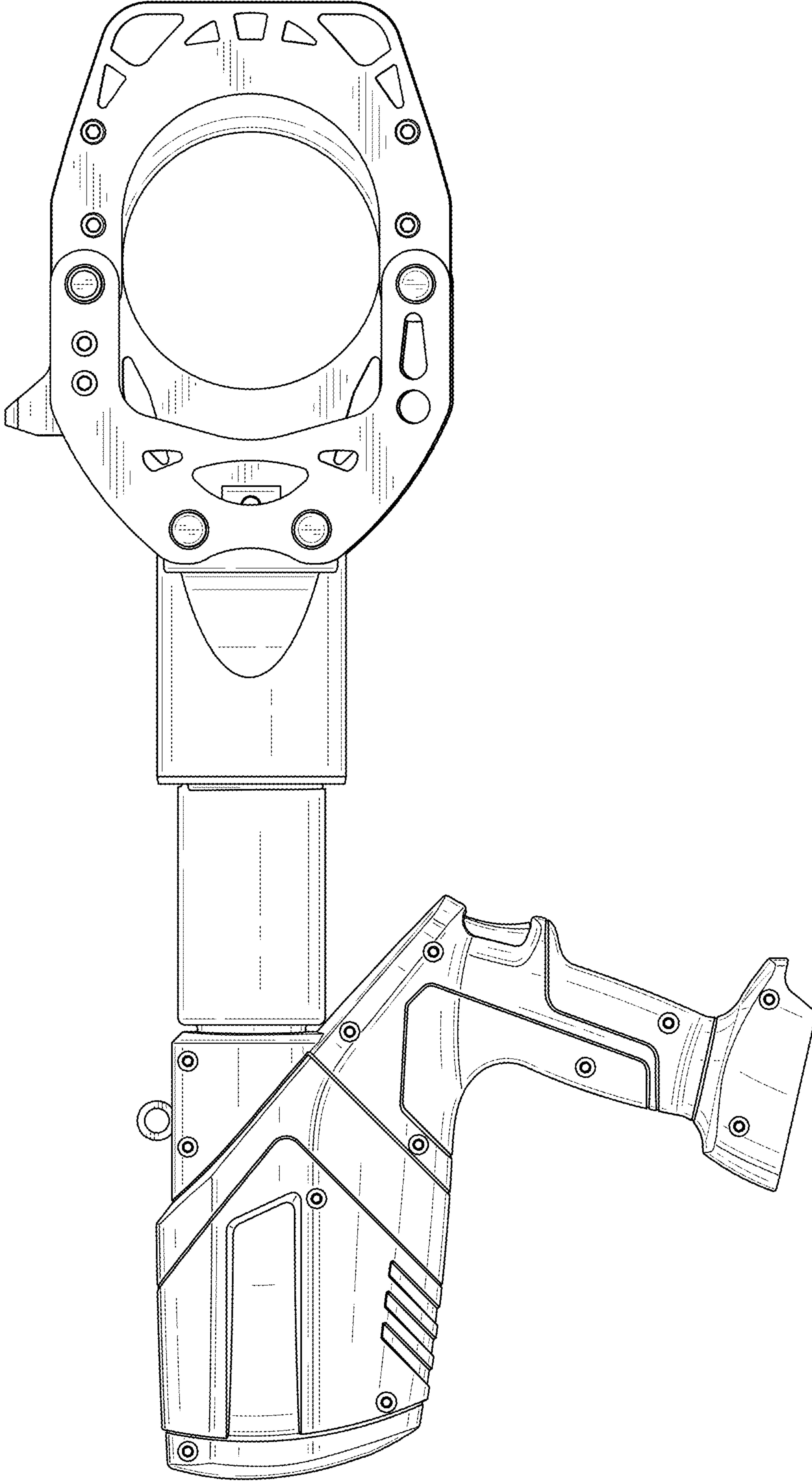

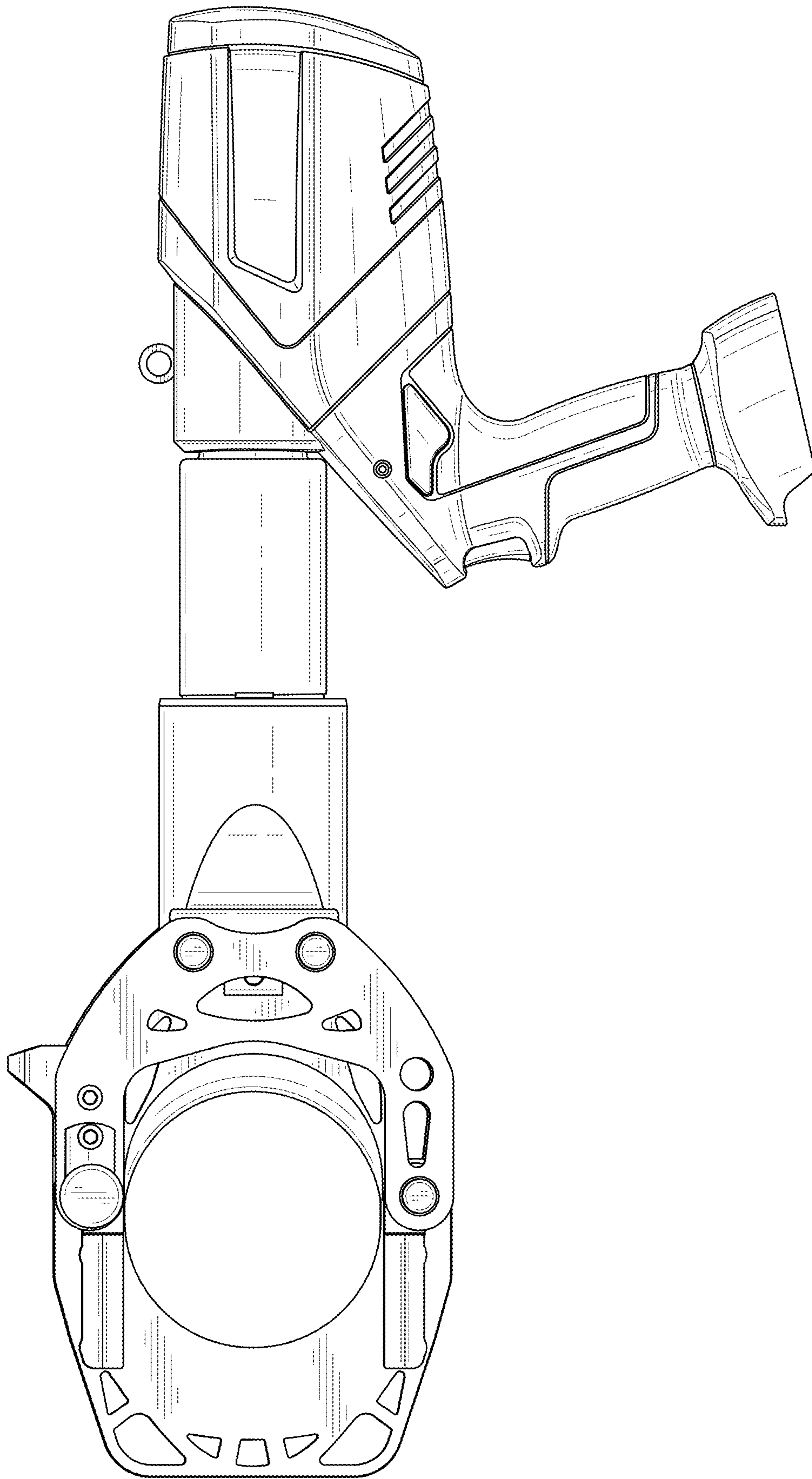

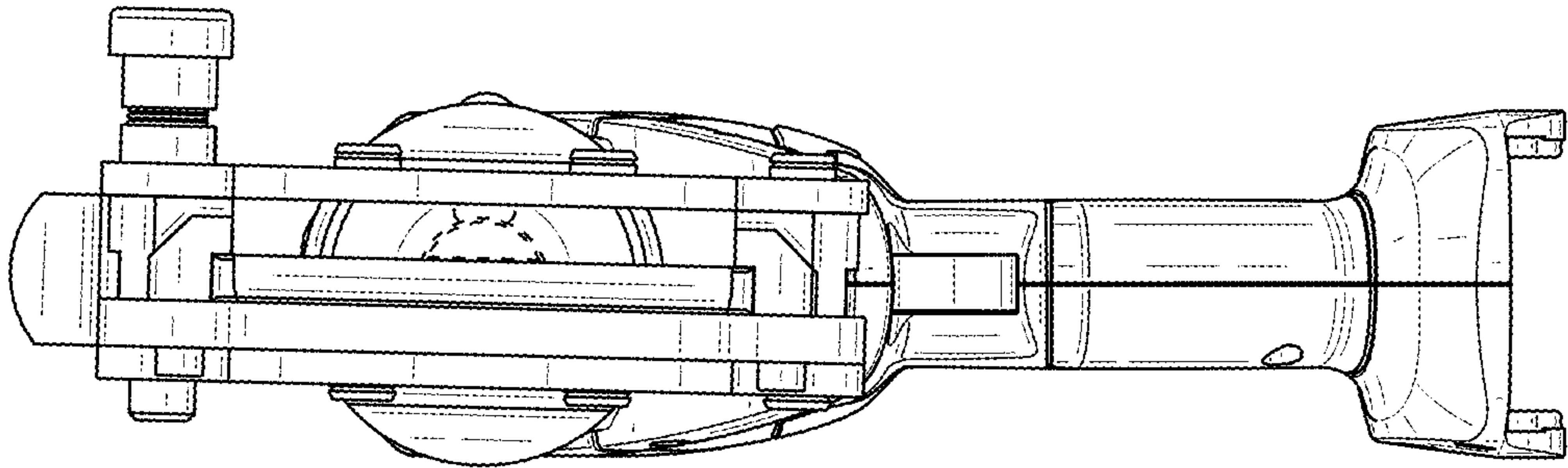

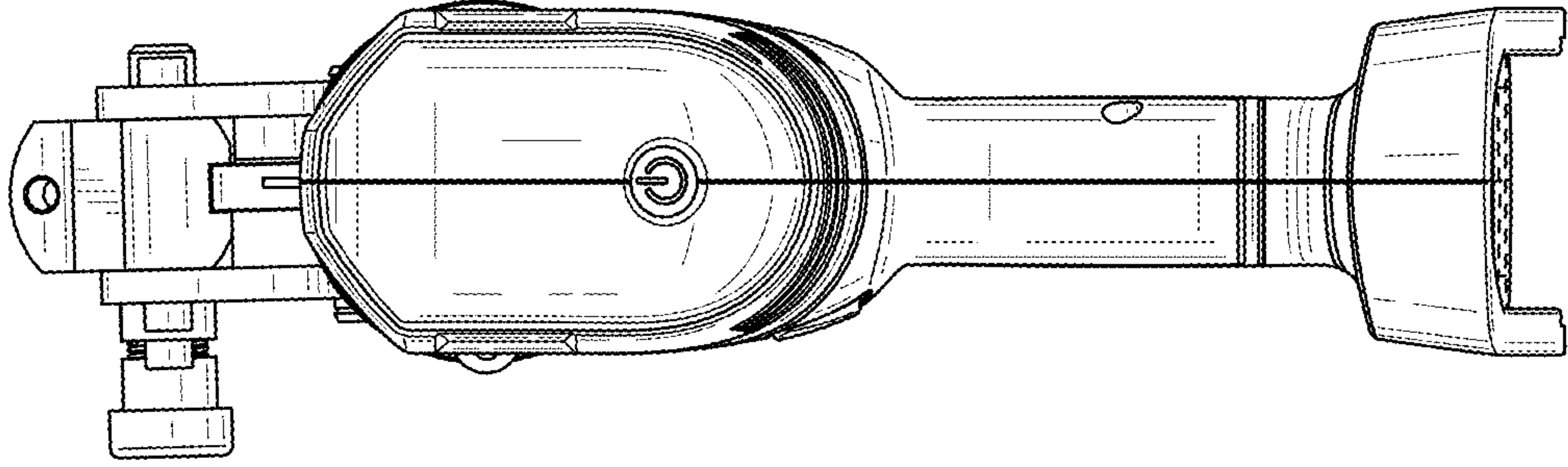

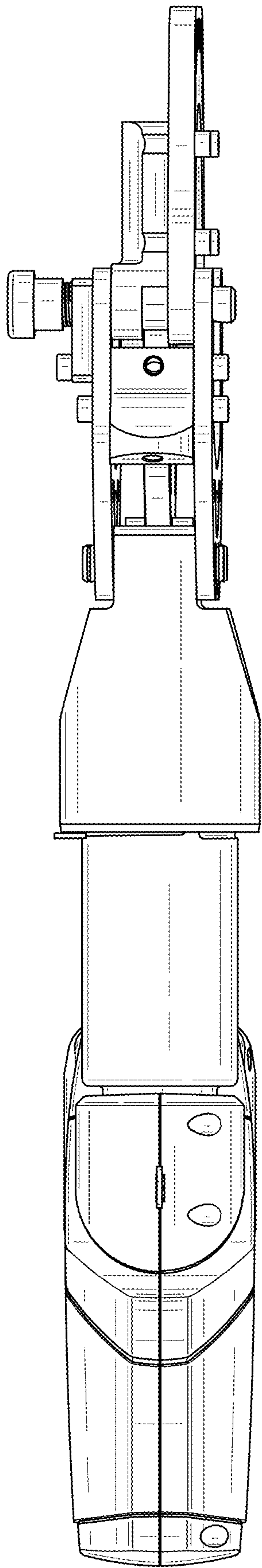

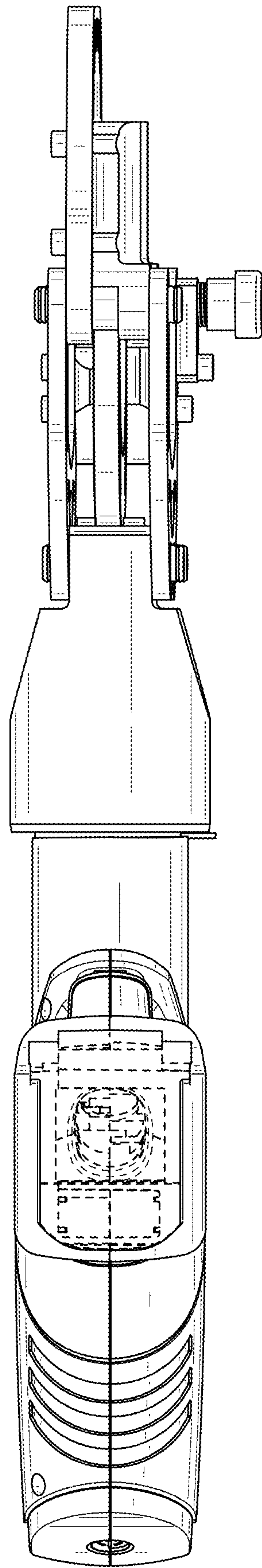
