FIG. 4 is a side elevational view;

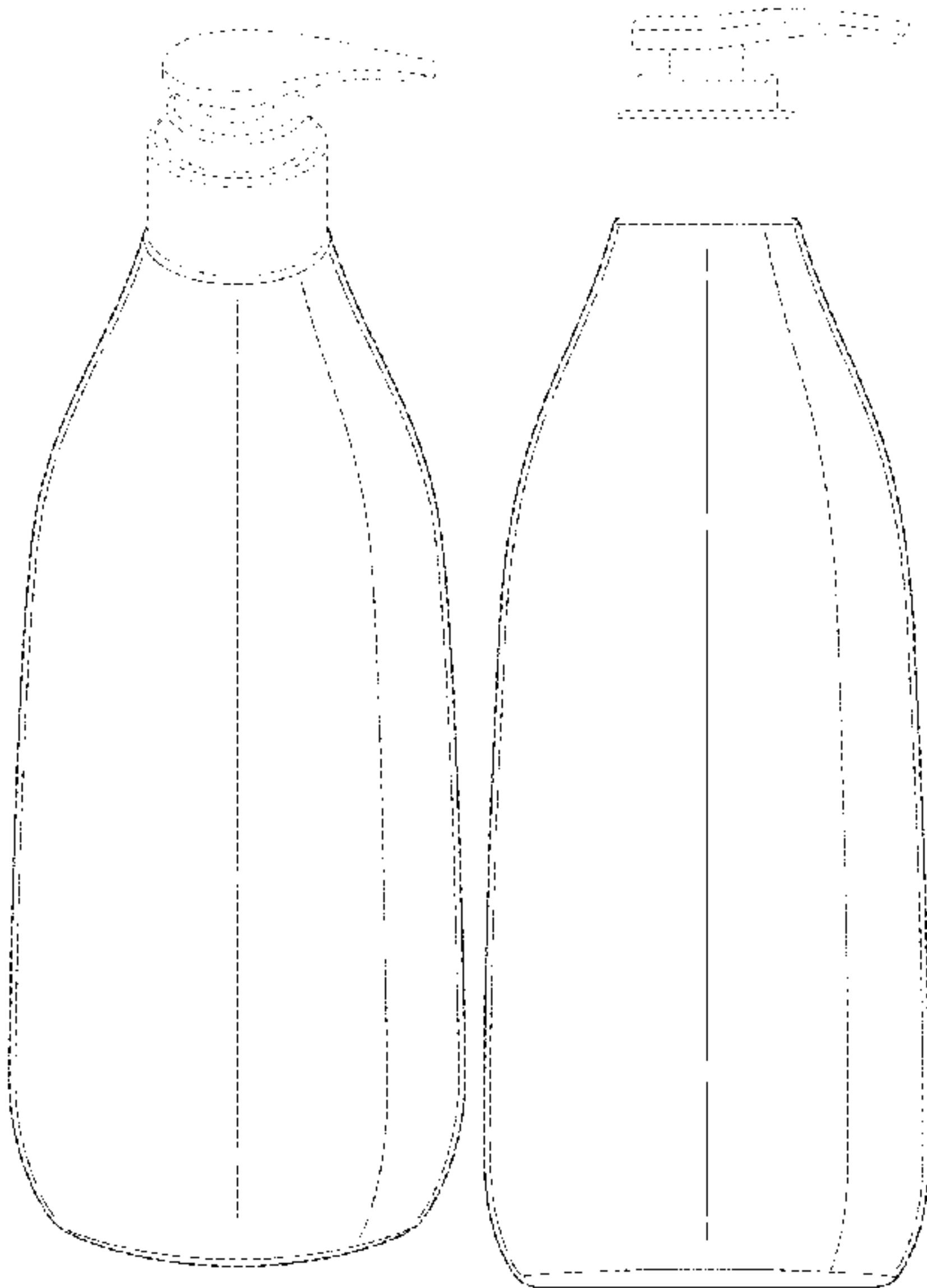
FIG. 5 is an elevational view of the other side;

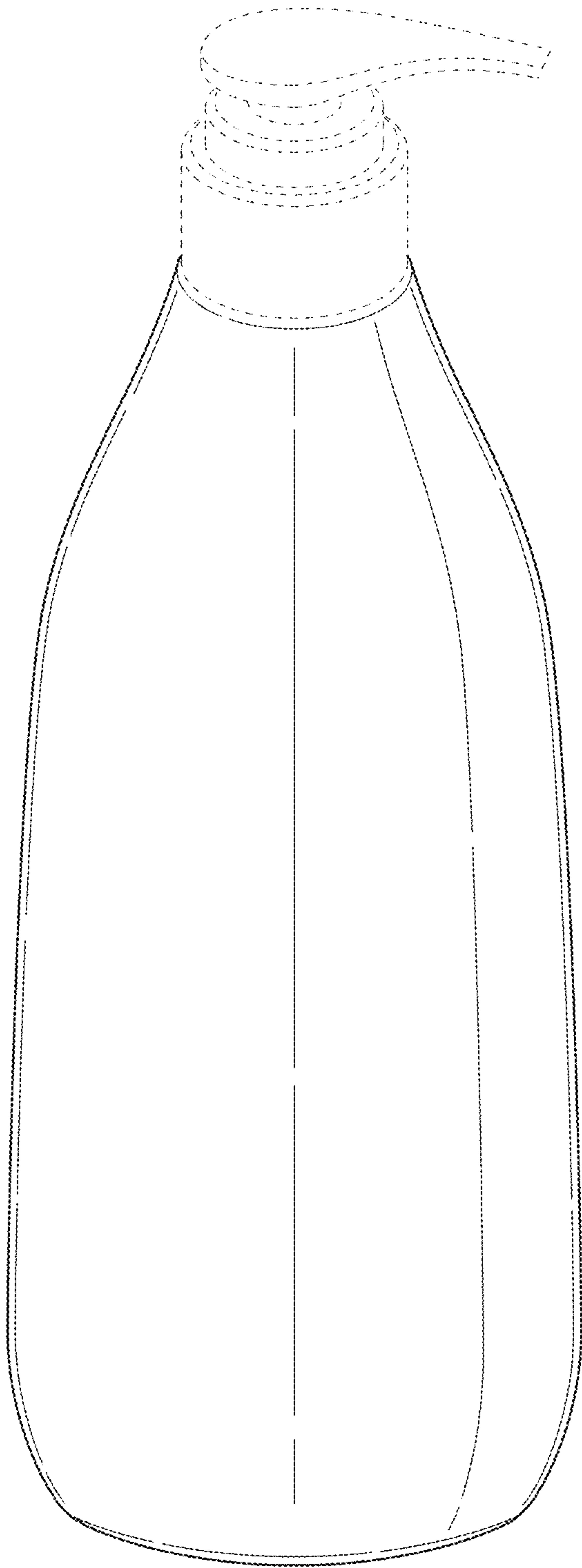

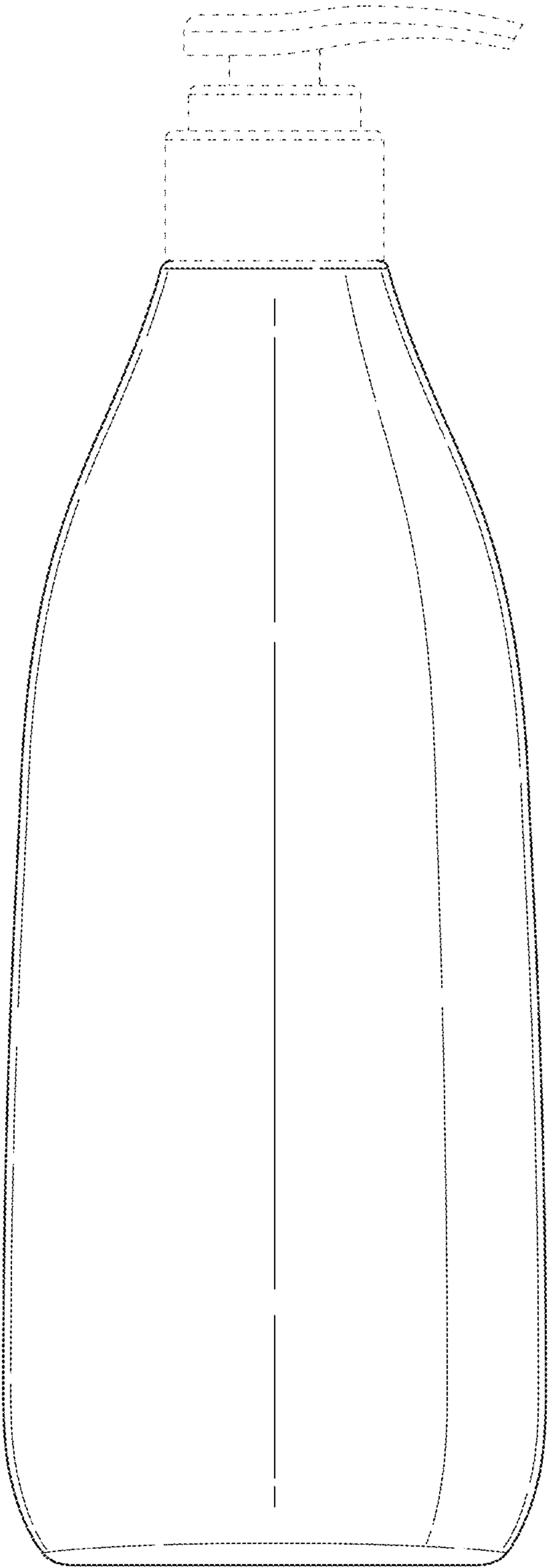

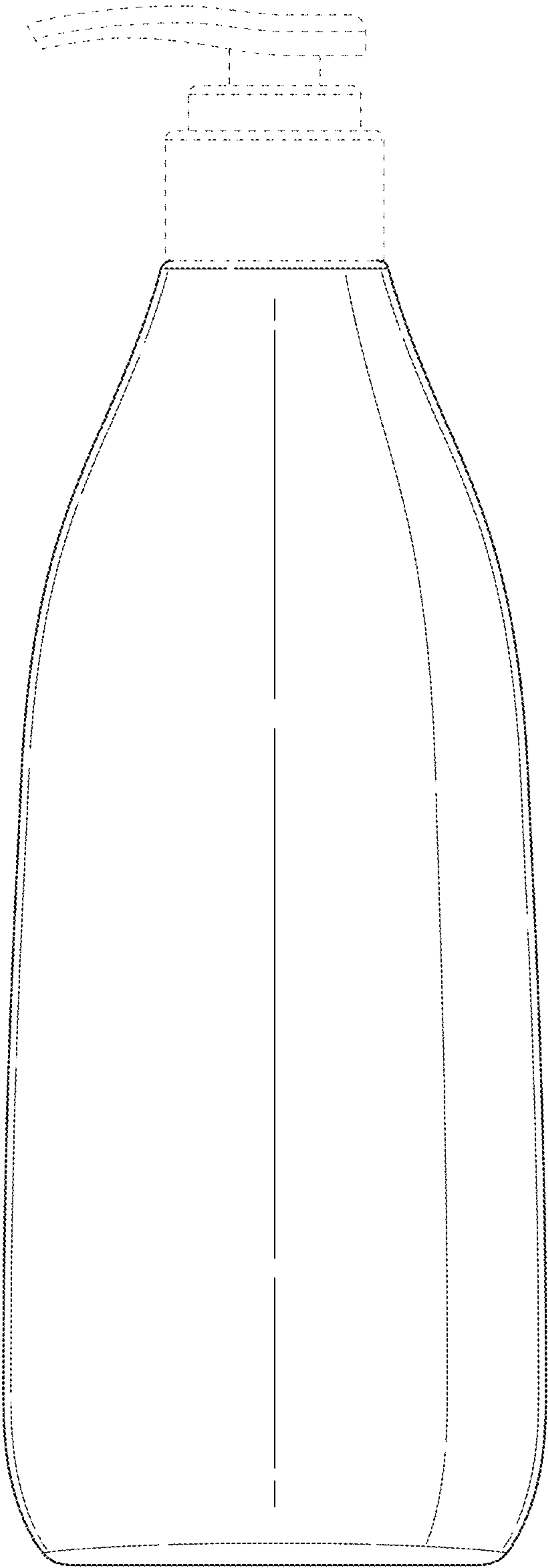

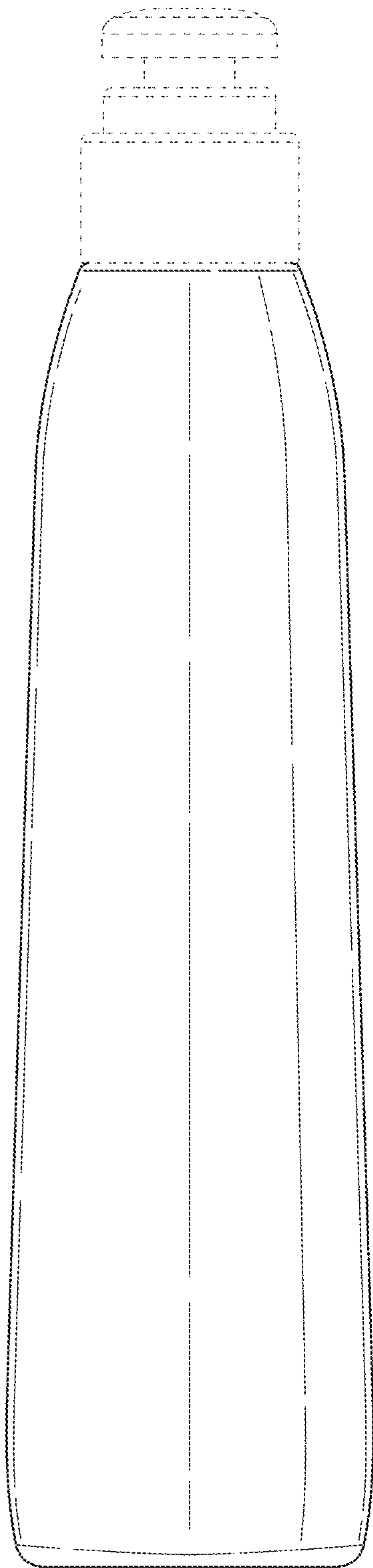

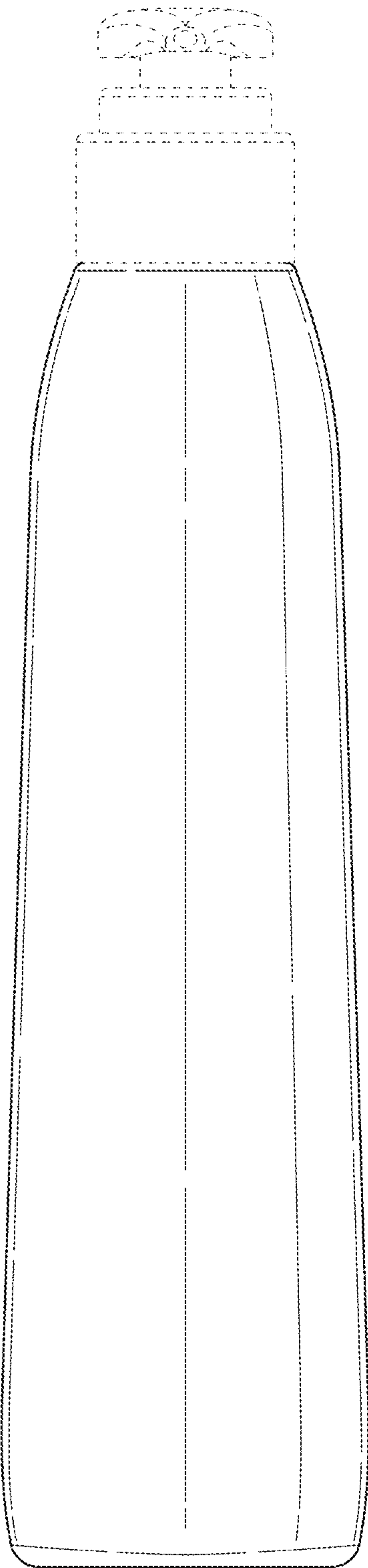

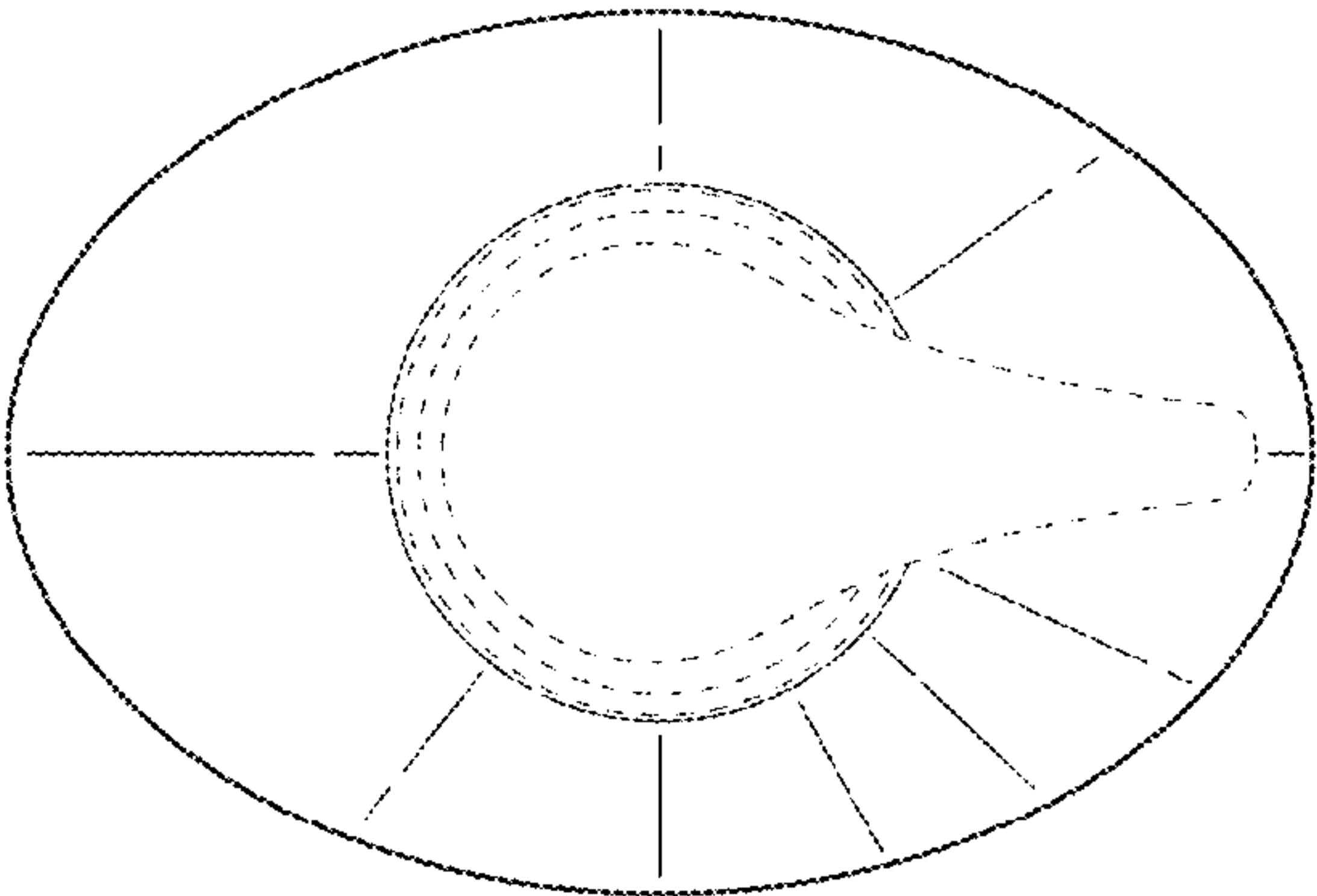

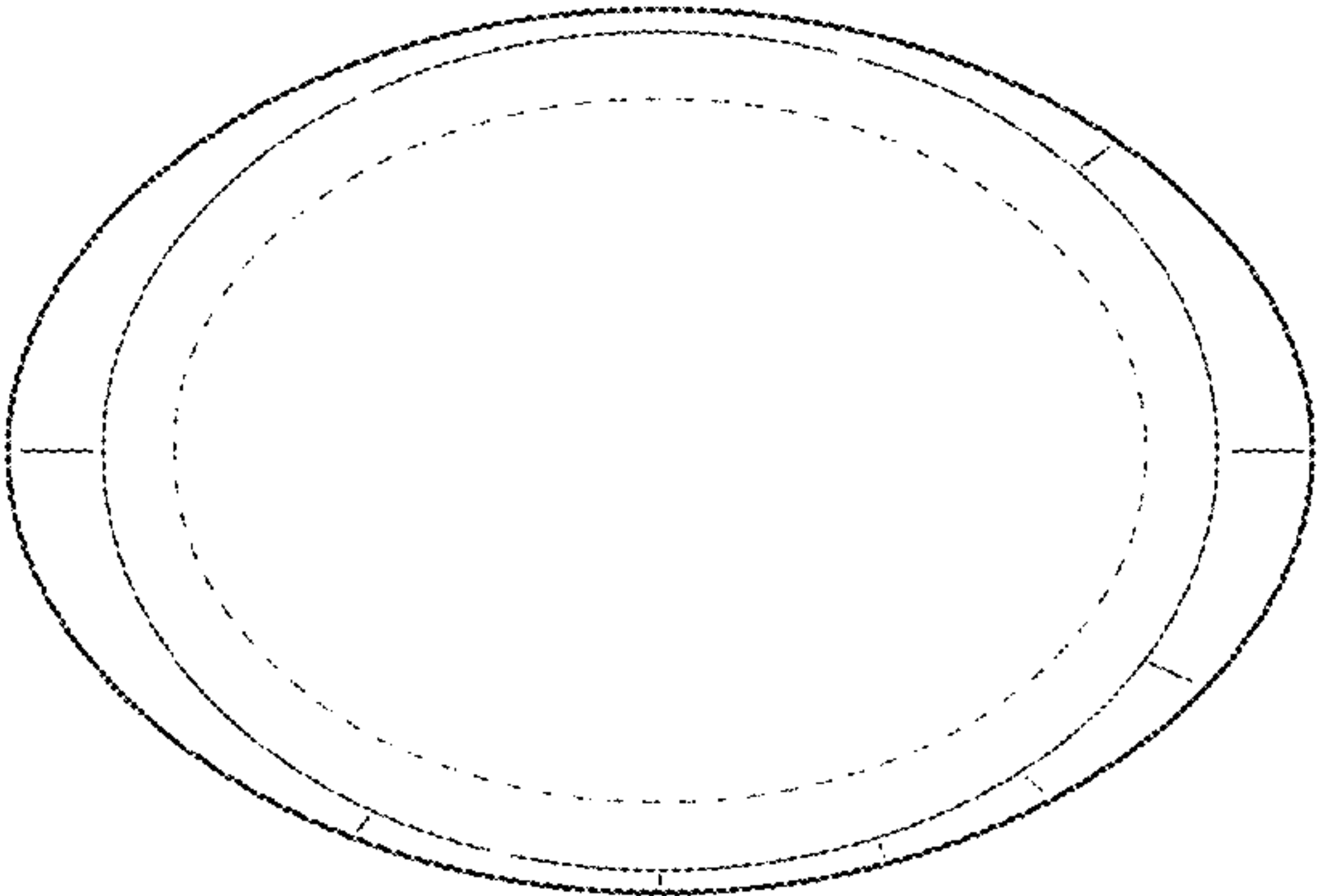
