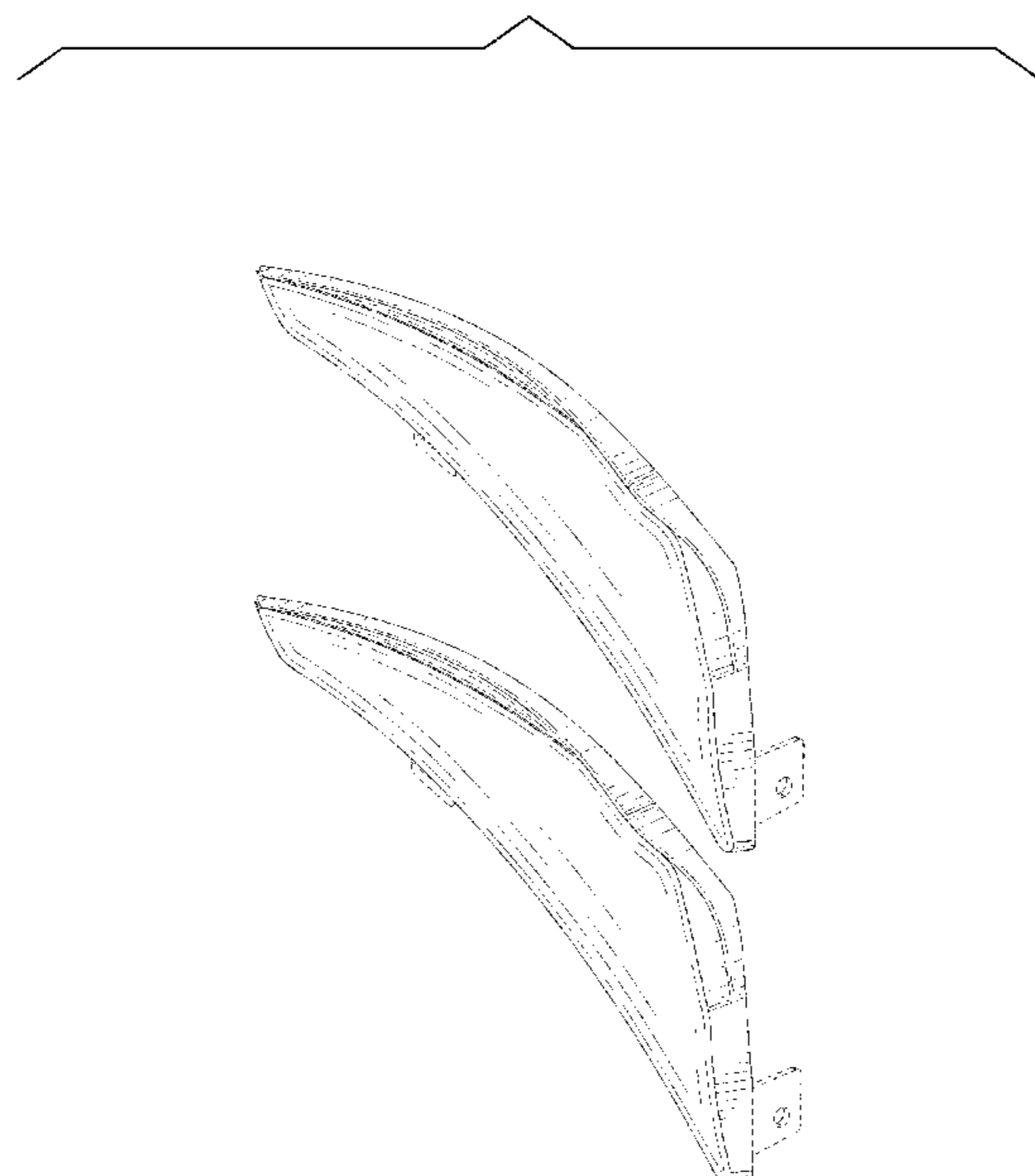
(57) **CLAIM**

The ornamental design for a mud flap set, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a mud flap set showing my new design;

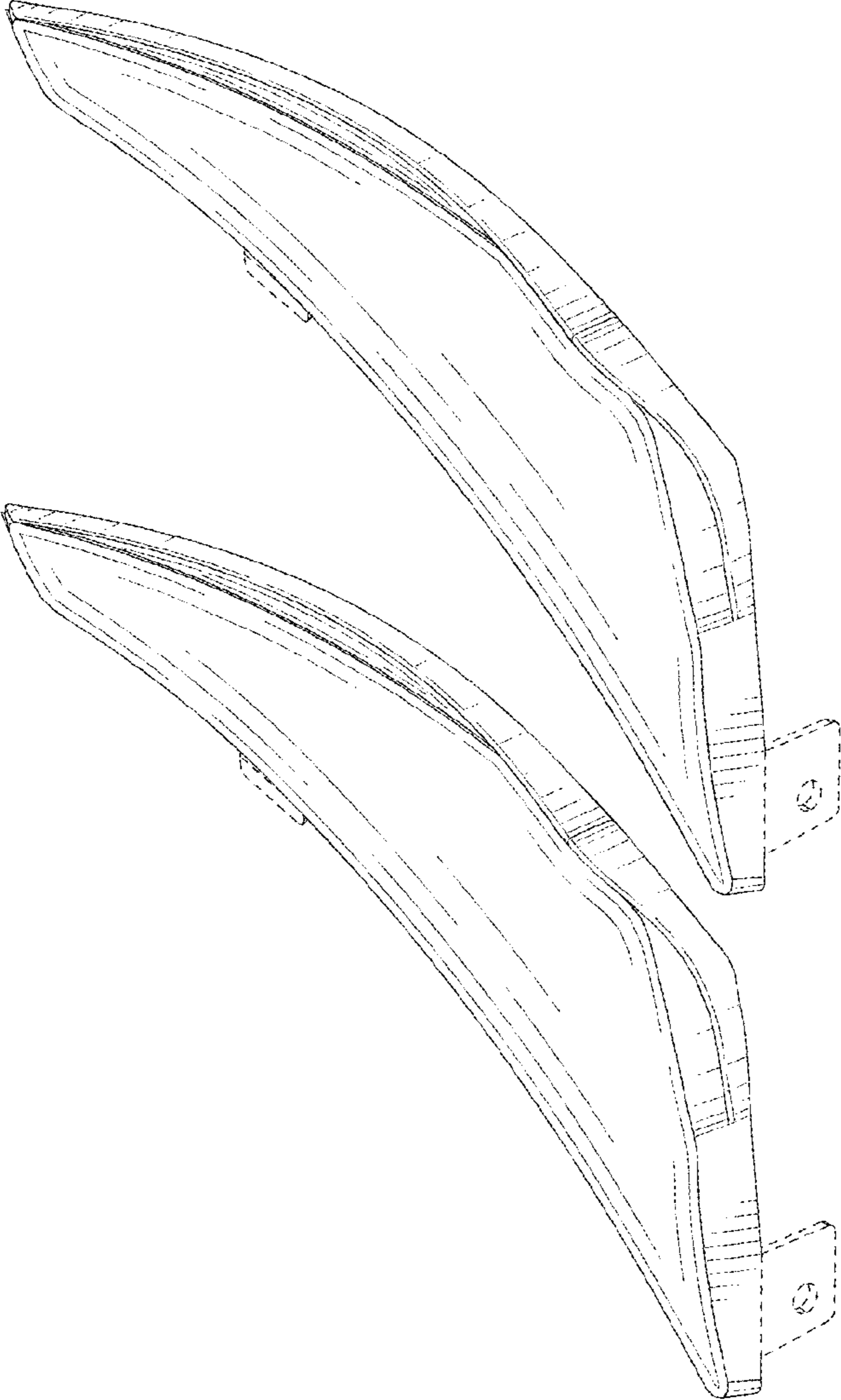
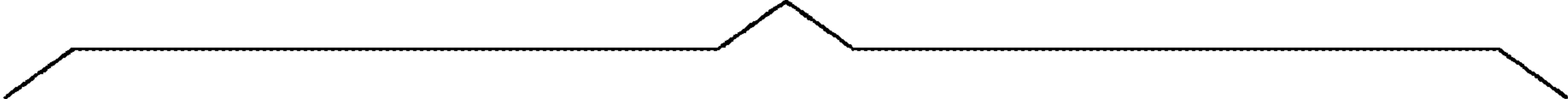

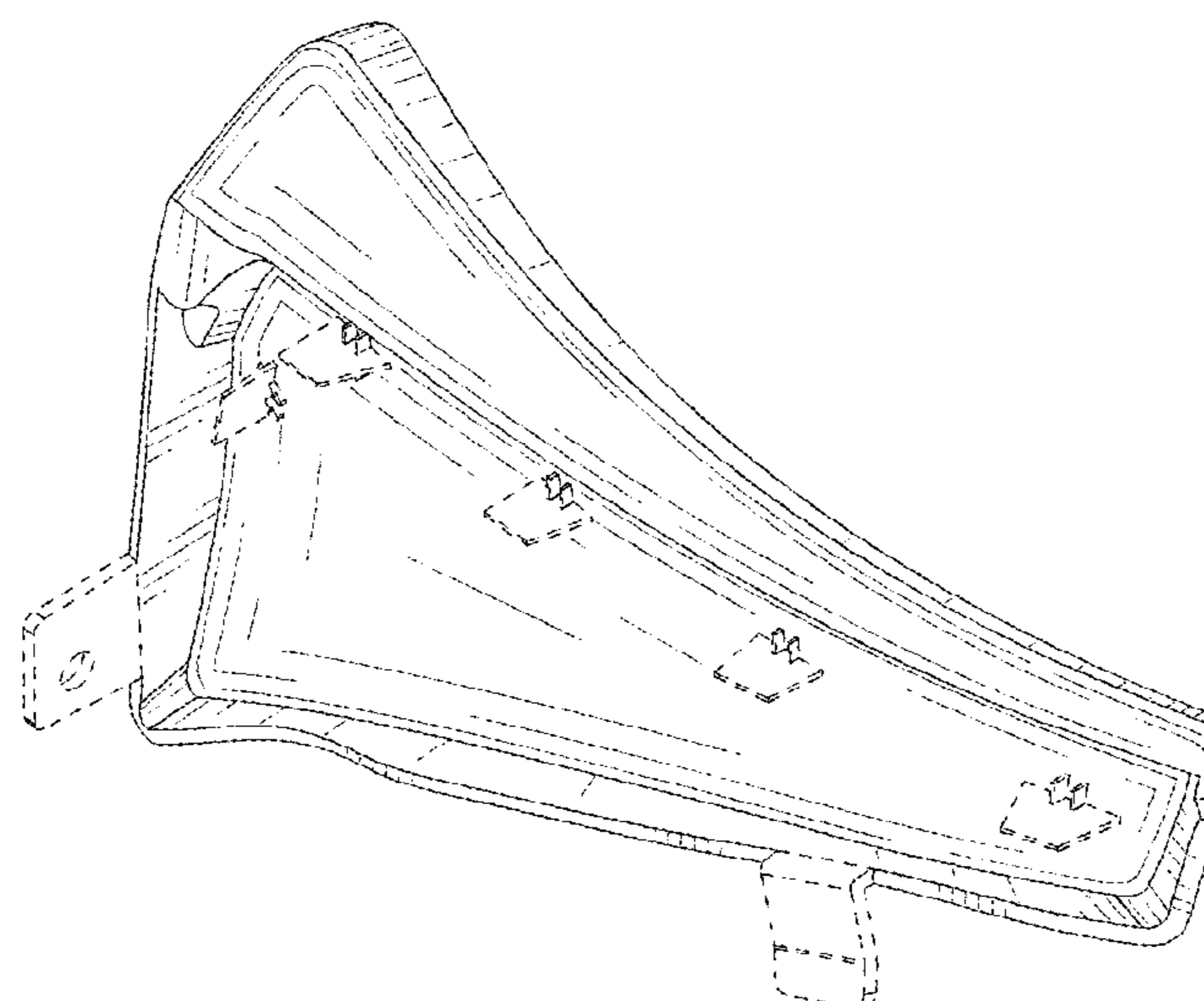
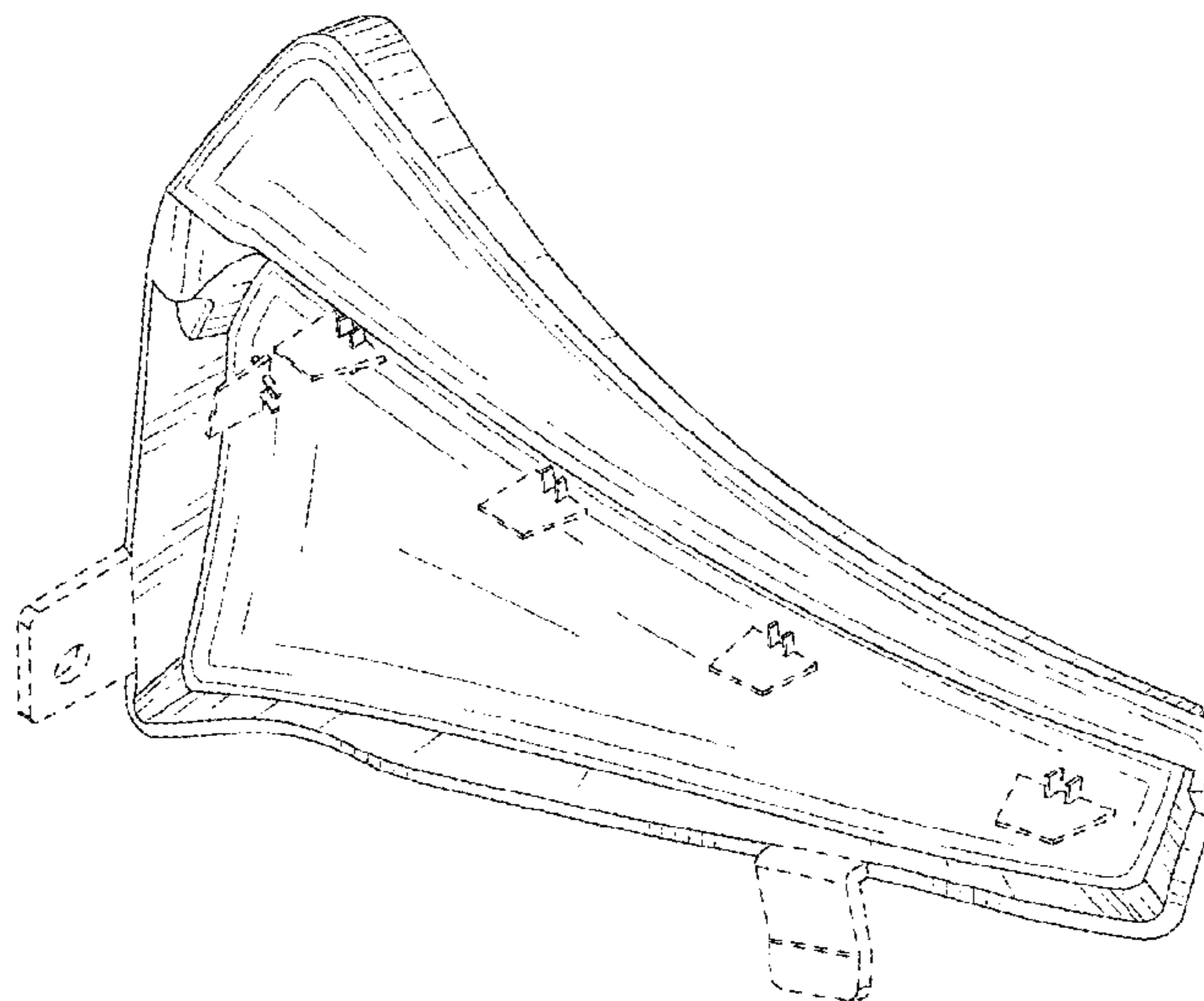

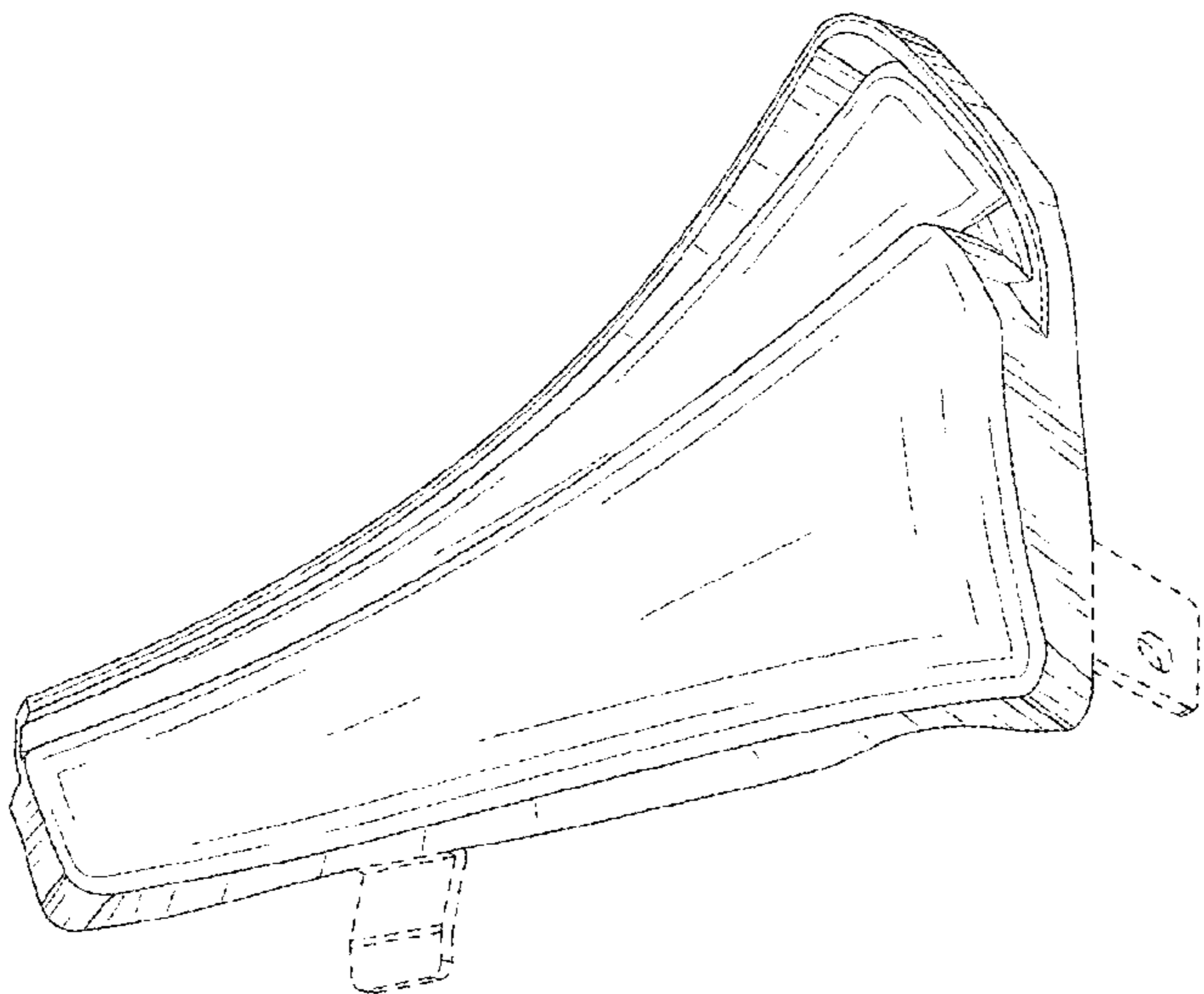
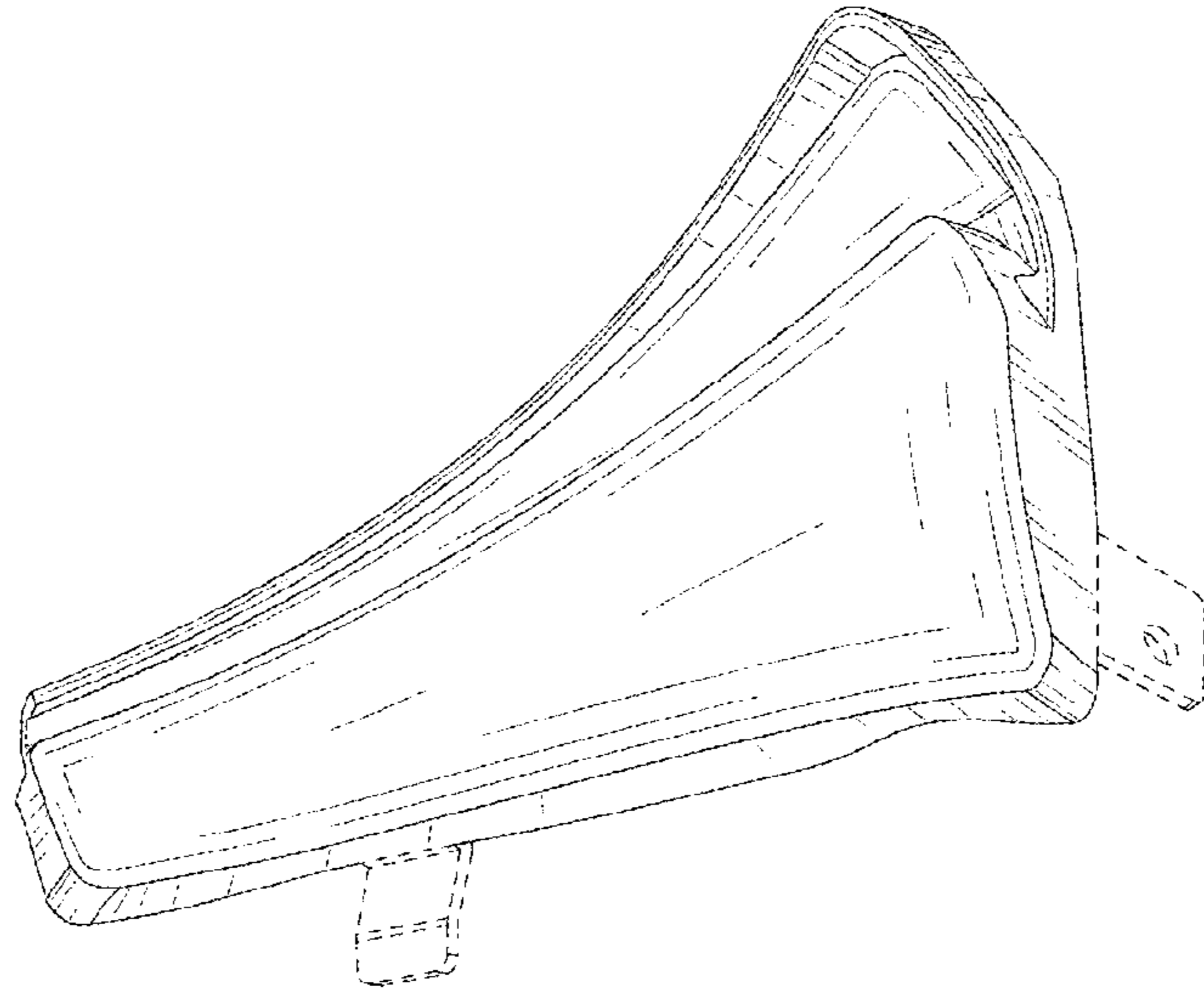

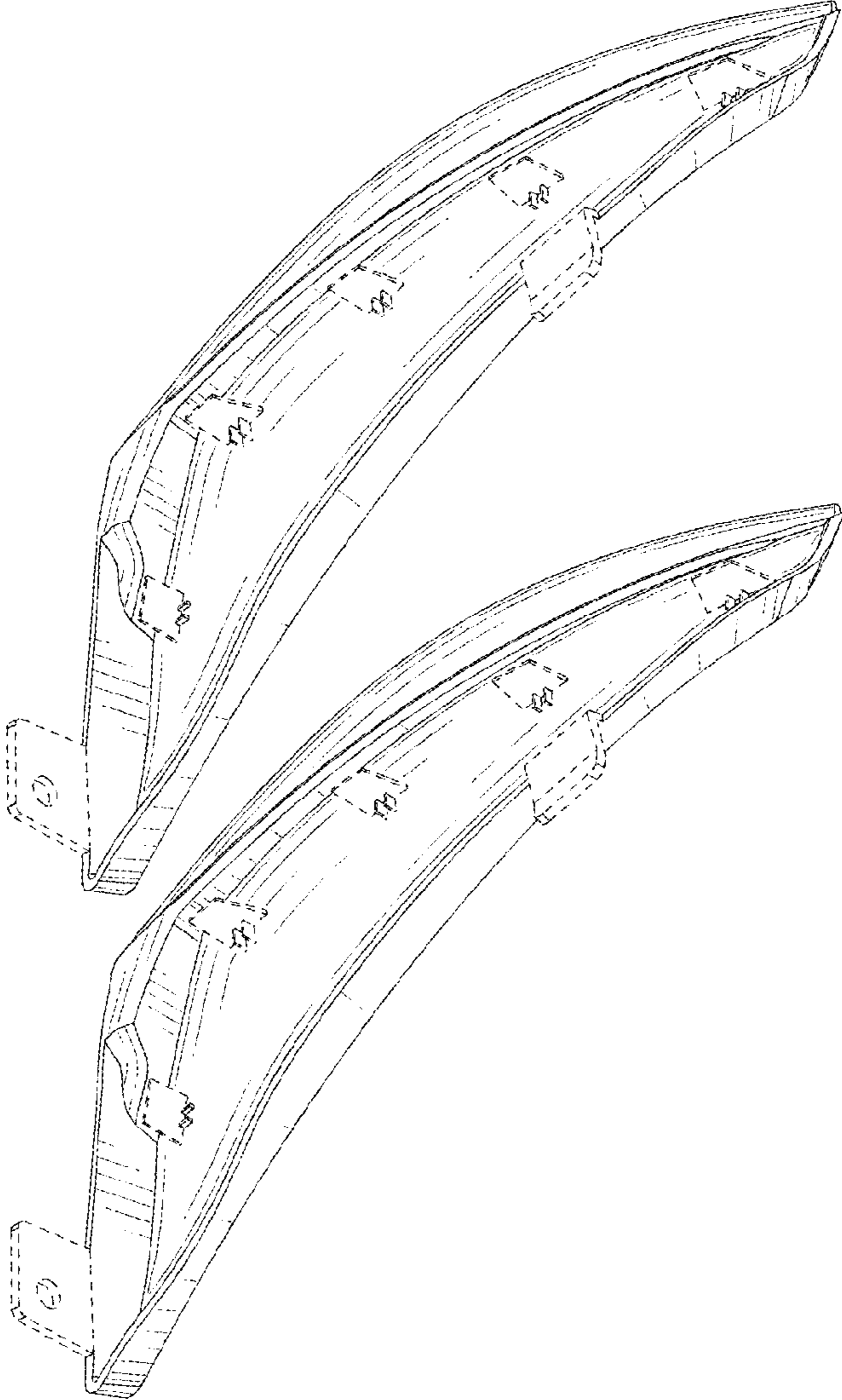
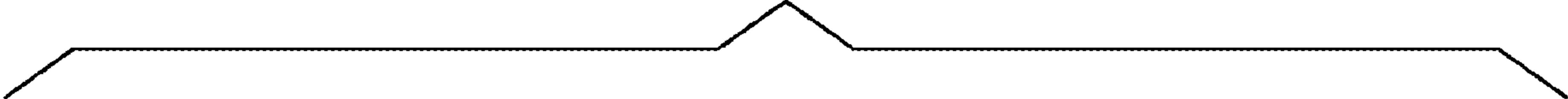

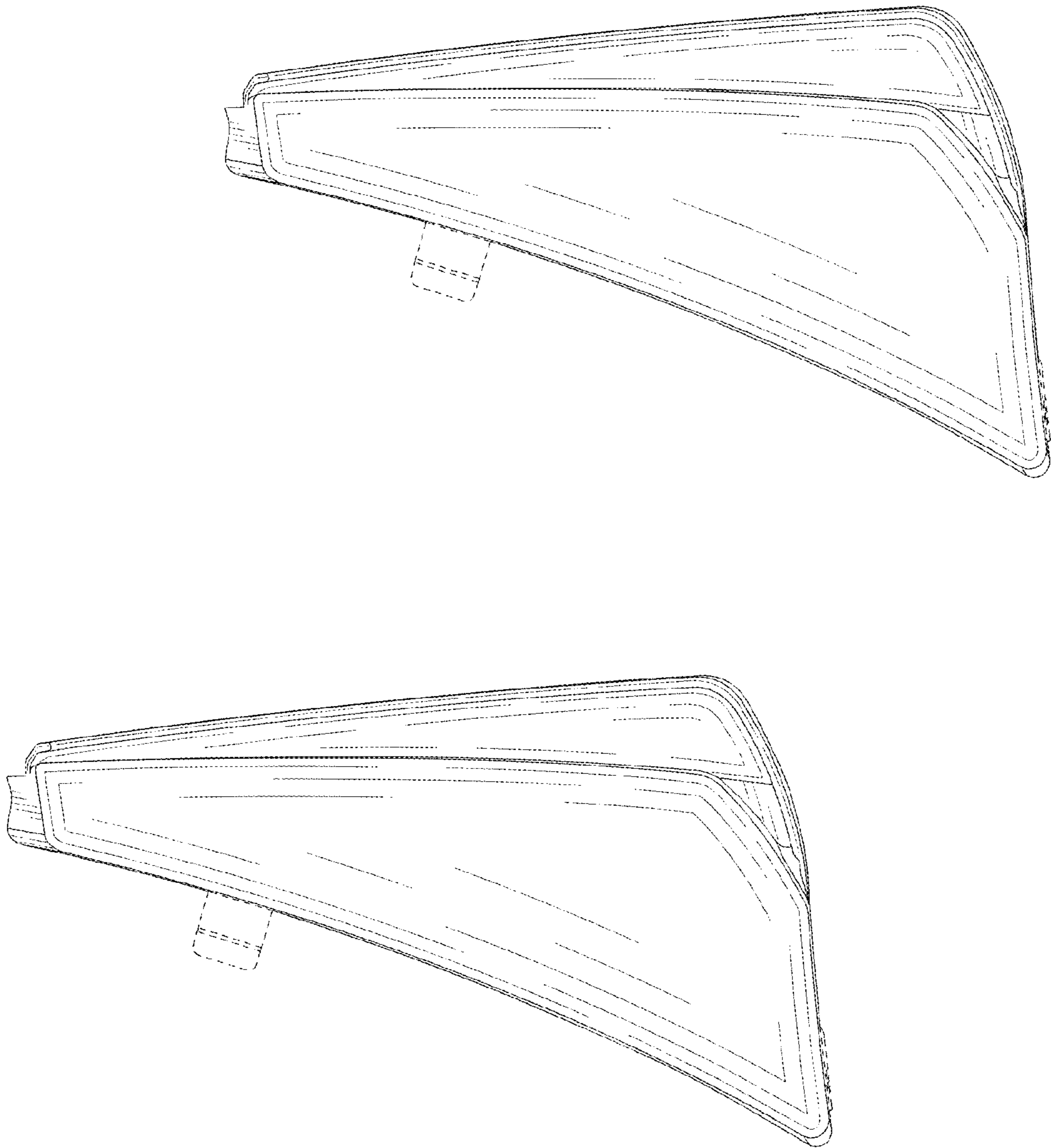

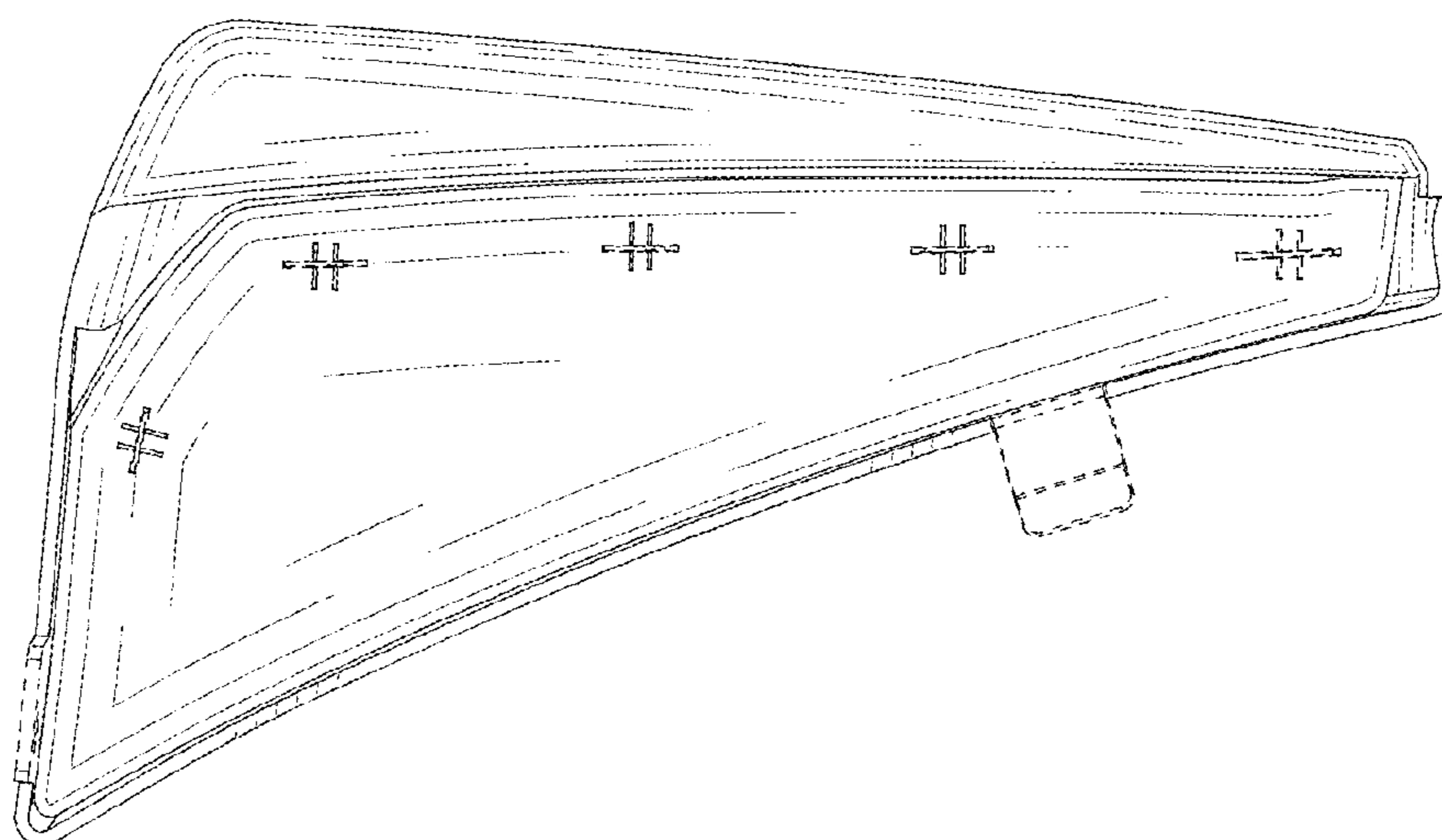
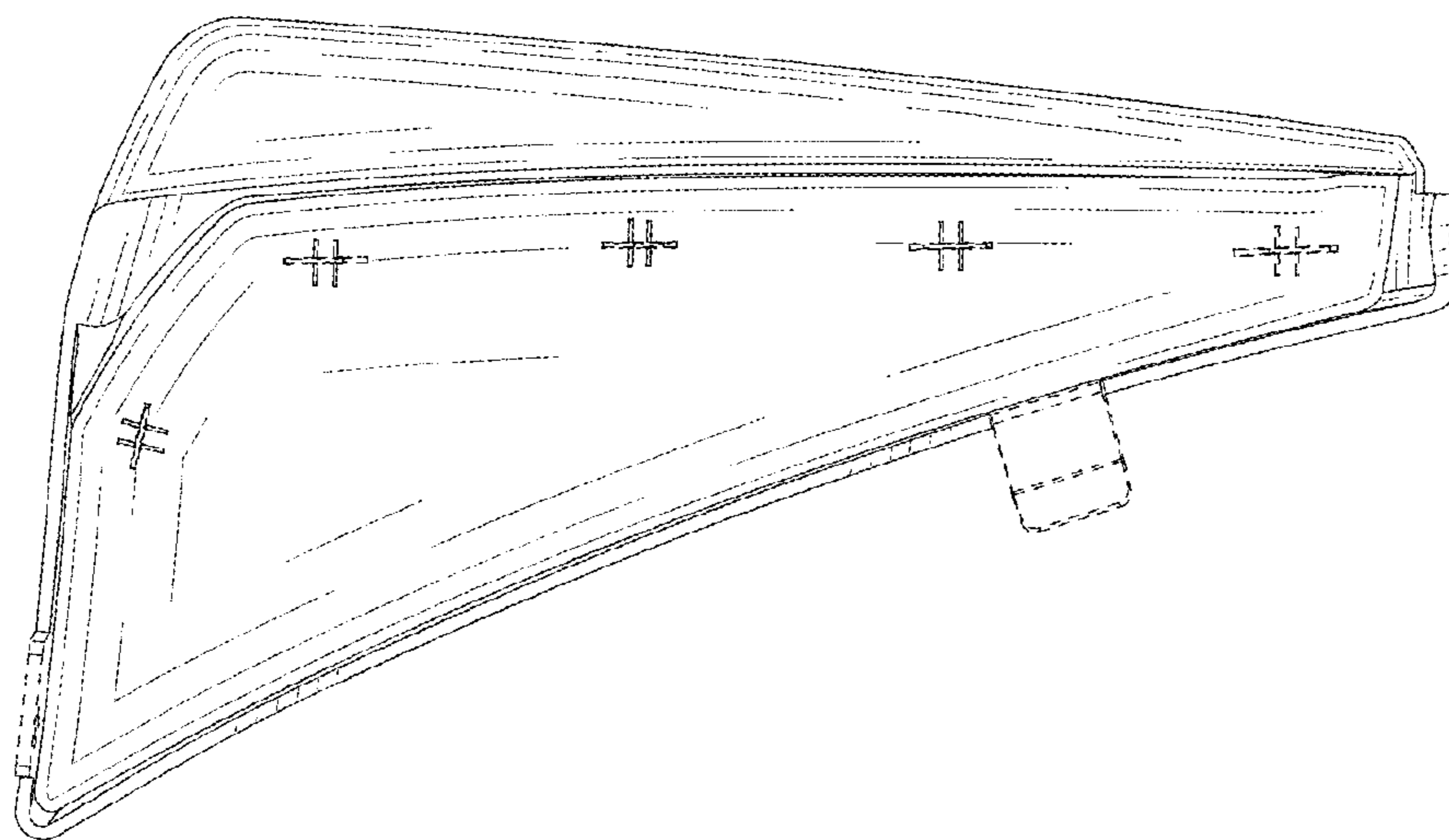

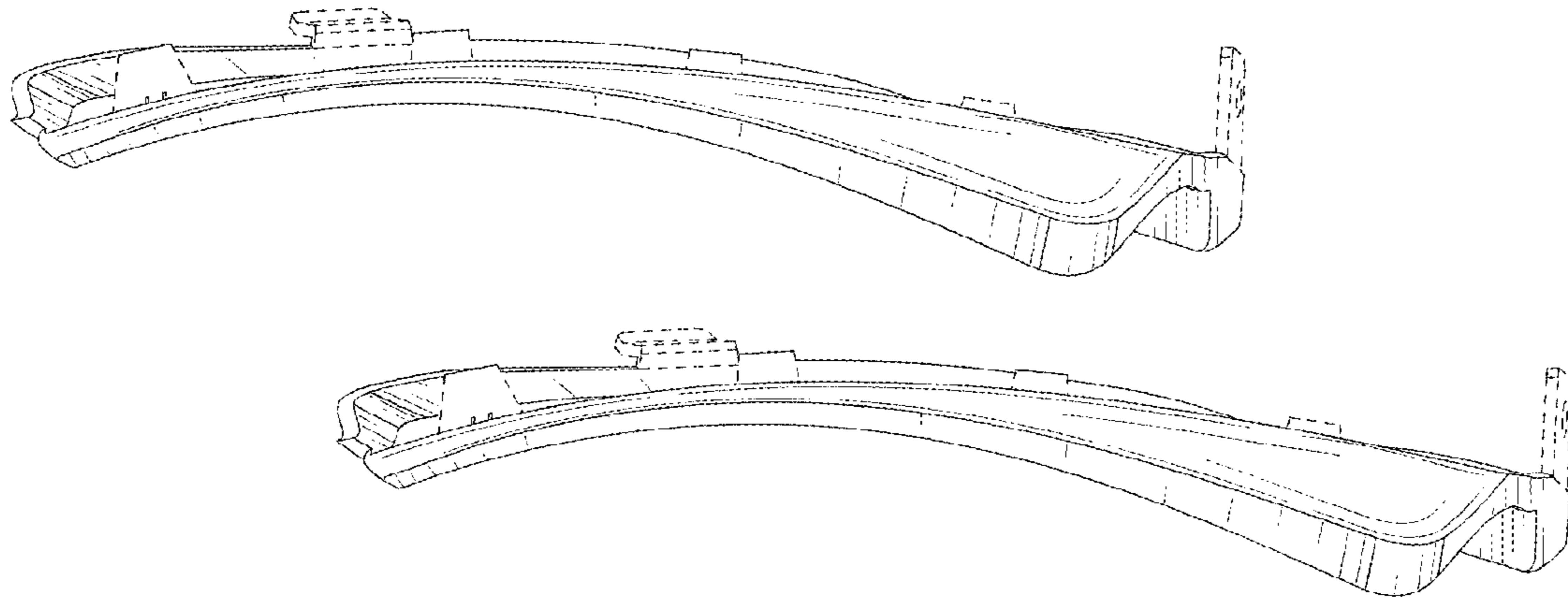
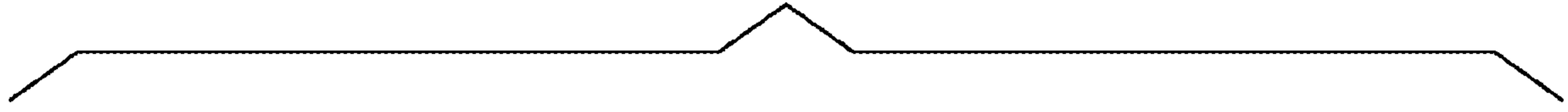

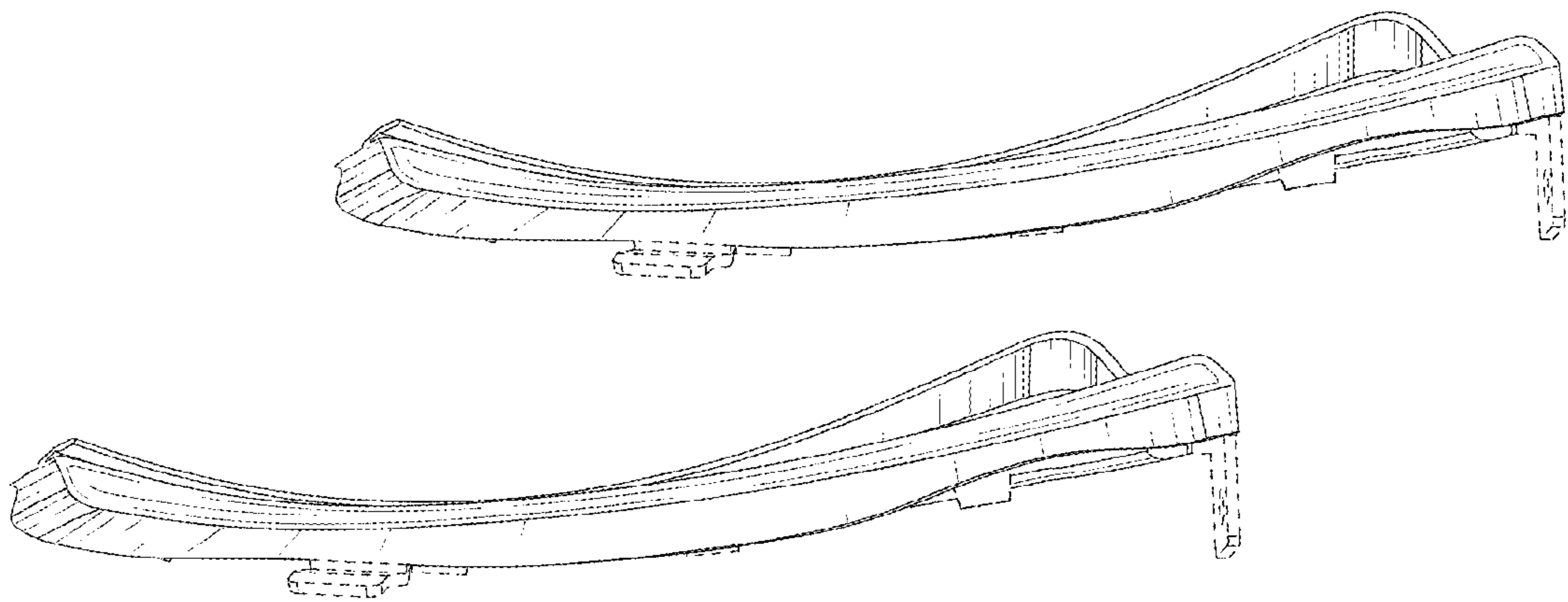
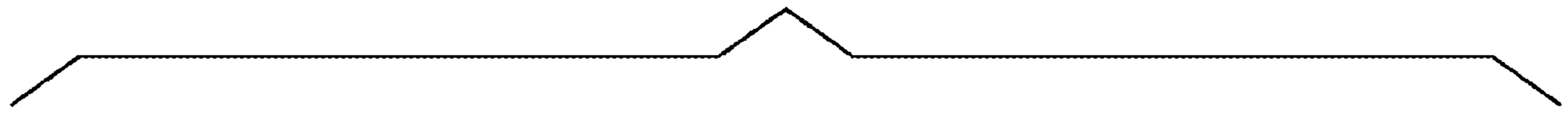

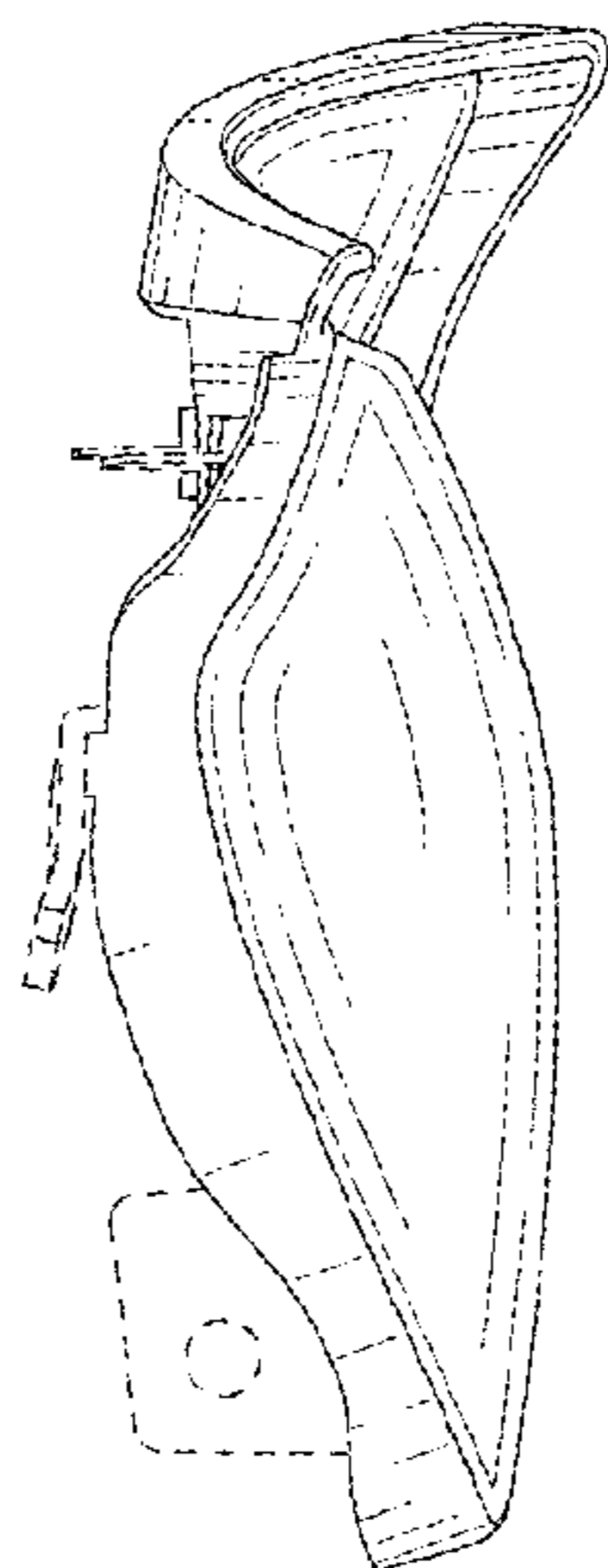
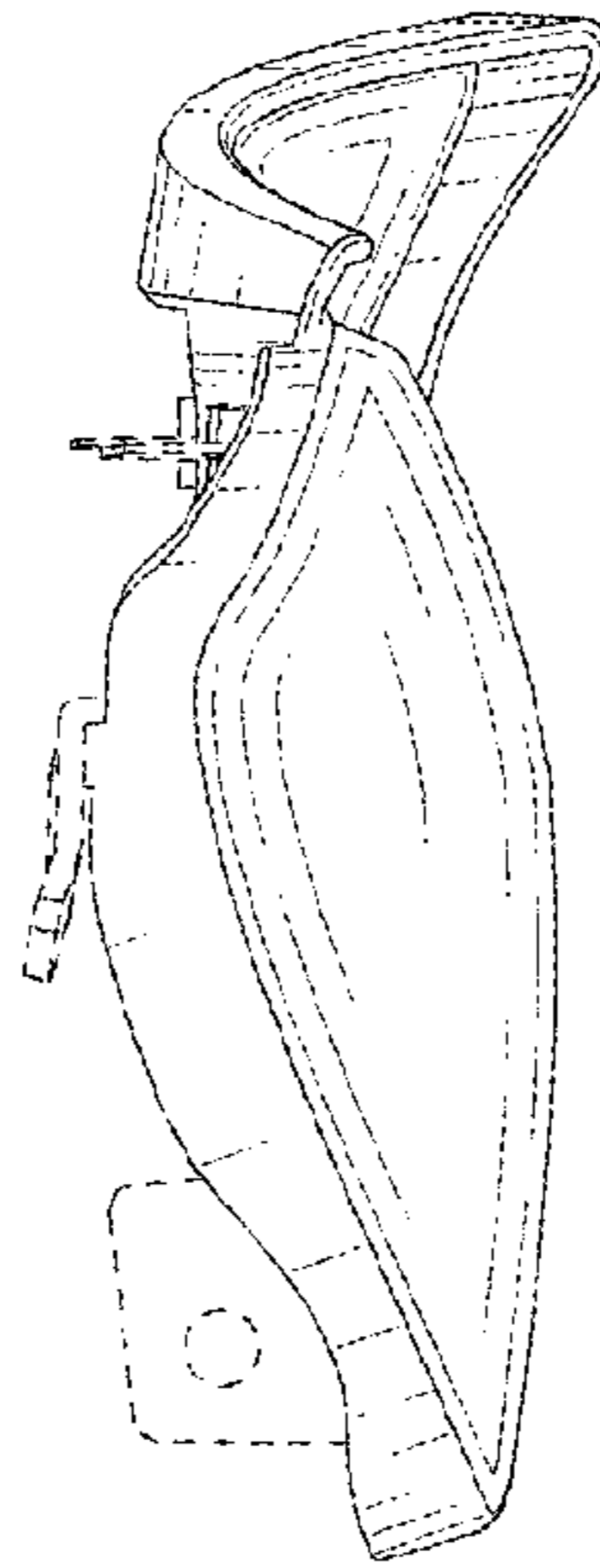

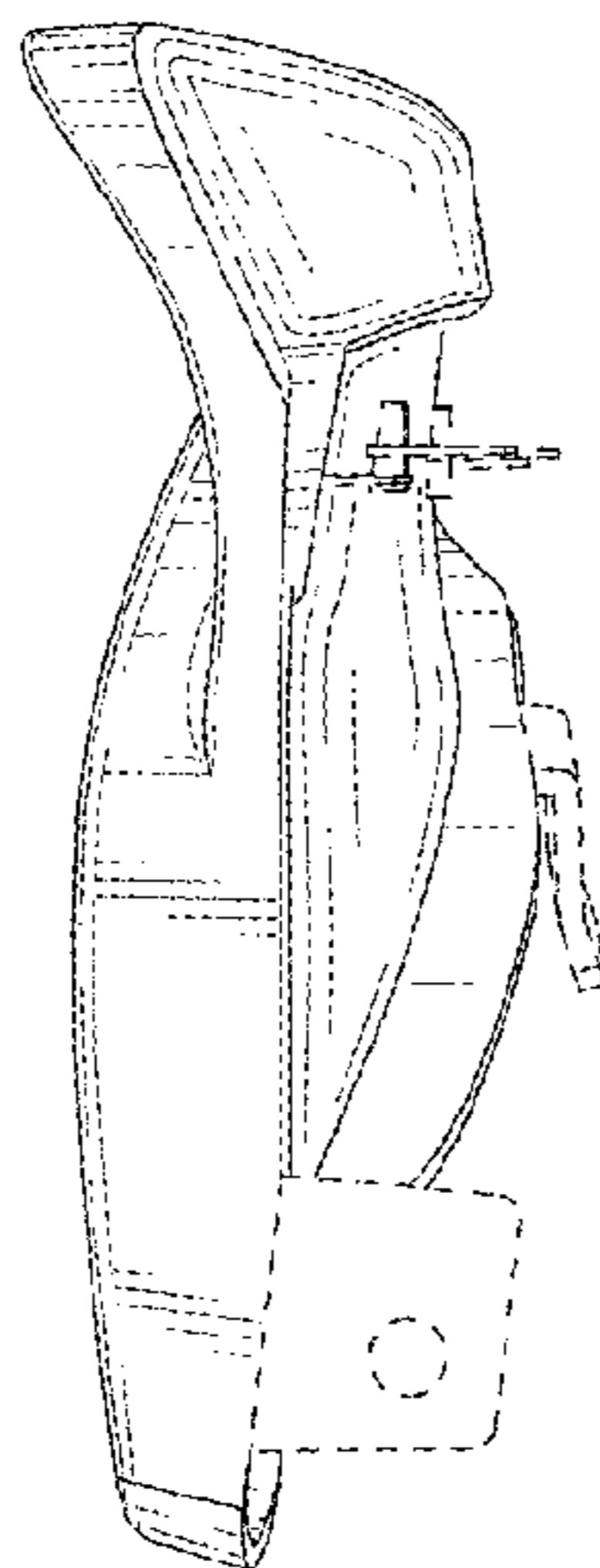
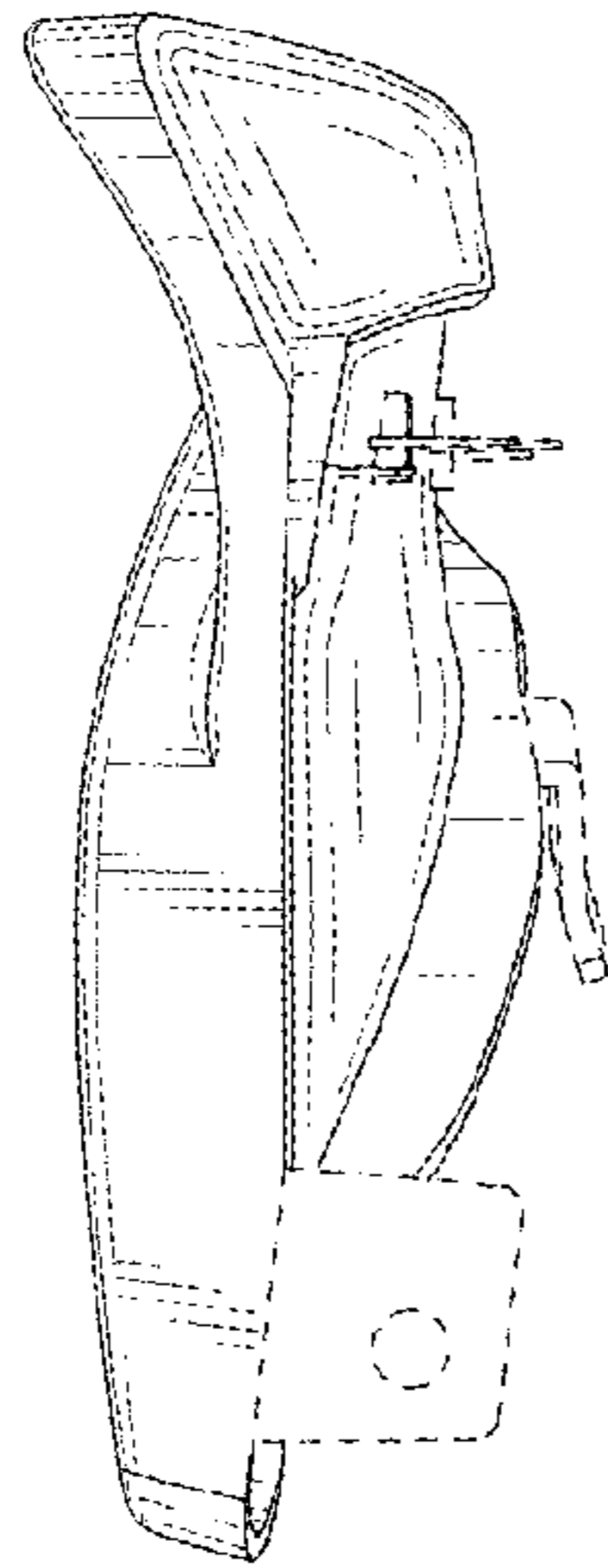
