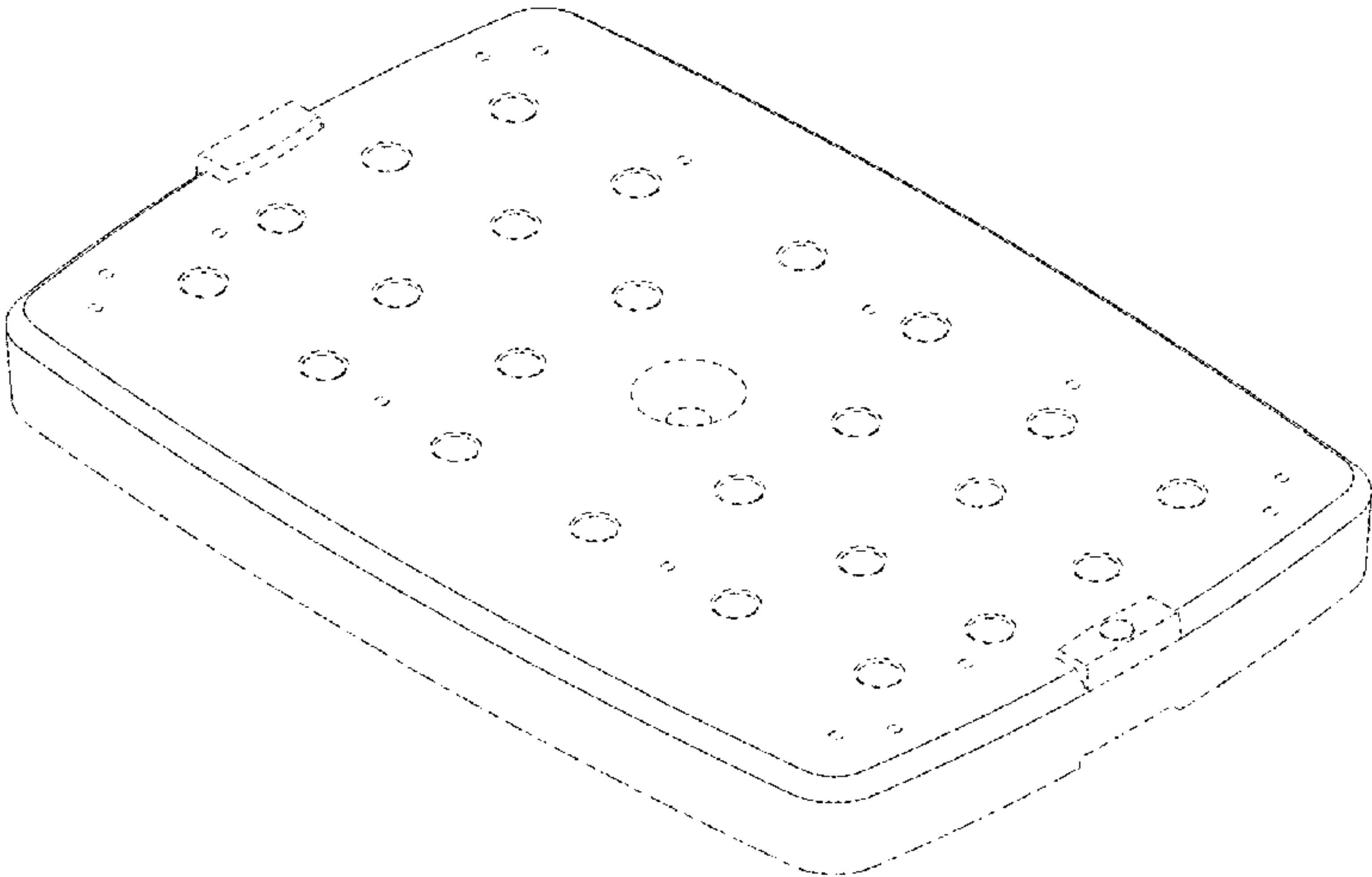
The ornamental design of a support member for a generator, as shown and described.

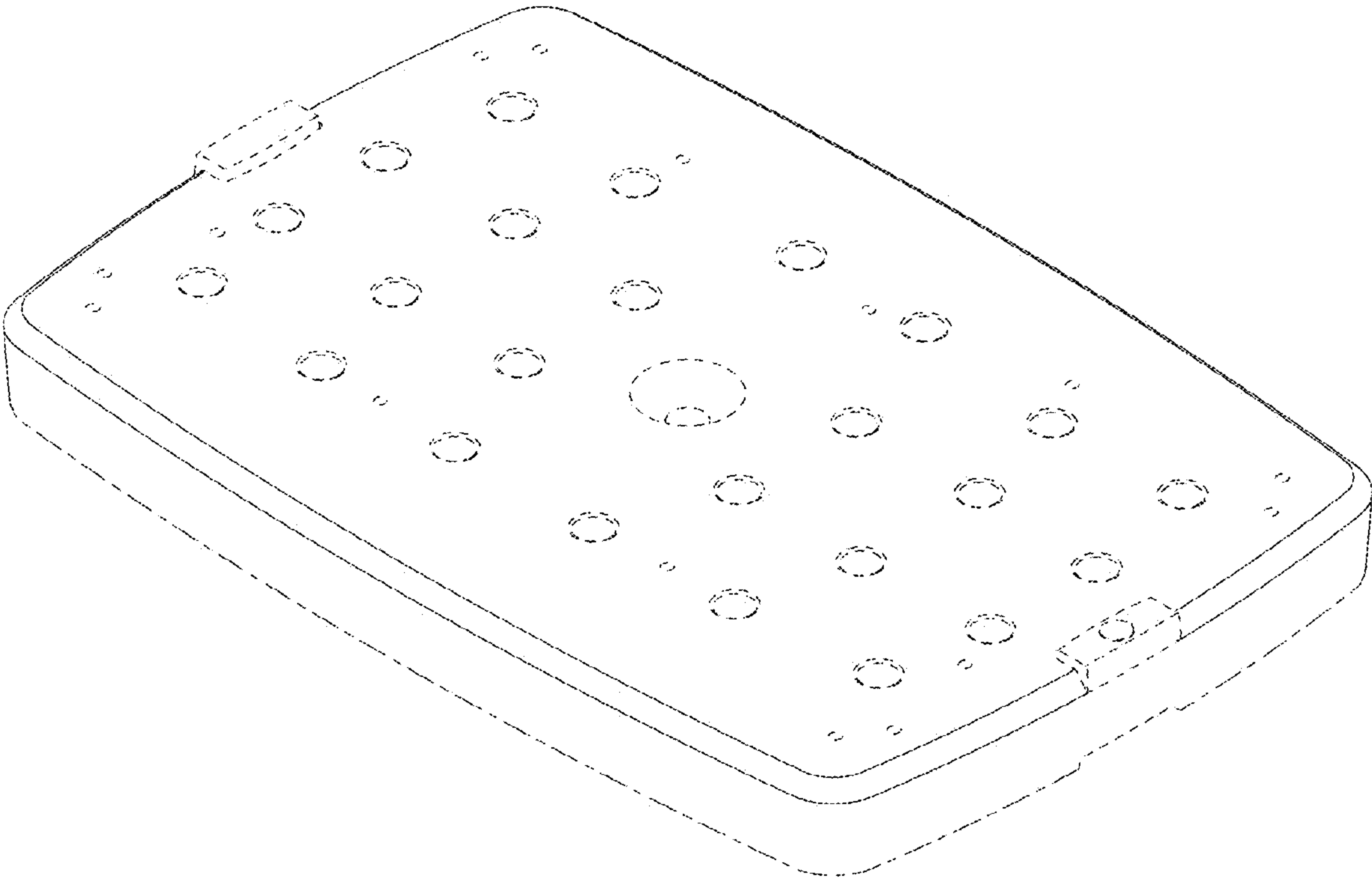

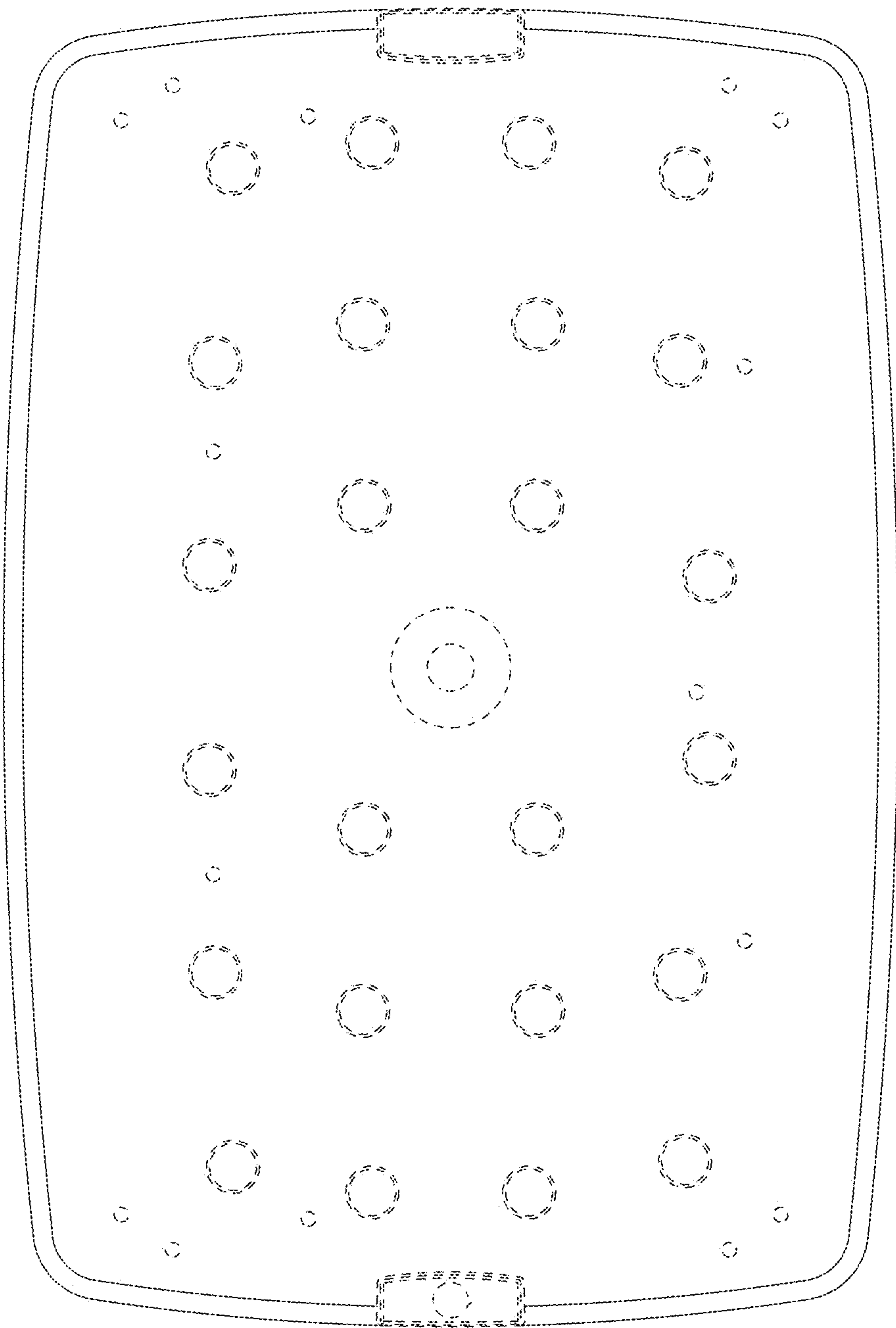

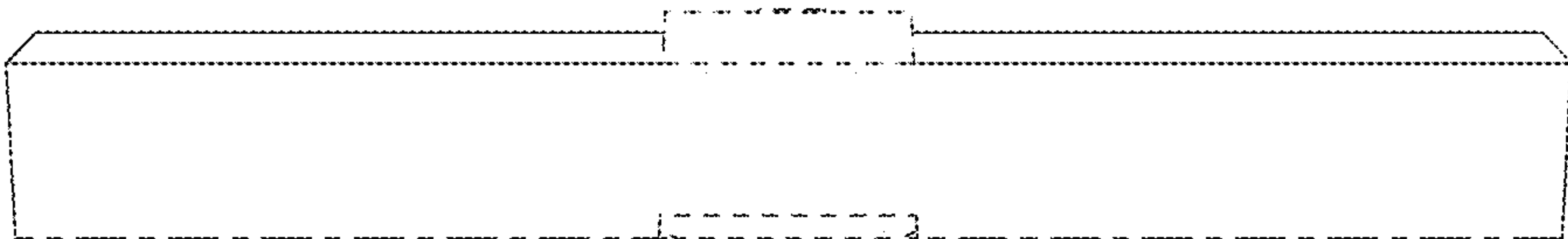

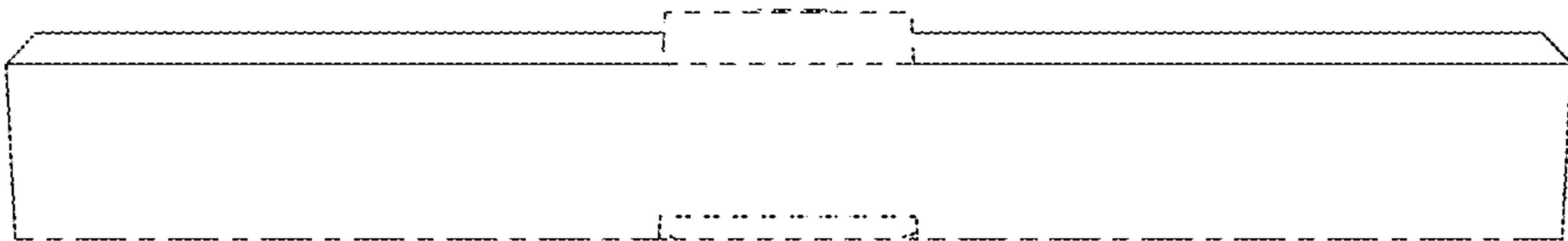

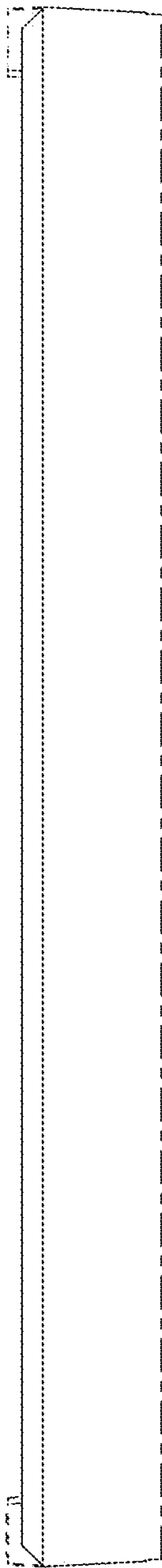

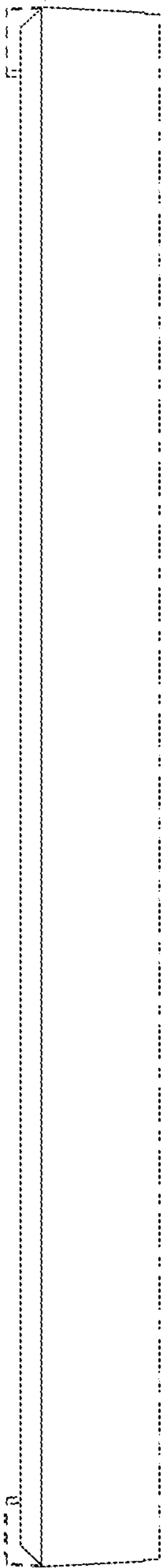

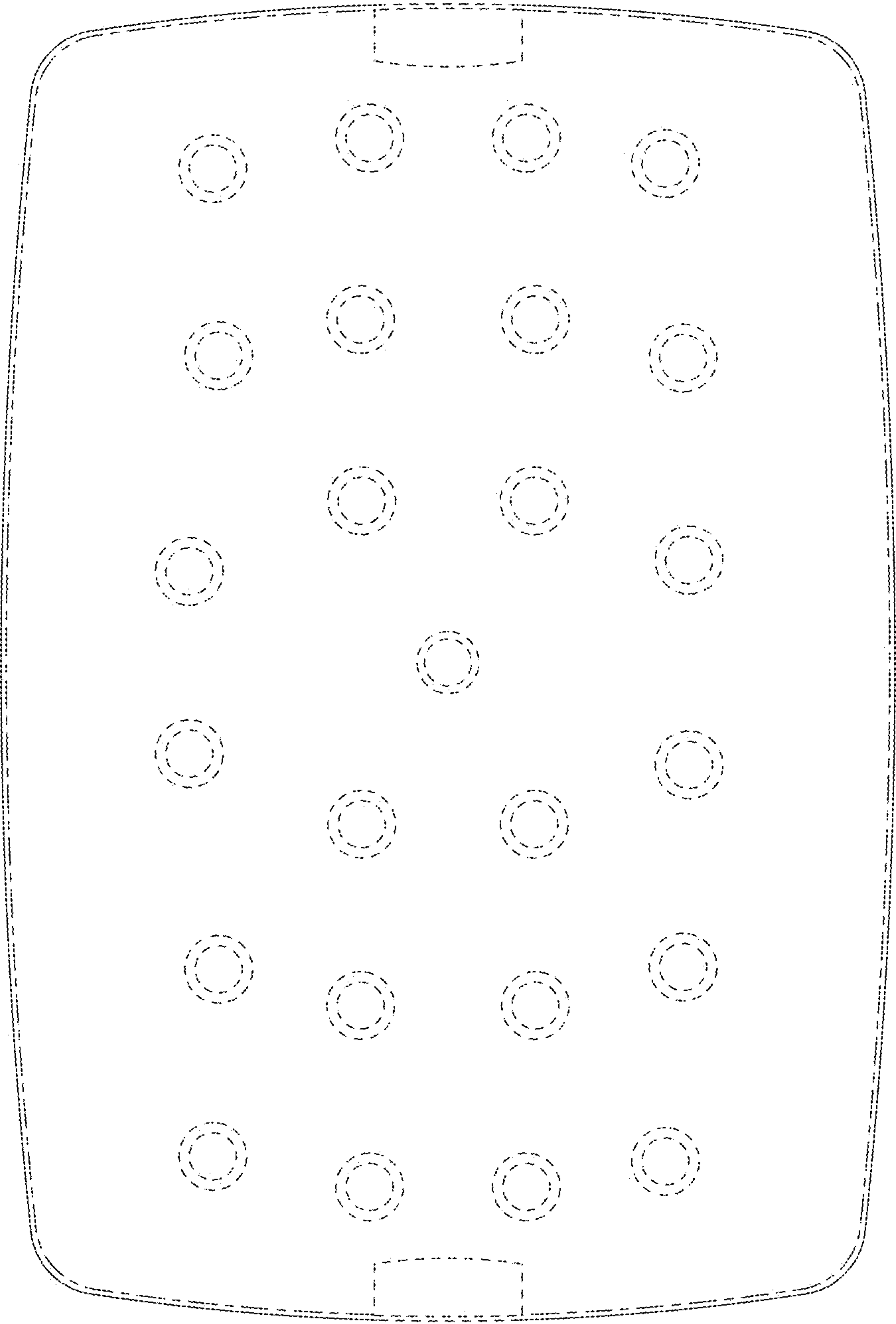
