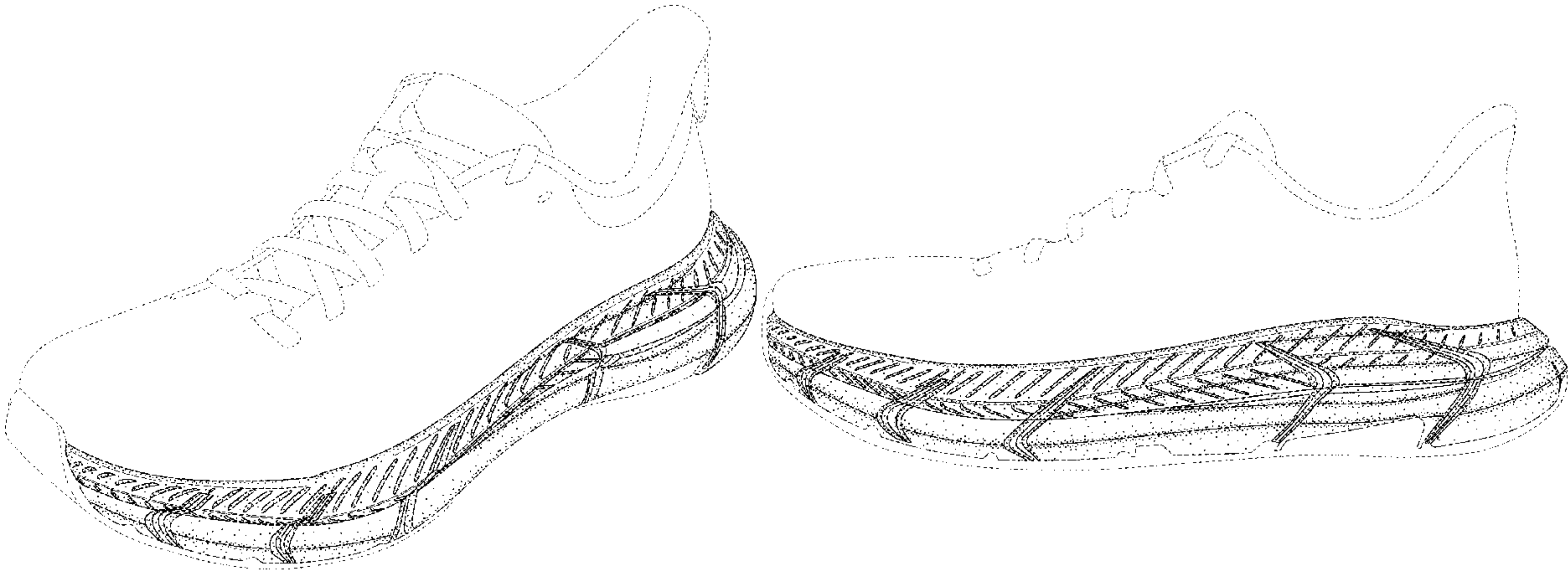
CLAIM

The ornamental design for a footwear midsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a footwear midsole showing my new design;
FIG. 2 is a rear perspective view thereof;

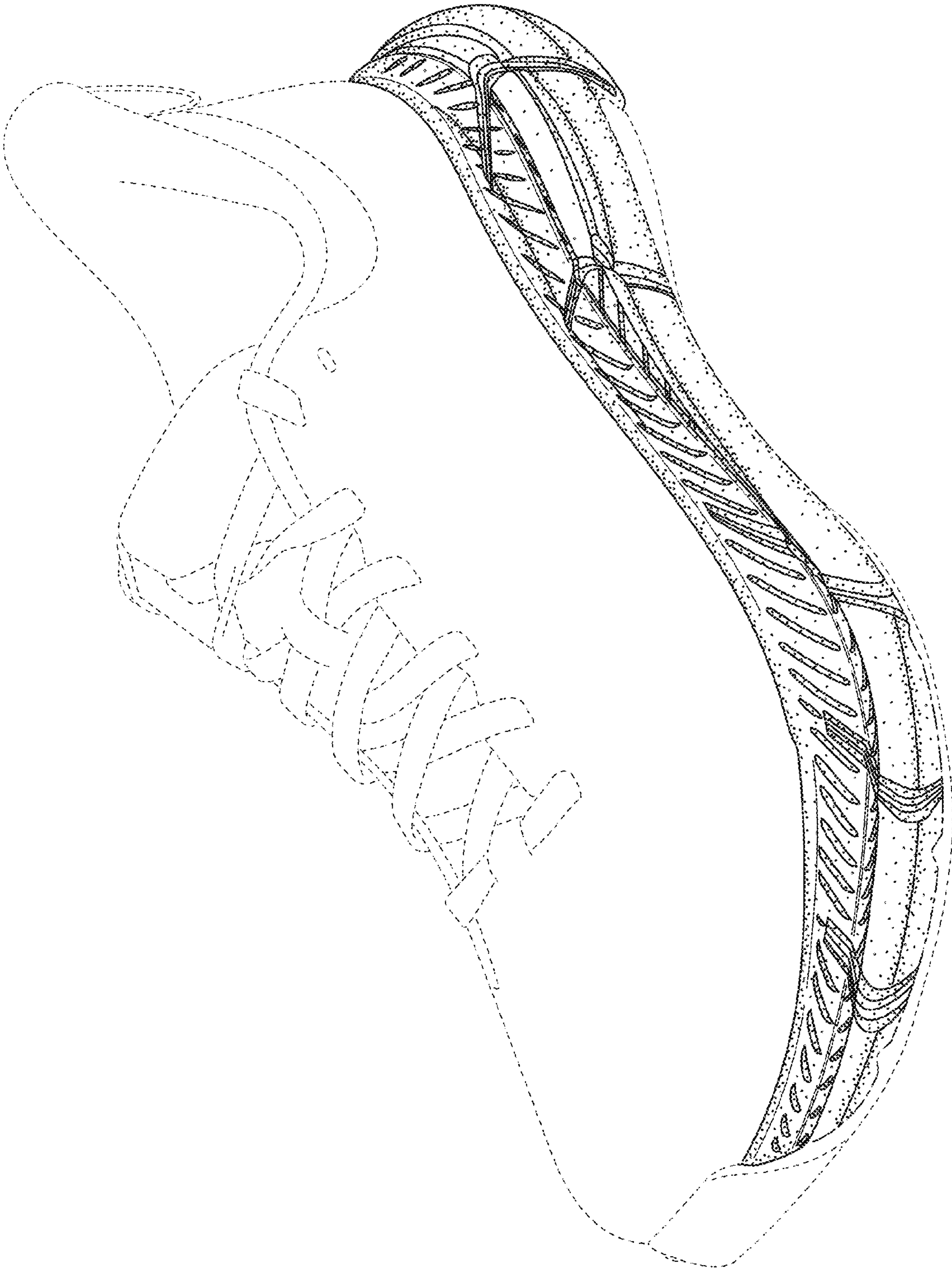

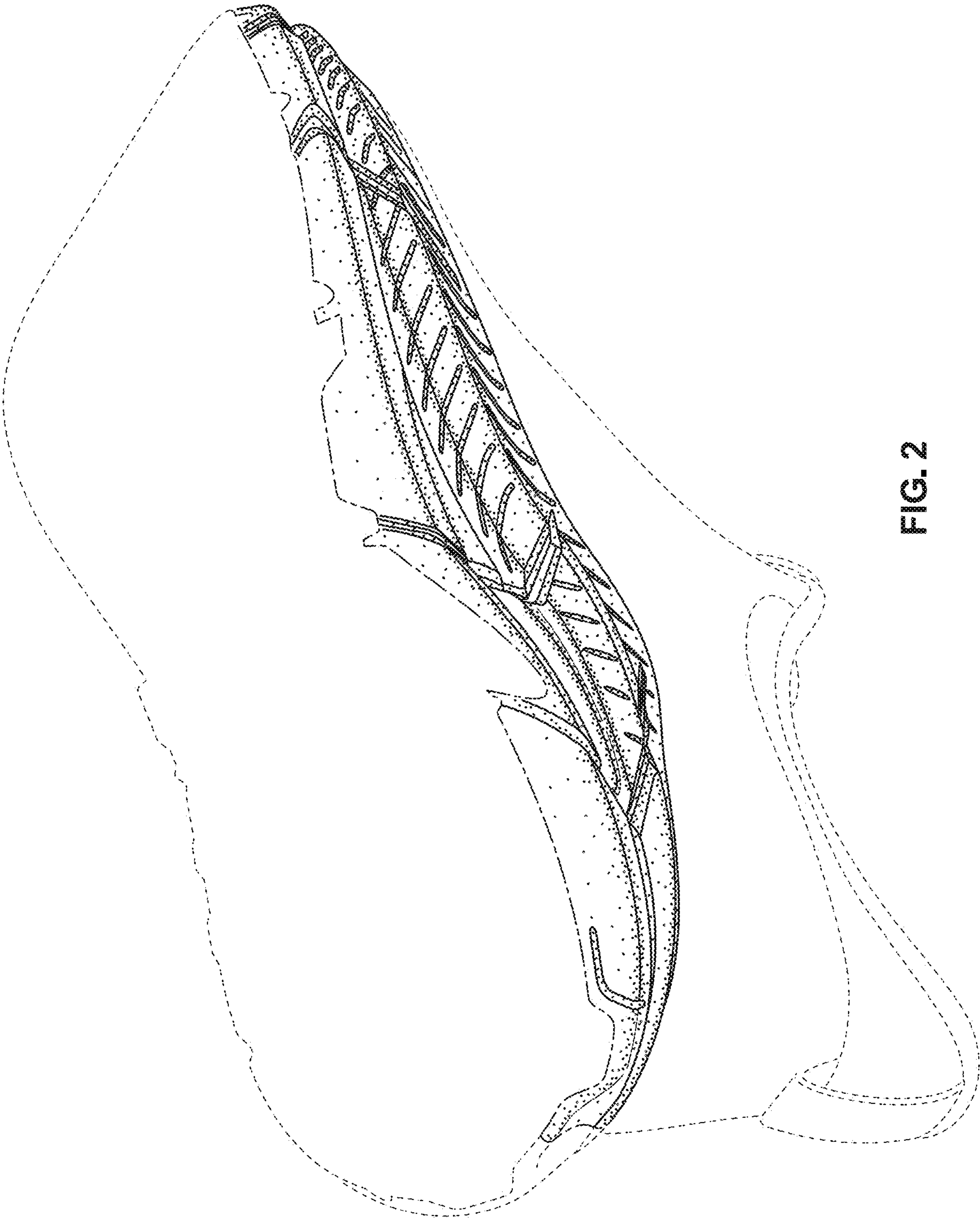

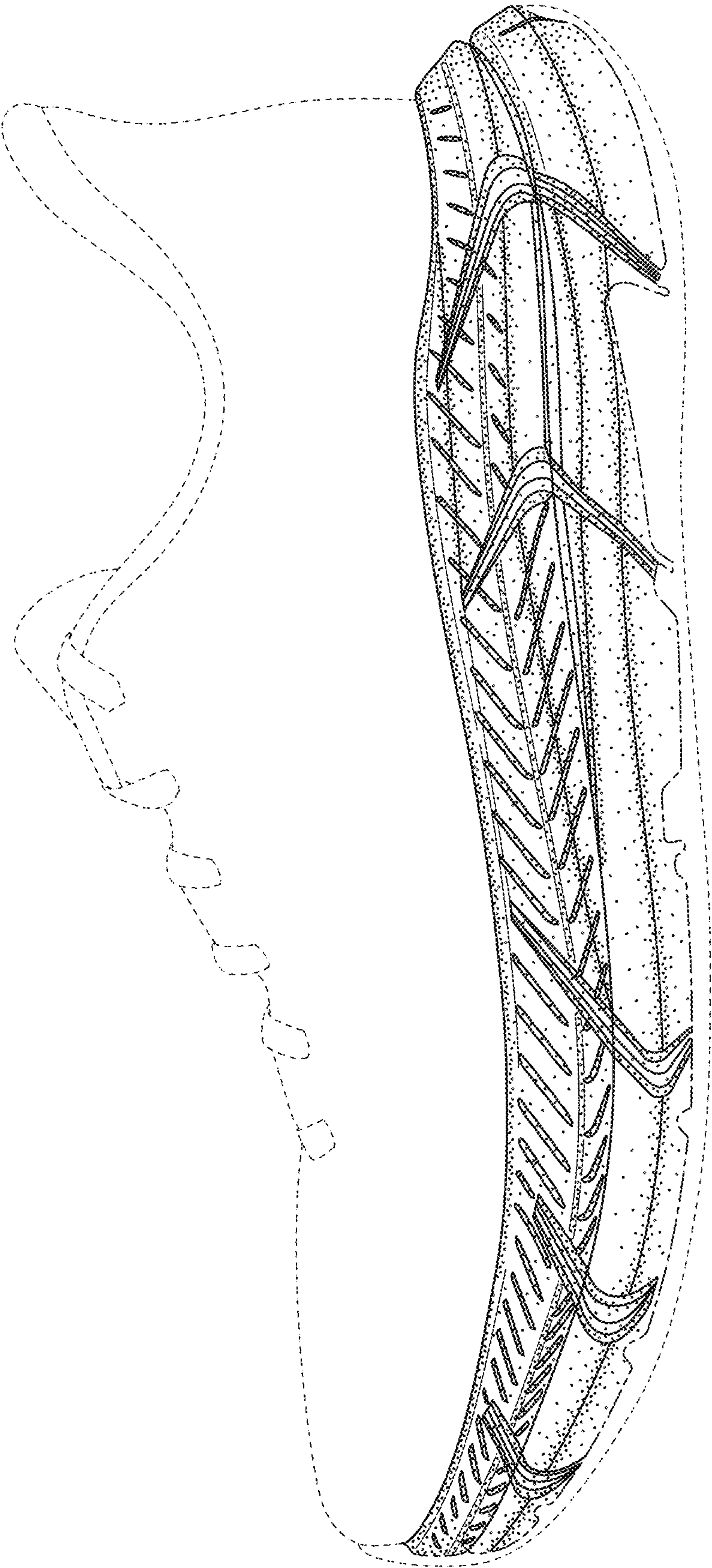

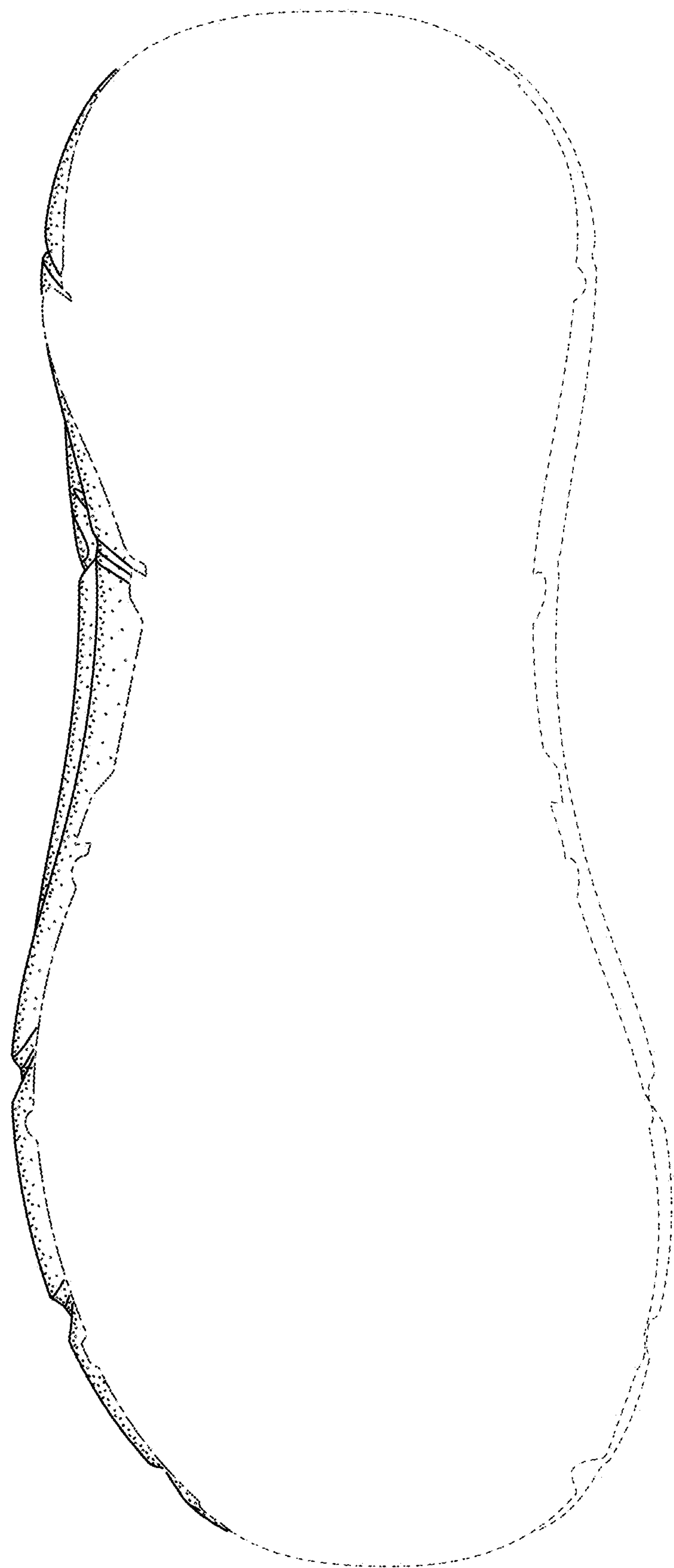
