(57) CLAIM

The ornamental design for a lever compression latch, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a lever compression latch, according to a first exemplary embodiment of the invention; FIG. 2 is a rear isometric view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a right elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. In the drawings, the broken lines indicate environmental structure that forms no part of the claimed design. The dash-dot lines indicate the boundaries of the claimed subject matter.

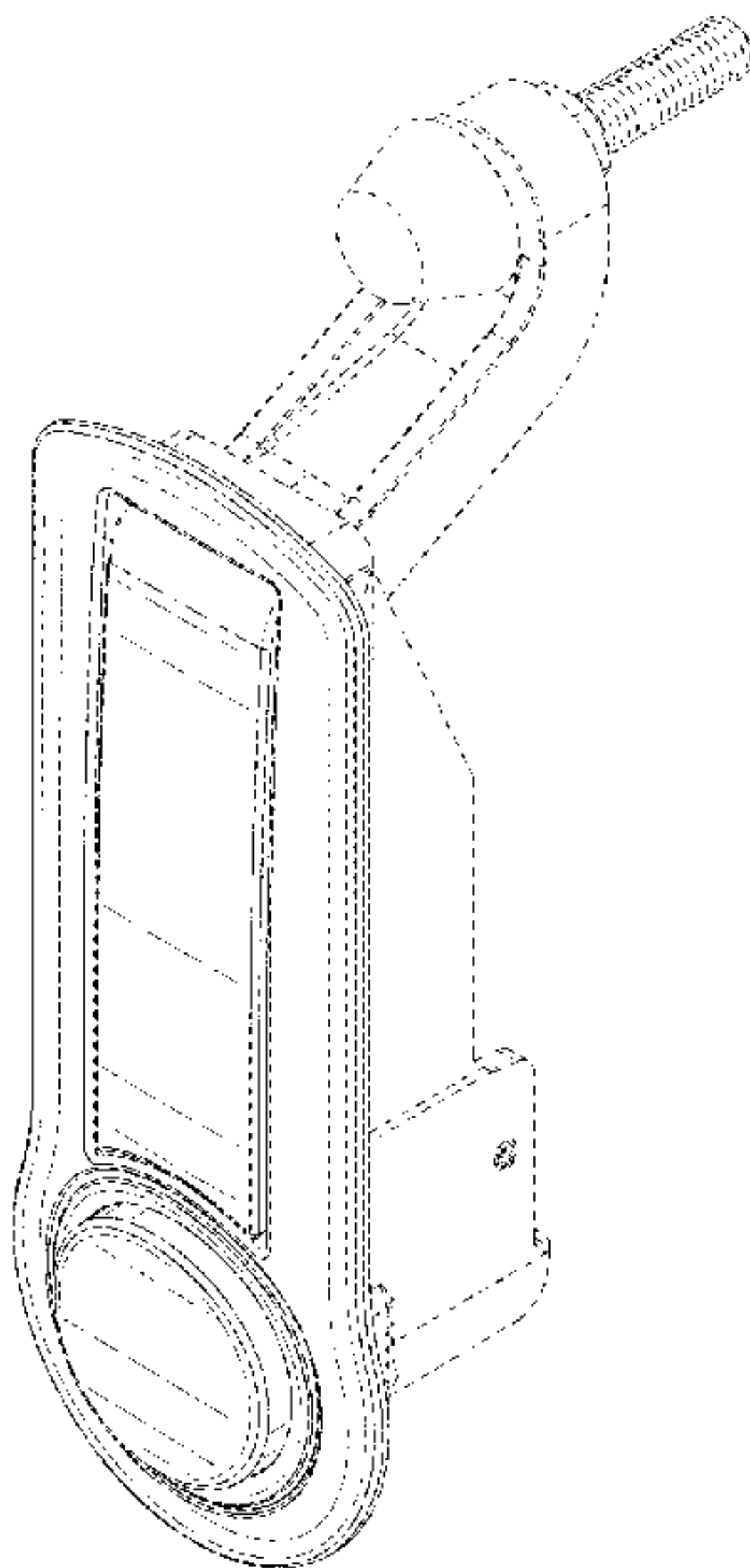

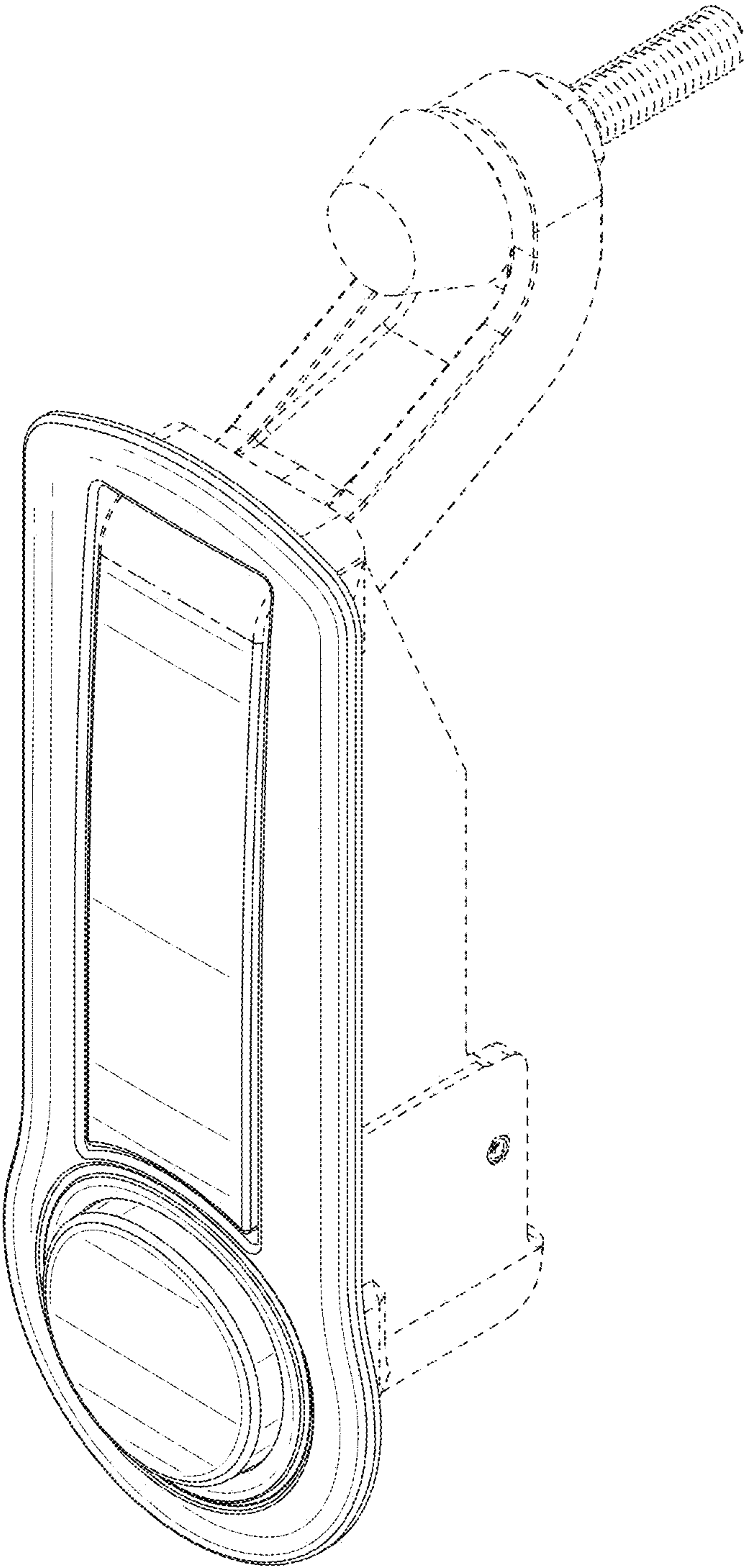

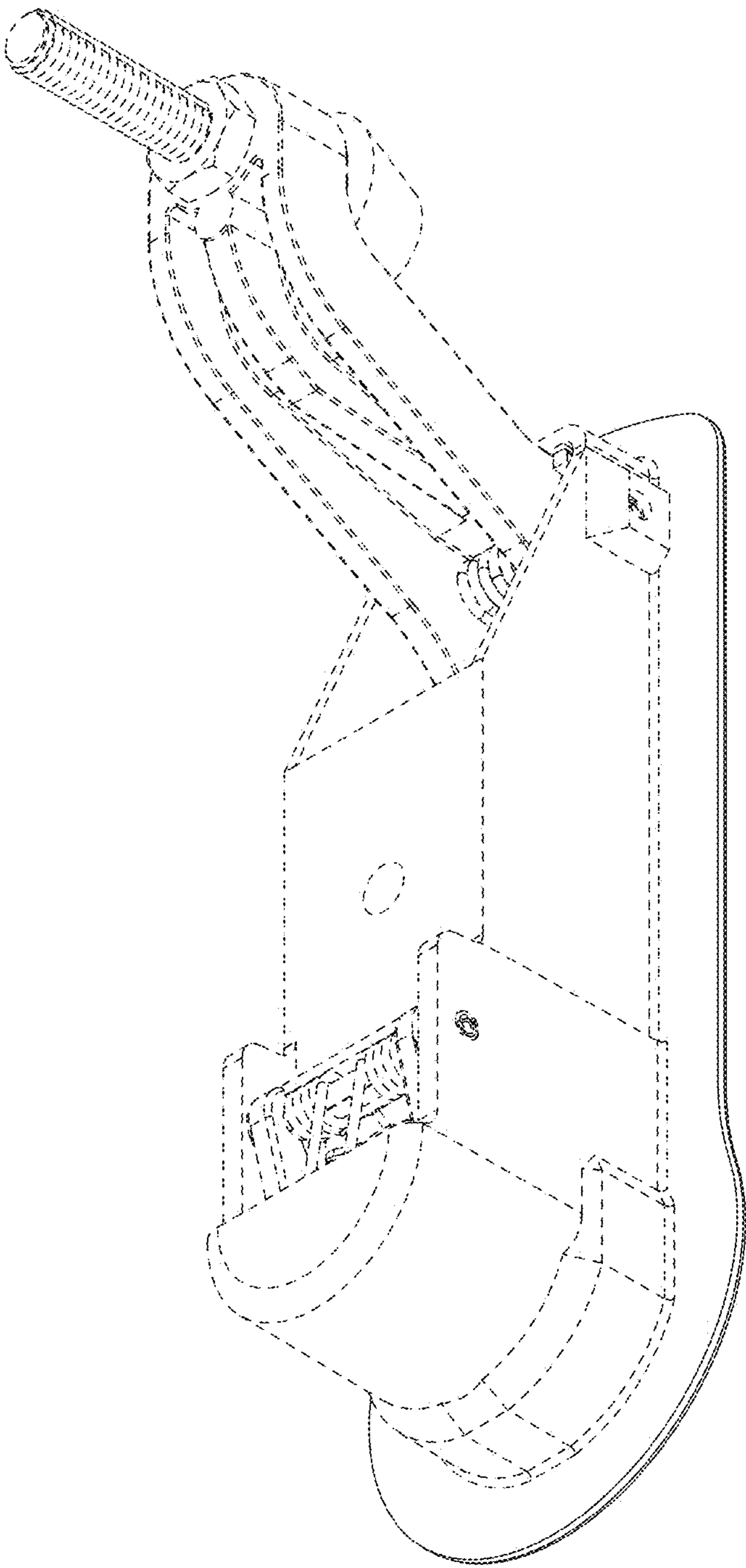

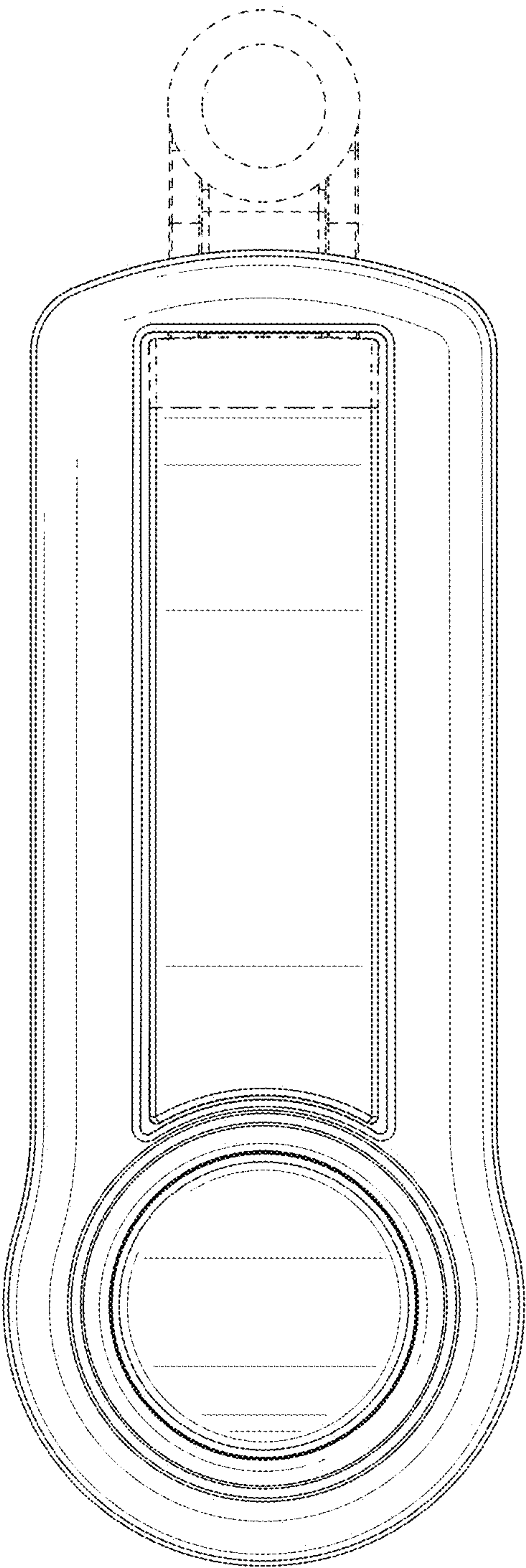

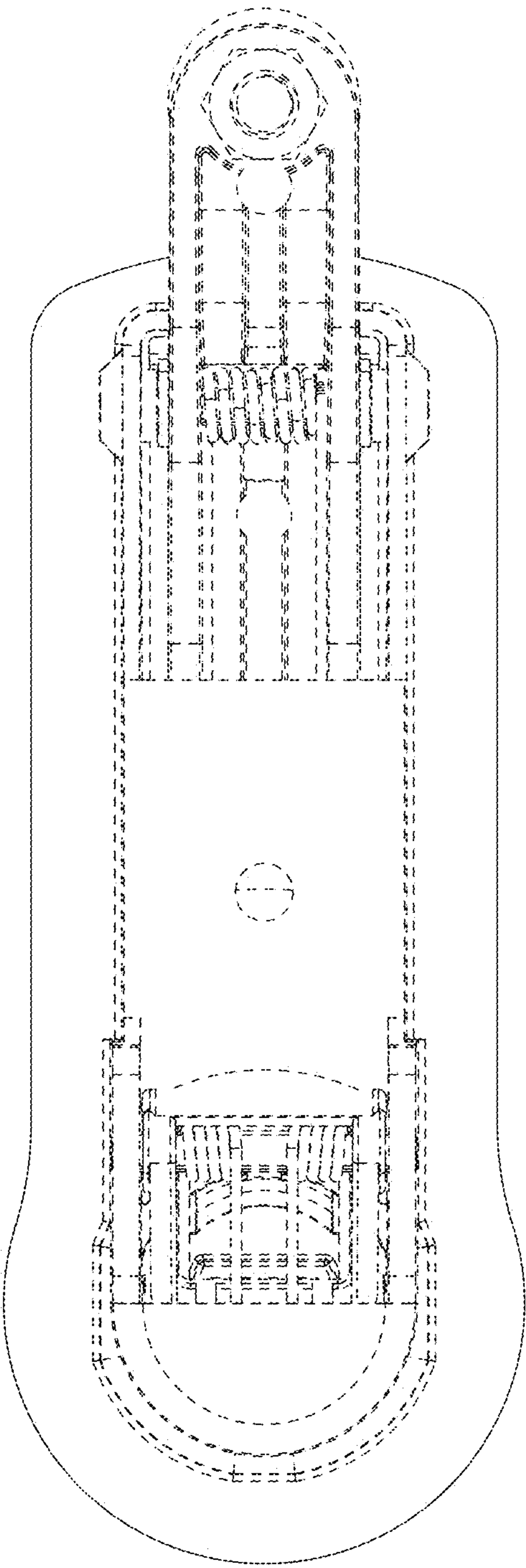

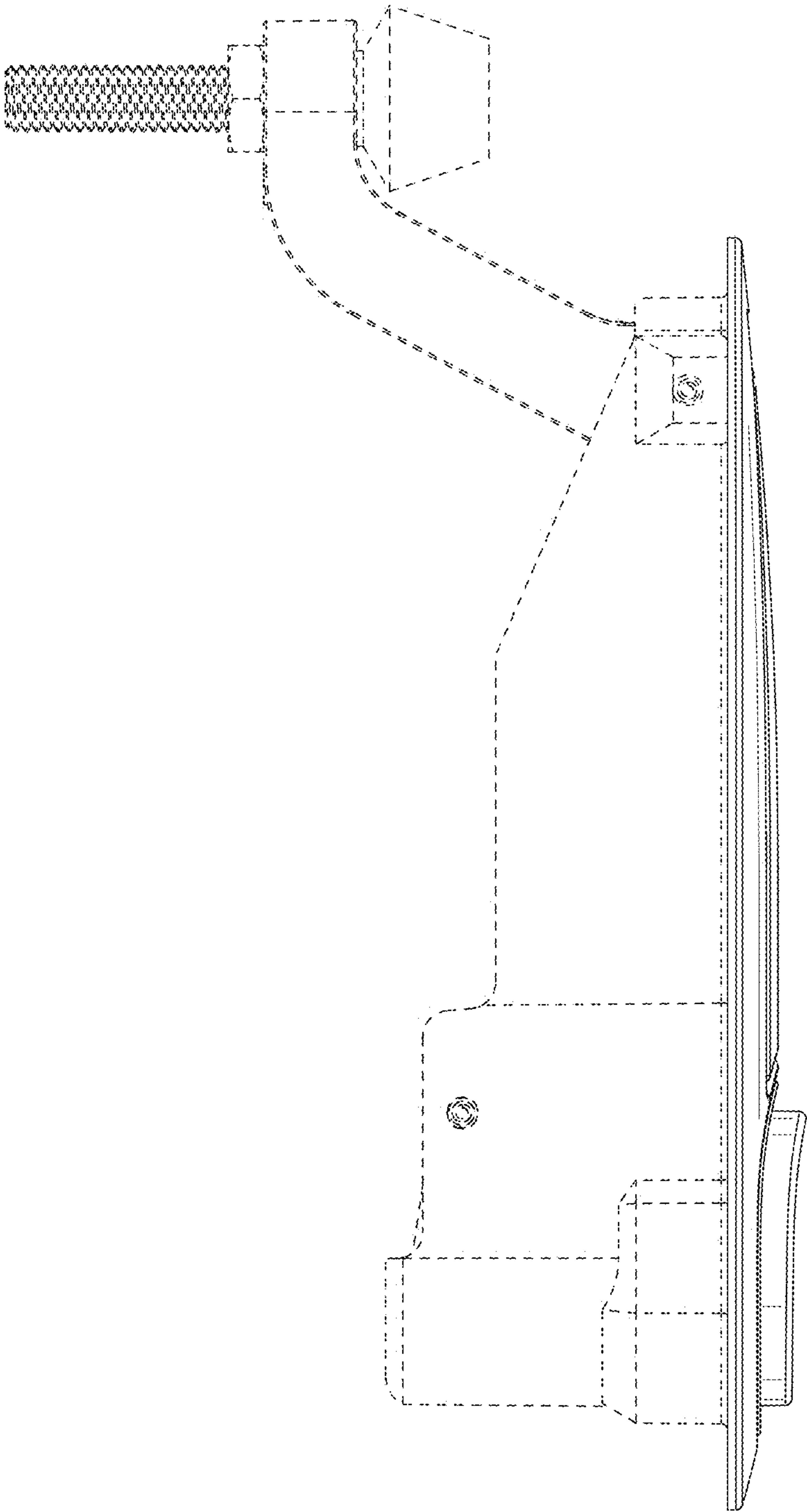

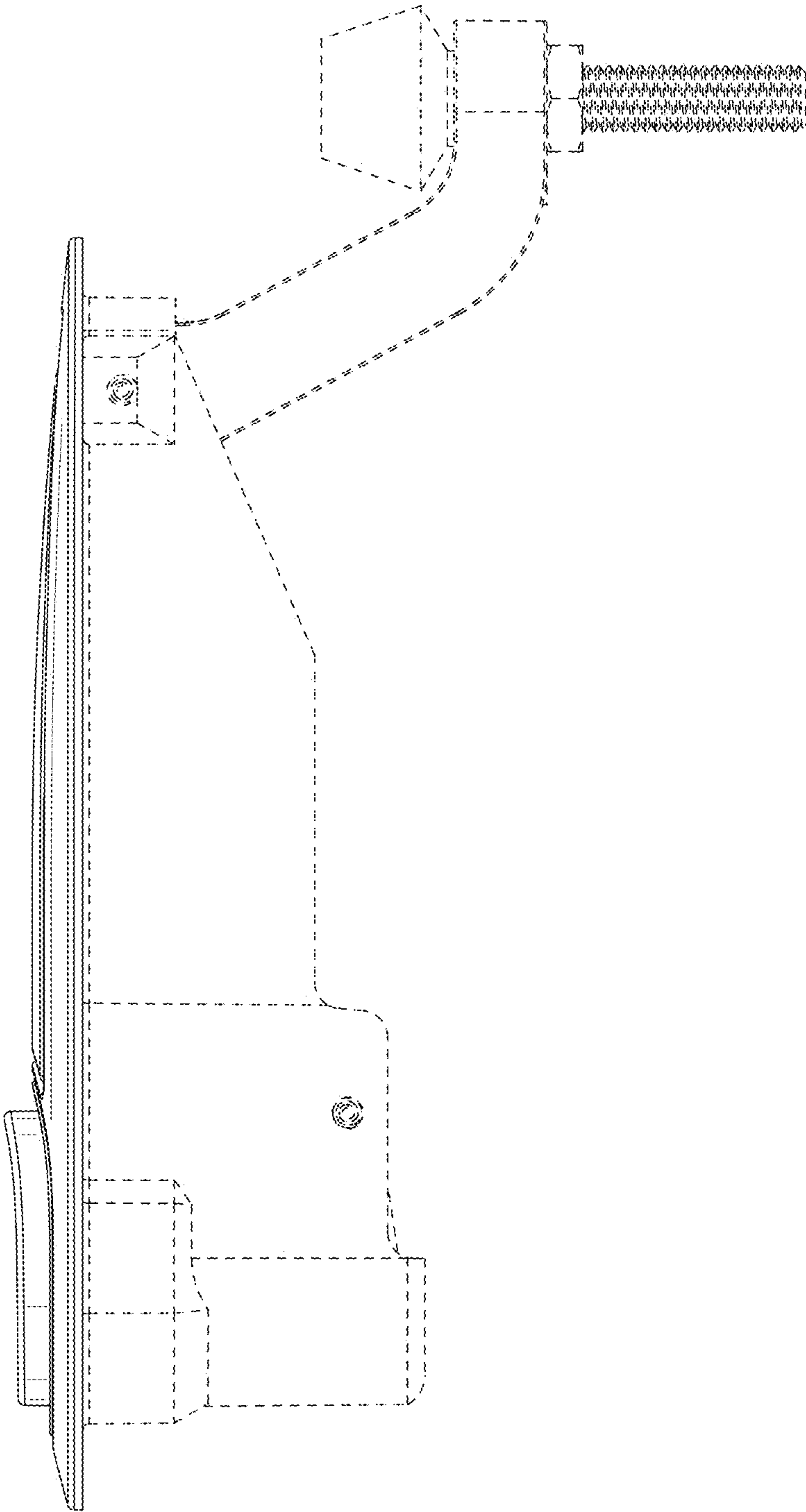

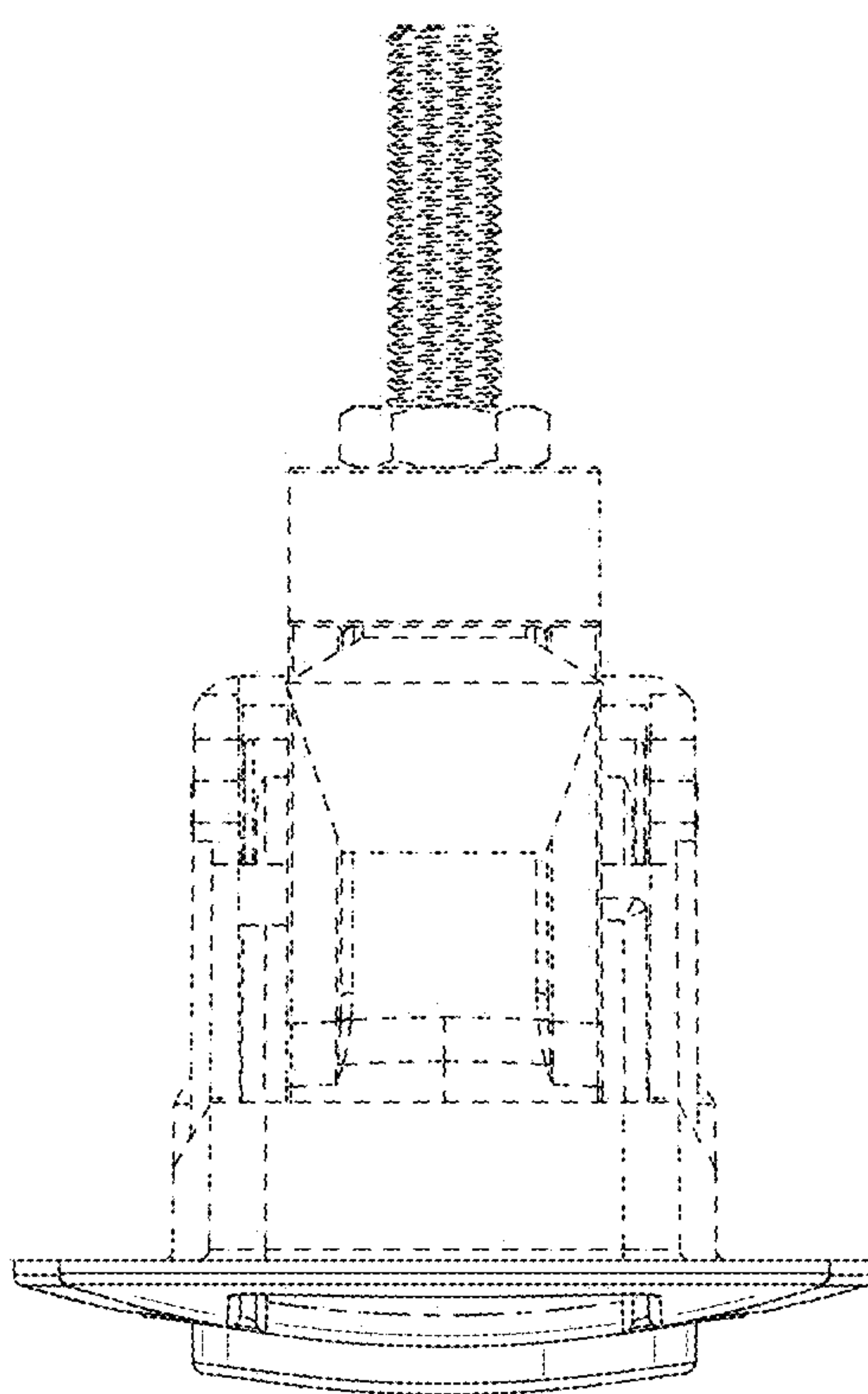

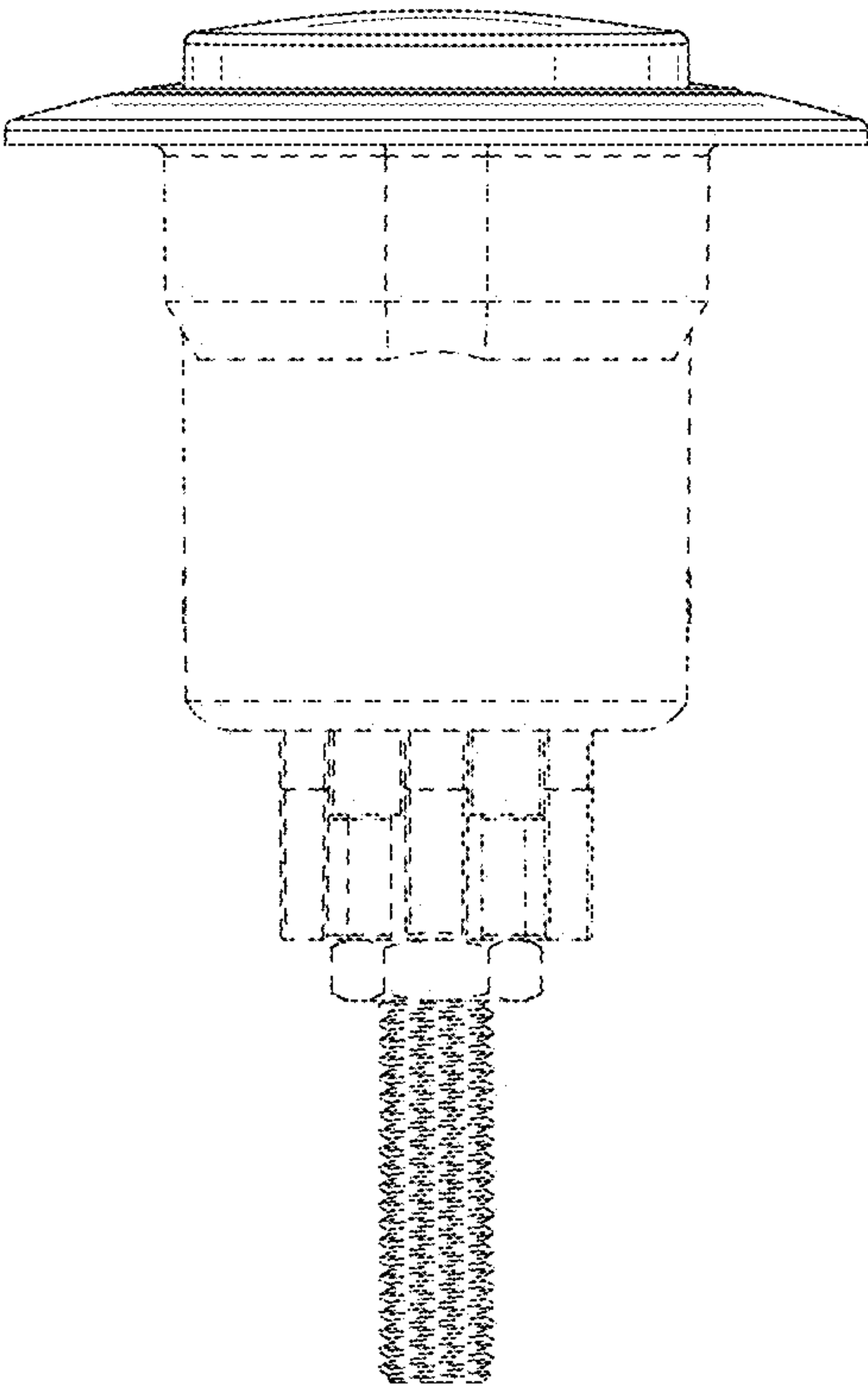
