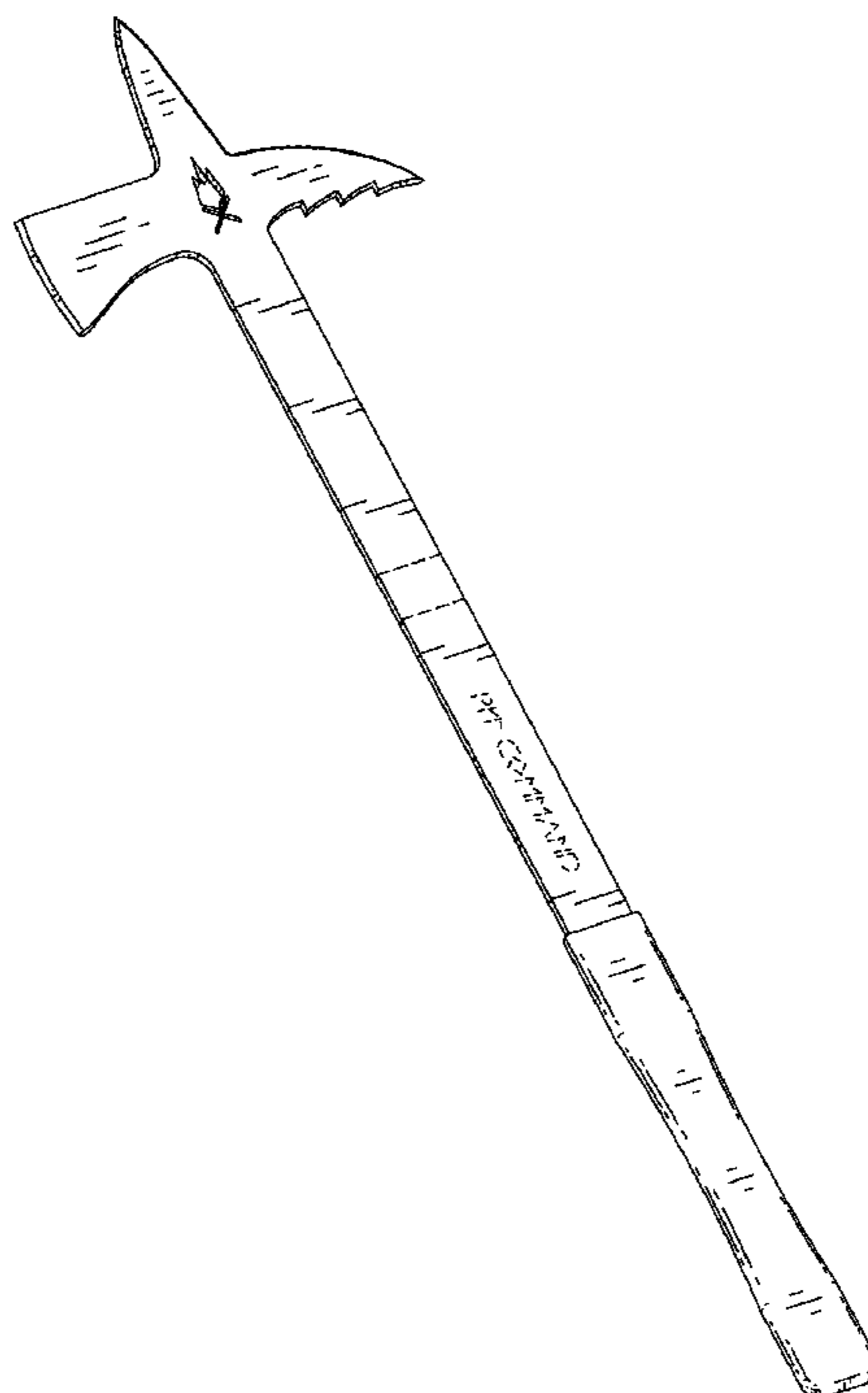
The ornamental design for a tool, as shown and described.

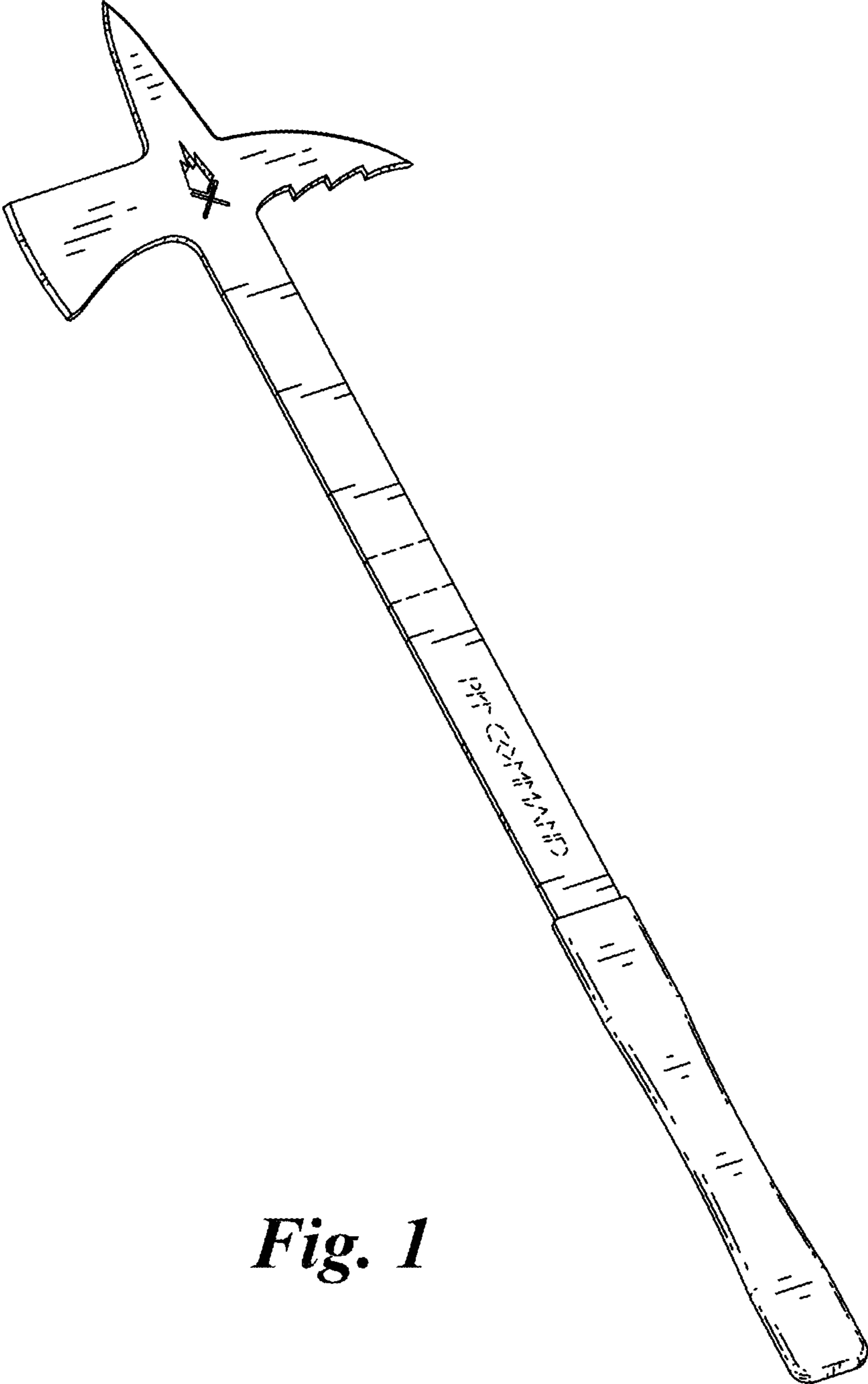
**DESCRIPTION**

 FIG. 12 is a rear elevation view thereof.

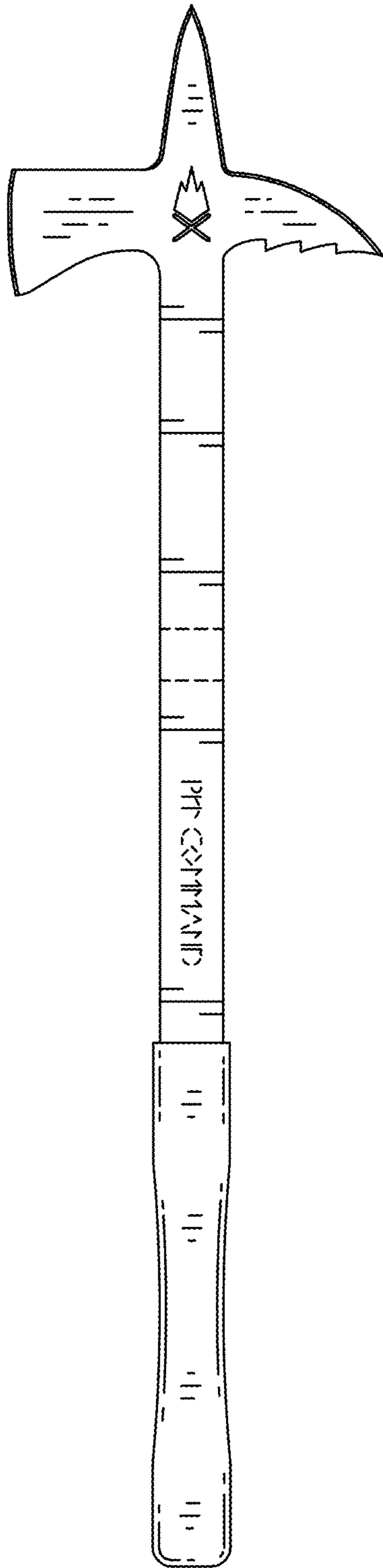
The broken lines in the figures illustrate portions of the tool that form no part of the claimed design.

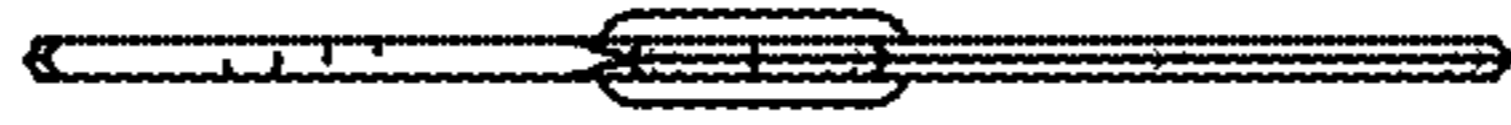

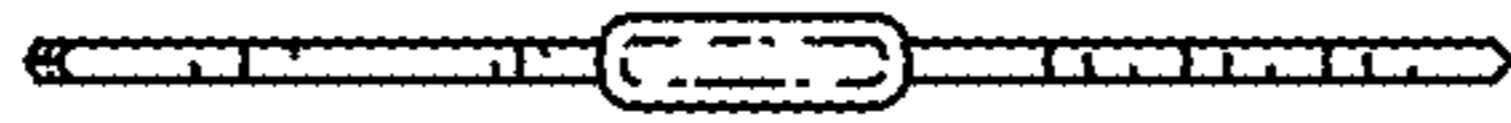

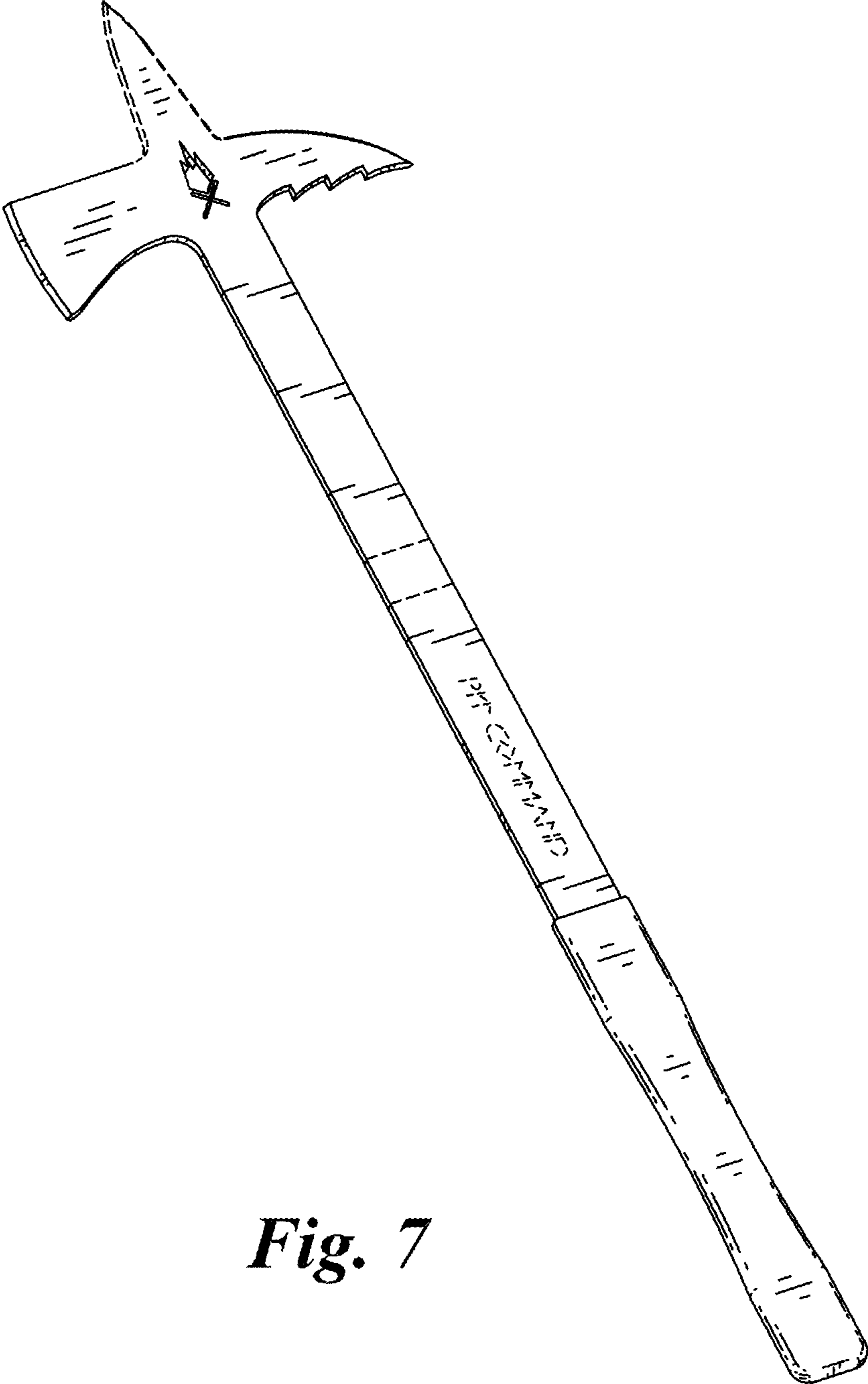

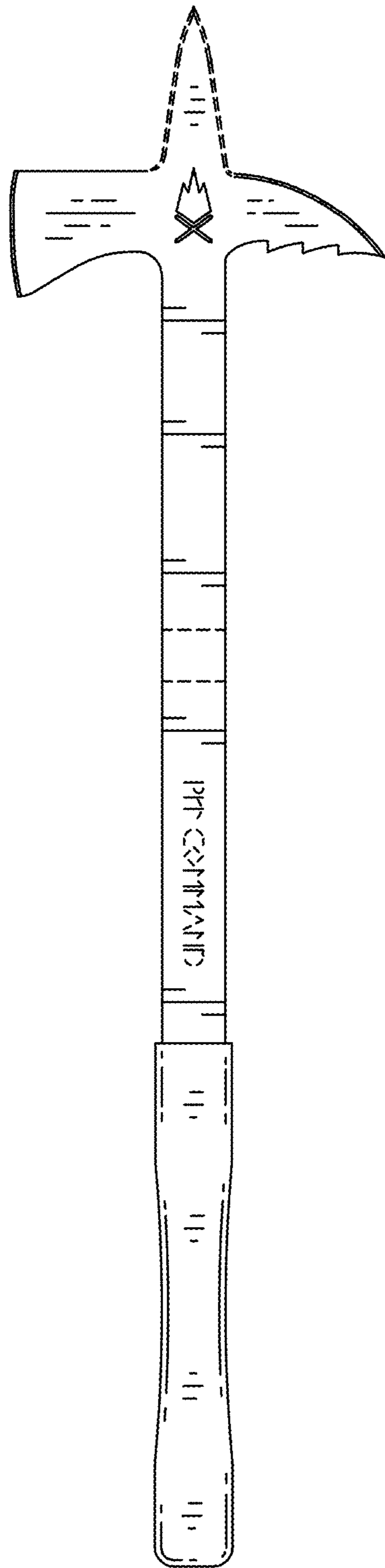

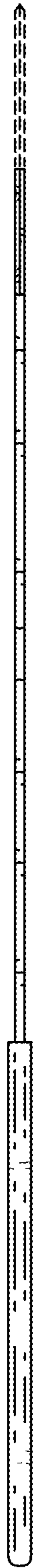

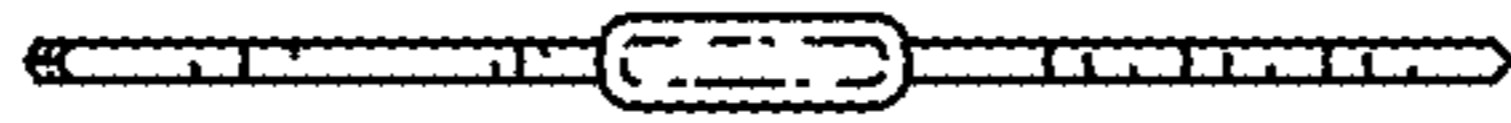
