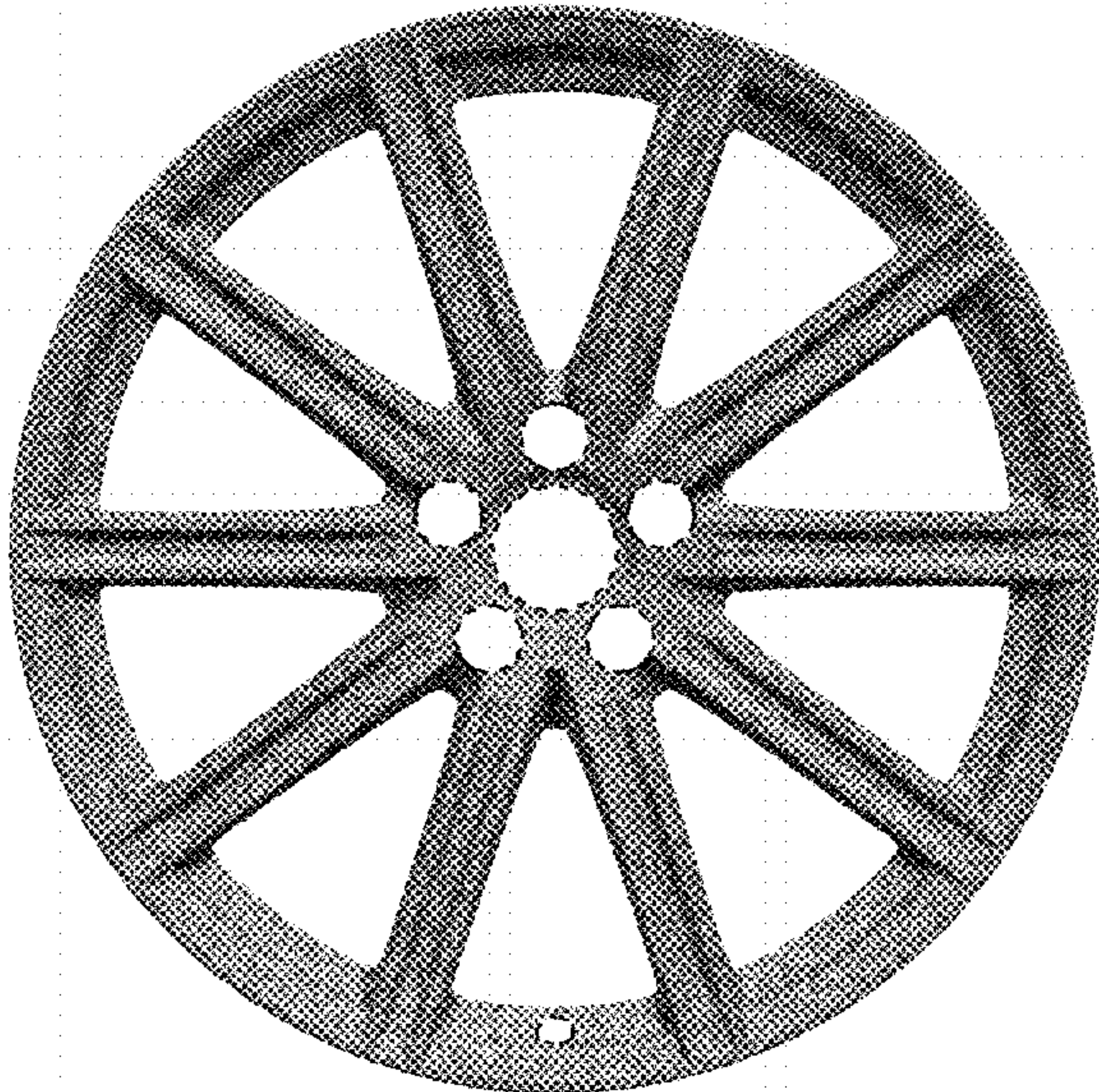
(57) CLAIM

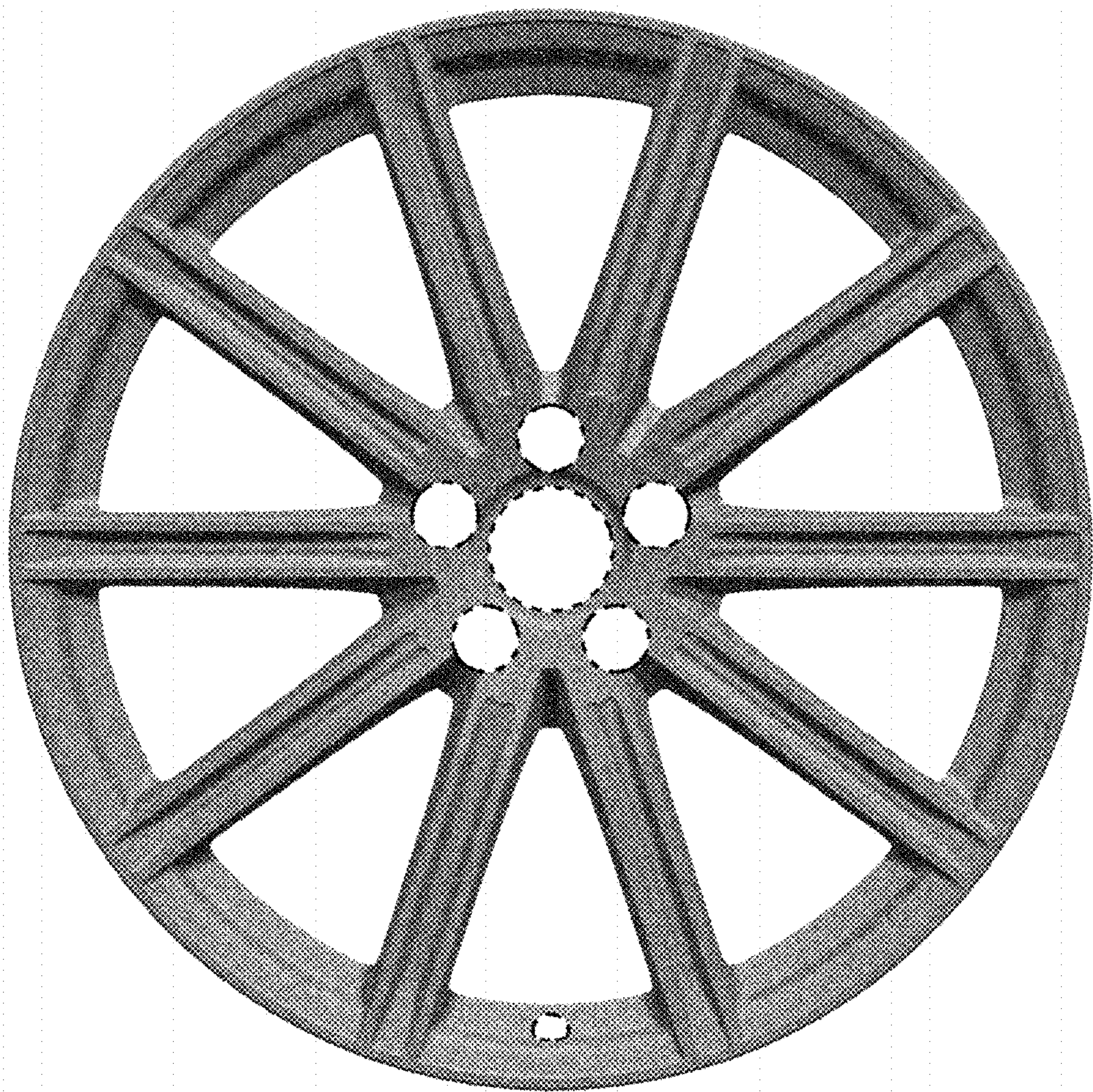

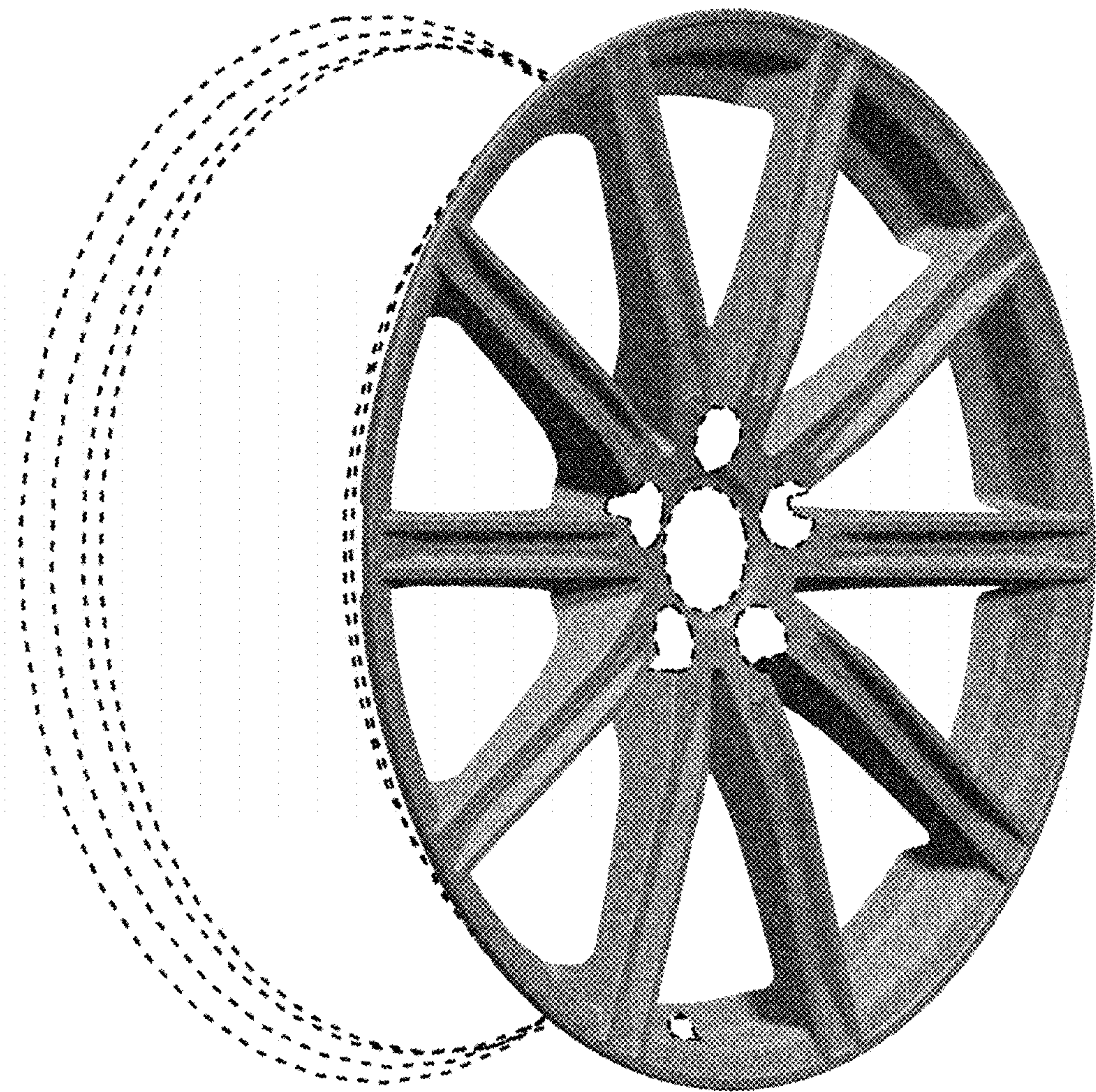

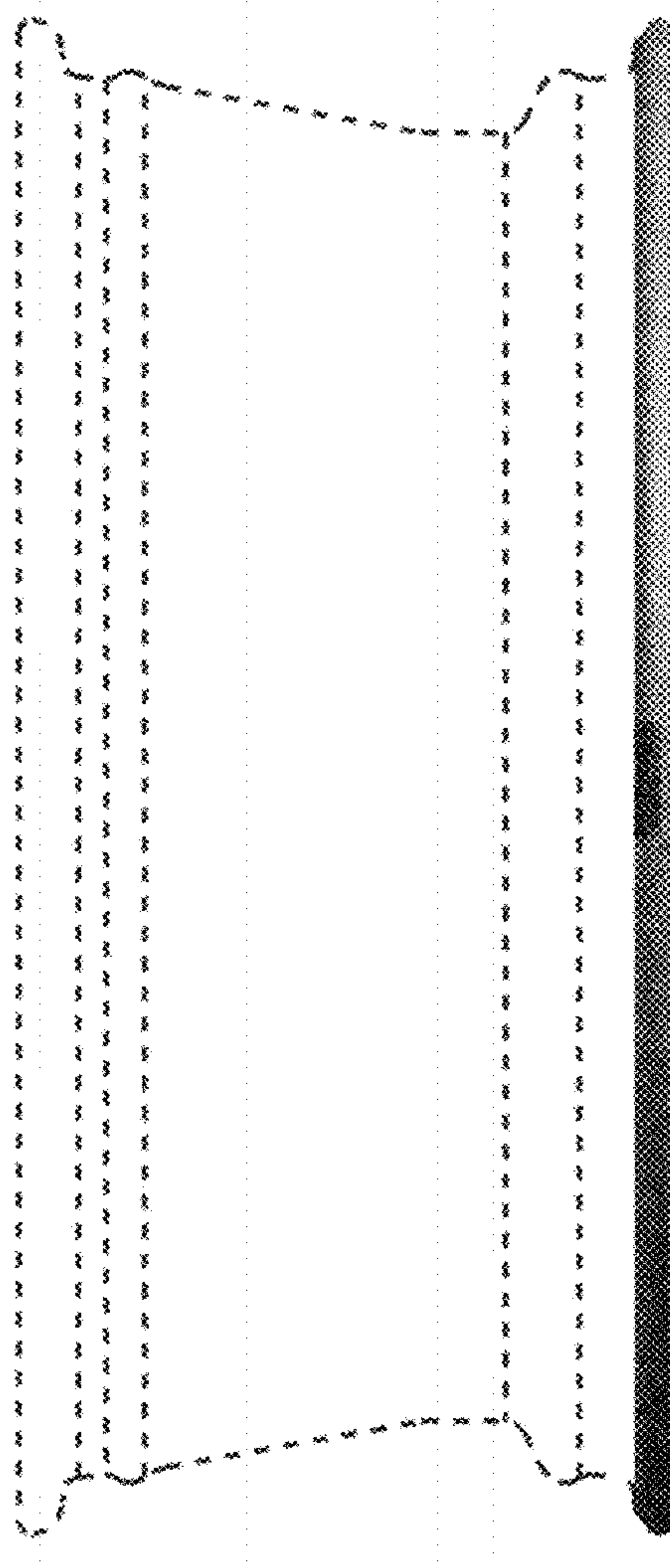
