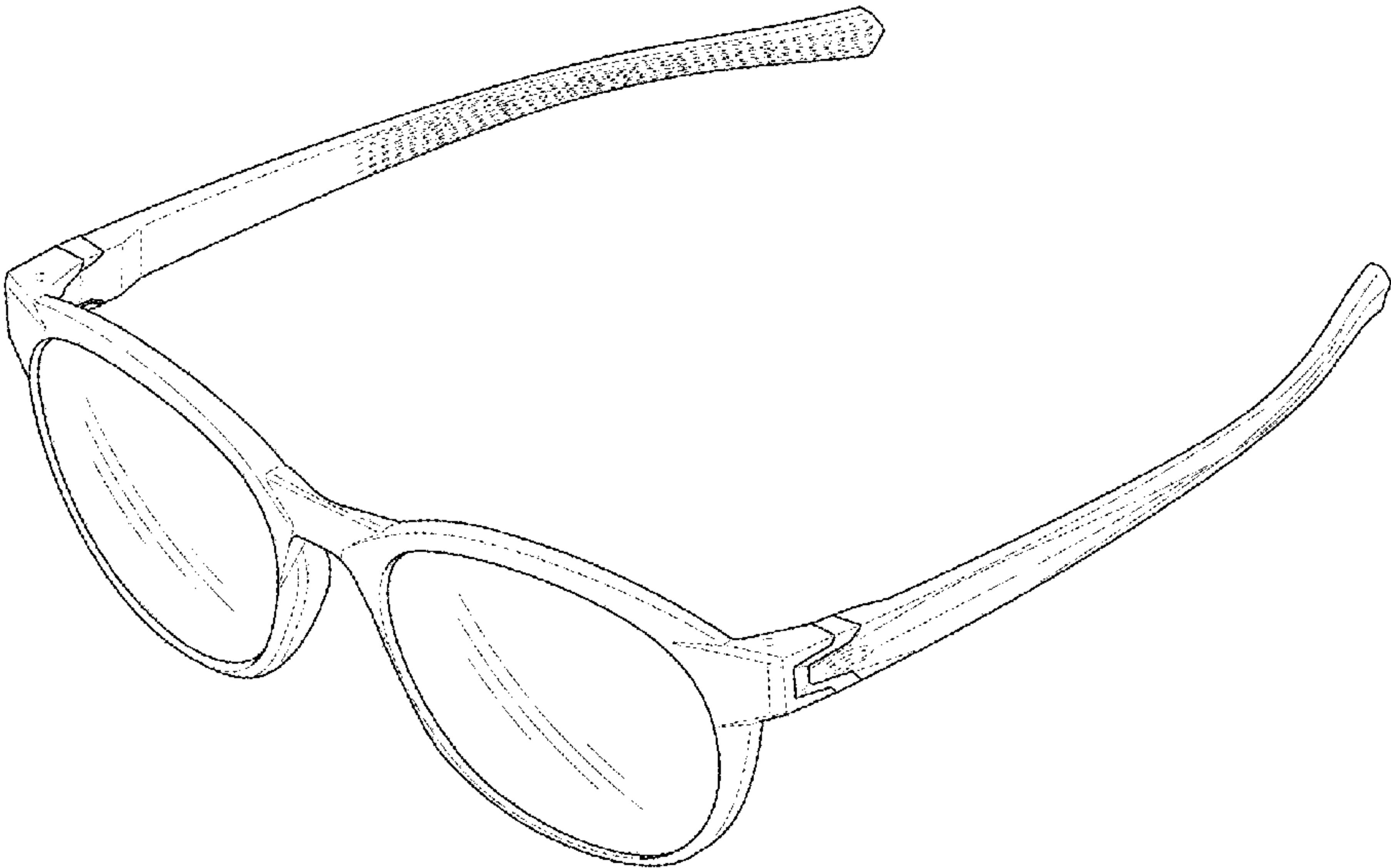
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top front perspective view of eyeglasses showing the claimed design;
FIG. 2 is a front view thereof;

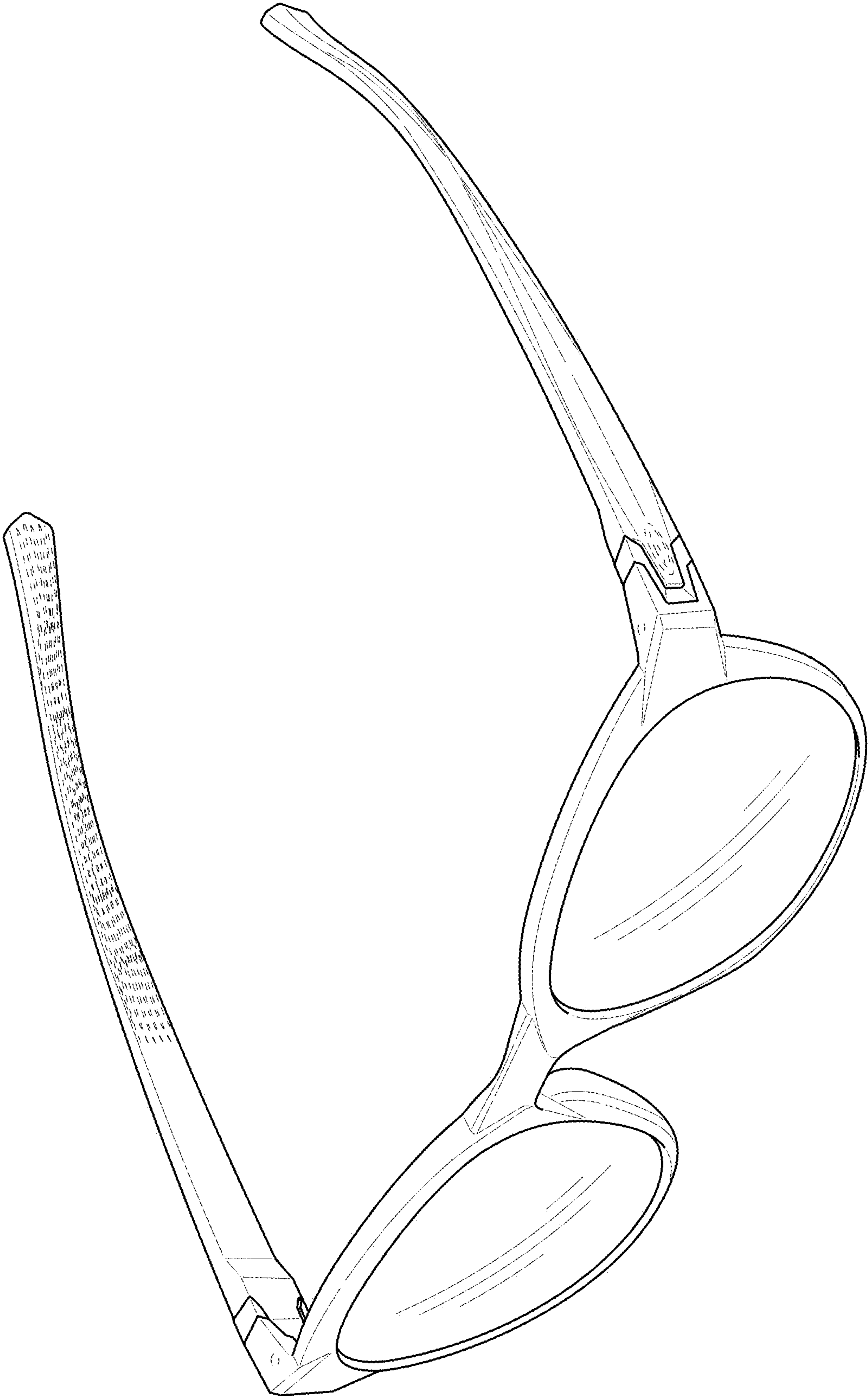

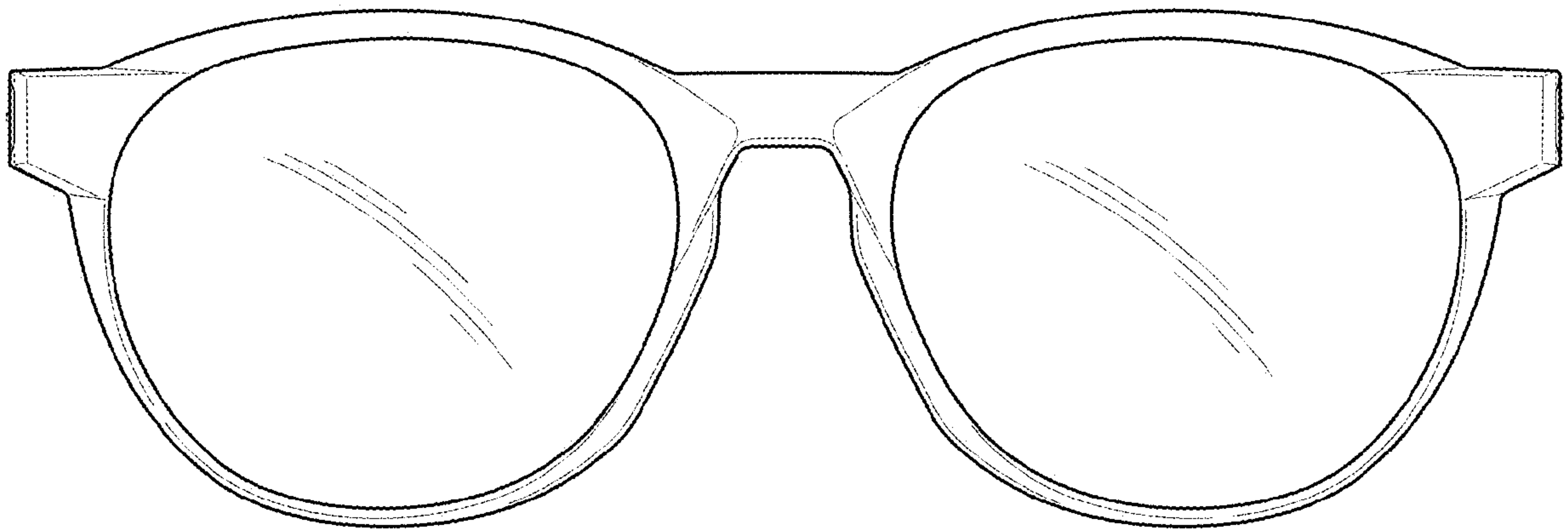

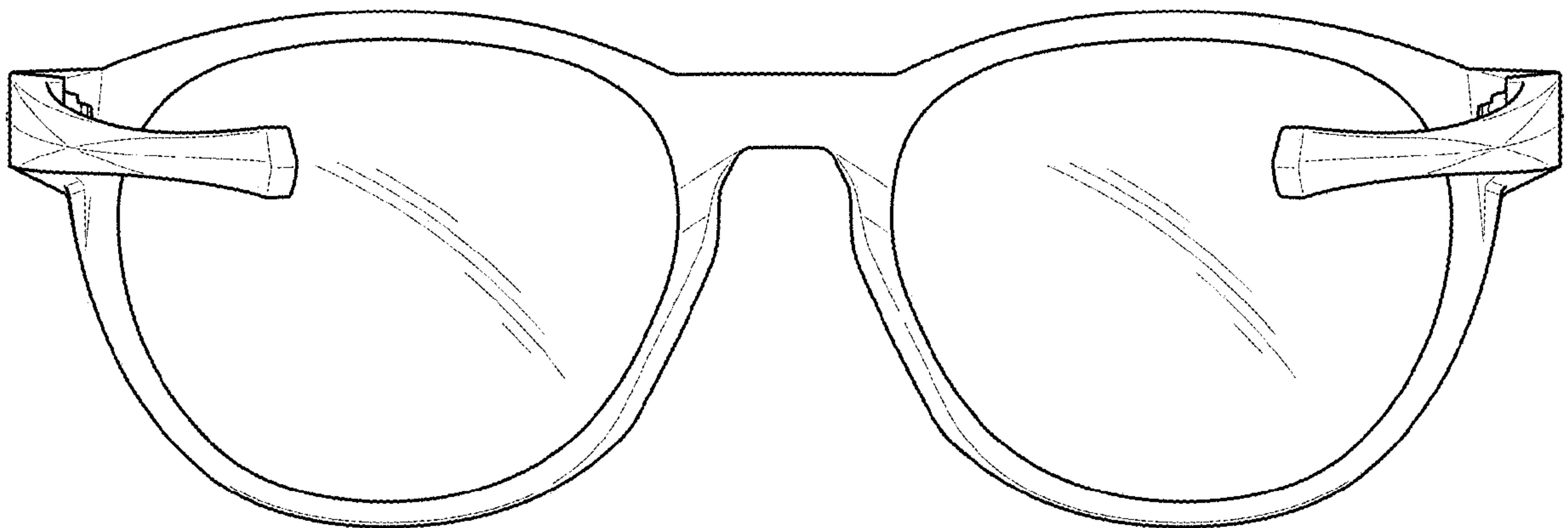

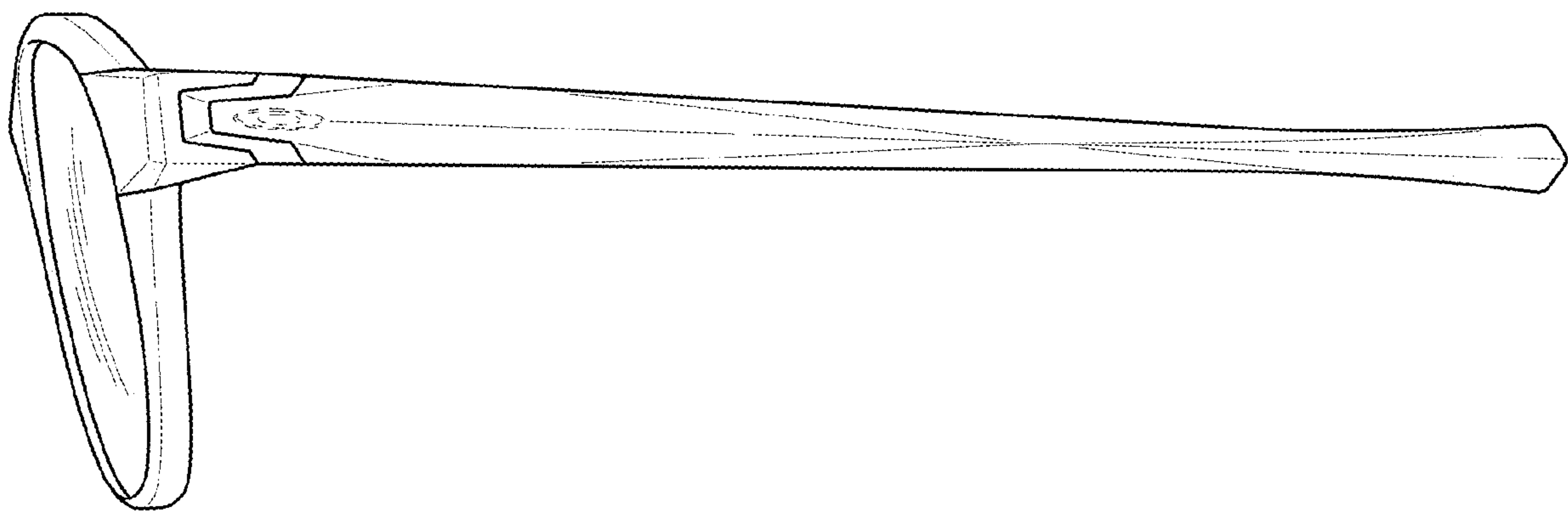

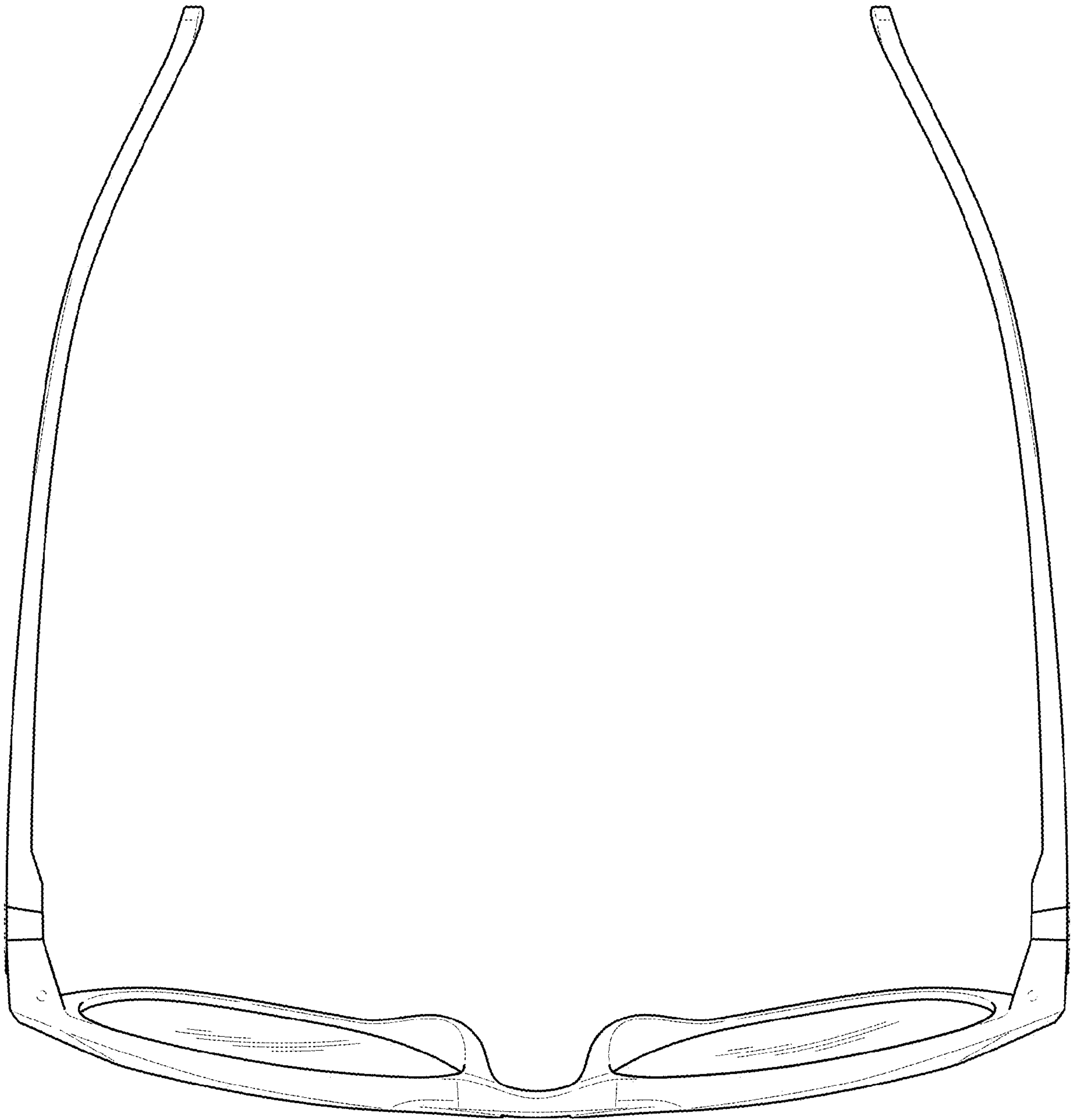

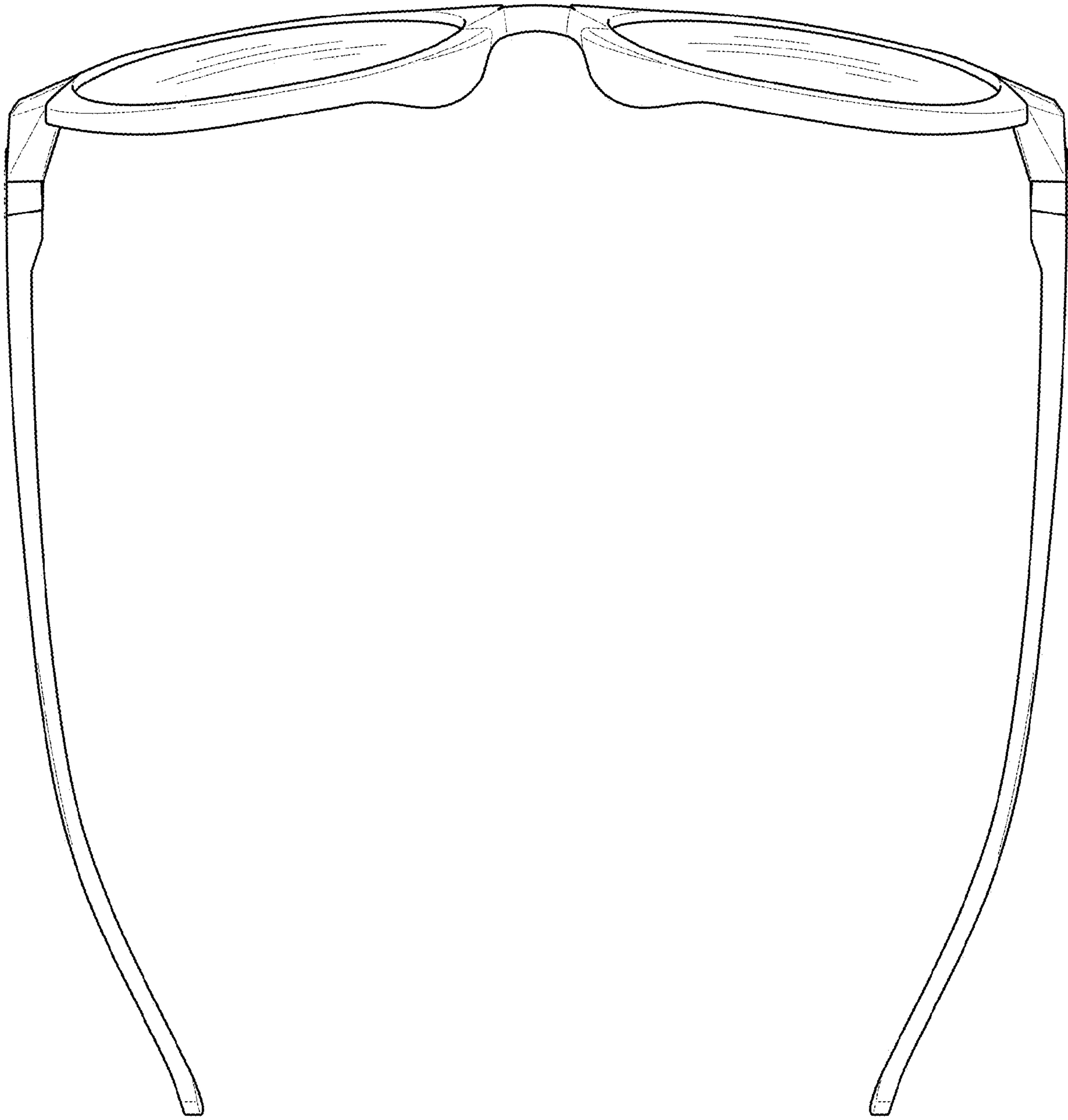
