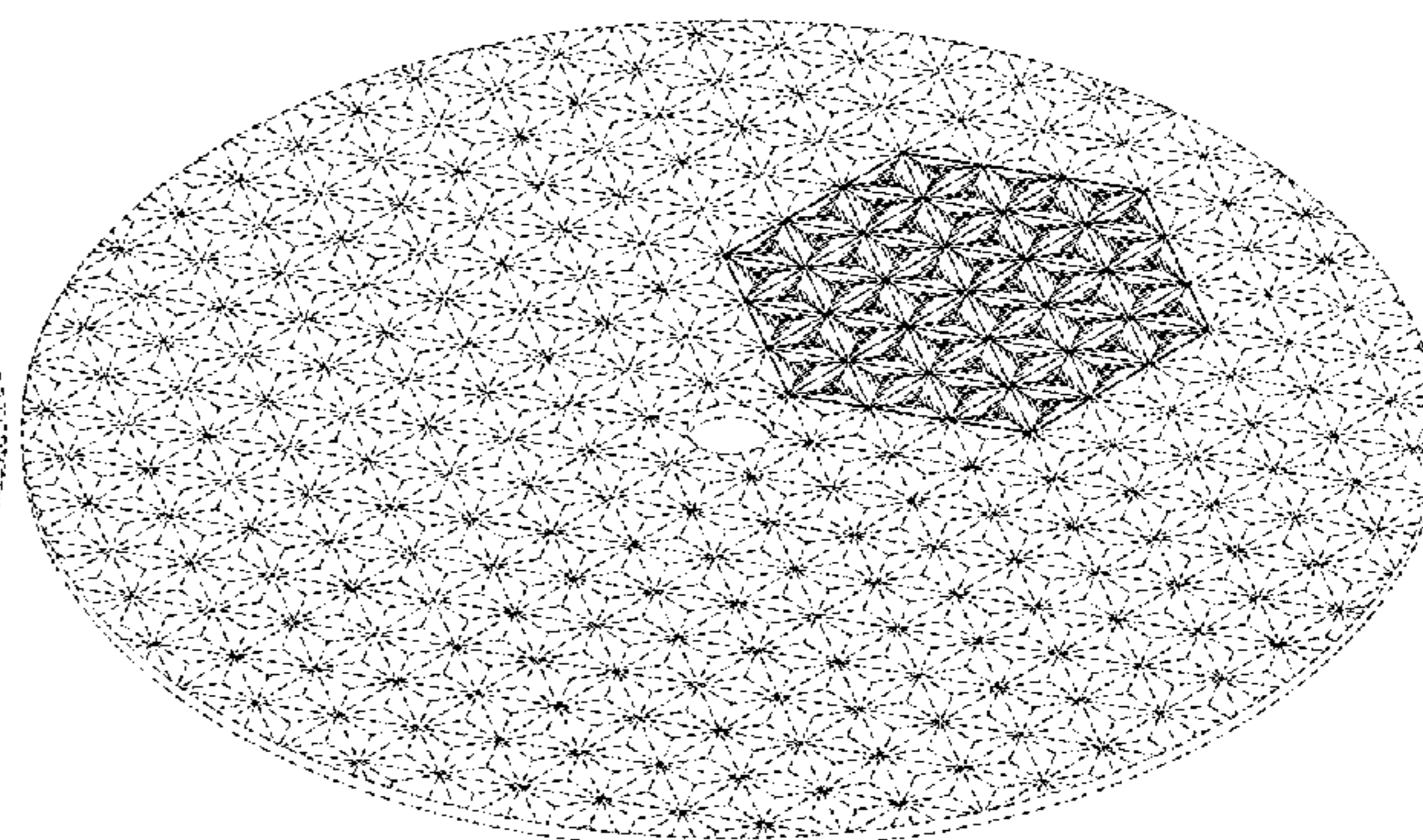
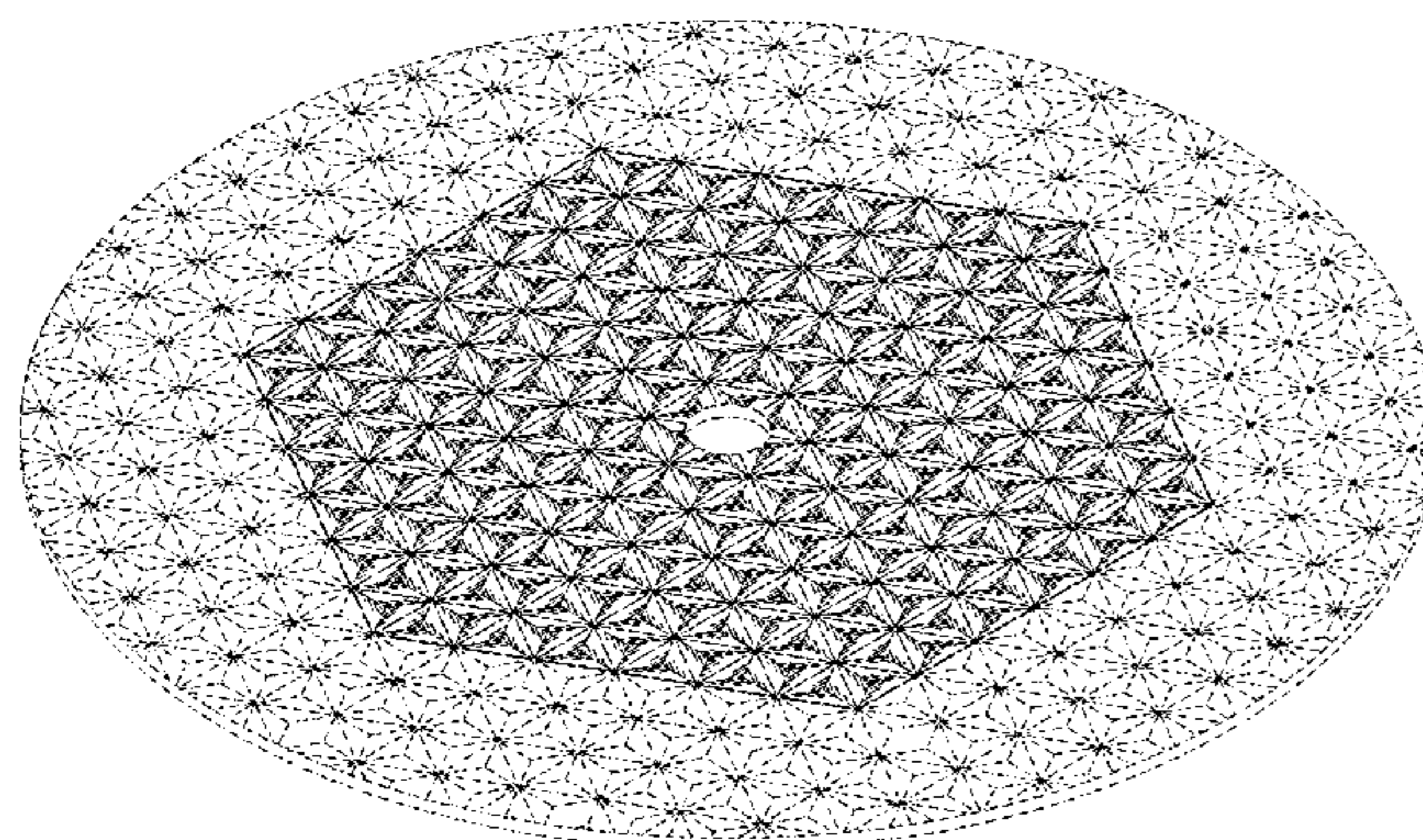
The ornamental design for a wristwatch dial, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a wristwatch dial showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is an enlarged detail of a portion as defined by dash-dotted circle 8 in FIG. 2; FIG. 9 is a cross sectional view thereof, taken along lines 9-9 of FIG. 8; FIG. 10 is a cross sectional view thereof, taken along lines 10-10 of FIG. 8; FIG. 11 is a perspective view of a second embodiment thereof; FIG. 12 is a front elevational view thereof; FIG. 13 is a rear elevational view thereof; FIG. 14 is a left side elevational view thereof; FIG. 15 is a right side elevational view thereof; FIG. 16 is a top plan view thereof; FIG. 17 is a bottom plan view thereof; FIG. 18 is an enlarged detail of a portion as defined by dash-dotted rectangle 18 in FIG. 12; FIG. 19 is an enlarged detail of a portion as defined by dash-dotted circle 19 in FIG. 18; FIG. 20 is a cross sectional view thereof, taken along line 20-20 of FIG. 19; and, FIG. 21 is a cross sectional view thereof, taken along lines 21-21 of FIG. 19.

The broken lines shown in the drawings illustrate portions of the wristwatch dial that form no part of the claimed design.

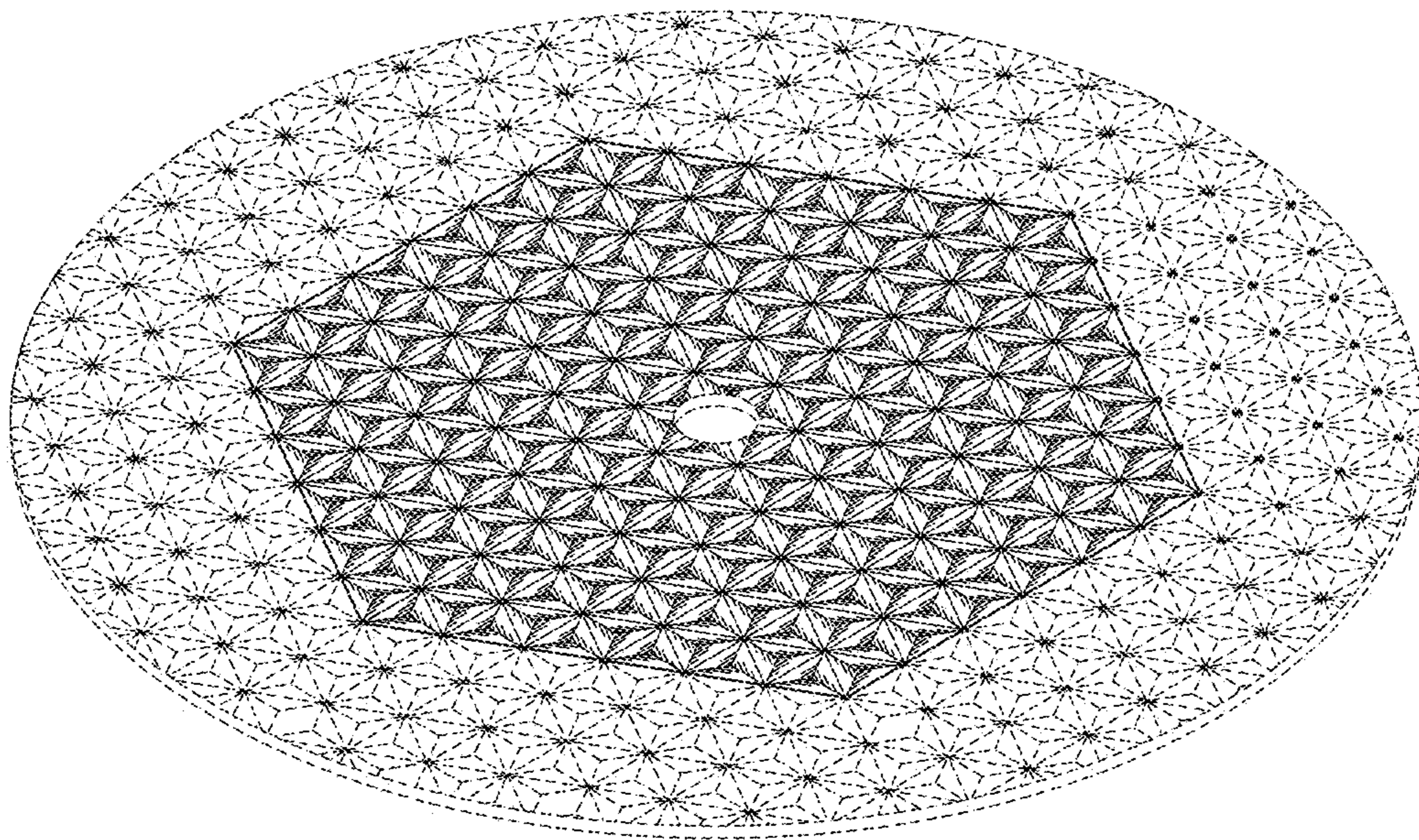

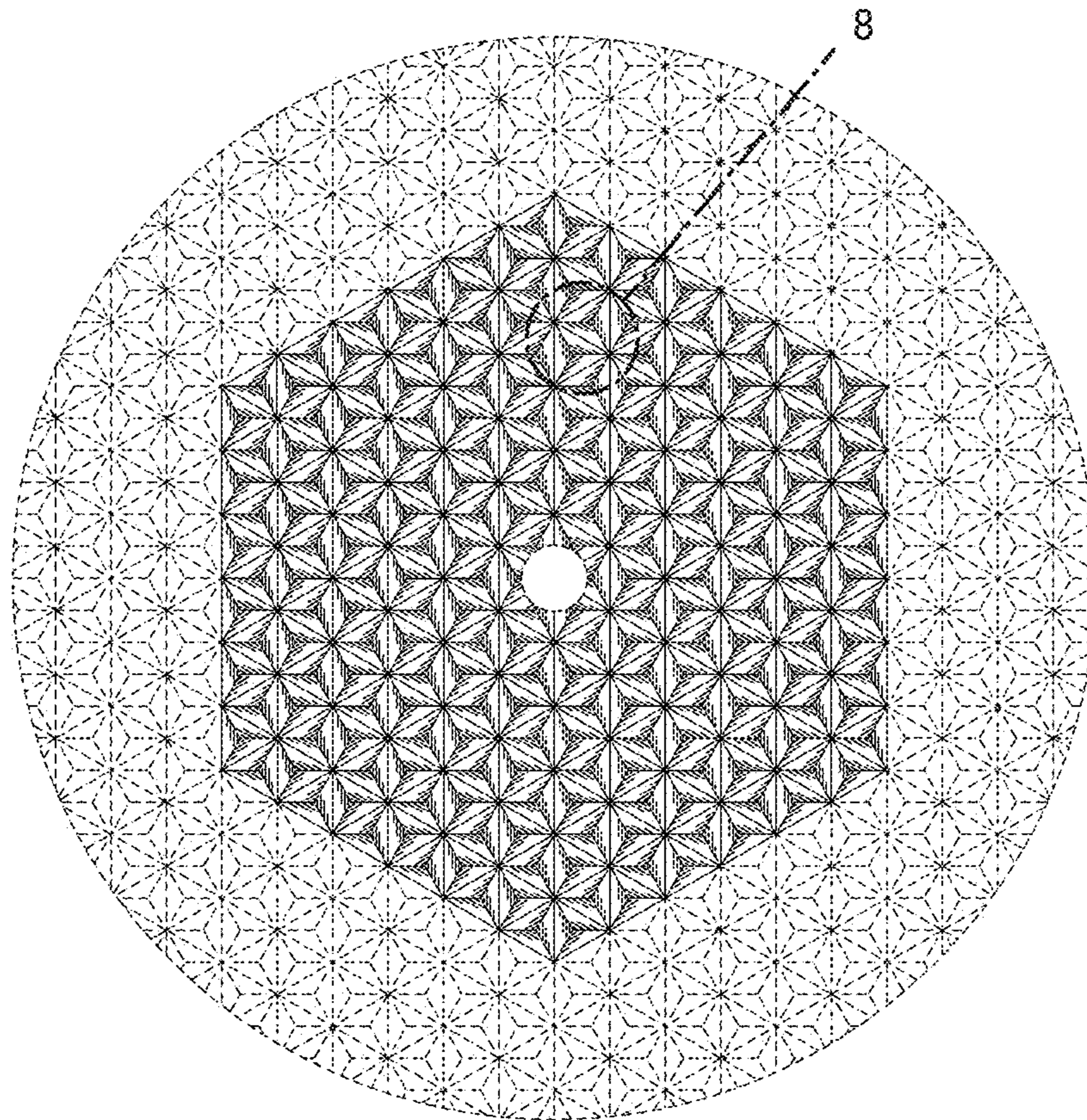

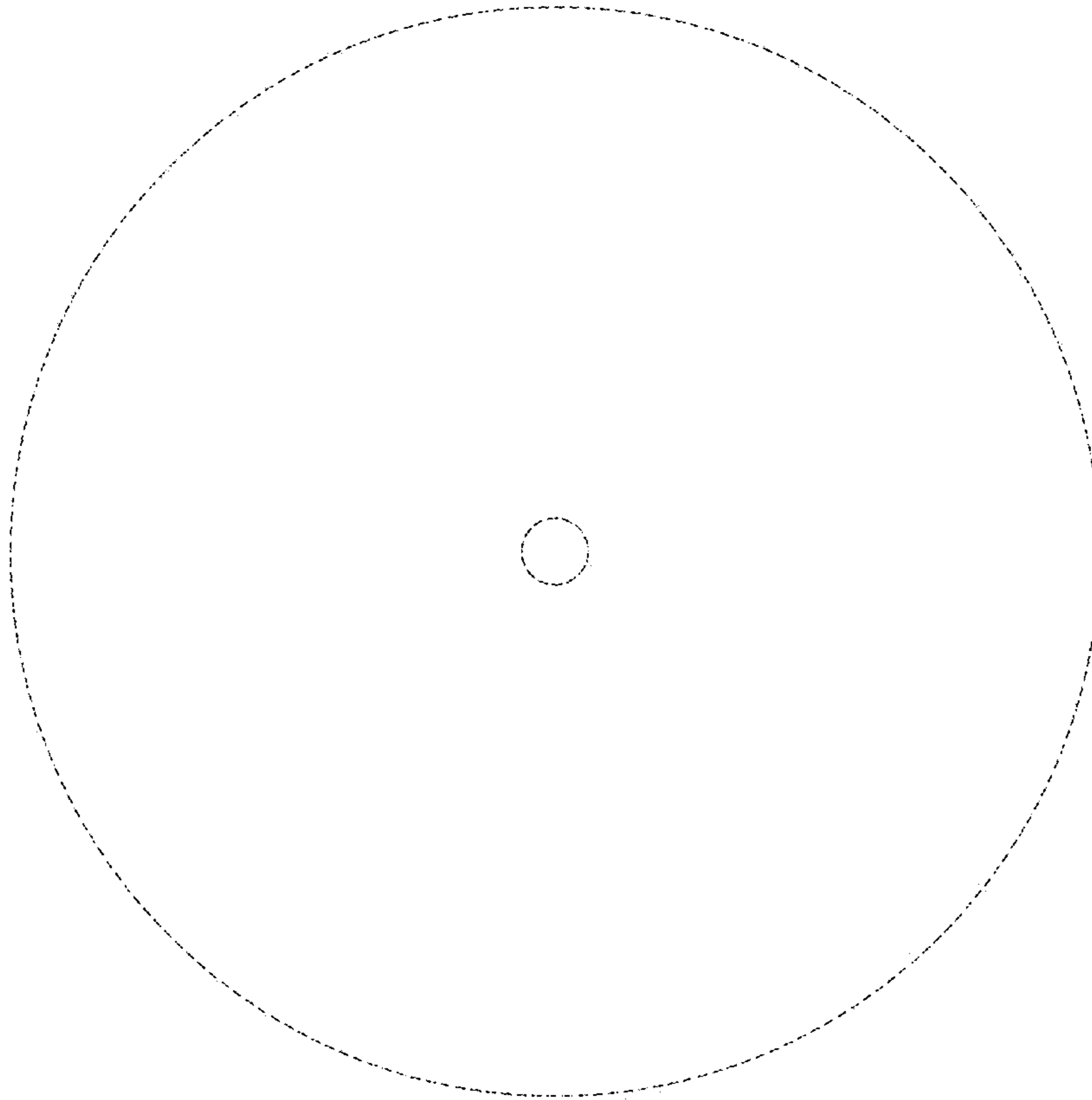

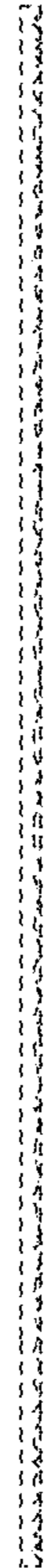

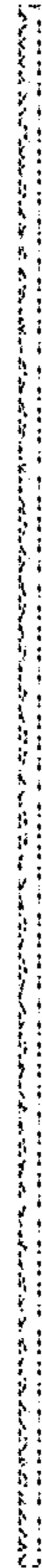

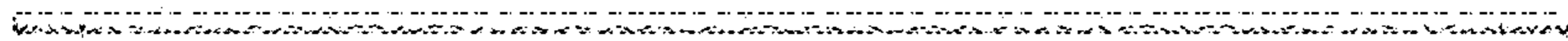

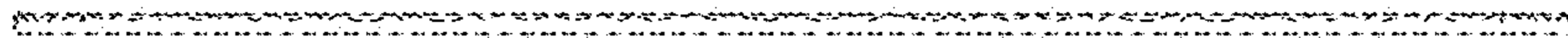

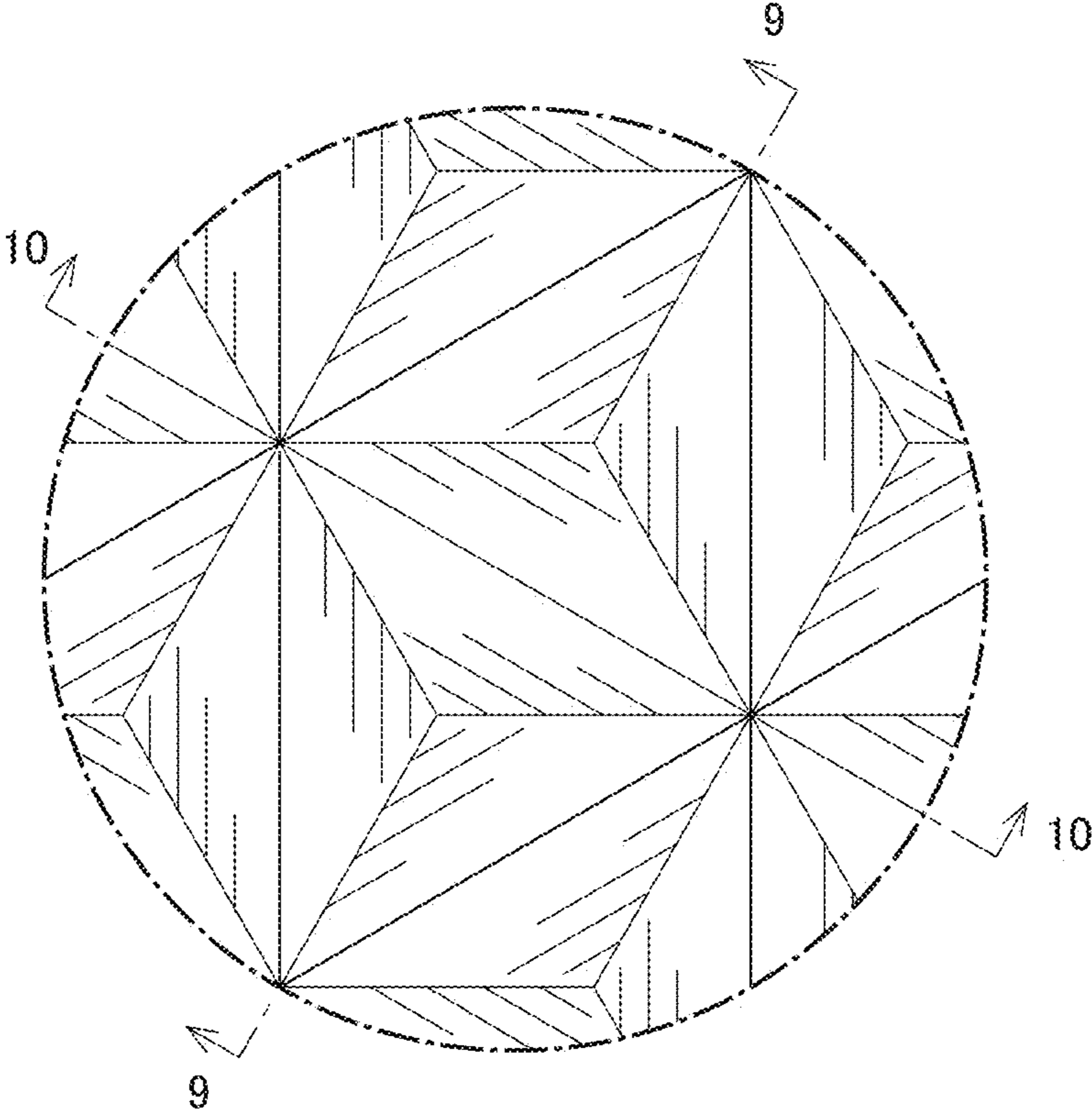

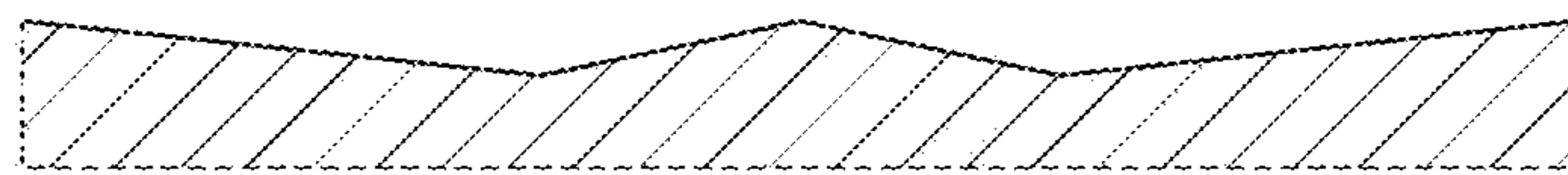

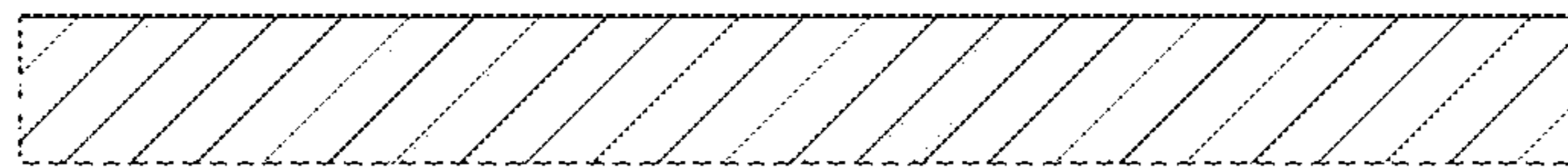

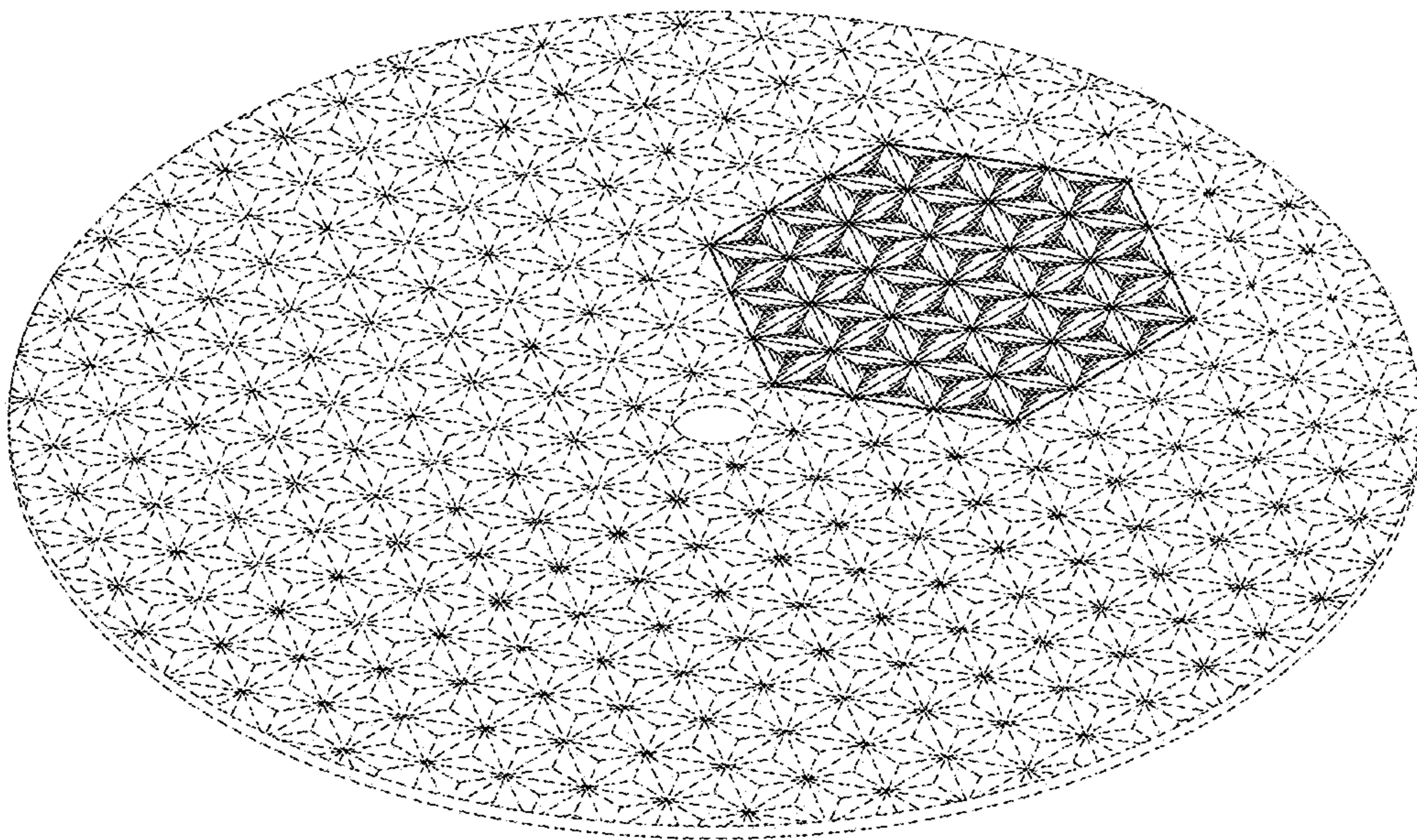

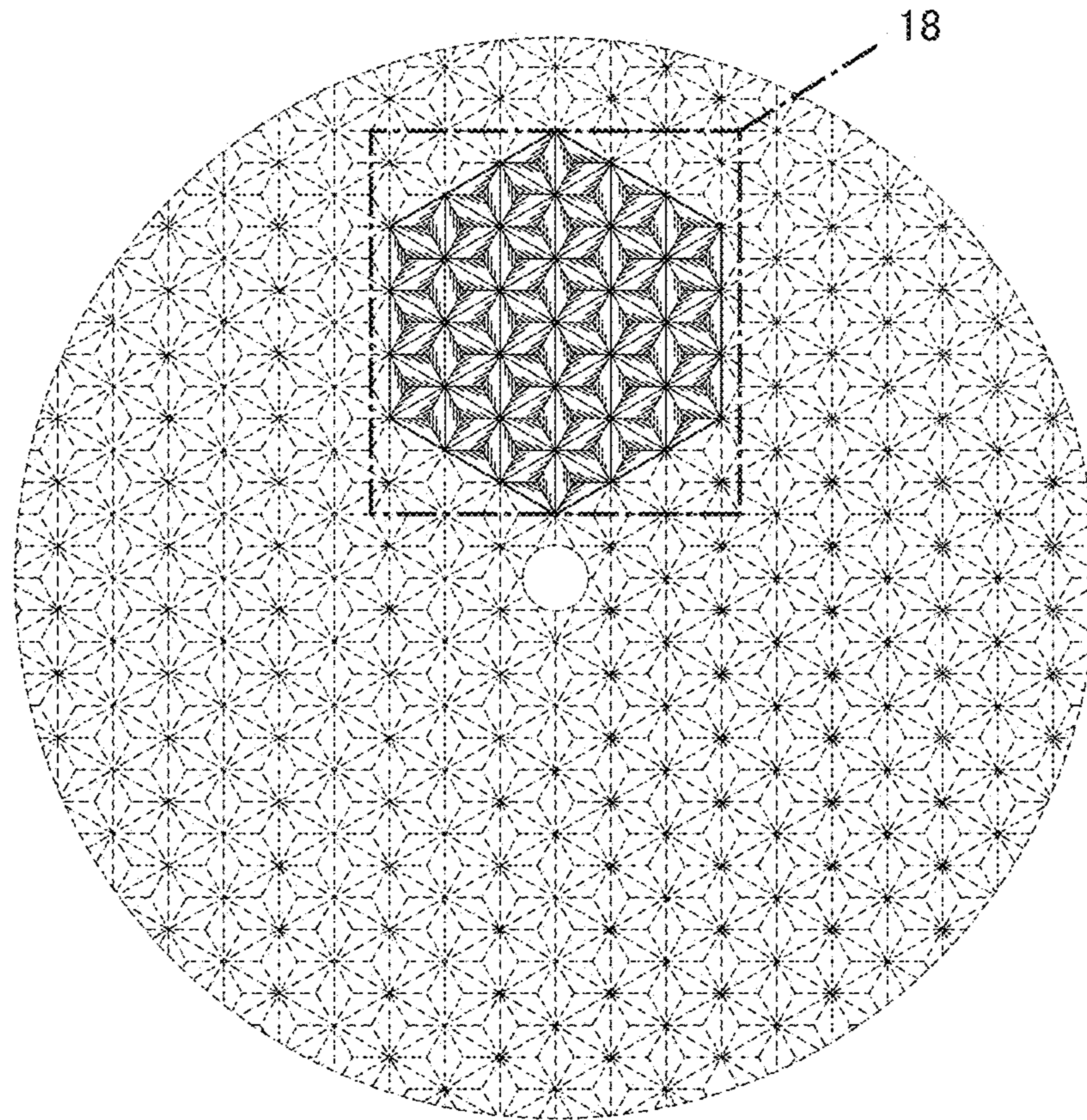

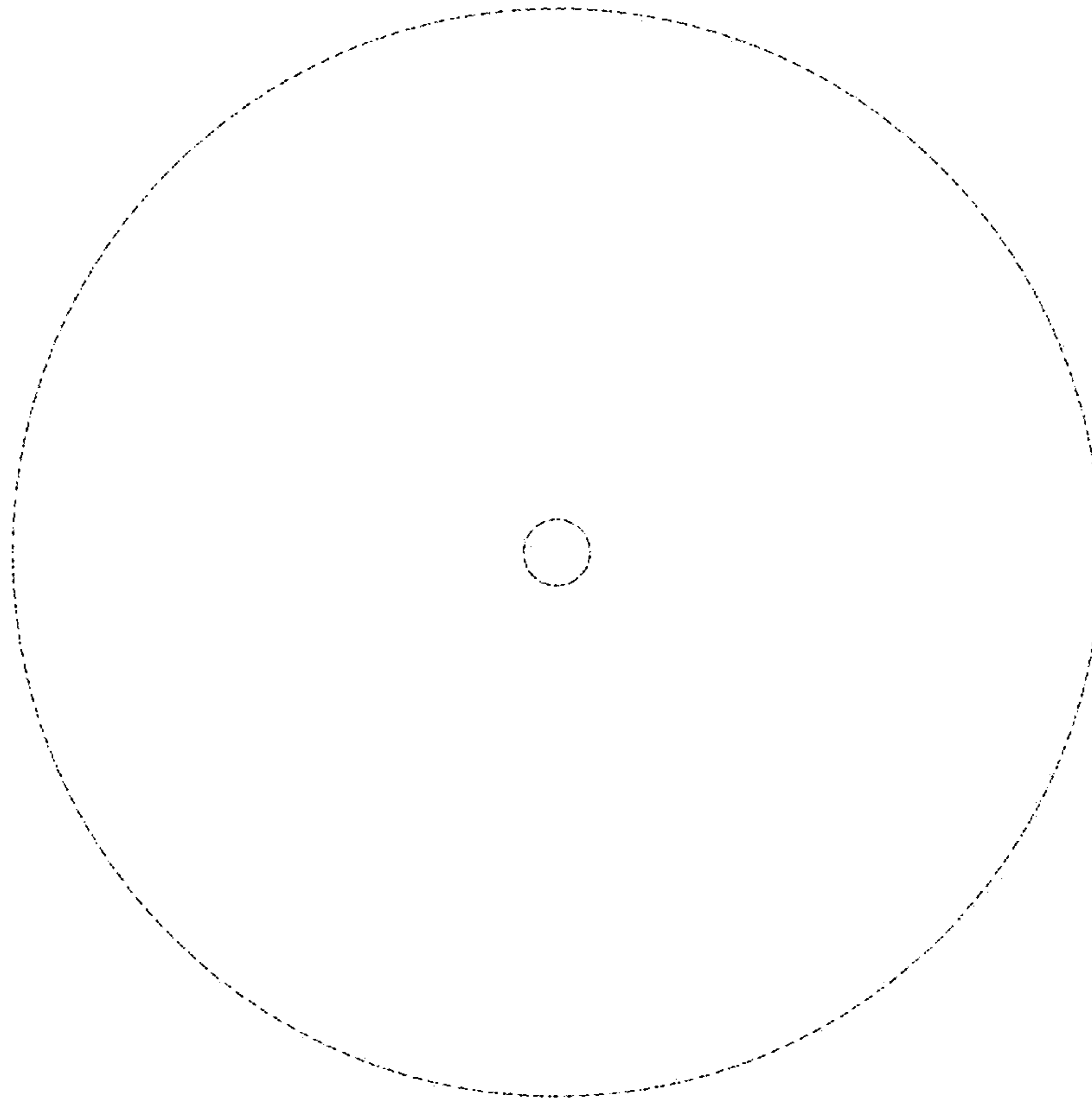

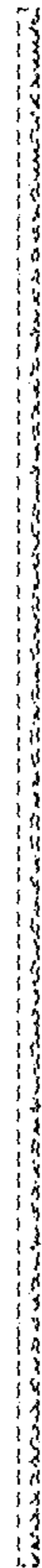

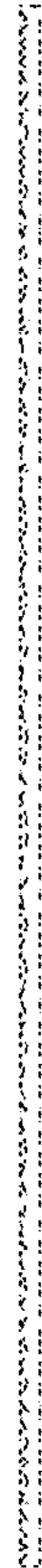

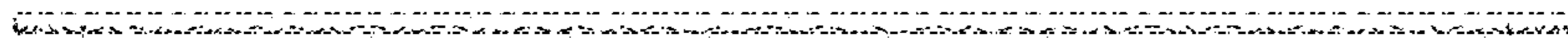

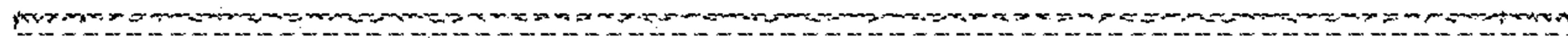

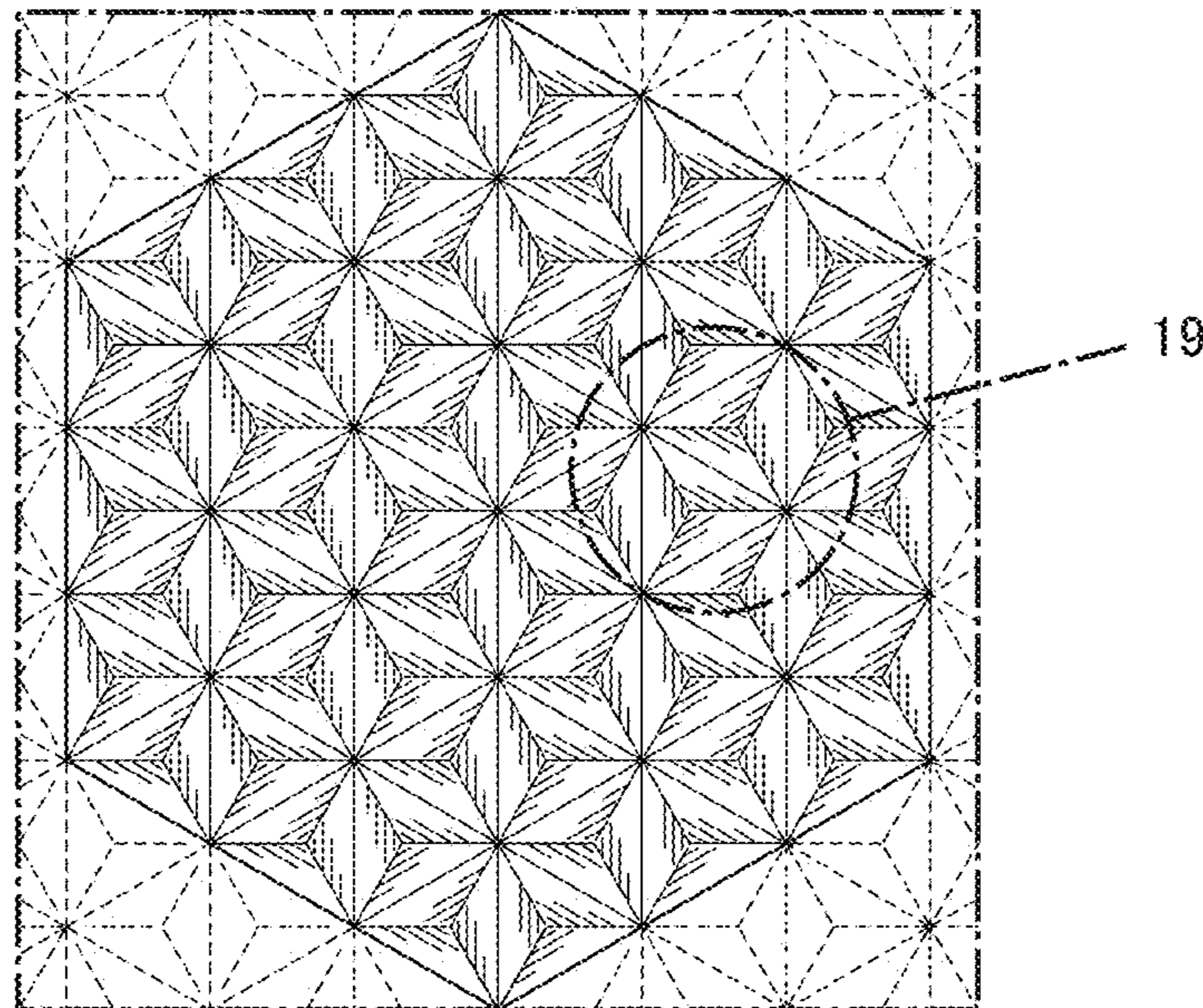

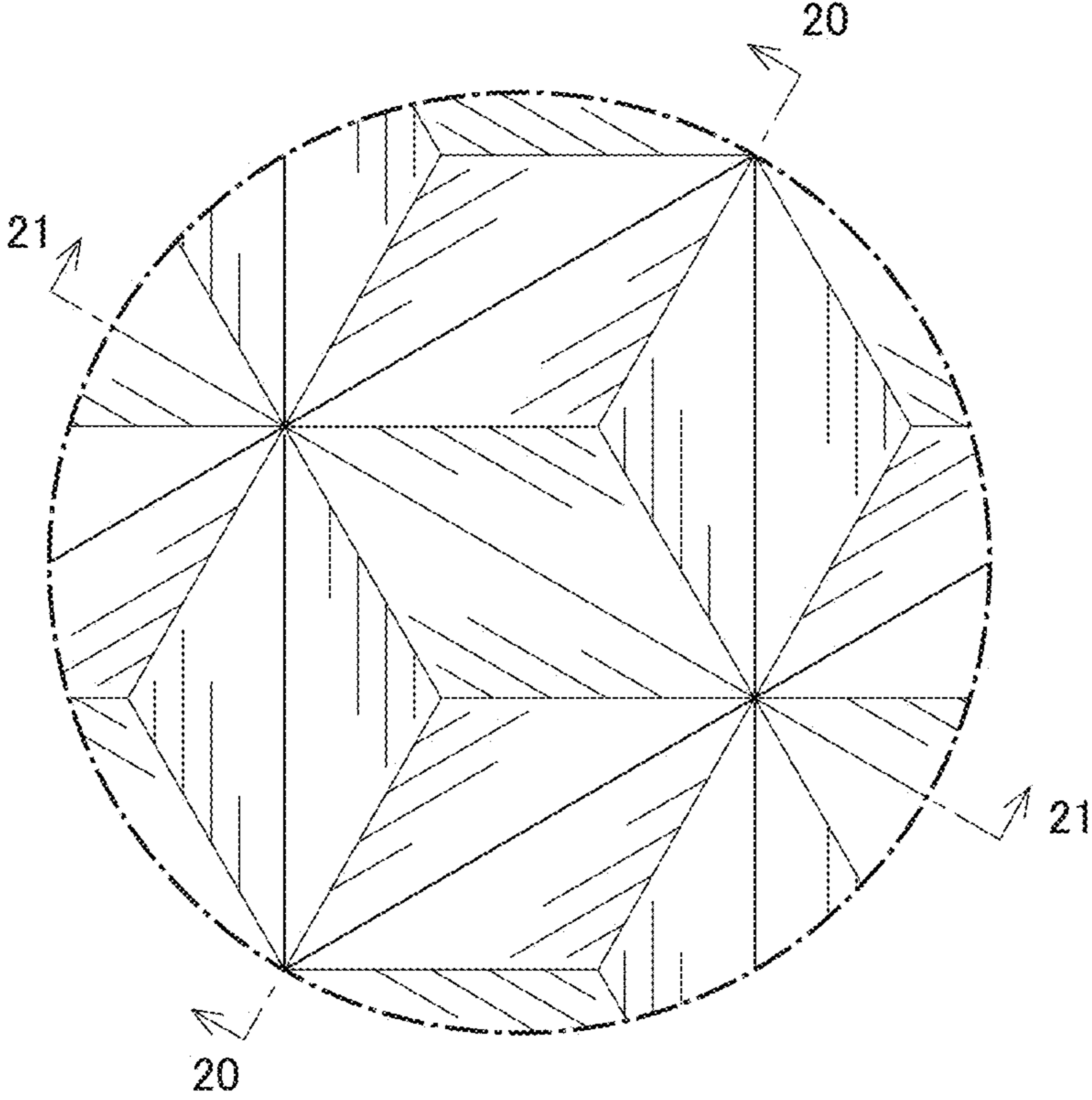

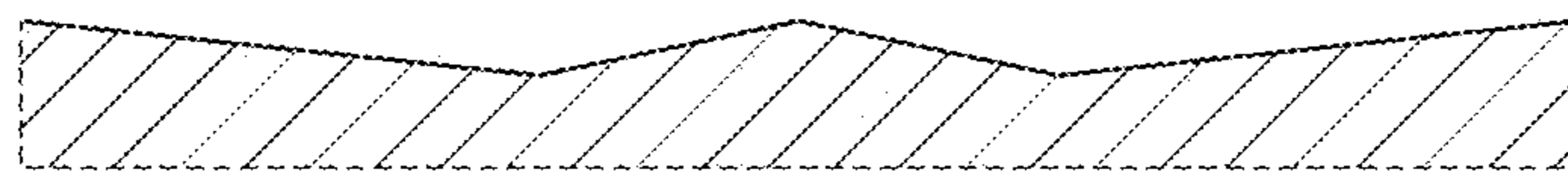
