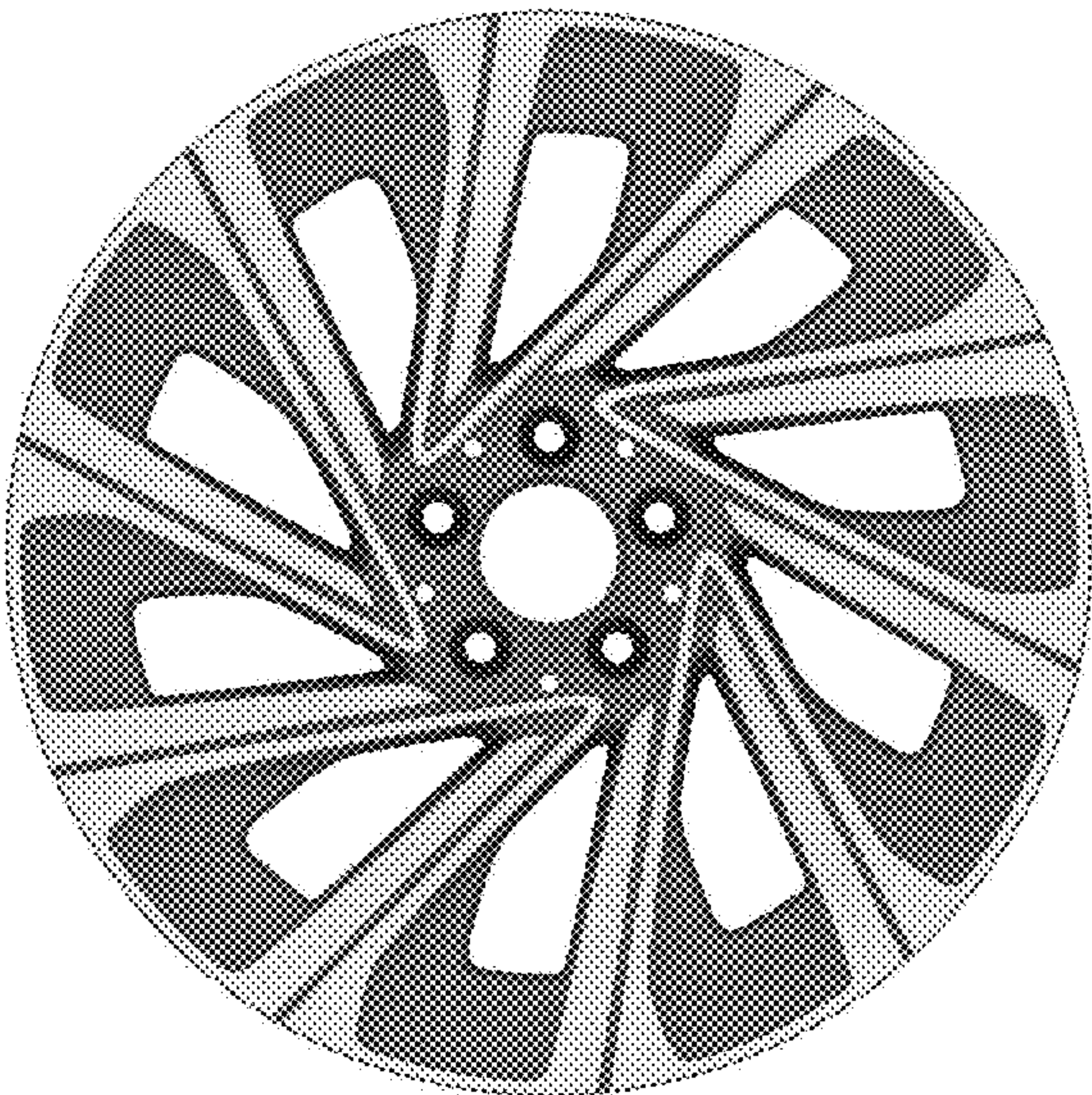
(57) CLAIM

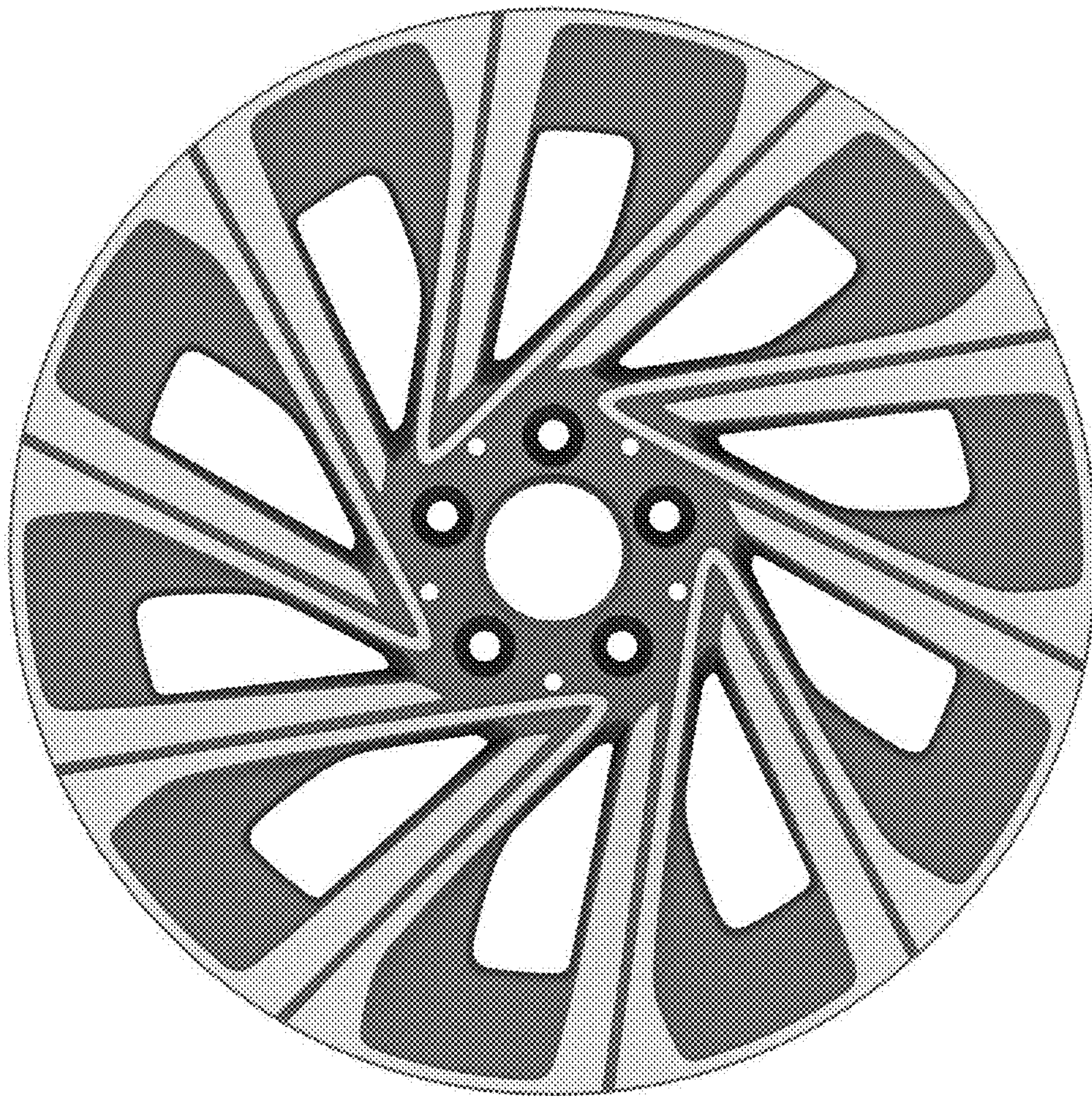
