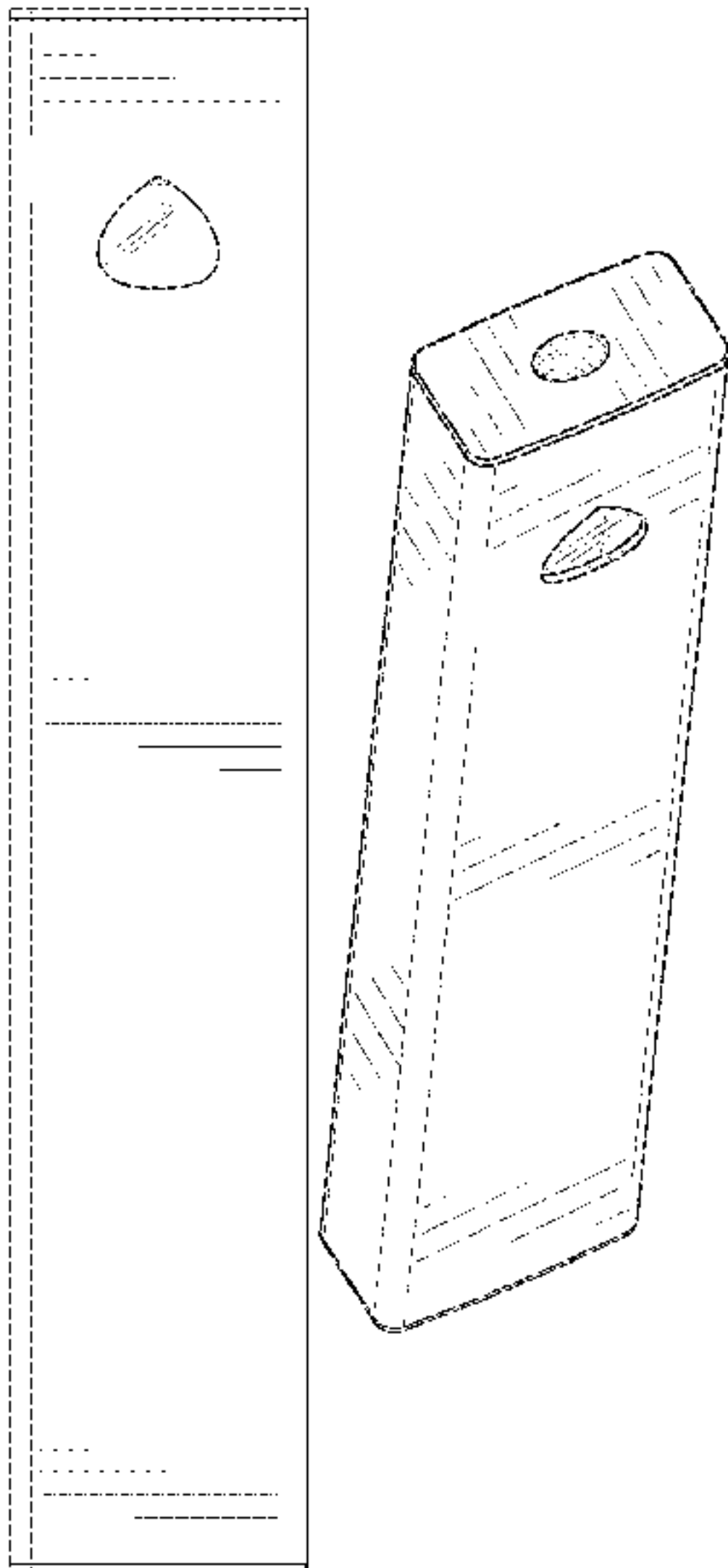
(57) CLAIM

DESCRIPTION

FIG. 1 is a front elevation view of an electronic cigarette, showing my new design;

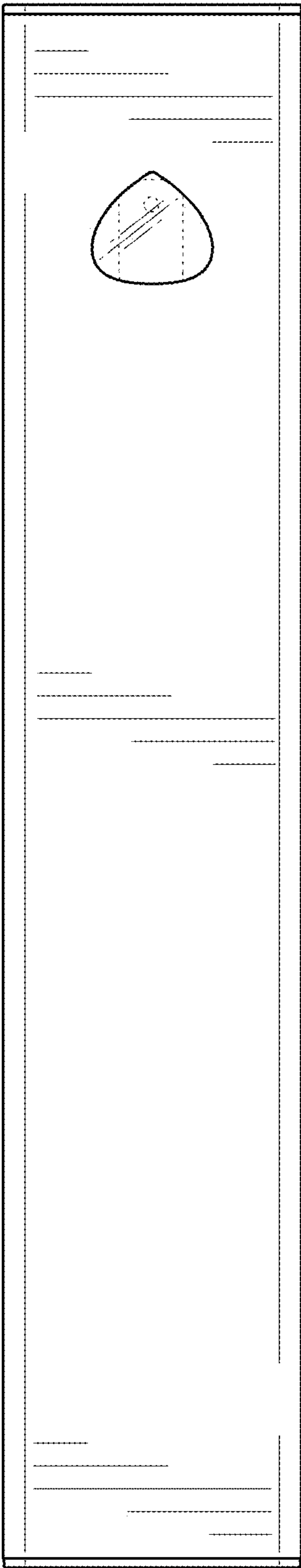

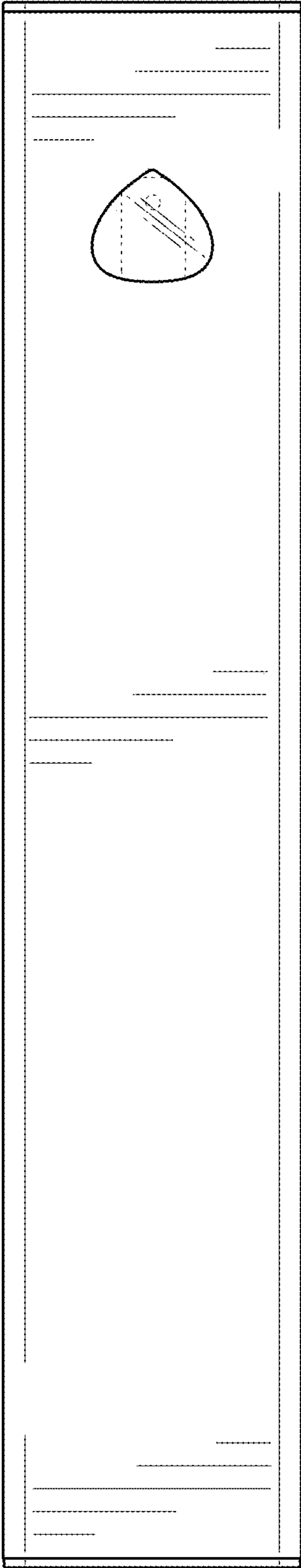

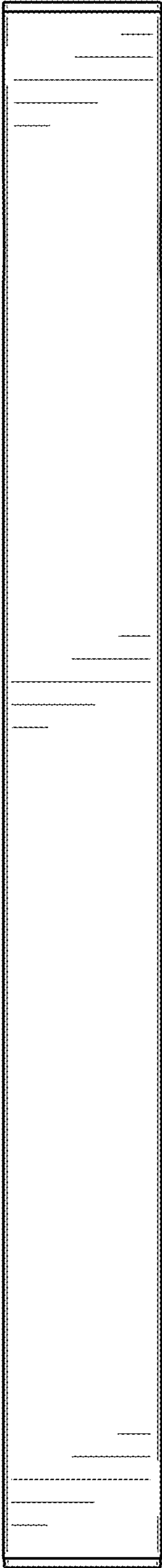

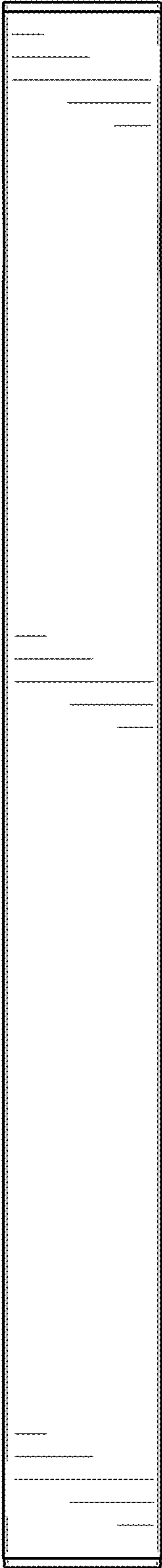

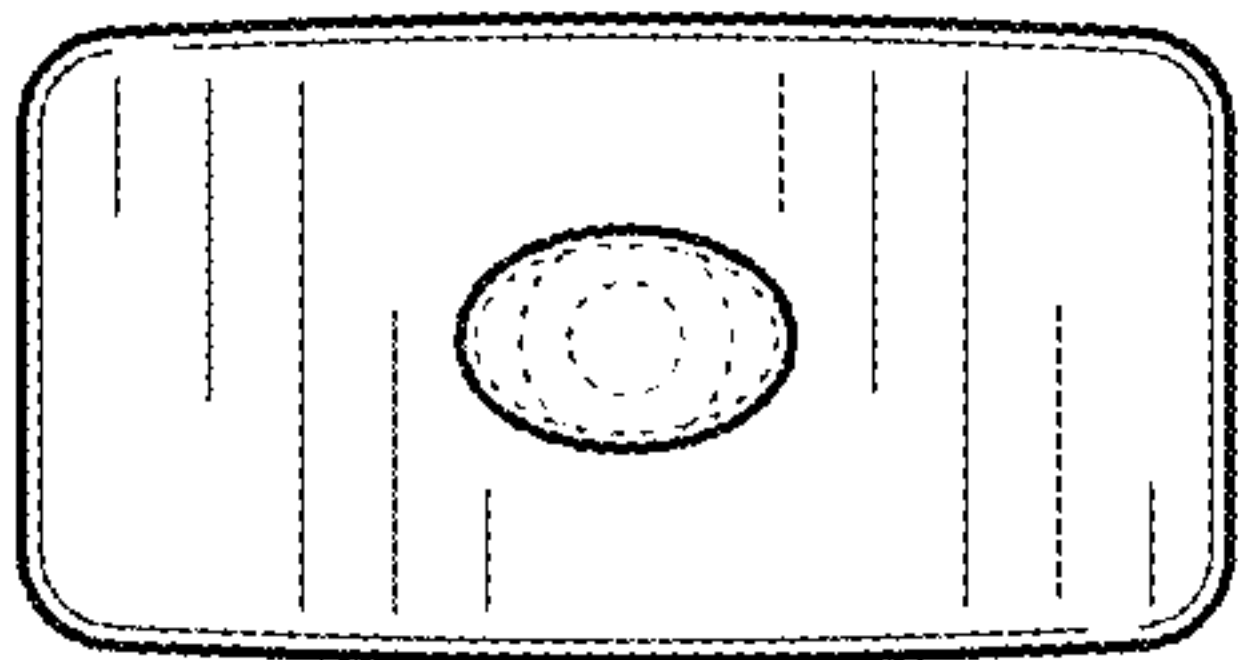

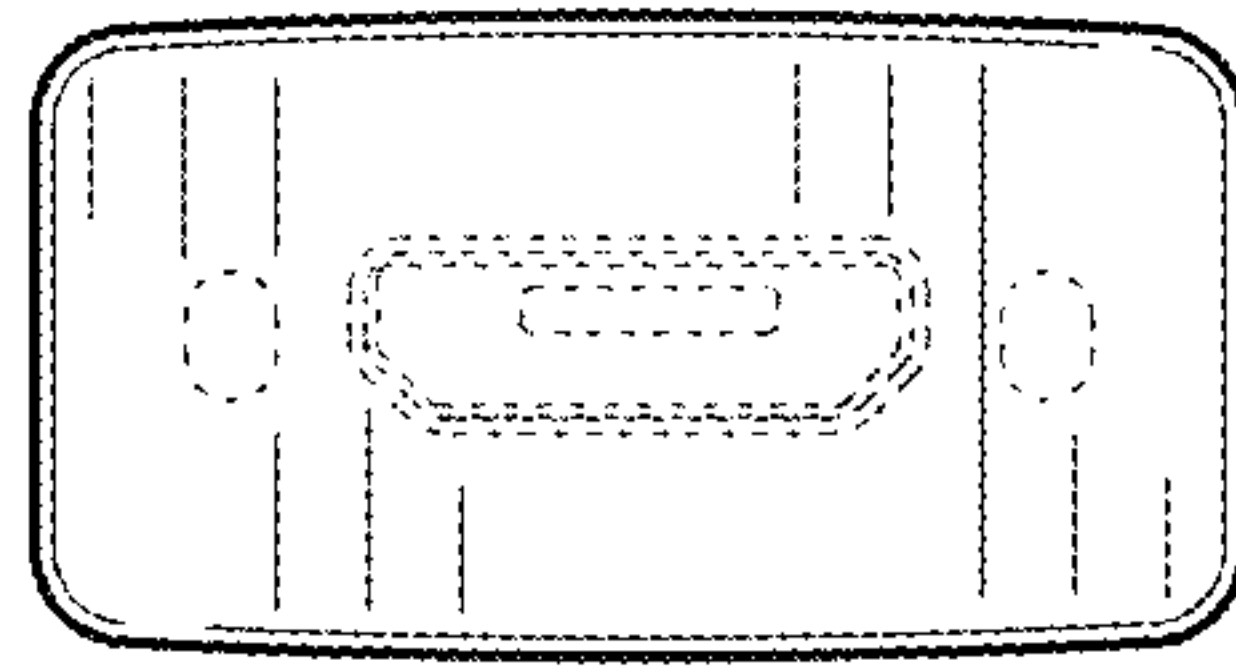

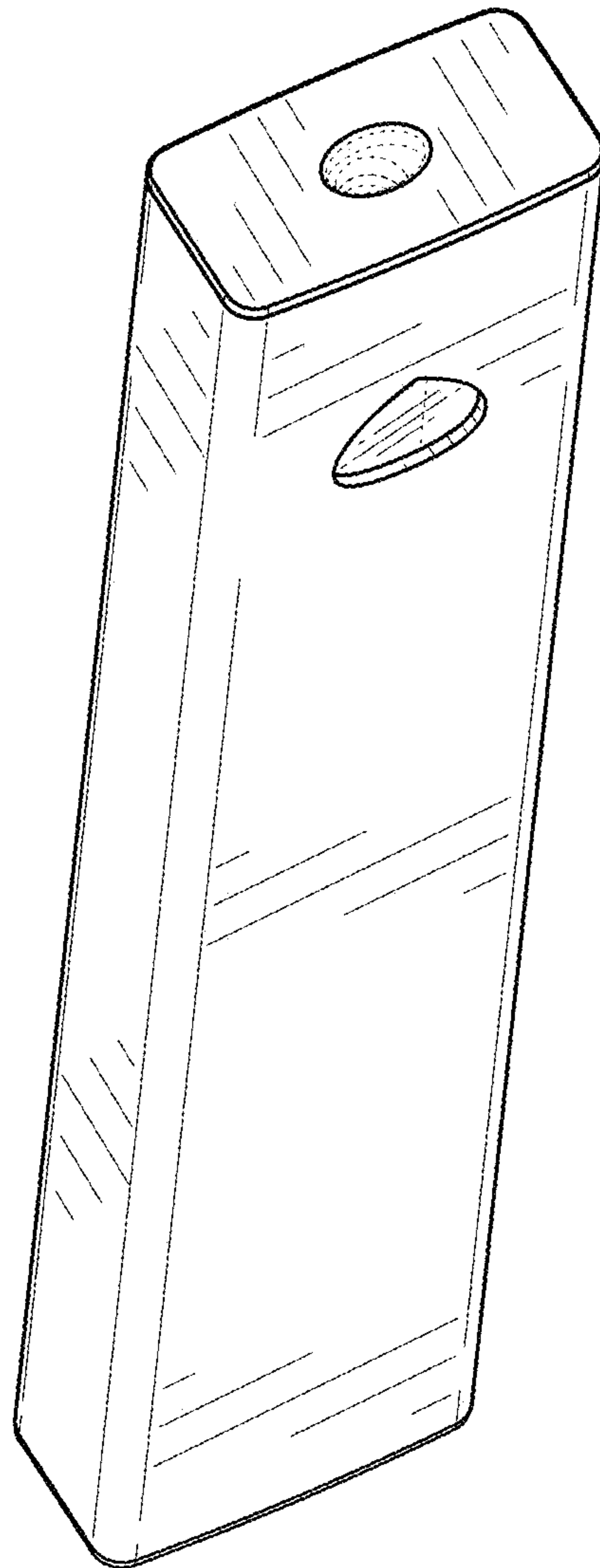

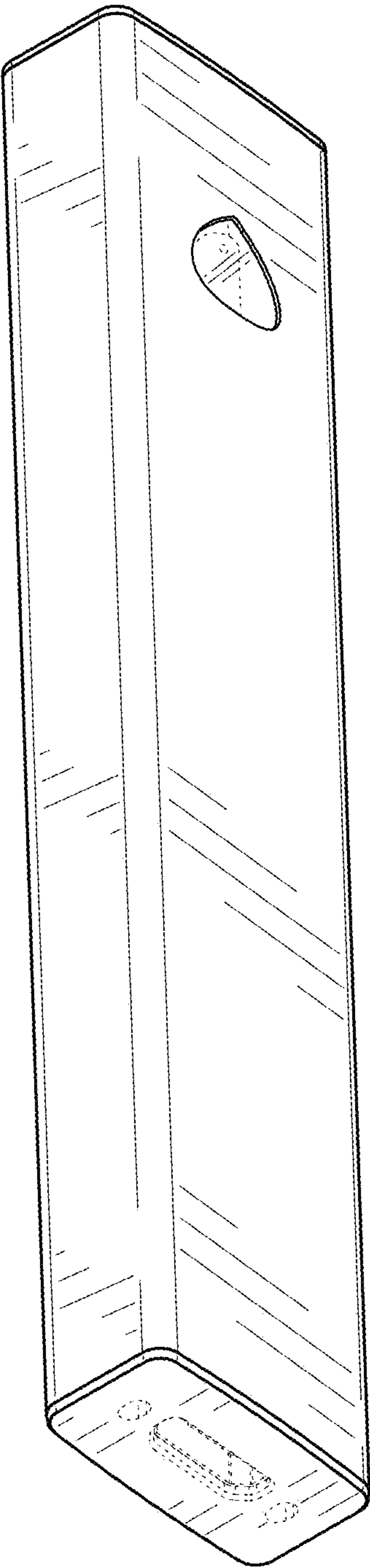
