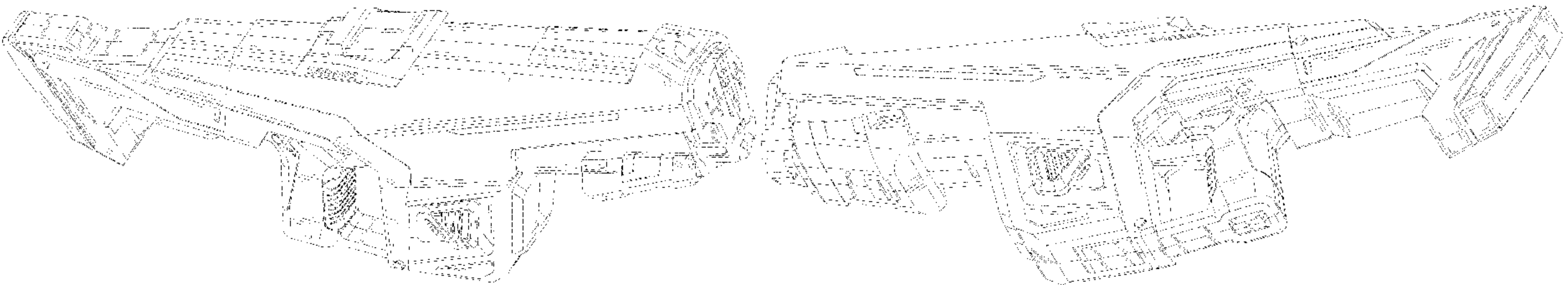
CLAIM

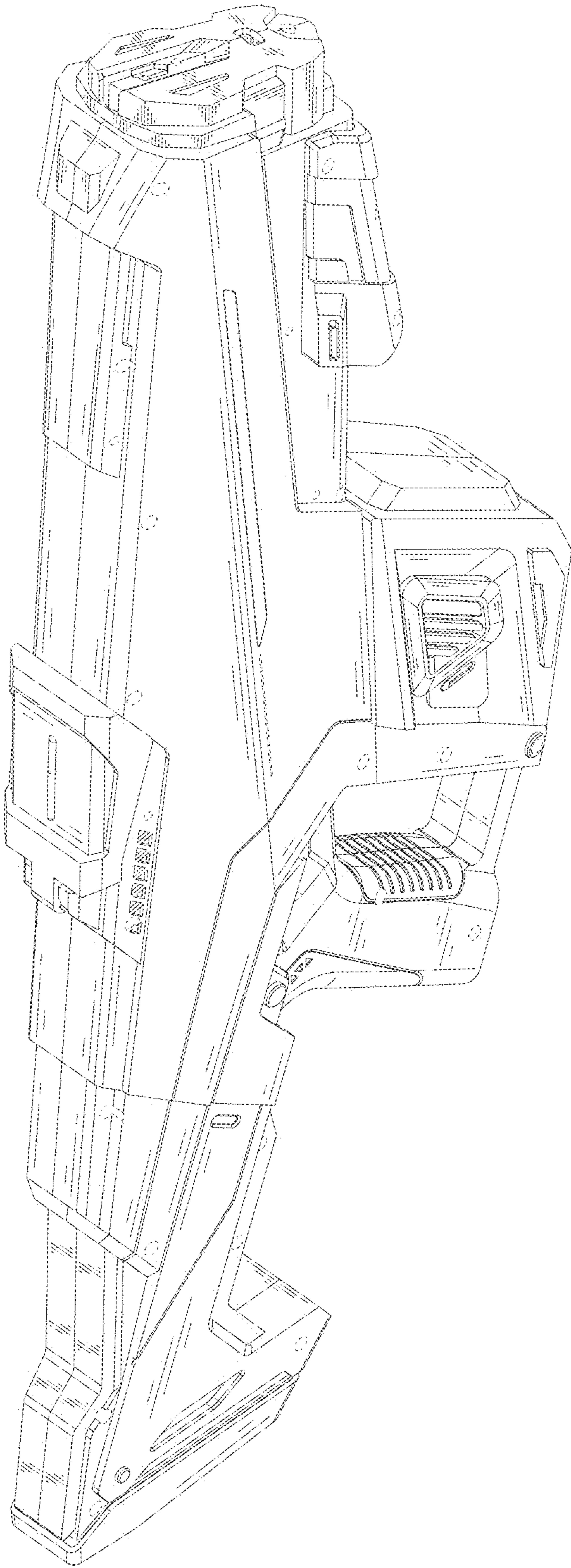

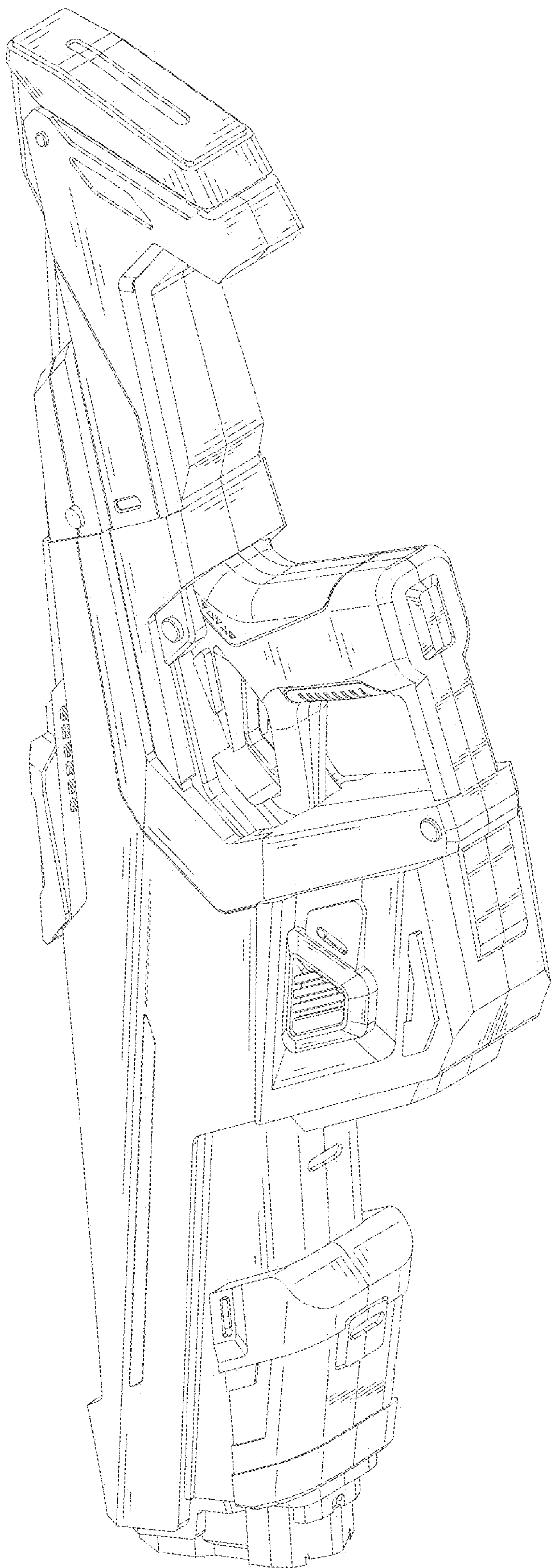

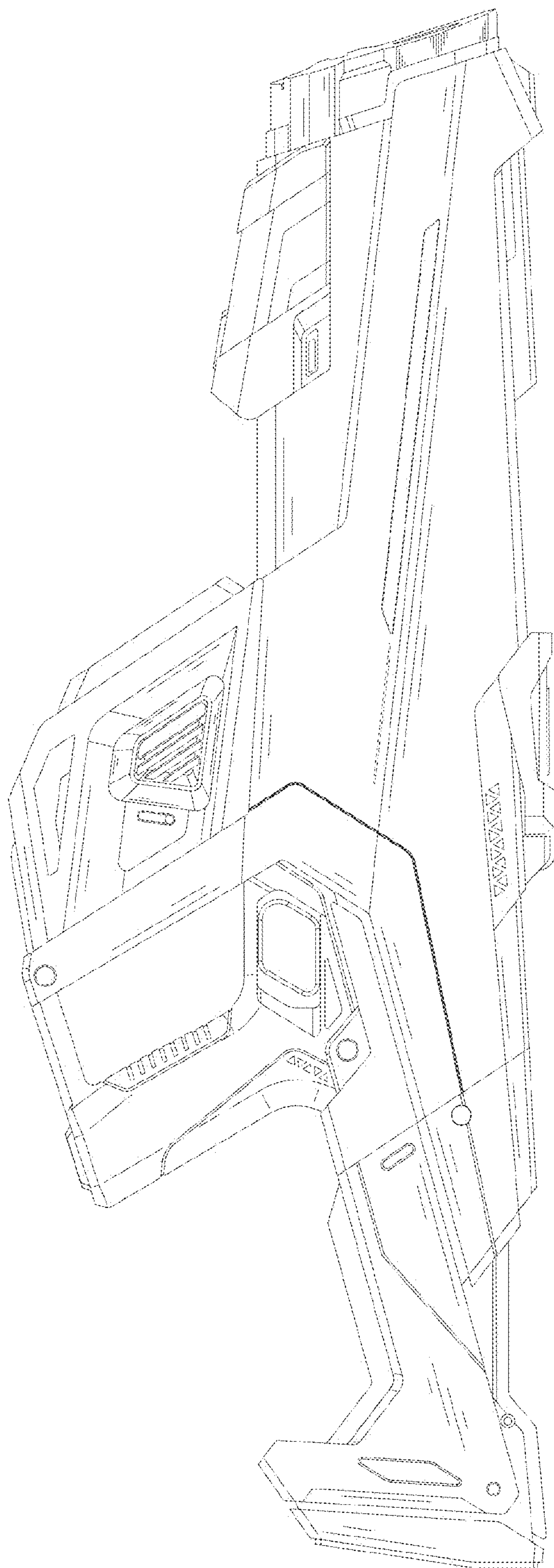

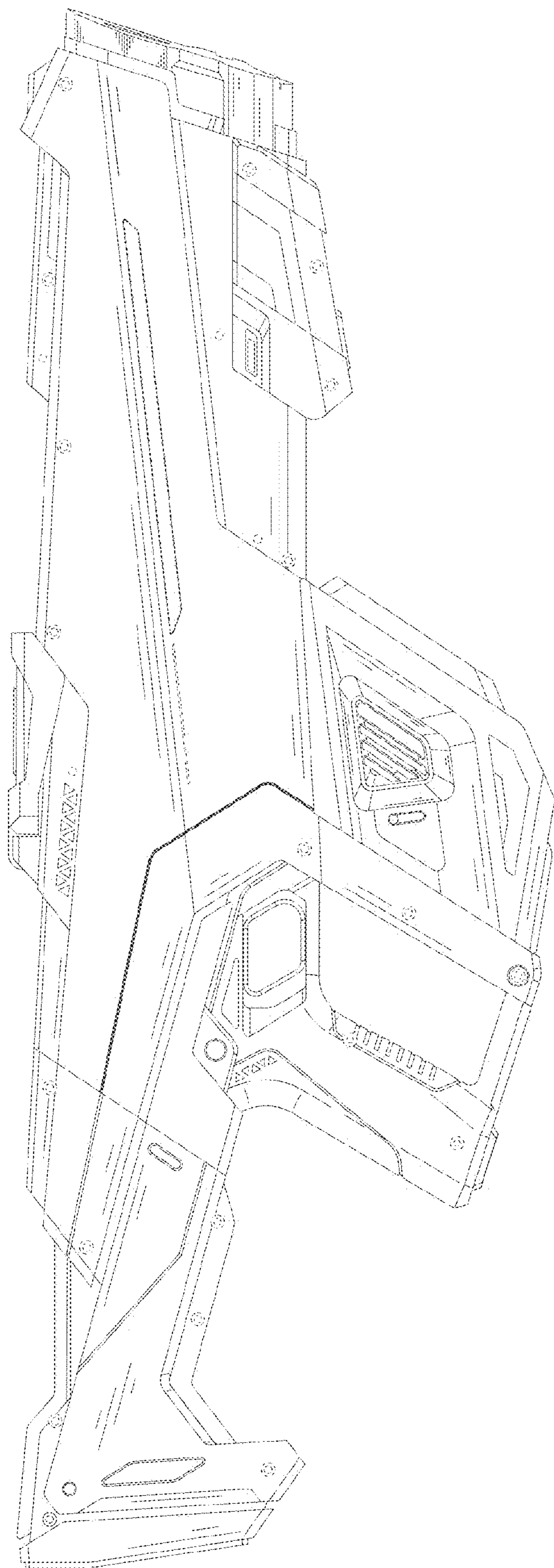

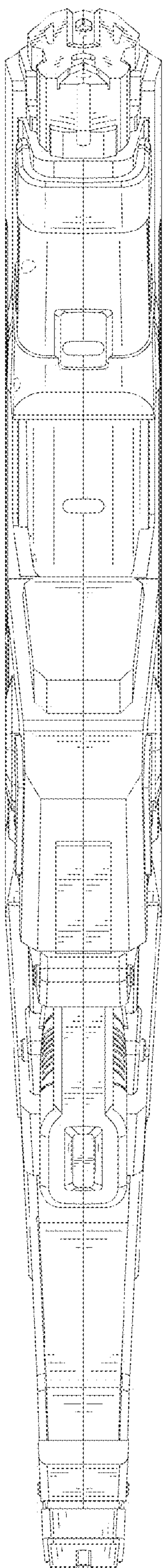

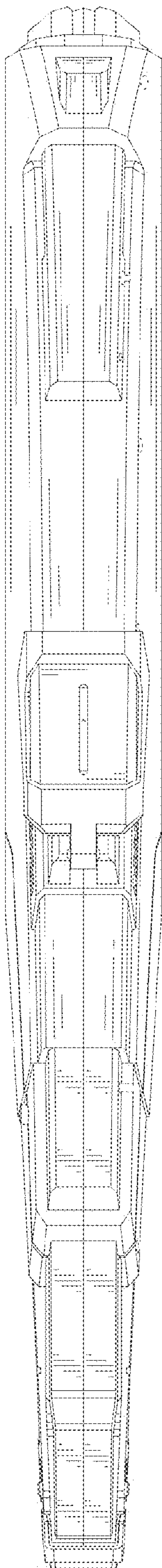

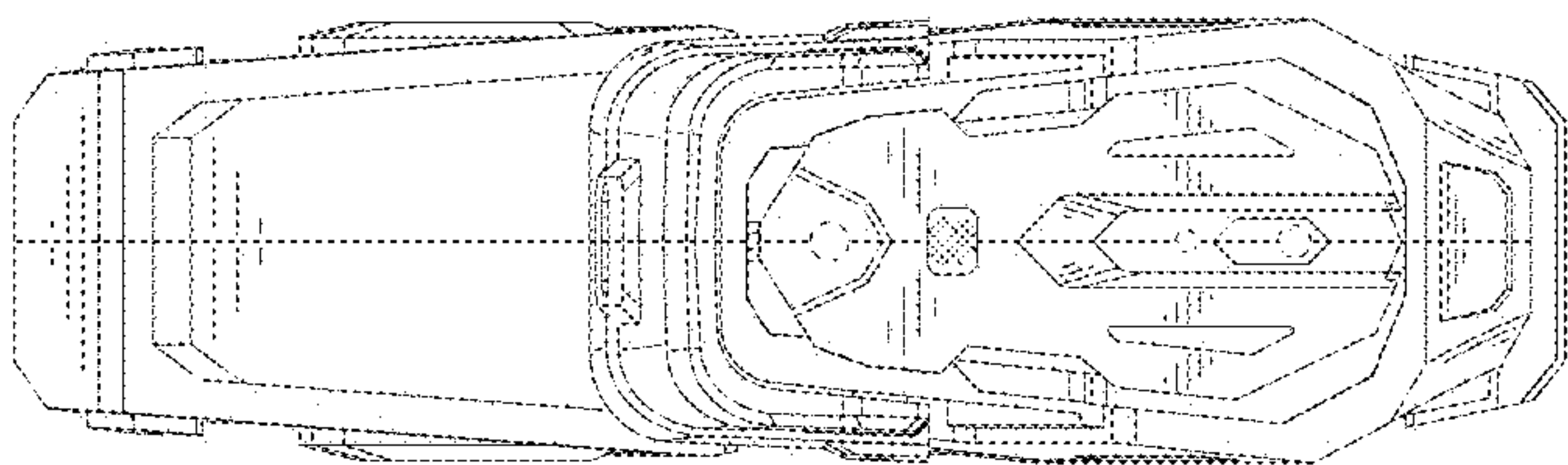

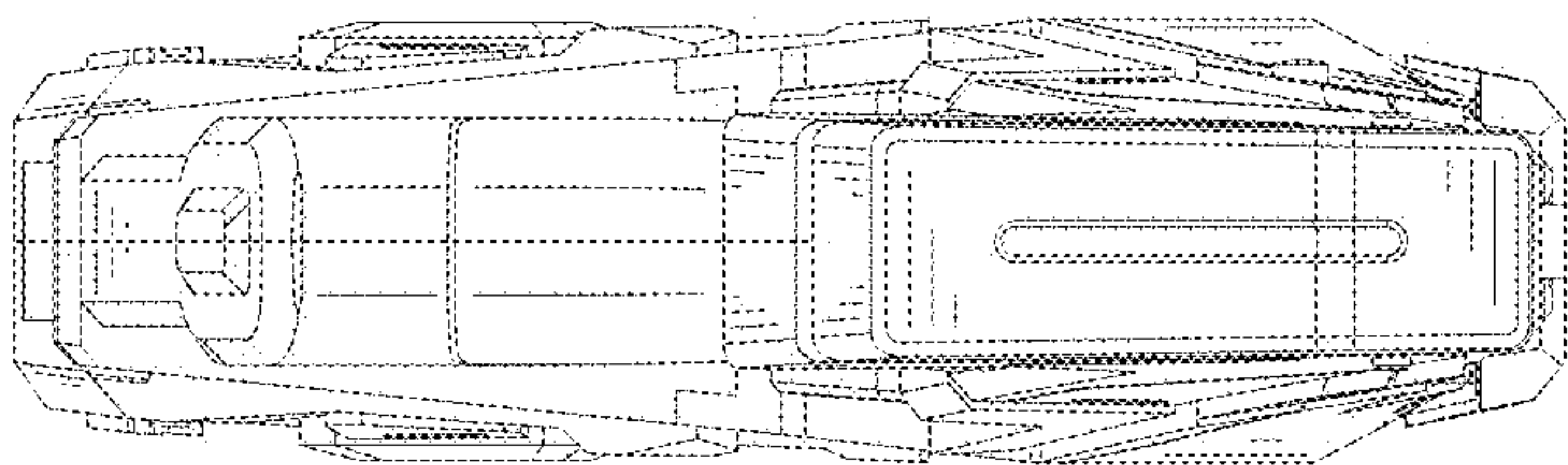
