FIG. 13 is a left side view thereof;

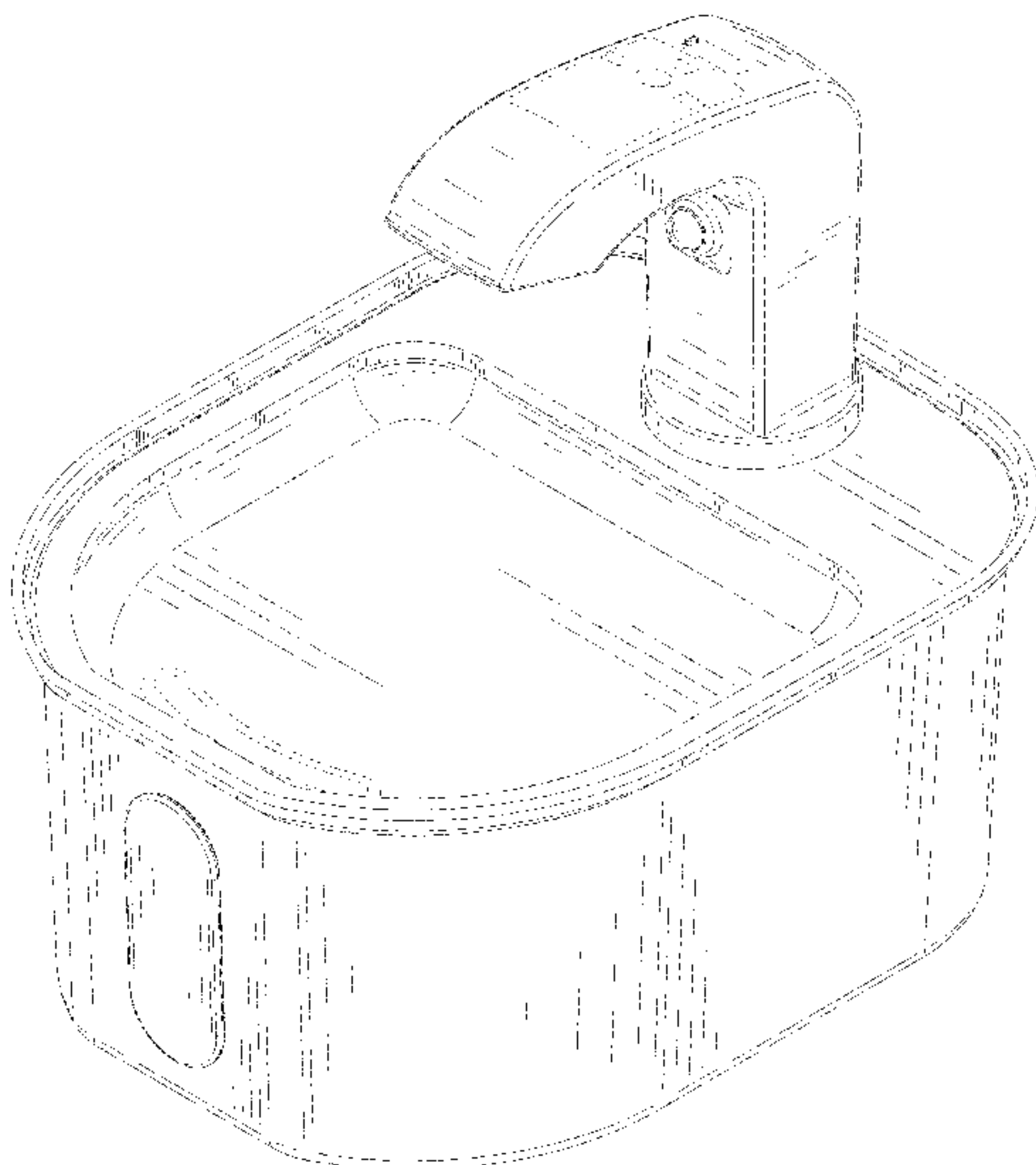
FIG. 14 is a right side view thereof;

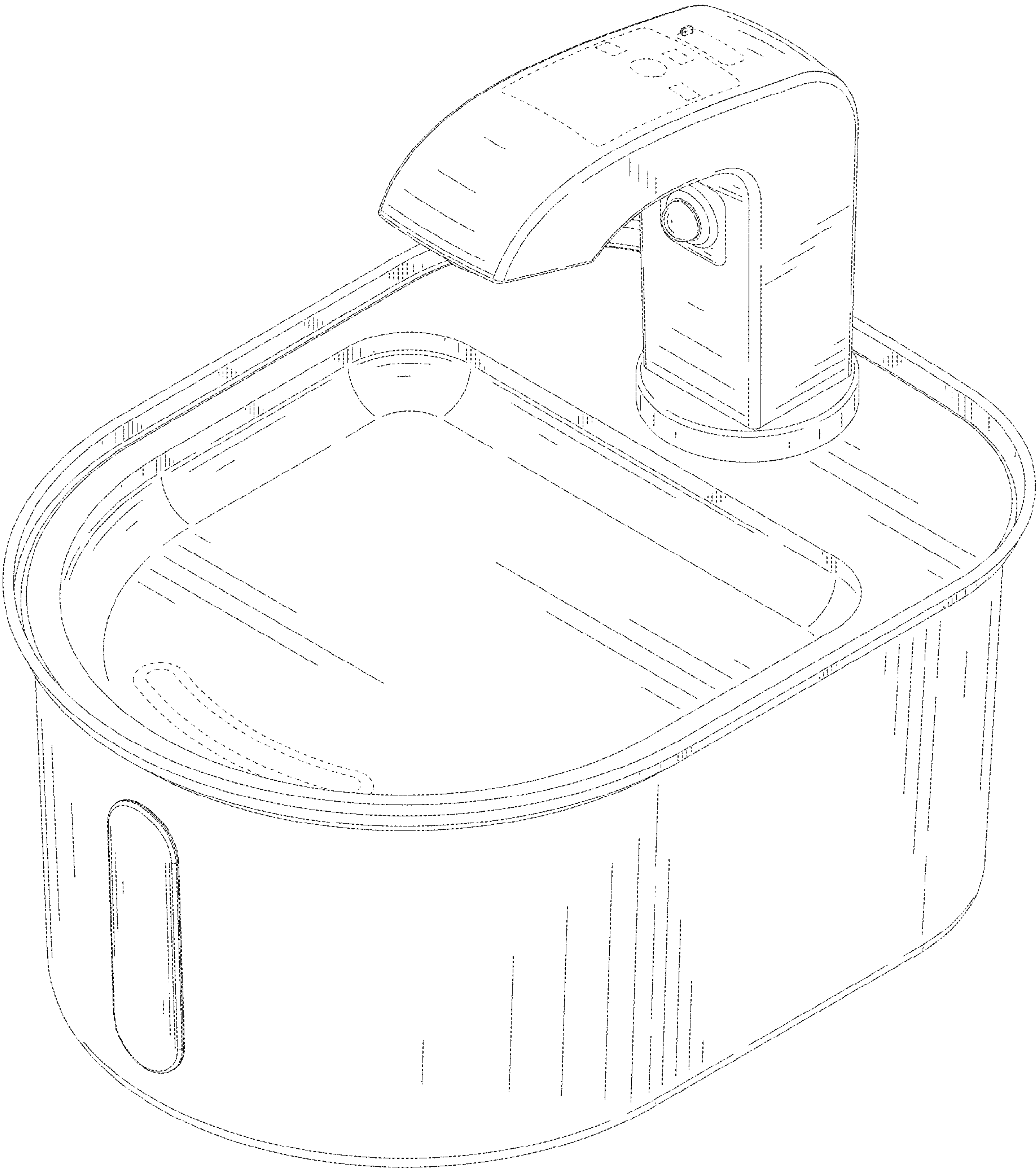

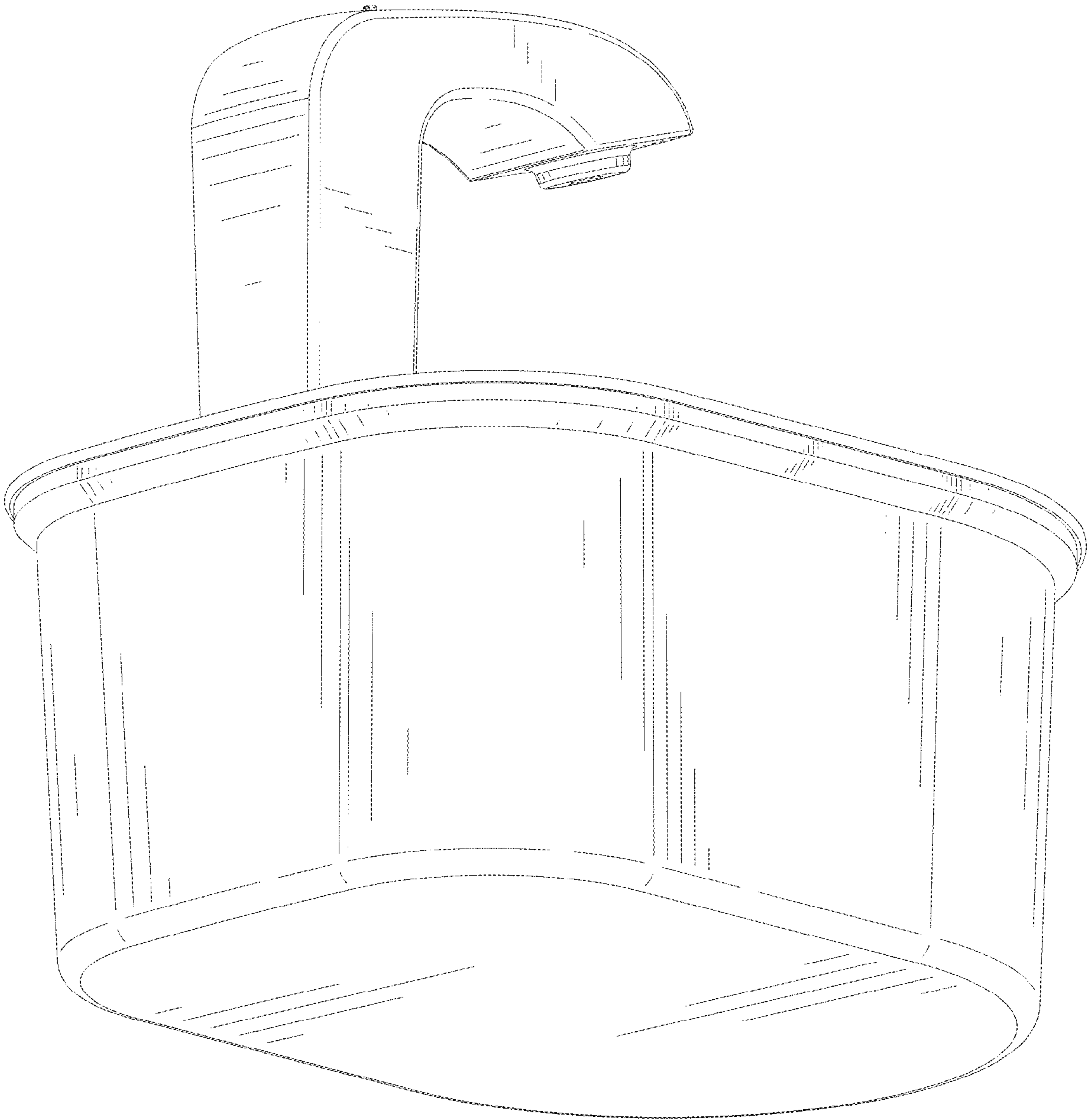

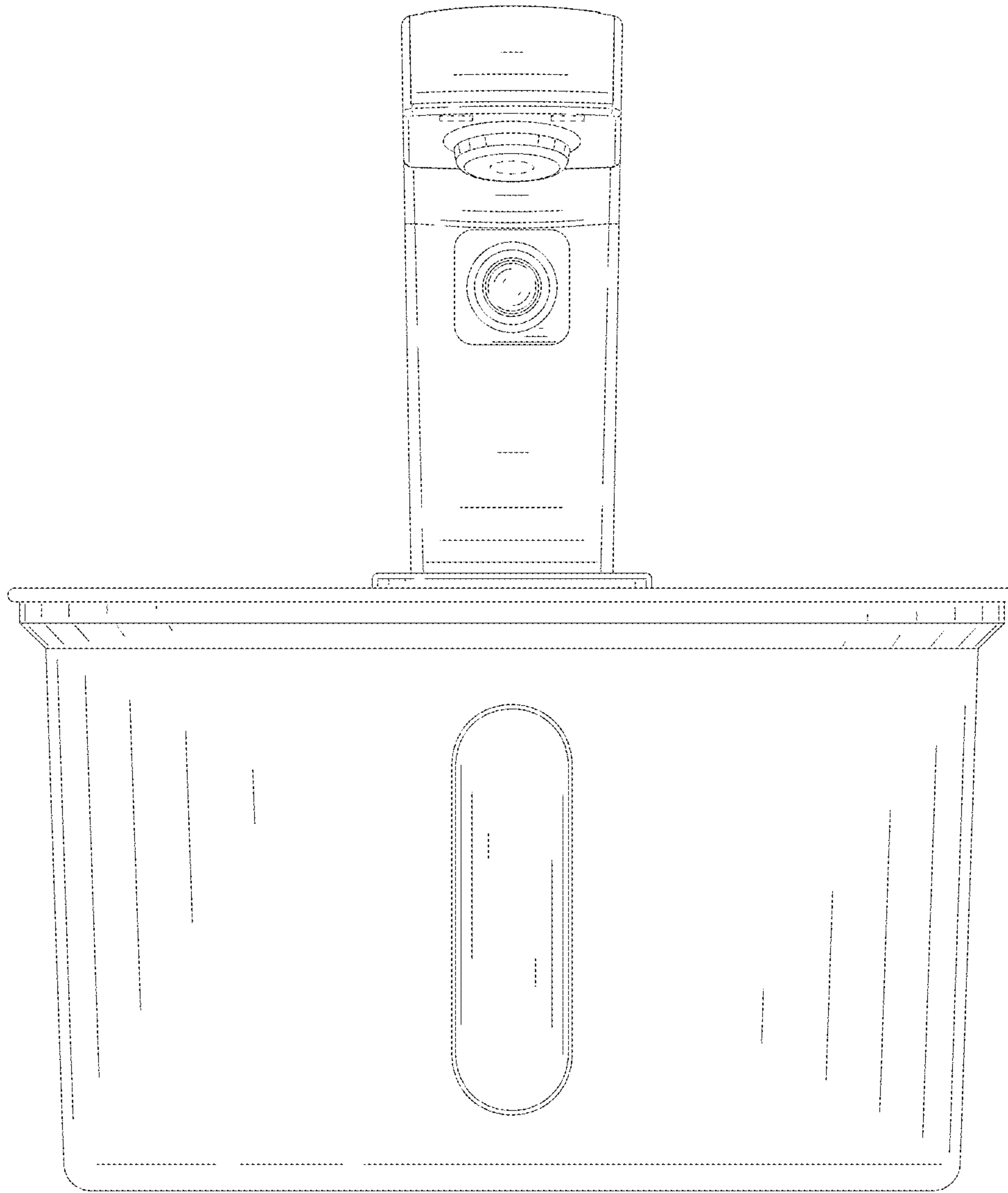

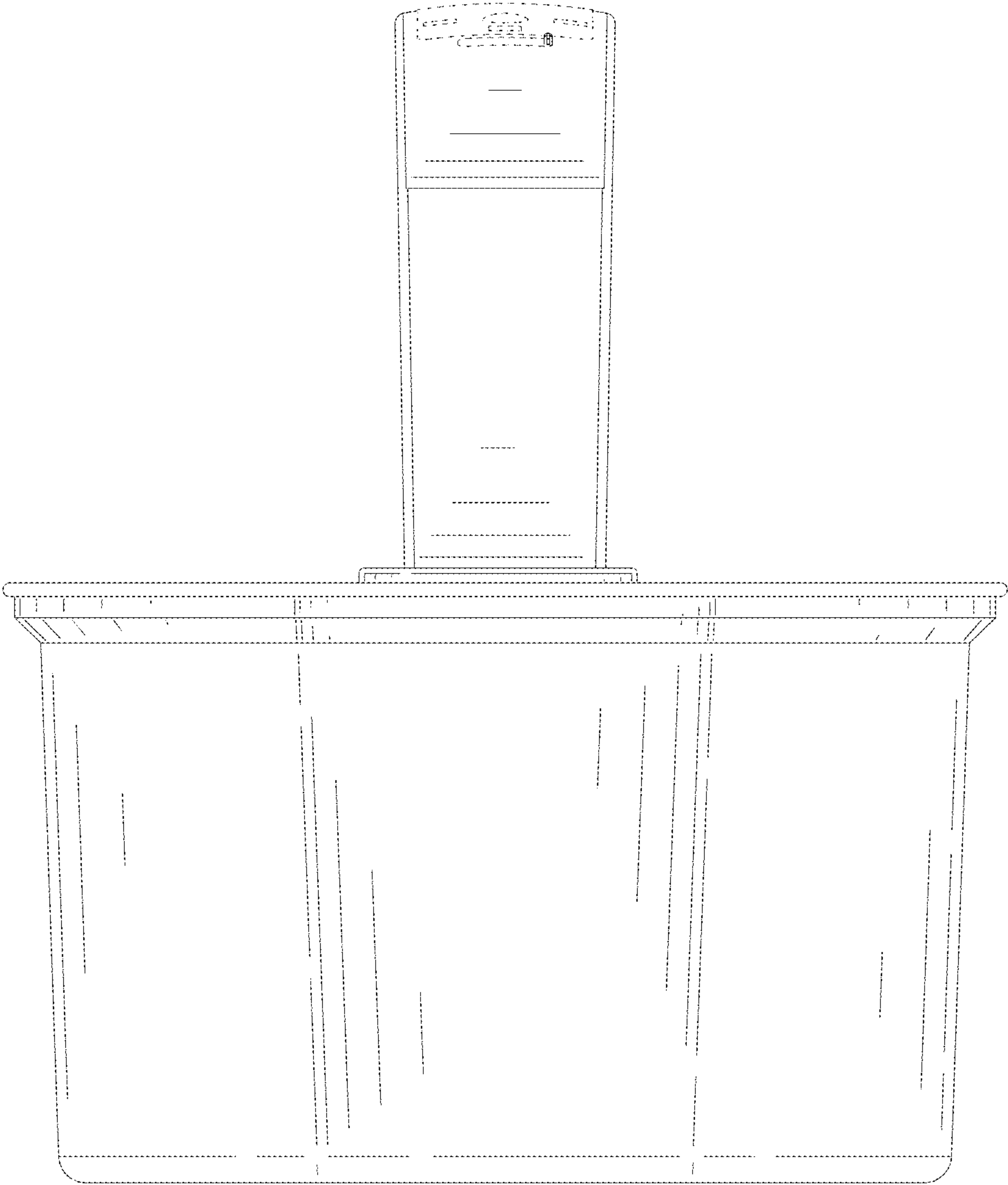

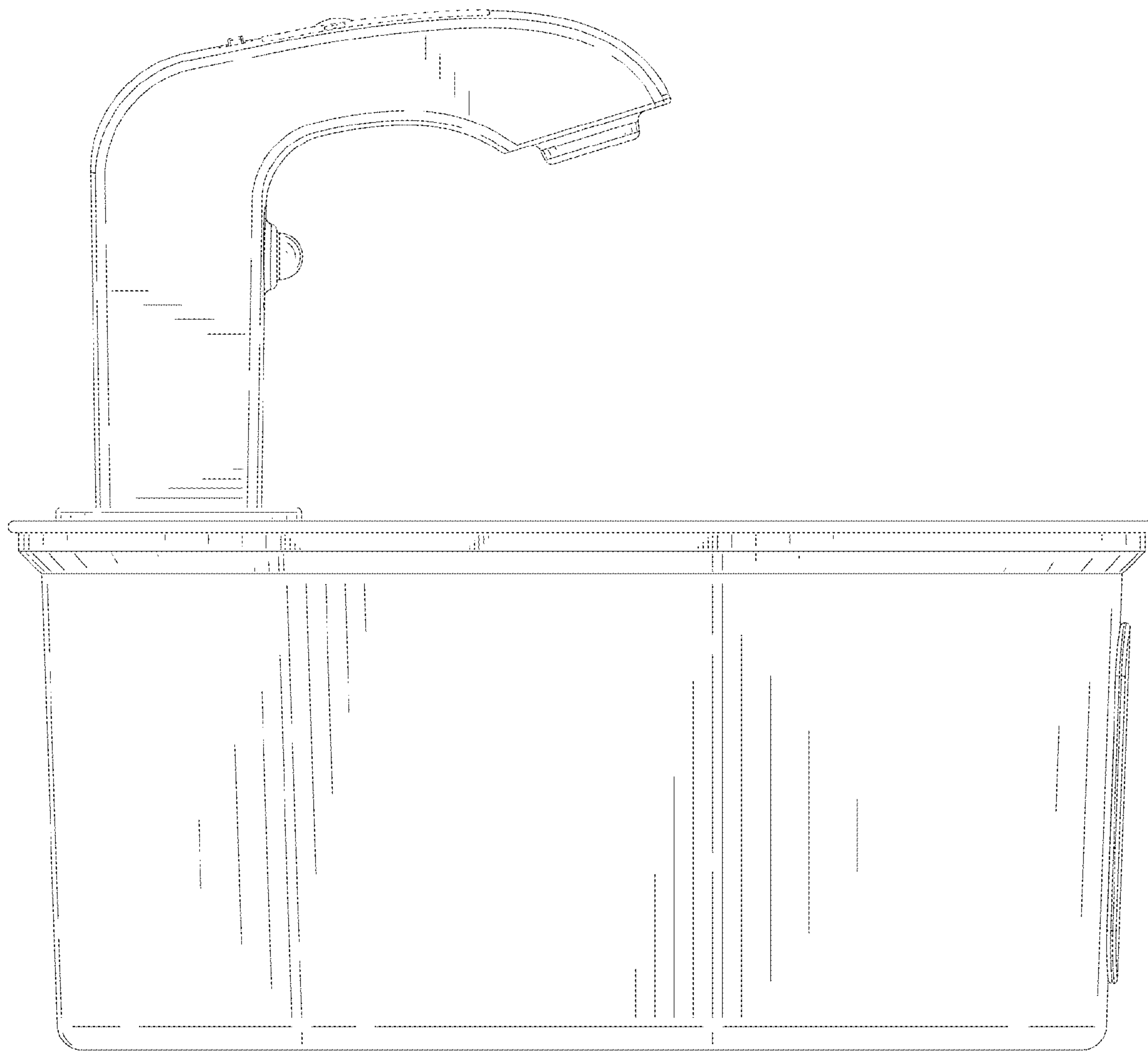

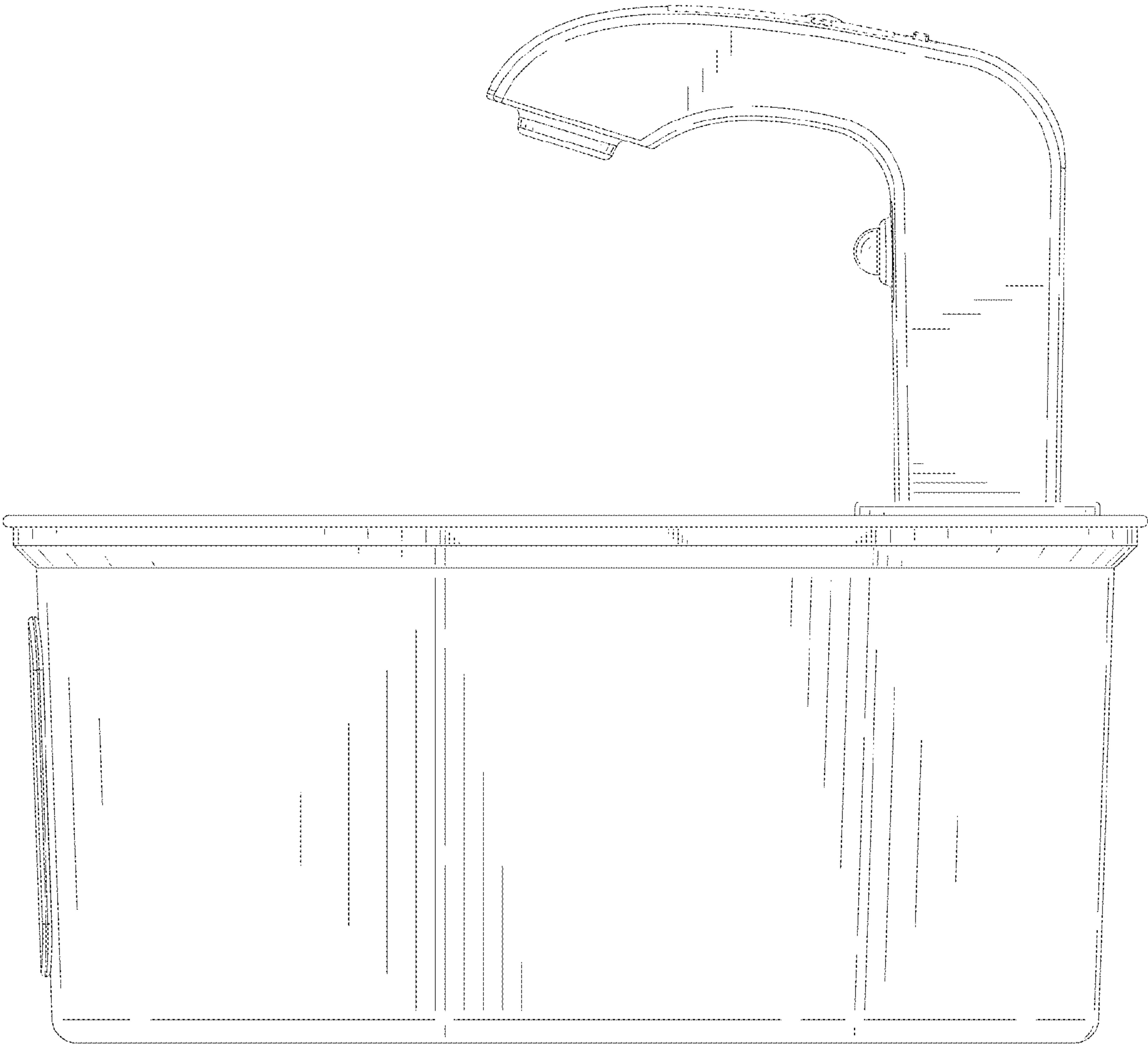

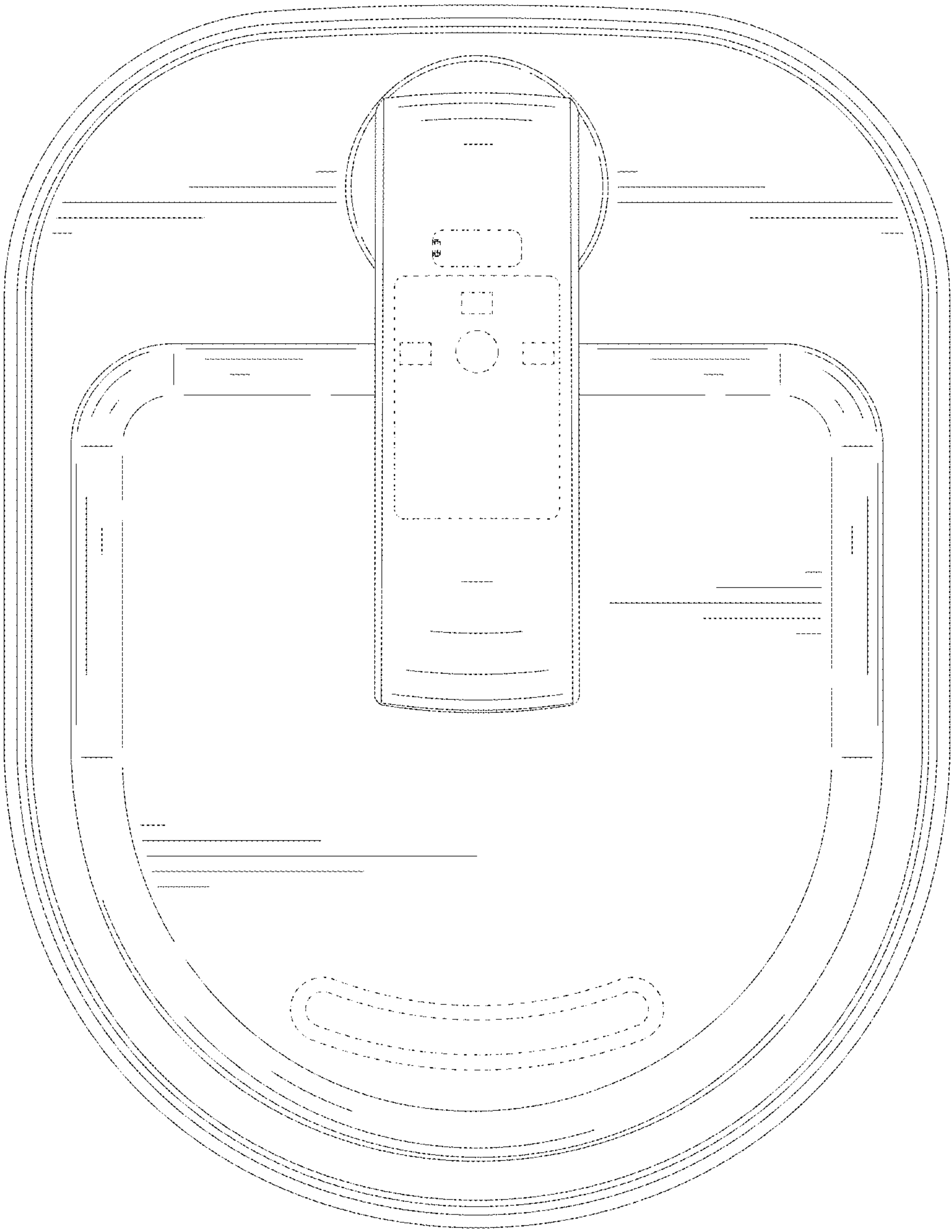

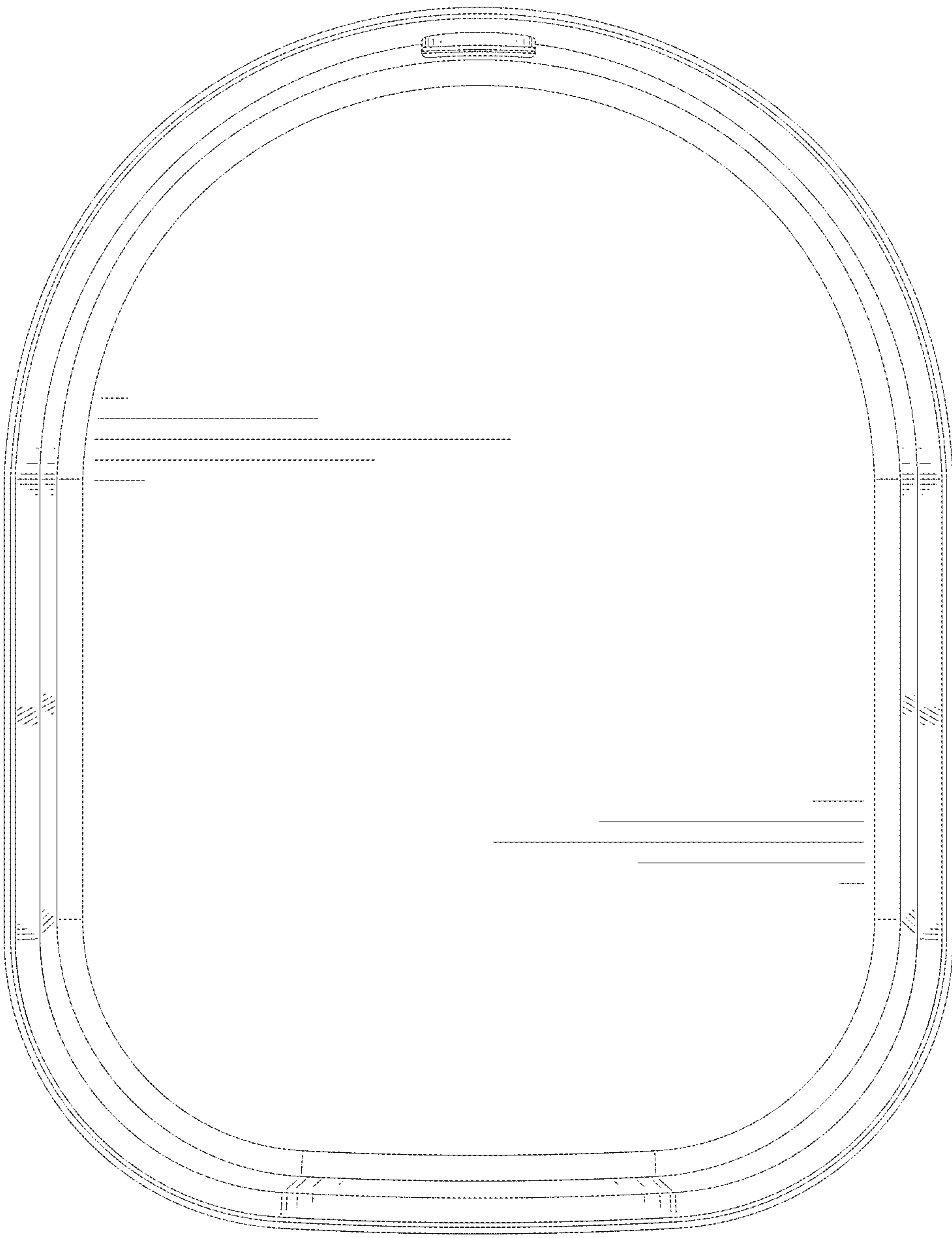

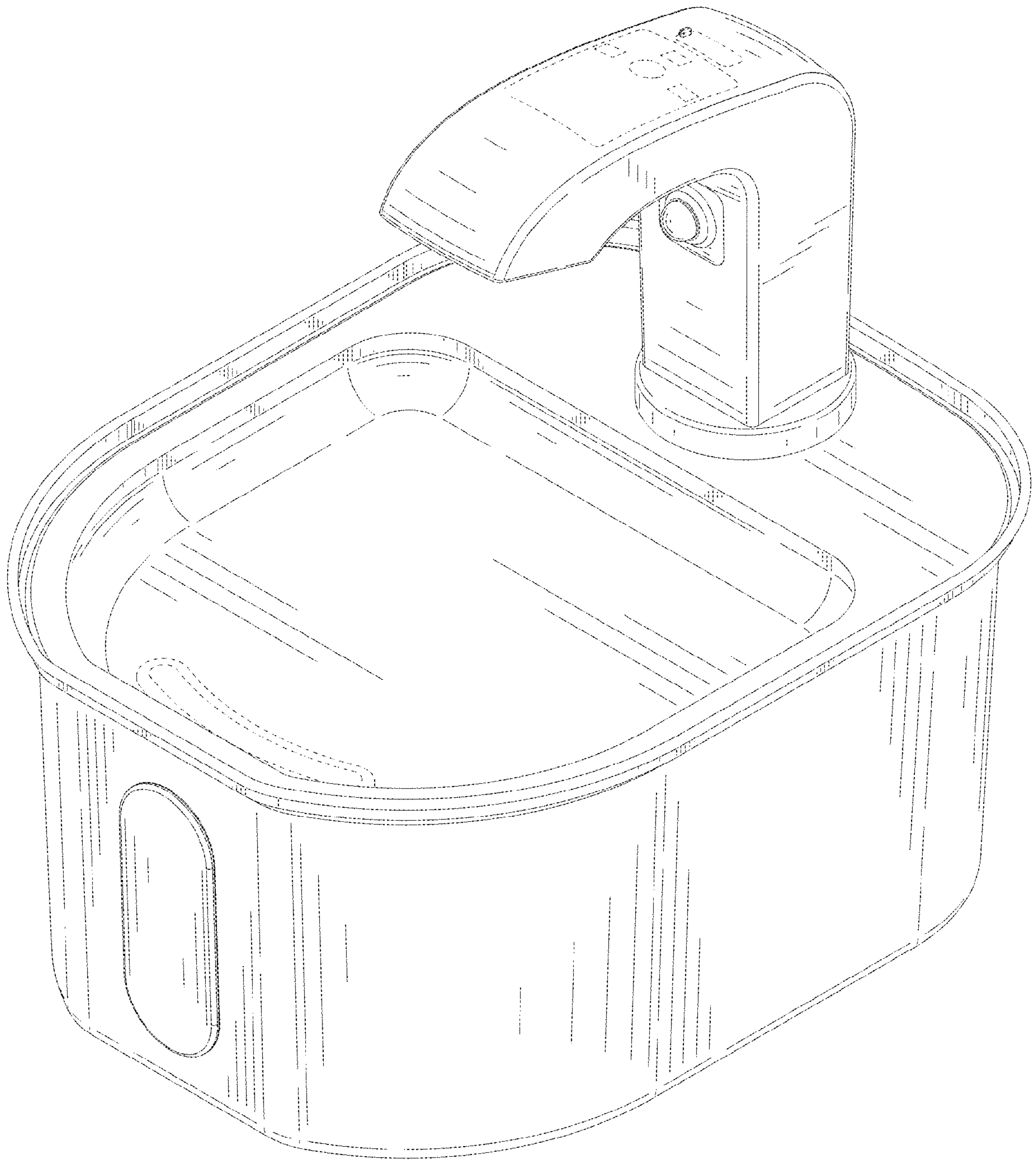

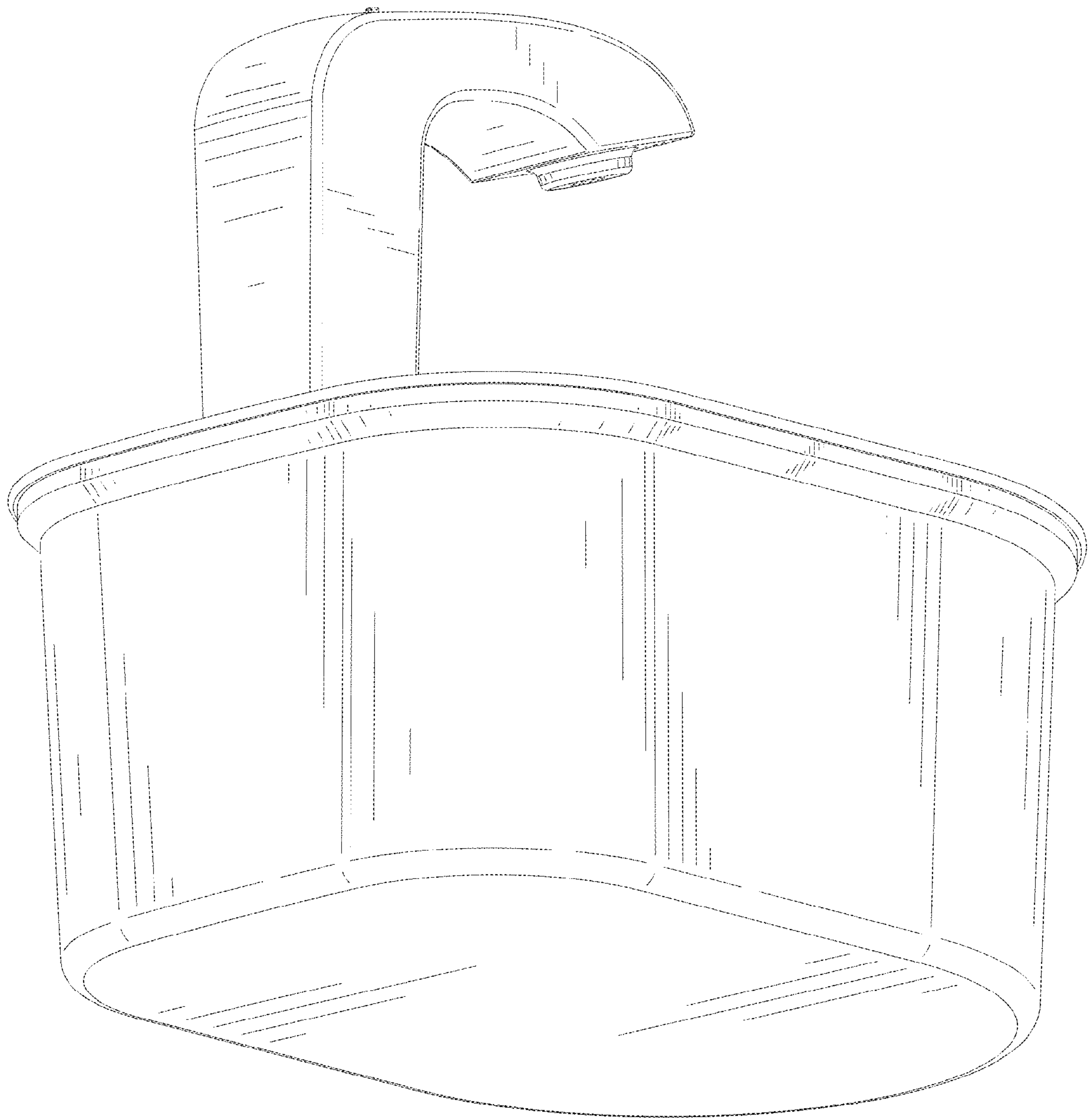

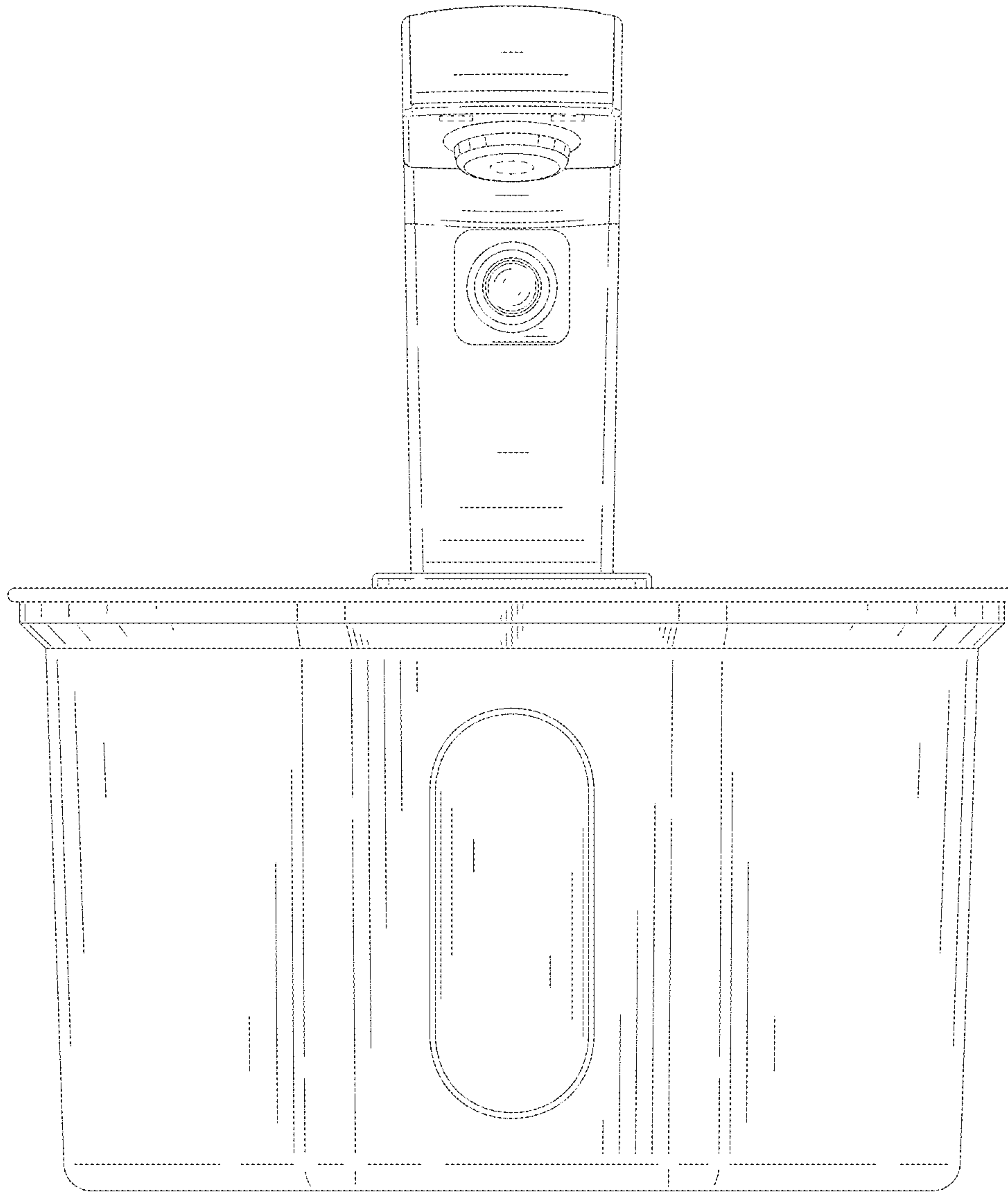

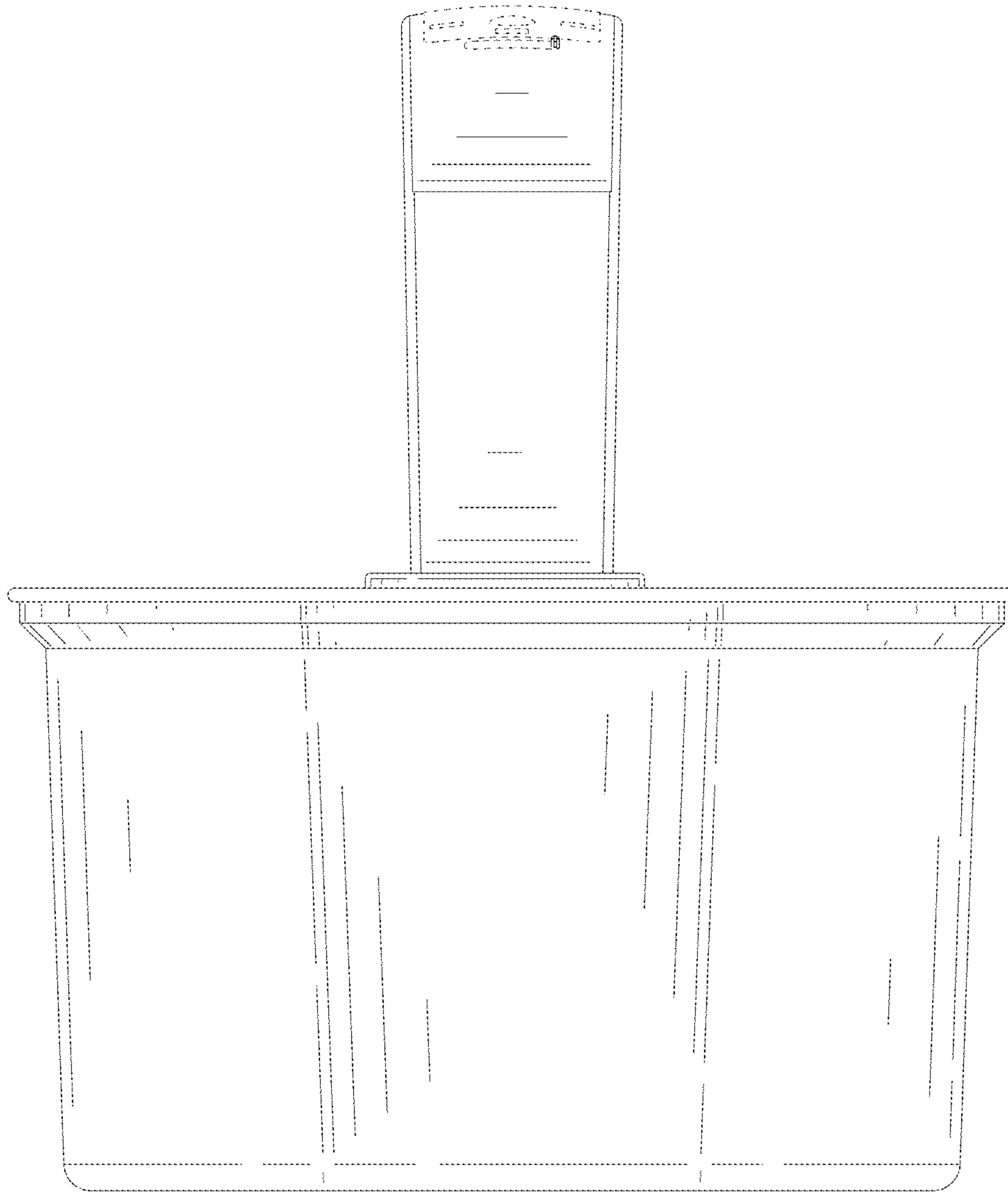

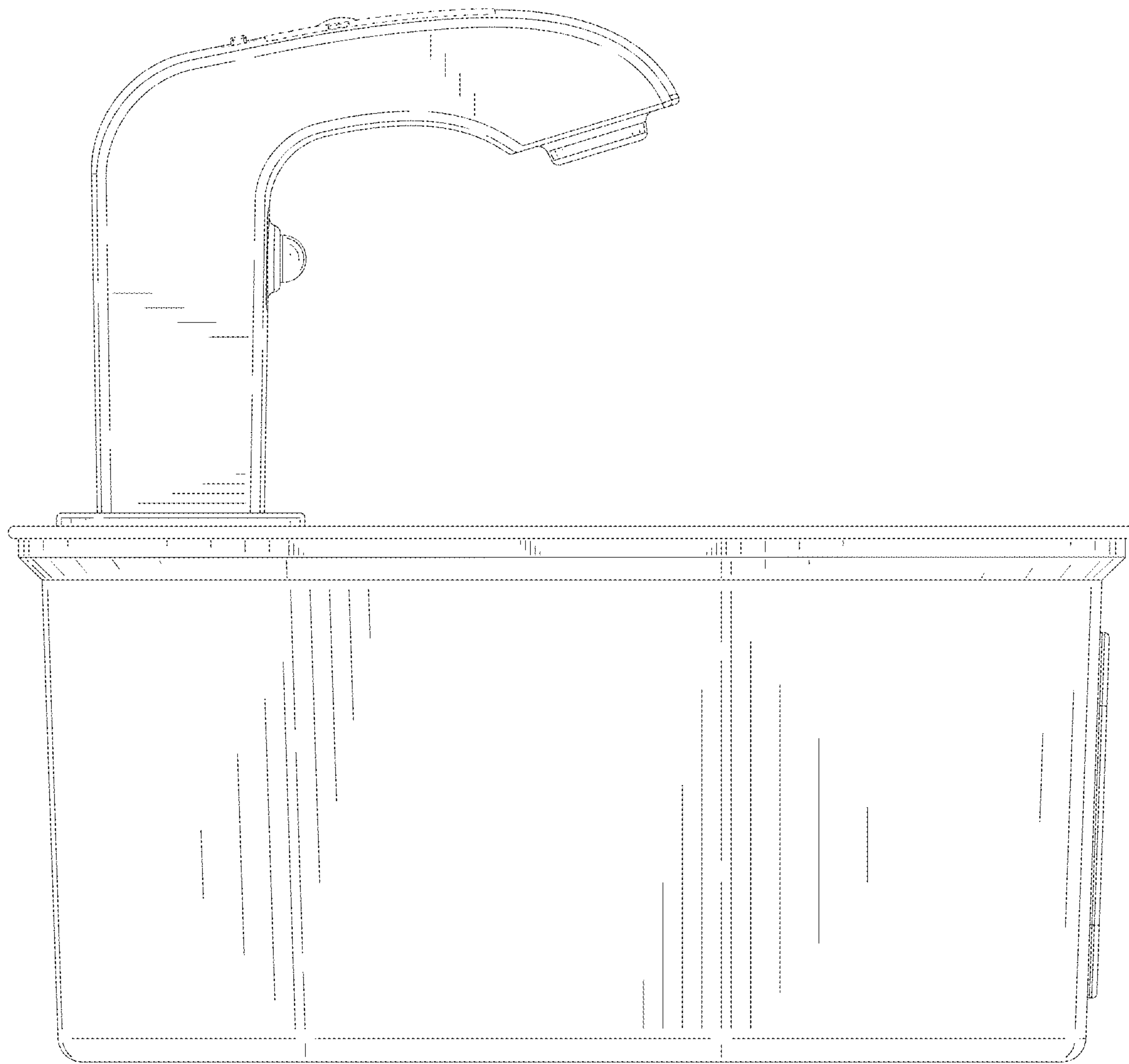

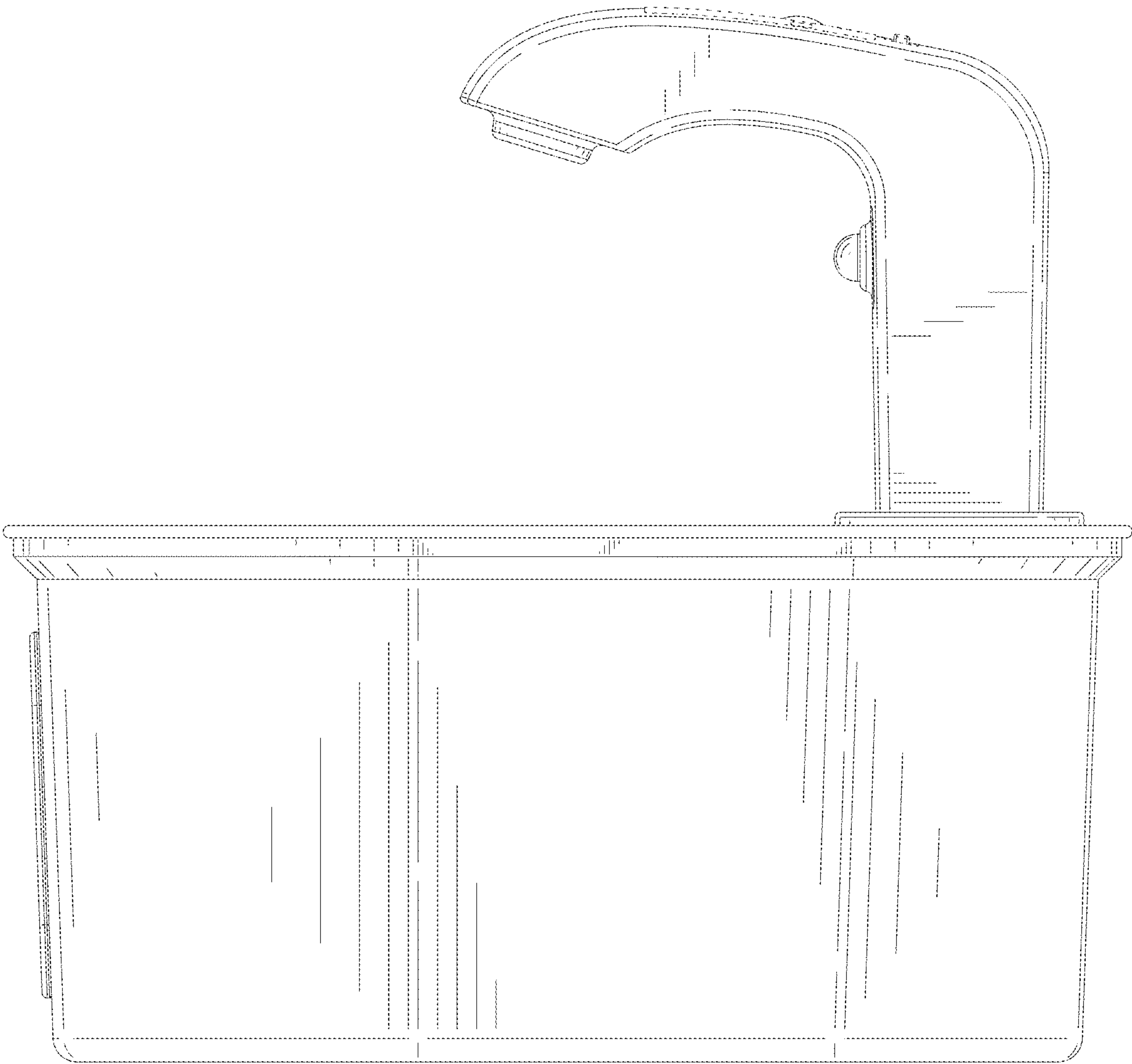

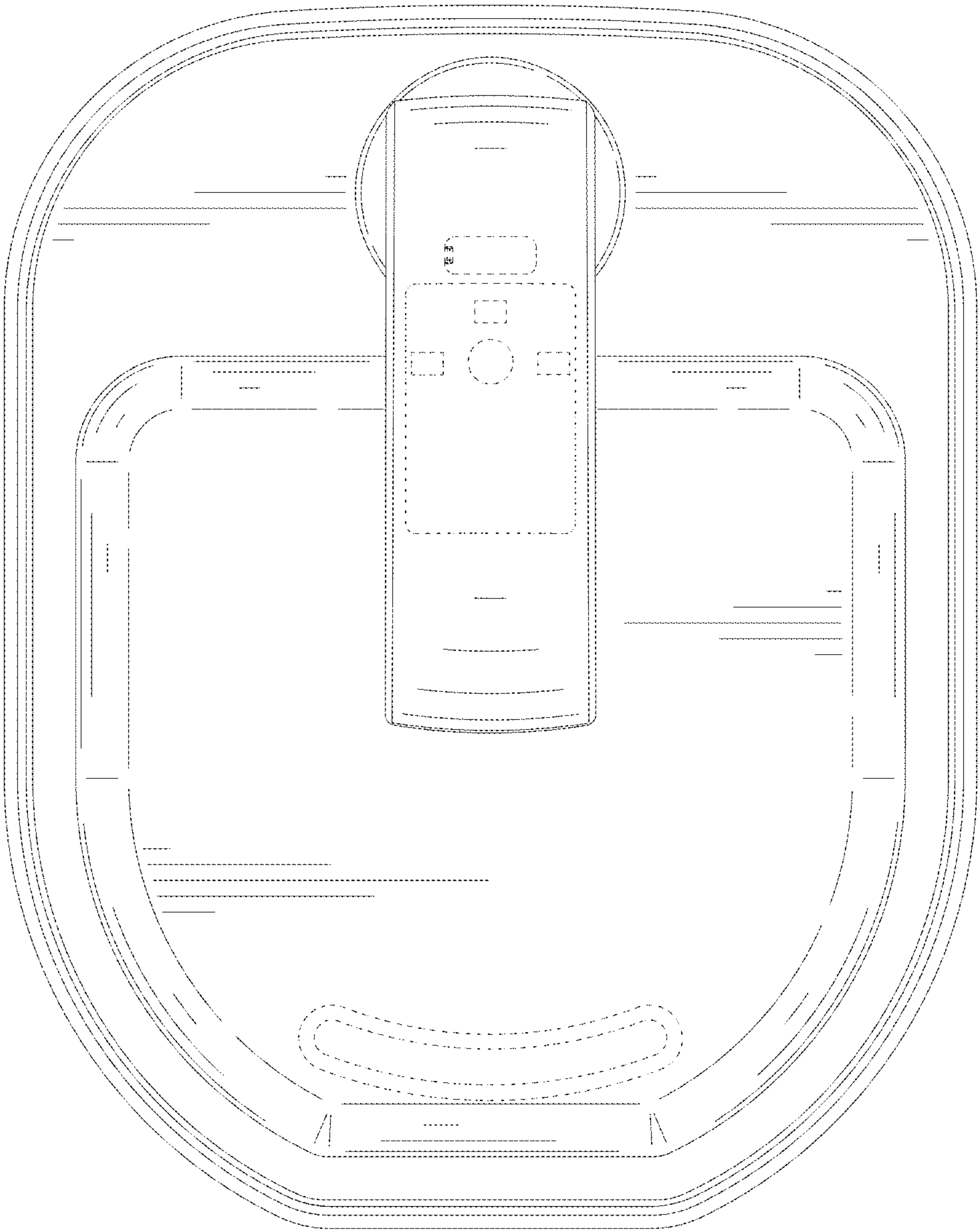

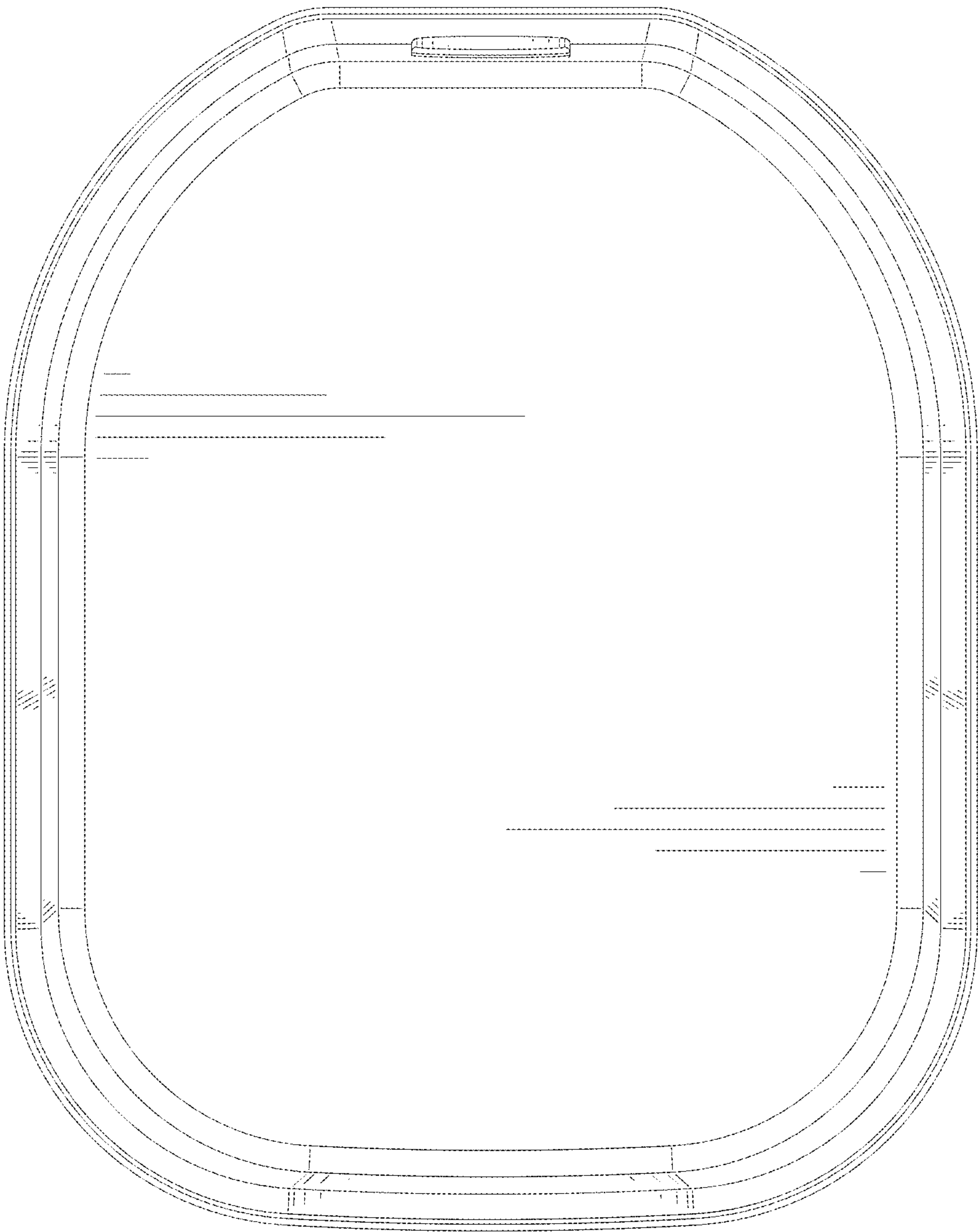
