The ornamental design for a footwear upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a footwear upper embodying the new design;

FIG. 2 is a top view thereof;

FIG. 3 is a right side view thereof;

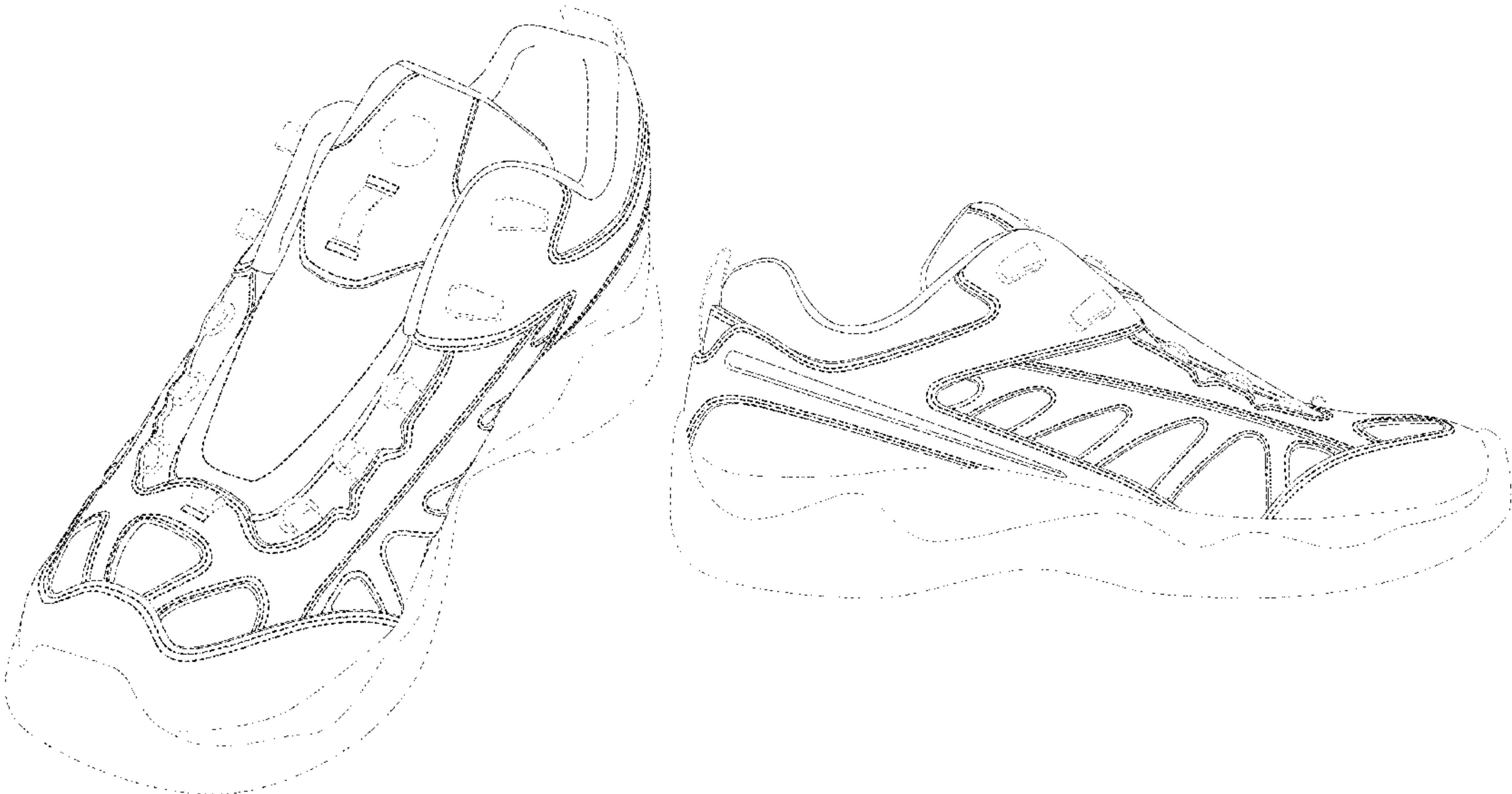
FIG. 4 is a left side view thereof;

The figures show features of an article of footwear with dot-dot-dash broken lines that form no part of the claimed design. Further, the dot-dot-dash broken lines immediately adjacent to the portions shown in solid lines form the boundary of the claimed design, with the broken lines forming no part of the claimed design. The even length broken lines in the figures depict stitching, which forms no part of the claimed design.

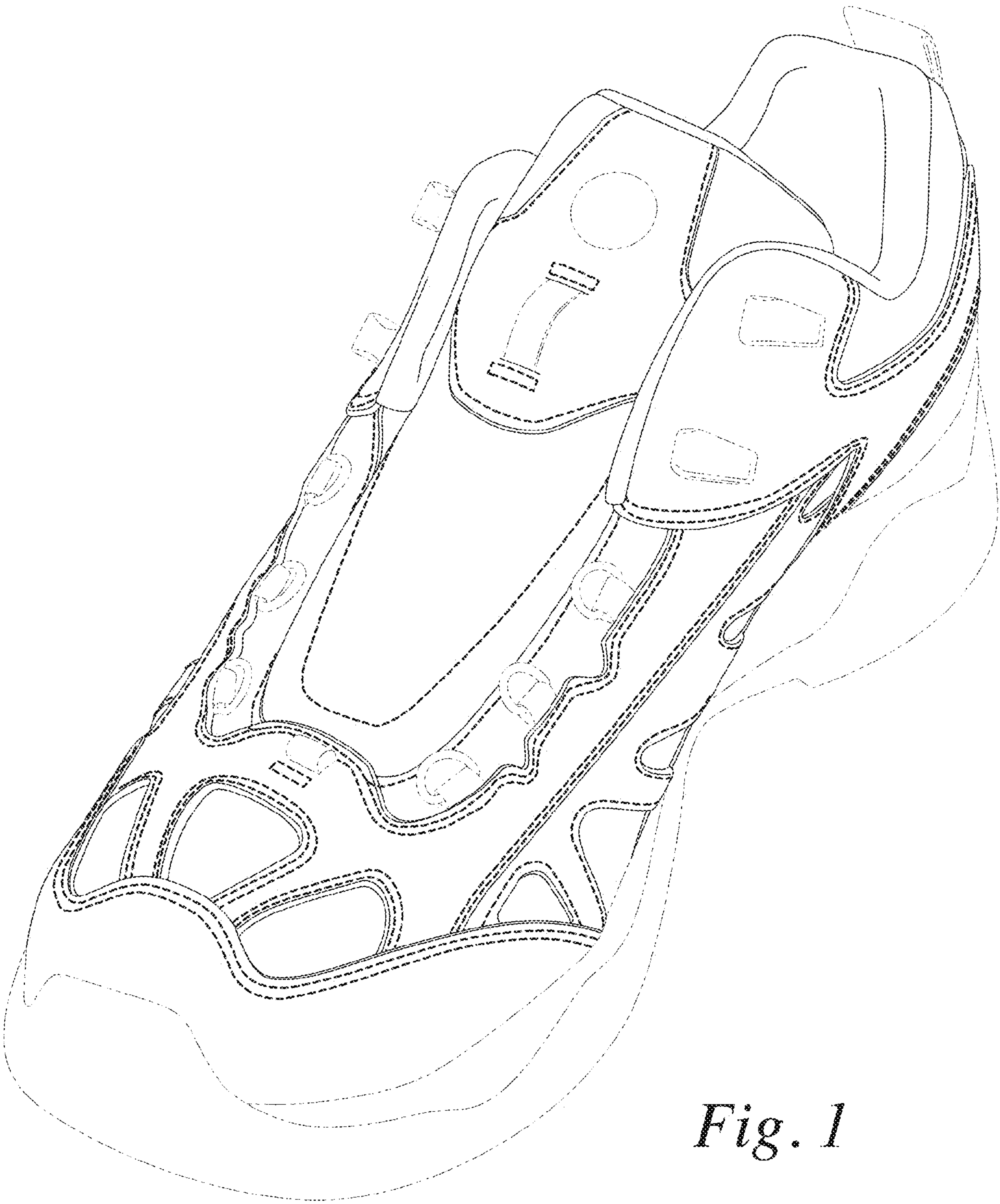

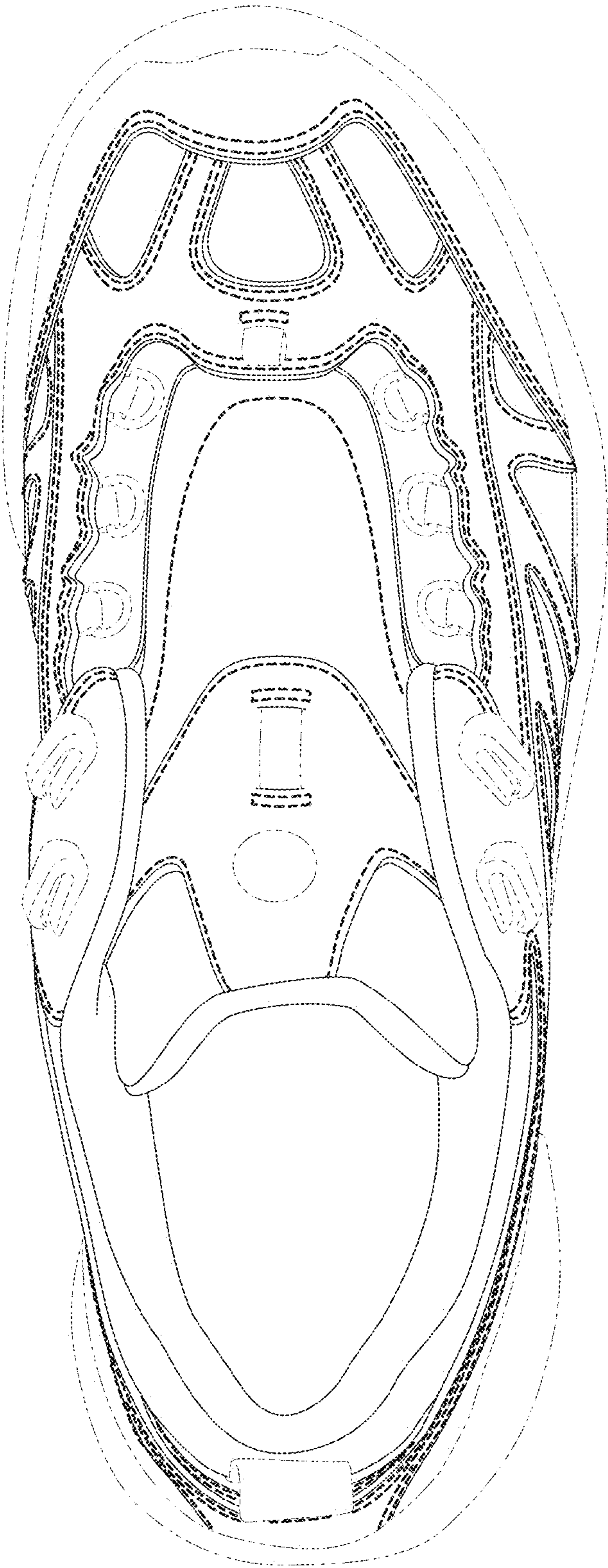

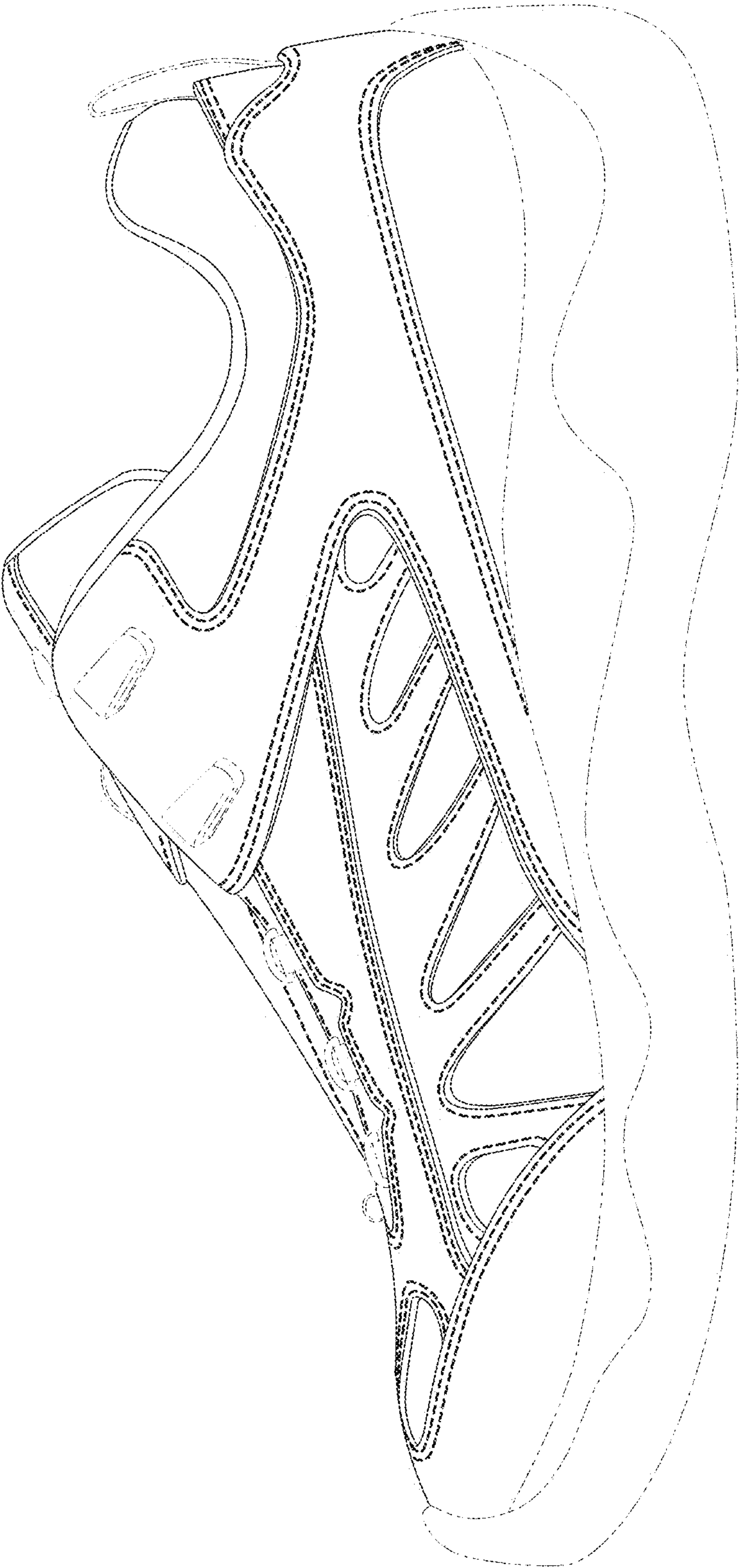

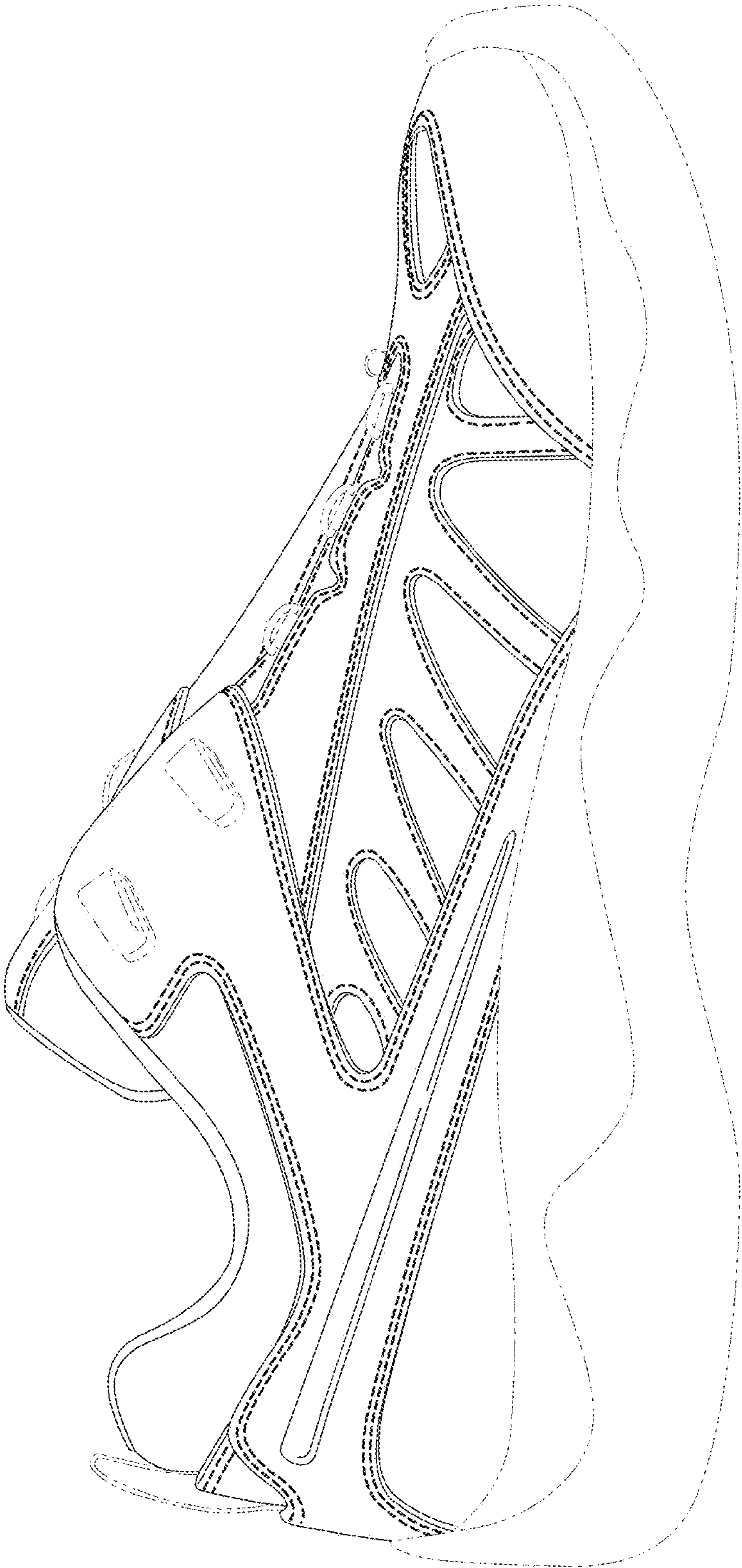

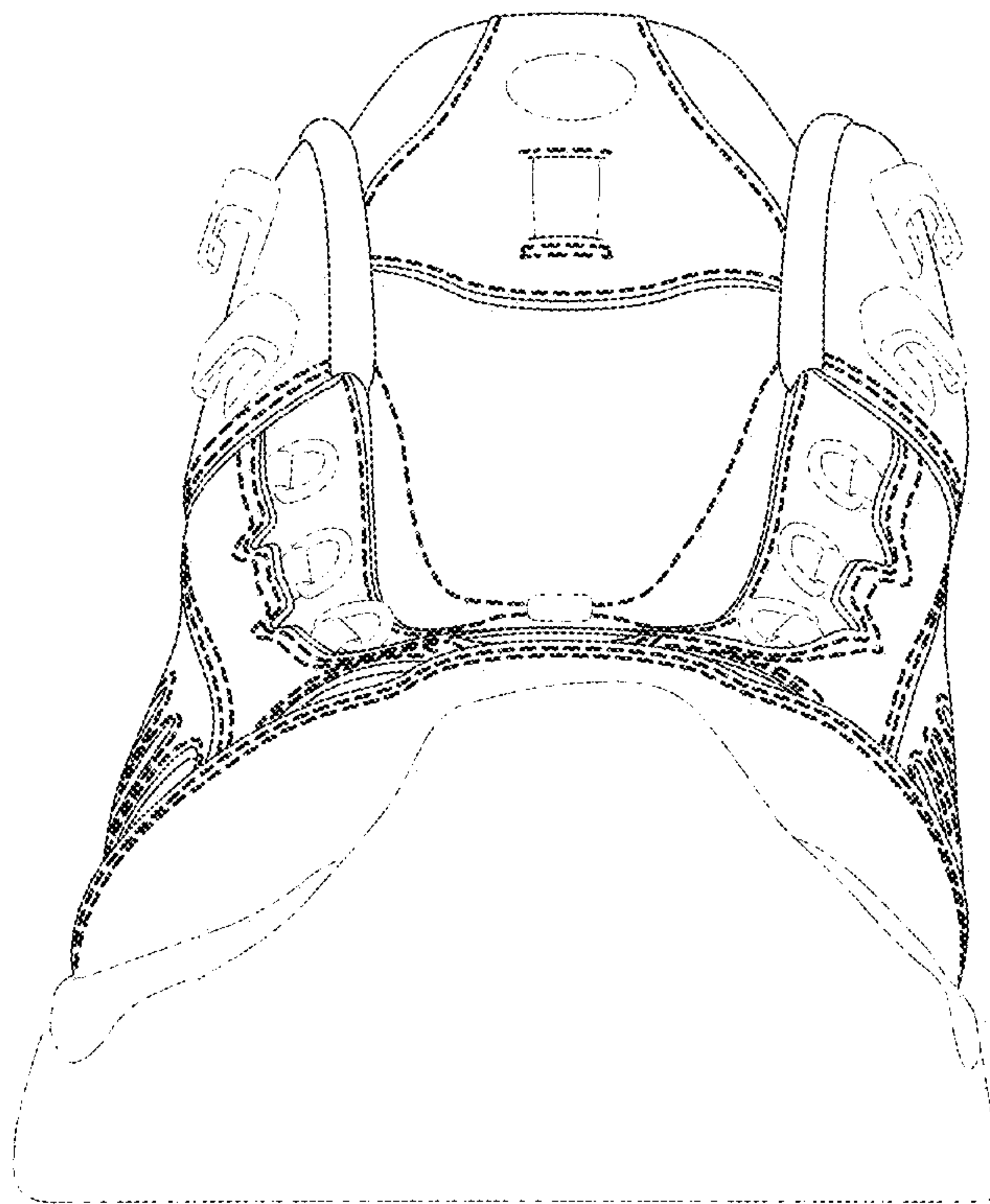

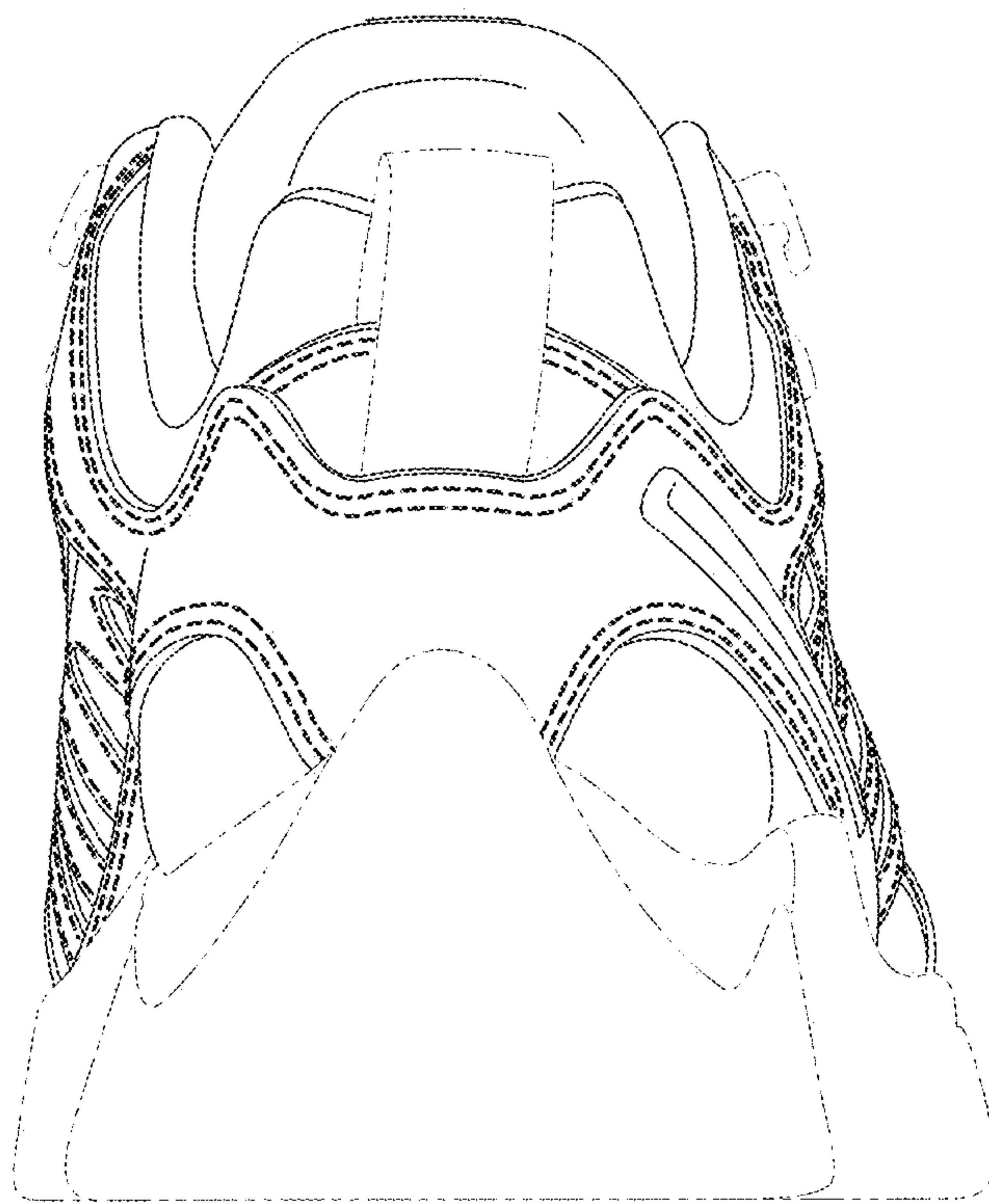
